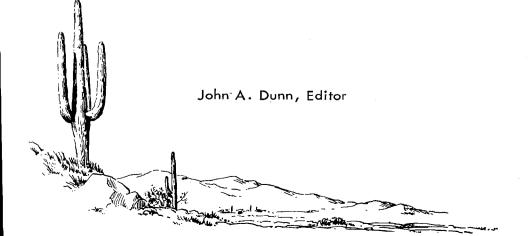

CONFERENCE PROCEEDINGS

FIRST SITTING

The seventh annual conference of the Arizona District of the Pilgrim Holiness Church was convened at the call of District Superintendent Emery in the Prescott Church at 9:00 a.m. May 1, 1962.

Reverend M. E. Turner, Pastor of the host church welcomed the annual conference and then led the assembled group in singing, "More Love to Thee, O Christ." Reverend H.G. Baker led in prayer.

Doctor R. C. Hawkins, General Secretary of Church Extension, and the conference presiding officer, was introduced by the District Superintendent. He read a portion of scripture from Hebrews 13 and then spoke on the topic, "The Even Life." Above all the children of God must be poised in a troubled age. If we fail in this respect the church will extinguish the light of hope for mankind. The established life, the speaker averred, is not extraneous but grounded on inner enablement and a deep, abiding grace that springs from a divine inner enablement. We must be so positioned that God can be our helper and this can only be so as we are totally emptied of self and only want what God wants us to have.

The roll of ministers and delegates was called.

A motion to accept the transfer of Reverend Don Johnson, a licensed minister from the East Michigan District, carried.

By motion the schedule of sessions was set as follows:

9:00 - 11:30

1:30 - 5:00

7:00 - until business is completed.

A motion also carried to designate the platform and the first three rows of seats on both sides of the church the conference bar.

District Superintendent Emery presented a splendid report which was accepted by a hearty, "Praise God." The auditor's report was read by the District Secretary.

Reverend M. E. Waddell, District Treasurer read the financial report. A motion to accept this report with gratitude toGod and appreciation to the Treasurer for his labors, carried with a chorus of "Amens."

In the absence of Statistician Denzel Clouse his report was read by Reverend M. E. Waddell. This report was accepted by motion.

Sunday School Promotional Secretary John Dunn gave a resume of accomplishments in this department across the district. After this good report was received by motion carried, awards, as listed by the Secretary, were presented to the appropriate pastors and superintendents.

There was 100% attendance of pastors present in the first session. Each one of these men gave a resume of personal labors as well as reporting on the state of the local church. A motion to accept these reports, with gratitude to God, carried with a hearty "Amen."

Before the last two pastoral reports were given, a motion carried to extend the time until the business at hand was completed.

The District Superintendent announced the District Women's Missionary Society Meeting would convene at 1:00 p.m. Conference Action Committee Secretary John Dunn read Item #3 from that report. It was moved, seconded and carried to adopt this resolution relating to the organization of the annual meeting of the Women's Missionary Society.

Reverend Charles Cooper requested the privilege of introducing Reverend Bert Mead of the Michigan District. Brother Mead came forward and was greeted by the presiding officer after which he testified.

The conference recessed by singing, "Tis So Sweet to Trust in Jesus" and with prayer by District Trustee H.C. Fridenmaker.

SECOND SITTING

The second sitting of the conference was called to order with the singing of "I Love to Tell the Story." Prayer was offered by Elwood Hunter.

The minutes of the first sitting were approved as read.

A motion carried to grant Reverend Bert Mead an honorary seat in the Conference bar.

The financial report of the Promotional Secretary of Sunday Schools was accepted by motion carried.

Reverend M. E. Waddell read the Financial Statement of the Arizona District as prepared by Mr. Denzel Clouse, and it was adopted by motion.

A partial report of the Educational and Examining Board was read by the Committee Secretary, Reverend H. G. Baker, A motion carried to receive the report,

The Conference Action Committee reported through its secretary, Reverend John Dunn.

Resolution #1 was adopted by a unanimous standing vote.

Resolutions #2, 4, 5, 6, 7, and 8 were adopted by motions carried.

A motion to substitute for #9 lost. Resolution #9 carried.

Resolutions #10 and #11 were read and the motion to substitute #11 for #10 carried.

Resolution #12 was also adopted by motion carried.

The District Superintendent appointed Sidney Baumgarner, Reverend Don Johnson, and Floyd Thomas as tellers.

The General Secretary of Church Extension read the following names as nominees of the General Board for District Superintendent: O. D. Emery and Harold R. Crosser. Reverend O. D. Emery was elected Superintendent on the first ballot. His speech of acceptance was, "Forward we go!"

Ballots were cast for Assistant District Superintendent with the election of Harold R. Crosser on the second ballot after a motion to vote on one of the three highest carried.

Reverends John Dunn and M. E. Turner were the Council Nominees for District Secretary. John Dunn was elected on the third ballot.

A ballot for District Treasurer was cast using the Council nominees, Reverend M. E. Waddell and Mr. Denzel Clouse. M. E. Waddell was elected on the first ballot.

A ballot was cast for Advisory member to the Council. A motion carried to vote for one of the three highest which were: Reverends M. E. Turner, H.G. Baker, and Charles L. Cooper. There was no election. It was moved, seconded and carried to vote for one of the two highest, M. E. Turner and H.G. Baker. M. E. Turner was elected.

Words of appreciation for retiring councilmen Reverend Charles L. Cooper

and Mr. Elwood Hunter were expressed by the Presiding Officer.

Council Nominees for the Educational and Examining Board were Charles L. Cooper and H.G. Baker. Reverend H.G. Baker was elected.

A motion carried to hear the Council nominees for a three year term as District Trustee. Mr. H. C. Fridenmaker and Mr. Bruce Collins were nominated. H. C. Fridenmaker was elected.

The Presiding Officer called for a short recess.

The conference reconvened and a motion carried that the District Council choose the place for the next conference.

Announcements were made and promotional materials distributed.

The final report of the Educational and Examining Board was read and approved by motion.

Committee appointments for the coming year were read by the District Super-intendent.

Miss Louise Van Metre was introduced to the Conference by Reverend O. D. Emery. She testified of her concern for the Spanish speaking people of Arizona.

Reverend Duane Watkins indicated his concern for the college and university students of the area.

A motion carried to appoint several men to investigate spiritual activities on Arizona campuses (Campus Crusade for Christ). District Superintendent Emery appointed Charles Cooper, Duane Watkins, and Don Johnson.

Several motions presented from the floor by permission of the Chairman were either lost or withdrawn.

Conference Action Committee Resolution #13 carried unanimously.

A motion to adjourn carried. The Doxology was sung and the prayer of dismissal given by Reverend Charles L. Cooper.

CONFERENCE REPORTS

Address of the DISTRICT SUPERINTENDENT to the District Conference Session--May 1,1962

To our esteemed Secretary of Church Extension, Dr. R. C. Hawkins, fellow ministers, delegates and friends, greetings:

When the mariner has been tossed for many days in thick weather, and on an unknown sea, he naturally avails himself of the first pause in the storm, the earliest glimpse of the sun, to take his latitude, sound his depths and ascertain whether he be on course. The waves, the wind and the weather encompassed us all, as through another year we came. Today we avail ourselves of a pause to read our position and chart our course. Let us get a fix upon the Eternal One, the Changeless One, the One in whom there is no variableness. We must thread our way through the business of this Conference made bold by faith in Him, rather than daunted by fear of our adversaries.

This Conference holds promise of momentous significance. Your approval will move our District into the "Advanced Level". The provision of this forward step is greater self-government. The requirement is gradually increased self-support for this District program. Many things combine to indicate to me that this is the Holy Ghost's direction for us at this time.

We have been on course this year in our accomplishment of our goals. (1) The goal for membership gain was 10% or 35 numerically. We gained 16,4% or 57 numerically.

(2) The Sunday School attendance goal was 10% or 74 numerically. Our gains were 12.2% or 91 numerically. This year saw many new records set for total attendance in the District.

(3) Auxiliaries have been fostered both in the churches and on the District level. The first Men for Mission chapters were organized in two churches this year. Other Youth Societies and Missionary Societies have been organized.

(4) A Branch Sunday School was started in the Phoenix Paradise Valley area by Phoenix First Church. We hope to see several of our churches undertake this branch Sunday School program.

(5) The use of Probationary and Junior Membership systems in the churches is increasing. I believe ten of our churches now use these.

(6) Lay visitation programs are under way in most of our churches at this time.

(7) Budget payments have been higher than ever. Seven churches have paid in full and regularly. These are Phoenix First, Phoenix Westside, Phoenix Mt. View, Phoenix Bethel, Prescott, Yuma and Tempe.

The measure of attainment in the areas of these goals is very outstanding and gratifying.

Our district operational funds were up about \$100 per month over the previous year, for a monthly average of \$474. In addition to this amount taken out of the 15% District U. S.F. we also paid \$711 to the General U.S.F. and over \$900 to Central Pilgrim College.

This year has been marked by the leadership of the Holy Ghost. The program of the District has been His. He sent the workers, honored the Truth, convicted the world, led His work and directed in decisions. A steady flow of Holy Ghost activity continues to abound today throughout this part of the church.

Some degree of temporal success accompanied the spiritual successes. The sale of the Camp Ground improvements solved many problems. The new church building at Tucson Rita Manor is under construction. It promises to be a beautiful building and will greatly facilitate the continued growth of this new church. Phoenix Mt. View, Phoenix Westside and the Prescott congregations all purchased new parsonage properties this year. The District Council accomplished the purchase of a new, adequate District Parsonage also.

District Meetings held this year have been quite outstanding. The various boards and committees to whom these responsibilities fell are commended. The effort this year has been a team effort.

The District Council feels we have the program for next year which is pleasing to the Holy Ghost. I will set forth these goals.

(1) Pattern for Progress Growth Standards

a. 10% Membership Gains

b. 10% Sunday School Attendance Gains

c. 10% Local Church Regular Offerings Increase

(2) Foster auxiliaries - Youth, Women's Missionary Society, Men for Missions and create Christian Youth Crusade

(3) Lay Visitation Evangelism in each church

(4) New missions, Branch Sunday Schools and Prayer Meetings to reach the lost of our area.

(5) Use of Probationary and Junior Membership systems in the churches.

(6) Payment of all Budgets in full and monthly

An AWARD OF EXCELLENCE will be given those churches which meet the growth standards of the Pattern for Progress, pay all their 15% Budget and meet the suggested goals of the three annual denominational offerings.

An AWARD OF MERIT will be given those churches which meet any two of the growth standards of the Pattern for Progress, pay all their 15% Budget and participate in the three annual denominational offerings.

Three other forward steps which the District Council has approved are:

(1) Appointment of a pastor for the Paradise Valley work.

(2) Efforts to open missionary work among the Spanish-speaking people of our cities. Also efforts to open a work among the Negro populace.

(3) Laying of plays for opening the newly added New Mexico area. (A recent General Board action placed New Mexico under this jurisdiction.)

Much depends on us as we serve God in this vital area of our Nation. Within our borders lie three of the fastest growing cities of America. Phoenix is third fastest, Tucson seventh and Albuquerque is tenth. (World Book 1961 Annual Supplement, page 233) No greater field exists on earth today. God grant that we shall be made adequate by the Holy Ghost.

My personal report is listed with the other ministers in the statistical tables.

This has been a busy year. I have travelled 23,000 miles by auto, 21,000 miles by air and some by rail both in and out of this District to perform my duties and hold the meetings to which I was called. Your prayers and cooperation are deeply appreciated by me.

Finally brethren, I exhort you to stand firm in your faith. May the grace of our Lord Jesus Christ be with you. Maranatha!

Report of the SUNDAY SCHOOL PROMOTIONAL SECRETARY 1961-1962

IT IS A REAL JOY to bring to this 1962 conference a summation of the past year in the Sunday Schools of our District. The reason for our joy is because everyone has contributed in making it a great year in our Sunday Schools.

The Sunday School Conventions held in the Tucson and Phoenix areas were an outstanding contribution to the District Sunday School program. It was our honor to have Reverend J.D.Abbott, National Director of Pilgrim Sunday Schools as the Convention speaker.

The October Rally Day showed a 4.6% increase over one year ago with a total attendance of 916.

THE YEARLY HANDICAP injected real enthusiasm throughout the Sunday schools. The last Sunday of the handicap was great with an attendance of 1061. The five Sunday District-Wide Handicap Contest average was 945.

THE ANNUAL SUPERINTENDENT'S BANQUET was another milestone in the co-ordination of the District Sunday School promotion and planning. Tucson First Church under the able leadership of Pastor Harold R. Crosser and Sunday School Superintendent Mr.Wainscott were presented the Annual Handicap Contest Banner plus winning the free dinner. Tempe was a very close runner-up.

PHOENIX FIRST CHURCH is to be commended in the starting of a new branch Sunday School in Paradise Valley.

January, February, and March proved to be the biggest months ever in average attendance for our Sunday Schools. The numerical gain for the year is 91, representing a 12% increase over the past year. Every month showed a gain over the same month of the preceding year. The Decade of Progress Ship will be awarded to the Tucson, Rita Manor Pilgrim Church, having the highest total points (11,274) of the 10 churches reporting. Tucson, First Church was runner-up with 10,900 points.

Tucson First Church led the pack with the highest numerical gain of 22 with three churches contending strongly just behind. Tempe was second with a numer-ical gain of 21, while Yuma and Mt. View gained 19 and 18 respectively.

Yuma First Church takes the percentage banner with a 106% increase. Tempe ran second with a 42% increase.

Three Sunday Schools receive the 25% award ribbons while 4 receive the 10% ribbons. The percentages are as follows:

Report of the CONFERENCE ACTION COMMITTEE MAY 1, 1962

CONFERENCE

WHEREAS the District Superintendent has presented the Quadrennial Pattern for Progress for the 1962-66 period to all pastors and churches of our district,

THEREFORE BE IT RESOLVED that the Pattern for Progress be adopted by the Conference.

BE IT FURTHER RESOLVED that the following goals be adopted as the Local Church and Conference Goals for the coming year:

- 1. Pattern for Progress Growth Standards
 - 10% Sunday School Gains
 - 10% Church Membership Gains
 - 10% Local Church Financial Gains
- 2. Fostering of Youth Society, Women's Missionary Society,
- Men for Missions, and creation of Christian Youth Crusades 3. Lay Visitation Evangelism in each Local Church
- 4. New Missions, Branch Sunday Schools and Prayer Meetings throughout the District
- 5. Use of Probationary and Junior Membership programs

6. Payment of all budgets in full and by the month. (Carried) 2. BUDGETS

BE IT RESOLVED that the 15% District United Stewardship Fund be pro-rated and expended under the direction of the District Council on the following basis: District Operational Fund 71%, General U.S.F. 19% and Central Pilgrim College 10%. (Carried)

3. MISSIONARY ORGANIZATIONS

WHEREAS there is a need for greater representation from the Local Missionary Societies to the annual Women's Missionary Society business meetings;

BE IT RESOLVED that Article VI of the Constitution be amended to read:

"ELECTIONS--Annually the organization shall meet to elect its officers. The District President shall be elected from two or more nominees provided by the District Council. Other officers shall be elected from among the active members. The electing body shall be constituted of the district society officers of the previous year, the local society presidents, the wives of all district pastors and district superintendent, and one delegate from each society for each 10 members or major portion thereof. If a local church does not have a society the church board may choose a delegate to represent that local church at the district society meeting. The officers shall be elected for the term of one year, and shall serve until their successors are elected and qualified. The District Superintendent or his representative shall preside at the meeting of election. Election shall be by majority vote." (Carried)

4. CAMP

BE IT RESOLVED the resolution #4 of the Conference Action Committee, as appearing on page 21 of the 1961 Conference Journal be amended to read:

"INASMUCH AS there are great difficulties involved in having summer camp meetings in the populous areas of Phoenix and Tucson, and INASMUCH AS the majority of the members of our churches live in these areas,

STANDING RESOLUTIONS OF PREVIOUS CONFERENCES

LOCAL CHURCH

1. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.

2. Each local church is urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total membership.

3. Each local church shall have a Public Relations Chairman, who will submit copy of local news events to district publications and local newspapers.

4. BE IT RESOLVED that all local indebtedness involving an expenditure of more than \$500, where financing is involved, be approved by the district council. (1960)

5. BE IT RESOLVED that all non-Pilgrim Evangelists must first have the approval of the District Superintendent or the District Council before being called for evangelistic activity in our churches. (1960)

6. BE IT RESOLVED that no church may borrow from its pastor, nor may any pastor underwrite loans for a church so as to make himself legally responsible as an individual, without the prior consent of the District Council. (1961)

CONFERENCE

1. The district council and the following committees and boards shall meet one day prior to the Annual Conference to take care of such work as they have at hand. Conference ActionCommittee and the Educational and Examining Board.

2. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED, that the Ordination Service take place at 4:00 p.m. the first day of Conference. (1957)

3. The Educational and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for a period of two years and one for one year.

4. There shall be a memoirs committee which shall annually list departed members by name, date of decease, and church, for inclusion in the Conference Journal. In the case of ministers there shall be a picture and a brief resume of ministerial labors.

5. BE IT RESOLVED that the district furnish credential forms to each local church conference delegate and alternate to be filled out and signed by the pastor

and the church secretary, and sent to the district secretary at least 30 days prior to Conference. (1959)

6. BE IT RESOLVED that the District Trustees and the Statistician be made permanent members of the District Conference.

7. INASMUCH as there is such close correlation between the work of the Resolutions Committee and the Ways and Means Committee: THEREFORE BE IT RESOLVED that there be the appointment of a Conference Action Committee of 5 members, which would combine the functions and capacities of the Resolutions and the Ways and Means Committees. (1960)

8. BE IT RESOLVED that there be the appointment of a Building Appraisal Committee: (competent in the field of appraisal) the function of which shall be to set the value of all church property.

BE IT FURTHER RESOLVED that the appointment of this committee be made bi-annually, for the purpose of making a general appraisal of all local church and district property bi-annually,

AND BE IT FURTHER RESOLVED that all properties acquired between these appraisals shall be carried as tentatively appraised by the District Council, until the next general appraisal. (Revised 1961)

9. INASMUCH AS Resolution Number 6, p. 16 of the 1960 Conference Journal carried and provides that all resolutions and ways and means actions be classified both in presentation and in publication.

BE IT RESOLVED that the following general classification, "Report of the Conference Action Committee" and "Standing Resolutions of Previous Conferences", be applied to all past and present conference legislation, and

BE IT FURTHER RESOLVED that the present "Standing Rules" heading be abolished, and legislation of previous conferences currently listed under this heading be classified under "Standing Resolutions of Previous Conferences" and,

BE IT FURTHER RESOLVED that the following specific classifications be applied to all past, present and future legislation:

Local Church Conference District Superintendent Ministerial District Council Budget Camp Sunday School Youth Missionary Organizations (1961)

DISTRICT SUPERINTENDENT

1. BE IT RESOLVED that the District pay \$175.00 per month on salary of the District Superintendent; BE IT FURTHER RESOLVED, that the District Superintendent be remunerated for meals and lodging incidental to travel. (Revised 1962)

MINISTERIAL

1. Before licensed or ordained ministers coming from other churches shall be received into the local church, the pastor shall consult with the District Superintendent and Council regarding said minister.

2. Each pastor is to be granted a two weeks vacation with full salary.

3. INASMUCH as several of our districts have a group hospitalization, surgical, and medical insurance plan, and since a number of the district pastors have expressed a desire for such a plan, BE IT THEREFORE RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical, and medical plan. AND BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the district pay \$5.00 per month to be applied to the District Superintendent's premium. This resolution is recommended first for discussion by the committee with the added recommendation that the lay delegation be given the privilege of discussion. (1959--Revised 1962)

4. BE IT RESOLVED that when ministers come to this district from other denominations, that the Executive Officer of the transferring minister be contacted by the District Superintendent asking for a recommendation, to be in the hands of the District Council at least 30 days prior to moving date. AND BE IT FURTHER RESOLVED that the transferring minister be interviewed by the District Council prior to reception of his credentials. (1959)

5. INASMUCH AS the Manual, Section 178, requires the District Council to formulate a list of inactive ministers,

THEREFORE BE IT RESOLVED that a ministerial classification Directory be adopted: (1961)

(For the classification directory refer to page 22 of the 1961 Conference Journal)

DISTRICT COUNCIL

1. BE IT RESOLVED that laymen may serve on the District Council. (1959) 2. BE IT RESOLVED that each council member be paid 5 cents per mile for travel expense to and from council meetings and that when several members travel in one car, the driver be paid an additional one cent per mile for each council member travelling with him. (Amended 1961)

BUDGET

1. BE IT RESOLVED that all monies raised in local churches for district, general or Bible College purposes be disbursed through the District Treasurer, and only such monies as are processed accordingly may be credited to the local churches on the District Treasurer's report.

2. BE IT RESOLVED that each church pay monthly to the District Treasurer 15% of all regular church offerings and regular Sunday School offerings, and that the 15% will not apply to monies raised for the Building Fund, Land Fund or any special offerings raised for a department supported by these budgets. No other exceptions are to be made. The 15% will constitute the total budgetary assessment to the church.

BE IT FURTHER RESOLVED that this budget be known as the District United Stewardship Fund. (1961)

CAMP

1. WHEREAS it appears that the cost of owning and maintaining a camp ground is prohibitive;

BE IT RESOLVED, that the Conference instruct the Council to take steps

to dispose of the real property on the camp ground and that the proceeds be applied as follows:

1. Satisfy the claims of cabin owners;

2. Camp ground indebtedness;

3. Balance if any to be put in a Camp Fund. (1960)

2. INASMUCH AS there are great difficulties involved in having summer camp meetings in the populous areas of Phoenix and Tucson, and

 $\ensuremath{\text{INASMUCH}}$ AS the majority of the members of our churches live in these areas,

THEREFORE BE IT RESOLVED that we plan a mid-winter indoor camp in the early months of each calendar year, to be alternated between the cities of Phoenix and Tucson, and that this indoor camp replace the summer adult camp meeting.

BE IT FURTHER RESOLVED that our summer camp meeting activity be reserved for enlarged district youth camp development, and that no additional camp programs be planned by our churches without approval of the District Council. (1961)

Note -- Current legislation in effect, Conference Action Committee #4.

SUNDAY SCHOOL

1. BE IT RESOLVED that the work of the District Sunday School Board be financed by offerings from the District Camp Sunday School and Sunday School conventions, and

BE IT FURTHER RESOLVED if a need for additional funds for this Board arises, a request shall be made to the District Council for appropriations. (1961)

YOUTH

1. INASMUCH AS the need for activity among our youth is so great, THEREFORE BE IT RESOLVED that at least six Zone Youth Rallies be held during the conference year in each Zone, with the responsibility of planning and implementing these rallies to be cared for by the elected Zone Committee. (1961)

MISSIONARY ORGANIZATIONS

1. WHEREAS the organization of the Women's Missionary Society of Arizona was provided for by the 1960 Conference, and the Articles of Constitution appear on page 16 of the 1960 Conference Journal,

BE IT RESOLVED that the organization be encouraged as a coordinator of the local church societies within the District. (1961)

2. WHEREAS the 1960 Conference provided for the organization of the Arizona Men for Missions, and adopted the Constitution which appears on page 15 of the 1960 Conference Journal,

THEREFORE BE IT RESOLVED that the work of this organization be promoted in the churches in the District. (1961)
