CONFERENCE PROCEEDINGS

FIRST SITTING

The Tenth annual conference of the Arizona-New Mexico District of the Pilgrim Holiness Church was convened at the call of Superintendent Crosser.

Reverend Melvin Lockard led the assembled group in singing several hymns of the Church. M. E. Turner and Kenneth Artz led in prayer.

Superintendent Crosser introduced Dr. Hawkins as presiding officer.

Dr. Hawkins read from the Scripture found in John's Gospel the 4th Chapter and began reading at verse 46. He spoke to the conference using the subject, "Faith That Achieves." Our hearts were challenged to put our faith to work as he spoke concerning the Word of Faith, the Work of Faith and the Wonder of Faith.

The roll of ministers and delegates was called.

A motion carried to designate the platform and the first four rows of seats as the conference bar.

A motion carried to accept the transfers of the following: J. V. McCullough, ordained from Wisconsin, M. E. Turner, ordained from Gulf States and Richard Hawkins, 1st year from Michigan. A further motion carried to receive Jack Gilbert, 2nd year from Central District and Dale Hallaway, ordained from S. Indiana pending receipt of letter of transfer.

Dale Hallaway, Eugene Zerby, Edwin Diggs, Lowell Downey and Jack Gilbert were appointed ushers for the conference.

By motion, the schedule of sessions was set as follows: 9:00-11:30 a.m., 1:30-5:00 p.m., 7:00 p.m. until business is completed. Carried.

District Superintendent Crosser presented his annual report to the conference. It was accepted with a hearty "Amen."

The auditors report was read and approved.

The District Treasurer, Denzel Clouse read the financial reports. A motion carried to accept his report.

It was moved and carried to hear the summary totals of the Statisticians report. It was approved as read.

The Sunday School Promotional Secretary, Rev. David Miller, gave a brief resume of the District Sunday School endeavor.

The pastors reports were presented to the conference.

Following due announcements, the first sitting adjourned with Reverend Metz pronouncing the benediction.

SECOND SITTING

The second sitting opened with Denzel Clouse leading in prayer and with singing "Wonderful, Wonderful, Jesus Is To Me." Testimonies of victory followed.

The conference was favored with several songs by the Journeymens Quartet.

The minutes of the first sitting were approved as read.

Pastors reports continued and were received with a hearty "Amen."

District Superintendent H. R. Crosser, presented the newly organized church of Glendale, Arizona. Rev. David Miller and Mrs. Mary Young were presented to Dr. Hawkins as the pastor and delegate from our newest church. A motion carried to receive the Church at Glendale into the conference.

The Educational and Examining Board reported through its Secretary, Eugene Zerby. It was moved and carried to adopt their report.

The Memoirs committee presented their report. It was adopted by standing in a moment of silent prayer followed with prayer led by Dr. Hawkins.

The report of the Conference Action Committee was presented through its Chairman M. E. Waddell.

Resolution #1 was adopted by motion carried.

Resolution # 2 by motion carried was amended "and BE IT FURTHER RESOLVED that the Church Secretary count the ballots and notify the pastor and District Superintendent at the close of the election. Resolution #2 was adopted as amended.

Resolutions # 3 and 4 were adopted by motions carried.

Resolution # 5 was amended by motion carried "and if necessary the above schedule will follow the next day." Resolution # 5 was adopted as amended by motion carried.

Resolutions #6 and 7 were adopted by motions carried.

Resolution # 8 was amended to read "October" and delete the word November by motion carried. Resolution # 8 was adopted as amended by motion carried.

Redolution # 9 was adopted by motion carried.

Resolution # 10 was tabled.

A motion carried to recess until the ordination service at 4 p.m. W. A. Elkins dismissed in prayer.

The conference was called to order by the Chairman for the purpose of the ordination service. The congregation sang "A Charge to Keep I Have." Rev. Eugene Zerby led in prayer. Superintendent Crosser ushered the Ordinands David Miller and Jack Gilbert to the

presiding officer for the ordination rite.

Reverends Dunn, Waddell and Lockard read appropriate passages from the Scripture. Dr. Hawkins spoke to the Ordinands and the congregation using the theme, "An Able Minister of the Gospel." He read from II Corinthians 3:6. Dr. Hawkins gave the ordination charge followed by Rev. Crosser leading in prayer and the laying on of hands by the ordination council.

The service closed with singing and appropriate congratulations to the newly ordained ministers. M. E. Turner dismissed in prayer.

THIRD SITTING

The third sitting of the conference was called to order by the Superintendent. W. A. Elkins led the conference in singing "Jesus Is All The World To Me." Lowell Downey led in prayer. Mrs. Phylliss O'Neil sang a solo.

The minutes of the second sitting were approved as read.

It was moved to call for the election of officers at 9 p.m. Carried.

It was moved to amend Resolution # 11 at the close of # 1 as follows: "It shall be fully recognized by our churches and pastors that it is the intent of this legislation that the United Stewardship Fund of \$8.00 per member per year as set up by the General Conference of 1962 is to be paid out of this fund. Carried. It was moved to amend Resolution # 11 under # 2, paragraph 1 to read "100% of pastor's tithe", paragraph 3 to read "15% of the Pastor's and District Superintendent's tithe." It was moved to substitute the use of the 300 Club receipts to offset the Operational deficit. A motion lost to substitute. A motion lost to amend the amended resolution. Resolution # 11 was adopted as amended by motion carried.

Under resolution # 12 it was moved to substitute paragraph 5 as recommended by the District Council: "AS a result we shall set as our goals: A. One or more new starts each year. B. Organize one or more churches each year. C. A 10% annual increase in mem-

bership, Sunday Schools and finance. Substitute motion lost. Under resolution # 12 it was moved to delete the 1st paragraph under # 6. Carried. Resolution # 12 was adopted with noted deletion.

Resolutions # 13, 14 and 15 were adopted by motions carried.

The election of officers followed. For the office of Superintendent the following names were presented as nominees from the General Board: H. R. Crosser, M. E. Waddell, John A. Dunn, Melvin Lockard.

Following 14 ballots a motion carried to refer the matter of nominees for District Superintendent to the General Superintendent of the Pilgrim Holiness Church as outlined in the Manual.

Council nominees were read for a three year term on the Educational and Examining Board. They were M. E. Turner and Melvin Lockard. Melvin Lockard was elected on the first ballot.

A ballot for a three year term on the Board of Trustees was cast. Henry Fridenmaker was elected on the second ballot.

A ballot for lay delegate to the International Conference was cast. Denzel Clouse was elected on the second ballot.

The conference adjourned with a prayer of dismissal by Kenneth Artz until Wednesday at 7 p.m.

FOURTH SITTING

The fourth sitting of the conference was called to order by Superintendent Crosser. The assembled group was led in singing "A Charge To Keep I Have." Rev. Alvin Ransom led in prayer.

The minutes of the third sitting were approved as read.

It was moved and carried to seat Leta Shutz as alternate delegate from Apache Junction.

The election of a Superintendent followed. T. M. Weir was presented as a nominee by General Neff. There was no election. General Neff presented the name of R. T. Powell as a nominee for Superintendent. There was no election.

It was moved and carried to refer the matter to the Executive Council for appointment.

The election of the Assistant Superintendent followed. Two ballots were cast resulting in no election. It was moved and carried to vote on the two highest on the last ballot, which was John A. Dunn and Melvin Lockard. John A. Dunn was elected Assistant District Superintendent on the fifth ballot.

Council nominees for District Secretary were: M. E. Turner, David Miller and Lowell Downey. M. E. Turner was elected District Secretary on the second ballot.

Council nominees for District Treasurer were: Denzel Clouse and David Miller. Denzel Clouse was elected District Treasurer on the first ballot.

Ballots were cast for an Advisory seat on the district Council. No election resulted on the first ballot. It was moved and carried to vote on the two highest namely Lowell Downey and Melvin Lockard. Melvin Lockard was elected Advisory member to the District Council on the second ballot.

The election of a ministerial delegate to the International Conference followed. One ballot was cast with no election. It was moved to vote on the two highest who were Melvin Lockard and John Dunn, Carried. John Dunn was elected as a ministerial delegate to the International Conference in 1966 on the second ballot.

A ballot was cast for the alternate ministerial delegate to the International Conference. Melvin Lockard was elected on the first ballot.

The election of a lay alternate delegate to the International Conference followed. Kenneth Artz was elected on the second ballot.

It was moved and carried for the conference to vote on the two nominees for District Superintendent presented earlier. A session of prayer followed. Reverend T. M. Weir was elected on the second ballot.

Presiding officer, Dr. R. C. Hawkins reported to the conference that T. M. Weir accepted the position as District Superintendent of the Arizona-New Mexico District.

The Conference Action Committee presented a final resolution to the Conference: BE IT RESOLVED that by a rising vote we express our deep appreciation to Dr. R. C. Hawkins for his challenging messages, for his outstanding and efficient chairmanship of this annual conference - to the Tempe Church and pastor for their hospitality and to District Superintendent Crosser for his faithful and effective leadership. Carried by a rising vote.

Conference closed by singing "God Be With You" and Willard Metz pronouncing the benediction.

CONFERENCE REPORTS

ADDRESS OF THE DISTRICT SUPERINTENDENT
TO THE DISTRICT CONFERENCE SESSION--May 18, 1965

To the tenth annual conference of the Arizona-New Mexico District of the Pilgrim Holiness Church, in session, to our faithful and courageous Secretary of Church Extension, my good ministerial brethren, and our fine corps of lay people, Pilgrim Greetings!

Grace be unto you, and peace, from God our Father and from the Lord Jesus Christ.

I thank my God upon every remembrance of you,
Always in every prayer of mine for you all
making request with joy,

For your fellowship in the gospel from the
first day until now:

Being confident of this very thing, that he
which hath begun a good work in you will
perform it until the day of Jesus Christ.

Phil. 1: 2 - 6

I thank God for the high honor and the holy privilege
of Preaching the Gospel and seeking lost men. In what-

ever place I have served during 21 years of ministry, my work has been carried out with fear and holy compulsion.

One of my happiest tasks during the past year was the nurturing of two new churches. The heroic labors of Reverend and Mrs. Willard Metz at Roswell, New Mexico, are making possible a new Pilgrim Church in that needy city. I have enjoyed nurturing the new church at Glendale, Arizona, while they sought a pastor. Reverend C. J. Meyers has graciously assisted until Reverend David Miller recently was installed as full-time leader of the congregation. From a frail beginning of 16 in Sunday School, there are now 18 members, eight of which transferred from Phoenix, First, and 60 enrolled in Sunday School. I was overjoyed two days ago as I attended divine worship at Glendale to find 52 in Sunday School, 42 in morning worship, and 22 in the evangelistic service. It is a thrill to present the new Glendale church to this conference. I assure you that whatever the cost of starting new churches, the experience at Glendale last Sunday persuades me the cost is not too great.

There have been some significant advances in property acquisition. Phoenix, Calvary, under the leadership of Reverend John Dunn, has taken the first step in its relocation program and has constructed a very lovely and commodious parsonage at minimal cost. The whole Pilgrim Family rejoices with them in this accomplishment. The new congregation at Glendale also has purchased a parsonage that will not outgrow its usefulness for many years.

The effort at Roswell, New Mexico, has been greatly augmented by the purchase of a church and parsonage. The entire plant, worth more than twice as much, was secured for \$13,000.00. Brother Metz is caring for the renovation which will require another \$1,500.00. The Yuma Church, under the leadership of Reverend David Miller, made a wise move in securing a neighboring lot to the church. They will have room for expansion. Phoenix, Westside, with Reverend Roy Brown as pastor, found it necessary to use the parsonage for overflow Sunday School attendance while Brother Brown graciously moved into his own home several blocks away.

It has not been as easy to re-establish the church in Albuquerque as it has been to start fresh in Roswell. After nine months of searching for a pastor, a man has finally appeared on the scene who offers to serve without salary. Surely the hand of God is on Reverend Schauner Vance who feels a divine compulsion to go to Albuquerque and establish a Pilgrim Church there. A Beautiful parsonage in tip-top condition awaits the arrival of Brother Vance's fine family.

The Sunday Schools of the District will show a loss of 109. Phoenix Westside, went against this tide and had a gain of 25. Brother Brown and his congregation are to be congratulated. The church membership stands at 441 or 22 less than last year. Under God we must reverse this trend of losses and start on the high road of revival and spiritual awakening. There will be some increase in property equity ... the exact amount to be reported by the statistician.

Three churches, Tucson First, Glendale and Phoenix Bethel paid their D. U. S. F. in full. The failure of total response in this area has left a gaping deficit in District operation and caused us to pay no United Stewardship fund to the General Church.

After nine years of Gospel effort in Arizona, we are convened for this historic conference. In the eyes of the world, this gathering is insignificant, but according to eternal values we are doing big business. Remember, one soul is worth more than all the world. Praise be to God, many hundreds have been blessed and led to Jesus in this district during its short history.

It has been my privilege to attend nine of our ten annual conferences and to watch the Arizona-New Mexico District rise from feeble beginnings and to see it move from strength to strength. The oppressions of Satan have brought stresses but the power of the Holy Spirit has overruled many times.

There is no doubt in my mind that God ordains a destiny for organizations such as ours. Whether we fulfill that holy purpose rests on our corporate choices and decisions. If an organization such as ours is truly alive -- an organism -- and remains alert to God's ordained will, there will always be tremendous

challenge and even crisis. The way we react to these crises will shape the future.

We are without doubt caught up in one of the great sweeps of history. Our age is transitional and revolutionary and by no means a friend of Gospel effort. It is the endtime. The clock of the ages is about to strike the midnight hour.

Added to this is the fact that the Arizona-New Mexico District is not at work in a quiet, conventional part of the country with settled mores, accepted standards of conduct and well-entrenched institutions. We live and work in a dynamic part of the nation exploding with unparalleled growth. This growth and the tremendous migration westward produce shock waves that are continually beating on the church. While we forge a new society and bring together many different cultural and religious patterns there must be a continuous effort to distill a holy unity out of diversity and produce the finest from our sectional differences.

I am persuaded that the Pilgrim Holiness Church must understand her surroundings and swing out into the tide of affairs around us. She must form her own strengths and by the help of God create an atmosphere that will prevent this new society of the Southwest from moral catastrophe. Organized righteousness and moral strength must rise out of a thousand churning circumstances.

If the Pilgrim Holiness Church in this area is to chart a course that will produce spiritual good, she must at this time understand herself, evaluate the changing scene, and arrive at some philosophical and moral guide lines for the future. The way we did it back home is not going to be good enough. Wrestling matches over conflicting methods will only sap our strength. Our efforts must be cooperative or become chaotic.

We must quite ourselves like men and in a statesman-like way unite to choose the overall best for the Pilgrim good. The church must not drift but anchor itself so that while there is "Boom in the Desert," the Pilgrim Holiness Church will blossom as a rose.

In the light of certain circumstances, and after long months of agonizing appraisal and reappraisal, I

have set down some things that to me seem basic to the forward movement of this district. First, if I am going to work under the banner of the Pilgrim Holiness Church, I will first, last and always be unswervingly loyal to the denomination and foster her program at every turn. This does not mean I will not want my church to be better, but I will contribute to her betterment always.

We must as well have an unbending insistence on a sane Gospel message. Our fears and our prejudices cannot motivate us. We cannot cater to either the deadening extreme of formalism or the blasting, blighting extreme of fanaticism. If we cater to an emphasis of so-called standards, we will lose our field. If we foster the time-worn forms and failures of the nominal church, we will lose our force. We must make our churches spiritual workshops, with love in the midst, and even run the risk of being accused by legalists of compromising. Forty years ago, the stentorian-voiced, hell-fire preacher and General Superintendent, George B. Kulp, urged that new converts be received immediately into the church. Really, love can find a way to bring a wide variety of people into a church in a peaceful way.

At the same time, we must be unafraid of moral disciplines. God has constituted authorities and a vital church is sometimes charitably vigorous in dealing with the unruly. Should I be timorous in declaring to you the old-fashioned idea that when I belong to a body such as this conference, I plan to abide by its decisions and it is my bounden duty to perpetuate its regulations in the local church to which I belong. If we individually become a law unto ourselves and decide what we will do or not do, according to convenience, we will create a wild merry-go-round of self will and open a Pandora's box of unhappiness.

How wonderful to have unchanging confidence in the ability of God. Our Lord has a way of reversing failure when faith takes hold. Under divine approbation our adversities can become our advances and our stumbling blocks our stepping stones. Pessimism is soon dissipated by holy optimism and sanctified faith that is unmingled with doubt.

And in the light of what I know God can do, I have unashamed zeal for the enlargement of this district. We must state and restate, affirm and reaffirm, our motivations for this home missionary endeavor. We must grow with these cities so that souls can be saved. We must be breathless in our pursuit to capture men and women for God. Vision is indispensable to progress. The day calls for an aggressive program whether we think we get enough money or not from the Mother Church. I am persuaded we could have triple the allocation received from Indianapolis and still have sparse results. "Self support is the answer to some of our greatest problems." There is no petal-strewn path to the successful creation of a new district and new churches. This business is a thorn road. Personal piety is going to accomplish more than prominence, program, or money. We must be willing to be quietly spiritual rather than flamboyant or faddish. But at the same time, it is Pentecostal to expect many to be swept into the kingdom. But remember, the witnessing, vibrating tongue came out of a quiet prayer meeting in the upper room.

God has untapped resources. He wants us to lay ahold of the promises and dare to be definite with Him. We do despite to the Divine when we fail to have faith. "Nothing lies beyond the reach of prayer except that which lies outside the will of God."

There is work to be done. Let us get busy and do it.

SUPERINTENDENT'S PERSONAL REPORT

I have ministered 108 times, have made 71 visits to the churches and have 75 times of consultation with pastors.

In the process of my labors, 116 other services have been conducted including 15 annual meetings, eight council meetings, 38 board meetings, and 21 prayer meetings. Varied other activities included three visits to Central Pilgrim College for Executive Committee Meetings, attendance at two Superintendent's Conferences and two stints of deputation work for the Department of Church Extension, and one revival.

Miles traveled in the District were 19,104 and out-

side 22,583. My salary was paid in full.

Let me express my deep gratitude to all who have been so kind to me in the midst of these labors and have cooperated for the advancement of the salvation work as carried on by the Pilgrim Holiness Church.

1. LOCAL CHURCH

BE IT RESOLVED that # 2 under Local Church, page 32 be amended to read as follows: Each local church is urged to raise a subscription list to the Pilgrim Advocate equal to its total family membership. (Carried)

2. LOCAL CHURCH

BE IT RESOLVED that a call pastor meeting be conducted between the first two Sundays of March. BE IT FURTHER RESOLVED that in the absence of the District Superintendent the Church Secretary conduct said meeting. BE IT FURTHER RESOLVED that the pastor present a letter of answer to the District Superintendent within 15 days of acceptance or rejection of call. It is understood that each pastor enters into a moral contract when accepting a call to a church and should do everything possible to honor the term of his call. BE IT FURTHER RESOLVED that retiring pastors terminate their services on the 2nd Sunday of June. (Carried as amended, see minutes of conference sittings for amendments).

3. LOCAL CHURCH

In the interest of good business practice BE IT RESOLVED that the offerings received in the local churches be counted cooperatively by both the Secretary and the Treasurer of the congregation or designated parties appointed by the local church board and that the pastor consistently be informed of offering receipts each Sunday. (Carried)

4. LOCAL CHURCH

BE IT RESOLVED that budget monies be forwarded to the District Treasurer by the local church Treasurers no later than the 10th of each month. (Carried)

5. CONFERENCE

BE IT RESOLVED that the District Conference of the Arizona-New Mexico District be held annually on the Tuesday following the third Sunday in May with the following schedule of sessions: 9:00 A.M. - 11:30 A.M.;

1:30 P.M. - 5:00 P.M.; 7:00 P.M. - 9:00 P.M.; or until business is completed. BE IT FURTHER RESOLVED that the meeting of the auxiliaries be held on the day previous to District Conference with the Missionary Society and District Youth Conferences convening simultaneously at the host church at 7 P. M. (Carried as amended)

6. CONFERENCE

BE IT RESOLVED that # 11 under Conference, page 33 be amended to read as follows: (BE IT RESOLVED that the conference year of the Arizona-New Mexico District shall begin April 1 and end March 31 the following year, and that all reports be sent to the District Superintendent and District Statistician by April 15, (1962). (Carried)

BE IT FURTHER RESOLVED that the District Treasurer receipt the local church quarterly, giving credit on the amount of tithe payed by their pastor. The District Superintendent's tithe shall be receipted to the church of his own choice. BE IT FURTHER RESOLVED that 10% of the Pastor's tithe be applied to the International Conference Delegate Fund. BE IT FURTHER RESOLVED that 50% of the Pastor's tithe and 100% of the District Superintendent's tithe shall be applied to the 1964-65 District Operational Indebtedness. 3. BE IT RESOLVED that an offering shall be received in each church during the visit of the District Superintendent and that said offering be applied to the District Superintendent's traveling expense. (Carried as amended)

12. BUDGET

WHEREAS the District Superintendent has presented a new program WAGING THE WAR to spearhead spiritual growth and numerical progress in Pilgrim Home Mission fields; BE IT RESOLVED that the following plan of expansion be adopted for this Church year 1965-66: There is no easy way to wage the relentless warfare that is Church Extension. Still it is a great honor to be in God's army. To endure hardness as a good soldier is one mark of deep devotion to God and dedication to our task. This is an offensive warfare. This is intensive warfare that requires our very best. In wresting territory from the enemy we are assured of Divine Leadership and Divine Strength that will enable us to win the war. To systematically wage this offensive warfare we will do the following during this Church year. 1. We will wage war on our knees with meaning-

ful prayer meetings and the deepening of the devotional life of our ministers and our members. 2. We will wage the warfare locally to enlarge our churches by every possible means enlarging our buildings and drafting new recruits through lay visitation, ladies and mens organizations, CYC, and an increased emphasis on Sunday night evangelism. 3. We will wage war for prosperity through a planned annual budget and a systematic monthly check on income with faithfulness to care for District and General Church obligations. 4. We will wage the war with planned aggression by meaningful District gatherings and regular gatherings of ministers where spiritual life will be cultivated as well as inspiration to achieve will be engendered. Regular reports will be submitted by pastors by the 10th of each month. 5. As a result we shall set as our goal a 10% annual increase in Church membership, Sunday School Attendance, and finance. 6. (first paragraph deleted) THEREFORE the primary emphasis of our District Church Extension effort this year shall be the strengthening and establishing of present existing churches. (Carried)

STANDING RESOLUTIONS OF PREVIOUS
CONFERENCES

LOCAL CHURCH

1. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.
2. Each local church is urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total family membership. (Revised 1965)
3. BE IT RESOLVED that all local indebtedness involving an expenditure of more than \$500, where financing is involved, be approved by the District Council. (1960)
4. BE IT RESOLVED that all non-Pilgrim Evangelists must first have the approval of the District Superintendent or the District Council before being called for evangelistic activity in our churches. (1960)
5. BE IT RESOLVED that no church may borrow from its pastor, nor may any pastor underwrite loans for a church so as to make himself legally responsible as an individual, without the prior consent of the District Council. (1961)

1. The district council and the following committees and boards shall meet at least 30 days prior to the Annual Conference to take care of such work as they have at hand. Conference Action Committee and the Educational and Examining Board.
3. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED, that the Ordination Service take place at 4:00 p.m. the first day of Conference. (1957)
3. The Educational and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for period of two years and one for one year.
4. There shall be a memoirs committee which shall annually list departed members by name, date of decease, and church, for inclusion in the Conference Journal. In case of ministers, there shall be a picture and a brief resume of ministerial labors.
5. BE IT RESOLVED that the district furnish credential forms to each local church conference delegate and alternate to be filled out and signed by the pastor and the church secretary, and sent to the district secretary at least 30 days prior to Conference. (1959)
6. BE IT RESOLVED that the District Trustees and the Statistician be made permanent members of the District Conference. (1959)
7. INASMUCH AS there is such close correlation between the work of the Resolutions Committee and the Ways and Means Committee: THEREFORE BE IT RESOLVED that there be an appointment of a Conference Action Committee of 5 members, which would combine the functions and capacities of the Resolutions and the Ways and Means Committees. (1960)
8. BE IT RESOLVED that there be an appointment of a Building Appraisal Committee: (competent in the field of Appraisal) the function of which shall be to set the value of all church property. BE IT FURTHER RESOLVED that the appointment of this committee be made bi-annually, for the purpose of making a general appraisal of all local church and district property bi-annually. AND BE IT FURTHER RESOLVED that all properties acquired between these appraisals shall be

carried as tentatively appraised by the District Council, until the next general appraisal. (Revised 1961)

9. INASMUCH AS Resolution #6, p. 16 of the 1960 Conference Journal carried and provides that all resolutions and ways and means actions be classified both in presentation and in publication. BE IT RESOLVED that the following general classification, "Report of the Conference Action Committee" and "Standing Resolutions of Previous Conferences", be applied to all past and present conference legislation and BE IT FURTHER RESOLVED that the present "Standing Rules" heading be abolished, and legislation of previous conferences currently listed under this heading be classified under "Standing Resolutions of Previous Conferences" and, BE IT FURTHER RESOLVED that the following specific classifications be applied to all past, present and future legislation: LOCAL CHURCH, CONFERENCE, DISTRICT SUPERINTENDENT, MINISTERIAL, DISTRICT COUNCIL, BUDGET, CAMP, SUNDAY SCHOOL, YOUTH, MISSIONARY ORGANIZATIONS. (1961)

10. WHEREAS the District Council has recommended the moving of the Arizona-New Mexico District into the "ADVANCED LEVEL," THEREFORE BE IT RESOLVED that this conference approve the promotion of the Arizona-New Mexico District into the "ADVANCED LEVEL STATUS." (1962)

11. BE IT RESOLVED that the conference year of the Arizona-New Mexico District shall begin April 1 and end March 31 the following year, and that all reports be sent to the District Superintendent and District Statistician by April 15. (Revised 1965)

12. WHEREAS the District Conference expenses for pastors and delegates is to be paid by the local churches, and WHEREAS this creates a disadvantage for the churches at greater distances from the place of conference, THEREFORE BE IT RESOLVED that the total expense for District Officers, pastors and delegates be pro-rated and paid on a basis similar to the General Conference system, for automobile travel. (1962)

13. WHEREAS the District Superintendent has presented the Quadrennial Pattern for Progress for the 1962-66 period to all pastors and churches of our district, THEREFORE BE IT RESOLVED that the Pattern for Progress be adopted by the Conference. BE IT FURTHER RESOLVED that the following goals be adopted as the Local Church and Conference Goals for the coming year: 1. Pattern for Progress Growth Stand-

ards - 10 % Sunday School Gains, 10% Church Membership Gains, 10% Local Church Financial Gains. 2. Fostering of Youth Society, Women's Missionary Society, Men for Missions, and creation of Christian Youth Crusades. 3. Lay Visitation Evangelism in each Local Church. 4. New Missions, Branch Sunday Schools and Prayer Meetings throughout the District. 5. Use of Probationary and Junior Membership programs. 6. Payment of all Budgets in full and by the month. (1962)

DISTRICT SUPERINTENDENT

1. BE IT RESOLVED that the District pay \$200.00 per month on salary of the District Superintendent; BE IT FURTHER RESOLVED, that the District Superintendent be remunerated for meals and lodging incidental to travel. (Revised 1963)

MINISTERIAL

1. Before licensed or ordained ministers coming from other denominations shall be received into the local church, the pastor shall consult with the District Superintendent and Council regarding said minister. (Revised 1965)

2. Each pastor is to be granted a two weeks vacation with full salary.

3. INASMUCH AS several of our districts have a group hospitalization, surgical, and medical insurance plan, and since a number of the district pastors have expressed a desire for such a plan, BE IT THEREFORE RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical and medical plan. AND BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the district pay \$5.00 per month to be applied to the District Superintendent's premium. This resolution is recommended first for discussion by the committee with the added recommendation that the lay delegation be given the privilege of discussion. (1959 - Revised 1962)

4. BE IT RESOLVED that when ministers come to this district from other denominations, that the Executive Officer of the transferring minister be contacted by the District Superintendent asking for a recommendation, to be in the hands of the District Council at least 30 days prior to moving date. AND BE IT FURTHER RESOLVED that the transferring minister be interviewed by the District Council prior to reception of his credentials. (1959)

DISTRICT COUNCIL

1. BE IT RESOLVED that each council member be paid 5 cents per mile for travel expense to and from council meetings and that when several members travel in one car, the driver be paid an additional one cent per mile for each council member travelling with him. (Amended 1961)

2. WHEREAS those who serve as District Secretary and District Treasurer must devote considerable time to their duties, and INASMUCH AS other districts comparable in size to our district pay their Secretary and Treasurer token remunerations, THEREFORE BE IT RESOLVED that the yearly honorarium for the District Secretary be \$60.00 and the District Treasurer \$75.00. (1962 - Revised 1964)

BUDGET

1. BE IT RESOLVED that all monies raised in local churches for district, general or Bible College purposes be disbursed through the District Treasurer, and only such monies as are processed accordingly may be credited to the local churches on the District Treasurer's report.

CAMP

1. WHEREAS it appears that the cost of owning and maintaining a camp ground is prohibitive; BE IT RESOLVED, that the Conference instruct the Council to take steps to dispose of the real property on the camp ground and that the proceeds be applied as follows: 1. Satisfy the claims of cabin owners, 2. Camp ground indebtedness, 3. Balance if any to be put in a Camp Fund. (1960)

2. BE IT RESOLVED that the district promote a week-end summer camp meeting on rented grounds beginning in July of 1964. (1963)

SUNDAY SCHOOL

1. BE IT RESOLVED that the work of the District Sunday School Board be financed by offerings from the District camp Sunday School and Sunday School conventions, and BE IT FURTHER RESOLVED if a need for additional funds for this Board arises, a request shall be made to the District Council for appropriation. (1961)
