



Proceedings

FIRST SITTING

The Twenty-first Annual Conference of the California District of the Pilgrim Holiness Church met at the Rees Memorial Pilgrim Holiness Church, Fifth and Howard Streets, Pasadena, California, on July 12, 9:00 a.m., with our General Superintendent, Rev. Walter L. Surbrook in the chair.

Rev. W. H. Neff, District Superintendent, was in charge of the devotional service. Rev. R. V. Steelhead led in singing "Where He Leads Me I Will Follow Still." Rev. Katharine Hollowell and Rev. Forrest Benner led to the Throne in prayer. Closed by all singing, "A Charge To Keep I Have."

General Superintendent, Rev. Walter L. Surbrook, was introducted to the Conference by Rev. W. H. Neff, District Superintendent. Rev. Surbrook addressed the Conference from the 4th chapter of 2nd Corinthians, taking for a text the 5th verse, "For we preach not ourselves but Christ." A very helpful and instructive message was given.

The Secretary called the roll of Delegates. Forty-seven responded from the Ministerial and Deaconess, and Twenty-one from the Lay Delegates.

It was moved, seconded and carried that the Conference bar consist of the first seven rows of seats in the auditorium and the platform.

It was moved, seconded and carried that the hours of session be 9 a. m. to 12:00 noon, 1:00 p. m. to 4:00 p. m., and 7:00 p. m. to 9:00 p. m.

It was moved, seconded and carried that the District Superintendent appoint members to fill vacancies on committees, as needed.

The following were appointed:

The District Superintendent, Rev. W. H. Neff, gave his personal report, which was heartily accepted with a rising vote of appreciation.

At this time Rev. Neff presented three new churches to the Conference, as follows: Rosemead, Rocklin, and Inglewood. The delegates of these new churches were given seats within the Conference bar.

The District Treasurer, Rev. Elmer R. Hall, gave his report. It was moved, seconded and carried that his report be accepted by each responding with a hearty Amen.

Rev. and Mrs. Forrest Benner, pastors of the Phoenix church, were presented to the Conference by the Reception Committee.

It was moved, seconded and carried that the order of business at 7:00 o'clock tonight be the election of officers.

It was moved, seconded and carried that the Conference recess until 2:00 o'clock. The sitting was dismissed with prayer by District Superintendent Rev. W. H. Neff.

SECOND SITTING

The second sitting opened at 2:00 o'clock with Rev. O. C. Myers leading in singing the song, "I've Anchored My Soul in the Haven of Rest." Rev. John Hess led the gathering to the Throne in prayer.

The District Secretary read the names of Rev. Forrest Benner and Rev. Mrs. Ruth Hampton, as recommended to this Conference for membership. It was moved, seconded and carried that they be accepted into our fellowship.

Rev. and Mrs. Coleman Avery, members of the North Carolina District, were introduced to the Conference. It was moved, seconded and carried that we accept Rev. Avery into our Conference.

The report of the Statistical Committee was given by Rev. Forrest Benner and Rev. Robert Hahn. It was moved, seconded and carried that we accept this report. (See Reports.)

The report of the Auditing Committee was given and accepted by the Conference. (See Reports.)

Rev. Elmer R. Hall, Chairman of the Ways and Means Committee, gave report.

It was moved, seconded and carried that Resolution No. 1 be accepted. Moved, seconded and carried that Resolution No. 2 be accepted. Resolution No. 3 was lost. Moved, seconded and carried that Resolution No. 4 be accepted.

A partial report of the Educational and Examining Board was given. It was moved, seconded and carried that this report be accepted.

A personal report of the work done at Tucson, Arizona by Brother and Sister Abbott, was read by the Secretary. A cheery Amen was given by the Conference for faithfulness in the labors of the workers engaged there.

A partial report of the Resolutions Committee was given by the Chairman, Rev. R. E. Hahn.

It was moved, seconded and carried that we rescind the order of the day and proceed to the election of officers.

It was moved, seconded and carried that the District Superintendent appoint tellers for the balloting. Those appointed were as follows: R. W. Josey, W. C. Mays, R. E. Hahn, Joe Mayfield, F. T. Benner, and Coleman Avery.

The ballots cast for District Superintendent resulted in Rev. W. H. Neff being overwhelmingly re-elected.

The ballots cast for the election of Assistant District Superintendent resulted in the re-election of Rev. Roy E. Morgan.

The Ballots cast for the election of District Secretary resulted in the re-election of Rev. Garnett L. Palmer.

The District Council nominated Rev. Elmer R. Hall to the Conference for District Treasurer. Rev. Hall was unanimously re-elected by a vote of acclamation.

The ballots cast for the additional Council members resulted in the election of Rev. P. W. Thomas, Rev. F. W. Henry, and Rev. G. A. Moran.

It was moved, seconded and carried that the time be extended to 5:15 p. m. for the election of a member to the Educational Committee. Moved, seconded and carried that the vote be by acclamation. Rev. James M. Dooley was unanimously re-elected.

The ballots cast for the additional member to the Examining Committee, resulted in the election of Rev. F. W. Henry.

The ballots cast for the election of a member as District Trustee resulted in the election of Brother M. T. Bufkin.

Moved, seconded and carried that we adjourn until 7:00 p. m.

Conference adjourned with prayer by Rev. R. E. Morgan.

THIRD SITTING

The third sitting convened at 7:00 o'clock with Rev. Surbrook in the chair.

Rev. R. V. Steelhead led the Conference in singing an inspiring song and Rev. Ralph Haines led the Conference to the Throne in prayer.

The Secretary read a letter of Greeting from Rev. Paul S. Rees of the Covenant Tabernacle Church in Minneapolis, Minnesota. It was moved, seconded and carried that this greeting be printed in the Minutes.

It was moved, seconded and carried that this Conference send greetings to Sister Seth C. Rees.

A further report was given by the Educational and Examining Committee. It was moved, seconded and carried that this report be accepted.

The Resolutions Committee recommended that Resolutions Number 1 and 3 of the 1942 Minutes be deleted. Moved, seconded and carried that this be accepted.

Mrs. Katharine Hollowell, a member on the Committee on Memoirs, read a report on the death of Rev. H. L. Blake.

A report was read by Rev. Robert E. Hahn, the Executive Secretary of the Young Peoples Society of the California District. It was moved, seconded and carried that we accept this report.

A report was given on Sunday Schools visited and Out-look on District, by Rev. George Moran. This report had a very encouraging note.

It was requested that each Church state the number of copies of the Conference Minutes it will want, also the number of subscriptions to the Advocate it will try to secure for the coming year.

REPORT OF THE DISTRICT SUPERINTENDENT

To the Annual Conference of the California District of the Pilgrim Holiness Church: Christian Greetings:

We have come up to another Conference through the grace and mercy of God. Let us rejoice and be glad together.

The past year has been an eventful one throughout the world, and the general dislocation of things, by reason of the necessary war effort, has naturally affected the work of the church; it has been sometimes helpful and other times harmful. Certain gains have been realized for which we are grateful; however, we hasten to say that they have not been of such proportion as to lead to either personal or District pride.

You will see by the Treasurer's report that this has been the best year in the history of the past fifteen years. That is true, likewise, of the individual churches. The reason is, of course, the general increase of funds throughout the country, and the faithfulness of our people in stewardship of the increase.

At the point of membership, despite a determined effort to increase our number, and despite an increase in the number of church units, we have nevertheless suffered a net loss of five members. This is due to the fact that several of the churches found it advisable to cleanse their rolls.

While the total membership has not this year, for the first time in six or seven years, shown increase, that unfavorable actuality is offset by the encouraging fact that the District has organized three new Churches this past year: at San Gabriel, Inglewood, and Rocklin. And things are shaping up well for immediate organization at Tuscon, Arizona; at Oakland prospects are encouraging. While two of these churches are the result of the migration of Pilgrims, the heartening fact is they give us two more working centers. Thus five more red points are set up on the map of California where Pilgrims are working for God and the Church. We are thankful for this enlargement of the borders of our District.

Concerning the properties of the church much could be said, buildings have been improved, mortgages paid, etc.—and this has been no little item. The pastors' reports will show their gratifying improvements. This is to **their** credit. Together, pastors and superintendent have been working on this matter of paying off mortgages and making improvements while money is flowing more freely than usual.

I have preached 208 times, and have seen about 250 seekers for the grace of God. I have visited each church at least three times. It has been impossible to go on a Sunday each time, because **first**, work in these new fields has demanded many of my Sundays; and **second**, I have been repeatedly invited to fill the pulpit of several independent churches and I have felt it wise to accept these invitations.

The District has done well by me financially, \$2,329.88. I am very grateful. I take the Advocate. I am grateful for the fine support of the people and pastors.

May God bless us with vision and power to carry on in the ominous days ahead!

1

It is recommended that the District Conference create the office of District Sunday School Secretary, which person is to be nominated by the District Sunday School Committee, the nomination to be ratified by the District Council, and said secretary shall be an ex-officio member of and responsible to the District Sunday School Committee.

2

Inasmuch as there is a great need for trained Sunday School teachers, BE IT RESOLVED that the District Sunday School Committee be empowered to select and promote a course of training for Sunday School teachers, and a system of certificate awards to be presented to those satisfactorily completing the prescribed course.

WHEREAS, there is a need of prepared Sunday School workers in all our churches, BE IT RESOLVED that an hour each day be set aside during the Camp Meeting, to be known as the Sunday School Worker's Hour, the body of which is to be selected by the Sunday School Committee in Conjunction with the District Superintendent.

BE IT RESOLVED that all plans for the Construction or remodeling of church buildings be presented to a committee on which there shall be an architect, a builder, a Sunday School man, and a financier for their suggestions.

WE RECOMMEND that there be attached to all recommendations for renewal or advancement of license, a copy of the Licentiates report of his or her ministerial labors for the past year and further that these recommendations be in the hands of the Educational and Examining Committee at least one week before the opening of Conference.

RESOLUTIONS IN EFFECT FROM PREVIOUS YEARS

1

WHEREAS our next General Conference does not convene until June, 1946, and also that our present assessment if faithfully paid during this Quadrennium will be in excess of the needed amount for our apportionment,

We recommend that this assessment be reduced to 15 cents per member per year.

2

RESOLVED that our District Superintendent or his Assistant shall, when possible, conduct quarterly meetings at each church, at which time he shall preach a Gospel sermon and administer the Sacrament.

3

RESOLVED that the Educational and Examining boards shall meet with the candidates for District License during the Camp in order to conserve time during the District Conference.

4

WE RECOMMEND that another two-day District Sunday School Convention be held, the date to be fixed by the District Sunday School Committee and the District Council.

5

Furthermore, BE IT RESOLVED, that the District Sunday School Committee be authorized to provide a display of Sunday School and Christian literature for sale at the Camp Meeting and Sunday School Convention.

6

WHEREAS we now have a standing Statistical Committee to function during the Assembly year, BE IT RESOLVED that all reports be made in full and sent to the Statistical Committee not later than one week before the District Assembly date.

7

RESOLVED that since some of our churches seem to have no definite system of raising their general, district, and local expenses, THEREFORE BE IT RESOLVED that each Church adopt the budget system and make an effort to raise the same.

8

RESOLVED that no pastor employ an evangelist without the endorsement of the District Superintendent.

9

RESOLVED that a love offering be taken monthly for the pastor of each church, and that the delegate see that this is done.

0.1

RESOLVED that before Licensed or Ordained Ministers, coming from other churches, shall be received into the local church, the pastor shall consult with the District Superintendent and Council regarding said minister.

11

RESOLVED that every pastor set a numerical goal in every department of his church and strive faithfully by the aid of the Holy Spirit to realize such goal before the Assembly year will have closed.

12

WE RECOMMEND that each self-supporting church put forth a home missionary campaign and try to establish at least one new church.

13

WHEREAS it is already our practice to alternate our home and foreign missionary offerings throughout the year, WE RECOMMEND that the months of August, October, December, February and April of each year be designated as the months for our home missionary offerings.

14

RESOLVED that we have a Camp Meeting Association with membership dues of \$1.00 per year, and that the District Superintendent present this Association to the people on his first visit to every church on the District and get as many members as possible.

15

RESOLVED that 10 per cent of all offerings except foreign missions, home missions, building fund, and evangelistic offerings be sent to the Treasurer.

16

BE IT RESOLVED that this District require that our District Superintendent devote six months of his time to NEW HOME MISSIONARY WORK, under the direction of the District Council, giving him five months to visit the Churches and one month's vacation with pay.
