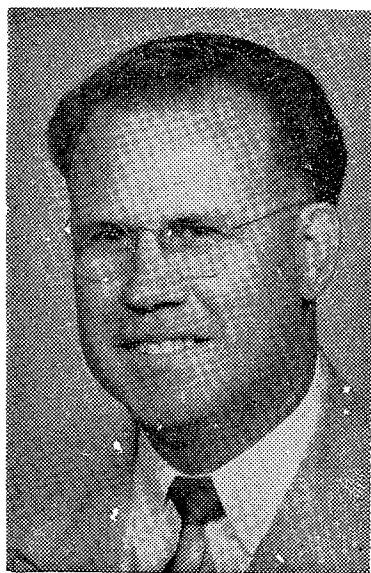
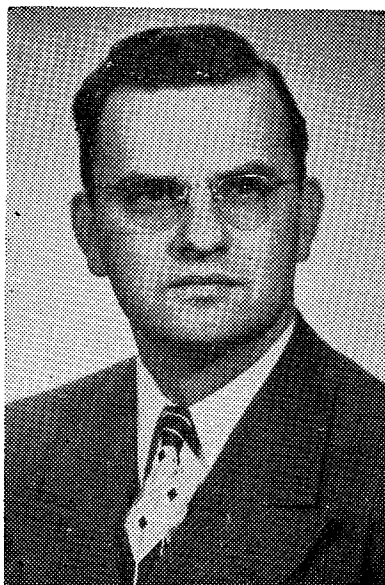

CALIFORNIA ANNUAL DISTRICT CONFERENCE

Journal of Proceedings

First Sitting, June 26, 1958

The thirty-sixth conference of the California District of the Pilgrim Holiness Church convened at El Monte, California, at 9:00 a.m., Thursday, June 26, 1958.

Conference opened with prayer by District Superintendent Lundy Hill. Congregational singing was led by Clifford Morgan, after which Thomas Lee led in prayer.

The District Superintendent introduced Rev. R. G. Flexon, General Superintendent, presiding officer of the conference.

Brother Flexon brought a stirring message on the subject "Good Organization," using as Scripture reference I Corinthians 12. The church is likened to the body, with the different members filling appropriate and necessary places. Each of us in our church organization has his place to fill in order that the body may function properly.

To have good organization we must—1. organize, 2—deputize, 3—supervise. Some benefits of good organization are:

1—Satisfaction of fellowship,

2—Appeal to permanency (Independent work is built around personalities; organization is built upon principles.)

3—Ease of shared responsibility,

4—Power of added ability.

In order for an organization to function efficiently we need:

1—Well defined lines of administration,

- 2—Faithful observance of all rules and regulations of the church and district,
- 3—Faithfulness in taking corrective measures against things that are wrong,
- 4—Pastors and people who are in sympathy with the program of the church who will "sell" the program to others,
- 5—Well defined objectives,
- 6—Men to operate the organization—men who: a. are prayerful, b. have a vision, c. are loyal, d. are trustworthy, e. have ambition without being ambitious, f. live to serve, g. have conviction of purpose, who do not seek the praise of men, h. are not influenced by money, i. will preach God's message, j. are filled with the Holy Ghost and have a compassion for the lost.

Brother Flexon called the conference to order at 10:30 a.m. Upon motion, roll call was postponed until the evening session. Conference bar was designated as the first ten rows of seats.

Time for conference sessions as set by previous conference was announced as follows: 9:00 a.m. - 12:00 noon; 2:00 - 4:30 p.m.; 7:00 - 10:00 p.m.

Motion carried that we grant a seat within the conference bar to pastors and delegates from churches which have not been able to pay their budgets in full but have made a conscientious effort to do so.

The District Superintendent's report was read and received.

Report of the Assistant District Superintendent was read and accepted.

A recommendation from the District Council was read that the following be received by the conference:

Rev. Donald Pownell, ordained minister from the Pennsylvania-New Jersey District,

Mrs. Rae Gale Pownell, ordained deaconess from the Pennsylvania-New Jersey District.

A motion carried to receive the above.

Brother Flexon personally welcomed the Pownells who gave brief words of testimony.

Financial report of District Young People was read and received.

Upon motion conference recessed at 11:40 a.m.

Lundy Hill dismissed with prayer.

Second Sitting

The second sitting of the conference opened at 2:00 p.m., Thursday, June 26, 1957, with the congregation singing "Amazing Grace."

Following a period of silent prayer, Rev. Flexon led in petitioning the throne of grace.

Report of the Executive Secretary of Pilgrim Young People was read and received.

Partial report of the Resolutions Committee was presented and acted upon as follows:

Resolution No. 13—carried.

Roll call of churches was made with pastors or delegates responding by designating the copies of the District Minutes desired, and by stating a goal of subscriptions or renewals to the PILGRIM HOLINESS ADVOCATE to be secured in the next twelve months.

Partial report of the Educational and Examining Board was read and accepted. (See Appendage.)

The Reception Committee introduced Rev. E. L. Horton who is transferring to this district from the Pennsylvania-New Jersey District.

Partial report of Ways and Means Committee was presented and acted upon as follows:

Resolution No. 1—carried.

Motion carried at 3:00 p.m. to recess until 3:30.

Conference re-convened at 3:30 p.m. with singing of "Tis So Sweet to Trust in Jesus." Rev. R. G. Flexon called the conference to order.

Bro. Martin Horine requested the privilege of making a comparative report of the progress of the District Youth work. Report was received with interest.

Motion carried to adjourn at 3:55 p.m.

Rev. Thomas Lee dismissed with prayer.

Third Sitting

The third sitting opened at 7:00 p.m., June 26, 1958 with group singing led by Rev. Steelhead. Rev. Thomas Hamon led in prayer.

Brother Flexon spoke briefly, noting important legislation passed and objectives outlined by the recent General Conference, challenging the conference to covenant, by the help and grace of God, to do greater things this coming quadrennium than ever before.

Motion carried that we dispense with the roll call and accept the conference registrar's records as official for this conference.

Minutes of previous sittings were read and approved.

Motion carried that the first order of business be the election of officers.

The District Superintendent appointed the following tellers: Paul Miller, Gene Daffern, Joe Fillmore, Omar Fenton, Martin Horine, Ralph Pynchon. Clarence Black was appointed scribe.

Rev. Flexon led in prayer for God's direction in the election of officers.

Ballots were cast for District Superintendent.

Report of balloting for District Superintendent declared Lundy Hill elected.

Ballots cast for Assistant District Superintendent declared Thomas Lee elected.

Council nominations for District Secretary were: Edward Bickmore, Max Greene, Garnett Palmer. Edward Bickmore was elected.

Council nominations for District Treasurer were: Thomas Hamon, Bruce Chamberlain, William Rugh, Robert Rogers. Thomas Hamon withdrew his name. Bruce Chamberlain was elected District Treasurer.

Ballots were cast for three advisory members of the District Council.

Motion carried that four tellers be excused to count the ballots.

Council nominations for District Trustee for a term of three years were: Richard Bufkin, Bob White, Everett Tompkinson. Richard Bufkin was elected.

Council nominations for District Sunday School Committee—one to be elected for a term of three years—were read as follows: Daisy Johnson, May Heck, Conrad Park, Gene Daffern, Eldon Stohr. Report of balloting declared no election. May Heck withdrew her name. Gene Daffern was elected to serve on the Sunday School Committee.

Report of balloting for three advisory council members declared Clifford Morgan and Max Greene elected.

Motion carried that the conference vote on the next three highest names for additional council member.

Motion carried that the time be extended to complete the election of conference officers.

Thomas Hamon was elected advisory member of the District Council.

Motion carried that the Educational and Examining Board be separated into two boards—the Educational Board and the Examining Board.

Examining Board nominations—one to serve for a term of three years—were: David Olson, E. W. Hall.

Motion carried that tellers retire to count the ballots cast.

Nominations for Educational Board, one to serve for a term of three years, were: Paul Beck, Max Greene. Paul Beck was elected.

Nominations for four members of the District to serve on the school board—two for a term of three years, one for two years, one for one year—were read as follows: Thomas Hamon, Martin Horine, Edward Bickmore, Fred Wells, Joe Fillmore, Max Greene, Bruce Chamberlain, Paul Beck, Conrad Park, Clarence Black, David Olson, Richard Bufkin.

Motion carried that the two names receiving the highest number of votes be elected to serve for three years; the next highest for two years; the next for one year.

An amendment to the motion, that the election of school board members be by plurality vote, carried.

Motion carried that tellers retire to count the ballots.

Motion carried that tellers be excused to count ballots cast for Missionary Committee.

Ballots cast for Sunday School Promotional Secretary indicated no election. Motion carried that the two highest candidates be voted upon. Both candidates withdrew their names. Motion carried that the District Council appoint the Sunday School Promotional Secretary.

Results of balloting for school board members declared Thomas Hamon and David Olson elected for a term of three years, Paul Beck for two years, Martin Horine for one year.

Report of balloting for District Missionary Society Committee declared Ione Hall, Beulah Boyd and Helen Larson elected.

Motion carried that matters pertaining to the budget be scheduled as the first item of business at the 9:00 a.m. sitting Friday, June 27.

Conference adjourned at 11:10 p.m.

Max Greene dismissed with prayer.

Fourth Sitting

The fourth sitting of the conference opened at 9:00 a.m., Friday, June 27, 1958, with congregational singing led by Thomas Lee. Paul Beck led in prayer.

Brother Flexon brought a brief devotional message from Luke 9, noting some reasons why some individuals did (and do) not become disciples of Christ: 1. They are bound to earth's comforts, 2. to earth's customs, 3. to earth's companions.

Minutes of the previous sitting were read and approved.

Partial report of the Ways and Means Committee was presented and acted upon as follows:

Resolution No. 3—carried.

Motion carried to consider plan A of Resolution 4. Motion was made to adopt plan A. Motion was made to amend plan A to read that all monies in excess of \$5,000 raised for Building fund would be assessed at the rate of 10%, the first \$5,000 to be exempt. Amendment carried.

Motion carried to table the motion to consider plan A, and to proceed to consider plan B of Resolution No. 4.

Motion to adopt plan B was tabled.

Motion carried to remove from the table both motions relative to adopting plans A and B and vote by ballot to accept either plan A or B.

Motion carried to refer the matter of finance to the committee for drafting of one recommended plan.

Motion carried that we take a secret ballot as to which type plan, budget or percentage, is preferred.

The Reception Committee introduced Rev. Clinton Jones, President of the Wesleyan Methodist Church of the California District, and Rev. Wilson, Wesleyan Methodist pastor, who were granted seats within the conference bar. Both ministers gave words of personal testimony.

Partial report of the Auditing Committee was read and approved.

District Treasurer's report was read and received.

The fourth sitting adjourned at 12:00 noon.

Rev. Max Greene dismissed with prayer.

Fifth Sitting

The fifth sitting opened at 2:00 p.m., Friday, June 27, 1958.

The Ordination Service was opened with prayer by C. L. Morgan. The congregation, led by John Newby, sang "Rock of Ages," and "A Charge to Keep I Have." Paul Beck led in prayer. Portions of Scripture were read by Thomas Lee, Max Greene, and Bruce Chamberlain.

Candidates for ordination were presented by the District Superintendent as follows: Robert Rogers, Joy Spencer, and Ralph Pynchon, ministerial; Jean Hogle and Rebecca Newby, deaconess.

General Superintendent Rev. R. G. Flexon gave timely instruction to the candidates, presenting applicable comments on the practical applications of I Timothy 3:1-8. Brother Flexon then read the ordination charge. As the candidates knelt at the altar, the ordination council, composed of R. G. Flexon, Lundy Hill, Thomas Lee, Paul Beck, Clifford Morgan and Max Greene laid hands on the candidates as each was ordained by Brother Flexon. Prayer was offered by Rev. Flexon. While singing "Blest Be The Tie," the congregation passed by and extended best wishes and prayers for God's blessing to the newly-ordained ministers and deaconesses.

Rev. Flexon read a telegram telling of the homegoing of Edna Neff, wife of our General Superintendent William H. Neff.

Minutes of the previous sitting were read and approved.

Final report of the Auditing Committee was read and approved.

Motion was made that the District Council send a representative from this district to the funeral of Sister Neff.

Motion carried to extend the time to 5:00 p.m.

Final recommendations of the Educational and Examining Boards were read and approved. (See appendage).

Motion carried that the Statistical Report be received without its being read.

Motion carried that the District Council be authorized to act on any unfinished business of the conference.

Conference adjourned at 5:05 p.m.

Rev. Flexon dismissed with prayer.

In Memoriam

MRS. EVA M. DAUEL

Mrs. Eva M. Dauel in girlhood was baptized and joined a church but knew nothing of saving grace.

In 1907 in Denver she was saved, and married to Rev. Carl H. Dauel, by whose side she stood for over fifty years in evangelistic and pastoral work. Churches served: Rocky Ford, Colorado, Whittier and Olinda, California. Several years they Superintended Fifth Street Mission, Los Angeles, where many were redeemed. A number of years they served the combined District of California, Arizona and Oregon as Superintendent. After Bro. Dauel's death in 1946 she assisted Rev. Katharine Hollowell, her sister, in the pastorate of Adams Memorial Church.

She passed away December 7, 1957.

Her cheery spirit and smile warmed the hearts of the friends who came to call. She was restful and resigned to go.

REV. JOHN H. KIEHL

Rev. John H. Kiehl was born in Pennsylvania on April 23, 1876 and passed away in Orange, California on September 11, 1957 at the age of eighty-one years.

As a small boy he moved to Kansas with his parents and later to Minnesota. On July 4, 1903 he was converted and later sanctified and called to preach the gospel. He labored several years doing pioneer and missionary work in the jackpines of Minnesota.

He was united in marriage to Edna Bills on December 22, 1897. To this union were born five sons, two of whom, Harry and Fred Wells, are serving on the California District. His wife passed away in December, 1914.

On December 11, 1916 he was married to Miss Fern Hoare of St. Paul, Minn. He continued in missionary work until October, 1917 for the Christian Missionary Alliance Church. He later moved to Santa Ana, California, where in August, 1918 he was called to pastor the Holiness Church (now a part of the Pilgrim Holiness Church) at Ojai, California, where he ministered for eight years. Soon after uniting with the Holiness Church he was elected to serve as an Elder on the general board, and continued in this capacity until 1946, when the Holiness Church amalgamated with the Pilgrim Holiness Church. During the above mentioned period of time he served as pastor of San Dimas, Riverside, and Santa Ana, California churches, and for a time as superintendent of the work in Kentucky.

Brother Kiehl was a man of God and was loved greatly by people wherever he pastored.

REV. ALBERT G. CROCKETT

Rev. Albert G. Crockett, a member of Rees Memorial Pilgrim Holiness Church, passed away July 12, 1957.

Bro. Crockett was a native of Illinois, but had resided in the vicinity of Pasadena since 1942.

Rev. Crockett came to the Pilgrims from the Nazarene Church. He spent many years pastoring the Pilgrim Churches in California. He was a faithful and loyal member of the Rees Church, whenever possible for him to attend.

PEARL BANGLE BOECK — 1875-1957

Pearl Bangle Boeck was born at La Fayette Springs, Mississippi, on November 26, 1875. At an early age she gave her heart to the Lord and when she moved with her family to California she joined the Holiness Church at Murietta.

In 1898 she was joined in marriage to Charles A. Boeck and they started their Christian home at Redlands, California. Many souls have been saved in their home because of their Godly example and Christian testimony.

Sister Boeck was an active member, a Deaconess, Sunday School Superintendent and teacher.

They moved to Los Angeles in 1921; the door opened to work among the Japanese people. The Lord blessed in this work for 19 years. During this time Sister Boeck was ordained by the Pilgrim Holiness Church as a Home Missionary and was given Life Credentials which she prized and treasured up to her death.

She will probably be best remembered by many who found Christ in the Children's Meetings which she conducted each Spring and August Camp Meeting. Her interest in Children began on the old Downey Camp Grounds, later at the Arroyo Seco Grounds and finally her love for the School children on the El Monte Grounds.

Christ was the center of her home life and for 59 years she was a happy and devoted Wife and Mother. She went to sleep in Jesus on September 1, 1957.

It is interesting to note that she was a faithful member of the Holiness Church for over 70 years, true to the Holy Bible and the Church Book of Rules.

Her testimony for Christ lives on.

(MRS.) FLORENCE GENEVIEVE LEE — 1859-1958

(Mrs.) Florence G. Lee went to her heavenly reward March 17, 1958, at Vancouver, Washington. She was 98 years of age. Sister Lee was an ordained minister of the California District of the Pilgrim Holiness Church, though she had been out of active service for several years.

She and her husband, Rev. William H. Lee, who passed away in 1919, were the founders of the People's Mission Church, which in 1925 merged with the Pilgrim Holiness Church to form the Rocky Mountain District.

Following the conversion of her husband and his call to the work of God, they sold all to follow Him.

Sister Lee was a gifted and versatile woman who seemed able to turn her hand to many things.

More than 30 years of her life were spent in intense and active labors for the Lord.

Even in retirement she never lost interest in the work of God.

Her life and labors of love will live on.

RATIBEH SHOUCAIR

On April 19, 1958, Miss Ratibeh Shoucair went to be with her Heavenly Father. For this she had been preparing for many years. She was an Arab Christian, highly esteemed and loved by all the Pilgrims who read of and prayed for her work among her own people.

Sister Shoucair labored at and operated the Good Shepherd school in Bethlehem for over fifty years.

Several years ago she came to California to take care of her brother's children, whose mother had died. She stayed four years. During this time she lived next door to members of the Holiness Church, which amalgamated with the Pilgrim Holiness church, and through their lives and examples she was led into the experience of holiness.

When she returned to Bethlehem to resume her teaching, the Holiness Church took over the support of her and the school.

We learned that through the years Sister Shoucair has taught over four thousand girls besides some boys.

Sister Shoucair sacrificed much for the school, using only a small amount from her meager salary to barely meet her needs and turned the rest into the work.

She has gone home, leaving behind very little of earthly possessions, but an untold wealth of Christian training and influence in the lives of many people.

EDNA MAE NEFF

While the 1958 conference was in session, Edna Neff, wife of our General Superintendent, passed away. Our deepest and sincere sympathies are extended to our dear General Superintendent and family during this time of bereavement. Sister Neff, a faithful and never tiring Pilgrim passed away June 27, 1958 at 10:20 a.m. at her home in Indianapolis, Indiana. A memorial to Sister Neff will appear in the 1959 conference minutes.

A number of the California Pilgrims have just returned from one of the most history-making General Conferences ever held by the Pilgrim Holiness Church. The conference was marked by an unusual manifestation of the presence of the Holy Ghost. The reports revealed some progress made in all the departments of the church. Per capita giving was at an all time high. The California District ranks third with a per capita giving of \$258.86 during the past four years. Goals were presented and accepted for the next quadrennium which no doubt will be presented to this conference by our General Superintendent. I trust this conference will give an enthusiastic support to our general conference action. The strong vote that was given in favor of merging with the Wesleyan Methodist Church was indeed remarkable. Let each of us pray that God's will be done as the Wesleyans proceed to vote on this matter at their General Conference next year. However, we must continue to work, pray and plan to build a stronger Pilgrim work as if this merger may never be realized.

It is my sincere prayer that this conference shall be moved upon by the Holy Ghost and that He shall give understanding and guidance throughout this very important gathering.

I. Conference Activities

A. The Ministerial Meeting was one of the highlights of the past year. The attendance was very good and the ministry of Rev. Joshua Stauffer excellent.

B. The Sunday School Convention under the direction of Dr. P. F. Elliott was worthwhile. Some of our church schools have shown a good increase in attendance during this year.

C. Mile High Pines Youth Camp is making good progress. The young people are proceeding with a building program and are looking forward to a good

year of summer camps.

D. Western Pilgrim College has had a difficult year financially, however, I believe the school has experienced one of the best years spiritually, especially among the student body. After giving ten years of service to the school, Dr. C. W. Thomas has resigned to accept a position on the staff at Owosso College. Our prayers go with the Thomases. The School Board has called Dr. Wm. S. Deal to serve as school president. Let us as the California District support Brother Deal wholeheartedly. The task he faces is a big one and can only be accomplished by the cooperation of all of us. The school is not separate from the District, but a part of our district. To neglect either would be disastrous.

E. Generally, our pastors and laymen are standing by loyally and are giving their time and means to see the work go forward.

II. Church Progress

The Corona church has remodeled the exterior of their building. I am sure this will do much for the church's standing in the community.

The Dixon Pilgrims have started their parsonage.

El Monte Church is building a much-needed Sunday School unit.

Escondido has finished and dedicated a lovely new parsonage.

Pomona is building another Sunday School unit.

San Fernando Pilgrims will soon complete their beautiful church and Sunday School plant.

Other churches have made improvements in many areas that have made their ministry more effective in their sphere of service.

Highest membership gain shown is Riverside with a gain of 33.

Second highest is Long Beach with a gain of 15.

A few of our churches have made noticeable gains in attendance in the worship services and in the prayer services. This is very gratifying to both pastor and people.

III. Church Extension

Rev. Russell Johnson and his good wife have opened up a new work in Solano Beach. They are worshipping in a rented building. The work certainly looks encouraging. A very good Sunday School has been organized and the preaching crowd is gratifying. The District is paying half of the rent and the group is making up the balance.

The District is still carrying the payments and taxes on the Yucaipa property. The church at Yucaipa has taken on new life. Brother and Sister McCoy have sacrificed much financially to pastor the work there. The Lord has helped them and they are building a good foundation. The church has more than enough members to date to organize.

The Glendora project has at last begun to materialize. After many discouraging setbacks the property was finally cleared and plans are being drawn for the new church. Work will be started soon on the new building. The corporation which was formed by Mr. Black, Mr. Klein and your superintendent is furnishing the money for this project.

Plans are being made to send Rev. Paul Miller into Sacramento this fall. Brother Miller has been very successful in starting new work and I feel he will do well for us in that great needy field.

IV. Continuing Labors

Sermons and addresses, 115; church board meetings, 65; annual meetings, 28; youth rallies, 3; district council meetings, 13; Western Pilgrim College Board meetings, 12; other committee meetings, 10; Ministerial meetings, 1; Dedication of church, 1; dedication of parsonage, 1; funerals, 2; General Board meetings, 4; Church Workers' Conference, 1; Youth conference and camp, 1.

In addition to the above, I have taken care of the office duties, worked several days on district properties and traveled 33,054 miles in district interests.

(This does not include 30,400 miles traveled on my missionary trip.)

Through the providence of God and the help of one of our laymen I was privileged to visit the great work of the Pilgrim Holiness Church in South Africa. It was indeed the most enjoyable ministry of my lifetime; the many dedications of native children, the ordaining of preachers, the baptizing of believers, the communion services, taking new members into the Pilgrim Holiness Church—persons who had been saved from raw heathenism, the many seekers who sought God at the altars are among the numerous things which left a tremendous imprint on me. Everywhere I went I saw the graves of the fallen brave. Africa is receiving the gospel but at an awful cost in blood and tears. It was Melville B. Cox, a great Methodist missionary to Africa who died at the age of 33, who said, "Let a thousand fall before Africa be give up." The 100 years which have passed since he made this statement have witnessed many of this number fall and Africa is receiving the gospel. The sun is rising in dark Africa and the Pilgrims are having a part in this glorious work.

Someone has said that if you want your church to grow, give to missions. The statement is only partly correct. If a church grows it will be as a result of our missionary zeal and our evangelistic passion for the lost that live in our community. We must not rest in ease in our district because of the fact that we are giving well to missions. Let us give ourselves to this holy war. We know that our district is not reaching the lost as we ought. Much of the seeking we have comes from working the saints over. Our great need is a great emphasis on soul burden, a greater exercise in soul travail for the lost and a venturing obedient faith, tied in with personal work, lay visitation, cottage meetings and all other evangelistic means that are available. If by the grace of God we as preachers could direct our people into this great channel of extensive evangelistic soul winning, our problems will be taken care of. For such an awakening I am praying, preaching and laboring.

As a district, I trust we shall take the challenge of our General Conference program for the next four years; namely, that we shall as a district strive to

1. Start two churches per year,
2. Realize a 10% gain in Sunday School attendance,
3. Develop, where possible, branch Sunday Schools,
4. Organize prayer and fasting groups in each church,
5. Promote lay visitations in all churches.

In closing, may I say that I pray Heaven's rich blessings may come down on every one who will help to heal the open sore of the world.

I have attended seven district rallies, conducted five zone elections, held five District Youth Council meetings, made a number of trips to Mile High Pines and visited most of the churches and some several times. I have traveled a little over 9,000 miles in these activities. (I've worn out myself and nearly a set of tires and accomplished very little.)

Projects

Our National Youth Projects, the white missionary work in Africa, the church extension work in Florida and the radio broadcast are showing good progress. We urge you to pray much and give that the needs of these projects will be met. The Youth News is suffering from our neglect of subscribing, so let's remedy this.

Mile High Pines

(Editor's note: Inasmuch as Mrs. Neff passed away while conference was in session, a wire expressing condolence was sent to Dr. Neff, and action taken to establish a memorial to Sister Neff.)

No. 5—Be it resolved that this conference empower the editing committee to clarify and condense the standing resolutions.

No. 6—Be it resolved that the District Forward Movement and the Finance Committees be discontinued.

No. 7—Be it resolved that Standing Resolution No. 37, Page 40, of the 1957 minutes be deleted.

No. 8—Be it resolved, that licensed ministers and deaconesses be notified in advance of conference concerning their Ministerial standing and the necessity of meeting with the Educational and Examining Board on the day previous to Conference and in event it is impossible to do so, they shall notify these boards in writing. If there is no response it will indicate to the Educational and Examining Board that the licentiate is not interested in his, or her, credentials.

No. 9—Be it resolved that an honor system for recognition of churches who pay their budget be established and that a chart shall be compiled by the District Treasurer and displayed at the District Camp and Conference.

No. 10—Be it resolved that a semi-annual Pastors' Retreat be established and that the District Superintendent arrange for such meetings.

No. 11—Whereas the School Board has been reorganized to be in line with policies of Zone Schools throughout the denomination, so that each district in the zone has equal representation on the School Board in proportion to membership and, whereas California now has more members on the school board than allowed by the new policy, now therefore,

Be it resolved that this conference dissolve and vacate all standing elections by this conference to the school board and be it further resolved that this conference elect from nominations made by the District Council its representatives to the School Board.

No. 12—Whereas some resolutions have far reaching ramifications and thus demand the careful attention of the delegates, therefore

Be it resolved that the Ways and Means and Resolutions Committee meet 30 days prior to Conference, and

Bt it further resolved that mimeographed copies listing all resolutions with committee recommendations be placed in the hands of all delegates no later than 10 days prior to said District Conference,

And be it further resolved that each local church be limited to two resolutions each to be sent to the chairmen of the respective committees no later than the 15th of May.

No. 13—Be it resolved that the following be added to resolution No. 4, Page 34, of the 1957 conference minutes:

3—The camp meeting board is empowered to hire such help as is necessary to have the delegates' accommodations properly arranged and clean.

No. 14—Be it resolved that the president of Western Pilgrim College prepare and give a report of the general conditions of the zone college together with a full personal report each year to the district conference. We further recommend that this report be sent to the other Districts of the School Zone.

No. 15—Whereas we are grateful for the blessing of the Lord which has been evidenced through progress in the past year, and

Whereas our District Superintendent has untiringly given himself to the work of building the District, therefore. Be it resolved that we give Rev. Lundy Hill a rising vote of appreciation and thereby pledge him our prayers and support for the ensuing year.

No. 16—Be it resolved that the Conference give its presiding officer, Rev. R. G. Flexon, a rising vote of thanks for his labor of love among us.

No. 17—Be it resolved that this conference give a rising vote of thanks to Rev. Lyle Tullis for taking such excellent care of the conference grounds; to Rev. Conrad Park and to the kitchen and dining-room crews for the magnificent manner in which they have entertained this conference.

No. 18—Be it resolved that greetings be sent to Mrs. R. G. Flexon, the wife of our general superintendent and presiding officer; to Rev. and Mrs. P. W. Thomas, editor of the Pilgrim Holiness Advocate and members of the District; to Mrs. Seth C. Rees; and to all the missionaries now serving under appointment abroad, who hold membership in this District.

No. 19—Whereas the manual states—"any church or pastor failing to raise the budget without good reason shall be denied a voice in annual conference," and whereas a number of our churches have failed to raise their budgets for the past year, now therefore be it resolved that this Conference authorize the District Council to appoint a committee from its membership to visit these churches early in the fiscal year for the purpose of counseling and assisting them in working out their budget problems.

Ways and Means

No. 1—Be it resolved that local and district youth finances or monies given for youth activities be listed separately in district and local reports.

No. 2—Be it resolved that the District Young People's Executive Secretary, or his representative, shall have the privilege of holding two services annually in each of the churches of the district in the interest of the work of the District Young People's Committee and that an offering shall be taken in said service and forwarded immediately to the District Treasurer, being specified as an offering for the District Young People's Committee.

No. 3—Be it resolved that the District Superintendent's salary be continued at \$4,000.00 per year in addition to his residence, utilities and traveling expenses.

No. 4—Be it resolved that standing resolution No. 30 on Pages 38 and 39 of the 1957 District Minutes be amended as follows:

- 1—The combined General and District Budgets shall be computed on the basis of \$1.75 per member per month or a total of \$21.00 per year.
- 2—Paragraph c to read: This system of finance shall be designated as the District Unified Stewardship fund and each and every church in this district shall pay monthly to the District Treasurer for the account of said Stewardship Fund their proportionate monthly budget responsibility.
- 3—Add section e. to read: The District Treasurer shall distribute within 30 days after receipt, the funds received in the Stewardship Fund as follows:
 - 1—62% to District Budget; said 62% to be distributed on the following basis:

Superintendent's account	49%
Operational Expense	20%
Home Missions	15%
General Conference Reserve	4%
Maintenance	4%
Sunday School Promotional Committee	4%
Young People's Executive Committee	4%
 - 2—38% to the General Budget; and if the said 38% should exceed the annual General Budget responsibility then, in that event, the amount received over and above our annual General Budget responsibility shall be used for District Home Mission Work.

No. 5—Be it resolved that standing resolution No. 35 on Page 39 of the 1957 District Minutes be amended by adding the following: Be it further resolved that each and every church in this conference accept a Stewardship responsibility to Western Pilgrim College of a goal in the amount of \$10.00 per member per year, payable monthly directly to Western Pilgrim College.

No. 6—Whereas there is an urgent need for further education on the subject of tithing, and whereas many of our people are contributing all or part of their tithe to other areas of Gospel work, within and without the church, and whereas Section 69, Page 36, of the Manual specifically stipulates that the tithe should be paid into the treasury of the local church, therefore be it resolved that the District Council appoint one of its members as Chairman of a committee to be appointed by the District Council to investigate and provide material for the education of our people in this area of tithing. Be it further resolved that this be an item of business in the first session of the District Council following this Conference.

No. 7—Be it resolved that because of General Conference action, the following deletions and corrections be made:

- 1—That the word "established" be deleted from Standing Resolution No. 5 on Page 36 of the 1957 Conference Minutes.
- 2—That the budget responsibility exemption for missionaries under commission be deleted from sub-paragraph a of Standing Resolution No. 30 on Page 39 of the 1957 Minutes.

STANDING RESOLUTIONS FROM PREVIOUS CONFERENCES

(1)

Be it resolved that the District Council shall be informed of all **matters of major legislative** change prior to presentation to the conference.

(2)

Be it resolved that all **school offerings** shall be **paid directly** to Western Pilgrim College. The School Treasurer shall keep an individual account for each church and report to the District Treasurer monthly and to the annual conference.

(3)

We recommend that Section 92, paragraphs 4, page 51, and Section 149, paragraphs 8, page 82 of the 1954 Manual of the Pilgrim Holiness Church, which

reads as follows, be enforced:

"Any church or pastor failing to raise the budget without good reason shall be **denied a voice** in the annual **conference**."

(4)

Be it resolved that the local churches pay the **traveling expenses and entertainment** of their **delegates** for the Conference business sessions. This does not include camp meeting.

(5)

Whereas, the General Conference has made provision that newly organized churches in districts assume one-fourth of their United Stewardship Fund the first year after being organized; one-half of their budget the second year; three-fourths the third year, and beginning with fourth year pay in full:

Therefore, be it resolved that on this district we apply the same percentages in regard to our **district budget**.

(6)

Be it resolved that the following items be paid out of the **District Expense Fund**:

1. Utilities for the home of the District Superintendent.
2. Publication of the Pilgrim News.
3. District office expense.

(7)

Be it resolved that the **cafeteria and lunch stand** be considered part of the camp meeting operations and all monies pertaining thereto be held in the Camp Meeting Fund.

(8)

Be it resolved that **ministers** coming to this district **from other denominations** be interviewed by the District Council before their **credentials** are presented to the Conference.

(9)

Whereas in the past important papers have been lost and a considerable loss of time and finance was necessary to secure new papers, therefore be it resolved that all local churches of the district forward to the District Council, for filing, all **legal papers** pertaining to the ownership of the local church property.

(10)

Whereas, the District owns shares in the **Lexington Blvd. Mutual Water Co.**, therefore be it resolved that the following five district **officers**, by virtue of their office, be appointed to represent our shares in the Water Co.: The District Superintendent, Assistant Superintendent, Treasurer and Secretary and the President of the Board of Trustees. And be it further resolved that the representatives vote the shares as a block as instructed by the District Council on matters of policy.

(11)

Be it resolved that the **District Council** and following **committees** and boards, meet one day prior to the annual Conference to take care of such work as they have on hand. The Resolutions and Ways and Means Committees, and the Educational and Examining Boards.

(12)

Be it resolved that the following sums be allowed to the District Secretary and the District Treasurer for their services:

District Secretary—\$25.00 per quarter.
District Treasurer—\$85.00 per quarter.

(13)

Be it resolved that all plans for the **construction or remodeling of church buildings** be presented to a District Building Committee on which there shall be an architect, a builder, and a financier for their suggestions.

(14)

Resolved that before licensed or ordained **ministers** coming from other **churches** shall be received into the local churches, the pastor shall consult with the District Superintendent and Council regarding said minister.

(15)

Be it resolved that each **pastor** be granted the privilege of holding at least one **revival** each conference year.

(16)

Be it resolved that our district **Educational and Examining Boards** be instructed to secure a set of questions covering the course of study prescribed by the manual and make the same available to those desiring to take the Study Course.

(17)

We recommend that, whereas we now have a standing Statistical Committee to function during the conference year, be it resolved that all **reports** be made in full and sent to the **Statistical Committee** not later than one week before the conference date.

(18)

Be it resolved that the use of our **District Camp Grounds** be limited to the activities of the Pilgrim Holiness Church.

(19)

Resolved that when recommendation for **credentials** is presented to the Conference the candidate be present, or send a written testimony to accompany the recommendation.

(20)

Be it resolved that the part of the **District Superintendent's** and other district officers' **expense**, relating to the propagation of district home missions, be so designated and paid for out of district home mission funds.

(21)

Whereas, the school has operational control of the Conference grounds the greater part of the year; therefore we recommend that the matter of **maintenance man** for said **grounds** be left to the consideration of the District Council and the School Board.

(22)

Be it resolved that the Conference form a **committee** of four which shall have charge of the Old Folks' Home buildings and **grounds**, said committee to be comprised of the District Superintendent, the pastor of the El Monte Pilgrim Holiness Church, the President of the Board of Trustees, and one member to be appointed by the District Council.

(23)

Be it resolved that the **District Superintendent** be given an annual **vacation** with pay, not to exceed two weeks.

(24)

Be it resolved that each local church be urged to raise a **subscription** list to the **Pilgrim Holiness Advocate** equal to its total membership.

(25)

Be it resolved, that the **Conference Minutes** be sold at 75c per copy. Be it further resolved, that each church remit from local funds for the minutes ordered, and then sell them to the members for the stipulated price.

(26)

Be it resolved, that there be a **Camp Meeting Grounds Committee** appointed by the Council to improve and prepare the Camp Ground for Camp services.

(27)

Be it resolved, that in lieu of the Annual District Home Missions offering received the last Sunday of Camp, we adopt a system known as the **District**

Home Missions Reserve Call System to operate as follows: The District Superintendent be privileged to ask for a special offering toward the needs of any mission project, not to exceed the equivalent of three \$5.00 calls to each voluntary member per year.

(28)

Be it resolved that our pastors be urged to secure Pilgrim Holiness **Evangelists** as much as possible. And be it further resolved that evangelists from other denominations be secured under the District Superintendent's approval.

(29)

Be it resolved that the **financial records of all departments** of the District be submitted to the District Auditing Committee at least **THREE** days prior to the District Conference. This includes District Treasurer, District Youth, Sunday School Committee, and Western Pilgrim College.

(30)

Whereas in order that the pastor may be at his best and the church may be served better by the **pastor** receiving an **annual vacation**, therefore, be it resolved that each church of the District give its pastor a two weeks' vacation with pay.

(31)

Be it resolved that the **time of sittings of future Conferences** be set as follows: 9:00 a.m. - 12:00 noon; 2:00 p.m. - 4:30 p.m.; and 7:00 p.m. - 10:00 p.m., respectively.

(32)

Be it resolved that the first order of business of the afternoon sitting of the second day of District Conference be that of the ordination service.

(33)

Be it resolved that each and every church in this conference shall take an **offering each** and every **month** during a major Sunday service for **Western Pilgrim College**.

Be it further resolved that each and every church in this conference accept a stewardship responsibility to Western Pilgrim College of a goal in the amount of \$10.00 per member per year, payable monthly directly to Western Pilgrim College.

(34)

Be it resolved that the District Sunday School Promotional Secretary, or his representative, shall have the privilege of holding two **services** annually in each of the churches of the District **in the interests of** the work of the **District Sunday School Committee** and that an offering shall be taken in said service and forwarded immediately to the District Treasurer being specified as an offering for the District Sunday School Committee.

(35)

Whereas, the **funds** received by the District from pledges for construction of a **camp dormitory** are not sufficient to cover the costs of construction, and whereas, these funds could be a great help in developing churches in our district, now therefore be it resolved that the District Council shall continue to promote the raising of funds for a campgrounds dormitory, and be it further resolved that until such time as sufficient funds are received to cover the costs of construction of a campgrounds dormitory that the District Council be authorized and is hereby authorized to use said funds for short term loans on properties for the development of our district.

(36)

Be it resolved that the District Secretary be informed immediately upon the **death of a minister or minister's wife** of the District, and that he notify by telephone all pastors in the District and that proper notification be given to the editor of the District publication.

(37)

Be it resolved that the Conference adopt the following **method of pastoral**

recall:

- 1—That each church shall vote during the last full week of March on the recall of its pastor.
- 2—That each local church secretary shall forward to the District Superintendent the results of such vote within five days following the time of voting.
- 3—That each pastor shall forward to the District Superintendent his reply relative to his recall, within 15 days of the time of voting. (See 1954 Manual, Section 53, Paragraph 3, Page 29).
- 4—That each pastor who does not plan to be a candidate for recall shall notify the District Superintendent on or before the 15th day of March.

(38)

Be it resolved that the District Conference follow the method prescribed in the 1954 Manual, Section 45, Page 28, which reads as follows: "Each **delegate** shall be provided with a **certificate of his appointment**, signed by the pastor and secretary."

Be it further resolved that a **Conference registrar** be appointed by the District Council, the registrar to assume his duties at the entrance to the district tabernacle one hour prior to the opening of each session of the Conference, and further that the duties of the registrar shall be to register all members of the conference and all duly certified lay delegates, presenting each member or delegate with a badge admitting him within the Conference Bar.

That the Conference registrar shall receive and record the certificates from the lay delegates, and shall present the list of registered delegates to the conference secretary prior to the opening of each session of the conference.

(39)

Whereas there seems to be considerable misunderstanding relative to the **listing of inactive ministers**,

Therefore, be it resolved that the Conference adopt the interpretation of the General Board with reference to Section 178 of the 1954 Manual,

"We understand by the term 'actively and regularly engaged in the work of the ministry,' to mean pastors with a regular appointment and full time evangelists and to ministers who are under special appointment. With reference to the aged ministers we suggest that only those above 65 years may be so classified."

(40)

Be it resolved that the District Superintendent call a **meeting of all District leaders and pastors** for the purpose of introducing the programs of the various departments for the coming year, this meeting to be held during the month of October.

(41)

Whereas it seems necessary to have a uniform method of **computing Sunday School attendance** in the District so as to make the comparison of statistics on an equal basis between each and every Sunday School, thus permitting the enjoyment of equal opportunity in said comparisons,

Therefore, be it resolved that only those attending Sunday School who arrive on or before 15 minutes after the regular beginning time of the Sunday School class period be counted in reports to the District Conference or to any of its committees or officials.

(42)

Whereas the projects and information in regard to the Foreign Missionary Department could be better co-ordinated and better results could be achieved within our individual churches and within our District as a whole through the help of a **District Missionary Society Committee**,

Therefore be it resolved that the District Council shall nominate and the District Conference shall elect from the nominations of the District Council a Missionary Society Committee of not less than three members whose number and terms shall be for such periods as the District Council shall provide.

Be it further resolved that from among those elected the District Council shall appoint one to serve as District Missionary Society President. It is intended that this Missionary Society Committee shall operate under the same rules and organization as the District Sunday School Committee.

(43)

Be it resolved that 1. the responsibility for the **preparation of the district camp grounds** for annual conference and camp meeting be delegated to the district Camp Meeting Board; 2. the secretary of the Camp Meeting Board shall be responsible for notifying all pastors and all other ministers of the District as to the dates for any work days set for the preparation of the grounds; 3. the camp meeting board be empowered to hire such help as is necessary to have the delegates' accommodations properly arranged and cleaned.

(44)

Be it resolved that each church be responsible to furnish two man days' labor or \$25.00 for **preparation of the Camp Meeting buildings and grounds** at least three days prior to Camp Meeting upon the call of the District Superintendent.

Any church that fails to provide the labor or funds set forth above, the active ministers of that church shall be denied their usual camp discount privileges.

Each individual who at the call of the District Superintendent works three man-days or more preparing the grounds and buildings for Camp Meeting shall be entitled to free board during Camp Meeting.

(45)

We recommend that the following **system of finance** be adopted:

a. The combined General and District Budgets shall be computed on the basis of \$1.75 per member per month, or a total of \$21.00 per year. The budget responsibility of each local church shall be determined by the District Council by deducting 10% from the total membership of the church, then, providing the number of non-voting members (under the age of 14 years) exceeds 10% of that number, then, in that event, the number that is in excess of 10% of that number, is to be deducted. The resulting number will be the local church's membership for budget responsibility.

To enable the District Council to determine this responsibility, each and every local church shall, during the first week in June of each conference year provide the District Council with a list of names and addresses of each and every member on the rolls of the local church as of the 31st day of May. Each member shall be listed under one of the following categories: (1) active members, (2) non-voting members.

b. The special Rally Day, Thanksgiving, and Easter offerings, plus offerings taken by representatives of the various departments of the General Church, shall be in addition to the budget.

c. This system of finance shall be designated as the District Unified Stewardship fund and each and every church in this district shall pay monthly to the District Treasurer for the account of said Stewardship Fund their proportionate monthly budget responsibility.

d. Specified funds are not to be considered as part of the budget.

e. The District Treasurer shall distribute within 30 days after receipt the funds received in the Stewardship Fund as follows:

(1) 62% to District Budget, said 62% to be distributed on the following basis:

Superintendent's account	49%
Operational Expense	20%
Home Missions	15%
General Conference Reserve	4%
Maintenance	4%
Sunday School Promotional Committee	4%
Young People's Executive Committee	4%

- (2) 38% to General Budget; and if the said 38% shall exceed the annual General Budget responsibility of this District, then, in that event, the amount received over and above our annual General Budget responsibility shall be used for District Home Mission Work.
