## DISTRICT SUPERINTENDENT'S REPORT

To the 41st Annual Conference of The Pilgrim Holiness Church, California District, convened at El Monte, California, June 27, 1963. Greetings! We are gathered together this morning as delegates assigned to the solemn but joyous task of doing the King's business. We shall be hearing and receiving reports that will reflect the true state of our beloved district. These reports will point up where we have failed as well as where we have succeeded. To those of us who shall be called upon to render reports it will be somewhat like traveling along the same roads again, but to others who have not accompanied us over last year's busy roads, the picture would be incomplete without them.

The business before us will demand some changes in present policies and procedures and this is both healthy and normal. We must organize sufficiently to meet the demands forced upon us by a swelling and complex society. We must be willing to alter our methods but at the same time continue to be moved by the same inner springs of action. As men projected by holy purpose, we must be ambitious without having ambitions. The demands of this arena of spiritual conflict call for unfeigned humility, unimpeachable integrity, selfless dedication and an unwavering faith. To the fulfillment of this sacred trust we, who are called of God, must be irrevocably dedicated.

### Spiritual Condition

The spiritual tone of the local churches seems to be good generally. This is particularly true where the local churches are effectively reaching the people outside their immediate constituency. I am sure that it is agreed that one of the components of true spirituality is that a church have an active visitation program to reach the lost. I am happy to report that many of our district churches are doing just this. We cannot and must not rely on the annual or

semi-annual revival effort to evangelize our communities or fulfill our responsibilities to the world.

### Local Churches

The *East Pasadena* church, under the splendid leadership of pastors Rev. and Mrs. Fillmore, has completed and dedicated a beautiful new church sanctuary. God is blessing the labors of the East Pasadena Pilgrims.

The *Redondo Beach* church has secured a zoning variance and is hoping to start on their new sanctuary program soon. Rev. and Mrs. Seelig are having a very fine and profitable ministry in this field of labor.

The *Chino* church is looking for a site to relocate. This move seems to be imperative and both Pastor Pond and the Chino Pilgrims are working hard at the task.

*Sacramento* church, under the dedicated leadership of Rev. and Mrs. Schletewitz, has constructed a beautiful new sanctuary and Sunday school unit. This new addition to the California District is a real credit to the work of God.

The *San Diego* church is also in quest of a new church relocation site. The pastors, Rev. and Mrs. Sorenson, are doing a very fine job pastoring the church and are spending much time and energy seeking to advance the work of God in this vast area of the district.

The *San Dimas* church, under the leadership of its fine new pastors, Rev. and Mrs. Smalley, is approaching the beginning date for their new church building program. The building program should begin early this conference year.

The *Ventura* church was sold this last year and the proceeds from the sale are ear-marked for a new church site in the southeast Ventura area. The District Council felt that this was a good move and will place the new church in a newly developing area with a far greater field of labor.

This has come about due to the Mountain View School District demanding the Headquarters Property for a public school site and other district property matters. This investing of time in these mundane and uninspiring matters brings satisfaction only as we recognize that this, too, is an important part of His work.

I have also spent some time this past year attending our local church services unannounced. This has given me a better opportunity to observe and to evaluate. I must frankly and truthfully report that in the main, we can well be rightfully proud of our Pilgrim ministry. We need not take second place to any. We need but to expand our influence and to extend our borders.

This past conference year has experienced a significant increase in District Youth activities. We have been very fortunate to have a conscientious and hard working District Youth Council. Most members were very faithful in attendance and follow-through, though special recognition is due our Vice President, Rev. Smalley for his help on the Council, in Youth Camps and zone meetings. Once again, the Eastern Zone has set a fine standard in its program, participation and promotion of local, zone and district and national youth activities.

During this past year, effective use has been made of workshops on the zone and district levels. Two district-wide workshops were conducted in conjunction with all-day rallies, and two others were held especially for pastors and sponsors. Besides the district workshops, each zone (where feasible) had two zone-wide workshops under the direction of the District Youth Council. By developing the themes of leadership, organization and Christian service, these workshops were a great blessing and help to all participants.

As Youth President, I have conducted nine Youth Council Meetings; participated in four Mile High Pines Board meetings; attended or conducted 12 zone workshops or rallies; visited nine churches; conducted two district rallies; traveled over 2,000 miles and met with many local, zone and district youth committees.

Several items of special interest or importance should be mentioned. First, this year saw the beginning of a district youth choir under the direction of Wayne Allen; this promises to be a valuable addition to our district youth program. Second, the District Youth Council has formulated a comprehensive and well-rounded program for our young people attending Camp Meeting; this should do much to make Camp Meeting even more valuable for our Young People. Third, for the first time our zones were organized before the Annual Youth Conference; this should improve continuity of leadership and program and also facilitate communication and promote a vigorous zone program early in the fall. Fourth, inter-church Bible quiz competition was introduced into our final district rally; this promises to add interest, variety and value to both zone and district rallies.

While this has been a year of some progress, much remains to be done. Some churches have no youth society; other societies struggle for survival and very few are making the impact for Christ and the Pilgrim Holiness Church that could and should be made in every community served by a Pilgrim church. Let us work and pray that under the Spirit's indwelling and guidance, this coming year will be one in which plans become programs and visions become realities for Pilgrim Youth at the local, zone, district and national levels.

## REPORT OF EXECUTIVE SECRETARY OF MILE HIGH PINES

This year's report on Mile High Pines is somewhat different than reports of the past inasmuch as the Board of Directors has been forced to take action to alter the course of planning somewhat. Over a year ago, the Board voted to borrow several thousand dollars to finish the Fellowship Hall and install additional water facilities, including a new tank and several hundred feet of water line. The money available was insufficient to cover this broad a field. Much was accomplished, however, with the Fellowship Hall receiving needed correction stipulated by the governmental agencies, and some other outstanding financial obligations being cared for. The Board had stipulated, however,

at the time of borrowing the money that if the camp could not be made self-sustaining and in good financial shape by July of 1963, steps would be taken to sell the camp facilities.

It was with this understanding that I accepted the position of Executive Secretary in the summer of 1962. The problems at that time seemed almost insurmountable and the additional obstacles that arose in our path later on confirmed the fact that we needed, as a Board, to face the picture realistically and proceed with their plan to sell the property. An appraiser has been contacted and after a market value has been established, we will pursue the list of prospects we have who are interested in buying a camp.

The Board feels that if a sale can be arranged, the equity received from same can be invested to insure a camping program for the future which will exceed what we are now able to offer.

On behalf of the Board of Directors, I wish to express our appreciation to the faithful ones who supported the camp throughout the years and solicit your continued understanding and faithfulness as we chart a new course in regard to providing camping facilities for the district.

# ANNUAL REPORT OF DISTRICT MISSIONARY SOCIETY PRESIDENT

June 1, 1962 to May 31, 1963

To the Annual District Conference, Greetings:

As we close another busy year, we do truly thank the Lord for His help in all our activities, which indeed have been many.

We express our appreciation to each society that has cooperated to the fullest extent. I have marveled at the beautiful spirit our presidents have shown in our district work.

Our first point of interest centered about the project for Central Pilgrim College. This consisted in providing 43 yards of plastic table covering, 100 cereal dishes, aprons of every description and dish towels. This project was completed in October, 1962, at a total cost of \$98.44.

Our out-going missionary to Peru, Miss Daisy Buby, claimed our attention for the month of November, during which time we assisted her to get into some of our churches and presented her list of needed things to the societies. As usual, our societies did not fail to help. How wonderful it is that the Lord is keeping the record; even though it be but a cup of cold water in His Name.

A considerable amount of preparation was made before our District Missionary Convention, which was held in Rees Memorial Church in January of this year.

Twenty-five of our churches were represented and a wonderful time of fellowship and inspiration was enjoyed by all.

We were favored by having our Missionary Society Director, Miss Ruth Meeks and Miss Orpha Case, missionary from Africa, as the main speakers. Miss Daisy Buby and Mrs. Gene Garrard also added inspiration to the services. We had but one regret: the time was all too short.

Our District Superintendent, Rev. Thomas Hamon, very graciously assisted in each service, for which I was indeed grateful.

After the convention, we began to work on the District Project of securing the needed supplies for our guest rooms for the Camp Meeting workers. These consisted of quilts, sheets, pillow cases, towels, etc., also some new dish towels for the cafeteria.

I have tried to keep in close contact with each society and to lend whatever aid or direction I could to each group. It has been thrilling to receive reports of how the Lord has been blessing. You will hear all about that Wednesday morning, when the presidents make their report.

At that time we will also be presenting a class of 31, who will receive certificates for having completed the reading course.

The rest of my time has been taken up with writing letters, answering S.O.S. calls and telephoning to jog up some who are slow about getting their reports.

Every six months it is necessary to compile a report for Miss Meeks, concerning all the work done by all the societies on the district. When I try to make up this report, I think I feel like the missionaries must, when they try to tell us in their letters about all they are doing. It is impossible to give a full report.

## RESOLUTIONS OF THE 1963 CONFERENCE

### Ways and Means Committee

No. 1—Lost.

No. 2—Inasmuch as the District owes \$8,321.91, on the District parsonage and has paid \$3,562.04 interest since Nov. 14, 1956,  
**BE IT RESOLVED** that the balance be paid in full from the sale of the District properties in El Monte, California. (Carried)

No. 3—Lost.

No. 4—Amendment to No. 6, page 30 (District Minutes).

**BE IT FURTHER RESOLVED** that each church receive an offering for Central Pilgrim College at least once each month as a means of reaching the above goal. (Carried)

No. 5—**BE IT RESOLVED** that the following be substituted for paragraphs 1, 2 and 3 of No. 3, page 32, of the 1962 District Minutes under United Stewardship Fund:

The following system of finance shall be followed, in caring for the United Stewardship Fund obligation of each local church:

Twelve percent (12%) of all offerings received by the local church in all departments (EXCEPT all specified funds raised for the construction or acquisition of the church buildings or property, Sunday School units, and parsonages; and for all specified purposes outside the California District) shall be remitted by the local treasurer(s) each month to the District Treasurer. (Carried)

No. 6—Lost.

No. 7—**BE IT RESOLVED** that Resolution No. 1, page 26, be omitted from the District Minutes. (Carried)

No. 8—**BE IT RESOLVED** that funds from the sale of the District properties be used to liquidate any outstanding District obligations, aside from Local Church Loans, and that the balance of the funds be placed in the Revolving Loan Fund. (Carried)

No. 9—WHEREAS the 1962 District Conference authorized the District Council to sell the headquarters property, and WHEREAS the Mountain View School District has declared its intent and purpose to take possession of said property for public school purposes, either by negotiation or by the power of eminent domain, and to this end has appraised the property fronting on Klingerman Avenue with a uniform depth of 100 feet @ 85¢ per square foot, and the remaining portion of the property @ 70¢ per square foot,  
**THEREFORE BE IT RESOLVED** that the proceeds from the sale of the entire District Headquarters property be placed in a separate fund to be called a Revolving Loan Fund. (Carried)

No. 10—**BE IT RESOLVED** that the District Conference hereby authorize the District Treasurer to make necessary adjustments in the Treasurer's books so that all departments shall be brought to current status. (Carried)

No. 11—**BE IT RESOLVED** that the Revolving Loan Fund be governed by the following By-Laws:

**BY-LAWS GOVERNING THE CALIFORNIA DISTRICT OF THE  
PILGRIM HOLINESS CHURCH LOAN FUND**

1. The California District of The Pilgrim Holiness Church shall maintain a fund to be known as the CALIFORNIA DISTRICT LOAN FUND. The purpose and use of this fund shall be to loan money to churches on the California District under the supervision and jurisdiction of the California District Council for the purpose of buying property and/or buildings, and erecting, repairing, improving or enlarging church buildings, parsonages owned by the local church and/or California District and for the purpose of paying off current loans made by local churches from outside lending institutions which are being paid at a higher rate of interest. Such money shall be used only for capital improvements or payoff of indebtedness incurred by same.

2. This fund shall be under the control of the District Council, also known as the Board of Directors and under the direct supervision of three directors: namely, the District Superintendent, the District Secretary, and the District Treasurer.

3. The District Treasurer shall carry this fund in the Crown Savings and Loan Association of El Monte, California in a separate account from all other funds of the church. The District Superintendent shall be Chairman of the Board of Directors. He shall carry on all correspondence relative to this fund. All monies shall be paid through the office of the District Treasurer, and he shall keep all records and papers of same.

4. This fund shall be built by monies received from the sale of the District Headquarters property, sale of other district properties not otherwise designated for other purposes, special contributions and low interest loans or investments by individuals.

5. All monies collected as interest shall be added to the capital to increase it. No gifts shall be made from this fund for any purpose, nor shall it be used except for making loans.

6. The directors shall prepare an application form to be filled out by the church making application for a loan. The note and mortgage shall be signed for the church by the local trustees, if any; the pastor, district superintendent, and district trustees. It shall be secured by a mortgage on the property and such other security as may be required by the directors. Loans shall be made only when title to such property is written according to the Manual of the Pilgrim Holiness Church. The local church applying for loan shall further agree that in event of loan payment delinquency that the Board of Directors of the District Loan Fund has the privilege of selling the secured note to another lending institution with the understanding that such action could result in an increase in the interest rate of such loan.

7. All applications are to be made by the local trustees and pastor on behalf of the local church after they are instructed to do so by the local church board. The application shall then be submitted to the District Council for consideration and disposition. A committee from the District Council shall investigate the property on which the loan is to be made. The investigating committee shall then report their findings to the District Council and a two-thirds vote of the entire council shall be necessary to grant a loan. All checks drawn on this fund must bear the signatures of both the District Superintendent and the District Treasurer.

8. Interest at the rate of 5% per annum will be computed on all loans. Loans may be made on any of the following plans:

1. 5 year—Payments, which include interest, shall be \$18.88 per thousand per month.
2. 10 year—Payments, which include interest, shall be \$10.61 per thousand per month.
3. 12 year—Payments, which include interest, shall be \$9.25 per thousand per month.
4. 15 year—Payments, which include interest, shall be \$7.91 per thousand per month.

In exceptional cases, longer term loans may be granted by the District Council. Preference shall be given to 10-year loans. There shall be no pre-payment penalty. No monies shall be loaned as second mortgages or side notes.

9. The District Council shall govern the size of the loan by the funds available and the value of the property on which the loan is to be made.

10. These by-laws governing the CALIFORNIA DISTRICT LOAN FUND may be changed

at any meeting of the District Council, if such changes are passed by a two-thirds vote of the District Conference. Such changes shall not be retroactive.

No. 12—BE IT RESOLVED that Standing Rule No. 3, District Minutes, page 30, be changed to read as follows: The District Home Missions Board expenses be paid out of District Home Missions funds. The chairman shall make a quarterly report to the District Council and the board of expenses and activities. (Carried)

No. 13—BE IT RESOLVED that the District Council be empowered to acquire property at a proper location, and to build a district office which shall adequately meet needs of our district conference. (Carried)

### **Resolutions Committee**

No. 1—Covered by editing.

No. 2—BE IT RESOLVED that each standing rule be dated, such date to be its origin or last revision. Carried as amended to read that a reporting committee shall be instructed to prepare said dating within one year and future rules to be dated upon origin.

No. 3—Ruled out of order.

No. 4—BE IT RESOLVED that Resolution No. 3, of the 1962 Conference, page 27, be changed to read as follows: "A District Home Missions Board be established. Such board is to be made up of two lay members, two pastors, and the District Superintendent. This board shall be appointed by the District Council, and the chairman appointed from the members of said board." (Carried)

No. 5—BE IT RESOLVED that Resolution No. 8, of the 1962 Conference, page 27, statement a., be changed to read as follows: "That each church, when renewing pastoral relations, shall vote during the last full week of March." (Carried)

No. 6—BE IT RESOLVED that Standing Rule No. 8, under Annual Conference, page 29, be deleted. (Carried)

No. 7—BE IT RESOLVED that Standing Rule No. 1, under Conference Committees, page 29, be deleted, and the following replace it: "It is recommended that all plans for construction or remodeling of church buildings and parsonages be presented to the District Building Committee for their suggestions. Said committee shall be appointed by the District Council." (Carried)

No. 8—BE IT RESOLVED that Standing Rule No. 2, under Conference Committees, page 29, be deleted. (Carried)

No. 9—BE IT RESOLVED that Standing Rule No. 3, under Conference Committees, page 29, be deleted. (Carried)

No. 10—BE IT RESOLVED that the following words be deleted from Standing Rule No. 7, under Conference Committees, page 29: "with committee recommendations." (Carried)

No. 11—BE IT RESOLVED that the District Council be requested to formulate a list of inactive ministers according to Section 167, 1962 Manual, and place such list in the 1963 District Journal and Minutes, to be effective with the close of the 1963 Conference. (Carried)

No. 12—BE IT RESOLVED that the duties relative to the Life Leases, between the California District of the Pilgrim Holiness Church and such persons involved, become the responsibility of the District Council. (Carried)

No. 13—BE IT RESOLVED that local churches calling pastors from outside the confines of the District, pay the necessary expenses involved in the changing of automobile license and registration. (Carried)

No. 14—BE IT RESOLVED that Resolution No. 7, of the 1962 Conference, page 27, be changed to read as follows:

"Conference—the third Tuesday and Wednesday of June."

"Camp Meeting—the third through the fourth Sunday of July."

"Pastors' retreat—during the week preceding Easter." (Carried as amended from May to June.)

No. 15—BE IT RESOLVED that this conference go on record as supporting the general leadership of the church, and extending to them the fullest cooperation by standing behind the spirit and the intent of the church manual. (Carried)

No. 16—Referred to Ways and Means Committee.

No. 17—BE IT RESOLVED that the conference give its presiding officer, Dr. Melvin Snyder, a rising vote of thanks for his labor of love among us.

No. 18—BE IT RESOLVED that this conference give a rising vote of thanks to the retiring District Superintendent, Rev. Thomas Hamon, for giving himself sacrificially in the office of District Superintendent for the past three years. We wish him God's blessings in his new field of labor.

No. 19—BE IT RESOLVED that a rising vote of gratitude be given to Mr. Edward C. Bickmore for his years of untiring labors and unceasing efforts serving the District in the office of District Secretary.

No. 20—BE IT RESOLVED that this conference give a rising vote of thanks to the Conference Grounds Board and the kitchen and dining room crews for their fine entertainment of the conference.

No. 21—BE IT RESOLVED that Greetings be sent to all the missionaries now serving under appointment abroad, who hold membership in this District.

## STANDING RULES AND BY-LAWS

### Annual Conference

1. The time for conference sittings shall be as follows:  
9:00 a.m. to 12:00 noon; 2:00 p.m. to 4:30 p.m., and 7:00 p.m. to 10:00 p.m.
2. The District Conference shall follow the method prescribed in the Manual, Section 45, which reads as follows:  
"Each delegate shall be provided with a certificate of his appointment, signed by the pastor and secretary."  
The Conference Registrar, appointed by the District Council, shall assume his duties at the entrance to the District Tabernacle one hour prior to the opening of each session of the Conference and shall register all members of the Conference and all duly certified lay delegates, presenting each member or delegate with a badge admitting him within the conference bar.  
The Conference Registrar shall receive and record the certificates from the lay delegates and shall present the list of registered delegates to the Conference Secretary prior to the opening of each session of the Conference.
3. The members of all standing Conference committees shall be members of the Annual District Conference with voice and vote.
4. The chairman of the Statistical Committee shall present orally the following highlights from the Statistical Committee report: total number of seekers, membership, Sunday school attendance and the financial summary of totals by departments. This entire report shall be posted before the fourth sitting of the Conference.
5. The ordination service shall be conducted in a special service at the beginning of the evening sitting on the first day of Conference.
6. The District Council, the Resolutions Committee, the Ways and Means Committee, the Educational Board, and the Examining Board shall meet one day prior to the Annual Conference to take care of such work as they have on hand.
7. When recommendation for credentials is presented to the Conference the candidate shall be present or send a written testimony to accompany the recommendation.
8. Each local church delegate shall be reminded of and shall abide by the following requirement found in Section 92, Paragraph 3, of the Manual: "All delegates shall pledge themselves to their local church that they will stay until the close of the annual conference unless called home by sickness or death." Further, that such delegates pledge to attend all sessions.
9. Since local church lay delegates are required by Manual to stay until the end of conference, all who hold credentials in the California Conference shall also feel obligated to conduct themselves in like manner.



## Conference Committees

1. The financial records of all departments of the Conference shall be submitted to the District Auditing Committee at least three days prior to the District Conference. This includes District Treasurer, District Youth, Sunday School Committee.
2. The Conference Sunday School Promotional Secretary or his representative shall have the privilege of holding two services annually in each of the churches of the Conference in the interest of the work of the Conference Sunday School Committee and an offering shall be taken in said service and forwarded immediately to the Conference Treasurer being specified as an offering for the Conference Sunday School Committee.
3. All licensed ministers and deaconesses shall be notified in advance of Conference to meet with the Educational and Examining Boards on the Saturday previous to Conference and in the event it is impossible to do so they shall notify these boards in writing. If there is no response it will indicate to the Educational and Examining Boards that the licentiate is not interested in his or her credentials.
4. The Ways and Means and Resolutions Committees shall meet 30 days prior to Conference and mimeographed copies listing all resolutions shall be placed in the hands of all delegates no later than 10 days prior to said District Conference.
5. A District Home Missions Board shall be established. Such board is to be made up of two lay members, two pastors, and the District Superintendent who shall be chairman. This board shall be appointed by the District Council. Responsibilities involved shall be:
  - a. To investigate new areas to establish churches, such investigation to include surveys and finances needed;
  - b. Recommendations to the District Council as to how to implement plans to establish new churches;
  - c. To be responsible to carry out the recommendations presented to and approved by the District Council in order to establish such churches;
  - d. Such board shall be directly amenable to the District Council.
6. A permanent committee known as the District Stewardship Committee, shall be established to investigate and provide material in the area of tithing for the education of our people. This committee shall be comprised of the following officers: District Superintendent, District Sunday School Promotional Secretary, District Youth President, District Missionary Society President. This committee shall make a report of its activities to the annual conference.
7. The Conference Scholarship Committee shall be appointed by the District Council for the purpose of raising finances for a District Scholarship Fund. This committee will serve in the examination and recommendation of worthy students to receive help from such funds. Said committee is to be amenable to the District Council and all final appointments are to be subject to Council approval.

## District

1. The following items shall be paid out of the District expense fund: Utilities for the home of the District Superintendent; Publication of the California Pilgrim; District office expense.
2. The cafeteria and lunch stand shall be considered part of the camp meeting operations and all monies pertaining thereto shall be held in the camp meeting fund.
3. This Conference shall list inactive ministers according to the interpretation of the General Board with reference to Section 178 of the Manual. "We understand by the term 'active and regularly engaged in the work of the ministry,' to mean pastors with a regular appointment and full time evangelists and to ministers who are under special appointment. With reference to the aged ministers we suggest that only those above 65 years may be so classified."

4. The following sums shall be allowed the District Secretary and the District Treasurer for their services:  
District Secretary—\$ 25.00 per quarter;  
District Treasurer—\$100.00 per quarter.
5. This conference shall accept and adopt a goal of \$5.00 per member per year in support of Central Pilgrim College. The basis for determining membership responsibility for the above-mentioned goal is to deduct 10% from the total voting membership of the church. Each church shall receive an offering for Central Pilgrim College at least once each month as a means of reaching the above goal.
6. The District Youth President or his representative shall have the privilege of holding two services annually in each of the churches of the District in the interest of the work of District Youth and an offering shall be taken in said service and forwarded immediately to the District Treasurer being specified as an offering for District Youth.
7. The full membership of the district shall covenant to daily hold up the hands of District leaders and officers with prayer and supplication.
8. The following dates shall be set for District functions:  
Conference—the third Tuesday and Wednesday of June.  
Camp Meeting—the third through the fourth Sunday of July.  
Summer Camps—Labor Day weekend and the preceding three weeks.  
Pastors' and Leaders' Conference—in the last full week of September.  
District Home Missions Emphasis—the month of September.  
District Stewardship Emphasis—the month of November.  
District Ministerial Convention—in the last full week of February.  
Pastors' Retreat—during the week preceding Easter.  
Annual Sunday School Banquet—in the month of May.
9. A system to raise finance for District Home Missions shall be established. This system shall be known as the District Home Missions 500 Club, the purpose of which shall be to secure subscriptions to the 500 Club—individuals who will pledge themselves to give \$1.00 per month for the establishment of new churches in California. The District Superintendent shall solicit members during his visit to the local churches, and an offering for District Home Missions to be taken at that time.
10. The Office of Public Affairs of the National Association of Evangelicals shall be authorized to speak for the California District of the Pilgrim Holiness Church on all legislative matters that are of vital interest to Christian citizens.
11. All correspondence with the General Missionary Society Director at headquarters, including reports, shall be directed to the District President, who will in turn relay the information to headquarters and/or secure an answer in return. The ONE EXCEPTION to the above rule relates to the correspondence concerning MISSIONARY CHRISTMAS BOXES, which should still be carried on directly with headquarters.

### **District Council**

1. The District Council shall be informed of all matters of major legislative change prior to presentation to the conference.
2. The District Council shall promote the raising of funds for a camp grounds dormitory and is hereby authorized to use said funds for short-term loans on properties for the development of our district until sufficient funds are received to cover the costs of construction of a camp-grounds dormitory.
3. The District Secretary shall be informed immediately upon the death of any pastor or pastor's wife of the district and he shall notify by telephone all pastors in the district and notify the editor of the district publication.
4. An honor system for recognition of churches who pay their United Stewardship Fund shall be established and a chart be compiled by the District Treasurer and displayed at the District Camp and Conference.

5. The District Secretary shall give written notification to all appointees to standing conference committees within 30 days after District Conference. The chairman of each standing committee shall be notified by the District Secretary 60 days prior to District Conference to activate his committee.
6. Ministers coming to this District from other denominations shall be interviewed by the District Council before their credentials are presented to the Conference.

### **District Superintendent**

1. The District Superintendent's salary shall be \$4,500.00 per year in addition to his residence, utilities, traveling expenses and automobile mileage at seven cents per mile.
2. The District Superintendent shall be given an annual two-week vacation with pay.
3. The District Superintendent shall arrange for an annual Pastors' Retreat.
4. During the month of September, the District Superintendent shall call a meeting of all District leaders and pastors for the purpose of introducing the programs of the various departments for the coming year.
5. The District Superintendent, in cooperation with youth zone leaders and heads of departments of the District Conference, shall formulate a district calendar and place same in the hands of each pastor and department head of this district; each youth zone leader and district department head shall prepare and send his annual schedules to the District Superintendent prior to the Pastors' and District Leaders' Conference the last week of September each year.

### **Local Church**

1. All local churches shall pay the traveling expenses and entertainment of their delegates for the Conference business sessions.
2. All local churches shall forward to the District Council for filing all legal papers pertaining to the ownership of the local church property.
3. Each pastor shall be granted the privilege of holding at least one revival in each Conference year.
4. All reports shall be made in full and sent to the Statistical Committee not later than one week before the Conference date.
5. Each local church shall be urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total membership.
6. The Conference Minutes shall be sold at \$1.00 per copy and each church shall remit from local funds for the Minutes ordered and then sell them to the members for the stipulated price.
7. Pastors are urged to secure Pilgrim Holiness evangelists as much as possible. Evangelists from other denominations shall be secured under the District Superintendent's approval.
8. Each pastor shall receive an annual two-week vacation with pay.
9. Each church shall be responsible to furnish two man-days' labor or \$25 for preparation of the camp meeting buildings and grounds at least three days prior to camp meeting upon the call of the Conference Grounds Board. Any church providing the labor or funds set forth above, the active ministers of that church shall be entitled to meals at one-half price. Each individual, who at the call of the Conference Grounds Board, works three man days or more preparing the grounds and buildings for camp meeting shall be entitled to free board during the camp meeting.
10. The names and addresses of the following officers of each local church shall be submitted to the editor of the *California Pilgrim* for publication with or in the August issue of each year:
  - Sunday School Superintendent;
  - Youth Society President;
  - Missionary Society President.

11. Each church shall pay the assessment fees of the pastor and wife who are members of the Ministerial Benefit Association.
12. The conference shall use the following method of renewing pastoral relations:
  - a. That each church shall vote during the last full week of March on renewal of pastoral relations.
  - b. That each local church secretary shall forward to the District Superintendent the results of such vote within five days following the time of voting.
  - c. That each pastor shall forward to the District Superintendent his reply within 15 days of the time of voting. (See 1962 Manual, Section 53, Paragraph 3.)
  - d. That each pastor who does not plan to renew pastoral relations shall notify the District Superintendent on or before the 15th day of March.
13. We recommend that before licensed or ordained ministers coming from outside the California District, or from other denominations, be received into local church membership, the pastor shall consult with the District Superintendent and the District Council regarding said minister.
14. All Sunday Schools shall conform to the General Sunday School Department's "Standard of Excellence" with respect to computing Sunday School attendance.

### United Stewardship Fund

1. The Manual of the Pilgrim Holiness Church which reads as follows shall be enforced:
 

"Any church or pastor failing to raise the United Stewardship Fund without good reason shall be denied a voice in the annual conference."
2. Newly organized churches shall assume one-fourth of their United Stewardship Fund the first year after being organized, one-half the second year, three-fourths the third year, and beginning with the fourth year, pay in full.
3. The following system of finance shall be followed, in caring for the United Stewardship Fund obligations of each local church:

Twelve percent (12%) of all offerings received by the local church in all departments (EXCEPT all specified funds raised for the construction or acquisition of the church buildings or property, Sunday School units, and parsonages; and for all specified purposes outside the California District) shall be remitted by the local treasurer(s) each month to the District Treasurer.

The District Treasurer shall distribute within 30 days after receipt the funds received in the United Stewardship Fund as follows:

1. 62% to District Stewardship Fund, said 62% to be distributed as follows:
 

Superintendent's Account .....	51%
Operational Expense .....	20%
Home Missions .....	15%
International Conference Reserve .....	4%
Sunday School Promotional Committee .....	4%
Young People's Executive Committee .....	4%
Missionary Society Committee .....	2%
2. 38% to General Stewardship Fund; and if the said 38% shall exceed the annual General Stewardship Fund responsibility of this District, then the amount received over and above our annual General Stewardship responsibility shall be used for District Home Missionary work.

No. 4—BE IT RESOLVED that Resolution 7 in the Resolutions of the 1962 Youth Conference Minutes be deleted.

No. 5—BE IT RESOLVED that the official name *Pilgrim Youth Society* be used on all materials and in all oral communication.

No. 6—BE IT RESOLVED that the District Youth Minutes be published with the present Standing Resolutions listed in categories and designated as Standing Rules and By-Laws and be it further recommended to the District Council that the Youth Minutes be incorporated in the District Minutes, and if this is not feasible, that they be mimeographed.

No. 7—BE IT RESOLVED that Resolution 8 in the 1962 Youth Conference Minutes be amended to read: These elections are to be considered as preliminary, and the District Youth President shall bring to the annual Youth Conference the names of the officers to be ratified by said Conference.

No. 8—BE IT RESOLVED that the District Youth Council be urged to approach the District Sunday School Committee to cooperate in District Christian Education planning. Such group would present to the District Council their suggestions for the implementation of a total Christian Education program to the local churches.

No. 9—BE IT RESOLVED that this Conference go on record as giving its whole-hearted support to the Greater Los Angeles Billy Graham Crusade, Aug. 15 - Sept. 8, 1963, urging each local society to participate fully with the youth committee of said Crusade.

No. 10—BE IT RESOLVED that the date of the Annual Youth Conference be set by the District Youth Council and that the Annual Youth Banquet be held the evening before the Conference, thus combining these two vital items relating to the youth of the California District.



## CALIFORNIA DISTRICT PILGRIM YOUTH SOCIETY STANDING RULES AND BY-LAWS

### Annual Youth Conference

No. 1—The three members of the Resolutions Committee shall be elected to office at Annual Youth Conference.

No. 2—The District Youth Council shall appoint three members to serve on a Conference Committee. The members shall serve for one year. It shall be the duties of this committee to assist the District Youth President in preparation for the District Youth Conference or any District Youth meeting.

No. 3—All reports to the District Youth Conference shall be submitted to the District Youth Secretary one week prior to the Conference.

No. 4—All reports to the District Youth Conference are to be prepared in triplicate: one copy to go to the District Youth President; one copy to the District Youth Secretary; one to be retained by the local society. In reference to the local society, the society president's report shall be given to the society secretary and the Zone Chairman's report to the zone secretary.



### District Youth Council

No. 1—Where at all possible, no one person should hold two offices on the District Youth Council.

No. 2—The District Young People's President shall send a written quarterly report to the District Council covering his activities, those of the zone leaders, District Youth Treasurer, and Pilgrim Youth Camp Chairman or Activities of Youth Camp Committee.

No. 3—The District Youth shall hold a quarterly workshop for the purpose of: (a)—exchanging programs and ideas for youth services; (b)—discussing methods of working unsaved youth into young people's services; (c)—discussing problems relating to local youth societies.

No. 4—The *Picayo* editor from California District Youth shall be instructed to send news items each month to the Pilgrim Youth News.

## Local Societies

No. 1—The report of each local president to Annual Conference shall include all receipts upon which budget is to be paid. (This includes all receipts except for General Church youth projects.)



## Pilgrim Youth Camps

No. 1—The annual District Youth Conference shall elect four advisory members to the Mile High Pines Board.

No. 2—Whereas the Pilgrim youth camp operates separately from California District Youth, working agreement has been arranged by the Youth Council and the Youth Camp Board as to operation of the camp.

### I. Responsibilities of Mile High Pines Board of Directors:

- A. Improvements of Camp facilities (incl. financial records of same).
- B. Maintenance of Camp facilities (incl. financial records of same).
- C. Physical functioning of the Camp.
  - 1. Operation of the electrical facilities.
  - 2. Water system (incl. hot water).
  - 3. Sewage.
  - 4. Garbage disposal.
  - 5. Necessary fires.
  - 6. Refrigeration and cooking facilities.
  - 7. Washing machine.
  - 8. Maintenance of camp truck, registration and insurance.
- D. Rental of Camp facilities.
  - 1. Advertising.
  - 2. Establishing rates.
  - 3. Formulate instructions to rentees (note II B 4 & 5)
  - 4. Maintain proper financial records.
  - 5. Require adequate insurance and accident report.
- E. Hiring a Camp Supervisor and other necessary employees.
- F. All legal aspects relating to the camp including:
  - 1. Tax exemption.
  - 2. Health permit.
  - 3. Fire permit.
  - 4. Arranging for fire warden, occupancy lists and evacuation plans. Posted instructions for evacuation in every cabin.
  - 5. Liability insurance.
  - 6. Insurance on personnel where necessary.
  - 7. Maintaining of all legal documents in M.H.P. Board office.
  - 8. Retain the services of a lawyer.
  - 9. Handling of incoming and outgoing mail.
- G. Promotion.
  - 1. Pilgrim Youth Camp Fellowship—appointment.

### II. Responsibilities of the District Youth Council.

- A. Before camping begins:
  - 1. Camp location and dates.
  - 2. Choosing Camp Directors.
  - 3. Publicity (begin early).
  - 4. Pre-registration (begin early).
  - 5. Printing application blanks.
  - 6. Camper and staff insurance.
  - 7. Transportation to camp.
  - 8. Set camper fees.
  - 9. Secure services of a Nurse.
  - 10. Apply for surplus foods.
  - 11. Appoint person or persons responsible for buying food.
  - 12. Secure services of cook and helper.
  - 13. Snack Bar operator.
  - 14. Arrange for swimming facilities.

- B. Definition of Camp Director's duties, to include such things as:
1. Secure staff, including Counselors, Speakers, Recreational Director, Bible and Craft instructors.
  2. Preparation of daily schedule (to be submitted by July 15).
  3. Procedure to be followed in filing accident reports and insurance claims.
  4. Cleanliness requirements for kitchen, dining hall, dishwashing facilities, rest rooms and shower rooms.
  5. Maintenance of proper bed spacing, general cleanliness of cabins, and entire camp area.
  6. Holding fire drills.
  7. Distribution of mail.
  8. Holding basic course for counselors (prior to camping season).
  9. Preparation of occupancy list and post.
- C. Prepare standardized outline for Camp Director's report.
- D. Prepare standardized regulations for counselors and campers.
- E. Preparation of written instructions in the Health Center regarding First Aid and filing insurance forms. Carried.

## Zone

No. 1—Each newly elected zone chairman shall secure the name, address and phone number of each local church youth society officer, and zone officers for the President. This information must be submitted in writing, for informational purposes, within 60 days following Conference.

No. 2—Each zone chairman shall send a written quarterly report to the District Youth President.

No. 3—In case the zone chairman is incapacitated in any way, the Executive members of the District Youth Council, along with the District Superintendent, shall appoint his successor.

No. 4—Each zone treasurer shall pay to the District Youth Treasurer 10% of all offerings taken at zone rallies.

No. 5—Within 60 days prior to the Annual Youth Conference, the District Youth President shall meet with the regular delegates of each zone to elect officers for that zone. These elections shall be considered preliminary and upon presentation by the Youth President, shall be ratified by the Youth Conference. Such officers shall take office immediately following the Youth Conference.

No. 6—The Dixon, Sacramento and Fresno area societies shall be called the Capital Zone. As result of the 1962 Youth Conference, Los Gatos is added to this zone.
