JOURNAL OF PROCEEDINGS

First Sitting, July 9, 1951

The Twenty-ninth Annual Conference of the California-Arizona District of the Pilgrim Holiness Church convened at El Monte, California, at 9:00 A.M., Monday, July 9, 1951.

Rev. John M. Newby led the conference in the congregational song service.

Rev. Lundy Hill led in prayer for divine guidance in the Conference proceedings.

Rev. Clifford L. Morgan, District Superintendent, read a letter from the General Superintendent, Rev. L. W. Sturk, appointing Rev. R. A. Beltz, Secretary of Church Extension, as the presiding officer for the California-Arizona Conference.

Brother Beltz spoke to the Conference, taking his text from Titus 1:5a, "For this cause left I thee in Crete, that thou shouldest set in order the things that are wanting, . . ." He spoke on the subject "Making The Best Of a Hard Situation"; stressing the thought of being faithful at our post of duty, and presenting a challenging message on the fact that the Gospel message meets the deepest need of both individuals and communities today. The District Superintendents' report was read and a motion prevailed that the same be accepted.

The second sitting of the Conference opened at 1:40 P.M., Monday, July 9, 1951, with a congregational song led by Brother William Rugh, followed by prayer offered by Brother H. J. Olsen.

The presiding officer ruled that Brother M. T. Bufkin, who is not a lay delegate, should be accepted as a member of the Conference.

Rev. Beltz gave a number of helpful hints to the ministers.

The minutes of the first sitting were read and approved as corrected.

Motion carried that the calling of the roll be dispensed with for this sitting.

Mrs. Grace Robinson was introduced to the Conference and a motion sustained that she be given an honorary seat in the Conference.

A Report from the Auditing Committee was read and accepted.

The Statistical report was read, and approval was deferred until the evening sitting!

The District Treasurer's Report was read and accepted.

The following were introduced to the Conference and welcomed among us: Rev. Isaac Phillips, President of the Tabernacle Church Association, and Brother and Sister Jones from Wichita, Kansas, Pilgrim Holiness Church.

The third sitting of the Conference convened at 7:10 P.M., Monday, July 9, 1951, with congregational singing led by Rev. J. Maxey Walton. Rev. R. A. Manuel led the Conference in prayer.

Rev. Beltz spoke in behalf of our denominational paper, The Pilgrim Holiness Advocate.

The roll call was given by the District Secretary and the answer was given by way of a pledge as to how many subscriptions each pastor and lay delegate would endeavor to secure for the Advocate in the coming year. Sixty-seven responded from the ministerial directory and 31 from among the lay delegates.

The minutes of the second sitting were read and approved.

A final report from the Educational and Examining Boards combined was read and acted upon individually as follows:

Motion carried that the remaining candidates be referred to the District Council for placement.

The District Council recommended to the Conference that the following candidates be ordained as ministers of the Gospel: Russell Johnson, Joe Fillmore, John M. Newby: and as Deaconesses: Daisy Johnson and Lucille Park.

Motion carried that they be ordained.

The ordination service proceeded as follows:

District Superintendent's Report

July 9, 1951

To the Twenty-ninth Annual Conference of the California-Arizona District of the Pilgrim Holiness Church.

Grace unto you and Peace, from God our Father, and the Lord Jesus Christ. First we wish to thank God for the grace He has given throughout the past year. We praise Him for salvation and for the blessings He has bestowed upon us. We have felt His presence as we have labored among the good people of this district.

We will endeavor with the help of the Lord to submit a report for the past year.

REVIVALS

God has given some gracious revivals over the District. Several of our pastors have reported blessed victories in the revivals conducted in their churches. We trust this will continue until every church in the Conference will burn with revival fire.

MINISTERS

God has given us an excellent group of Spirit-filled ministers who are carrying a burden for the lost. We thank God for our pastors and for their faithfulness to the cause of God.

CHURCH EXPANSIONS AND IMPROVEMENTS

Bell Gardens by rebuilding and adding to a two-car garage has made a cozy little, two-bedroom parsonage out of it. East Los Angeles has improved their facilities by building a Sunday School unit 18 x 48 which was dedicated Easter Sunday afternoon. East Pasadena sold their parsonage on Backus street and purchased the house and lot next to the church, rebuilding and enlarging it into a beautiful parsonage. North Redondo has purchased two lots on an excellent corner and have their plans drawn for a new church. The Ojai Church built a two-car garage and completed their new three-bedroom parsonage. Oak View is building a new auditorium on a "pay as you go basis," and coming along well with it. Redlands has purchased the lot adjoining their property with a small building partly erected. This has been mostly finished since the purchasing of it. Santa Ana has built new Sunday School units which are a real improvement to their property. Most all of the churches of the District have made some improvements by painting the church or parsonage, installing new pews, planting lawns or remodelling parts of their present structures. We are glad for the progress that is being made in this part of the work. Some improvements on the camp ground are just being completed by converting three three-bedroom cabins on Adams Drive into apartments with modern facilities.

HOME MISSIONS

1—Coolidge, Arizona

A new work was opened in Coolidge October 8, 1950 under the leadership of Rev. H. E. Wilson. This work is doing well with a good Sunday School, and while it is not organized, there are sufficient members at present to organize. Two lots have been purchased and plans are being made to build.

2—Lynwood Gardens

A splendid group of folk in Lynwood Gardens carrying on a work under the name of "Community Holiness Tabernacle," has united with us and a church with seventeen (17) members was organized May 6, 1951. Rev. Lehman K. Wright is the good pastor.

3—Yucaipa

In November, 1950, an excellent corner lot, size 105 x 168, was purchased in the Dunlap Acres section of the Yucaipa Valley. This Valley has a population of approximately 10,000 without a Holiness work. On March 13, of this year, a ground-breaking service was held. Shortly after this a building was started which will serve as a temporary auditorium and three class rooms. This building is of stucco-frame structure, size, 32 x 40, and is almost completed, having been built mostly by donated labor from men of the various churches, both preachers and laymen. We plan, the Lord willing, to open this work July 22 with Rev. and Mrs. Ted Willingham as the workers.

4—*South Phoenix*

A building in South Phoenix has been engaged to open a new Pilgrim Holiness Church. Rev. C. J. Meyers had planned to open this work the latter part of May, but there were adverse conditions which hindered this. He, however, plans, the Lord willing, to open this work July 15. A twenty-five (25) foot house trailer and a Sunday School bus have been purchased and paid for for Home Missionary work.

MEMBERSHIP

Several of the churches of the district have made splendid gains in membership. The highest percentage gain was shown by Adams Memorial with a 46% increase. Eleven of the churches show an increase, 11 show a decrease, and 6 show the same as the previous year. Some who may show a considerable decrease is due to the membership list not having been corrected or adjusted periodically.

YOUTH WORK

The Youth Work has progressed well under the direction of its Executive Secretary, Brother Martin Horine. A real effort has been put forth to improve the youth camp at Mile High Pines. The Zone Youth Rallies have been spiritual and for the most part well attended.

SUNDAY SCHOOL

Like the membership of the church, some of the Sunday Schools show splendid gains while others have remained about the same as the previous year. Rev. Ivan Williams, Sunday School Promotional Secretary, planned and conducted six Zone Conventions with Rev. Moreland Yundt of Ontario, Canada, as the special worker. These were very profitable meetings.

FINANCIAL

The financial plan presented by the Ways and Means Committee at the 1950 Conference has been very successful. Most of the churches have paid their budget or most of it, and others are striving to do so. We appreciate the way the churches have cooperated in this respect.

PILGRIM BIBLE INSTITUTE

The past year has been one of the best in many respects in the history of the school. The Lord has blessed with a revival spirit and the School closed in a better condition financially than usual. We would urge every church on the district to do their best to support this important phase of the work. Our good president, Rev. Clifford W. Thomas, and the sacrificial faculty have worked faithfully to see the school advanced.

PERSONAL REPORT

During the year from June 1, 1950 to May 31, 1951 we have visited all the churches several times and attended a total of 250 services, preached 110 times or more with twenty-seven (27) seeking the Lord. Held one twelve (12) day revival and one five (5) day meeting. Attended the General Conference at Frankfort, Indiana, and one District Superintendents' meeting at Indianapolis. Conducted one District Ministerial Convention and attended the Ministerial Meeting at Portland, Oregon, in behalf of the School. Conducted twenty-seven (27) Annual Church Business Meetings, fifty-five (55) Board Meetings, twenty-seven (27) District Council Meetings, and served as one of the workers in the Youth Camp at Mile High Pines. Organized one church, dedicated one Church, and one Sunday School Unit, and covered all the churches on the District in a Home Missionary deputation program, raising \$2975.00 in pledges, and worked approximately twenty (20) days on the church building at Yucaipa, preached two funerals and traveled in the interest of the district, 33,950 miles. I received from the churches for special services, \$70.00, which was turned to the District Treasurer. Our salary and traveling expense is paid in full.

We appreciate the cooperation and fellowship we have had from the pastors and laity of the churches. We would not ask for better. We regret more has not been accomplished but thankful to God for what He has helped us to do.

Last, but not least, we have appreciated our good Assistant Superintendent and the members of the District Council. It has been a real pleasure to work with these brethren.

Executive Secretary Report of the Young People's Society

July 9, 1951

To The Twenty-ninth Annual Conference of the California-Arizona District of the Pilgrim Holiness Church.

Greetings in Jesus Name.

Many eventful things have transpired since our last conference. As you recall, our Youth Camp was in the balance and it looked as though we would lose it. The matter was turned to the Young People's committee and District Council with power to act. These two committees voted unanimously to keep the camp if at all possible. We presented this vote of confidence to the Government District Ranger and received an extension of time. Armed with these facts, we presented our proposition to our Labor Day Youth Camp group. A ballot worded, "Mile High Pines, do you want to keep it? Yes, or No." This ballot was also carried to all our zone rallies. Out of nearly 250 votes cast, only 3 voted to sell the camp. Since that time work has progressed at Mile High Pines. All the kitchen cabinet doors and drawers and casing have been installed and are covered with three coats of paint. The walls, ceilings and floors are nearly completely covered in our twenty by sixty dining room. And all but four of our dining room tables have been covered. The five by twenty-eight septic tank has been completed. These last several items mentioned were requirements of the health department. One new cabin, 16 by 25, with roof and nearly all the siding on, will soon be ready for use. The footing is dug and permit taken out for another cabin.

We still stand in desperate need of your cooperation and donated help and finances.

Our zone rallies this year have been very well attended, but it seems as though the enthusiasm and interest is very low. We are trusting you will pray much about this condition for this coming year.

We traveled nearly 7000 miles this year in the interest of our Young People's work. This includes trips to Mile High Pines, District Ranger, Youth Rallies, churches, and etc. We received \$16.00 in offerings and approximately 2 cents per mile for traveling expenses.

We wish to give a note of appreciation to those that have so loyally stood by our Youth Camp, save for three churches and about a dozen faithful workers we would have lost our camp. If you were not among these three churches and these few who put in hours and hours of time, we trust you will pledge yourself for this coming year to make up for lost time. It takes a lot of sacrifice and self-denial to carry on a work of this kind.

We are trusting as we go from this conference that you will bind yourselves together as one mighty force for God and Pilgrim Youth.

Greetings:

We praise God for His abundant grace and victory through the precious blood of the Lamb.

The past year has been a most busy one, indeed, in the work of the Lord, and we are happy to report victory and joy in the service of our Lord and Master, and for the Church in Pilgrim Bible Institute.

During the past year the school has shown definite progress. Through the united efforts of a godly faculty and spiritual student body we have maintained a spiritual atmosphere throughout the school year. We have had several gracious revival times and some outstanding chapel services during the year.

During the past year we had an enrollment of 150 students. This is not a large student body, but they were certainly a choice group, many of them being outstanding Christian workers. The prospects for a larger enrollment this coming year are very good, many new students have already registered and most of last year's students are returning. We had a splendid graduating class this year with a total of 28; eleven in grammar school, 12 in high school, and 5 in Bible College. Three couples are taking pastorates this coming year and several others are filling important positions in several of our District churches.

We are happy to be able to report that we were able to close the year with all current expenses paid. Praise the Lord. This has been possible for the following reasons:

1st: We join with the Apostle Paul in saying, "Our God has supplied all our needs according to His riches in glory by Christ Jesus."

2nd: We have had a godly, consecrated, sacrificing faculty and staff that has been willing to work for meager wages.

3rd: Most all the students have paid their bills.

4th: The churches have given liberally to the school a total of over \$5,000 for which we are very grateful.

5th: We have carefully planned and closely budgeted to stay within our means.

By way of a personal report we will briefly state the following facts:

1. As president of both the Pilgrim Bible Institute and The El Monte Pilgrim Schools, and having no Principal for the High School or Grammar School we have been busy in administration work.

2. I have taught 15 hours a week.

3. I have preached on an average of twice a week.

4. Served as the evangelist for 1 revival meeting in Pomona Church.

5. I have traveled over 25,000 miles, visiting all but four churches in the states of Arizona, California, Oregon and Washington.

6. I attended General Conference at Frankfort, Indiana, last June; the Superintendents and School Presidents meeting in January in Indianapolis; the Northwest Ministerial Conference in Portland in February; the Ministers' conference in Rosemead, and District conference in El Monte.

7. Served as instructor in our Youth camp last encampment.

RESOLUTIONS OF THE 1951 CONFERENCE

No. 1. Be it resolved that the California-Arizona District purchase all the books listed in the Manual for the study courses, that are not in the Pilgrim Bible Institute Library. All books in the School Library to be available to ministerial candidates of the District on a circulating basis of a two weeks' period with privilege of renewal. District Council to work out all details.

No. 2. Be it resolved that resolution No. 2 of the 1950 Conference be deleted and the matter of opening and closing the lunch stand be under the jurisdiction of the District Council.

No. 3. Be it resolved that Resolution No. 8 of standing resolutions from previous Conference be deleted from the minutes since it is not in harmony with provisions already laid down in the Manual. *Page 110—Section 150 to 153.*

No. 4. Be it resolved that resolutions No. 9 and 10 of the standing resolutions be deleted from the Conference minutes, since these provisions are covered by the Manual. (Page 75—Section 101.)

No. 5. Be it resolved that Resolution No. 29 of standing resolutions be deleted from the minutes, the Manual having made provision for the filling of this office. (Chapter 6, page 79, paragraph 9.)

No. 6. Be it resolved that Resolution No. 24 of standing Resolutions be substituted by the following—

Be it resolved that the use of our District Camp Grounds be limited to Pilgrim Holiness activities alone.

No. 7. Be it resolved that greetings be forwarded to the following members of our Conference who are absent by reason of illness: Rev. R. W. Brown of Tucson, Arizona; Mrs. C. A. Thompson of Ventura, California; Rev. and Mrs. H. E. Wilson of Coolidge, Arizona.

No. 8. Be it resolved that greetings be extended from this Conference to Mrs. R. A. Beltz, wife of our presiding officer, to Rev. L. W. Sturk, our General Superintendent, and to Mrs. Seth C. Rees.

No. 9. Be it resolved that the Conference give its presiding officer, Rev. R. A. Beltz, a rising vote of thanks for his labor of love among us.

No. 10. Be it resolved that the Conference give our District Superintendent, Rev. C. L. Morgan, a rising vote of appreciation for his untiring work for that District.

No. 11. Be it resolved that the Conference give a rising vote of thanks and appreciation to Fred K. Wells, the custodians, and to the kitchen and dining room help, for the gracious way they have served in helping to make this a successful Conference.

RESOLUTIONS OF THE WAYS AND MEANS COMMITTEE

No. 1. Be it resolved that the District Council be authorized to establish a Revolving Loan Fund to be known as the "District Building Loan Fund" for the benefit of the churches in this District which want to borrow money at a low rate of interest for building purposes. Such funds, to be solicited from private parties who want to invest money and from wills and bequests.

No. 2. Be it resolved that the District Superintendent's salary for the ensuing year be continued at \$3,400.00 per year in addition to his residence, utilities, and traveling expenses.

No. 3. Be it resolved that each church take one offering each month for Pilgrim Bible Institute. Be it further resolved that the present "Mite Box" system be continued in behalf of Pilgrim Bible Institute and that the goal of a penny-a-day per member be raised through this system.

No. 4 Lost.

No. 5. Whereas, our present rest-room facilities have become a source of constant trouble and expense, and, whereas, it may become necessary during this fiscal year for the District Council to arrange to connect our facilities with the proposed sewer system for this district;

Therefore, we recommend that the Conference authorize the District Council to provide for this connection, and also to purchase and install the necessary equipment to place our facilities in first class condition.

No. 6. Be it resolved that the following Ways and Means resolutions of the 1950 Conference be deleted: Page 24; Nos. 2 and 3.

Notice to All Churches

Inasmuch as some of the churches have inquired about the various assessments, percentages and offerings which they are to send in each month and how they are to figure them. Therefore, for the benefit of all, the Ways and Means Committee lists below all items of importance which are to be standard procedure in each church.

(1) With each remittance from your church, please include a remittance sheet so that each amount can be credited to the proper account.

(2) 12% of regular offerings and tithes after deducting building funds and rentals, same to be distributed according to "Ways and Means resolution No. 9."

(3) 10% of regular Sunday School offerings to be used for district Sunday School work and General Sunday School and Youth Work.

(4) District assessments \$2.00 to be distributed according to Ways and Means resolution No. 8.

NOTE: Assessments are to be pro-rated to a monthly basis and remitted each month.

Assessments are based on total membership, with exemptions provided for those regularly engaged in Christian work such as active missionaries and evangelists and all non-voting members.

(5) Ministers' Retirement Plan:

If your pastor is participating in the Retirement Plan, you will deduct 2% of his salary and send in each month. Along with this your church will contribute the equivalent of 4% on his salary (or twice the amount he paid) and send along with the 2%, keeping each percentage separate in your remittance sheet. If you send in a remittance to the Minister's Retirement Fund, please include two copies (original and duplicate) of the Pension Plan Remittance sheets and keep one copy for your own files. Be sure the form is clearly and correctly filled out.

(6) Monthly Missionary offerings to be taken according to Ways and Means Resolution No. 10.

(7) All Sunday School birthday and thank offerings go to District Home Missions.

(8) All District and General Funds should be paid through the local church Treasurer to the District Treasurer.

(9) All churches should use the budget system. Obligations should be met weekly and sent monthly to the District Treasurer. All offerings should be mailed so they will reach the District Treasurer by the 10th of the month. This will make for easy and prompt handling of all accounts.

Because of the increase in the expense of printing, be it resolved that the price of the District Minutes be 25c per copy, the same to be paid out of the local church funds not later than thirty days after received.

(2)

Whereas the stress and strain of the times in which we live are such as to tax the strength of the busy pastors of our district, be it resolved that each church of the district give their pastor a two weeks' vacation with pay.

(3)

Resolved that love offerings be taken monthly for pastors of each church and that the delegate sees that this is done.

(4)

Be it resolved that the local churches pay the traveling expenses and entertainment of their delegates for the Conference business sessions. This does not include camp meeting.

(5)

Whereas, the General Conference has made provision that newly organized churches in established districts assume one-fourth of their General Budget obligations the first year after being organized; one-half of their budget the second year; three-fourths the third year, and beginning with the fourth year pay in full;

Therefore be it resolved that on this district we apply the same percentages in regard to our district budget.

(6)

Be it resolved that the following items be paid out of the District Expense Fund.

1. Utilities for the home of the District Superintendent.
2. District Superintendent's traveling expense.
3. Publication of the Pilgrim News.
4. District office expense.

(7)

Be it resolved that the cafeteria and lunch stand be considered part of the camp meeting operations and all monies pertaining thereto be held in the Camp Meeting fund.

(8)

Be it resolved that ministers coming to this district from other denominations be interviewed by the District Council before their credentials are presented to the Conference.

(9)

Whereas in the past important papers have been lost and a considerable loss of time and finance were necessary to secure new papers, therefore be it resolved that all local churches of the district forward to the District Council, for filing, all legal papers pertaining to the ownership of the local church property.

(10)

Whereas the District owns shares in the Lexington Blvd. Mutual Water Co., therefore be it resolved that the following five district officers, by virtue of their office, be appointed to represent our shares in the Water Co.: The District Superintendent, Assistant Superintendent, Treasurer and Secretary, and the President of the Board of Trustees. And be it further resolved that the representatives vote the shares as a block as instructed by the District Council on matters of policy.

(11)

Be it resolved that the School Board for the Grade and High School shall be comprised of five members. One elected for 4 years, one for 3 years, one for 2 years, and two for 1 year. And be it further resolved that all subsequent elections be for a full three years.

(12)

Whereas the Pilgrim Holiness Church of the West Coast is in need of a more adequate Bible School, where our young men and women will receive recognized Bible training within our church, thereby retaining them for our denomination, be it resolved that the the District Council and the School Board make plans to expand our present Bible School facilities, either by a building program on our own beautiful campus, or by investigating some worthy project elsewhere in the immediate future.

(13)

Be it resolved that the District Council and following committees and boards meet one day prior to the annual Conference to take care of such work as they have on hand. The Resolutions and Ways and Means Committees, and the Educational and Examining Boards.

(14)

Be it resolved that each church on the district be responsible to furnish at least two man days labor in preparation of the grounds for camp meeting, subject to the call of the District Council.

(15)

Be it resolved that the emphasis being placed on the work among the children of the Sunday Schools shall not be lessened, but that a greater stress shall be placed on the work among our young married folk and adults, thus building into our Sunday School program a definite place for the family as a complete unit.

(16)

We recommend that each self-supporting church put forth a home missionary campaign and try to establish at least one new church.

(17)

Be it resolved that all plans for the construction or remodeling of church buildings be presented to a committee on which there shall be an architect, a builder, and a financier for their suggestions.

(18)

Resolved that no pastor employ an evangelist without the endorsement of the District Superintendent.

(19)

Resolved that before licensed or ordained ministers coming from other churches shall be received into the local churches, the pastor shall consult with the District Superintendent and Council regarding said minister.

(20)

Be it resolved that each pastor be granted the privilege of holding at least one revival each conference year.

(21)

Be it resolved that our district Educational Board be instructed to secure a set of questions covering the course of study prescribed by the manual and make the same available to those desiring to take the Study Course.

(22)

Be it resolved that the reports of the Examining and Educational Boards be included in the body of the minutes.

(23)

We recommend that our District Superintendent or his Assistant shall when possible, conduct quarterly meetings at each church, at which time he shall preach a gospel sermon and administer the sacraments.

(24)

We recommend that, whereas we now have a standing Statistical Committee to function during the conference year, be it resolved that all reports be made in full and sent to the Statistical Committee not later than one week before the conference date.

(25)

It is recommended that the district create the office of District Sunday School Secretary, which person is to be nominated by the District Sunday School Committee, the nomination to be ratified by the District Council, and said secretary shall be an ex-officio member and responsible to the Sunday School Committee.

(26)

Resolved that when recommendation for credentials is presented to the Conference the candidate be present, or send a written testimony to accompany the recommendation.

(27)

Whereas the devastating influence of the liquor traffic in America is gaining such momentum, be it resolved our church and ministry take a more militant stand against the sale of the same.

(28)

Be it resolved that our District Superintendent appoint an editing committee comprised of the District Secretary and one or two other members to expedite the editing and publishing of our District Minutes.

(29)

Inasmuch as the ministerial directory in the district minutes does not differentiate between missionaries in foreign lands and ministers in the homeland, therefore, be it resolved that in the future these be shown in two separate lists.

(30)

Be it resolved that the necessary data for the General Statistician be placed in our District Minutes.

(31)

Be it resolved that the part of the District Superintendent's and other district officer's expense, relating to the propaganda of the district home missions, be so designated and paid for out of district home mission funds.

(32)

Be it resolved that the District Young People's and the Sunday School Committee's financial reports be submitted as a yearly report to the District Conference.

(33)

Whereas the local churches have been paying for the pastor's traveling and housing expenses during camp meeting and conference, and whereas some of the pastors have to leave full time or part time secular work to attend such camp and conference, thereby cutting off part of their source of income and creating a financial problem; therefore be it resolved that each church assume the responsibility of seeing that the local pastor's temporal needs are adequately supplied during this time.

(34)

Whereas the school has operational control of the Conference grounds the greater part of the year; therefore we recommend that the matter of a maintenance man for said grounds be left to the consideration of the District Council and the School Board.

(35)

Be it resolved that the number of the District Board of Trustees be reduced from seven to three, one to be elected for three years, one for two years, and one for one year, same to be put into operation as the terms of the present trustees expire.

(36)

Be it resolved that the Conference form a committee of three which shall have charge of the Old Folks Home buildings and grounds, said committee to be comprised of the District Superintendent, the pastor of the El Monte Pilgrim Holiness Church and the President of the Board of Trustees.

(37)

We recommend to the Conference that they instruct the District Treasurer to send monthly to all Pastors a report of monthly remittances from local churches to the District Treasurer. This report to be posted in a conspicuous place in the church.

(38)

We recommend that the 10% of the Sunday School offerings be divided as follows:
50% General Sunday School and Young People's Assessments.
50% District Sunday School Committee.

No. 8. We recommend that the District Assessment remain at \$2.00 per member per year, to be divided as follows:

\$0.15 General Conference Expense.
.85 Camp Ground Maintenance.
1.00 General Administration.

(39)

Be it resolved that the District Superintendent be given an annual vacation with pay, not to exceed two weeks.

(40)

We recommend that the District Secretary and the District Treasurer be allotted the sum of \$25.00 per quarter for their services, and the District Treasurer be allowed \$20.00 per month for secretarial assistance.

(41)

We recommend that we take offerings for the Departments as follows:

Foreign Missions in August.
General Church Extension in September.
District Home Missions in October.
and every third month thereafter in sequence.

(42)

We recommend that the 10% of the regular church tithes and offerings be raised to 12% and that this amount be distributed as follows:

- 30% to District Conference Expense.
- 60% to District Superintendent Fund.
- 10% to District Home Missions.

(43)

Whereas, the General Conference has set as a goal for church extension, 200 new churches within the next quadrennium, be it resolved that the California-Arizona Conference set as a goal the establishing of at least three new churches per year for the following four-year period.
