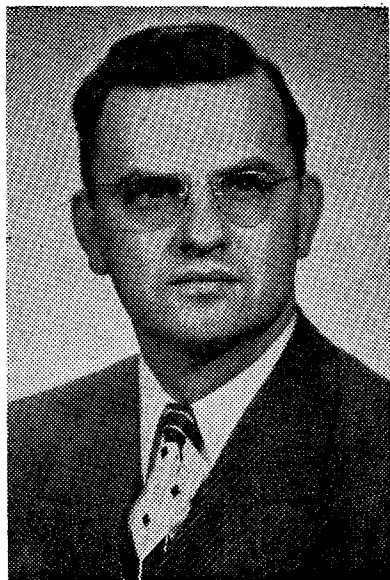

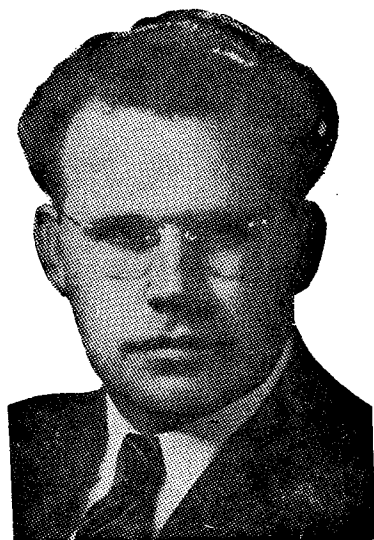

CALIFORNIA-ARIZONA ANNUAL DISTRICT CONFERENCE

JOURNAL OF PROCEEDINGS

First Sitting, June 30, 1955

The thirty-third annual conference of the California-Arizona District of the Pilgrim Holiness Church convened at El Monte, California, at 9:00 a.m., Thursday, June 30, 1955.

Rev. John Newby led the group in congregational singing, after which Rev. Thomas Lee led in prayer.

The District Superintendent introduced Rev. William H. Neff, General Superintendent, presiding officer of the conference. Rev. Neff gave some timely remarks relative to the importance of having God's presence upon the Church, pointing out the challenge which this 20th Century offers a spiritual people.

William H. Neff, ordained minister from the North Carolina District of our church.

Mrs. Edna Neff, ordained minister from the North Carolina District.

Mrs. Anna Major, licensed minister from the Christian Missionary Alliance Church.

Mrs. Ruth E. Long, ordained minister from the Pittsburgh District of our church. A motion carried to receive the above.

The District Superintendent's report was read and accepted with a rising vote of appreciation.

Rev. Thomas Lee, Assistant District Superintendent, gave an oral report, which, on motion, was received.

The District Sunday School Promotional Secretary's report was read and received with a rising vote of appreciation to Rev. John Newby for his excellent work in this field.

Brother Newby presented certificates of award from our General Church to the following Sunday Schools:

The report of the President of Western Pilgrim College was presented and accepted by a rising vote of thanks and appreciation to Rev. Clifford W. Thomas for his efforts this past year.

A resolution from the General Board was read by the District Secretary for consideration by the conference. Rev. Neff explained this resolution, which was received on motion as follows:

WHEREAS, the General Board of the Pilgrim Holiness Church has authorized the Pilgrim Pension Plan, Inc., to make loans of pension funds to local Pilgrim Holiness Churches under such conditions as require active participation on the part of the Pilgrim Holiness Districts,

THEREFORE, BE IT RESOLVED by the Annual Conference of this district that the District Council, District Trustees, and all district officials be, and they are hereby authorized, to do and perform any and all acts required of them in the consummation of authorized loans to local Pilgrim Holiness Churches of this district, subject however, to the limitations and conditions set out in said Resolution of the General Board of the Pilgrim Holiness Church authorizing said loans. The Reception Committee introduced Rev. M. T. Cockman, representative from the General Church Extension Department, who was given an honorary seat within the conference bar.

Rev. Ellis Morrell, pastor of our San Fernando Church, upon motion, was received by the conference.

At the suggestion of Brother Neff, a brief memorial service in honor of our late General Superintendent, Dr. L. W. Sturk, was scheduled for the opening of the next session of the conference.

The first sitting adjourned at 11:25 a.m.

Second Sitting

The second sitting of the conference convened at 2:10 p.m., Thursday, June 30, 1955.

Rev. Paul Miller led the group in singing "The Sweet Bye and Bye."

The congregation joined in singing "I Won't Have to Cross Jordan Alone," a song made famous throughout our movement by Brother Sturk.

Reverend Neff spoke briefly concerning the most admirable character of Brother Sturk, stating that the words of Paul concerning Barnabas, a "good man," sum up the life and influence of Dr. Sturk. Brother Neff pointed out the two emphases which Dr. Sturk made paramount during his administration: (1) spirituality in the church, (2) unity in the church, and cited that Brother Sturk had been successful in realizing in great measure the desires of his heart for the Pilgrim Holiness Church in these avenues. The memorial address was concluded with a plea to the California-Arizona Pilgrims to continue to fight faithfully the battle, taking up the sword Brother Sturk has lain down, until the end time, until Jesus comes.

District Superintendent, Rev. Lundy Hill, led in prayer.

The service closed with the group singing "Face to Face."

The conference requested that minutes of this memorial service be sent to Mrs. L. W. Sturk.

A motion carried to schedule the election of officers for the evening service, to follow the report of the Educational and Examining Boards.

The second sitting adjourned at 4:45 p.m.

Third Sitting

The third sitting opened at 7:09 p.m. with group singing "When We All Get To Heaven," led by Rev. Robert Simonds. Brother M. T. Cockman led in prayer.

Brother Neff brought a timely exhortation to the church relative to some of the tasks which face us: 1. the task of checking encroaching worldliness; 2. that of developing a strong and disciplined devotional life; 3. the re-creation, or pushing forth, of an evangelism with depth, one rooted and grounded in Biblical principles, energized by the Holy Spirit.

Minutes of the second sitting were read and approved.

A partial report of the Educational and Examining Boards was presented, and recommendations ratified.

District Council recommendations for ordination were read and approved.

On motion, time for the ordination service was set at 9:30 a.m. Friday, July 1. The conference proceeded with the election of officers.

The District Superintendent appointed the following tellers: Robert Simonds, Joe Fillmore, William Rugh, Paul Miller, Mervin Storms, John Newby. Garnett Palmer was appointed scribe.

All heads were bowed in silent petition, seeking Divine guidance.

Results of the balloting for members of the Educational Board declared C. W. Thomas elected for a term of three years, and William Rugh for one year to fill the unexpired term of George Moran who resigned.

The report of the balloting for Examining Board member declared Rev. C. J. Meyers elected for three years.

Ballots were cast to elect the remaining member of the District Council. Fred Wells was elected.

Thomas Lee, Clarence Black, Edward Bickmore and Omar Fenton were Council nominees for trustees of Western Pilgrim College, two to be elected for a period of four years.

District Council appointments to fill vacancies on the Sunday School Committee were: Rita Olson, three years; Minnie Morgan, two years.

Ballots were cast for District Sunday School Promotional Secretary. John Newby was elected.

Thomas Lee and Clarence Black were elected trustees of Western Pilgrim College.

The District Secretary read the Statistician's report which, on motion, was received with thanks expressed to those who prepared it.

Motion carried to adjourn. The third sitting closed at 9:35 p.m. with prayer by Reverend Neff.

Fourth Sitting, July 1, 1955

The fourth sitting of the conference convened at 9:07 a.m. Daniel Chamberlain led the group in singing "Stepping In The Light." Omar Fenton led in prayer.

Minutes of the third sitting were read and approved.

The Reception Committee introduced Rev. Paul William Thomas, missionary on furlough from the Philippines. Brother Thomas gave his testimony.

Council recommendations for candidates for ordination were: Mervin Storms, Ila Miller, Daniel Chamberlain and Kathryn Thomas as ministerial; Mrs. Alice Walker, deaconess.

The ordination committee consisted of Rev. William H. Neff, Rev. Lundy Hill, Rev. Thomas Lee, Rev. Paul Beck, Rev. C. L. Morgan, Rev. Thomas Hamon.

The ordination service, with Reverend Neff presiding, proceeded as follows:

Paul Beck led the group in singing "A Charge To Keep I Have."

Thomas Lee, Lundy Hill and Thomas Hamon read portions of scripture.

Reverend Neff read from II Corinthians 5:9-14, and in his characteristic practical way pointed out the three reasons why Paul preached the gospel: 1. His love for Christ—Christ's love for him as expressed in verse 14 "the love of Christ constraineth us"; 2. Fear that he had of the danger that awaits the lost, verse 11 "Knowing therefore the terror of the Lord, we persuade men"; 3. Verses 9 and 10 "we must all appear before the judgment seat of Christ"; "Wherefore we labour, that... we may be accepted of him." The Auditing Committee reported that the books of Western Pilgrim College and the District Young People had been audited and found to be correct.

A motion carried that the report of the Auditing Committee be accepted and the District Council be authorized to accept the Young People's Treasurer's report.

The financial report of Western Pilgrim College was read and accepted with a rising vote of thanks to Mr. Clarence Black, President C. W. Thomas, and Mrs. Gladys Pitzer for their untiring efforts in the work of the school.

Final report of the Educational and Examining Boards was presented and recommendations ratified.

A resolution of the District Council, as follows, was read and, upon motion, adopted:

WHEREAS, information received from various sources indicate that it is for the best interest, benefit and advantage of the PILGRIM HOLINESS CHURCH that the present school be divided into a college division and a primary and secondary division, in order to obtain certain tax benefits and other operational benefits and advantages;

NOW THEREFORE, BE IT RESOLVED by this thirty-third annual conference of the California-Arizona District of the PILGRIM HOLINESS CHURCH,

THAT the existing non-profit corporation, PILGRIM BIBLE INSTITUTE, be amended under the laws of the State of California and under the name of WESTERN PILGRIM COLLEGE for the purpose of conducting a Christian college; that the Amended Articles of Incorporation be in the manner and form approved by the duly elected Trustees and Directors of the PILGRIM BIBLE INSTITUTE and that said directors be and are hereby authorized to execute and file such amended articles;

THAT in addition thereto that this conference authorize the transfer from the said corporation so much of its assets as may be required to separate the college portion of the Institute from the secondary and primary portions;

BE IT FURTHER RESOLVED that a non-profit corporation be formed under the laws of the State of California under the name of WESTERN PILGRIM SCHOOLS INC., for the purpose of conducting a Christian primary and secondary educational institution, that the Articles of Incorporation be in the manner and form approved by the duly elected trustees and directors of the PILGRIM BIBLE INSTITUTE and that in addition thereto, this conference authorize the transfer to said corporation so much of the assets of the PILGRIM BIBLE INSTITUTE as may be required to separate the primary and secondary portions from the college portion;

BE IT FURTHER RESOLVED that the duly elected Board of Trustees of the PILGRIM BIBLE INSTITUTE be the duly elected Trustees and Directors of WESTERN PILGRIM COLLEGE, and shall serve as advisory members to the Board of Directors of WESTERN PILGRIM SCHOOLS INC., for the ensuing year;

BE IT FURTHER RESOLVED that the duly elected District Council of the California-Arizona District of the PILGRIM HOLINESS CHURCH be the duly elected Trustees and Directors of WESTERN PILGRIM SCHOOLS INC., for the ensuing year;

BE IT FURTHER RESOLVED that the following described property be deeded to WESTERN PILGRIM COLLEGE subject to the following restrictions and conditions to-wit: that the property here conveyed be used for no other purposes than a Christian college and upon violation of said conditions that the title revert to the grantor.

Parcel 1. The Westerly 334.27 feet of the South half of Lot 9 of Tract No. 565, in the County of Los Angeles, State of California, as per map recorded in Book 15 page 97 of Maps, in the office of the county recorder of said county;

EXCEPT: The South 125 feet of the North 150 feet of the West 150 feet thereof.

Parcel 2. The South 49.15 feet of the West 137.5 feet of the North half of Lot 9 of Tract No. 565, in the County of Los Angeles, State of California, as per map recorded in Book 15 Page 97 of Maps, in the office of the county recorder of said county.

BE IT FURTHER RESOLVED that the following described property be deeded to WESTERN PILGRIM COLLEGE subject to the following restrictions and conditions to-wit: that the property here conveyed be used for no other purposes than a Christian college and that no lien or encumbrance be ever permitted on said property, and upon violation of either of said conditions that the title revert to the grantor. All that portion of Lots 9 and 10 of Tract No. 565, in the County of Los Angeles, State of California, as per map recorded in Book 15 Page 97 of Maps, in the office of the county recorder of said county described as follows:

Parcel A. The South 90 feet of Lot 9 EXCEPT the West 334.27 feet thereof;

Parcel B. The South 90 feet of the West 66 feet of the South half of Lot 10;

Parcel C. The East 120 feet of the West 186 feet of the South 250 feet of the South half of Lot 10.

The past year has been one of interest and activity for California-Arizona Pilgrim youth. Every zone has been active this year with each zone having at least two and as many as seven rallies since September. One District Youth Rally was held at El Monte and the same evening a district-wide young people's potluck fellowship dinner was inaugurated.

In the past year I have attended ten rallies, visited several of our California churches as well as representing our youth work at our ministerial convention in Fresno. (At our Arizona ministerial convention our district youth work was well represented by Rev. John Sheets.) In this visitation enough money was pledged to equip all our cabins with bunk beds which we hope to install before our 1955 summer camps.

The use of our Mile High Pines camp for local and zone activities has been encouraged and we are happy to report that more and more use has been made of these facilities. The Young People's Committee has recognized the desperate and immediate need of modern sanitation facilities and every effort is being made to have these installed as soon as possible.

Last year a week long teen-agers' camp was started and of the 35 attending, 34 left with vibrant Christian testimonies and a similar report could be given of the two junior camps. The Labor Day Camp was well attended with results that only eternity can measure.

During the year I have traveled over 1,000 miles in the interest of District Youth, held numerous committee meetings, attended two of our Youth Camps. I have received \$20.00 and much spiritual enrichment and fellowship as compensation.

Let us work and pray together that this coming year will be a successful one in which we can see the completion of a much needed fellowship hall at our Youth Camp as well as the upbuilding of our California-Arizona Pilgrim Youth in the most holy faith.

DISTRICT SUPERINTENDENT'S REPORT

To our General Superintendent and the thirty-third annual conference of the California-Arizona District of the Pilgrim Holiness Church, convened at El Monte, California, June 30, 1955.

God has been good to each of us; none is worthy of the bountiful bestowal of His all-inspiring blessings which have been showered upon us from time to time. With a deep feeling of awe and gratitude to Him, I submit the following report of the past year's activities.

CHURCH BUILDINGS

South San Gabriel. The Pilgrims at South San Gabriel have arisen to meet the challenge of a growing church in a very needy community by erecting a commodious new church building. This church was dedicated last fall. The indebtedness is being paid off at a small monthly payment. Brother Thomas Hamon has worked hard and faithfully to see the job well done. Members and friends of the church assisted also.

Rees Memorial. The Pilgrims at Rees Memorial have recently finished a beautiful Sunday School unit and youth center building. The interior of this commodious annex is nearly beyond description. Many hard weeks of work have gone into this project, much of the work being donated by members and friends. This building program was begun under the ministry of Rev. George Moran, brought to completion this year during Rev. William Neff's period of service to the church. In honor of the late Professor Alex Krag, Mrs. Krag has given a beautiful new baby grand piano to be used in the new chapel.

Riverside. The Riverside church was purchased by the State Highway Department to make way for a freeway through the city. After many weeks of searching for available lots, and numerous disappointing experiences, an acre of ground was purchased

on Streeter Street near Central Avenue and work begun on a new church building. Today we have a beautiful building with approximately 2500 square feet of floor space nearly completed. Brother Josey has done most of the work for us, for about one-half standard wages. He is to be commended for this sacrifice. The neat, attractive building speaks well for the builder. Present plans are to build a Sunday School wing to be used temporarily for pastor's living quarters. The plans for the Riverside project, accepted by the Planning Commission and the Building Department of the city, call for a complete plant, built by units, as the need arises, and when fully completed will accommodate five hundred people. The present building will be converted to a youth building and Sunday School unit when the main sanctuary is erected. We hope to be able to dedicate this new building soon.

PARSONAGES

Fresno. The Fresno Pilgrims have dedicated a beautiful new parsonage since last conference, which, I believe, is on a par with the best in our movement. Much credit is due the pastor, Brother Hughes, and the faithful members and friends of the Fresno church.

San Dimas. The Pilgrims in San Dimas have finished a very lovely parsonage there. The pastor, Brother Newby, and the members and friends of the church have done an excellent piece of work.

IMPROVEMENTS

Many of our churches have made decided improvements in their properties this year. Rosemead, El Monte, Buena Park, Santa Ana, Cottonwood, East Los Angeles, San Diego, North Redondo, Lynwood, Long Beach, Oak View, Corona, Bell Gardens, West Phoenix, Tucson First, Adams Memorial, South Phoenix, have added much to the beauty and usefulness of their places of worship in various ways. The District Tabernacle has been repaired and painted; sidewalks have been poured; roads and parking areas have been black-topped, greatly adding to the beauty of our headquarters, as well as to the comfort of those who frequent the grounds.

HOME MISSIONS

The Home Missionary Department of the District is still sending substantial help to our churches at South Phoenix, Yucaipa, Dixon, and Lynwood. A new work was started in Carlsbad by the Santa Ana Pilgrims under the direction of their good pastor, Bro. Park. Brother Don Mack, from Western Pilgrim College, is now pastoring the work. The group meets in the Woman's Club House at present, and has accumulated a fund of several hundred dollars to make a down payment on a lot, when a suitable one is located. We have had very encouraging reports from this fine group.

I have preached several times in North Rialto where a new work has been started. Brother Dage, pastor of the Riverside church and his good folk, have helped to open this new work. Brother Guinn, formerly from the West Virginia District, is now pastoring this group.

After meeting twice with the Planning Commission of West Covina we were refused permission to build a church on the three lots which Mr. Snoddy had set aside for us. However, Brother Snoddy is including a parcel in his plans for a new subdivision near the former site for a Pilgrim Holiness Church, and believes that the city will not turn us down in this new arrangement. There are hundreds of children and older folk who are not attending church anywhere whom we would like to reach with the Gospel. Pray that the Zoning Board of West Covina will not refuse us the privilege of starting a work in this needy field. Recently more than fifty people signed a petition for us favoring a church's being built in this community. Victor Klein and Clarence Black have given the District Home Missions \$3700.00 to be used for new work. From this fund we are loaning the Riverside church enough money to complete their building, the amount to be repaid from a loan secured on the completed plant. Also through this Foundation several thousand dollars was given for the erection of our new Administration Building of Western Pilgrim College, and for the new sidewalks on the District grounds. Except for the Foundation, this money would have gone to the government for taxes. Thank God for men who have an interest and burden for the program of our church and the salvation of souls.

APPRECIATION

To the Assistant Superintendent, Brother Lee, and all the Council members, district officers, pastors, members and friends of our great California-Arizona District of the Pilgrim Holiness Church, I say "Thank you" for your cooperation and kindness manifested this year. I earnestly request that you continue to do your very best, for there is yet much ground to be possessed.

RESOLUTIONS OF THE 1955 CONFERENCE

No. 1. BE IT RESOLVED that in the future all matters of major legislative change be reviewed by the District Council prior to presentation to the Conference.

No. 2. BE IT RESOLVED that Resolution No. 12 be replaced by the following:

BE IT RESOLVED that each zone put forth a specific home missionary campaign and try to establish at least one new church per year, and that each zone effect an organization to carry out this program.

No. 3. BE IT RESOLVED that all ministerial and deaconess license candidates be requested to meet quarterly at Western Pilgrim College for a three hour period, at which time there will be study, examinations, assignments, etc., these seminar sessions to be under the direction of the Educational Committee and to meet during the following months: September, December, March, June.

No. 4. BE IT RESOLVED that the Educational Committee be granted permission to formulate a Survey Examination for those ministerial and deaconess candidates who feel that they have covered the equivalent of the prescribed course of study.

No. 5. BE IT RESOLVED that the District Superintendent call a meeting of all District leaders and pastors for the purpose of introducing the program of the various departments for the coming year, this meeting not to be later than September 15th.

No. 6. BE IT RESOLVED that the Conference give its presiding officer, Rev. William H. Neff, a rising vote of thanks for his labor of love among us.

No. 7. WHEREAS God has marvelously blessed our District during the past year, for which we thank God, and whereas our District Superintendent, Rev. Lundy Hill, has worked untiringly and devotedly; therefore, BE IT RESOLVED that the Conference give him a rising vote of thanks.

No. 8. BE IT RESOLVED that this Conference give a rising vote of thanks and appreciation to Fred K. Wells, Mildred Gustin, Rev. and Mrs. Conrad Park and the kitchen and dining room help for the gracious way they have served in helping to make this Conference a success.

No. 9. BE IT RESOLVED that greetings from this Conference be sent to Mrs. Seth C. Rees, Mrs. Alta Adams, Mrs. L. W. Sturk, Rev. Christopher Stone and Rev. Jemima Walker.

RESOLUTIONS OF THE WAYS AND MEANS COMMITTEE

No. 1. BE IT RESOLVED that the District Superintendent's salary be continued at \$4,000.00 per year, in addition to his residence, utilities and traveling expenses.

No. 2. BE IT RESOLVED that Resolution No. 5 of the 1954 Ways and Means on page 28 be continued with the stipulation that specified funds are not to be included in the school budget of \$4.00 per member per year, said budget is to apply to general school expenses.

No. 3. BE IT RESOLVED that all school offerings, budget and specified included, shall be paid directly to Western Pilgrim College beginning July 1, 1955. The School Treasurer to keep individual account for each church and report to the District Treasurer monthly and to the annual conference.

No. 4. BE IT RESOLVED that Resolution No. 4 of the 1954 Ways and Means on pages 27 and 28 be amended as follows:

(1) Subparagraph c.—delete the words "beginning with the remittance for the month of August 1954."

(2) Add subparagraph d.—"Specified funds are not to be considered as part of the budget."

No. 5. WE RECOMMEND that Section 92, paragraph 4, page 51, and Section 149, paragraph 8, page 82 of the 1954 Manual of the Pilgrim Holiness Church, which reads as follows, be enforced:

"Any church or pastor failing to raise the budget without good reason shall be denied a voice in the annual conference."

No. 6. WHEREAS there is a need for a **simplified standard accounting system** in our local churches that is correlated with our District and General Church accounting systems, and WHEREAS our General Church is now working to provide such a system,

THEREFORE, BE IT RESOLVED that this Conference go on record as favoring a uniform simplified accounting system in our local churches which is correlated with our District and General Church accounting systems, and

BE IT FURTHER RESOLVED that the District Council appoint a committee to put such a uniform accounting system into effect at the earliest possible time.

No. 7. BE IT RESOLVED that the **annual reporting form** be revised to conform with operational systems and procedures.

No. 8. BE IT RESOLVED that Resolution No. 6 of the 1954 Ways and Means on page 28 be amended to include the **District Superintendent** in the **Ministers' Pension Plan**, the District Superintendent and the District paying their proportionate shares.

No. 9. BE IT RESOLVED that Resolution No. 32 of the 1954 Standing Resolutions on page 30 be amended to show the sale price of the **Conference Minutes** at 75c per copy.

Standing Resolutions from Previous Conferences

(1)

Be it resolved that the California-Arizona District purchase all the books listed in the Manual for the **study courses**, that are not in the Pilgrim Bible Institute Library. All books in the School Library to be available to ministerial candidates of the District on a circulating basis of a two weeks' period with privilege of renewal. District Council to work out all details.

(2)

Whereas the stress and strain of the times in which we live are such as to tax the strength of the busy pastors of our district, be it resolved that each church of the district give its **pastor a two weeks' vacation** with pay.

(3)

Be it resolved that the local churches pay the **traveling expenses and entertainment** of their delegates for the Conference business sessions. This does not include camp meeting.

(4)

Whereas, the General Conference has made provision that newly organized churches in established districts assume one-fourth of their **General Budget obligations** the first year after being organized; one-half of their budget the second year; three-fourths the third year, and beginning with fourth year pay in full:

Therefore, be it resolved that on this district we apply the same percentages in regard to our district budget.

(5)

Be it resolved that the following items be paid out of the **District Expense Fund**:

1. Utilities for the home of the District Superintendent.
2. Publication of the Pilgrim News.
3. District office expense.

(6)

Be it resolved that the **cafeteria and lunch stand** be considered part of the camp meeting operations and all monies pertaining thereto be held in the **Camp Meeting fund**.

(7)

Be it resolved that **ministers** coming to this district **from other denominations** be interviewed by the District Council before their **credentials** are presented to the Conference.

(8)

Whereas in the past important papers have been lost and a considerable loss of time and finance were necessary to secure new papers, therefore be it resolved that all local churches of the district forward to the District Council, for filing, all legal papers pertaining to the ownership of the local church property.

(9)

Whereas, the District owns shares in the **Lexington Blvd. Mutual Water Co.**, therefore be it resolved that the following five district officers, by virtue of their office, be appointed to represent our shares in the Water Co.: The District Superintendent, Assistant Superintendent, Treasurer and Secretary, and the President of the Board of Trustees. And be it further resolved that the representatives vote the shares as a block as instructed by the District Council on matters of policy.

(10)

Be it resolved that the **District Council** and following committees and boards meet one day prior to the annual Conference to take care of such work as they have on hand. The Resolutions and Ways and Means Committees, and the Educational and Examining Boards.

(11)

Be it resolved that each church on the district be responsible to furnish at least two man days labor in **preparation of the grounds** for camp meeting, subject to the call of the District Council.

(12)

Be it resolved that all plans for the **construction or remodeling of church buildings** be presented to a committee on which there shall be an architect, a builder, and a financier for their suggestions.

(13)

Resolved that before licensed or ordained **ministers** coming from other churches shall be received into the local churches, the pastor shall consult with the District Superintendent and Council regarding said minister.

(14)

Be it resolved that each **pastor** be granted the privilege of holding at least one **revival** each conference year.

(15)

Be it resolved that our district **Educational Board** be instructed to secure a set of questions covering the course of study prescribed by the manual and make the same available to those desiring to take the Study Course.

(16)

We recommend that our **District Superintendent** or his Assistant shall when possible, conduct **quarterly meetings** at each church, at which time he shall preach a gospel sermon and administer the sacraments.

(17)

We recommend that, whereas we now have a standing Statistical Committee to function during the conference year, be it resolved that all **reports** be made in full and sent to the **Statistical Committee** not later than one week before the conference date.

(18)

Be it resolved that the use of our **District Camp Grounds** be limited to the activities of the Pilgrim Holiness Church.

(19)

Resolved that when recommendation for **credentials** is presented to the Conference the candidate be present, or send a written testimony to accompany the recommendation.

(20)

Whereas, the devastating influence of the **liquor traffic** in America is gaining such momentum, be it resolved our church and ministry take a more militant stand against the sale of the same.

(21)

Be it resolved that the part of the **District Superintendent's** and other district officers' expense, relating to the propagation of district home missions, be so designated and paid for out of district home mission funds.

(22)

Whereas, the local churches have been paying for the **pastor's traveling and housing expenses during camp meeting and conference**, and whereas, some of the pastors have to leave full time or part time secular work to attend such camp and conference, thereby cutting off part of their source of income and creating a financial problem; therefore be it resolved that each church assume the responsibility of seeing that the local pastor's temporal needs are adequately supplied during this time.

(23)

Whereas, the school has operational control of the Conference grounds the greater part of the year; therefore we recommend that the matter of a **maintenance man** for said grounds be left to the consideration of the District Council and the School Board.

(24)

Be it resolved that the Conference form a **committee** of four which shall have charge of the Old Folks' Home buildings and grounds, said committee to be comprised of the District Superintendent, the pastor of the El Monte Pilgrim Holiness Church, the President of the Board of Trustees, and one member to be appointed by the District Council.

(25)

Be it resolved that the **District Superintendent** be given an annual vacation with pay, not to exceed two weeks.

(26)

We recommend that the **District Secretary** and the **District Treasurer** be allotted the sum of \$25.00 per quarter for their services, and the District Treasurer be allowed \$20 per month for secretarial assistance.

(27)

Be it resolved, that this Conference go on record as being in favor of a **regulation** which would prohibit the sale of **alcoholic beverages** within six hundred (600) feet of the property lines of schools, churches, libraries, and playgrounds.

Be it further resolved, that we are opposed to the **advertising** of alcoholic beverages during daylight hours on radio or television.

(28)

Be it resolved, that this Conference elect a **representative** to the Board of Directors of the **California Temperance Federation**, at their request.

An amendment was made to this resolution, referring this appointment to the District Council.

(29)

Be it resolved that each local church be urged to raise a **subscription** list to the ***Pilgrim Holiness Advocate*** equal to its total membership.

(30)

Be it resolved, that each local church specify a time for the **delegates** to give a **report** of the District Conference.

(31)

Be it resolved, that the **Conference Minutes** be sold at 75c per copy. Be it further resolved, that each church remit from local funds for the minutes ordered, and then sell them to the members for the stipulated price.

(32)

Be it resolved that there be a **Camp Meeting Grounds Committee** appointed by the Council to improve and prepare the Camp Ground for Camp services.

(33)

Be it resolved, that in lieu of the **Annual District Home Missions** offering received the last Sunday of Camp, we adopt a system known as the **District Home Missions Reserve Call System** to operate as follows: The District Superintendent be

privileged to ask for a special offering toward the needs of any mission project, not to exceed the equivalent of three \$1.00 calls to each voluntary member per year.

(34)

Whereas many of our scholars do not remain for preaching services, and whereas it has been recommended that the Sunday School have an evangelistic emphasis, therefore, be it resolved that our pastors be urged to have a **unified Sunday School and church service** once per quarter.

(35)

Be it resolved that our pastors be urged to secure **Pilgrim Holiness Evangelists** as much as possible. And be it further resolved that evangelists from other denominations be secured under the District Superintendent's approval.

(36)

Whereas many of our churches do not have Baptismal facilities and whereas the ordinance has been a blessing in many lives, therefore, be it resolved, that the pastors send to the District Superintendent at least ten days prior to camp meeting the names of baptismal candidates and if the number of candidates is sufficient to warrant such, a **baptismal service** be held **during camp**. Final decision in this matter shall rest with the District Council.

(37)

Be it resolved that the **financial records of all departments** of the District be submitted to the District Auditing Committee at least **THREE** days prior to the District Conference. This includes District Treasurer, District Youth, Sunday School Committee, and Western Pilgrim College.

(38)

Whereas the General Conference has revised the General Budget and whereas the present set-up does not properly equalize the finances to meet the new obligation; therefore, we recommend that this conference adopt the following simplified **system of finance** as suggested by General Conference Action:

a. The combined General and District budgets shall be computed on the basis of **\$1.50 per month per member**, or a total of \$18.00 per year. The figure for calculating the responsibility of each local church is the total **membership** reported to the previous conference, less **10%**. All missionaries under commission to be **exempted**.

b. The **special Rally Day, Thanksgiving, and Easter offerings**, plus offerings taken by representatives of the various departments of the General Church, shall be in addition to the budget.

c. Remittances shall be sent to the District Treasurer.

d. **Specified funds** are not to be considered as part of the budget.

(39)

Be it resolved that we adopt a **school budget**, a minimum of **\$4.00 per member per year**, based on the same member ratio as the District and General Budget. Be it further resolved that each church take an offering each month to be applied on said budget. We also request that **school representatives** visit each church at least once each semester to aid the church in raising the school budget. **Specified funds** are not to be considered as part of the budget.

Inasmuch as the General Conference passed legislation requiring all local churches to participate in the **Ministers' Pension Plan**, be it resolved that all of our churches cooperate by participating in said pension plan. Be it further resolved that the District Superintendent be included in this plan, the District and the Superintendent paying their proportionate shares.

WHEREAS, the Arizona Pilgrims are so far removed from the District headquarters and consequently from such church activities, and whereas it seems advantageous to the growth of our church in that state, and whereas it would release funds for the extension of our church in unevangelized areas of California, be it resolved, that we as a Conference petition the Department of General Church Extension that they take over as soon as practical the churches now in Arizona.
