ASSEMBLY PROCEEDINGS

The Twenty-fifth Annual Assembly of the Idaho-Washington District of the Pilgrim Holiness Church met for the annual session, at Spokane, Washington, on the School grounds at E. 1717 Rowan Ave., August 10, 1939, at 9:30 A.M., with District Superintendent Rev. E. R. Himmelright presiding.

Song service was led by Rev. T. C. Abbott, singing the songs, "He Leadeth Me" and "Sunlight." The Assembly was then led to the Throne of Grace in prayer by Rev. W. J. Webster. Again we joined in singing the song "Under the Blood." Our District Superintendent, Rev. E. R. Himmelright read some scripture from I Cor. 1:12-31 and gave a good exhortation admonishing each one to be true to God, and work together for souls and for His kingdom. A letter was read from our General Superintendent, Rev. W. L. Surbrook, to the Assembly, and a rising vote of appreciation was given to our General Superintendent for his interest in us. A vote of appreciation was also given to our District Superintendent for his services in our district.

Roll call was read with twenty-four responding.

Motion made that the Hermiston church be accepted into the district. Carried.

Motion made and carried that the action of the District Council be approved in accepting the following into the district, namely, Paul Idler, Harper Cole, Lloyd Laubaugh, and Mrs. O. W. Hampton.

Motion made that the first four rows of seats constitute the assembly bar.—Carried.

Motion made that the Chair appoint the committees. Carried.

The following were appointed: Resolutions—Revs. J. W. Partridge, Stanley Weber, C. R. Bennett, and E. E. Storm. Ways and Means—Rev. W. J. Webster, R. A. Fullerton, Rev. T. C. Abbott, and Rev. Ralph Tromble.

Auditing—Revs. C. A. Wilson, Ida Garner, and O. W. Hampton.

Reception—Mrs. Alice Norris, and Florence Kenney.

Editing—Rev. Ralph Tromble, R. A. Fullerton, and Rev. O. W. Hampton.

Motion made that the time of sittings be 9:00 A.M. to 11:30 A.M. and from 2:00 P.M. to 5:00 P.M. Carried.

Motion made that in reading reports only the totals be read. Carried.

Motion made that our District Superintendent read his report. Carried.

Rev. E. R. Himmelright then gave his report, which was accepted.

The following ministers' reports were then read and accepted: W. J. Webster, Ralph Tromble, T. C. Abbott, O. W. Hampton, C. R. Bennett, Ida Garner, Hazel Goss, L. W. Goss, J. W. Partridge, Stanley Weber, M. E. Stockman, Florence Kenney, Alice Norris, E. E. Storm, C. A. Wilson, Mrs. C. A. Wilson, and Paul Idler.

The following Deaconesses' reports were read and accepted: Mrs. E. R. Himmelright, Mrs. Opal Webster, and Mable Bittleston.

The following church reports were read and accepted: Athol, Benton City, and Coeur d'Alene.

Our time being expired we were dismissed with prayer by Mrs. Ralph Bond.

SECOND SITTING

Called to order at 2:00 P.M. Song service led by Rev. Paul Idler, singing the song "Wonderful Peace." Scripture read by Rev. W. J. Webster, from Ephesians 4:1-16. We were then led in prayer by Rev. C. A. Wilson. Mrs. J. J. Satre then sang "Nothing Satisfies But Jesus." Previous minutes were then read, corrected, and approved. The reception committee then presented the following: Miss Ellen Martz, Mrs. Ruberg, Mrs. Everett Crow, Mrs. Bradburn, and Mrs. T. C. Abbott.

Motion made that Mrs. T. C. Abbott and Mrs. Ruberg be given an honorary seat in the Assembly bar. Carried. Motion made that we dispense with the roll call. Carried. We then proceeded with the following church reports: Grandview, Kamiah, Kennewick, McGuires, Spirit Lake, Spokane, Weippe, Hermiston. These reports were accepted.

The Resolutions Committee then gave a partial report. Motion made that we read all the present resolutions. Carried. Considerable time was spent in discussing these resolutions, after which the Ways and Means Committee gave a partial report.

The Auditing Committee then gave their report which was accepted. A rising vote of thanks was given to our District Treasurer for his faithful labors during the past year. He then gave his report which was accepted. Motion made that we have the election of officers at 10:00 A.M., August 11, 1939. Moved to adjourn. Adjourned with prayer by Rev. J. W. Partridge.

THIRD SITTING

The Assembly joined in singing the song "Alone With God," led by Rev. Harper Cole.

Scripture was read by Rev. T. C. Abbott from Col. 3:1-17. We were then led in prayer by Mrs. J. J. Satre. Previous minutes were then read and approved. Rev. J. H. Philpot then spoke to the Assembly for a few minutes. The Resolutions Committee then gave a partial report at this time, and a number of resolutions were adopted. The Reception Committee at this time presented the following:

Mrs. Effie Mann, Mrs. Judd, Mr. and Mrs. Brown, Mr. Triplet, Mr. Scott, and Rev. J. H. Philpot. Motion made that Brother and Sister Philpot be given an honorary seat in the Assembly bar. Motion made that we rescind the action of the previous sitting as to the time of elec-

tion and that we proceed with the election of officers at this time. Carried.

Motion made that the Chair appoint the tellers. Carried.

The following were appointed: Revs. J. W. Partridge, Stanley Weber, and C. R. Bennett.

Feeling our need of the help of God we then went to Him in prayer, led in prayer by Rev. J. H. Philpot.

Moved to recess until 2:00 P.M. Carried.

Dismissed with prayer by Rev. Ralph Tromble.

FOURTH SITTING

Called to order at 2:00 P.M., singing the song "Unsearchable Riches" led by Rev. Harper Cole. The Assembly was led in prayer by R. A. Fullerton. Rev. Stanley Weber read the scripture from Eph. 1:15-23. Previous minutes read and approved.

Ways and Means Committee gave a report at this time, and some more resolutions were adopted.

The statistical report was given and accepted.

The Reception Committee presented the following to the Assembly at this time: Brothers King and Evans, Sisters Cronrath, Cederbloom, Rosenau, and Miller.

The recommendations of the Examining Board as approved by the District Council were given at this time. Approved.

Motion made to have the Ordination Service Saturday, August 12th, at 10:00 A.M. Carried.

Motion made that we have the annual school meeting at 3:00 P.M. August 11th, 1939. Carried.

Present minutes read and approved.

Moved to adjourn. The Assembly joined in singing "Praise God From Whom All Blessings Flow." We then went to our knees in prayer asking God to bless and help us in the days to come. Led in prayer by Rev. W. J. Webster.

The ordination service was held at the appointed time. God poured out His Spirit as these men were ordained to the ministry. The ordination committee was Rev. E. R. Himmelright, Rev. W. J. Webster, Rev. T. C. Abbott, Rev. O. W. Hampton, Rev. J. W. Partridge, and Rev. Ralph Tromble. The candidates were C. A. Wilson and E. E. Storm.

DISTRICT SUPERINTENDENT'S REPORT

To the Annual Assembly of the Pilgrim Holiness Church of the Idaho-Washington District:

Greetings in the name of our Saviour, Jesus Christ:

The past year has been a year of problems for all of us, but through all, God has been very gracious to us as individuals and as a district. Souls have been saved. Each church has made some gains in one way or another. We give God the praise for all that has been accomplished through His Name. We appreciate the privilege that has been ours of working with this sacrificing group of men and women.

I have preached 182 times, held six revival meetings, with 90 seekers either for salvation or sanctification, prayed with for healing 6, organized one church at Hermiston, Oregon, held 23 business meetings, traveled 12,370 miles on the district, received for travel expense, \$212.00, received in salary, \$719.90, gifts in food from the churches, \$51.90, and a special offering of \$10.60.

Appreciating God's mercy and the many privileges that have been ours throughout the year, we respectfully submit this report.

RESOLUTIONS

1. Resolved, that we have two prayer conventions during the year, and that the time and place of said conventions be arranged for by the Superintendent and his assistant.
2. Resolved, that 200 copies of the District minutes be printed.
3. Resolved, that the District Superintendent appoint the Statistical Committee two weeks prior to the Assembly.
4. Resolved, that no worker shall be allowed on our platforms whose practice, that is, their lives and dress, does not come up to our church standards.
5. Resolved, that our District Superintendent be our Home Missionary, and that he choose his helpers.
6. Resolved, that our District Council serve as the Campmeeting Committee or elect a committee if necessary.
7. Resolved, that we recommend active pastors to be elected as advisory members of the District Council.
8. Resolved, that no pastor or church call an evangelist without the consent of the District Superintendent.
9. Resolved, that each pastor preach or at least touch definitely on tithing twice a year.

10. Resolved, that inasmuch as we are living in such times of worldliness, we the Assembly deem it the duty of the parents to see to it that they dress their children properly, restraining them from going in anklets and without shirts, and in pajamas and slacks.

11. Resolved, that all parent members of the Pilgrim Holiness Church refrain from cutting their girls' hair, and to dress them as becometh holiness.

12. Resolved, that each church have a uniform treasurer's book to keep accurate accounts.

13. Resolved, that we express our appreciation to our District Superintendent, Secretary, and Treasurer, for their services during the past year.

14. Resolved, that the pastors who change, make their changes at the first of July, unless the council sees fit under certain conditions, to have it otherwise.

15. Resolved, that each pastor be responsible to see that the annual reports from his church be sent in not later than July 10th, and in case of failure to do this, the pastor explain same to the Assembly.

16. Resolved, that our churches give our District Superintendent an offering of provisions when he comes for the quarterly meetings.

17. Resolved, that no church board shall accept members into our churches who come from other holiness churches until they first have received a letter of recommendation from the church where the applicant was a member, or at least make thorough investigation.

18. Resolved, that we express our appreciation to Sister Weber and her helpers in the kitchen and dining room for their services.

WAYS AND MEANS

1. Be it resolved, that each local church of the district be apportioned the minimum of \$5.00 per voting member to finance our General church and district obligations. Said amount to be distributed as follows: Foreign Missions, \$2.00; District Expense, \$2.00; General Budget, \$0.50; General Home Missions, \$0.50.

2. Resolved, that all active and inactive licensed and ordained ministers and deaconesses pay the tithe of the remuneration received from their ministry into the local church treasury, to be forwarded to the District Treasurer, to be applied on the District Superintendent's salary.

3. Resolved, that each church take a foreign missionary offering each month.

4. Resolved, that there be an assessment of 15 cents per member annually for the General Assembly expense.

5. Resolved, that each local treasurer send all money for district and general purposes to the District Treasurer the first of each month, or more often if necessary.

6. Resolved, that we attempt to pay our District Superintendent the following per month, for his services, \$52.50; house rent, \$10.00; telephone, \$2.50; and traveling expenses. This said amount to be paid bi-monthly.

7. Resolved, that our District Treasurer send our pastors a monthly statement of their churches' district obligation, and that the pastors attempt to raise this amount when in the arrears.
