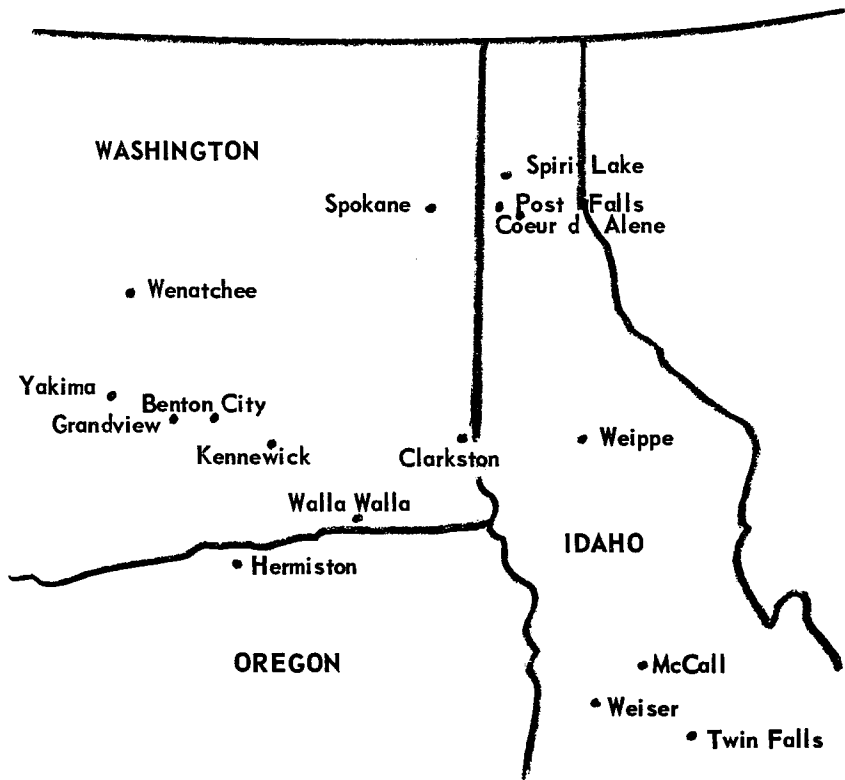

JOURNAL OF PROCEEDINGS

First Sitting, July 21, 1958

The forty-fourth annual conference of the Idaho-Washington District of the Pilgrim Holiness Church convened at the District Tabernacle in Clarkston, Washington on Monday, July 21, 1958 at 8:30 a.m.

Rev. Lester Boone led in the singing of "I Am Thine, O Lord" after which Rev. C. E. Dietz led in prayer.

Rev. I. G. Canary, District Superintendent, introduced Dr. William H. Neff, General Superintendent, as chairman of the conference. Dr. Neff commented briefly from Philippians 4:1-5, mentioning the duties and responsibilities of the churches to the propagation of the gospel.

The district secretary proceeded to call the roll, to which 25 ministerial, three ordained deaconesses and 16 lay delegates responded. Pearl Bennett was accepted as a delegate from Kennewick. Durwood Link and Mrs. Elizabeth Evans were received as ordained ministers from other churches.

A motion carried that the first four rows constitute the conference bar.

It was moved and carried that the hours of the sessions be from 8:30 a.m.-12:00, 1:30-5:00 p.m., and 6:00-9:00 p.m.

Rev. David Bailey and Rev. Lester Boone were appointed by Rev. Canary to act as a Reception and Courtesy committee.

The District Superintendent's report was read and accepted.

The Reception committee introduced two visiting ministers, Rev. H. A. Downing of Ranchocordova, California; and Dr. W. T. Bruner of McCall, Idaho. They were given a seat in the conference bar.

The Committee also presented Rev. and Mrs. Ronald Benjamin, who are to pastor in Weippe this next year. They are transferring from the California conference. He was deferred from sitting in the conference bar until the Educational Committee presented their recommendation.

Rev. D. L. Goss, Assistant Superintendent, gave an oral report, which was accepted by the conference.

The Auditor's report was read and accepted.

The District Treasurer's report was read by Rev.

Swinney and accepted by the conference.

The report of the District Youth Executive Secretary, Miss Betty Miller, was read and accepted.

The report of the District Young People's Treasurer was read and accepted.

Dr. Neff commented on the fine group of young people who were present at the camp meeting.

Mrs. Canary, The District Missionary President, read the financial report of the Missionary societies, and her own report. Both were accepted.

The Sunday School Promotional Secretary, Rev. Frank Evans, presented his report which was accepted.

The report of the Editor of "Pilgrim Echoes" was read by Rev. Evans and accepted by the conference.

At 10:05 the conference recessed for 15 minutes.

The Educational Committee presented Rev. Ronald Benjamin to the conference. He was accepted and given a seat in the conference bar.

The report of the Resolutions Committee was presented and acted upon.

Motion was made to adjourn after announcements. Dr. Bruner dismissed with prayer.

Second Sitting

The sitting of the conference convened at 1:30 p.m.

Rev. Boone led the congregation in singing after which Mr. Pulliam led in prayer.

The minutes of the first sitting were read and approved.

The report of the Ways and Means Committee was presented and acted upon.

The Education Board made the following recommendations which were passed by the conference:

That Rev. Boone, Rev. Cyrus Lynch, and Rev. Bailey be ordained; Ronald Benjamin be placed in the fourth year; Stanley Miller be retained in the second year; Roy Kneeland be placed in the first year and that DeVere DeField be retained in the first year.

The District Statistician, Mrs. C. R. Lynch, read her report which was accepted with a rising vote of thanks.

The Conference recessed at 3:20 for 15 minutes.

The conference reopened with silent prayer and followed by prayer by Dr. Neff.

Rev. Canary appointed the following as tellers:

Lester Boone, Ronald Benjamin, David Bailey, E. E. Meeks, Cyrus Lynch, Ray Brewer, and Margo Acheson.

Donald Goss was elected as Assistant Superintendent.

The District Council nominations for Secretary were Cyrus Lynch, Frank Evans and David Bailey. David Bailey was elected District Secretary.

Nominations for Treasurer were Martin Swinney and Lester Boone. Martin Swinney was elected District Treasurer.

Ballots were cast for three council members.

Tellers retired to count ballots.

David Bailey was elected as College Board Representative for a term of two years.

Report of the balloting for council members declared E. E. Meeks and O. A. Wells elected on the first ballot and Frank Evans on the fourth.

Nominations for the Examining Board were E. E. Meeks and Martin Swinney. Martin Swinney was elected.

Nominations for the Educational Board were Margo Acheson and Cyrus Lynch. Cyrus Lynch was elected.

The Educational Board recommended Albert R. Weaver for first year license.

It was moved and carried to adjourn to reconvene at 6:30. The conference was dismissed with prayer by Rev. Lynch.

Third Sitting

The third sitting of the conference convened at 6:35 p.m. The congregation sang the chorus of "We'll Work Till Jesus Comes" after which Rev. Stanley Miller led in prayer.

The minutes of the previous sitting were read and approved.

The Educational Board recommended E. E. Meeks for ordination at this conference. It was passed.

The final report of the Ways and Means Committee was presented and Resolution No. 7 was adopted.

It was moved and seconded that the rent from the district parsonage be put in a fund for a new district parsonage. It was lost.

The Ordination service convened at 6:55 p.m.

Rev. Benjamin led the congregation in "A Charge To Keep I Have" and "Jesus, Saviour, Pilot Me."

Rev. Goss read I Timothy 3:1-9 and Rev. Swinney II Timothy 3:16-4:5.

Following the reading of the Scripture, Dr. Neff spoke from Colossians 1:23, "I am made a minister"; I Corinthians 9:19, "Servant of all"; and I Corinthians 9:27, "I keep my body under".

The candidates knelt at the altar and those assisting placed hands upon them as Dr. Neff proceeded to ordain each of the candidates.

The service closed with the singing of the "Doxology", "I'll live for Him", "Blest Be the Tie that Binds", and "Faith of Our Fathers".

It was moved and passed that all unfinished business be referred to the District Council for action.

Conference was dismissed with prayer by Dr. Neff.

1898-1958

Mrs. Edna Mae Neff, after an illness of several months, went to her heavenly reward from their home in Indianapolis on the morning of June 27, 1958. Sister Neff came from Western Pennsylvania. She was born of English and Scotch parentage.

She was a godly woman, well known and greatly loved, the wife of Dr. William H. Neff, a General Superintendent of the Pilgrim Holiness Church. Sister Neff was a talented and versatile woman - a person with a fine mind and charming personality. She appeared equally at home on the platform, in the kitchen, or an office. Energetic and tireless, she was "in labors more abundant".

Her life and ministry were characterized by a serene and restful spirit. This was true to the very end of the journey. And thus, with life's work well done, being very fruitful for the Kingdom, the life of Sister Neff can be remembered as one faithful to her calling and "full of good works".

DISTRICT SUPERINTENDENT'S REPORT

Dr. William H. Neff, members of the 44th Annual Idaho-Washington Conference, Pilgrim Holiness Church, Greetings.

It is with a profound appreciation of God's providential love and care that we gather here on this lovely camp site. May we humbly beseech the inspiration and illumination that can only come from our gracious Lord. May we turn the benefits of the Gospel of good news in the right direction through this conference and all through the coming year. Dr. Halford E. Luccock states that: "Some people turn the good news around that it looks backward instead of forward. Some turn it upside down so that it looks downward instead of upward to God's sky. Others turn it so that it looks inward entirely, instead of outward to a world of need."

In many respects this has been the best year for the district that we have known. To God be all the praise. The love of the brethren, the prayers of the people and the good spirit of cooperation has made our work lighter and our burdens easier to bear. Many of the churches have been faithful in paying the district budget and other interests of the church. All have worked, prayed and cooperated to the good of the work. Yakima has increased the pastor's salary to a fair support. Clarkston has also increased the pastor's salary and had a good increase in membership.

In Prospect: We believe that the district stands on the threshold of a bold adventure into victory and success for the coming year. The future is as bright as the promises of God and our faith to believe and achieve. Twin Falls, Weiser, Benton City, Walla Walla and Wenatchee are all in home missionary status. Walla Walla is making good progress with Brother Evans and his good people. The investment made there has been worth while. We must help Weiser and Benton City to negotiate a loan. We are still committed at Walla Walla for building and utilities support. We must help Twin Falls in securing a good pastor. Wenatchee is holding the Sunday School in the Y.M.C.A. building with the Roy Kneelands and the Eslingers as the main workers. Above all we must support these works with a volume of believing prayer. God does answer prayer. We must not retreat one inch. There is yet much territory to possess. We can and we will, by God's help, keep our faces into the fight. We must continue to do our utmost in each of our local churches to develop them into stronger and more spiritual light houses of life and power. We need not remain small and struggling in any place. Preachers, we must pray more and live more devotedly to Jesus Christ. We must give our churches more direction in ways and means of soul winning.

Brother Stanley Miller has bravely carried on at Benton City in the building of the new church and in pastoring the work. Brother Teddy Willingham and his good people at Weiser have kept true and loyal as they have worshipped in the home at Weiser. The Roy Kneelands have kept plugging away at Wenatchee with very little

help from outside the church. Sister Martha Meeks came to our rescue as our fine cook for the camp. The David Baileys have been a real blessing as song leaders and singers in the camp together with Sister Holley and Anna Hooker as musicians. I appreciate all who worked so well in their departments during the camp. God bless you everyone.

Personal Report: I have preached 156 times, conducted 26 church board meetings, held 15 annual business meetings, conducted 10 district council meetings, present at 4 youth council meetings, conducted 8 communion services, conducted one baptismal service, one funeral, attended church leaders conference at Indianapolis, General Conference, Mid-Winter Youth Convention, Ministerial Convention and School Board meeting. We have worked several days on camp grounds together with Brother Goss in roof coating the tabernacle, dining hall and wash room. We have planted several trees and hope someday to see the whole grounds become a grove of trees. We traveled 12,325 miles in the interest of the district. We have received our salary paid in full and all traveling expenses reported.

We pray that God shall smile upon the officers, pastors, and laymen this coming year. Let us believe, pray, give, work and persevere until Jesus comes.

Few though we may be, God has increased our strength and we are expecting that He will continue to do so.

Reports cannot portray a true picture, but they might give an idea of the situation to some extent. Numerically membership in the local societies of the

district has increased from 168 to 196, a gain of 28. The number of meetings held increased from 400 to 556. Total offerings locally for last year were \$536.45, this year \$590.79. On the two District projects, roofing for camp buildings and the Walla Walla church, a total of \$100.87. More has come in since the ending of the year.

For the national project "Operation Radio", \$16.02 has been sent to headquarters.

During the past year the district youth have held a Youth Camp, previous to the annual camp in 1957, during which God blessed and strengthened His work. The theme "Caravaning the Christ Way" was carried out in many ways throughout the Camp.

The annual District Mid-winter Youth Convention, held at Walla Walla, proved a great blessing. The district Sunday School joined with the youth to present many enlightening and profitable ideas for the churches. God met with us, according to His promises, for encouragement and incentive.

As a special project the District Youth conducted a Scripture Memorization contest on a local, zone and district level. The final "Quote Time" held at the Ministerial Convention in Spokane, proved an interesting time with Mrs. Janice Schuenemann as the winner.

As Executive Secretary I have traveled 1180 miles, written each church many times, spent innumerable hours in planning, attended the Youth Camp, the Mid-winter Youth Convention and all the Yakima Valley zone meetings.

The plans for the future, as approved by the Youth Executive Council include better organization with monthly reports from each society and zone, presentation, and execution of General Conference changes in Youth organization, and the repetition of the Scripture Memorization Contest.

Last conference the Youth were given permission to conduct a separate Youth Camp in 1958, on a conditional basis. Plans are made for this to be held at Sanders, Idaho, August 18-22.

May God continue to bless our Youth.

DISTRICT SUNDAY SCHOOL PROMOTIONAL SECRETARY'S REPORT

Dr. Neff, members of the Idaho-Washington District, and friends:

It has been a privilege and a pleasure to serve the district this past year in the capacity of District Promotional Secretary of Sunday Schools.

Last year our General Secretary, Dr. P. F. Elliott called a conference of all district promotional secretaries to meet at Indianapolis for the launching of a movement-wide Enlargement Campaign to be entered into by every local Sunday School of the Pilgrim Holiness Church. Because there were no district funds provided for your Secretary to go to this conference, we were unable to attend this meeting, and as a consequence did not know about this movement-wide enlargement campaign until after we had made our own District plans for the fall. That is why we did not enter into our church-wide Sunday School project.

However, our District Sunday School Board launched a District plan which started in September and continued through December. This plan represented a boat race... The goal was not so much who reached a destination first, but to make a 10% increase each month. The ship which failed to make this 10% was sunk. We appreciated the cooperation each school gave. I believe every Sunday School of the District made a poster which pictured the progress made by competing schools. At the conclusion of the contest, we found that 5 schools -- Weippe, Spokane, Kennewick, Wenatchee, and Walla Walla were able to show a 10% increase for the entire period of the contest.

In October it was our privilege to have Rev. Joe Brown, Dr. Elliott's assistant, to hold some rallies on the district. I accompanied Brother Brown to the zone meetings held at Kennewick, Clarkston, Post Falls, and an evening service at Spokane. Brother Brown has helped us during the year in securing materials and giving suggestions.

A new venture was tried this year. Since the Sunday School and Youth work are so closely allied, a mid-winter Youth and Sunday School Convention was held at Walla Walla. We appreciated the cooperation of all who helped to make this convention a success.

A number of Sunday School books were sold at this convention, and quite a bit of Sunday School literature was given away.

The District Sunday School Board has functioned as a board better this year, and was able to meet together several times to plan for the District work.

We want to thank pastors and Sunday School Superintendents and Sunday School Secretaries for their cooperation in sending in the monthly reports. Most of the time we received 100% cooperation.

A new Sunday School has been added to our number -- Burbank, Washington. This is a community Sunday School, but one of our good pastors and family has been pastoring it. Brother Idler has been sending in reports for the last five months, and for this period made an excellent showing.

We all rejoice with Spokane for winning the numerical banner for the year with a gain of 22. Also, honorable mention should be made of Weippe who came second with a gain of 21. Of course, we rejoice that Walla Walla won the percentage banner with a gain of 100%.

I trust that in the coming year you will pray for and stand by your District Sunday School Board and your Promotional Secretary as you have stood by us, and consider the future success of your Sunday Schools enough to send your District Promotional Secretary to the important meeting of the Promotional Secretaries of all of our districts that will be held at Indianapolis in September. An inspired and informed Promotional Secretary will mean inspired and informed District Sunday Schools.

"PILGRIM ECHOES" EDITOR'S REPORT

Dr. Neff, members of the Idaho-Washington District Conference, and friends:

Greetings in Jesus' name.

At last year's Conference, the District Council appointed me to take over the work of editing a district paper to be printed monthly. This was a new venture for me.

From the beginning and during the year I have found a good response in working with pastors and people in sending in materials. It has been a pleasure for me to try to put your paper out in a way that will give folk a good impression of you. I have endeavored to work with the departmental heads to get their materials before the people. I have appreciated working with our District Superintendent, Brother Canary.

The parsonage at Walla Walla has been a publishing house about three days each month, and an especially inky and messy place for me on the day of mimeographing. I am indebted to Brother and Sister Kenneth Snyder for helping put the paper together, and addressing for mailing; to my wife and to Anne Powell for doing the typing; to Brother G. N. Wickens for his liberality and kindness in printing the heading for the front page for two issues.

We send out 20 packages to churches, and mail single copies to 36 individuals who have requested it, including several District Superintendents and some officials at headquarters. We print 250 copies of our paper. This involves a cost of about \$10.00 per month. This cost could be cut down \$1.00 or \$1.50 per month if the large envelopes in which the churches receive their papers would be returned to the editor periodically. These envelopes are tough enough to be used for a whole year.

Let me say in conclusion: This is your paper. Use it for your revival announcements, or any coming events and news. It's up to you to send in the materials; the editor only arranges them for you.

STANDING RESOLUTIONS

1. Resolved that the district council serve as the district trustees.
2. Resolved that all recall meetings be held sixty days prior to the district conference. The district superintendent to be notified of the results of said meetings within ten days.
3. Resolved that the superintendent appoint the statistician at least two weeks prior to the conference.
4. Resolved that the conference year close May 31st and that each pastor see that correct reports from his church be sent in not later than June 15.
5. Resolved that in the quarterly meetings each church take an offering for the superintendent's travel expense to be sent to the district treasurer.
6. Resolved that the district superintendent, upon his first quarterly visit to the churches, instruct the local church board as to its duties.
7. Resolved that all committees be appointed by the district council at the close of each conference and hold office through the year, except the reception committee, which the superintendent shall appoint at the beginning of each conference.
8. Resolved that each pastor and the superintendent be given a two-week vacation with pay.
9. Resolved that each church pay their pastor his salary during camp and conference.
10. Resolved that we have a district young people's convention during the year and that it be held at a convenient time for the young people who are in school.
11. Resolved that we have a meeting for ministers and workers at least three times during the camp meeting, the district superintendent shall be in charge and all ministers and workers are urged to be present.
12. Resolved that we have a District Sunday School Committee to promote Sunday School interest in the district and to cooperate with the general

committee and that said committee be appointed by the District Council, and the District Superintendent be a member of the committee. Be it further resolved, that said committee be given one service during the annual Camp Meeting.

13. Resolved that the people who attend camp meeting be counted in attendance at their local Sunday School.
14. Resolved that we elect a district missionary president to oversee the work of the local missionary societies, and be it further resolved that each missionary society send a quarterly report to the district missionary president, and an annual report to the conference and that said report be entered in the conference minutes.
15. Resolved that we include a directory of pastoral appointments and local major officers in our minutes.
16. Resolved that two hundred and fifty copies of the district minutes be printed.
17. Resolved that each pastor give an oral report of from three to five minutes to the conference annually.
18. Resolved that a modified quarterly report, set up by the District Superintendent, take the place of standard quarterly reports.
19. Resolved that all reports to the conference be typed: be it further resolved that secretarial help be furnished the District Secretary so that the Conference Minutes be completed within a month from the ending of conference.
20. Resolved that a copy of the records of the Educational and Examining Boards shall be given to the District Secretary each year.
21. Resolved that the District Council shall approve a district home missions program, to be presented to each local church.
22. Resolved that new cabins be constructed to meet

current demands. All building plans are to be under the direction of the District Council.

23. Resolved that there shall be a separate youth camp after the district camp meeting of the year 1958.
24. Resolved that the youth council and district council approve of a general plan to accommodate the youth summer camp.
25. Resolved that the youth council be authorized to set up and operate the youth camp meeting board, subject to the approval of the district council.
26. Resolved that the district camp meeting shall convene on the second Saturday of July carrying over to and including the third Sunday.
27. Resolved that the district conference convene the Monday following the close of camp meeting.
28. Resolved that the district council appoint a camp meeting board of three to be responsible for the operation of the camp meeting. It shall be the responsibility of this board to plan and execute the operations of the various functions of the camp such as: maintenance and repair; cooking and kitchen help; the operation of the book store and the lunch stand; reservation and assignment of rooms; advertising and all other relative functions pertinent to camp meeting operation. The members of this board shall be elected respectively for one, two and three year terms.
29. Resolved that the Pilgrim Echoes be the established name for the district publication.
30. Resolved that the district council appoint an editor and arrange a means of finance for a monthly district publication.
31. Resolved that the district go on record as desiring the help of the General Superintendent on the district.
32. Resolved that the next term of office for the

representative to Western Pilgrim College Board of Directors shall be for two years, and thereafter for a term of three years.

33. Resolved that a Minister's Institute be held in the Spring and that the public be invited to the evening services only. The time, place and speaker will be arranged for by the District Superintendent and his assistant.
34. Resolved that we effect, for one year, a Pastor-Superintendent relation on the district.
35. Resolved that, since a separate Youth Camp for 1958 was conditional and whereas the success or failure of such Camp cannot be determined until after the Camp, the future of the Youth Camp be determined by the combined District Council and Youth Council after the Youth Camp. There shall be joint discussion, and separate voting. The action shall pass by a majority vote of both councils.

WAYS AND MEANS

1. Resolved that each church raise the equivalent of 12% of the receipts except building and improvement funds and evangelist's offerings to be applied on the district budget as follows: 70% for District expense; 6% for General Conference Delegate expense; 24% for District Church Extension. Be it further resolved that each church raise an amount equal to \$8.00 per member for the General Budget.
2. Resolved that all treasurers send local money for the district and general purposes to the district treasurer by the tenth of each month.
3. Resolved that each local treasurer give the pastor a monthly statement of the church's district obligation and that when in arrears the pastor and treasurer shall attempt to raise the same.
4. Resolved that a special offering be taken the last Sunday of Camp for District Home Missions and/or camp improvement.
5. Resolved that each Sunday School send 5% of their regular offering to the district treasurer for the district church extension work.
6. Resolved that the annual remuneration of the secretary and statistician be \$15.00 each, the treasurer \$30.00 and the editor of Pilgrim Echoes \$25.00. Purchasing agent to receive five cents per mile car expense.
7. Resolved that the travel expense of 5 cents per mile and entertainment for all sessions of the council except those meetings held during the camp meetings and conventions be assumed by the district.
8. Resolved that the Superintendent's salary be \$100 per month and that he receive five cents per mile when he uses his car and actual train or bus fare when traveling in the interest of the district. District to assume all district phone call expense.
9. Resolved that the district treasurer be bonded, such amount to be set by the council, and the cost to be paid out of the district expense fund.

10. Resolved that all pastors and unstationed ministers be requested to pay their tithe from ministerial remuneration to the local treasurer to be directed into the district expense fund.
11. Resolved that the district treasurer pay the equivalent of 4% of the Superintendent's salary into the pension fund of the General Church.
12. Resolved that the treasurer deposit the General Conference Delegate Fund in a savings account until needed.
13. Resolved that all pastors and their families be granted 50% discount on price of registration and meals for District Camp. Except those authorized by Camp Committee to work their way through. If working permission granted, full registration shall be paid by the person working.
14. Resolved that the camp registration fee be \$2.00 for every one six years or older. Be it further resolved that the regular cost of meals shall be \$1.00 per day or 50 cents per meal except those working their way through camp, and all children under age of 6.
15. Resolved that each church raise \$7.00 per member for Western Pilgrim College each year.
16. Resolved that 5% of all local regular Youth offerings and 5% of all regular Youth Zone offerings be sent to the Youth Treasurer monthly for district youth expenses.
17. Resolved that all District finance that is budgeted shall have prior approval of the District Conference and all special offerings of all departments have approval of District Council.
