JOURNAL OF PROCEEDINGS

The forty-sixth annual conference of the Idaho-Washington District of the Pilgrim Holiness Church convened at the District Tabernacle at Clarkston, Washington on Monday, July 18, 1960.

Reverend Charles Stewart led in the congregational singing of "Tis So Sweet to Trust in Jesus" after which Sister Laura Himmelright led our hearts in prayer.

The District Superintendent, Reverend I. G. Canary, introduced Dr. R. G. Flexon, General Superintendent of the Western Area of the Pilgrim Holiness Church, as

chairman over the conference. Dr. Flexon commented effectively about "A Planned Ministry" using I Corinthians 9:16-27 as the basis for his remarks. He urged the pastors to make the most out of their ministry, striving for greater leadership on the local level.

The chairman called for the reading of the roll, requesting each pastor of a church to answer his call by stating the number of Advocate subscriptions he would attempt to secure from his local congregation in the coming year. Ten ordained ministers, four licensed ministers, four ordained deaconesses and eleven lay delegates answered to the call of the roll.

A motion carried that all pews inside the first three posts of the tabernacle constitute the conference bar.

A motion carried that the hours of conference settings be the same as last year, i. e., 8:30-12:00 a.m.; 1:30-5:00 p.m. and 6:00-9:00 p.m.

Mrs. Betty Hall from our new branch Sunday School in Nixon, Montana was presented to the conference, gave her testimony and was seated in the conference as a guest.

Sister Eslinger from Wenatchee, Washington was granted an honorary seat within the conference bar.

Reverend and Mrs. E. W. Hall from San Gabriel, California were presented to the conference by the District Superintendent as the new pastors to Hermiston, Oregon. They gave their testimonies and were received into the conference bar.

Reverend Canary presented Reverend and Mrs. Don Sheets from Buena Park, California to the conference as new pastors to Kennewick, Washington. They gave good testimonies and were also granted seats in the conference bar.

The Chairman called for the report of the Examining Committee. Reverend Bob Meeks, one of our fine young district preachers, was received into the conference.

The list for inactive ministers was read upon call by the Chairman.

Dr. Flexon reiterated the necessity of each church hav-

ing their United Stewardship Fund paid in full to have voting privileges in the district conference.

A motion carried that all delegates be seated in the conference this year, but asserted that the United Stewardship Funds must be paid next year or those delinquent must give a written reason to the General Superintendent why it was not paid.

Th District Superintendent presented Reverend and Mrs. C. P. Pridgen and Dr. William S. Deal to the conference who heard their good testimonies and granted them honorary seats within the conference bar.

Our District Superintendent, I. G. Canary, gave a stirring report to the conference which was accepted with thanksgiving.

Assistant Superintendent, E. E. Meeks reported. A motion carried to accept it.

The Sunday School promotional secretary's report was read and accepted.

The Editor of the Pilgrim Echoes reported. A motion carried to accept the report.

The District Treasurer's report was read and accepted with gratitude.

A rising vote of appreciation was extended to our good District Treasurer, Mr. Emmett Cameron, for his splendid records.

Dr. William S. Deal, President of Western Pilgrim College, presented a monumental report which was graciously received by the conference.

The District Missionary Society President's report was read and accepted.

The Chairman called for the reports of the Resolutions Committee.

A motion from the floor carried that no speaker shall be given the floor more than twice on each subject and that each speech be limited to three minutes.

The Resolutions Committee presented the following resolutions:

Resolved that standing resolution No. 13 be amended to read, "Resolved that 200 copies of the District Minutes be printed." Carried.

Resolved that resolution No. 14 be deleted. Carried. Resolved that resolution No. 19 be deleted. Carried. Resolved that resolution No. 24 be deleted. Carried. Resolved that resolution No. 27 be deleted. Carried. Resolved that resolution No. 29 be deleted. Carried. Resolved that resolution No. 30 be amended to read, "Resolved that the District Youth President be a member of the Camp Meeting Board by virtue of his office." Carried.

Resolved that the name of our camp ground be known as Highland Park Camp Ground. Carried. (1960)

Resolved that the Assistant Superintendent be made permanent chairman of the Camp Meeting Board. Carried. (1960)

Resolved that we adopt a one week camp meeting schedule, and be it further resolved that it be held so as to conclude on the first Sunday of July. Carried. (1960)

Resolved that this conference recommend to the local churches that one other person, appointed by the pastor, assist the local treasurer in counting the offerings, and that a written record be given the pastor after each service. Carried. (1960)

Resolved that this conference go on record as being vigorously opposed to the election of a Roman Catholic as President of the United States. Carried. (1960)

Resolved that the District Missionary Societies be permitted to close the fiscal year on June the 30 instead of May 31. Lost.

A motion carried to adjourn and reconvene at 1:00 p.m. The afternoon session convened with the congregation singing "My Burdens Rolled Away" led by Reverend James Rosentrater.

A motion carried to dispense with the calling of the roll. The minutes of the last session were read and approved. A motion carried that resolution No. 15 be deleted.

The Ways and Means Committee submitted the following resolutions:

Resolved that resolution No. 14 be deleted and adopt the following substitute: "Resolved that we set a goal of five dollars per voting member per year for our Bible College Budget to be distributed 20% to Central Pilgrim College; 40% to Western Pilgrim College until the indebtedness is cleared; and 40% to a student travel fund to be administered by the council. Be it further resolved that this resolution shall be rescinded in the event of the reopening of a western zone school. Carried. (1960)

Resolved that the District Superintendent or his duly authorized representative be permitted to visit each church for the purpose of raising funds for District Church Extension needs. Carried. (1960)

Resolved that resolution No. 5 be amended to read: "Resolved that the annual remuneration of the Secretary and Statistician be \$15.00 each, the Treasurer \$120.00 and

the editor of the Pilgrim Echoes \$25.00. The purchasing agent is to receive 5ϕ per mile for car expense. Carried. (1960)

A motion came from the floor for the Ways and Means Committee to reconsider the budget as presented and bring it again to the floor. Lost for want of a second.

A motion carried to delete the 10% ceiling and leave the ceiling to the discretion of the council.

Resolved that resolution No. 1 be amended to read: "Resolved that each church raise the equivalent of 12% of the receipts except building and improvement funds and evangelists offerings to be applied on the district budget as follows: 54% for District Administration expense, and 6% for general conference delegate expense and 40% for District church extension. Be it further resolved that each church raise the amount equal to \$8.00 per member for the United Stewardship Fund.

Resolved that resolution No. 9 be deleted. Carried. (1960) Resolved that resolution No. 12 be deleted. Carried. (1960)

Resolved that the following rate schedule for District camp entertainment be adopted:

\$10.00 per person for all over twelve years of age.

5.00 per person for all between 6 and 12 inclusive.

1.00 per person for all under six.

Part time rates will be 35ϕ per day registration for those who lodge on the camp ground and 50ϕ per meal. Carried. (1960)

Resolved that each local church shall pay the assessments for the pastor and his wife for the Ministerial Benefit Association. Carried. (1960)

Resolved that the conference recommend to the local churches the following suggested minimum standard for pastors salaries:

James Rosentrater recommended for ordination.

A motion carried that we express our appreciation for our Evangelists, The Jason Felter Family, our Conference Chairman, Dr. R. G. Flexon, and the cooks and kitchen helpers.

The Chairman instructed the conference to proceed with the election of officers.

Ballots were prepared for the election of Assistant Superintendent. Reverend E. E. Meeks was elected on the first ballot.

Charles Stewart and W. L. Boone were presented to

the conference as nominees for the office of District Secretary. W. L. Boone was elected.

Because of withdrawals, Emmett Cameron was presented to the conference alone for the office of District Treasurer. He was elected.

A motion carried to recess.

Ballots were prepared for the three additional council members. Frank Evans, Charles Stewart and O. A. Wells were elected on the first ballot.

Frank Evans and E. W. Hall were presented to the conference as nominees to the Examining Board. E. W. Hall was elected.

James Rosentrater, Andrew Amos and Ronald Benjamin were presented as nominees for the Educational Board. James Rosentrater was elected for a three year term and Andrew Amos for a two year term.

A motion carried that the statististical report be accepted without being read.

A rising vote of apreciation was given to Mrs. Deloris Boone, the District statistician.

A motion carried that the time of the ordination service be at 7:30 p.m.

A motion carried to leave all unfinished business to the discretion of the District Council.

The conference adjourned.

The ordination service convened at 7:30 p.m.

The congregation joined in the singing of "Rock of Ages" and "A Charge to Keep I Have" led by Reverend W. L. Boone.

Reverend I. G. Canary, District Superintendent, led our hearts in prayer, beseeching God to inspire and direct the candidate and his wife in the ministry.

Reverend E. E. Meeks, Assistant Superintendent, read, followed by Reverend Frank Evans and Dr. William S. Deal reading II Tim. 4:1-8 and Titus 2:1-11 respectively.

Following the reading of the Scriptures, Dr. Flexon spoke to the candidate regarding loyalty in the ministry, in the home, to himself, to his congregation, and to the souls of lost humanity.

With the laying on of the hands of ordination committee, Dr. Flexon proceeded with the ordination ceremony, praying that God would truly lay His hands upon Reverend James Rosentrater and impart to him all the gifts and graces of the Spirit that must attend a successful ministry.

As the congregation sang with feeling, "Blest Be the Tie That Binds", well-wishing and blessings were conferred upon the candidate by the fellow ministers and laymen.

God laid it upon our beloved General's heart to make a plea for those who had lost the love for Jesus and His Word out of their hearts to come to the altar to which a large number harkened, weeping and groaning their way back to that sweet and irreplaceable position of joyful and present communion with the Lord of Glory.

The conference was dismissed with our souls constrained to say, "Hitherto hath the Lord helped us." Amen.

Our thanksgiving and praise ascend unto our God for His providental care upon us all throughout another year of tears and triumphs. Sister Canary joins with me in thanking each of you for your generous gift on our 25th wedding anniversary which made possible the best vacation that we have ever had. I want to thank Brother Meeks, our fine Assistant, in the wonderful way in which he came to our rescue in time of need. Our appreciation also extends to our good Council and all the Brethren and our good people throughout the district. God has answered prayer and He has given us renewed strength in body and soul. We are also grateful for the help that Brother C. P. Pridgen, has rendered in our camp. Our

hearts were blessed over and over with the gracious ministry of the Felter Family. How we do thank God for the Holy Ghost manifestations throughout our camp.

Rev. W. L. Boone and the Ernie Lewis family were greatly blessed of God in their ministry of song and music.

-TEMPORAL.

There have been some good gains in our district this year. Clarkston has made improvement in the Sunday School rooms and decorated the church throughout. They have placed a new covering on the floor in the sanctuary. Coeur d' Alene has installed a stoker in the parsonage furnace and re-wired the parsonage. Grandview has completed the basement excavation and poured the cement floor. They are making other improvements. Hermiston has drywalled and decorated Sunday School rooms and sanded the floor in the sanctuary. Kennewick has made improvements in the parsonage and church. Post Falls installed a very fine highway church sign beside their church. Walla Walla has installed a downstairs bathroom. Yakima is building much needed Sunday School rooms and rest rooms.

Camp Grounds—Five major projects have been completed on the grounds this year. The walk-in cooler installed, buildings built around cooler and for book room and registration office, dining hall tables and benches built, new dorm built with rest rooms and showers, and cement floor poured in the tabernacle. Much of this work was done by Andrew Amos, James Rosentrater, Gene Hall, Charles Stewart, Lester Boone, Keith Jones, Ronald Benjamin and E. L. Pullman. Several others also helped. The Boones, God bless them, took their vacation time to work at the camp grounds. Sr. Amos did most of the cooking for the workers. Delores Boone also assisted. Brother Amos is to be highly commended in the wonderful way in which he has managed the building projects and in the renting of the grounds to other groups. Hundreds of dollars have been saved and made through his efforts. Brothers Meeks and Cameron moved the cooler from Wapato to Clarkston. We are grateful to all our people and preachers who have given of their time and effort to make these much needed improvements. It is imperative that a boys' dorm be builded before another camp. The framing materials are on the ground and paid for.

The Benton City property has been sold and the money is to be used in district church extension in a much more suitable and larger field. Wenatchee Sunday School is continuing under the leadership of Sister Eslinger. A new Pilgrim Sunday School was organized at Noxon, Montana. Gordon Hall, a good Pilgrim layman, is our leader there. We need a good couple to go there as pastors. The opportunity is challenging.

A Word to our Laity—

Most of our laity are God fearing, cooperative and loyal Pilgrims. We thank God for you and pray that your tribe shall increase. However, some things in some of our churches need to be pointed up and corrected. 1. Pastoral Respect and Cooperation. Whatever our pastors' weakness and shortcomings, almost all of our churches are getting much more than you are paying for. How many of our laity would work all day at your regular job and then drive a school bus or do other work in order to do the work of "God's called Man"? Some, and I say this to your shame, seem to want a slave instead of a "Servant of God". Instead of exploiting your pastor's weaknesses, you ought to pray for him and hold up his hands. To withhold your tithes and support simply because you do not agree with your pastor, is purely carnal. To oppose "God's Servant", with carnal gossip and maneuver, is devilish and will cause you to lose your soul and go to Hell, unless it is repented of and restitution is made. The same is true in regard to district work. Our laity needs to show the same spirit of sacrifice and work as the pastor is required to do. If we do this, we will all make progress together.

A Word to our Pastors-

Fellow preachers, our high calling is second to none in this world. We dare not allow anything or anybody to sidetrack us in our God-called mission! Another affection, another job, or debt or burden or any other thing that would separate us from our Calling or dilute our Gospel must be accounted as sin. The true Gospel must be our "Trumpet". In "That Day", Jesus Christ will not in the least be impressed with all the gadgets and tinsel that you may have collected. He will be tremendously interested in the souls of men which have been committed to your trust. We must be after souls and true Kingdom building. Holding some so-called lines and self opinionated standards can be as damning in final results as flagrant and sinful worldliness. We must be prayerful, God-filled men, and rightfully dispense the Gospel of Jesus Christ in its glorious realities.

A Respectful Observance to Our General Leaders—

As one of the small districts, we speak with a small voice and few votes. However, our hearts are warm and we love our church. We are burdened about some fixed patterns.

- 1. The small average salary of about \$33.00, per week over the church and the loss of quality personnel is cause of serious consideration. It is no secret that we have lost scores of pastors who were of the best in quality. We have heard much about the need of better trained pastors, but we have heard no certain voice about the need for a better supported ministry. Too often our good pastors are called upon to be the "sacrifice", instead of the "Shepherd".
- 2. We are perplexed over the continued avalanche of demands from different departments of our church in our camps, over the district and in our struggling churches. Are we trying to do too much with too little? Do we need a policy of quality work more so than a quantity work? We feel that we need a General Voice speaking at the local level in behalf of the "Key" man in our whole church structure; the Pastor. The vehicle of church loyalty should travel on a two-way street.

Personal report—

We do thank God for the privilege that we have had in serving God and the church during the last six years. Some times have been of stress and strain. This is to be expected. Most times have been those of blessings and helps. We thank God for it all. We seek God's will in our life and in the work of the district. Never have we enjoyed greater cooperation from the Council and the pastors of our district.

Most of our people are loyal and sacrificing and spiritually minded. I trust that all of our churches will realize the true worth of a "God Called Man" to minister to them the fruit of everlasting life.

In the Pastoral-Superintendent relationship we have attended the Church Leaders' Conference at Indianapolis; have attended two College Board meetings; worked at the camp grounds eight days; have traveled 6,698 miles in the interest of the district, preached 34 times in district interests; visited the churches and annual meetings 26, organized one new Pilgrim Sunday School at Noxon, Montana; conducted the youth conference; assisted in district camp and two conventions. All our salary and expenses are paid in full. Our chief desire is to see souls won to Jesus Christ and His Kingdom builded on earth. God bless you every one.

WESTERN PILGRIM COLLEGE PRESIDENT'S REPORT TO CONFERENCE

To the 46th annual conference of the Idaho-Washington District of the Pilgrim Holiness Church.

It is with pleasure that I report to you at this conference something of what the Lord has helped us to do spiritually and financially this year. We are grateful for a wonderful year in every way.

Progress of the work in general

This has been a wonderful year spiritually. We have had many times of gracious refreshings from the presence of the Lord.

Our Spiritual Emphasis Week, Fall Revival, and Holiness Emphasis Week, were spiritual highlights long to be remembered. Prayer meetings in the early mornings, at noonday, in the classes, and in the evenings, have been great assets to keeping up the spiritual tide. Most of our students in our upper division of high school and in the college seem to have had definite victory, and most of them plan to give their lives to some form of full-time Christian service.

Our Gospel team workers in the churches, missions and elsewhere have been blessed of the Lord. Various types of services have been rendered by a number of our students in several of the nearby churches.

I. Statistical report

We enrolled for the entire year 46 in college, 50 in high school, and 25 in the seventh and eighth grades. We made about 21 percent gain in college enrollment this year over last, but we lost some in the high school, due to the late reopening.

We graduated 21 young people from high school and college this spring and 13 from junior high school, making a total of 34 graduates from all departments. Several of the college and high school young people are definitely going into full-time Christian service.

II. Financial report

The financial picture has also been most encouraging this year. Miss Coy has proven to be an excellent Business Office Manager. She has helped me much in financial matters concerning the School. We have been able to pay teachers' salaries in full as well as all of our current bills. Be sides, we have reduced teachers' back salaries from \$8,700 last year at this time to just over \$1,600. We have also paid almost \$3,000 on other bills. For example, we have paid \$600.00 back taxes, reduced the Warner Press bill to \$300.00, reduced the Pilgrim Publishing House bill by about \$200.00, \$200 has been paid on the sewer bill, the fire alarm system has been installed and paid for, costing about \$1,300, and \$1,300 was paid on the local church debt of \$5,000 which was being purchased for our permanent chapel.

We have met our obligations consistently, and have finished the year in the black. As of June 15, current bills were paid and there was a balance of about \$2,100 in the bank. This is the first year I can recall of late when we have been so prospered.

This condition is attributable to the fact that we have cut out extra discounts and scholarships, raised tuition in the junior high, high school and college, and that we operated a more successful collection program for student funds. The Zone giving was actually below last year's income. A few items of saving also may be noted, such as Miss Coy's new dish-washing method whereby students did their own dishes to the saving of about \$1,000 during the year. Also Mr. Tullis took over management of the grounds with student aid, saving a considerable amount of money. Careful management by others was helpful, too. It has been done largely by the blessing of God and the assistance of a fine staff and Faculty who aided the President wholeheartedly. III. My Personal Report.

During the year I have attended to all duties incident to the office of President and have also held a number of revival meetings. Offerings from three of these have been turned back to the school, amounting to over \$300.

We have covered most of the churches in the California district twice in deputational work. The response has been most gracious. Last summer we covered the Northwest districts with good results. A good number of fine students came to W.P.C. from this area.

I have preached 109 times, prayed with 88 seekers. I have conducted during the year 5 school services, traveled 11,350 miles in the interest of the School, and attended two General Board meetings. For all purposes, I have traveled about 25,000 miles.

The school group has always been graciously received everywhere we have gone. May I thank each pastor and layman for every kindness shown us in this work. We sincerely appreciate all you have done and will yet do for W.P.C. Our last year here on this campus has been a most fruitful and happy one in the Lord.

Eight schools made a gain in average attendance this year, while four schools made a loss.

- 1. Resolved that the District Council serve as the District trustees.

- 3. Resolved that the conference year close May 31st and that each pastor see that correct reports from his church be sent not later than June 15th.
- 4. Resolved that in the quarterly meetings each church take an offering for the superintendent's travel expense to be sent to the district treasurer.
- 5. Resolved that all committees be appointed by the district council at the close of each conference and hold office through the year, except the reception committee which the superintendent shall appoint at the beginning of each conference.
- 6. Resolved that each pastor and the superintendent be given a two-weeks vacation with pay.
- 7. Resolved that each church pay their pastor his salary during camp and conference.
- 8. Resolved that we have a district young people's convention during the year and that it be held at a convenient time for the young people who are in school.
- 9. Resolved that we have a district Sunday School committee to promote Sunday School interest in the district and to cooperate with the general committee and that said committee be appointed by the district council, and the district superintendent be a member of the committee. Be it further resolved that this committee be given at least one service during the annual camp meeting.
- 10. Resolved that the people that attend camp meeting be counted in attendance at their local Sunday School.
- 11. Resolved that we elect a district Missionary President to oversee the work of the local missionary societies and be it further resolved that each missionary society send a quarterly report to the district missionary president, and an annual report to the conference and that said report be entered in the minutes.
- 12. Resolved that we include a directory of pastoral appointments and local major officers in our minutes.
- 13. Resolved that 200 copies of the district minutes be printed.
- 14. Resolved that all reports to the conference be typed: be it further resolved that secretarial help be furnished the

- district secretary so that the conference minutes be completed within a month from the ending of conference.

- 24. Resolved that the youth president be a member of the camp meeting board by virtue of his office.
