**JOURNAL OF PROCEEDINGS**

The forty-seventh annual conference of the Idaho-Washington District of the Pilgrim Holiness Church convened at

the district tabernacle at Clarkston, Washington on Monday, June 26, 1961.

The conference began with Rev. Don Sheets leading the ministers and delegates in the singing of "Great Is Thy Faithfulness" after which Rev. E. E. Meeks, the Assistant Superintendent, led our hearts in prayer.

Rev. I. G. Canary, our beloved District Superintendent, introduced Dr. R. G. Flexon, General Superintendent of the Western Area of the Pilgrim Holiness Church, to the conference as Chairman. Using I Cor. 9:16-27 as a basis for his remarks, Dr. Flexon urged pastors to make their ministry effective by prayerful and deliberate planning. He incited God's men to preach scripturally, doctrinally and expositorily and then expect God to give them souls.

The chairman called for the reading of the roll to which 14 ordained ministers, 6 licensed ministers, 2 ordained deaconesses, 1 licensed deaconess, 11 lay delegates and one lay district council member responded.

A motion carried that all pews inside the first three posts of the tabernacle and the platform constitute the conference bar.

The time for the conference sessions was established as 9:00-12:00 for the morning session; 1:30-5:00 for the afternoon session; and 6:00-9:00 for the evening session.

The District Superintendent, Rev. I. G. Canary, presented the new church at Wenatchee, Washington with its pastor, Rev. E. E. Meeks, and delegate, Bob Dewey, to the conference.

The church was unanimously accepted into the conference with gladness.

The conference heard the report of the Examining Committee.

The Educational Board presented the following licentiates to the conference for approval: 4th year—Rev. A. P. Huffine, Mrs. A. P. Huffine; 3rd year—Dale Defield; 2nd year—Robert Meeks, Don Sheets; 1st year—Devere Defield, Marion King; 2nd year licensed deaconess, Mrs. Alice Fry.

A motion carried to accept the recommendations of the Educational Board.

E. W. Hall and James Rosentrater were appointed by the District Superintendent as the reception committee.

A motion carried to accept Rev. D. L. Goss into the conference as an ordained minister and Mrs. Ida Goss as an ordained deaconess.

The Chairman called for the report of the District Superintendent.

The conference received the report by standing with appreciation.

The reception Committee presented Dr. E. G. Felker, Rev. J. C. Nichols, and Rev. J. W. Partridge to the conference who heard their good testimonies. A motion carried that they be granted honorary seats in the conference bar.

The report of the Assistant Superintendent, Rev. E. E. Meeks, was received by the conference with gratitude.

The report of the auditing committee was read and approved.

Brother Emmett Cameron, the District Treasurer, read his report to the conference.

This report was gratefully accepted.

The District Superintendent read a letter of commendation to the District from Rev. R. A. Beltz, General Secretary-Treasurer, for the splendid offerings and high percentage of United Stewardship Fund paid the past year.

A motion carried to give the District Treasurer a rising vote of thanks.

The Chairman called for the report of the District Statistician.

A motion carried to accept the Statistician's report with the correction of a minor error regarding the property evaluation.

A rising vote of thanks was given to the Statistician.

The District Sunday School Promotional Secretary reported. It was accepted.

The District Youth President's report was read and accepted.



The conference heard and accepted the Pilgrim ECHOES editor's report.

Rev. Frank Evans, editor of the ECHOES, was given a rising vote of thanks.

The report of the District Missionary Society President was read and accepted.

The Chairman called for the report from the Resolutions Committee, and the following resolutions were presented to the conference:

Resolved to delete standing resolution No. 22. Carried.

Resolved to delete standing resolution No. 28. Carried.

Be it resolved that Ways and Means No. 7 be amended to read \$200.00 per month. Carried.

Be it resolved that Ways and Means No. 12 be amended to read as follows: "Resolved that we set a goal of five dollars per voting member per year for our Bible College to be distributed two-thirds directly to Central Pilgrim College, and one-third to be used for student travel to be administered at the discretion of the District Council." Carried.

Resolved that Ways and Means No. 14 be amended to read as follows:

Carried.

Resolved that all unspecified foreign missionary monies sent to the District Treasurer be applied to the United Stewardship fund until paid in full. And be it further resolved that all camp meeting offerings taken by the general interests of the denomination be first applied to the United Stewardship Fund through the District Treasurer.

A motion carried to refer this resolution back to the Committee for redrafting.

Resolved that each Sunday School tithe its income into the District Treasury for the purpose alone of promoting the District Sunday School interests. Motion lost.

Amended to read as follows: Resolved that each Sunday School give 5% of their total regular offerings into the District Treasury for the purpose alone of promoting the District Sunday School interests. Carried.

The morning session was adjourned by prayer.

The afternoon session began with the congregation singing "Praise Him! Praise Him!" led by Rev. Don Sheets, after which Rev. W. H. Harmon led us to the throne of grace.

Dr. Flexon commented briefly from a favorite passage of Scripture in John 15:7.

A motion carried to dispense with the calling of the roll.

The conference voted to allow interested members not delegates to sit to the right of the Conference Bar.

The minutes of the first session were read and approved with minor corrections.

The Chairman urged pastors to take advantage of the Ministerial Benefit Association.

Upon call of the Chairman, the Resolutions Committee continued its report.

The redrafted resolution referred to the committee was again brought to the floor and read as follows: "Resolved that all unspecified missionary offerings, both Home and Foreign, sent to the District Treasurer, be applied to the

unpaid missionary portion of the United Stewardship Fund until paid in full. And be it further resolved that all monies taken for the general interests of Foreign Missions and Church Extension at Camp be applied in the same appropriate manner through the District Treasurer.

A motion made to strike the words, "sent to the District Treasurer" carried.

A motion carried to insert General Church Extension in the places of "home" and "church extension" to keep from confusing it with District Church Extension.

It was moved to delete the last part of the motion, from "And be it further resolved . . ." to the end. Motion lost.

The resolution as amended reads as follows: "Resolved that all unspecified missionary offerings, both General Church Extension and Foreign Missions, be applied to the unpaid missionary portion of the United Stewardship Fund until paid in full. And be it further resolved that all monies taken for the general interests of Foreign Missions and General Church Extension at camp be applied in the same appropriate manner through the District Treasurer."

A motion carried to adopt the amended resolution.

It was moved that the conference receive no more reports from the Examining Committee. Lost.

Resolved that the Board of Directors of the Central Pilgrim College be requested to alter the representation on the same Board to include one ministerial representative from each District in addition to the District Superintendent. Carried.

Resolved that we proceed immediately to build a new district parsonage with volunteer labor. Be it further resolved that the present parsonage be retained indefinitely as a rental property after the new parsonage is completed. Carried.

Resolved that the following expenditures for District Church Extension be approved: Walla Walla, \$960.00; Wenatchee, \$4,080.00; Spokane, \$1,300.00; Walla Walla insurance, \$150.00. Total: \$6,490.00. Carried.

Be it resolved that Christian Education Sunday each May be utilized by the pastor to bring to the attention of

our people the need and importance of supporting our zone Bible college. And let an offering be taken this Sunday to be applied toward the district goal for our College support. Carried.

Be it resolved that our conference adopt the following Sunday School goals for the year:

1. 10% increase in average attendance.
2. 203 new enrollees in our Sunday Schools for a goal of 1000 enrolled in our district Sunday Schools.
3. Every Sunday School co-operation in the Decade of Progress program.

Resolved that we express our appreciation to Rev. Floyd Goins for his ministry among us; to Rev. and Mrs. Lester Boone, Mrs. R. G. Boone and Gay Boone for their ministry in music; and to Rev. and Mrs. Dean Felker and family for their varied ministry to us.

This resolution was accepted by a standing vote of thanks.

Resolved that we express our appreciation to our cooks, Rev. and Mrs. E. E. Meeks and Marjorie Meeks for their kind service; and to the many who helped in the menial tasks in the kitchen which contributed so much to the success and comfort of the camp.

This resolution was accepted by a standing vote of thanks.

Resolved that we give a rising vote of thanks to our beloved General Superintendent Dr. R. G. Flexon, for his ministry; leadership and presence among us. And especially do we resolve this thanks for his raising of the monies to build our new district parsonage. Carried.

Resolved that this conference request our District Secretary to give to our retiring District Superintendent, Rev. I. G. Canary, a letter of appreciation and commendation for his labors among us for these past seven years.

This resolution was accepted and carried by a standing vote of appreciation.

The following Memorials to the General Conference (1962) were presented to the district conference for approval: "Resolved that the calling of our pastors be for an in-

definite period rather than the limited one to three-year periods that are now enforced." Carried.

Be it resolved that we delete the age requirement imposed on the General Superintendents by Section 128, par. 5, stating that one may not be elected after he has passed the age of 70 years. Carried.

Be it resolved that a cumulative record of the ministers be instituted on the district level and that such a history of the preacher be required to be transferred from one district to another as he may move. Carried.

With the completion of the Resolutions-Ways and Means Committee report, the chairman requested that the conference proceed with the election of officers.

Ballots were cast for the office of District Superintendent. Rev. E. E. Meeks was elected.

Ballots were cast for the office of Assistant Superintendent. Rev. D. L. Goss was elected.

The District Council presented the names of James Rosentrater and W. L. Boone in nomination for the office of District Secretary. W. L. Boone was elected.

The Council placed the names of E. W. Hall and Charles Stewart in nomination for the office of District Treasurer. E. W. Hall was elected.

Ballots were prepared for three Advisory Council members. O. A. Wells and Frank Evans were elected on the first ballot. James Rosetrater was elected on the second ballot as the third Advisory member.

The Council presented the names of Charles Stewart and W. L. Boone as nominees for the Examining Board. Charles Stewart was elected.

D. L. Goss and W. L. Boone were presented as nominees for the Educational Board. D. L. Goss was elected.

Ballots were cast for two ministerial delegates to the General Conference. Rev. Frank Evans was elected on the first ballot.

A motion carried to elect the second delegate by a plurality vote and that the second highest be the alternate. Rev. O. A. Wells was elected with Rev. Charles Stewart as alternate.

A motion carried that we extend the time of the afternoon session until the election is concluded.

Ballots were cast for Lay delegate. No election on the first ballot.

A motion carried that we elect by a plurality vote and that the second highest be alternate.

Ballots were again cast. Mrs. Ruth Coy was elected with Elbert Bailey as alternate.

A motion carried that all unfinished business be left to the District Council.

Conference adjourned.

**CONFERENCE SUNDAY SCHOOL PROMOTIONAL  
SECRETARY'S REPORT**

Dr. Flexon, members of the 47th Annual Conference, and friends:

May our God and the Father of our Lord Jesus Christ be praised for His mercies which have enabled us to so meet again.

My duties as your promotional secretary began last August with my attendance at the Conference for Promotional Secretaries held at Indianapolis last August. I wish to thank all of you who made a contribution toward this trip.

The pages of the **Pilgrim Echoes** have been our main tool in disseminating information to you. These monthly reports and articles thus appearing were written to emphasize basic truths necessary for progress.

A five-year record system for each school showing the Sunday-by-Sunday attendance has been set up to improve the accuracy of reports as well as to preserve the statistical information.

The District showed a loss of thirteen in average attendance for a 1.7% loss.

We have tried vigorously to promote the Decade of Progress Program of the denomination. Seven schools qualified completely in the competition for the District Trophy. Clarkston won it with a total of 9,367 points. Clarkston



won the highest average attendance gain with thirteen. Wenatchee won the highest percentage gain with 37½%; Grandview showed a gain of 7½%; Kennewick, 5%; and Walla Walla, 3%.

Ten schools have qualified for the 1962 competition for the District Trophy.

We urge you to support the program set up by the Committee for the next year by voting its approval, and you are also urged to vote us necessary funds to operate.

Your demand for leadership from us is our highest compliment. Your prayers for us is our greatest need. Your cooperation is urged for the success of our schools. Our consolation is that you want to go forward, and will.

### MEMORIALS TO 1962 GENERAL CONFERENCE

Be it resolved that the calling of our pastors be for an indefinite period rather than the limited one to three years periods that are now enforced.

Be it resolved that we delete the age requirement imposed upon the General Superintendents by Sec. 128, par. 5, stating that one may not be elected after he has passed the age of 70 years.

Be it resolved that cumulative record of the ministers be instituted on a district level and that such a history of the preacher be required to be transferred from one district to another as he may move.

### STANDING RESOLUTIONS

1. Resolved that the District Council serve as district trustees.

2. Resolved that all recall meetings be held 60 days prior to the district conference, and that the District Superintendent be notified of the results of said meeting within ten days.

3. Resolved that the conference year close May 31st and that each pastor see that correct reports from his church be sent not later than June 15th.

4. Resolved that in the quarterly meetings each church take an offering for the Superintendent's travel expense to be sent to the district Treasurer.

5. Resolved that all committees be appointed by the District Council at the close of each conference and hold of-

fice through the year, except the reception committee which the superintendent shall appoint at the beginning of each conference.

6. Resolved that each pastor and the superintendent be given a two-weeks vacation with pay.

7. Resolved that each church pay their pastor his salary during camp and conference.

8. Resolved that we have a district young people's convention during the year and that it be held at a convenient time for the young people who are in school.

9. Resolved that we have a district Sunday School Committee to promote Sunday School interests in the district and to cooperate with the general committee and that said committee be appointed by the district council, and the district superintendent be a member of the committee. Be it further resolved that this committee be given at least one service during the annual camp meeting.

10. Resolved that the people that attend camp meeting be counted in attendance at their local Sunday School.

11. Resolved that we elect a district Missionary president to oversee the work of the local missionary societies and be it further resolved that each missionary society send a quarterly report to the district missionary president, and an annual report to the conference and that said report be entered in the minutes.

12. Resolved that we include a directory of pastoral appointments and local major officers in our minutes.

13. Resolved that 200 copies of the district minutes be printed.

14. Resolved that all reports to the conference be typed: be it further resolved that secretarial help be furnished the district secretary so that the conference minutes be completed within a month from the ending of conference.

15. Resolved that a copy of the records of the Educational and Examining Boards shall be given to the district secretary each year.

16. Resolved that new cabins be constructed to meet current demands. All building plans are to be under the direction of the district council.

17. Resolved that the district conference convene the Monday following the close of camp meeting.

18. Resolved that the district council appoint a camp meeting board of three to be responsible for the operation of the camp meeting. It shall be the responsibility of this board to plan and execute the various functions of the camp such as: maintenance and repair; cooking and kitchen help; the operation of the book store and lunch stand; reservation and assignment of rooms; advertising and all relevant functions pertinent to camp meeting operation. The members of this board shall be appointed respectively for one, two and three year terms.

19. Resolved that the Pilgrim Echoes be the established name for the district publication.

20. Resolved that the district council appoint an editor and arrange a means of finance for a district publication.

21. Resolved that ministers' institute be held in the spring and that the public be invited to the evening services only. The time, place and speaker will be arranged for by the District superintendent.

22. Resolved that the reports of all officers to be published in the minutes be limited to 400 words except the report of the district superintendent and that the officers reporting be the Treasurer, Sunday School Promotional Secretary, Youth President and the Missionary Society President.

23. Resolved that the district youth president be a member of the camp meeting board by virtue of his office.

24. Resolved that the name of our camp ground be known as Highland Park Camp Ground. (1960)

25. Resolved that the Assistant Superintendent be made the permanent chairman of the camp meeting board. (1960)

26. Resolved that this conference recommend to the local churches that one other person, appointed by the pastor, assist the local treasurer in counting the offerings and that a written record be given the pastor after each service. (1960)

27. Resolved that we adopt a one-week camp meeting schedule, and be it further resolved that it be held so as to conclude on the first Sunday of July. (1960)

28. Resolved that the Board of Directors of the Central Pilgrim College be requested to alter the representation on the same board to include one ministerial representative from each district in addition to the district superintendent. (1961)

29. Resolved that we proceed immediately to build a new district parsonage with volunteer labor. Be it further resolved that the present district parsonage be retained indefinitely as a rental property after the new parsonage is completed. (1961)

30. Be it resolved that the conference adopt the following Sunday School goals for the year:

1. 10% increase in average attendance.
2. 203 new enrollees in our Sunday School for a goal of 1000 enrolled in our district Sunday Schools.
3. Every Sunday School cooperating in the Decade of Progress program. (1961)

### WAYS AND MEANS

1. Resolved that each church raise the equivalent of 12% of the receipts except building and improvement funds and evangelists' offerings to be applied on the district budget as follows: 54% for district administration expense; 6% for General Conference delegate expense and 40% for district church extension. Be it further resolved that each church raise the amount equal to \$8.00 per member for the United Stewardship Fund.

2. Resolved that all treasurers send local money for the district treasurer by the tenth of each month.

3. Resolved that each local treasurer give the pastor a monthly statement of the district obligation and that when in arrears the pastor and the treasurer shall attempt to raise the same.

4. Resolved that a special offering be taken the last Sunday of Camp for district church extension and/or camp improvement.

5. Resolved that the annual remuneration of the secretary and statistician be \$15.00 each, the treasurer \$120.00 and the editor of the Pilgrim Echoes \$25.00. The purchas-

ing agent is to receive 5¢ per mile for car expense.

6. Resolved that the travel expense of 5¢ per mile and entertainment for all sessions of the district council and all other committees appointed by the district council except those meetings held during camp meeting and conventions be assumed by the district.

7. Resolved that the district superintendent's salary be \$200.00 per month and that he receive 5¢ per mile when he uses his car and actual train or bus fare when traveling in the interest of the district. Also the district is to assume all district phone call expense.

8. Resolved that the district treasurer be bonded, such an amount to be set by the council, and the cost be paid out of the district expense fund.

9. Resolved that the district treasurer pay the equivalent of 4% of the Superintendent's salary into the pension fund of the General Church.

10. Resolved that the treasurer deposit the General Conference delegate fund into a savings account until needed.

11. Resolved that all district finance that is budgeted shall have prior approval of the district conference and all special offerings of all departments have approval of the district council.

12. Resolved that we set a goal of five dollars per voting member per year for our Bible College to be distributed two-thirds directly to Central Pilgrim College and one-third to be used for student travel to be administered at the discretion of the district council. (1960)

13. Resolved that the district superintendent or his duly authorized representative be permitted to visit each church for the purpose of raising funds for the district church extension needs. (1960)

14. Resolved that we adhere to the following district Administration budget, to be exceeded only by a two-thirds vote of the council: (1960)

22. Be it resolved that Christian Education Sunday each May be utilized by the pastor to bring to the attention of his people the need and importance of supporting our zone Bible College. And let an offering be taken this Sunday to be applied toward the district goal for our college support. (1961)
