JOURNAL OF PROCEEDINGS

The forty-ninth annual conference of the Idaho-Washington District of the Pilgrim Holiness Church convened at the District tabernacle at Clarkston, Washington on Monday, July 8, 1963.

The conference began with Reverend D. Gene Whetstone leading the ministers and delegates in the singing of

"The Way of the Cross Leads Home", after which Reverend M. A. King led in prayer.

Reverend E. E. Meeks, District Superintendent, introduced Dr. Melvin H. Snyder, General Superintendent of the Western Area of the Pilgrim Holiness Church, as chairman of the Conference.

After reading a portion from Revelation 3:7-13, Dr. Snyder effectively challenged the hearts of preachers and laymen alike with an analysis of the seven churches. He projected the four likenesses of all the seven churches under the headings of Spiritual Perceptibility, "He that hath an ear, let him hear", Spiritual Conflict, "him that overcometh", Spiritual Accountability, "I know thy works", and Spiritual Responsibility, "unto the angel of the church".

At the call of the chairman, the roll of conference delegates was read, to which 11 ordained ministers, 5 licensed ministers, 2 ordained deaconesses, 11 lay delegates, and the District Missionary Society President responded.

A motion carried that the seats within the first three posts of the tabernacle, and the platform, constitute the conference bar. The chairman called for the delegates to be seated within the conference bar.

The time for the conference sessions was established as 8:30 - 12:00 for the morning session; 1:30 - 5:00 for the afternoon sessions; and 6:00 - 9:00 for the evening session.

The report of the District Superintendent was read and received with appreciation.

The District Secretary read the report of the Assistant Superintendent, and the conference approved it.

The auditor's report was received.

A motion carried for the District Treasurer to read only the balance sheet, and the totals for the remainder of the report. The conference gratefully received the Treasurer's report.

The District Superintendent appointed James Rosentrat-

er and A. P. Huffine as the reception committee.

Deloris Boone and Alice Fry were appointed as the committee on Memoirs.

The Reception Committee presented Reverend and Mrs. Martin Swinney, pastors of the Pilgrim Holiness Church of Vancouver, Washington, to the conference who heard their testimonies. They were granted honorary seats within the conference bar.

At the request of the chairman, each pastor present presented a brief personal report from his church. The conference approved the reports.

At the call of the chairman, the Statistician began her report.

The morning session was adjourned by expiration of time.

A motion carried to start the afternoon session at 1:00 P.M. instead of 1:30 P.M. as previously scheduled.

Afternoon Session

The afternoon session began with the singing of "Near The Cross", led by Reverend Devere DeField.

Reverend Don Sheets led in prayer.

The minutes of the morning session were read and approved.

Reverend and Mrs. O. K. Biddlingmeier, the new pastors at Walla Walla, were presented to the conference, who heard their testimonies, and voted to receive them into the conference bar.

The Statistician's report was resumed and approved.

A motion carried to have each pastor supplied with sufficient report forms, so that Quarterly reports be sent to the District Statistician, as well as to the District Superintendent.

The report of the District Missionary Society President was read and accepted.

The Resolutions Committee reported to the conference with the following recommendations:

Resolved that resolution number 12 be amended to read: Resolved that the reports of all officers to be published in the minutes be typed, and limited to 400 words, except the report of the District Superintendent, and that the officers reporting be the Treasurer, Sunday School Promotional Secretary, and the Missionary Society President. It was approved.

Standing resolutions numbers 14 and 15 were deleted.

It was recommended that Standing Resolution number 17 be deleted. After discussion, this recommendation was lost, and the Standing resolution was amended by striking the word "immediate".

A recommendation carried that Standing resolution number 19 be amended to read: Resolved that secretarial help be furnished the District Secretary so that the conference minutes may be completed within a month from the ending of conference.

Conference approved the recommendation that Standing Resolution number 21 be amended to read: Resolved that there be a District Camp Meeting Board, composed of the District Youth President, and two additional members, appointed by the District Council for one and two year terms respectively. It shall be the responsibility of this board to plan and execute the various functions of the camp such as: maintenance and repair, cooking and kitchen help, the operation of the book store and lunch stand, reservation and assignment of rooms, advertising and all relevant functions pertinent to the camp meeting operation.

Resolutions numbers 23 and 29 were deleted.

A resolution carried to express appreciation to our Camp workers through a general resolution.

A recommendation to amend Standing Resolution number 32 was carried. It now reads: Resolved that we express our appreciation to Brother and Sister E. E. Meeks for their

hospitality and work behind the scenes during Camp and Conference.

The following new resolutions were presented and approved:

Resolved that all District Officers accepting offices, be punctual and faithful in the organization and execution of their responsibilities.

Resolved that during each camp, opportunity to be baptized be given candidates for baptism.

Resolved that we effect a temporary Pastoral-Superintendent relationship.

Resolved that the time for Annual Conference sessions be established as 8:30 - 12:00; 1:00 - 5:00; and 6:00 - 9:00.

Resolved that the pews inside the first three posts of the tabernacle, and the platform, constitute the conference bar.

The Ways and Means Committee reported with the following recommendations:

That existing Ways and Means Resolution number 1 be amended by striking the words 54% and 40%; and substituting the words 50% and 44% respectively. Carried.

That existing Ways and Means Resolution number 6 be amended by striking the words \$55.00 per week; and substituting the words \$25.00 per week. Carried.

That Ways and Means Resolution number 5 be amended by striking the words \$120.00; and substituting the words \$180.00. Carried.

The following resolutions presented by the Ways and Means Committee were approved.

Resolved that the District Parsonage be placed on the rental market, and that the receipts therefrom be placed in the District Church Extension Fund.

Resolved that the funds in the New District Parsonage Fund, be transferred to the District Church Extension Fund.

The report of the Examining Board was presented to the conference, and the following was ratified:

To be ordained: Reverend Francis Aeschliman, Reverend Donald Sheets, Mrs. A. P. Huffine.

To be advanced to 4th year license: Reverend Devere DeField, Reverend Dale DeField, Reverend Robert Meeks.

To be retained in 2nd year license: Reverend W. H. Harmon, Reverend Albert Weaver, and Reverend Curt Heath.

To be retained in 1st year Deaconess license: Edith Aeschliman. To receive 1st year Deaconess license: Pearl Higdon.

After a 5 minute recess, the conference again assembled and sang a verse of "We'll Work Till Jesus Comes."

The conference proceeded with the election of officers, and the results were as follows:

Reverend E. W. Hall was elected as Assistant District Superintendent.

Reverend James Rosentrater was elected as District Secretary.

Reverend W. L. Boone was elected as District Treasurer.

Ballots were cast for the election of Advisory Members of the District Council.

The afternoon session was adjourned by expiration of time.

Evening Session

The Ordination service began with Reverend James Rosentrater leading the congregation in singing "A Charge to Keep I Have."

Prayer was offered by Reverend M. A. King, followed by the congregation singing "Rock of Ages".

District Superintendent E. E. Meeks presented the candidates for ordination, Don Sheets, Francis Aeschliman and Bernice Huffine, to Dr. Melvin H. Snyder, General Superintendent, and to the conference.

Reverend O. A. Wells read from the Word of God from I Timothy 3:1-16; followed by Reverend W. L. Boone, reading from II Timothy 4:1-8; and Reverend E. W. Hall, reading from Titus 3:1-12.

Dr. Snyder then brought a searching message from II Chronicles 16:7-10, using as his theme, "The Preacher God Wants". This preacher was described by Dr. Snyder as, (1) A man who will be quiet enough to hear God's voice. (2) A man who will be courageous enough to preach the message. (3) A man who will be honest enough to live the message.

With the laying on of hands, Dr. Snyder and the ordination committee proceeded to ordain the candidates to the ministry.

The election tellers reported the results of the first ballot for Advisory Members of the Council. Reverend M. A. King and Reverend D. Gene Whetstone were elected. Ballots were cast again, and Reverend O. A. Wells was elected as the final member of the District Council.

Ballots were cast for three year term on the Educational Board. A. P. Huffine was elected.

Ballots were cast for three year term on the Examining Board. E. W. Hall was elected.

Sister Martha Meeks was elected as District Missionary Society President.

The Committee on Memoirs presented memorial statements in memory of Reverend Ida Garner, Brother Edward Watson, and Brother Julian Satre, all of whom passed from the visible church to the church triumphant during the past Conference year. The members of the conference stood in reverence, while District Superintendent E. E. Meeks offered fervent prayer in behalf of the loved ones left behind.

A motion carried to receive the report of the Committee on Memoirs.

A motion prevailed to authorize the District Council to approve the minutes of the final session of the conference,

and to conduct any unfinished business.

As a token of appreciation, a love offering was received for Superintendent and Mrs. E. E. Meeks.

The Conference was adjourned.

DISTRICT SUPERINTENDENT'S REPORT

To our Chairman, Dr. Melvin Snyder, General Superintendent, to our good pastors, to our fine laymen, to friends of the Idaho-Washington District of the Pilgrim Holiness Church, and to the 49th annual conference, Greetings.

In the providence of God, we are permitted to gather in another annual conference, to review our successes and failures of the past year, to make plans for the future, to face up to the problems that confront us, and to earnestly seek the will of God in all our plans.

We have enjoyed the good fellowship of our good Assistant Superintendent, Brother Goss. We appreciated his wonderful help and encouragement. We also appreciated the fine Council, the pastors and their fine wives, and the laymen. We are sure that our fellowship among the ministry and laymen could not be improved; it is wonderful. We thank God for this, and are sure that He will bless this spirit. We feel all have stood by us one hundred percent.

We are thankful for a dedicated ministry. Some of them have worked and helped pay the bills of the local church and District Budget, and have forgotten their personal needs. We say, **THANK GOD FOR MEN LIKE THIS!**

God is mindful of His people. We have not had an accident nor any serious illness among our people with the exceptions of Sister Hall, Sister Wells, and Sister DeField. Thank God for His healing power for these good women.

We detect that we are in a world that is confronted with problems of every kind. There are some saying that the church is confronted with problems that it has never had before. So is the United States. The leaders of our country are not throwing up their hands in despair and saying, "If

we can solve the problems—.” It is not “if”; we are sure that it is “how”. We must discover how to meet the problems of a people who are confused, frustrated, and uncertainly seeking after materialism. We are among a people who are morally weak, intellectually strong, and spiritually defeated with no hope of the future. We are in a transitory era and the method that would solve the problems of yesterday will not work today. We find this is true in the medical world, in the agricultural world, and in the church world. We are going to have to change our methods in many ways. We can do this and not compromise. There is satanic opposition against the church such as never before, but Jesus said, “Upon this rock I will build my church and the gates of hell shall not prevail against it”. We are serving a victorious Captain; He will take us through.

We are faced with some problems that I am sure no other District has. We are on one of the greatest fields, but also on one of the hardest. We have problems which would not have been here if we had had more administration a few years ago. So, in view of this we are presenting our program to this conference.

I. THE FIRST THING IN OUR CHURCH IS TO BE SPIRITUAL.

Jeremiah 3:15 “And I will give you pastors according to mine heart, which shall feed you with knowledge and understanding”. Would we notice the words, “feed you with wisdom and understanding”. Jeremiah 10:21 “For the pastors are become brutish, and have not sought the Lord; therefore they shall not prosper, and all their flocks shall be scattered”. There are many religious teachers, some of them brilliant, preaching on mere morality, socialism, politics, questions of labor and capital, the “higher criticism”, railroad accidents, little recent events, and on everything else except those great giant truths that break down the soul, enrage Satan, gladden heaven, and disclose both the secrets of the human heart and destinies of eternity. Man’s fall and depravity produce the need of salvation; the Word

of God, the instrument of salvation; The Holy Ghost, the executive agent of salvation; eternity with its heaven or hell, the motives to salvation; and faith, the condition of salvation. These are the columnar truths in the temple of Redemption. Knock any of these columns out, and it will crumble.

In saving people, the Holy Ghost uses the truth especially designed to that end. 1.) The truth of man's fall, 2.) Human depravity and need, 3.) The Incarnation of the Son of God, 4.) Vicarious Atonement, 5.) The Personality and Agency of The Holy Ghost, 6.) The Resurrection of the dead, 7.) Heaven and hell, and 8.) Rewards and punishments. These are staple, soul-saving truths. How long has it been since you preached on them? We have many Districts and churches that have suffered division and sometimes split while preaching on the outward and many petty ideas. God gives us unction, not as a reservoir, but as a stream; not as a fountain, but as a current; not as a battery, but as a transmission. In the reservoir the water is dammed up, but in a channel the water is in perpetual flow. Jeremiah 23:1 "Woe be unto the pastors that destroy and scatter the sheep of my pasture! saith the Lord". I think some pastors in the Pilgrim Holiness Church are going to face this verse. I recommend every pastor to read "The Pastor and His People" by R. T. Williams.

II. DISTRICT ADMINISTRATION.

A. The District should have some plans which should not change regardless of change in personnel. These plans would include District Church Extension—what cities we are going into, the location, the purchasing of lots, and other items pertaining to this. Another plan included would be what is required of a pastor when he comes on the District in regards to visitation, number of hours he will be permitted to work, his attitude to the District program, and many more. This is just a sample.

B. Each church should support its pastor the very best they can with salary, donations, gifts, personal presence,

and anything else that will make it easier for the pastor. Each pastor should consider his support from the church. We recommend this be binding on each pastor. A pastor receiving less than forty dollars a week be allowed to work full time, but not over forty hours a week. A pastor receiving forty to sixty dollars should be allowed to work half time or twenty hours a week. A pastor receiving sixty dollars a week or more should not be allowed to work at all.

C. We feel there should be a meeting of the pastors and wives with the superintendent every two months. This should be a time of fellowship and discussion of the problems of each pastor. If this were done with frankness, I am sure that someone would have the idea that would be at least a partial solution to the problem. I feel our men are just as capable as any men in our church and well able to handle any pastorate.

D. We are glad for our Bible School, Central Pilgrim College in Bartlesville, and we feel that we should support it with both our finances and students. We are glad for the good number attending from this District. We want to urge every pastor to direct his young people to this school and to press upon the minds of all new converts their need for a year or more in our Bible School.

III. LOCAL CHURCH.

1. We feel that since each pastorate seems to be short, and there is seemingly no way to correct this, that each pastor should (1) Keep a file on the problems of his people that would be given to the succeeding pastor or to the District Superintendent with an explanation as to the nature of each. In every profession there is a training and briefing of the next man from the President of the United States on down, but we pastors are too proud to accept anything from the other man. The problems may not bother the new pastor, but the former pastor should have learned some things. There is no use in the next man going in and trodding the same groove for two years, then leaving, still in the same groove as the former pastor. This goes on

pastor after pastor after pastor.

(2) Every pastor should encourage his people to visit. We feel that lay visitation is the only hope for our church, and seemingly, as a general rule, the pastor and laymen are weak on this point. Therefore, each pastor should keep a complete file of his calls. This file should be turned over to the church secretary each month with a discussion of the calls. This will incite the program causing the pastor to do more if he is required to make a monthly report to the board. This may seem harsh, but every profession requires a man to produce. The ministry has no such requirement, and they are the very ones that should.

(3) Every pastor should have a building program, or a redecorative program so that we know at least two or three years in advance just what we are going to redecorate or build. There should be a file on this with each church board.

(4) Each pastor should have his church make definite plans for finances. They should have a church budget, and know what the operating expenses of the church will be for each week. The District Budget and the United Stewardship Fund should be paid. This could be taken care of in such a manner as to keep the budget current each month, and not wait until the end of the quarter before something is done about the amount in arrears. Every pastor must be able to finance his own program if he is to be a success in any church. If he cannot do this, he will be a failure on every field. This is a must in any business.

(5) The pastor should meet with the District Superintendent and his church board the number of evenings it takes to implement this program. We feel that just a call and a preaching service is not adequate for the duties of the District Superintendent. We must have definite praying if we expect anything from God. We must have a definite program with our goals and aims set.

(6) Every pastor should print a church bulletin, and one be sent to every prospective person who is on the calling list each week. This bulletin would contain the events of

the week and tell something of what the church is doing. A sermonette on salvation that is direct and to the point should be included. This will have a definite effect in the community and on the people.

Time and space will not permit us to list them all, but these are some of the plans for the future. I know we need something to make us aggressive. We must do something or die. Try one thing; if it doesn't work, try something else. Triumph is only a little "umph" added to try.

IV. OUR GOALS.

We have set the gains for a certain percent in previous years, but we feel that this is inadequate. Our goal this year is for each one to win one. This will double our membership. I believe this can be done. If it cannot be done, we are not doing very much. If we cannot call, pray, and get one in by some method or other, we need to pray through.

V. TEMPORAL GAINS.

There has been something done in nearly every church on the District this year in the way of beautifying the premises or improving the buildings. We will only mention a few here.

Grandview has made splendid gains in their building program. They have finished the basement, and it is a beautiful job. They are changing the entrance from the side of the church to the front. This will make a real improvement in the outward appearance. They have bought new chairs for the Sunday School rooms and different pews for the sanctuary. They have redecorated the parsonage and installed a new gas stove.

Post Falls has had a major building program. They have added an addition that is larger than the present building. The new addition has a full basement and a little more floor space on the main floor than is in the old church. The Sunday School rooms have been moved out of the auditorium. This makes one of the largest sanctuaries on the Dis-

trict. Brother Sheets expects to have this completed immediately.

Kennewick has made some real improvements around the premises, and in the parsonage. New gas burners have been installed in both the church and the parsonage. Brother Whetstone has labored much in and around the buildings.

VI. SPIRITUAL GAINS.

We have made some real gains in this phase of our church. We have made some gains in membership. In some places there has been the ten percent gain. We feel that our people are as spiritual as they are anywhere.

VII. MY PERSONAL REPORT.

We are glad for our church and its qualified leaders. We have appreciated our labors with Brother Snyder, and his able advice. We thank God for the wonderful harvest field of the Idaho-Washington District and for a place to work for our Lord. We feel the Pilgrim Holiness Church has had a great part in our spiritual life. The church owes us nothing, but we owe everything to the church and to God.

I have visited the churches fifty-two times, conducted thirty-four board meetings, preached one hundred nine times, attended two zone rallies, traveled approximately twenty thousand miles, held eleven council meetings, and preached two revivals. We have attended the Church Leaders and General Board meeting, attended the School Board meeting at C.P.C., attended the Ministerial meeting, attended Youth Convention. I have covered the District by Zones with Brother Snyder, visited a number of the churches with Brother Flexon and the College Quartette, and made a little over five hundred calls.

I have received my salary in full, one hundred eighty-nine dollars and eighty-three cents (\$189.83) in love offerings, fifty dollars (\$50.00) in food donations, and two hundred eighty-five dollars (\$285.00) in revivals. We have been paid in full for all the mileage we have turned in.

I have re-roofed some of the buildings, helped build a

new dorm, and spent many hours on the grounds. I appreciate the help of Brother Gene Hall on the grounds and the maintenance of the buildings.

I appreciate the help of all who helped on the grounds and buildings on clean-up days. I wish to thank Brother Boone and Brother Whetstone for their help in re-roofing the dining hall last fall.

REPORT OF THE COMMITTEE ON MEMOIRS

1. Ida G. Garner was born July 24, 1879. She came to this part of the country from North Carolina, having first attended God's Bible School in Cincinnati, Ohio.

She was a pioneer Pilgrim and served as District Superintendent of the Idaho-Washington District in its early years. Ida Goss operated a mission in Spokane for several years, and it was while in this work that she met and married her husband, the late Harry Garner. She also pastored the Post Falls Church for two years prior to her marriage.

She was a member of the Spokane Church and was active in visitation work. She passed from this life to her eternal reward on June 23, 1963.

2. Julian Satre was born in Hendrum, Minnesota, January 13, 1876. He came west when he was 16 years old, living in the Spokane and Vancouver Island area. In 1905 he purchased a farm around Post Falls, Idaho, where he also was manager of the Irrigation District for 36 years.

Bro. Satre was 72 years of age before he was converted; however, he had attended the Post Falls church for the past 38 years, and was a member for the past 15 years. He served the church as Sunday School treasurer for several terms. He drew the plans for the new building which he did not view upon completion, as he was blind for the last 7 months of this life.

He passed away at the Pinewood Manor Nursing Home, June 28, 1963, where he had been a patient for 7 months, leaving to mourn their loss, his wife and 5 children.

3. Edward Lovell Watson was born March 15, 1885 at Glouster, Ohio. At the age of 15 he was saved, but it was not until at the age of 31 that he was settled in his experience, was sanctified and dedicated his life to the Lord, responding to the call of God to work in the field of winning souls, by doing substitute preaching and home-missionary work in Kentucky.

He married Geraldine Wells at Kenton, Ohio, May 30, 1937 and after living in Akron, Ohio for 2 more years, they

moved to Seattle, Washington, where he did public utility work and continued working for the Lord by holding prayer meetings, holding jail services and helping pastors call.

For the past 14 years he and his wife and family of five children have been attending church on the Idaho-Washington District, being members of the Spirit Lake, Idaho church, and for the last 2 years, members of the Coeur d'Alene Pilgrim Holiness Church.

He passed away February 24, 1963 at the Coeur d'Alene hospital at the age of 77 years, but was active in the church up until the week preceding his death. The Sunday previous to his death, he testified to the marvelous saving and keeping power of his God and the service was blessed by the presence of God. He insisted that he would be in the services the next Sunday, but in the early hours of that day, his Master welcomed him into the heavenly worship services where praises to his God will never cease.

STANDING RESOLUTIONS

I. Conference

1. Resolved that the District Council serve as district trustees.

2. Resolved that all recall meetings be held 60 days prior to the district conference, and that the District Superintendent be notified of the results of said meeting within ten days.

3. Resolved that the conference year close May 31st and that each pastor see that correct reports from his church be sent not later than June 15th.

4. Resolved that all committees be appointed by the District Council and hold office through the year, except the reception committee which the superintendent shall appoint at the beginning of each conference.

5. Resolved that each pastor and the superintendent be given a two-weeks vacation with pay.

6. Resolved that we include a directory of pastoral appointments and local major officers in our minutes.

7. Resolved that 175 copies of the district conference minutes be printed.

8. Resolved that a copy of the records of the Educational and Examining Boards shall be given to the District Secretary each year.

9. Resolved that the Pilgrim Echoes be the established name for the district publication.

10. Resolved that the District Council appoint an editor and arrange a means of finance for the Echoes.

11. Resolved that a ministers' institute be held in the spring and that the public be invited to the evening services only. The time, place and speaker will be arranged for by the District Superintendent.

12. Resolved that the reports of all officers to be published in the minutes be typed and limited to 400 words except the report of the District Superintendent, and that the officers reporting be the Treasurer, Sunday School Pro-

motional Secretary and the Missionary Society President.

13. Resolved that this conference recommend to the local churches that one other person, appointed by the pastor, assist the local treasurer in counting the offerings and that a written record be given the pastor after each service. (1960)

14. Resolved that the laity be encouraged to report the number of calls made per month to the pastor so that the pastor may report them to the editor of the Echoes. (1962)

15. Resolved that we favor the General Executive Councils' proposal for the mergers of smaller districts and that this district conference authorize their District Council to effect the merger of our district with the Pacific Northwest District if acceptable terms can be attained. (1962)

16. Resolved that all district officers accepting offices be punctual and faithful in the organization and execution of their responsibilities. (1963)

17. Resolved that we effect a temporary Pastoral-Superintendent relationship. (1963)

18. Resolved that the time for Annual Conference sessions be established as 8:30-12:00; 1:00-5:00; and 6:00-9:00. (1963)

19. Resolved that the pews inside the first three posts of the tabernacle, and the platform, constitute the conference bar. (1963)

20. Resolved that secretarial help be furnished the District Secretary so that the conference minutes be completed within a month from the ending of conference.

21. Resolved that the district conference convene the Monday following the close of camp meeting.
