# JOURNAL OF PROCEEDINGS

# First Sitting

The Fifty Third Annual Conference of the Idaho-Washington District of the Pilgrim Holiness Church convened at 8:00 a.m. on July 3, 1967 at Clarkston, Washington. Reverend Devere DeField led in the singing of "More About Jesus" after which Reverend W. L. Boone led the conference in prayer. District Superintendent E. E. Meeks introduced General Superintendent J. D. Abbott as chairman of the conference.

Upon entering the pulpit Rev. Abbott read from II Peter 3: 1-11 and pointed out that this scripture is speaking of conditions during the last days. He also quoted an Old Testament text, "Who knoweth whether thou art come to the throne for such a time as this." The church needs an awareness to the conditions of the day. There is a work that needs to be done in these dark days. Speaking on the subject of the "Challenge of the Church" Rev. Abbott pointed out several avenues of challenge to which we must respond.

- The Challenge to Love. "Owe no man anything but to Love one another." This is a debt which can never be fully paid.
- 2. A Challenge to Give.
  - A. Tithing and offering giving is a worthy challenge.

    Many times excuses are offered instead of our tithes.

    Successful men everywhere have been great givers.
  - B. Giving of our energies is also a part of the call to loyal stewardship. However, our energies cannot be given in lieu of our tithes.
- 3. A Challenge to New Testament Purity.

  It is a great challenge to live pure and undefiled before God. There is no challenge in "getting by".
- 4. The Challenge of New Testament <u>Joy</u>. The world is looking for the mark of real joy in our lives. The genuine "Joy of the Lord" is needed today.
- 5. A Challenge to <u>Believing Prayer</u>.

  Campmeeting Prayer is necessary but the Battlefront
  Prayer is needed the other 51 weeks out of the year.

  We believe in miracles, so let's believe God to bring
  some to pass. In meeting this challenge, we save others
  as well as ourselves. Let there be a liveliness and a
  reality about ourselves which depicts an able God as our
  leader. Will we rise to the challenge? A bright future
  is before us!

Then taking the chair Rev. Abbott called the conference to order and asked the secretary to call the roll. There were 13 Ordained Ministers, 3 Licensed Ministers, 3 Ordained Deaconesses, 13 Lay

Delegates and the Missionary Society President (Mrs. Meeks) who answered the roll call. A motion carried to hear the reading of the Examining Board's report at this time and to add to the roll any new names of persons satisfactorily passing the board's examination and the vote of the conference. The following is the report of the Examining Board.

"After prayerful consideration and due examination of the persons listed, we the Examining Board make the foll-wing recommendations."

- Rev. Melville Cooper be received into the Conference as an Ordained Minister.
- 2. Rev. Ed Meeks be granted 4th year license.
- 3. Rev. Leroy Birnbrook be retained in 4th year license.
- 4. Rev. Eldon Fry be granted 3rd year license.
- 5. Rev. Curt Heath be retained in 2nd year license.
- 6. Rev. Guy Norris be retained in 2nd year license.
- 7. Rev. Larry Cameron be granted 2nd year license.
- \*8. Dale Wright be granted 2nd year license.
- \*9. Wilbur Clark be granted 1st year license.
- \*10. Darrell Hanson be granted 1st year license.
  - 11. Louisa Hutchins be retained in 1st year Licensed Deaconess
  - 12. Edith Aeschliman decided to discontinue her studies, therefore we recommend her name be dropped.
  - (\* denotes new names added to the roll.)

A motion was made that the report of the Examining Board be received with the exception of the person named in item #8. It was carried. The Chairman ruled the succeeding steps for a licensed minister in his progress towards ordination must be in the order as manual provides (i.e., starting with 1st year and advancing through 4th year; then after 2 years of active ministry he is eligible for ordination.) Therefore, since the party named in item #8 did not hold 1st year license he should be granted 1st year license instead of 2nd year. The ruling was received. (Editor's note-Due to illness Norma Jean Birnbrook did not appear before the educational and examining boards, therefore her status is continued in the directory as 1st year deaconess.)

The chairman then declared the roll to be complete and called attention to the established boundaries of the conference bar. (See Res. #18) At this time the reception committee presented to the conference Rev. John Larson, pastor of Wenatchee; and Brothers Finney and Conner, visiting ministers. A motion carried to seat Brother Larson as a voting member of the Conference and Brothers Finney and Conner were given Honorary seating in the Conference Bar. The Chairman then called for the reading of the various reports. They were given in the following order.

- District Superintendent Rev. E. E. Meeks:
   A motion carried to receive his report with thanks.
- Assistant Dist. Superintendent James Rosentrater: A motion carried to receive his report.

- 3. The District Auditor, Emmett P. Cameron:
  "I have examined the books of account of the Idaho-Wash.
  District of the Pilgrim Holiness Church and find them
  complete and in balance. They have been carefully and
  accurately maintained." Signed, Emmett P. Cameron
  A motion carried to receive his report.
- 4. District Treasurer W. L. Boone:
  The treasurer read his report and a note from the Wenatchee Church which stated their intent, God being their
  helper, to assume the property payments by the end of the
  fiscal year (June 1968). A motion was made to receive
  the report and it was carried.

Bro. Abbott delayed the reading of the reports at this time to make presentation of the "General Superintendent's Certificate of Recognition". They were presented on the basis of percentage of United Stewardship Fund which was paid as indicated in the Treasurer's Report. Those churches having 80% of the United Stewardship Fund paid were presented with One Star Certificates. Those churches were Weippe, Idaho and Grandview, Wa. Those churches having 100% of the fund paid received Three Star Certificates. They were Spirit Lake, Id., Post Falls, Id., Clarkston, Wa., and Hermiston, Or. Remarks of praise were spoken for these several churches for a fine job, and words of challenge were offered for all in the coming year. The reading of the reports continued.

- 5. District Sunday School Promotional Sec**y** James Rosentrater A motion carried to receive his report.
- 6. Dist. Missionary Society President Martha Meeks:
  After the reading of the report, the chairman called the attention of the delegates to the many fine posters which were prepared and displayed by the various societies. A motion carried to receive the report.
- 7. District Statistician Deloris Boone:
  After the reading of this report the chair commented on
  the exceptionally fine work of the statistician in preparing and presenting her reports. A motion carried to
  receive her report.

Momentarily deviating from the presentation of reports the Chairman presented a copy of the current issue of the Pilgrim Holiness Advocate. He explained its relation to the Merger activity and directed our attention to the many fine articles which should prove to be informative to all. He suggested that many would want to purchase extra copies and pass them out to neighbors and friends. A motion carried to recess for ten minutes at this time

After the recess the Chairman called for a report from the Resolutions Committee. The recommendations from the committee were given as follows:

Part "A" - Changes in Standing Resolutions

- 1. Recommended and moved that Res. #2 be amended to read:
  "Resolved that Pastoral Recall be held on the 1st Sunday
  of April each year and that the pastor give his answer
  within 15 days after the recall vote." Carried.
- 2. Recommended and moved that special mention be made of Res. #14 and that participation be encouraged. The Chairman drew the attention of the conference to the resolution.
- 3. Recommended and moved that Res. #21 be amended to read:

  "Resolved that the District Sunday School Board be granted one service on the Camp Schedule, in addition to the Sunday Morning Sunday School hour, for the purpose of presenting the Promotional Program. The time of the service to be set by the Dist. Supt. and the Promotional Sec'y."

  It was carried.
- 4. Recommended and moved that Res. #28 be amended to read:
  "Resolved that each local church receive an offering for
  Camp food prior to Camp Meeting, and the pastors encourage
  donations of canned fruit and vegetables, and the District
  Council appoint one person to contact the churches for
  this purpose prior to camp." Motion received a 2nd, but
  after some discussion was referred back to committee for
  re-wording. (See further report from committee in the
  Second Sitting.)
- 5. Recommended and moved that Res. #34 be deleted and the following resolution be received in its place. "Resolved that we have an annual Dist. Youth Retreat. The dates and schedule of activities to be established by the Youth Council and the approval of the District Council." Carried.

The two final items of Part "A" of the resolutions committee's report were held until the latter part of the conference.

Part "B" - New Resolutions.

- 1. This resolution, though not recommended by the committee, was introduced to the conference for discussion.

  "Resolved that we sell the Dist. Campgrounds and that the District rent campground facilities for the District Camp."

  After considerable discussion a motion carried to refer this matter to the Dist. Council for study, but with no power to negotiate a sale.
- 2. Recommended and moved by the committee that..... "In view of the prevailing spirit of the age, the tendency to lukewarmness, and the imminent return of Jesus Christ, be it resolved that the Idaho-Washington District adopt the following theme, "The Time Is Now For Spiritual Renewal". Be it further resolved that we:
  - A. Fast and pray at least one meal each week
  - B. Promote a bible reading program to read the Bible through in one year

- C. Organize and encourage a  $^{1}$ personal witnessing campaign.  $^{1}$ The conference humbly approved the motion.
- 3. Recommended by the committee and moved that, "Resolved that this conference establish a Comity Committee comprised of the District Council for the purpose of studying the future district boundaries in connection with the merging of the Pilgrim Holiness Church and the Wesleyan Methodist Church." It was carried.

The Chairman then called for the report of the Ways and Means Committee. Their report was given as follows:

- 1. Recommended and moved that Res. #6 be amended to read:

  "Resolved that the salary of the Dist. Supt. be \$40.00 per
  week to be supplemented by generous donations and offerings
  from the churches at the Superintendent's two yearly calls.

  The district will assume all district phone expense, utilities, postage and office supplies." It was carried.
- 2. Recommended and moved that Res. #12 be amended to read:

  "Resolved that this conference recommend that each local church pay the assessments of the Ministerial Benefit Assn. for their pastor and his wife, one half of the pastor's family medical insurance premium, and one half of the Social Security assessment on the pastor's salary from the church." It was carried.

A motion from the floor carried that the District Superintendent be included in the benefits of the preceding motion. Another motion from the conference carried that the District Secretary inform the local churches as soon as possible by way of mimeo copy of all new resolutions passed by the conference.

The report of the Memoirs Committee was then read to the conference. (Full text of which appears elsewhere in these minutes). It was noted that both young and old were named in the report, causing us all to realize the brevity of life and that the torch carried by the departed must now be carried by others. At this point the Chairman asked Rev. Meeks to appoint tellers for the balloting. He did so by appointing James Rosentrater (chairman and reporter), Lester Boone, Bob Meeks, Charles Stewart, John Larson and Devere DeField. Since the time for the first sitting had expired, Rev. Abbott asked the conference to stand for adjournment and in prayerful memory of those departed as named in the Memoirs Report. The first sitting was adjourned after a motion passed asking all delegates to report back for the afternoon sitting at 1:00 p.m.

# Second Sitting

The conference was called back to order at 1:00 p.m. by Chairman Abbott and all joined in spontaneously singing "Precious Name". The conference was led in prayer by Mrs. Alice Fry. A motion

carried to commit the reading and approval of the minutes to the District Council.

The next order of business was the election of the various officers and committee members. The results of the balloting are:

Assistant District Superintendent - James Rosentrater

District Secretary - Gene Whetstone

District Treasurer - W. L. Boone

Examining Board - M. A. King was elected to the 3 year term.

Educational Board - John Larson elected to the 3 year term.

Missionary Society President - Martha Meeks

Advisory Members to the Dist. Council - D. L. Goss, M. A. King, John Larson

C.Y.C. Director - Alice Fry

P.E.L.T. Director - James Rosentrater

Delegates to International Conference \_\_\_

Chairman Abbott briefly outlined the duties and activities of the elected delegates in relation to the final International Conference of the Pilgrim Holiness Church and the merging conference of the Wesleyan Church. After reading a printed directive as to how delegates were to be elected, the result of the balloting is as follows:

Ministerial Delegates - There were no nominations presented so the balloting proceeded as to the voters' choice. A motion carried to elect as delegate the person receiving the highest number of votes, with the first and second alternate positions to be filled by the second and third highest number of votes respectively. Elected were: W. L. Boone - Delegate, James Rosentrater - 1st Alternate, and D. L. Goss - 2nd Alternate.

Lay Delegates - A motion carried to receive nominations which had been previously selected by the Dist. Council. They were Ralph Bond, Al Bailey and Lane Dayton. Again a motion carried to elect as delegate the person receiving the highest number of votes and the alternates in relation to number of votes cast. The results: Ralph Bond - Delegate, Al Bailey - 1st Alternate, and Lane Dayton - 2nd Alternate.

A discussion ensued concerning the Ministerial Convention. An invitation from the Coeur d'Alene church was extended by the pastor, W. L. Boone, subject to the approval of the local church board. A motion was made to accept the invitation. Carried. Another motion carried to authorize the Dist. Council to schedule dates for the Ministerial Convention. At this point Rev. E. E. Meeks, pastor of Clarkston church, offered to host the Mid-Winter Youth Convention. A motion was made to accept the invitation. It was carried.

The chairman then asked the Resolution Committee to return and report on their recommendation concerning Res. #28. The recommendation was presented to the conference as follows: "Resolved that the conference establish a "Camp Meeting Stewardship Club" with membership participation of 504 per month, and that the pastors encourage membership among the local congregations."

After some discussion a motion was made to amend the recommendation to the effect that the name be "The Clarkston Campmeeting Association" and that "dues be set at \$2 annually". The amended motion Did Not Carry. A second motion to amend the recommendation which provided that persons be a member of the "Campmeeting Stewardship Club" and have the "privilege of buying shares in the club at the rate of 50¢ per share per month". After more discussion this amendment also was lost. A motion was made to refer the entire matter to the District Council to write the resolution as seemed best to the council. It was carried.

At this time the Chairman called the attention of the conference to the Special Offer currently appearing in the Pilgrim Holiness Advocate and being offered to new members enrolling in the Pilgrim Pension Plan.

A motion was made that all unfinished business be left up to the discretion of the District Council. It was carried.

Again the Chairman called upon the Resolution Committee to make its final recommendations to the conference. Res. #36 was read and a motion carried to receive the resolution as read. Res. #37 was read and a motion carried to re-affirm the contents of the resolution. This concluded the report of the Resolutions Committee.

General Superintendent J. D. Abbott made a few timely remarks during the closing moments of the conference, one of which was, "Our electing of officers means more than just marking a ballot." His comments were heartly received. A motion carried to adjourn the conference and the District Superintendent was called upon to dismiss the conference with prayer. The conference adjourned at 3:55 p.m.

# DISTRICT SUPERINTENDENT'S REPORT

To our General Superintendent Abbott, ministers, delegates, and friends to the Fifty-third Annual Conference of the Idaho-Washington District of the Pilgrim Holiness Church, greetings.

Once again we are gathered together by the providence of God. We will view the work at hand, make new resolutions, and delete some, as we prepare to make a better framework for the District. We are in an age of organization and committees. It is not more organizations we need, but more of the Holy Ghost. We need a going-down before God until we witness a pentecost of the early Church that caused them to grow by leaps and bounds. The people said, "They are turning our city upside down with their doctrine.

We feel we are living in a night of pitch-blackness, where the good is obscured and the bad is flaunted, paraded, and displayed before the people. We are in the day of the Great Society, which is a supercilious generation. The tinsel of this world is the

ultimate of their lives. Immorality, pleasure and position seem to be the goal in life or the success of this people. We need to lift Christ up in this pitch-blackness of apostasy, inconstancy, fickleness and indecision. We have suffered such a change in the church world until we have lost our moorings or anchor, the Lord Jesus Christ. We are adrift and do not know where we will come to bearing. May we hold the blood-stained banner of the Lord Jesus Christ up, that saves from sin and worldliness. John 15:7 says, "If ye abide in me, and my words abide in you, ye shall ask what ye will, and it shall be done unto you." What a challenge to our hearts. "The darker the night, the brighter the Light."

I still believe that old-fashioned John the Baptist preaching brings old-fashioned repentance and praying through. We have had so much of this believe stuff until the Church is filled with a Calvinistic doctrine. John the Baptist called sin, sin. Preachers, we need to call sin, sin, and worldliness, worldliness. We are in a day of mini-skirts, and they have pervaded, permeated, and impregnated the Holiness movement. Hollywood has invaded the ranks of the church through TV. It is just as much wrong to watch Hollywood on a twenty-inch screen as it is on a twenty foot one. These things used to be preached against, such as dances, shows, theaters, horse-races, promiscuous bathing, ball games, where gambling is, and many other things. I am still against these and have no thought of changing. If there is any doubt of where I stand, this clarifies it.

PASTORAL REPORT: We have had a number of churches this year to increase their pastoral support. This was done a number of times without any urge from the District Superintendent. This speaks well of our laymen.

CYC - We have been able to implement the CYC Program in some of our churches, this year. The district director has visited a number of churches and there are some who are going to start this program. We would like to see the CYC in every church on the district. We have found that it stabilizes the attendance of the Sunday School by having these children during the week.

DISTRICT INDEBTEDNESS: We have been able to see the district indebtedness go down every year in the district church extension program. We have been able to pay the Spokane property off this year. The total indebtedness has been reduced from approximately \$30,000 five years ago to around \$10,000.00. This is outstanding for a mere handful of members who have to take care of their local churches also.

IMPROVEMENTS: There has been improvement in nearly every church on the District. The Coeur d'Alene church has started a building program that will be the same as a new church when completed. They were unable to build a new one because of restrictions, but they could remodel their old one to any extent.

The Weippe church has been in a major building program for two

years. It has added Sunday School rooms, enlarged the sanctuary, changed the front until it does not look like the same building.

The Spirit Lake property has been improved in both the church and the parsonage. The addition to the parsonage has been completed and new cabinets have been installed in the kitchen. There has been a new furnace installed in the church, and it has been painted and otherwise improved.

The above 3 churches have paid for these improvements as they have built.

Chimes are being installed in the Clarkston church and new storm doors have been added to the parsonage. The old part of the church has been repainted as well as most of the parsonage. The bathroom and the kitchen in the parsonage have been redone by putting ceramic tile in the bathroom, formica on the cabinets in the kitchen and new linoleum in both rooms.

The Hermiston church has purchased a warehouse and it has been torn down and the lumber will be used for a new parsonage while the old parsonage will be used for Sunday School rooms. This church has done exceedingly well under the direction of Brother Rosentrater.

A new bathroom has been installed in the Kennewick parsonage, and other improvements have been made.

New carpet has been installed on the platform and down the aisle of the Spokane church. They have also refinished the pews in the sanctuary.

SPIRITUALLY: We have had a number of conversions over the district this year. We feel that we are still going ahead and telling the story of salvation. It is bringing results. The Hermiston church has been able to conserve a larger percentage of the results and they have had a substantial gain in membership this year.

PERSONAL REPORT: I am grateful for our church and its leaders. I want to express my appreciation to our Assistant Supt., Bro. Rosentrater, and the District Council. Bro. Rosentrater has been a real Brother in the Lord and has helped in anything that he has been asked to do. I would like to give a word of gratitude to the pastors for their loyal support and for the many fine meals and nights of lodging their wives have given me. I appreciate the Pilgrim Holiness Church.

I have visited the churches thirty-seven (37) times, conducted eighteen (18) board meetings, preached one hundred twenty eight (128) times, travelled approximately twenty four thousand, seven hundred twenty-four miles (24,724), attended eleven (11) zone rallies, held nine (9) council meetings, attended the school board meeting, attended the Church Leaders Conference, attended the Sunday School convention and performed many other duties essential to this office.

I have received my salary in full besides \$87.71 in love offerings, some food donations, and many deeds of kindness from the laity throughout the year. I have been paid for all—the mileage I have submitted to the District Treasurer.

I have spent many hours on the camp grounds mowing the grass and fixing the buildings.

I would like to express my appreciation to Sister Meeks for her faithfulness in all things.

Again I will quote the verse of Scripture in I Cor. 15:58, "Therefore, my beloved brethren, be ye steadfast, unmoveable, always abounding in the work of the Lord, forasmuch as ye know that your labor is not in vain in the Lord."

# REPORT OF DISTRICT PROMOTIONAL SECRETARY

To the 53rd Annual Conference of the Idaho-Washington District, we greet you in the Name of Jesus Christ, the Good Shepherd who gave His life for the sheep.

The year 1966-67 has been marked by a general good spirit of cooperation with the District program, on the part of the District Sunday Schools. There was an excellent response to the Idaho-Washington "500" race, for which considerable healthy enthusiasm was generated.

In checking the record, it becomes apparent that our Sunday Schools did a commendable job of getting monthly reports in. Of the 13 Sunday Schools, 3 reported on time every time. On the other hand, only 3 Sunday Schools reported late more than 2 times. Of the 150 report cards forthcoming during the year, only 27 were late.

The Sunday Schools did somewhat less than perfect in paying the 5% assessment. The District average, however, was approximately  $4\frac{1}{2}\%$ . Of the 13 Sunday Schools, 11 reported in the Decade of Progress program. This is very encouraging, since the highest number reporting any other year during the decade thus far was 8.

Clarkston is to be congratulated as the Sunday School of the Year, winning for the second time the Decade of Progress trophy, and with a margin of 5,240 points over the nearest competitor.

The District Sunday School Board has served the District well in the following manner:

- 1. Planning and presenting the District Program for the year.
- Approving for the people of the District, 3 area Sunday School-Conventions for their benefit.
- 3. Considering and ruling on a number of questions brought to their attention, resulting in better understanding in our Sunday School operation.
- Planning and presenting the 3 promotional services during Camp.

While we have been encouraged by some of our statistics, we are disappointed in some others. District-wide, we have suffered an enrollment loss of 54, and an average attendance loss of 11. While these figures do not reveal reasons, they certainly do indicate that there is something amiss.

Some recommendations for the year are in order:

- 1. 100% participation in the Decade of Progress.
- Full implementation of the Redemptive Numerals District Program, in order to recover our losses and achieve our 10% increase.
- Full participation by all Sunday Schools in area Sunday School Conventions.
- 4. Every Sunday School reporting every month, on time.

- 5. Religious attention to monthly Workers' Conferences.
- 6. Every Sunday School using the PELT Program.

If we set for ourselves some clear goals and pursue those goals under the direction of the Spirit of God, I am confident that we shall be able to render a better accounting at next Conference.

Also, he was a familiar figure at the Spokane Rehabilitation Center, where he had charge of the basket-weaving department, and likewise in many Spokane nursing homes. He maintained a regular schedule as he visited these homes, traveling by city bus to a different home each day, with a regularity which nursing home patients could depend upon. He had also served with the Army infantry in World War II.

Left to mourn his passing are a sister and two brothers.

She is survived by a daughter, three sons, a sister and two brothers, ten grandchildren and nine great grandchildren.

Mr. Roy A. Fullerton passed away September 7, 1965 and his wife, Irene M. Fullerton, passed to her heavenly reward on May 3, 1967. Both were members of the Pilgrim Holiness Church for 45 years. They had resided at Spokane for 32 years. Brother Fullerton was a member of the District Council, serving as District Treasurer. He had served as Sunday School Superintendent of the McGuire church for 17 years. Sister Fullerton at the same time had been active in the church teaching Sunday School classes at McGuire and Spokane for 23 years. - 2. A motion carried that the matter of the new project for the year be left with youth council. The project is a new stove for Spokane parsonage.

A memorial fund was started by Bro. and Sr. Glen Whittenberg, in memory of their daughter, Glenda, to be used to send someone who cannot afford to pay to the Youth Retreat each year. Bro. Abbott spoke of this investment and how it may lead to seeing a soul saved.

The remaining order of business was the election of officers. The result of the balloting is as follows:

# STANDING RESOLUTIONS

# I. Conference

- 1. Resolved that the Dist. Council serve as dist. trustees.
- 2. Resolved the Pastoral Recall be held on the 1st Sunday of April each year and that the pastor give his answer within 15 days after the recall vote. (Amended 1967)
- 3. Resolved that the conference year close May 31st and that each pastor see that correct reports from his church be sent not later than June 15th. Be it further resolved that the Dist. Statistician be authorized to reject all annual reports reaching him (or her) after the deadline.
- 4. Resolved that all committees be appointed by the District Council and hold office through the year, except the reception committee which the superintendent shall appoint at the beginning of each conference.
- 5. Resolved that each pastor and the superintendent be given a two-weeks vacation with pay.
- Resolved that we include a directory of pastoral appointments and local major officers in our minutes.
- 7. Resolved that 175 copies of the district conference minutes be printed.
- 8. Resolved that a copy of the records of the Educational and Examining Boards shall be given to the Dist. Seciy each year.
- 9. Resolved that the <u>Pilgrim Echoes</u> be the established name for the district publication.
- 10. Resolved that the District Council appoint an editor and arrange a means of finance for the Echoes.
- ll. Resolved that a ministers' institute be held in the Spring. The time, place and speaker will be arranged for by the District Superintendent.
- 12. Resolved that the reports of all officers to be published in the minutes be typed and limited to 400 words except the report of the District Superintendent, and that the officers reporting be the Treasurer, Sunday School Promotional Secretary and the Missionary Society President.
- 13. Resolved that this conference recommend to the local churches that one other person, appointed by the pastor, assist the local treasurer in counting the offerings and that a written record be given the pastor after each service. (1960)
- 14. Resolved that the laity be encouraged to report the number of contacts and calls made per month to the pastor so that the pastor may report them to the editor of the <u>Echoes</u>. (1962)
- 15. Resolved that all district officers accepting offices be punctual and faithful in the organization and execution of their responsibilities. (1963)
- 16. Resolved that we effect a temporary Pastoral-Superintendent relationship. (1963)
- 17. Resolved that the time for Annual Conference sessions shall be established as First Sitting 8:30 to 12:00; Second Sitting 1:30 to 5:00; Third Sitting 6:30 to 9:00.
- 18. Resolved that the pews inside the first 3 posts of the

- tabernacle, & the platform, constitute the conf. bar. (1963)
- 19. Resolved that secretarial help be furnished the District Secretary so that the conference minutes be completed within a month from the ending of conference.
- 20. Resolved that the district conference convene the Monday following the close of camp meeting.
- 21. Resolved that the District Sunday School Board be granted one service on the Camp schedule, in addition to the Sunday AM Sunday School hour, for the purpose of presenting the District Sunday School Promotional program; the time for this service to be set by the District Superintendent and the Promotional Secretary. (Amended 1967)
- 22. Resolved that the Tuesday afternoon service and one of the Morning Youth services be designated Sunday School Promotional services in addition to the Sunday Morning Sunday School service. (1965)
- 23. Resolved that the 5 days immediately preceding camp (Wed. through Sunday) be set aside as time for a Ministers' retreat; and that all regular stationed Pastors attending the retreat shall receive their regular weekly pay. (1965)
- 24. Be it resolved all pastors file quarterly reports with the District Superintendent by the 10th of the month after the close of the quarter. Further resolved any pastor failing to do so shall be amenable to the District Council. (1966)

# II. Camp

- 25. Resolved that each church pay their pastor his salary during camp and conference.
- 26. Resolved that there be a District Camp Meeting Board, composed of the District Youth President, and two additional members, appointed by the District Council for one and two year terms respectively. It shall be the responsibility of this Board to plan and execute the various functions of the Camp, such as: maintenance and repair, cooking and kitchen help, the operation of the book store and lunch stand, reservation and assignment of rooms, advertising and all relevant functions pertinent to Camp Meeting operation.
- 27. Resolved that the name of our camp grounds be known as "The Pilgrim Holiness Camp Ground", and that groups renting our facilities shall put up a temporary sign identifying their denomination while using the grounds. (1965)
- 28. Resolved that we adopt a one-week camp meeting schedule, and be it further resolved that it be held so as to conclude on the first Sunday of July. (1960)
- 29. Resolved that each local church receive an offering for camp expenses prior to camp meeting, and the pastors encourage donations of canned foods and vegetables; and that the dist. council appoint one person to contact the churches for the purpose of promoting and receiving the same. (Amended 1967)
- 30. Resolved that during each camp, opportunity to be baptized be given candidates for baptism. (1963)

# III. Sunday School

- 31. Resolved that the people who attend Camp Meeting, or other District group meetings, be counted in attendance at their local Sunday Schools. Be it further resolved that under no other circumstances, except herein described, shall a person be counted in attendance unless personally present at his own local Sunday School. (1964)
- 32. Resolved that the District Sunday School Promotional Secretary be appointed for the following year prior to the annual Conference, and that the Sunday School Committee be given at least one service during the Camp Meeting, at which the Committee shall present its plan for Sunday School Promotion and Enlargement during the coming year. Be it further resolved that said Committee shall meet at least twice during each Conference year. (1964)

# IV. Youth

- 33. Resolved that we have a district young people's convention during the year and that it be held at a convenient time for the young people who are in school.
- 34. Resolved that the minutes of the District Youth Conference be included in the regular district minutes. Further resolved that said minutes be given to the District Secretary in completed form ready for the publisher.
- 35. Resolved that we have an annual District Youth Retreat. The dates and schedule of activities to be established by the Youth Council with the approval of the District Council. (1967)

#### V. Missionary

36. Resolved that we elect a District Missionary Society President to oversee the work of the local missionary societies and be it further resolved that each missionary society send a quarterly report to the President and an annual report to the conference and that said report be entered in the minutes. (See also Resolution #17 under Ways and Means.)

# VI. Special (Annual)

- 37. Resolved that we express our appreciation to the following for their ministry and service during the 1967 Camp: Rev. H. K. Busby, camp evangelist; the Lewis family, camp singers & choir director; Alice Fry & Holly Hassinger, organists; Rev. Bob Meeks, youth president; Martha Meeks & Dee Gushulak, camp cooks; Rev. Whetstone, kitchen clean-up; Mrs. Rosentrater, dining room hostess; Rev. Rosentrater, purchasing agent; Rev. & Mrs. Litzell, World Missions representatives; Rev. & Mrs. N. N. Bonner, CPC representatives; Rev. W. N. Miller, General Church Extension representative; Rev. Boone, camp registrar; and Gen. Supt. J. D. Abbott, Chairman of the Annual Conference.
- 38. Resolved that we express our appreciation to District Superintendent and Mrs. E. E. Meeks for their hospitality and work behind the scenes during Camp and Conference.

#### New Resolutions Passed (1967)

1. In view of the prevailing spirit of the age, the tendency to

lukewarmness, and the imminent return of Jesus Christ, be it resolved that the Idaho-Washington District adopt the following theme, "The Time is Now for Spiritual Renewal". Be it further resolved that we promote this theme by encouraging all who will, to:

- A. Fast and pray at least one meal-each week,
- B. Promote a Bible reading program to read the Bible through in one year.
- C. Organize and encourage a personal witnessing campaign.
- 2. Resolved that this Conference establish a Comity Committee comprised of the District Council for the purpose of studying the future district boundaries in connection with the merging of the Pilgrim Holiness Church and the Wesleyan Methodist Church.

#### WAYS AND MEANS

- 1. Resolved that each church raise the equivalent of 12% of the receipts, excepting building and improvement funds and evangelist's offerings, to be applied on the district budget as follows: 55% for district administration expense; 38% for district church extension; 4% for International Conference delegate expense; and 3% for Church Loan Fund. Be it further resolved that the ministerial tithe from each pastor be channeled to the district administration fund through the local church-treasurer.
- Resolved that all treasurers send local monies for the District Treasurer by the tenth of each month.
- 3. Resolved that each local treasurer give the pastor a monthly statement of the district obligation and when in arrears the pastor and the treasurer shall attempt to raise the same.
- 4. Resolved that a special offering be taken the last Sunday of Camp for dist. church extension and/or camp improvement.
- 5. Resolved that the annual remuneration of the Secretary, Statistician, and Editor of the Echoes be \$30.00 each and the Treasurer be \$180.00. Be it further resolved that all authorized travel for district interests be reimbursed at the rate of 5¢ per mile, and that entertainment for all sessions of the district council and all other committees appointed by the council, except those meetings held during camp meeting and conventions, be assumed by the district.
- 6. Resolved that the salary of the Dist. Supt. be \$40.00 per week to be supplemented by generous donations and offerings from the churches at the Superintendent's two yearly calls. The district to assume all district phone expense, utilities, postage, and office supplies.
- 7. Resolved that the District Treasurer be bonded, such amount to be set by the Council, and the cost be paid out of the district expense fund.
- Resolved that the Treasurer deposit the International Conference delegate fund into a savings account until needed.
- Resolved that we set a goal of 40¢ per month per voting member for our Bible College, to be distributed two-thirds

- directly to Central Pilgrim College, and one-third reserved for administration by the District Council, for scholarships to Central Pilgrim College. (1964)
- 10. Resolved that the Dist. Supt. or his duly authorized representative be permitted to visit each church for the purpose of raising funds for the dist. church extension needs. (1960)
- 11. Resolved that two meals and one lunch be served each day at camp meeting and that the following rate schedule be adopted:

Resolved that this conference recommend that each local church pay the assessments of the Ministerial Benefit Association for their pastor and his wife; and one half of the pastor's family medical insurance premium; and one half of the pastor's Social Security assessment on his salary from the church. Be it further resolved that the Dist. Supt. be included in the provisions of this resolution. (1967)
- 13. Resolved that each Sunday School give 5% of their total regular offerings into the dist. treasury for the purpose alone of promoting the dist. Sunday School interests. (1961)
- 14. Resolved that Christian Education Sunday each May be utilized by the pastor to bring to the attention of his people the need and importance of supporting our zone Bible College, and let an offering be taken this Sunday to be applied toward the district goal for our college support. (1961)
- 15. Be it resolved that the district parsonage be placed on the rental market, and that the receipts therefrom be placed in the District Church Extension Fund. (1963)
- 16. Resolved that, in appreciation for a lifetime of service to the Idaho-Washington District of the Pilgrim Holiness Church, life-time free registration to all functions of the Idaho-Washington District be granted to Rev. and Mrs. O. A. Wells.
- 17. Resolved that each local missionary society or church send one dollar (\$1.00) per month to the District Treasurer for District Missionary Project.
- 18. Be it resolved that the local church endeavor to pay the United Stewardship Fund and Bible School budget on a monthly basis.
