PROCEEDINGS

FIRST SITTING The Third Annual Assembly of the Iowa, Missouri, Arkansas Home Missionary District of the Pilgrim Holiness Church convened at 1:30 P. M., Wednesday, May 17, 1939 at the Fair Grounds, Caruthersville, Missouri.

Rev. W. O. Bottenberg of St. Louis, Mo. led the Assembly in singing, "When We All Get to Heaven" and "Near The Cross." Rev. R. A. Beltz, Hannibal, Mo. led in prayer.

Rev. R. W. Wolfe, Secretary of Home Missions and Acting District Superintendent of this District was present and presided. He spoke feelingly of the good Providence of God that had richly overshadowed us in the past year. He read the 12th chapter of Romans and commented freely from the standpoint of energetic doing, stating that there are certain positive elements that are required in the Christian life to attain unto God's best for us.

The roll was called. A motion was made and carried that Ray Benefield, a local preacher who is pastor at Steele, Mo. be given a seat in the Assembly with full priveleges.

It was moved and seconded that the new churches at Garrison, Mo. and Blytheville, Ark. be received into the Assembly. Motion carried.

Motion made and carried that the first six rows of seats and the platform constitute the Assembly bar.

Rev. A. R. C. Howard was appointed by the Chair to serve as reception committee.

The following persons were introduced to the Avsembly and granted honorary seats in the bar: Rev. E. O. Howell, Superintendent of the Tennessee District; Rev. Elmer Moon, Rev. R. D. Brown, Rev. L. T. Wallingford, all of Tennessee; Rev. Dale G. Zeits, evangelist of Frankfort, Ind. and Rev. Paul Tharett of the Methodist Church, Rector, Arkansas.

Moved and supported that inasmuch as Brother Wolfe is serving as Acting District Superintendent that he take the official places on the committees in this Assembly, formerly held by R. A. Beltz, and that inasmuch as Rev. Edward Boone is absent that Brother Beltz serve in the place of Brother Boone. Motion Carried.

Moved and supported that all church reports be turned to the Statistical Committee and not read before the Assembly. Carried.

Moved and supported that Rev. R. W. Wolfe, Rev. F. W. Henry and Rev. R. F. Bradley serve as a Program Committee during this Assembly and Camp. Motion carried.

Motion carried that the hours of business session be from 9:30 to 11:30 A. M. each morning.

The Assembly adjourned by expiration of time following the benediction.

SECOND SITTING

The Second sitting was opened at 9:30 A. M., May 18. Rev. J. John Doll led in singing, "When We All Get to Heaven" and "Glory to Jesus." Rev. L. T. Wallingford of the Tennessee District led in prayer. Rev. A. R. C. Howard sang by special request "Amazing Grace".

Rev. E. O. Howell, District Superintendent of the Tennessee District conducted the devotional service. He read II Tim. 2:3 for a text and gave an inspiring message on "Paul's Charge to Timothy." His message embraced two outstanding facts: first, Making a good soldier; Second, To make a good soldier one must endure hardness.

The minutes of the first sitting were read and approved after corrections.

Rev. E. G. Marsh, president-elect of Colorado

Springs Bible Training School; Rev. W. E. Honeycutt of Baton Rouge, La. and Brother White of Jonesboro, Arkansas were introduced to the Assembly and on motion were granted honorary seats in the assembly bar.

By common consent the Chair was empowered to appoint two additional members on the Statistical committee. L. A. Braden and Rev. Will Brantley were appointed.

Motion made and seconded that the Chair appoint an Auditing committee. Carried. Rev. W. O. Bottenberg, Rev. J. John Doll and H. T. Nutter were appointed.

The Chair appointed Rev. R. A, Beltz as Camp and Assembly reporter.

The District Treasurer's report was read and accepted after a request for a more detailed report on Disctict funds. (See Treasurer's report).

Rev. R. A. Beltz, former district superintendent, read his superintendent's report for the five months he held the office. The report was accepted. (See District Superintendent's Report).

A motion prevailed to adjourn until 9:30 A. M. Friday. Dismissed with prayer.

THIRD SITTING

The Third sitting opened at 9:30 A. M., Friday, May 19. Rev. A. R. C. Howard led in singing, "Saved to the Uttermost" and "Heavenly Sunlight." Rev. Ellis Maness led in prayer. Rev. J. John Doll read the second chapter of II Timothy and discussed, "Constancy and Perseverance in the Christian life."

The Minutes of the second sitting were read and approved as read.

The roll was called and completed.

Brother Phillips of the Ohio District and Rev.

E. B. Overholt of the Kansas District were introduced to the Assembly and on motion were granted honorary seats in the bar.

The Chairman called for a report of the Resolution committee, which report was read and taken up in detail. (See Report of the Resolution Committee As Adopted by the Assembly).

Rev. R. W. Wolfe, chairman reported on the action of the General Board relative to appointing a District Superintendent for this District to fill the vacancy caused by the resignation of R. A. Beltz. He reported that Rev. W. O. Bottenberg had been chosen and that the Ways and Means Committee had been working out a plan for his support and he then called for a report from this committee.

The Ways and Means committee read their report. (See Report of Ways and Means Committee as Adopted by the Assembly.)

On motion the time was extended to hear further from the Ways and Means Committee.

Rev. W. O. Bottenberg was called on for a speech and spoke briefly accepting the office of District Superintendent and pledging his best efforts to the work of the District.

The Assembly adjourned by expiration of time. Rev. W. R. Miner of California gave the benediction.

FOURTH SITTING

The Fourth sitting opened at 9:30 A. M., Saturday, May 20. Rev. R. A. Beltz led in singing, "At the Cross" and "Blessed Assurance." Rev. A. C. Wieand led in prayer.

Rev. E. B. Overholt of the Kansas District led the devotional service, reading the fourth chapter of Ephesians.

The Minutes of the Third sitting were read and approved after correction.

The Auditing Committee reported that they had

examined the books and report of the District Treasurer and had found them to be correct. On motion their report was accepted.

The Resolution Committee gave their final report. (See Report of Resolution Committee as Adopted by the Assembly).

The Ways and Means Committee gave their final report. (See Report of Ways and Means Committee as Adopted by the Assembly).

Inasmuch as it is a custom of this Assembly for the District Superintendent to appoint all Assembly committees the Chair called on Rev. W. O. Bottenberg, newly appointed superintendent to make the appointment of the standing committees for next Assembly. (See pages 1 and 2 for committees as appointed).

It was agreed upon by the Assembly that since Rev. R. A. Beltz is to edit and publish the Minutes of this Assembly that he be granted the permission to include and church reports that may have arrived too late for the Statistical Committee to compile.

A fifteen minute recess was called to give the Ways and Means committee time to consider another resolution, after which time the Chair called the Assembly to order.

It was moved and supported that the District read and approve the minutes of this sitting. Motion carried. (These minutes were read and approved by the Council).

Motion made and carried that the 1939 Assembly be adjourned. The Assembly was dismissed by prayer by Rev. W. O. Bottenberg, Superintendent.

REPORT OF WAYS AND MEANS COMMITTEE AS ADOPTED BY THE ASSEMBLY

1. We recommend that all licensed and ordained ministers and evangelists of this assembly pay their tithe from income from ministerial labor into the District treasury for the support of the District Superintendent.

2. We recommend that each church and preaching point be apportioned the following amounts each month for the District Budget: (By District Budget we mean monies used for District Superintendent support and expense, District Home Missions and miscellaneous District expense).

These apportionments shall begin with the month of June and shall be sent to the District Treasurer not later than the 10th of the following month.

3. Since the above amounts do not include the General Budget, (the General Budget includes monies for Foreign Missions, General Home Missions and General Church Administrative expense) we recommend that each church raise their General Budget monthly on the basis as set by the General Assembly and the General Board.

4. We recommend that the District Superintendent visit each church and preaching point four times a year. That he be allowed the privelege of holding four revivals off the District between October 1 and May 1. (An exception shall be made this summer, giving him the privelege of holding two of these revivals this summer. The remainder of his time shall be devoted to District evangelism and Home Missionary work.

5. We recommend that the District Superintendent be paid a salary of \$50.00 a month and two cents a mile for travelling expense for travelling on the District in visiting churches and in Home Missionary work; that he be allowed expense for postage, phone calls and telegrams, the same not to exceed \$30.00 a year; that he be permitted to keep his evangelistic offerings over and above his salary, but he shall pay his own travelling expense to and from same. We further recommend that each church at the quarterly visit of the District Superintendent take an offering for him, the same to be applied on his travelling expense and the church shall be credited for this amount on their District Budget, providing it is sent to the District Treasurer.

6. Be it resolved that we ask the General Board to grant us permission to fully organize our District in the 1941 Assembly.

Be it further resolved that we petition the General Board to assist our District in the support of our District Superintendent for one year at the rate of \$30.00 a month, and the second year at the rate of \$20.00 a month for six months and \$10.00 a month for the second six months and that at the 1941 Assembly the District assume full responsibility for his support.

7. We recommend that we print 300 copies of the Minutes of this Assembly. We further recommend that we ask R. A. Beltz to print them by mimeograph, the same as last year and that he be paid \$30.00 to cover the cost of material and labor.

The Minutes shall be distributed among the churches and we urge that each pastor see that a copy is given to each family who are members of the church.

8. We recommend that the next Assembly and Camp be held at Caruthersville, Mo. August 9 - 18, 1940. The District Council shall be the Campmeeting Committee and shall organize and manage the Camp.

9. We recommend that Rev. F. W. Henry be paid \$10.00 for his services during the last year and this Assembly.

10. We recommend that we have a District Christian Worker's Convention and that we urge all Ministers, Sunday School Superintendents and Young People's leaders to attend. We further reccomend that it be held November 29 to December 1, the first service on Wednesday night and the closing service on Friday night. The District Council shall decide on the place, after receiving invitations from the churches, but inasmuch as the Camp and Assembly is at Caruthersville, we recommend that if possible it be held in the central or northern part of the District.

The program for this convention shall be arranged by the District Council.

7. Resolved that we express our appreciation to Rev. J. John Doll and the faithful cooks for their good work done in the kitchen and dining hall.

8. Resolved that we continue to build up our Pilgrim Holiness Advocate subscription list, thus endeavoring to have a leader among religious periodicals enter new homes.

9. Resolved that each church pay their offerings to deputational workers of Bible Schools, Foreign Missions and Home Missions through the District Treasurer, so that the District will get credit.

10. REPORT OF THE DISTRICT SUPERINTENDENT To the Third Annual Assembly. Iowa, Missouri and Arkansas District. Pilgrim Holiness Church: I beg to submit the following report of my labors as District Superintendent from July 1,1938 to December 1, 1938, a period of five months: Church visits made - 15. Sermons preached - 7. Churches dedicated - 1. (Garden Grove, Ia.) Miles travelled 3873. Received for travelling expense - \$77.46. Postage and miscellaneous expense - \$16.26 Salary for five months @ \$10.00 - \$50.00. During this period a new church was organized at Garrison, Mo. and a new preaching point was opened at Elytheville, Ark. and a contract made on a church property. A new parsonage was built at Lambert, Ark. and a new church building started at Stanley, Mo. From November 6 to November 21 I travelled the District with Rev. R. W. Wolfe, Secretary of Home

District with Rev. R. W. Wolfe, Secretary of Home Missions, visiting all the churches and preaching points except Springfield and Garrison, Mo.

On Decomber 1, 1938 we had ll organized churches and 5 preaching points with 531 members. There was a gain of 56 members or 11.7% during these 5 months.

Besides the travelling in the interest of the District I travelled 5,780 miles in deputation work for the General Church and 1,200 miles, to and from the General Assembly.
