Opening Session June 15, 1953

9:30 A. M.

The twelfth Annual Conference of the South Carolina District of the Pilgrim Holiness Church convened in the tabernacle at Winnsboro. South Carolina.

Remarks were made by Rev. M. T. Cockman, District Superintendent, after which Brother Taylor lead in the singing of the familiar Gospel song "Higher Ground." We were then lead to the Throne of Grace by our faithful pastor. Rev. J. H. Ellenburg.

Rev. Cockman then introduced the chairman of our conference, Rev. R. A. Beltz, General Secretary of Church Extension.

Rev. Beltz read a portion of Scripture found in I Corinthians 9:7-15. The subject of his exortations was entitled. "The Church Program For The Year." He said our object was first to glorify God, our Father, to exalt Jesus Christ, our Saviour, and to honour the Holy Spirit, second to carry out the great commission of our heaven-ascended Head by publishing the full gospel to every nation; and third, to conserve the holiness work by forming churches and aiding in placing over them Spirit-baptized pastors, who will feed the flock of God and in every way possible help to get souls ready for the coming of our Lord. Rev. Beltz stated that the following should play an important part in aiding the pastor to prepare for the church program of the year.

- The Ministry should preach the Word. 1.
- Have a continual preparation. 2.
- Be no respecter of person in his pastoral care.
- 4. Have a emphasis on spiritual revival
- 5. Take care of our financial obligations.
- 6. Sunday School, Young People's Service, Missionary Societies should have special attention.
- 7. The Ministry should have the power of the Holy Chost.

The secretary called the roll and the conference bar was fixed. The first two benches of the middle and right hand isle were established as the bar.

Rev. Taylor then read the report of last year's committees.

Rev. Friesen then introduced the guests. Rev. Marshbank, Rev. Higby, and Rev. Roland were introduced to the conference, and after a word of testimony, were given an honorary seat in the conference bar.

The report of our District Superintendent, Rev. M. T. Cockman, was read and accepted.

Rev. Beltz then revealed the action of the General Board in reference to the name of our District.

Our District, formerly the South Carolina district, shall be known as the South Carolina - Georgia District.

The report of the auditing committee was read and accepted.

The Treasurer's report was read and accepted.

The Statistician's report was read and accepted.

The Sunday School Committee's report was read and accepted. Rev. Ellenburg of Winnsboro, S. C. was presented the annual Sunday School award for the largest gain in the Sunday School this conference year.

The District Young People's Executive Secretary read his report, and it was accepted.

The Educational and Examining Board read their report. It was moved, seconded, and carried.

The morning session adjourned.

SECOND SESSION June 15, 1953 1:00 P. M.

Rev. Reltz called the conference to order.

Prayer was offered by Rev. W. L. Sutton

Rev. Beltz then called for the minutes. They were read and accepted as corrected.

The Ways and Means Committee's report was read and discussed. It was moved and accepted.

Ballots were cast for the three year term of the District Trustee. Rev. H. S. Mosser was elected.

Rev. Heltz stated that the District Superintendent, District Secretary, and District Treasurer were delegates to the General Conference, by the virtue of their office. He then stated that our conference was entitled to one ordained minister, other than the District Council, and one lay member to be delegates to the General Conference con-

wening in June of 1954. The ballots were cast and Rev. W. L. Sutton was elected as the ordained minister to be the delegate and J. H. Ellenberg was elected as the alternate delegate. The ballots were then cast for the lay delegate and Don Roland was elected on the second ballot. Miss Myrtis LeGrand was elected as the alternate delegate.

Rev. Beltz then announced the ordination service by appointing Rev. Cockman, Rev. Ellenberg, Rev. Higby, Rev. Sutton, and Rev. Friesen to serve as a ordination committee. The candidates, Rev. H. S. Mosser, and Rev. A. J. Taylor, were seated in front of the alter. The congregation was lead in the singing of Charles Welesy's well known hymn, "A Charge to Keep I Have." Rev. Beltz told the candidates that they were to serve, not to be served, they were to be well rounded in the Word. The ordination committee then placed their hands upon the candidates after which Rev. Beltz gave them their charge. The Spirit of the Lord was graciously near and a spirit of complete harmony prevailed.

It was moved and accepted that the minutes of the second sitting be left to the approval of the District Council.

Rev. Cockman lead in a closing prayer. It was moved and accepted that we adjourn.

REPORT OF THE WAYS AND MEANS COMMITTEE

The ways and means recommend that standing rule no. 7 which reads as follows:

The Sunday School offerings on the fifth Sunday shall be sent to the District Treasurer for miscellaneous District expense. We urge the churches to make this a generous offering each quarter; and standing rule No 16 which reads as follows:

Be it resolved, that the Birthday offerings be sent to the District Treasurer, to be put in a reserve fund to help defray delegates expense to General Conference in 1954. Be dropped as a standing rule of our conference and that the following resolution be adopted which reads as follows:

Inasmuch as all home missionary districts are exempted from paying the general budget, which is set in the Manual at \$5.50 per member (Pg. 97, sec. 138, paragraph 10) and

Inasmuch as this exemption was provided for by the General Conference several years ago to release home missionary districts from this financial responsibility so that they might have more money to use in church extension work in their district.

Therefore Be it Resolved, that this district assess each church at the rate of \$5.50 per member and that this money be used under the direction of the District Superintendent and District Council for church extension work in this district.

The following exemptions and reductions as provided for in the Manual on Pg. 98, sec. 138, paragraph 11, shall apply:

All newly organized churches on established districts shall be assessed but one-fourth of the general budget

quota for the fiscal year following their organization; one-half for the following year; and three-fourths the third year. From then on they shall assume their full quota.

Greetings to the 12th, Annual Conference of the South Carolina District of the Pilgrim Holiness Church.

- 9. Be it resolved, that each pastor make a monthly report of the Sunday School, giving the average attendance and the amount of offerings received immediately after the closing Sunday of each month, and that a copy be sent to the District Sunday School Secretary and also to the District Superintendent.
- 10. Be it resolved, that the District Superintendent make inspection and recommendation for painting and repairs to the tabernacle, calling upon the churches of the South Carolina-Georgia District to assist in this work.
- 11. Be it resolved, that a planned vacation Bible School be held during camp meeting week. Also the District Superintendent see that literature and teachers are available for this school.

STANDING RULES

- 1. The District Council shall set the date of the District Camp and Conference and call the workers.

- 3. There shall be a District Camp Meeting Association with dues of one dollar per member each year, money to be used in promoting the annual camp.
- he All licensed and ordained ministers shall tithe the income of their ministerial labors into the District Treasury for the support of the District Superintendent,
- 5. The churches shall raise the following amount each month toward the support of the District Superintendent.

Americus - \$6.00 Edgewood - \$6.00 Greenville- 5.00 Killian - 6.00 Lugoff - 5.00 Winnsboro - 6.00 In addition to these amounts, each church shall take a free-will offering for the Superintendent on each of his visits to apply on his traveling expenses.

- 6. The District Superintendent's salary from the District shall be \$50.00 a month, same to be paid from the ministerial tithe and the monthly appropriations from the churches.
- 7. All district funds shall be forward to the District Treasurer on or before the tenth of each month.
- 8. All church books and records shall be closed April 30th, and reports prepared for the annual district conference. The Statistical reports shall be sent immediately after this date to the District Secretary.
- 9. Each minister on the district shall contribute at least one week's work on the camp ground, subject to the call of the District Superintendent.
- 10. Each pastor shall be expected to attend the camp and conference and remain until the cleaning up is finished, unless excused by the District Council.
- 11. The District Young People's work shall be under the supervision of the District Superintendent. There shall be a Young People's Convention held in connection with the annual camp.
- 12. Be it resolved: that the week preceding Easter be a week of self-denial for the benefit of great Easter of-fering for Home Missions.
- 13. Be it resolved: that the District Treasurer, make a monthly report, on the first day of the month, to be sent to the District Superintendent.
- 14. Be it resolved: that our District Statistician have the Conference Minutes ready for publication thirty days after conference convenes.
