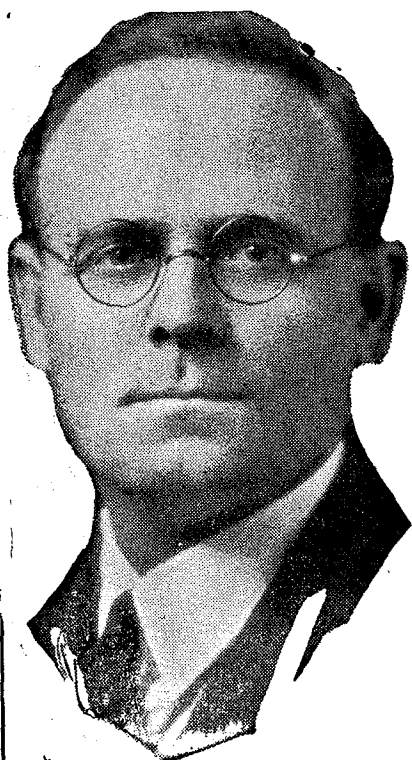

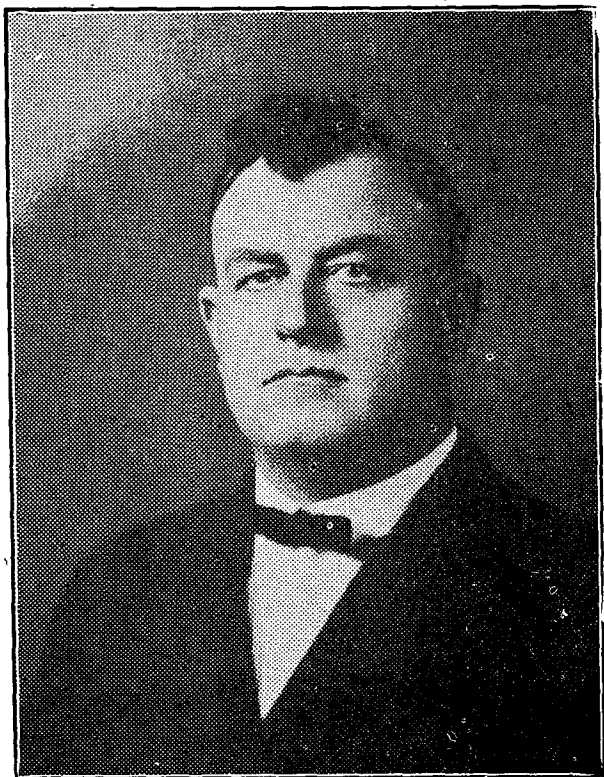

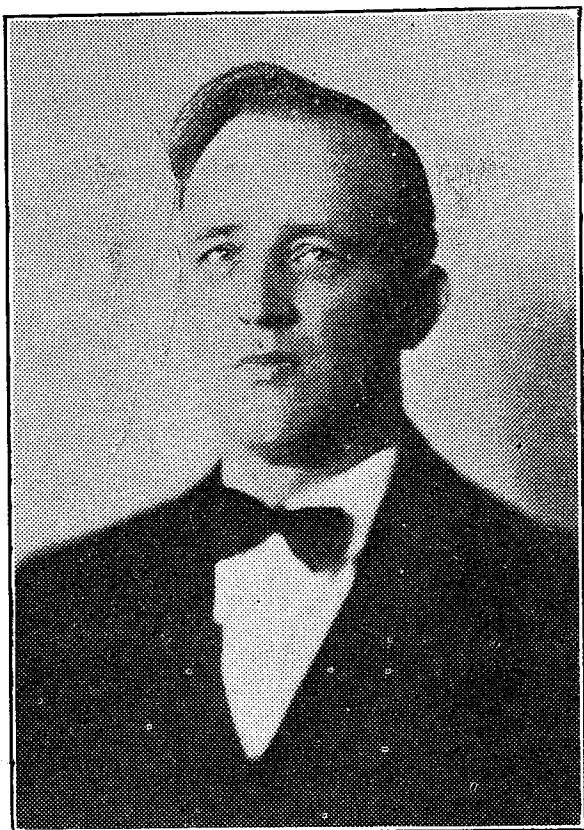

FIRST SESSION, TUESDAY MORNING, JANUARY 10th, 1933

The Twenty-eighth Annual Assembly of the Eastern District of the Pilgrim Holiness Church, comprised of Maryland, Delaware, and the Eastern Shore of Virginia, convened at Dover, Delaware, January 10th at 10:00 A. M. with the Assistant General Superintendent, Rev. W. L. Surbrook in the chair. Session was opened with the song, "All Hail the Power of Jesus' Name." Rev. H. E. Uhrig led in prayer. District Superintendent Rev. W. H. Vickers introduced Bro. Surbrook to the Assembly who read Romans 12 as a Scripture lesson and briefly commented on it.

Delegates were registered, roll was called, and the last session's minutes of last year's Assembly were read and approved.

Wheedleton be licensed, first year; that Willard and Roland Mitchell be recommended for license; that George Failing be granted first year license; that Jno. Bar be granted renewal of license; that I. A. Gurynn and Geo. Conley be granted renewal, first year license; that Mrs. H. D. Dukes be granted renewal of third year license; that C. W. Ellwanger, L. G. Meekans, L. A. Mowbray, Mrs. H. Shoemaker, and Mrs. Lola Vickers be granted renewal of first year licenses; that Srs. Winifred Mears and Mayme O. Parker be granted Evangelistic license; that Mrs. W. F. Wiggins be granted renewal, first year license; that Srs. Price and Minnie Cooper be granted renewal of Deaconess license.

Resolutions 15, 16, and 17 were read and adopted.

Moved and supported that our secretary, Bro. Dukes, be intrusted to look after the printing of the minutes.

Moved and supported we grant Bro Hope the privilege to go home. Resolutions 18 and 19 were read and adopted.

If favorable with the church the next ministerial convention will meet at Harrington, Del., if not the District Council will report a place.

Moved and supported that the District Supt appoint a committee of three to arrange subjects for the Ministerial Convention.

Moved and supported that Louetta Holden be elected president of the Young People's Society by acclamation.

Moved and supported that we excuse Bro. Bean from the Assembly.

Moved and supported that we receive Grover C. Thorp into the Assembly pending report of the examining board.

Moved and supported that we have a Young People's Convention of two days this year.

Moved and supported that resolution No. 11 be retained in our 1933 Minutes.

NEW CHURCHES

Moved and supported we receive the new church at Bishop's Head into the Assembly.

Moved and supported that we receive the new church at Cape Charles into the Assembly.

Moved and supported that we receive the new church at Chestertown.

Moved and supported that we receive the new church at Willards.

Committee was appointed by District Superintendent to form subjects for Ministerial Convention. They are: Bros. E. L. Lowry, J. O. Emerick, and H. E. Uhrig.

Moved and supported we approve the minutes by motion of Assembly.

Moved and supported that we adjourn to meet at Denton after the camp.

BE IT RESOLVED:

1. Any local church board desiring a change of pastors, should notify the District Superintendent of the same, at least sixty days before the sitting of the Assembly. Any pastor desiring a change in pastorates should notify the District Superintendent at least sixty days before the sitting of the Assembly.—Memorial to the General Assembly.

2. Whereas our Annual Assembly has grown so large that no church feels able to entertain it, and whereas the Assembly being held in mid-winter makes it still more difficult to find entertainment, be it resolved that we change the date from the second Tuesday in January to August 7, 1933 at 9 A.M. on the Monday after the close of the Denton Camp on Sunday, and that this Assembly be held on the Denton camp-ground. Carried.

3. We shall close all of the local church books on the last day of June. The District Superintendent shall attend the annual business meeting of each church, during his last visit. Carried.

4. Our next Annual Assembly shall convene in 1934. Tabled.
5. We shall close up all books May 31st, of each year. Lost.
6. Whereas there are four camp-meetings held on the Eastern District, be it resolved: That no two camp-meetings be held so that they will conflict with each other. Tabled.
7. When a church has twenty members or more, no two persons of one family shall be elected on the church board. Memorial to the General Assembly.
8. All ministers, evangelists, and singing evangelists, whether they are from the Eastern District or elsewhere, shall contribute one-half of their tithes to the support of this District's work, and that the pastor engaging such evangelists from off the District, shall notify them of this action while engaging them, collect the money and send it to the Treasurer. Tabled.
9. Inasmuch as the Pilgrim Holiness Churches of the Eastern District have found it difficult to meet their financial obligations to the District be it resolved that we economize by not obligating ourselves to pay any singers from the District budget. Lost.
10. We shall have but one Ministerial Convention during 1933, and that convention shall be held on April 18th, 19th, and 20th. Carried.
11. All necessary reports are to be in the hands of the Statistical Secretary one week prior to the date of the Annual Assembly. Carried.
12. Resolution No. 4 found in the 1932 Minutes shall be adopted for the year 1933. Carried.

Resolution No. 4 is: That our District Superintendent be both District Supt. and District Evangelist, that he devote his time to building up our District work, that is, visiting the churches, holding Home Missionary Meetings in halls and under our District tent. Be it further resolved that our pastors give him invitations to hold old-fashioned revivals in their churches, and that our District see that he has a reasonable support for said efforts. Carried.

Whereas our Young People's District Society has been of great spiritual benefit to our District, be it resolved that this Assembly appoint the necessary officers for this Society and that we petition the General Board to reconsider their action regarding same. Carried.

14. Inasmuch as the distance is so great to Colorado Springs and the traveling expenses so much, making it impossible for a full delegation to attend the General Assembly, we, the Eastern District, petition the General Board to change the Assembly to a more central location. Carried.

15: Whereas Bro. J. O. Emerick and the church at Dover have so splendidly entertained this Assembly be it resolved that we extend our appreciation by a rising vote of thanks. Carried.

16. Whereas our Assistant General Superintendent, Rev. W. L. Surbrook has so ably presided over this Assembly manifesting such a fatherly spirit, and giving such valuable instruction, be it resolved that we show our appreciation to him by a rising vote of thanks bidding him God's speed. Carried.

17. Whereas our District Superintendent has so faithfully served us the past year and whereas he has been the instrument in God's hand to enlarge the borders of our church, be it therefore resolved that we give him a rising vote of thanks. Carried.

18. Whereas we were privileged to have our General Secretary-Treasurer, Rev. P. W. Thomas present, giving us valuable information relative to General Church interests and assisting in the business of this Assembly, be it resolved that we show him our appreciation by a rising vote of thanks. Carried.

19. Whereas some of our churches are not able to pay their pastor the cash support due them, be it therefore resolved that our churches give the pastor a donation of provisions and cash monthly or quarterly, and in turn the pastor shall give them credit of the same. Carried.

20. This Assembly shall elect a Young People's Society president for the District and that this president visit the Young People's Societies on the District and do his best to organize Societies where there are none.

REPORT OF THE WAYS AND MEANS COMMITTEE

RECOMMENDATIONS:

1. We recommend that each local church take an offering equivalent to five cents per member for the purpose of meeting the expenses of our 1933 Assembly and same to be forwarded to the District Treasurer prior to the Assembly. Carried.

2. We recommend that we repeal resolution No. 10 of the Minutes of 1932. Carried.

3. We recommend that each local church appoint a Home-Missionary Secretary, for the purpose of stirring up interest in District Home-Missions in the local church, and seeing that each member and friend of the church has a chance to make a monthly contribution to that cause. Lost.

4. Whereas we have found a difficulty in the past in taking so many different special offerings to properly keep up our District and General budgets, we recommend that we combine our District and General budgets and that our Foreign Missionary money be raised separately. We further recommend that each local church sometime during each month shall take a special offering for the District and General budgets, this offering shall be equal to 10 per cent of the gross offerings of the Church and Sunday School, with the exception of building funds, all rents, foreign missions and evangelists support. Carried.

5. We recommend that each local church appoint a Home-Missionary secretary, for the purpose of stirring up interest in District Home-missions, and that each local church sees that each member and friend of the church has a chance to make monthly contributions to that cause. (This is recommendation No. 3 as amended.) Carried.

6. We recommend that each local church engage a returned Pilgrim Holiness Missionary and put on one or more missionary conventions during the year to raise equal to \$2.00 per member for the Foreign Missionary Budget. Carried.

7. We recommend that our District Superintendent receive not more than \$20.00 per week for his services, with an allowance of \$15.00 per month for house rent, seven cents per mile for the use of his truck outfit and two cents per mile for his car. We further recommend that all offerings taken in his work be reported to the District Treasurer and that the expenses of his meetings be paid from the same as directed by District Council and the remainder, if any, be applied on his salary. Carried.

8. We recommend that the 10 per cent raised in recommendation No. 4 be distributed as follows: The pastor shall instruct his local church treasurer to send one-third direct to the General Treasurer and the remaining two-thirds to the District Treasurer.

9. We recommend that this Assembly get an estimate on what it will cost to publish this "Minutes," and that each pastor, or delegate report how many they want and pay for same. Carried.

DISTRICT SUPERINTENDENT'S REPORT

To the Twenty-eighth Annual Assembly of the Eastern District of the Pilgrim Holiness Church, greetings: In many ways this has been one of the most blessed years of our ministry. It has been a year of sweet fellowship with the Lord, and our association with our preachers and the people has been about all that one could expect under present conditions.

Yet I am under the impression that much more could be accomplished if we only knew the secret of looking above the clouds of the economical depression that we have to admit hangs very low over our heads. Yet, I think that the most of us will have to recognize this fact that the "Spiritual" depression is effecting us the most.

There has been some wonderful revivals conducted on the District, and of course the churches have been edified. Yet it seems that out of so many conversions, there should be a greater growth in membership.

Several of our worthy soldiers in the ranks of the laity have been translated to heaven during the year, their names will appear in the report of the committee on memorials.

Four Churches have been organized during the year, three of which seem to be able to survive; we are fearful of the fourth, for some reason it does not seem to be able to go. This church was organized early in the year by Bro. Merrick Lowry, everything looked favorable for a while. Bro's Henry Shoemaker and W. F. Wiggins conducted a tent meeting at Chestertown, Md., which resulted in the organization of a church. Then we organized a church at Cape Charles, Va., and we organized a church and completed a church building at Bishops Head, Md.

We have covered the District twice during the year, and were called to several of the churches several other times to assist in some business problems. The singers made the first visit with me and were a great blessing to the work, they were asked for by many of our people on our last visit. During our first visit we preached to 4446 people, we

only preached to 1515 during the last visit; of course the weather was a great factor to this deduction.

Several changes have been made in pastorates, and there are several changes pending. We hope that all of such changes will be to the glory of God, and the building up of His Kingdom.

We should make every effort we can to evangelize to some extent at least the sixteen counties which are in our District absolutely untouched by our work. And I hope something will be done in this Assembly to this end. Yet from actual knowledge of the District and its activity since its organization, I will say that I believe we have had the best organized plan we have ever had for the promotion of the work of God on our District. I am confident that God has a workable plan by which we can cover our entire District.

I have received for my support from the District \$1,253.91, I have preached 320 times, have had 649 seekers, 262 professed conversions and 178 sanctifications. Traveled about 9000 miles, 3700 of which were covered in visiting the churches. I come to the close of the year feeling fine, enjoying good victory, and biting the bit to go. Thanking the Lord for the past, and am looking forward to greater victories.

REPORT OF YOUNG PEOPLE'S DISTRICT PRESIDENT FOR 1932

The Lord has surely been with us this year as we labored among the young people of this district.

The first meeting was in our home church at Dover, Del., on the regular young people's meeting night. This is the oldest society on this district. We had a splendid service with these dear young people.

The second was at Harrington, Del., on a Sunday night. The good pastor, Rev. Earl Lowry and his wife, who is president of the young people's work there, gave us a warm welcome and turned the entire service over to us. The church was full; a good part of those present being young people.

We had a gracious service at Goldsboro, Md. Sr. Mary Garrett and the young people's president, Mrs. Elliott, made us to feel welcome where we had a splendid service with another full house. There are some good young people at Goldsboro.

We then went to Milford, Del., where Bro. Shellhouse had a splendid band of young people present who wanted to be organized into a society. Here we effected an organization of twelve members. My heart was blest by seeing these young people interested in God's work.

At Bloxom Camp the pastor, Bro. Walls gave us from 1:00 to 2:00 o'clock on the last Sunday afternoon to address the young people. The tabernacle was filled before the service closed and we appreciated the privilege of speaking to the young people at that time.

The next meeting in line was the convention which was held on

Milton camp ground. It was one never-to-be-forgotten. The pastor in charge Bro. Adams, and the young people as well as older folk made us to feel welcome. 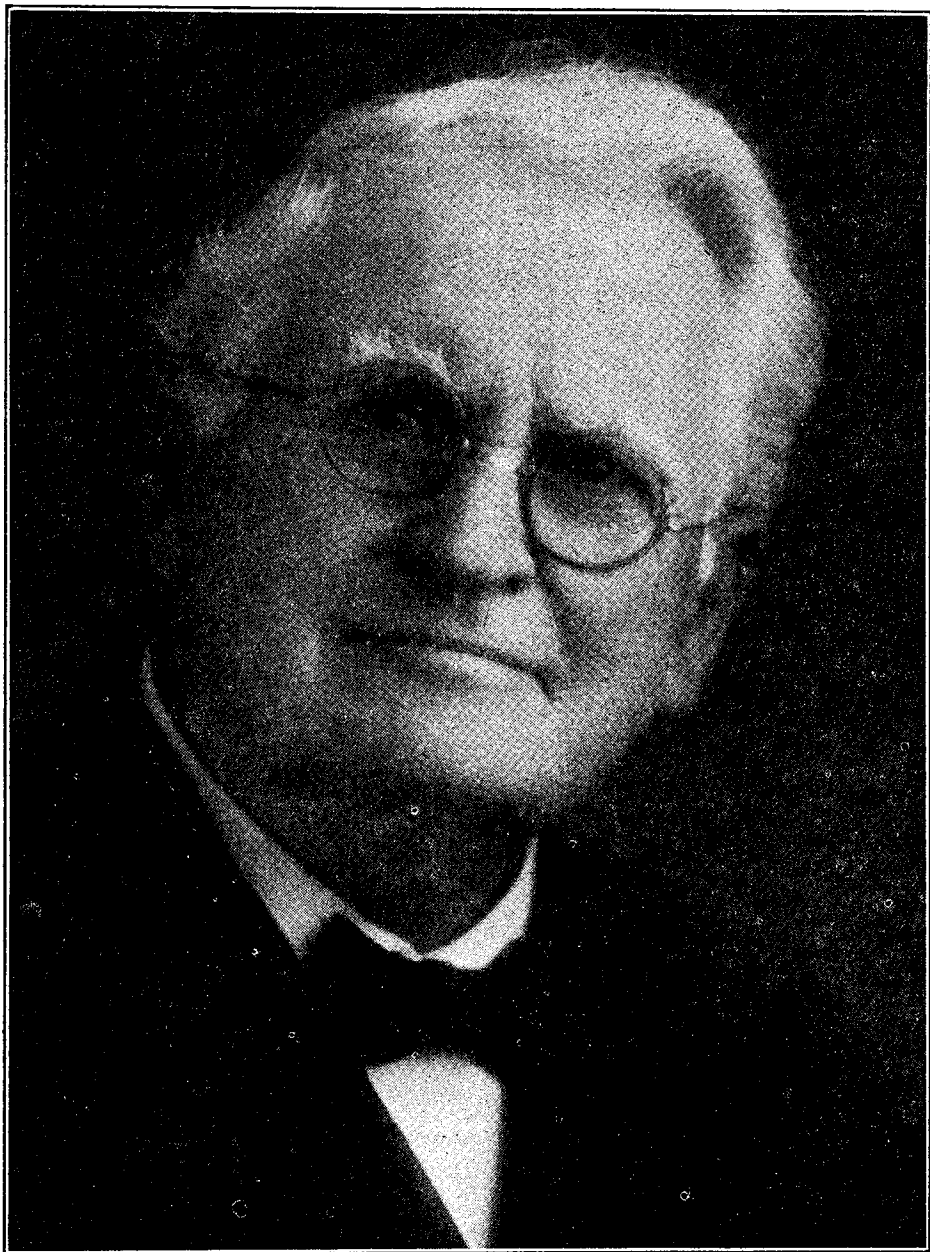

RESOLUTIONS

BE IT RESOLVED:

1. That the Sunday School offering of one Sunday in each month be used for Foreign Missions.

2. That no member from one Pilgrim Holiness Church be received into another Pilgrim Holiness Church in this district unless they receive a letter of good standing from the church of which they have been a member.

3. Whereas we have found a difficulty in the past in taking so many different special offerings to properly keep up our District and General budgets, we recommend that we combine our District and General budgets and that our Foreign Missionary money be raised separately. We further recommend that each local church sometime during each month shall take a special offering for the District and General budgets, this offering shall be equal to 10 per cent of the gross offerings of the Church and Sunday, with the exception of building funds, all rent, foreign missions and evangelists support. Carried.

4. That the offices of District Superintendent and District Evangelist be divided into two separate offices, i.e. instead of being a joint office filled by one person, it shall be two offices filled by two persons, namely the District Superintendent and the District Evangelist.

5. That all Preachers, Singers and Evangelists of this District who are not serving as pastors, pay 50 per cent of their tithes into the District budget, within the first five days of each month for Religious services rendered.

6. Whereas our Young People's Society has been of great spiritual benefit to our District, be it resolved that this Assembly appoint the necessary officers for this Society.

7. We recommend that each local church appoint a Home-Missionary secretary, for the purpose of stirring up interest in District Home-Missions, and that each local church sees that each member and friend of the church has a chance to make monthly contributions to that cause.

8. We recommend that the 10 per cent raised in resolution No. 3 be distributed as follows: The pastor shall instruct the local church treasurer to send one third to the General Treasurer and the remaining two-thirds to the District Treasurer.

9. That we have 300 copies of the Minutes printed and that the Pastors pledge the number of minutes for each church, payment to be made for the same within two months.

10. That each Pastor raise the equivalent of 5 cents per member in order to defray the expenses of the District Assembly.

11. That in order to defray the expenses of sending the delegates to the General Assembly that each Pastor take an offering equivalent to 15 cents per member, money to be in the hands of the district treasurer by the next District Assembly.

12. That we have one ministeral Convention and that the council have the privilege of setting date, selecting location, arranging topics for discussion, etc. of same.

13. That this Assembly elect a Home Missionary Board consisting of three members to supervise the evangelism in the district.

14. Whereas our General Superintendent has recently ruled that our Assembly year ends when we close our books, Be It Resolved that our books be closed June 30 and that our newly elected church board take office immediately and that all reports be in the hands of our Stasticion two weeks prior to our assembly.

15. Resolved that the district evangelist be paid \$18.00 per week and 2½ cents per mile auto expenses, allowing \$10 00 per month for house rent, also the necessary running expenses of pioneer meeting not to include board. Be it further resolved that all offerings received by the district evangelist in the district meetings be sent to the district treasurer and the evangelist paid by said treasurer.

16. That the district evangelist and the district home missionary board have the privilege of visiting the churches of the district in the interest of district Home Missions to create an interest in the churches

and plan means to raise money to make it possible to open work in the 16 counties of our district where we have no work, and that this money be used for that purpose only, and that all money raised by these representatives be applied on our 10 per cent budget of churches.

17. Whereas our General Secretary and Treasurer Rev. Paul Thomas has so ably presided over this Assembly in such a spirit of love and cheerful helpfulness, be it resolved that we show our appreciation to him by a rising vote of thanks.

18. Whereas our District Superintendent has so faithfully served us the past year and whereas he has been the instrument in God's hand to enlarge the borders of our Church, be it therefore resolved that we give him a rising vote of thanks.

19. That the District Superintendent be paid from the District Treasurer for all postage expenses relative to the district work, also secretary and treasurer included.

20. That the Churches with 50 members or more pay the District Superintendent \$10.00 a visit and the Churches under 50 members pay \$5.00 a visit.

21. That this Assembly elect a District Evangelist.

THE DISTRICT SUPT. REPORT FOR THE SIX MONTHS YEAR 1933

Bro. General Officer, the Council, preachers and lay delegation, Brethren: We are met again in the providence of God, to give an account of our stewardship, and our labours in His vineyard. It is rue, this has been a very short year brought about by an effort to change our Assembly sitting from the winter to the summer. Whether this is an advantage to our work, or a disadvantage remains yet to be seen. However, we hope the change will prove helpful in more than one way.

REVIVALS: Most of our churches have held one or more revivals during this seven months, either in the church or in a tent, and quite a number of people professed to have been either saved or sanctified, and in most every revival some are healed. Yet the very best season for revivals either in the churches or tent is just ahead of us; late summer and fall is our best revival season in this District.

DEATHS: We had hardly gotten home from our last Assembly, before the sad news reached us of the death of one of our Licensed preachers, Br. Willard Mitchell, one of our highly esteemed and respected and much beloved brothers, having laid down his armor in exchange for his golden crown, having crossed the line of worlds. However, our loss, we believe is his gain. Others have also been called away from us; they too, shall have space in these minutes in another place.

CHANGES OF PASTORATES: Several changes have been made in pastorates, and several more changes are pending. It is to be hoped that such changes will be conducive to a greater out-pouring of God's spirit upon both pastor and people. In order to effect a change of pastors proves to be no little task, since our church manual is so incomplete. It seems to be next to criminal to take a pastor away from church and leave him without a church. We can never be so religious under this present church government as it would be possible to

be, if we could help in every case, the out-going pastor also, as well as the in-coming pastor. God help us to do something to handle this difficult situation.

CHURCHES ORGANIZED OR REOPENED: There has been two churches organized. Bro. L. A. Mowbray, myself, assisted by Sisters Mears and Parker conducted a meeting in Secretary, Md., where we once had a church, but it has been closed for several years. God blessed us and we were enabled to re-organize. Bro. H. P. Adams and the Holden sisters organized a society at Girdletree, Md., and we opened a church that has been closed for many years at Wachapreague, Va. Sisters Etta Mitchell and Etta Clough, are pastoring this church, and God is blessing their efforts, and we are expecting to be able to re-organize there in the near future. We have several churches that are closed, and it is my intention to have each of them opened and doing something for God in the near future. Let us as the Council work to that end. Chincoteague, Va., Windy Hill, and Bozman, Md., are the closed churches referred to. Someone can go to these churches and have a meeting, if there is no way to sustain either of these closed churches, I believe they should be sold and the money used for District evangelism.

A CRISIS IN THE HISTORY OF OUR DISTRICT: Conditions have developed in our District, that must be handled with much prayer, much thought and much consideration, as well as all of the divine love we can possess. Our Council must be more thoughtful of the work of the Lord and the welfare of both the pastor and church. A mistake committed at this time may result in disaster. We be brethren, so let us act as "dear children" of God and "bear one anothers burdens."

MEMORIALS TO GENERAL ASSEMBLY

1. Any local church board desiring a change of pastors, should notify the District Superintendent of the same, at least sixty days before the sitting of the Assembly. Any pastor desiring a change in pastorates should notify the District Superintendent at least sixty days before the sitting of the Assembly.

2. When a church has twenty members or more, no two persons of one family shall be elected on the church board.

3. We recommend, as a Memorial to our General Assembly, that section 49, paragraph 3, be altered to read as follows: "Each charge shall support its pastor, providing that he devote his entire time to the same; and, the local church board shall, at their annual business meeting, stipulate a minimum salary for its pastor for the coming year. This decision shall be reached by a careful comparison of past reports of the church treasurer, and by a reasonable consideration for the pastor's present needs."

4. Be it resolved that section 49, Paragraph 1, in our Manual shall read thus: An Ordained or Licensed Minister may be called to the pastorate of a local church, or circuit, by a two-thirds vote of all the members of the church present and voting at the annual business meeting, provided, that said minister has been nominated to the church by a three-fourths vote of the local church board calling him. His term of office shall continue until the following District Assembly. He may be recalled from year to year without the local church board nominating him. All voting must be a secret ballot.

5. Substitution for Section 43 in Manual: Th annual church meeting shall elect a secretary, treasurer, Sunday School Superintendent and not more than five Elders and five Deacons or Deaconesses. These officers with the Pastor shall be elected by secret ballot, if there be no election on the first ballot, the two names receiving the highest number of votes shall be balloted for on the second ballot. Said officers are to enter upon their duties the first day of the assembly year, which shall be the day after the Annual Assembly.

6. Be it therefore resolved that the Eastern District of the Pilgrim Holiness Church appoint a committee, to be known as a Stationing Committee. Be it further resolved that said committee shall consist of the District Council. Be it further resolved, that said committee shall work in conjunction with each church delegate in appointing pastor for same.
