CHURCH COVENANT

1. Having been led to repentance toward God and faith in the Lord Jesus Christ as our Saviour, we now, in the presence of God, angels, and this Assembly, most solemnly and joyfully enter into covenant with one another as one body in Christ.

2. We promise, by the aid of the Holy Ghost, to shun the paths of sin, and to walk in the ways of righteousness and true holiness all the days of our life.

3. We engage not to forsake the assembling of ourselves together, as the manner of some is, but exhorting one another daily, and so much the more as we see the day approaching to strive together for the advancement of His Kingdom, and for the mutual upbuilding of the saints in holiness, knowledge and comfort.

4. We agree to contribute liberally and cheerfully to the support of the ministry and expenses of the church, the relief of the poor and the spread of the Gospel throughout the nations of the earth.

5. We also engage to maintain family and secret devotion; to endeavor to bring our children early to a saving knowledge of Christ, and to give them a guarded Christian education; to walk circumspectly in the world; to be just in our dealings, faithful in our engagements, exemplary in our deportment, and dress according to First Peter 3:3-4, "Whose adorning let it not be that outward adorning of plaiting the hair, and wearing of Gold, or putting on of apparel, but let it be the hidden man of the heart, in that which is not corruptible, even the ornament of a weak and quiet spirit which is, in the sight of God of great price."

6. To abstain from contracting debts without due care to discharge them; to avoid all tattling, backbiting, evilspeaking and unprofitable and frivolous conversation; to abstain from the sale and use of intoxicating liquors, tobacco and other harmful drugs in all forms; to avoid all places of worldly amusement, such as dances, shows, theatres, horse races, baseball games and places where gambling is indulged in, as well as to shun and have no association with or membership in secret societies and lodges which are oath-bound. (2 Cor. 6:14-17).

7. We will "remember the Sabbath Day to keep it holy" by doing no worldly business therein, such as buying and selling, and by avoiding all other occupations, pleasures or traveling which can not be consistently engaged in with an eye single to God's glory.

8. We further promise to walk together in Christian love and watchfulness, giving and receiving admonition with meekness and affection; to remember each other in prayer; to aid each other in sickness and distress; to cultivate Christian sympathy in feelings and courtesy in speech, and to be mindful of all the rules of our Saviour.

JOURNAL OF PROCEEDINGS

FIRST SESSION, MONDAY MORNING, AUGUST 6th, 1934

The Thirtieth Annual Assembly of the Eastern District of the Pilgrim Holiness Church, comprised of Maryland, Delaware, and the Eastern Shore of Virginia, convened at the Denton Camp Ground, Denton, Md., August 6th at 8:30 a.m.

Session opened by singing, "Friendship with Jesus," Rev. Mary P. Garrett led in prayer.

District Superintendent Rev. H. E. Uhrig, introduced to the Assembly our beloved General Superintendent, Rev. W. L. Surbrook. Bro. Surbrook addressed the Assembly by reading and commenting on the Word of God.

Delegates were registered, roll was called.

Rules governing the Assembly were adopted as follows: The conference bar to consist of the first eight rows in the middle section of the tabernacle. Business sessions to convene at 9:00 A. M., to close at 12:00, to reconvene at 2:00 P. M., and to close at 5:00 P. M. and to reconvene at 7:00 P. M. and to close at 10:00 P. M.

Moved and seconded that we accept Rev. P. F. Elliott, Sr., into our District, motion carried.

Moved and seconded that we accept Mrs. P. F. Elliott, Sr., into our District, motion carried.

Moved and accepted that we accept Rev. P. F. Elliott, Jr. into our District, motion carried.

Moved and seconded that we accept Rev. Geo. Culver into our District, motion carried.

Moved and seconded that Srs. Etta Clough and Etta Mitchell be granted an honorary seat in the conference bar, with the privileges of the floor. Motion carried.

Rec. E. R. Clough, of Madisonville, Ohio, and Rev. S. L. Adams, of Glassboro, N. J., were introduced to the Assembly and granted a seat in the conference bar.

Moved and seconded that the District Superintendent appoint committees, motion carried.

Moved and seconded that we hear the District Superintendent's report, motion carried.

Moved and seconded that we accept the Second Pilgrim Holiness Church of Cambridge into our District, motion carried.

Rev. Melvin Blaun of the New York District was introduced to the Assembly and was granted a seat in the conference bar.

Sr. E. R. Clough of the Ohio District was introduced to the Assembly and was granted a seat in the conference bar.

Bro. Slocum and daughter, Cora, were introduced to the Assembly and were granted seats in the conference bar.

Moved and seconded that we take a recess until 2:00 P. M., motion carried.

Rev. Chas. L. Slater dismissed with prayer.

Recess

Business resumed at 2:00 P. M. by singing, "Since Jesus Came into My Heart." A number of Scripture passages were quoted and Bro. P. F. Elliott led in prayer.

Moved and seconded that we hear the auditor's report., Carried.

Moved and seconded that we accept the auditor's report. Carried.

Moved and seconded that we accept the treasurer's report. Carried.

Moved and seconded that we accept the district Supt. (P. F. Bean) report. Carried.

Rev. R. O. Musser of Bethlehem, Pa., introduced to the assembly and granted a seat in the conference bar.

Moved and seconded that the District Superintendent appoint another member on the Resolutions Committee due to Bro. Phillip's illness. Carried.

Report of the resolutions committee:

Resolution No. 1 was read and adopted by motion.

Resolution No. 2 was read and adopted by motion.

Resolution No. 3 was read and adopted by motion.

Resolution No. 4 was read and adopted by motion.

Report of District Evangelist heard and accepted.

Resolution No. 5 was read and adopted as amended.

Resolution No. 6 was read and adopted by motion.

Resolution No. 5 was read and adopted as amended.

The report of the Young People's President was read and adopted.

Memorial No. 6 read and adopted.

Moved and seconded that we begin election of officers.

Substitute motion: Election of officers begin at 7:00 P. M. tonight. Carried.

Moved and seconded that the by-laws of the burial association known as the "Helping Hand" be read. Carried.

Moved and seconded that we accept the by-laws just read. Carried.

Moved and seconded that the by-laws read be tabled. Carried.

Moved and seconded that we charge 10c for the "Minutes" and take up an offering to cover the full amount. Carried.

Moved and seconded that we print 375 copies of the "Minutes." Carried.

Moved and seconded that we adjourn. Carried.

Dismissed with prayer by Bro. H. E. Uhrig.

SECOND SESSION, MONDAY, 7:00 P. M., August 6th, 1934

Second session began by singing, "He Abides."

Scripture lesson by Bro. Surbrook.

Roll call.

Minutes of previous session read and approved.

Mrs. Hobbs and Srs' Mengel and Temple were introduced to the Assembly.

Moved and seconded that we change the order of the day to take up an offering for the "Minutes." Carried.

Tellers appointed were: Bros. Culver, Clem, M. Elliott, and Elzey.

Moved and seconded that we vote for one of the two receiving the most votes. Carried.

Following are the new officers elected:

Rev. P. F. Elliott, District Supt.

Rev. T. S. Dixon, Assistant Superintendent.

Rev. H. D. Dukes, District Secretary.

Rev. H. E. Uhrig, District Treasurer.

Revs. C. S. Hope, P. F. Bean and W. H. Vickers, advisory members of Council.

Rev. E. J. Clem, District Evangelist.

Rev. H. P. Adams to fill a vacancy on the examining board.

Moved and seconded that the council submit 16 ministerial names from which we shall elect eight as delegates to the General Assembly.

Moved and seconded that the next four highest be elected as alternates.

Moved and seconded that each pastor submit a prospective lay delegate to the General Assembly. Carried.

Moved and seconded that the seven receiving the next highest be alternates. Carried.

Moved and seconded that the District Council take care of the work of the Home Missionary Board. Carried.

Moved and seconded that we elect a District Evangelist and that the said District Evangelist in conjunction with the Council stipulate a salary for said Evangelist and that this stipulation be submitted to this Assembly for their ratification. Carried.

Moved and seconded that our ministry suggest men able to fill this office of District Evangelist. Carried.

The following names were submitted: Bros. Clem, Vickers, Price and Adams.

Bro. Clem was elected.

Moved and seconded that we extend time 20 minutes. Carried.

Moved and seconded that the District Council be given the power to fill vacancies at the General Assembly. Carried.

Moved and seconded that we adjourn to reconvene at 8:00 A. M., Tuesday. Carried.

Prayer and dismissal by Bro. P. F. Elliott.

THIRD SESSION, TUESDAY MORNING, AUGUST 7th, 1934

Session opened by singing after which Bro. Dixon read the 13th Chapter of 1st Cor.

Dist. Sec'y. lead in prayer.

Moved and seconded we dispense with roll call.

Minutes read and approved.

Examining Board were excused.

Resolutions 7, 8 and 9 were read and adopted.

Moved and seconded that the District Council and District Superintendent meet and consider the salary of the District Superintendent and the time he shall give to district work.

The names of the ministerial delegates elected to the General Assembly are as follows: Bros. P. F. Elliott, Dixon, Dukes, Bean, Hope, Uhrig, Vickers, Phillips, Walls, Price and Adams. The alternates were: E. Lowry, Schelhouse, Elzey and Clem.

The names of the lay-delegates elected to the General Assembly are: Bros. Carroll, Price, Davis, Pritchett, Smith, Robinson and Vincent. The alternates were: Bros. DeFord, G. Elliott and Sr. Medford.

The report of the Committee on Memorials was read and accepted.

The Statistician's report was read and accepted.

The report of the Examiner's Board was read and accepted.

Moved and seconded that we take an offering to care for our General Superintendent's traveling expenses. Carried.

Memorial No. 7 concerning report blanks was carried.

Resolution No. 10 was read and adopted.

Memorial No. 8 was read and adopted.

Moved and seconded that we have an ordination service at 2:00 P. M.

Recommendation submitted by the Council concerning the District Evangelist read and adopted.

Time extended 10 minutes.

Moved and supported that the church covenant be included in the Minutes.

Dismissed for recess until 2:00 P. M.

The Examining Board recommended the names of Misses Nellie and Louetta Holden, Helen Vincent and Bro. Harry Sension for ordination.

The ordination service was conducted by Bro. Surbrook, general superintendent, together with several members of the District Council. God graciously smiled upon this service and the "Glory of the Lord filled the tabernacle."

Bros. Bean and Uhrig were given a rising vote of appreciation for their labors as District Superintendent for the past year.

Bro. Uhrig appointed Sr. Brewington as president of the Women's Missionary Board.

Moved and seconded that all pastors when returned to their churches raise at the rate of 25 cents per member, for expenses of the delegates to the General Assembly. Carried.

Moved and seconded we empower the council to finish any unfinished business and that the Assembly be adjourned. Carried.

Benediction by Bro. Surbrook.

RESOLUTIONS

BE IT RESOLVED:

1. That no church shall send the pastor's wife as a delegate to the Annual Assembly, if at all possible to send another member of said church. Resolution carried.

2. That each of our churches designate one day or evening of each month as "Donation Day" for the pastor. Be it further resolved: That the delegate present this monthly to their respective

churches; and see to it that this is carried out. In as much as many of our pastors are receiving inadequate support. Resolution carried.

3. That Resolution No. 5 in 1933 minutes be rescinded. Resolution carried.

4. That each Sunday School raise at least 10c each Sunday, the same to be sent to the District Treasurer, quarterly, to apply on purchase of a District Tent. Resolution carried.

5. That Resolution No. 11 in 1933 Minutes be rescinded. Resolution carried.

6. That in order to defray the expenses of sending the delegates to the General Assembly that each pastor take an offering equivalent to 5c per member, same to be sent yearly to the District Treasurer. Resolution carried.

7. That where possible each pastor hold a meeting within the bounds of his own church during the assembly year. Resolution carried.

8. That the manuscript for District Minutes be in the hands of the printer at least 30 days.

and be it further resolved: That churches receiving them send money for same within ten days to District Treasurer. Resolution carried.

9. That we have one Ministerial Convention and that the District Superintendent appoint a committee of three, to set a date, select location and arrange topics for rediscussion, at the same. Resolution carried.

10. Inasmuch as there has been a failure on the part of some of our pastors in carrying out some of the Resolutions of the District Assembly:

Therefore be it Resolved: That if any pastor shall refuse to carry out any resolution as passed by the District Assembly he shall be denied both voice and vote in the following District Assembly, unless he shows just cause. Resolution carried.

11. That we express our sincere appreciation to those who labored faithfully before the camp and assembly to get the buildings and grounds ready for our comfort; to kitchen and dining room help for so excellently providing for and serving in feeding our physical bodies; to Bro. Surbrook our beloved General Superintendent, who has so ably presided over this Assembly in such a spirit of love and cheerfulness; to Bro. Uhrig for his patience and wisdom in presiding over services of the camp, to Bro. Dukes for so faithfully discharging the secretarial duties of the Assembly. May God's blessing "that maketh rich and addeth no sorrow" be upon and abide with all these, His servants. Resolution carried.

12. That whereas our Young People's Society has been of great spiritual benefit to our District, be it resolved that this Assembly

appoint the necessary officers for this society, and the president of the society visit each church where there is a Young People's Society or a possibility of organizing one, and that each society give a free will offering to defray the expense of the same.

Be it further resolved that we have one Young People's District Convention each year. Resolution carried.

13. That the Sunday School offering of one Sunday each month be used for Foreign Missions.

14. That no member from one Pilgrim Holiness Church be received into another Pilgrim Holiness Church in this District unless they receive a letter of good standing from the church of which they have been a member.

15. Whereas we have found a difficulty in the past in taking so many different special offerings to properly keep up our District and General budget, we recommend that we combine our District and General budgets and that our Foreign Missionary money be raised separately. We further recommend that each local church some time during each month shall take a special offering for th District and General budgets, this offering shall be equal to 10 per cent of the gross offerings of the church and Sunday School, with the exeception of building funds, all rent, foreign missions and evangelist support Resolution carried.

16. We recommend that the 10 per cent raised in Resolution 15 be distributed as follows: The pastor shall instruct the local church treasurer to send one third to the General Treasurer and the remaining two-thirds to the District Treasurer.

17. That each pastor raise the equivalent of 5 cents per member in order to defray the expenses of the District Assembly.

18. Whereas our General Superintendent has recently ruled that our assembly year ends when we close our books. Be it Resolved, that our books be closed June 30 and that our newly elected church board take office immediately and that all reports be in the hands of our Statistician two weeks prior to our Assembly.

19. That the District Superintendent be paid from the District Treasurer for all postage relative to the district work, also secretary and treasurer included.

20. That the churches with 50 members or more pay the District Superintendent \$10.00 a visit and the churches under 50 members pay \$5.00 a visit.

RECOMMENDATION BY COUNCIL

1. Moved and seconded that we give our District Evangelist \$15.00 per week if possible and if sufficient funds come in we pay 2½c per mile for traveling expenses. and also house rent not to exceed \$10.00 per month. All offerings received by the District Evangelist shall be reported to the District Treasurer and be included into his salary.

DISTRICT SUPERINTENDENT'S PARCEL REPORT

From August 8 to December 20 of this Assembly year I served as District Superintendent. During this time I visited seventeen churches, with several additional visits. I traveled 1522 miles, wrote sixty letters and about seventy postal cards in connection with the District work. I received \$99.43. Some adjustments were made that were very important. Rev. P. F. Elliott, Sr., was called as pastor to the Dover, Del. P. H. Church. Delmar, Del. P. H. Church was successful in making same adjustment which was needed. Rev. C. W. Schelhouse filling the pulpit for some time.

During this time we lost one of our ordained ministers, Bro. T. L. Trice, who was a very highly esteemed member of Denton P. H. Church and a much beloved local minister among us all.

Greeting:

This report covers a period of seven and one-half months, during which time, we are happy to say, death has not entered the ranks of the ministry.

Two of our good brethren have been transferred to other Districts. Bro. J. Roland Mitchell has been transferred to the Rocky Mountain District, while Bro. J. F. Talbirt has been transferred to the Louisiana-Arkansas District.

There are a number of changes being made in pastorates, Bro. P. F. Elliott having resigned his pastorate at Dover, the church called his son, Paul, from the California District, who has already proven himself a great blessing to this church.

Bro. P. T. Bean has accepted the pastorate at Delmar, Bro. C. S. Hope, Hurlock; Bro. E. C. Elzey, Hooper's Island; Bro. Harry Sension, Girdletree, and Sisters Etta Mitchell and Etta Clough, Cape Charles.

The Milton Church has extended a call to Rev. Raymond Simpson. Trappe and Easton are yet without pastors. Trappe Church is being supplied by the writer.

I have visited all of our churches once and some of them twice, held numerous special board meetings, traveled over 3,000 miles and received for my support \$156.90.

One church has been organized by Bro. Vickers, known as the Second Church in Cambridge. Two new preaching points have been established. One at Cedar Grove, Del., by Sister Mary Garrett, which they expect to organize in just a few days, and the other at Lewes, Del., by Bro. H. P. Adams.

In conclusion, I wish to say that we have just passed through a very gracious camp meeting and the good Spirit of the Lord is sensed in the first sitting of this District Assembly.
