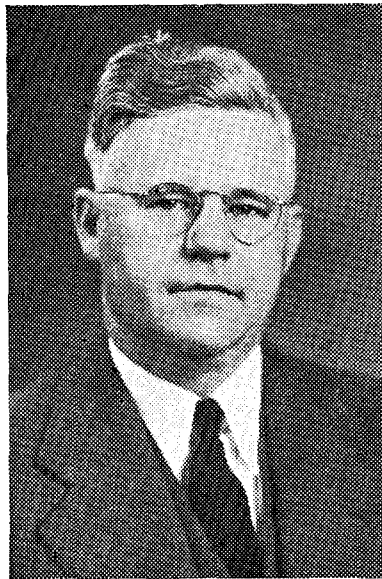

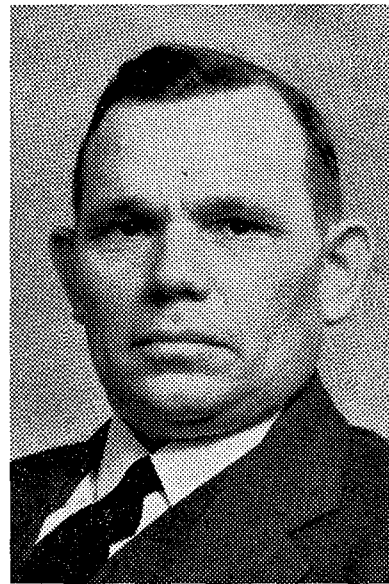

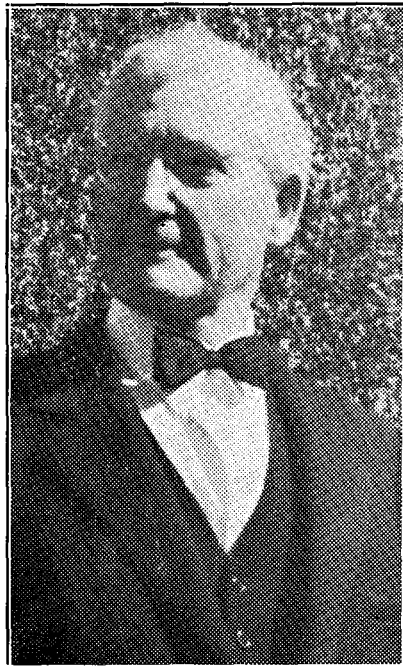

JOURNAL OF PROCEEDINGS

FIRST SITTING

The Thirty-seventh Annual Assembly of the Eastern District met on Denton Camp-ground at 9:00 o'clock Monday morning, August 4th, 1941, with Rev. H. D. Dukes, District Superintendent, in the Chair. The Session opened by singing "The Haven of Rest" led by Rev. Merrick Lowry.

We were led in prayer by Rev. T. S. Dixon, our Assistant District Superintendent. Our General Superintendent, Rev. W. L. Surbrook, read the scripture, reading from I Corinthians XII: 1-20, giving some excellent comment on the same.

Delegates were registered and the roll was called. The roll comprising the names of those present was as follows:

The first eight rows of seats in the two middle sections were designated as the Conference bar.

The hours for the sitting of the Assembly were set at 8:30 A. M. to 12:00 noon; 2:00 to 5:00 P. M., and 7:00 to 10:00 P. M.

The Assembly was then asked to allow Sister Elizabeth Clark to assist the District Secretary, this was granted.

The District Superintendent then appointed two Committees:

THE COMMITTEE ON MEMORIALS TO GENERAL ASSEMBLY: T. S. Dixon, W. C. Beard and William H. Vickers, and

THE WAYS AND MEANS COMMITTEE: P. F. Bean, H. P. Adams, and E. W. Lowry.

The District Superintendent then read his report and motion was made to accept it. Carried.

The District Statistician then read his report, after which motion was made to receive the same with corrections. Carried.

The District Treasurer then read his report, which was accepted by a standing vote and a cheery "Amen."

The Reception Committee then introduced to the Assembly, Rev. Harold D. Dieter, President of Allentown Bible Institute, and Sister F. G. Lee, one of the Founders of Colorado Springs Bible School. Each was asked to speak and willingly responded. The Chair then asked if there were any announcements; several announcements were then made and Assembly adjourned with prayer by Rev. H. D. Dieter, to meet again at 2:30 P. M.

SECOND SITTING, AUGUST 4th, 1941

Monday Afternoon, 2:30. The Sitting opened with Rev. T. S. Dixon leading the singing, after which Rev. E. P. Cranfield led in prayer.

The Chair then asked if any Committees were ready to report.

Resolution Committee reported:

Resolution No. 1 was sent back to the Committee for re-drafting but was lost in the Committee.

Resolution No. 2, Tabled; Brought back and adopted.

Resolution No. 3, Providing that District Superintendent give his full time to the District, was voted down.

Resolution No. 4 was offered and amended, the amendment was then rejected and the original resolution carried.

Resolution No. 5, Carried.

Resolution No. 6 was then read and adopted. Amendment was then made for Statistician to receive \$10.00 instead of \$15.00. Carried.

Resolution No. 7 was amendment, carried.

This being all for the present from the Resolutions Committee, The Ways and Means Committee was then asked to report, their resolution asking that our Ministers give 25 per cent. of their tithe toward the advancement of Church extension of home missions. It was adopted and after some discussion, carried.

This being all for the present from The Ways and Means Committee, The Committee on Memorials to General Assembly then reported.

Memorial No. 1, Carried after much discussion; Regarding Stationing Committee.

Memorial No. 2, Lost without a second.

Memorial No. 3, Lost by vote.

Memorial No. 4, Carried after some discussion; Recalling a Pastor.

Memorial No. 5, Carried; Replacing Directory in Church Manual.

Rev. and Mrs. William Dudley, Pastors of our Church in Washington, D. C., were then introduced to the Assembly, who reported the opening of the work in that place and testified to God's grace.

The Examining Board was asked to report, and the report read is as follows:

The Reception Committee introduced to the Assembly, Rev. W. C. Wheedleton. He spoke of being glad to be back on the Eastern District.

The setting of the hour for the Ordination Service was called for and it was postponed until a meeting of the District Superintendent and The Examining Board.

A motion was made that we have only one Ministerial Convention; It carried.

A motion was made for the setting of the time for election of District officers, but it was decided to wait until after we heard from The Ways and Means Committee.

The Chair then spoke of who was qualified to be delegates to General Assembly. Announcements were made and a motion carried that we recess until 7:00 P. M.

The Chair then called on Bro. Dukes to close the sitting with a prayer.

THIRD SITTING, EVENING AUGUST 4th

The sitting opened by song and prayer. The District Superintendent then asked the District Secretary to write a letter to Rev. J. Godwin Rimmer, expressing our sympathy that he was unable to attend the Assembly due to the serious illness of his wife.

The Ways and Means Committee then proposed and read Resolution No. 3, of last year's minutes, with an amendment which was carried with the amendment.

The Resolution Committee then read a further report:

Resolution No. 8, lost.

Resolution No. 12, adopted and carried.

The election of District officers being the order of the day, a motion was made that the District Superintendent name the tellers; They were named as follows: Grier Baker, Calvin Bradley, Newell Reed, Merrick Lowry.

The ballots then being passed to vote on District Superintendent, the count declared Rev. H. D. Dukes re-elected by a good majority. Ballots were then passed for the vote on Assistant District Superintendent and the count declared Rev. T. S. Dixon elected. District Secretary was next on the list and a count of the votes declared Rev. E. W. Lowry elected. Then ballots were again passed for the office of District Treasurer, and the count resulted in the election of Rev. P. F. Bean. Ballots were then passed for the three additional members of the District Council after ballots were cast and during their being counted the Chair asked the Assembly how they wished to elect their delegates to the General Assembly. Then a motion was made that the present District Council nominate eight names from which the lay delegates shall be elected to General Assembly. A recess was then called while the tellers counted the ballots for the Advisory members of the District Council; the result of the count showing two elections: C. S. Hope and W. C. Beard. Motion was then made that we vote on the three names receiving the next highest number of votes in the immediate previous ballot; this resulted in no election, so ballots were again passed to vote on the names having received the two highest number of votes. The result was the election of Thos. Phillips as the final member of the District Council. Ballots were then passed to elect members of the Examining Board. Motion was made that we put two names on one ballot; the highest one to serve for three years and the other to fill Bro. Beard's place; H. P. Adams received the highest, allowing him to serve three years, and W. H. Vickers was elected to serve for one year, filling out W. C. Beard's place.

Ballots were then passed to vote on the Home Missionary Board, after which the Assembly voted that we have a plurality, rather than a majority vote. The result declared elected, E. R. Clough, C. W. Shel-

house and H. P. Adams elected as Home Missionary Board. Motion was then made that the present elected Home Missionary Board in conjunction with the District Council, nominate two or more as Home Missionary Evangelists. Carried.

We then voted to take a recess, after which Assembly was called to order and the Secretary was asked to report the result of the ballot on Ministerial Delegates to General Assembly. The ballots declared W. C. Beard, C. S. Hope, W. H. Vickers, and H. P. Adams as delegates; and C. W. Shelhouse, E. R. Clough, C. E. Posey and Thomas Phillips as alternates.

The Council and Home Missionary Board having nominated M. W. Lowry and W. C. Beard, the vote was then cast declaring M. W. Lowry District Evangelist.

Motion that we extend the time and vote on Lay Delegates to General Assembly, carried; also motion that we have a plurality vote on this also instead of a majority vote, carried.

The Council then nominated at Lay Delegates to General Assembly: Oscar Ewell, Rufus Rew, Graham Price, Granville Pritchett, Powell Martin, John Pizzadili, Homer Sherwood and John Tyre.

Motion was made to adjourn until 8:30 Tuesday morning. Closed by prayer by Bro. Dixon. After which the ballot was counted which declared Oscar Ewell, Graham Price, Granville Pritchett and Rufus Rew Lay Delegates to General Assembly, and John Tyre, John Pizzadili, Powell Martin and Homer Sherwood as alternates.

Motion made that the Council elect a Trustee in the place of Brother A. A. Price, who has gone to his reward, the name to be mentioned Tuesday.

FOURTH SITTING, TUESDAY, AUGUST 5th, 1941

Tuesday morning the Assembly was called to order, Bro. G. F. Senter leading the song, "I'll Live for Him who Died for Me", after which Bro. Vickers led in prayer. The Chair then asked W. J. Crider to read a scripture and make some comments. He read II Cor. V: 12 through the remainder of the Chapter, giving us some very good remarks. Bro. Surbrook then spoke concerning our Pastors and people taking the Advocate. And that, while there is a financial boom, to get our church property out of debt and being very careful with our own financial obligations, that we may not be embarrassed when the depression comes. Also, that our churches make some effort to raise the salaries of our District Superintendent, Evangelists, Pastors, as the cost of living has greatly increased.

The Minutes were then read and, after some correction, approved.

The Resolution Committee then brought forth Resolution No. 9, which was lost. Resolution No. 10, dealing with rewards to churches, receiving greatest percentage in Advocate subscriptions, carried.

Resolution No. 11, dealing with hall runners, bed springs and mattresses for the dormitory over the dining room, Passed.

Resolution No. 12, dealing with establishment of a Home Missionary Board, Carried.

Resolution No. 13, Concerning M. D. B. A., Carried.

Bro. Vickers then spoke of taking time to reverence our deceased brethren by standing in secret prayer. The suggestion was adopted.

The Chair called for further business. The subject of naming Com-

mittees was up for discussion, motion was then made that our District Superintendent nominate these committees. He nominated the same ones as in last year's minutes. (1940)

The Secretary was then asked to call the roll to determine how many copies of the Minutes should be printed. Upon a motion from the floor, it was decided to have 400 copies printed.

The subject of invitations for Young People's Rallies was taken up. Several invitations were extended, Bro. Dixon extending an invitation to meet at the Denton Camp Ground just prior to the Camp Meeting of 1942.

It was decided we should have one rally at Laurel, Delaware, on Thanksgiving Day, and another to be held at Dover, Delaware, on Good Friday, 1942.

At this time Bro. Adams extended an invitation to have the Ministerial Convention in Salisbury the first Tuesday and Wednesday, 7th and 8th of April. It was accepted.

The Committee on District Resolutions reported and read the following resolutions:

Number 14, "Be it resolved that we express our appreciation to our General Superintendent, Brother Surbrook, for so ably presiding over this Assembly with love and kindness to all."

Number 15, "Be it resolved that we express our appreciation to our District Superintendent, Brother Dukes, for his labor throughout the Camp, and his wholehearted oversight of the entire District during the past year; also to his faithful Assistant, Brother Dixon, who so kindly cooperated with the District Superintendent.

Number 16, "Be it resolved that we express our appreciation to Brother Lowry as District Secretary and to Brother Bean as our District Treasurer, for their faithful and efficient services.

Number 17, "Be it resolved that we express our appreciation to Sister Hoffman for her faithful services as musical director and song leader during Camp; also to Brother Merrick Lowry as Assistant Song Leader."

Number 18, "Be it resolved that we express our appreciation to Brothers Adams and Dixon, for their many labors on the Camp Ground and in the dining room and kitchen during Camp; also to Sister Etta Mitchell with all the dining room assistants for their cheerful and efficient service."

A motion was then made to adjourn to meet again at 1:00 o'clock P. M.

FIFTH SITTING, TUESDAY AFTERNOON, AUGUST 5th

Assembly was called to order by Brother Surbrook. Brother Alfred Clark led in singing, "Take the Name of Jesus with you." Then Brother T. S. Dixon led in prayer. Business being resumed, the Resolutions Committee Number 19: "Be it resolved that this Assembly express its appreciation to Brother F. C. Walls for his abundant labors as Statistician."

Number 20, "Be it resolved that we express our appreciation to the colored folk, who so ably did the cooking all through Camp and Assembly."

Brother Dukes, our District Superintendent, then nominated Brother W. H. Vickers to fill the place on the Board of District Trustees, of Brother A. A. Price, who has gone to his reward.

Brother Merrick Lowry was then called to the platform and the Chair called for someone to play; Sister Nellie Holden responded and they sang "A CHARGE TO KEEP I HAVE." Brother C. S. Hope led in prayer, and the Chair then asked Brother Vickers to read a scripture on how a minister should walk. He read Titus III: 1-11. The Chair then asked Brother Dixon to read more scripture concerning how a minister should walk; he read II Timothy, IV: 1-8. Then the Chair asked Brother Dukes to read another scripture concerning how a minister should walk; he read I Timothy III. Brother Surbrock gave a timely admonition to the candidates for ordination, after which they were asked to kneel at the altar and the Ordination Committee laid their hands upon them and ordained the three following to preach the Gospel: Brother Alfred Clark, Brother Calvin Bradley and Sister Mary Joiner. And also ordained to Deaconess' work Sister Grier Baker and Sister Muriel Booze.

Brother Thomas Phillips then testified to the Assembly how God had healed him during the Camp.

The Resolution Committee then offered its final report, i. e.

Number 21, "Be it resolved that the District Council be authorized to fill vacancies of delegates to General Assembly if an emergency should arise.

All known business of the District being duly taken care of, a motion was made to adjourn and Brother Surbrock closed the session with prayer.

RESOLUTION OF THE WAYS AND MEANS COMMITTEE

WHEREAS, There is a need for a more extensive Home Missionary work in our District. Be it resolved that all Pastors and Evangelists give 25 per cent. of their tithes to the same; To be sent to the District Treasurer each month. The same to be designated for Church Extension work.

STANDING RULES

1. Inasmuch as our Y. P. S. Rallies have proven to be a great benefit and uplift to our district, be it resolved that they be continued. We further recommend that the Missionary activities among our Y. P. S. be continued and all monies for same be sent to the District Treasurer.

2. Inasmuch as our General Budget has been set at \$1.00 per member and Foreign Missionary Budget at \$2.00 per member, be it resolved that our District Budget be set at \$1.00 per member, making a total of \$4.00 per member. This money shall be sent to the District Treasurer as budget money to be proportioned accordingly. Furthermore, we suggest that a mite box be given to each member and asked to give 1c a day for the year.

3. We recommend that each pastor's wife ask her church for a don-

ation of fruits, vegetables, and canned goods not later than two weeks before the Denton Camp opens.

4. Inasmuch as Denton Camp has held a high spiritual standard from its beginning, be it resolved that we continue to both advertise and announce that nothing will be sold on the Lord's Day.

5. Inasmuch as there is a trend these days toward worldly dress, be it resolved that more strict rules be applied to the platform at Denton Camp.

6. Be it resolved that there will be no annual church business meetings held on the Lord's Day.

7. Be it resolved that the District Council engage children's and young people's workers, also pianists before camp convenes.

8. No pastor's wife shall serve as a delegate to the annual Assembly if another member of the church is available.

9. Be it resolved that each of our churches designate one day or evening of each month as "Donation Day" for the pastor and that the delegates present this resolution to their respective churches and see to it that this is carried out, inasmuch as many of our pastors are receiving inadequate support.

10. In order to defray the expenses of sending delegates to the General Assembly, be it resolved that each pastor take an offering equivalent to 5 cents per member, same to be sent yearly to the District Treasurer.

11. Wherever possible each pastor shall hold a meeting within the bounds of his own church within the Assembly Year.

12. The manuscript for the District Minutes shall be in the hands of the printer within at least 60 days and be it further resolved that churches receiving them send money for same within 10 days to District Treasurer.

13. No member from one Pilgrim Holiness Church shall be received into another in this District unless he receives a letter of good standing from the church of which he has been a member.

14. Each pastor shall raise the equivalent of 5 cents per member in order to defray the expenses of the District Assembly.

15. Whereas our General Superintendent has ruled that our Assembly Year ends when we close our books, be it resolved that our books be closed June 30th and that our newly elected church board take office immediately, and that all reports be in the hands of our Statistician three weeks prior to our Assembly.

16. The District Superintendent, Secretary and Treasurer shall be paid from the District Treasury for all postage relatives to the District work.

17. The churches with fifty or more members shall pay the District Superintendent \$10.00 a visit, all others \$5.00 a visit.

18. Resolved that no individual serve as a member of more than one of the following: Council, Examining and Educational Board, and Resolution Committee.

19. Inasmuch as there are many duties for the District Secretary and Treasurer to discharge during the year, be it resolved that our District pay each the amount of \$25.00 for their labors.

20. Resolved that the dates for the Ministerial Convention be set at this Assembly and invitations be extended for same.

21. Resolved that there be a registration of all who go to the dining room during our District Camp and that all be supplied with tickets to be presented upon entrance into the dining room.

22. Since the Assembly follows the District Camp, be it resolved that each minister and wife and delegate be entertained free, all others to pay 25 cents a meal to help pay expenses of the dining room.

23. Inasmuch as the ring meeting has been much appreciated in years past and since there are many who wish them continued, be it resolved that a leader be appointed by the Council to have charge of those meetings for the coming years and the same be announced and encouraged from the Denton Camp platform.

24. Whereas there is an increasing number of cars coming to our camp, be it resolved that the District Council have parking space marked out and three men be appointed as officers who can be empowered to look after this, and also the grounds in general, displaying his badge as officer, for our next camp.

25. Whereas there is too much work for the Caretaker during the Camp, be it resolved that the District secure a lady to assist her in cleaning the rooms and changing bed linens before the rooms are re-occupied.

26. Whereas Denton Camp is our District Camp, be it therefore resolved that the District Council place in every town and village within a radius of 50 to 60 miles, such posters as can be read easily, also notice to be sent to at least four city newspapers two weeks before our next camp.

27. Be it resolved that minister's children, 14 years of age or over, receiving free board, be asked to assist in the dining room when necessary.

28. Be it resolved that during the Camp the family prayer hour from 8 to 9 and the morning praise service from 9 to 10 with a leader appointed for the same, be announced and urged.

29. Whereas we recognize the need of supervision for the music of the camp, we recommend the appointment of Sr. Etta Hoffman as musical director of the same.

30. Resolved that we open all our churches at least once each year to the representatives of the Allentown Bible Institute and urge that a liberal offering be taken for the support of said school.

31. Whereas there has been no provision made to help our aged ministers or the worthy widows of the same; and whereas the needs are strategically imperative, therefore be it resolved that the Eastern District adopt an old age and disability benefit; and be it further resolved that this Assembly elect a board of three preachers, all men, to serve as trustees of the same; one, or more, of whom shall be a member of the Council; and these trustees shall make all inquiries concerning the need of the applicant and the distribution of all monies for the same.

32. Resolved that the names of delegates representing the churches coming to our District Assembly be mailed to our District Secretary 10 days before the Assembly.

33. Whereas, some of our preachers and churches are allowing special singers and evangelists to come in their pulpit with dresses cut off at the knee and short sleeves; therefore, be it resolved that we as the Eastern District refuse to tolerate this curse that once we took our stand against either in our home churches or on Denton Camp platform.

34. Resolved that a day and hour be set for a healing service at Denton Camp annually and same advertised on the posters.

He shall be allowed to use offerings received to cover his salary and expenses of the meeting. The same shall be reported to the District Treasurer, who when he is so authorized by the Home Missionary Board shall forward the necessary money for these meetings.

5. Be it resolved, That to encourage the churches in securing Advocate subscriptions, an award be offered to the church securing the greatest number of subscriptions, based on a percentage of membership.

6. Be it resolved: That runners be purchased for the halls of the dormitories to lessen the noise; and springs and mattresses for the beds that now have none.

7. Be it resolved: That we elect a Home Missionary Board, consisting of the District Superintendent and three other members. The duty of this Board is to plan for meetings in the new fields in conjunction with the District Evangelist.

8. Be it resolved: That a Committee of two be appointed to visit each Church, and that the M. D. Benefit be thoroughly explained. And that this be done within the next thirty days, or at the earliest date possible. And that they be paid three cents per mile and that an offering be taken at each visit.

9. Be it resolved: That the District Council be authorized to fill vacancies of delegates to General Assembly if an emergency arises.

10. Be it resolved: That we express our appreciation to our General Superintendent, Brother Surbrook, for so ably presiding over this Assembly, with love and kindness to all.

11. Be it resolved: That we express our appreciation to our District Superintendent, Brother Dukes, for his labor throughout the Camp, and his wholehearted oversight of the entire District during the past year; Also to his faithful Assistant, Brother Dixon, who so kindly cooperated with the District Superintendent.

12. Be it resolved: That we express our appreciation to Brother Lowry, as District Secretary, and to Brother Bean, as our District Treasurer, for their efficient and faithful services.
