# Journal of Proceedings

## FIRST SITTING

August 2, 1943

The Thirty-ninth Annual Conference of the Eastern District, Pilgrim Holiness Church, convened at Denton, Maryland, Camp Ground, Monday morning at 8:45, August 2, 1943 with our District Superintendent, Brother Dukes in the Chair. Brother Graham F. Senter was asked to lead the singing, and we sang "What a Friend We Have in Jesus," and "Have Thine Own Way." Bro. Wm. H. Vickers then led in prayer, after which Bro. Dukes presented our General Superintendent, Rev. Walter L. Surbrook to the Conference. Bro. Surbrook read II Corinthians, IV:1-5, using verse 5 as a text, he gave an excellent message to the Conference.

The roll call of pastors was then made, followed by a roll call of lay delegates, thus completing the roll. Lay delegates to Conference were as follows:—

The time was then set for the sitting of Conference: Motion was made and seconded that we use the same hours of sittings as last year which was 8:30 A. M. to 12:00 noon; 2:00 P. M. to 5:00 P. M. and 7:00 P. M. to 10:00 P. M. It was passed.

Motion was then made, seconded and passed that the Conference bar be set to include the platform and the first nine rows of benches of the two middle blocks of the Tabernacle. Brother Harold Dieter was then invited to the platform. The Chair then asked if there were any vacancies to be filled. The District Superintendent appointed Bro. Beard to the Resolutions Committee to take the place of Bro. Crider, who has moved from the District.

The report of the District Superintendent was then called for. His report was read, and a motion was made that we accept it; Every one accepted it with a cheery "Amen."

The Chair then called for the report of the District Statistician, but he not being present, the Statistical report was postponed until the afternoon sitting.

The Audit Committee's report was heard and approved. The District Treasurer's report was then called for, read, and after a few comments, was cheerfully accepted.

The District Superintendent gave a report of a new Church near Bethlehem, Maryland, and made a motion that we accept this Church into the Conference, and seat its delegate, Mr. John Price in the Conference Bar; It was seconded and passed.



The District Superintendent then gave the report of a new Church organization at Chestertown, Maryland, moving that it be accepted into the Conference, and that we seat its delegate, Heston Wiltbanks, in the Conference Bar; It was seconded and passed. The District Superintendent then gave a report of an organized body in Baltimore, which had been sponsored by The First Pilgrim Holiness Church of Baltimore. Motion was made, seconded and passed, that we accept Sr. Robinson as their delegate to Conference.

The report of the Ways and Means Committee was next called for. It was read and its Resolution No. 1 was read and approved, as were numbers 2 and 3.

The Statistician having arrived, his report was called for, and having been read, his report was accepted, and it was moved, seconded, and passed that we recess until 2:00 P. M.

### SECOND SITTING

The Second sitting opened at 2:00 P. M. by General Superintendent, Bro. Walter L. Surbrook. Bro. Graham Senter led us in singing "Hiding in Thee." Bro. Dukes led in prayer, then Bro. Surbrook asked Bro. S. Lewis Adams, a visiting brother from the Pennsylvania-New Jersey District to give the Conference a little report on the progress of his church work, giving us some helpful ideas along this line. He gave a fine report, after which he was granted an honorary seat within the Conference Bar.

The Examining Board was then asked to report. It was moved, seconded and passed that we accept this report. A motion was passed that Bro. and Sister Floyd Baker, Brother and Sister Howard Williams, Bro. Victor Bateman and Allen Clark all be accepted in the Conference, and that they take their places within the Bar.

The Resolutions Committee was then asked to report.

Resolution No. 1 was read and adopted.

Resolution No. 2 was read and adopted.

Resolution No. 3 was read and a motion was made to amend the resolution to read "One" ministerial convention instead of "two" a year. It was passed, and the resolution, as amended, was carried.

A motion was made and seconded that the District Statistician receive his report again to make any necessary changes in it.

Resolution No. 4 was then read, and by motion was amended to read "that it be three consecutive days, separate from the 2 days work already discussed in the morning sitting." It carried.

The Ways and Means Committee was then asked to report, and reported as follows: Resolution No. 4 was read and carried; Resolution No. 5 was read and carried.

It was moved and seconded that Brother Dieter be given time to discuss progress of Allentown Bible Institute; It carried and Bro. Dieter brought us an excellent report on the work of the School.

The Committee on Resolutions was then asked to report any further resolutions; Resolution No. 13 was lost. Resolution No. 14 was read and a motion made and seconded that this resolution be referred back to the Committee.—Carried.

A motion made, seconded and carried that we have the election of District Officers. Tellers were appointed by The District Superintendent as follows: Bros. Senter, Alfred Clark, Reed and Bradley. Ballots were cast for the election of District Superintendent, and Rev. H. D. Dukes was elected. Ballot were then cast for the election of Assistant District Superintendent. We moved to adjourn to meet at 6:00 P. M.

### THIRD SITTING

The evening session of Conference was opened by Bro. Walter Surbrook in the Chair. Rev. Calvin Bradley led in singing "My Burdens Rolled Away." We were then led in prayer by Bro. Graham Senter, after which Bro. Surbrook read a scripture lesson from Hebrews XI, giving a few helpful comments on the word "Faith."

The roll was then called for and made, asking the ministers how many subscriptions to the Advocate they would try to get this year, also how many copies of the Annual Conference Minutes they desired. A motion was made that we have 500 copies of the Minutes printed—Carried. The Minutes of the First and Second sittings were then read and approved, since there were no corrections.

The report of the findings on the ballots for the Assistant District Superintendent was read, declaring Rev. T. S. Dixon elected. Ballots were then cast for District Secretary, and the ballot declared Rev. Earl W. Lowry elected. Brother P. F. Bean, having been nominated by the District Council as candidate for District Treasurer, a motion was made from the floor that we elect him by acclamation, by a rising vote,—Carried, and he was elected.

Ballots were then cast to elect the three remaining members of the District Council. The tellers were excused to count the ballots while Conference continued its business, by a motion which was made, seconded and passed.

It was moved and seconded that the same brethren as last year, be elected as District Trustees for the following year; It carried, electing Revs. Wm. H. Vickers, T. S. Dixon, H. D. Dukes, Mr. Graham Price and Mr. James Trice.

A motion was made that we hear from the Resolutions Committee. Resolution No. 15 was read and lost; Resolution No. 16 was read. It was moved and seconded that we should refer it back to the Committee for re-drafting.

The Memorial Committee then gave its report, which was adopted. A motion was made that we refer Resolution No. 16 to The Council, thus ignoring a previous motion to refer it back to the Committee. Carried.

The findings of the tellers on ballots for the three remaining members of The District Council, declared Bro. Hope and Bro. Beard as members. Motion was made and seconded that we vote for one of the three next highest, in order to get the final member of The Council—Carried. This ballot declared no election, and a motion carried that we vote for one of the two highest ones. This ballot declared Rev. Wm. H. Vickers the final member of The Council.

The Council having nominated Bro. Posey to succeed himself for a period of three years on the Examining Board, and having reported so to the Conference, a motion was made and seconded that we elect Bro. Posey by acclamation; It carried and Bro. Posey was elected.

Bro. Vickers then resigned from the Examining Board, due to his having been elected to the District Council, and Bro. Grier Baker, having been previously nominated for that post, was also elected by acclamation as the final member of the Examining Board for a term of two years.

Committees then appointed by the District Superintendent were:—**Auditing**—Srs. Garrett and Etta Clough, **Memorial**—Srs. Nellie and Louetta Holden, **Editing**—Bros. E. W. Lowry and Beard, **Ministerial Convention**—Bros. Dixon, Vickers and Grier Baker, **Reception**—Bros. Dixon and Phillips, **Resolutions**—Bros. Senter, Reed and Schelhouse, **Statistician**—W. Calvin Bradley, **Ways and Means**—Bros. Bean, Adams and Merrick Lowry.

The Resolutions Committee brought these remaining Resolutions—Resolution No. 5 was carried by a cheery "Amen." Resolution No. 6 was carried by a cheery "Amen." Resolution No. 7 was carried. Resolution No. 8 was carried by a cheery "Amen." Resolution No. 9 was carried by a cheery "Amen." Resolution No. 10 was carried by a cheery "Amen." Resolution No. 11 was carried.

A motion made and seconded that Bros. Senter, Beard and Adams be given a "thank you" for their excellent work during Camp; Carried, and a cheery "Amen" was said to approve.

A motion made and seconded that we cut the time allowed to get the minutes ready for the printers from 60 days to 15 days; Motion amended to read "30 days" instead of "15 days," carried, and passed as amended.

A motion made and seconded that we thank the Cambridge Baking Co. for the Birthday cake which they sent the Camp, also that we send them a "Thank you" card. Carried.

A motion made, seconded and passed that we thank Elizabeth Clark for her work with the District Minutes.

A motion made and seconded to give Bros. Earl Lowry and Beard \$10.00 each, for their work of editing the minutes. Carried.

A motion made and seconded that we raise the salary of the District Superintendent \$10.00 per week; An amendment was made to reduce the \$10.00 raise to a \$5.00 raise per week, making a salary of \$35.00 per week; Amendment seconded and passed; Main motion as amended, carried.

Invitations for the Ministerial Convention were given: Oxford, Maryland and Bloxom, Virginia invited the Ministerial Convention to their respective churches; Motion was made, seconded and carried, that we accept the invitation to Oxford.

A motion was made that we leave the time for Ministerial Convention with the Church and The Council to decide. Carried.

Motion made, seconded and passed, that we have two Young People's Rallies, on Thanksgiving Day and Good Friday, as is our custom. Invitations to Young People's Rallies were then extended by the Denton Church on Good Friday, and by the Roxana Church on Thanksgiving Day. These were accepted by passing of a motion from the floor.

A motion was made and seconded that the Council notify the ministers of the date of the Ministerial Convention, at least 60 days before the date set. Carried. It was then suggested, and the Chair ruled, that the District Secretary incorporate into the District Minutes, the time for the Ministerial Convention, as he is Pastor of the Oxford church, and will know when his people will want the Convention. (Editing committee's note:—This date was set by the Secretary as October 26-27.)

A motion was made and seconded that our District Superintendent appoint a leader for Women's Missionary Society work in the District. It carried.

A motion made and seconded that the ministers give  $\frac{1}{4}$  of their tithes to the support of District expenses. Carried.

A motion was made and seconded that we thank God for His marvelous presence during the Camp. We stood and sang "Praise God From Whom All Blessings Flow."

A motion made and seconded that we adjourn. Carried. Conference was dismissed by prayer by our General Superintendent, Bro. Walter L. Surbrook.

## DISTRICT SUPERINTENDENT'S REPORT

To the Thirty-Ninth Annual Conference of the Eastern District, Greetings:

We are indeed thankful to God for the privilege of laboring in His vineyard for another year, and that despite the restrictions due to war conditions, our services all over the District are well attended, the church work is progressing and we expect to "carry on" till Jesus comes.

I filled the positions of both pastor of Dover Church and of District Superintendent until October 4, 1942, when I began to give my full time to the District work. Our time has been very full. Aside from the regular church visits and annual business meetings, we have made many visits helping the churches with problems, getting pastors, etc. We feel our hearts were closer knit together for these meetings.

In the five revivals we held on the District, God has richly blessed and given much lasting and definite results, in 92 seeking regeneration and 17 seeking sanctification.

Realizing we should take advantage of the general financial lift, we have encouraged our churches to build and pay for their buildings, make improvements and liquidate their debts. Accordingly, Salisbury, under Bro. Adams' careful leadership, has built a Sunday-school annex, costing approximately \$3,000.00, the greater part of which has already been paid. Bloxom, with Bro. Bean as Pastor, has paid off their Tabernacle indebtedness of \$1,400.00 and now have several hundred dollars in their treasury, looking forward to erecting a church building. The Cambridge Church, pastored by Bro. Schelhouse, has lifted their indebtedness of \$1,200.00. The Roxana Church has paid their indebtedness by cash and pledges, making a total of approximately \$7,000.00 on their church and parsonage, paid in the last two years. Bro. Grier Baker is their able pastor. Laurel, under Bro. Clough's leadership, has beautified their church by sanding the floors, painting the pews, also the walls and ceiling. There have also been other changes and improvements in our churches and parsonages that we will not take the space to mention. Delmar, under Bro. Senter's encouragement, has paid off their mortgage of over \$1,600.00 and are now painting and beautifying their church and parsonage.

Our church building at Harmony, costing \$2,500.00, was completed early this Conference year, and on November 1. was dedicated. Shortly afterward they were able to liquify their entire building costs. This we feel, is an excellent start for the new church organized there. This organization was completed on November 18, with 14 members. Its present membership is 20, and they are going forward in the name of The LORD with Rev. E. W. Lowry as their present pastor.

A new work at Chestertown, organized as a church, are worshipping in a rented hall at present, looking forward to a better location a little later on. This is a college town and the most Colonial on the Delmarva Peninsula.

The Pilgrim Holiness Chapel work in Baltimore, cared for by Sr. Etta Mitchell, has been organized as a body, and is self-supporting, looking forward to a possible church organization, giving us the second church in Baltimore.

The revivals over the District this year have been graciously owned of God. Our Rallies, Ministerial Conventions and Camps—all were times of great spiritual uplift and instruction.

Just two days before this year's camp here at Denton, our new combination building was completed. We now have ample room for lunch-stand, book-room and business office. Surely this splendid building is a credit to our work and shows the growing interest and love for our District Camp. God bless the brethren for their cheerful and helpful service in erecting this building. We are yet looking forward to further improvements and above all, are seeking God's best for all concerned. We feel we have learned some valuable lessons this year at The Master's feet and in the school of experience that we will never forget.

Financially, the District has paid us in full, our salary, rent, necessary District traveling expenses and other incidentals such as postage, telephone, etc. We have no complaint to make and only wish we could have accomplished more for the Master and the District.

RESOLUTION No. 1—Whereas there is much undergrowth and leaves gathering on the grounds outside the wire; therefore be it resolved: That all the preachers give one day to renovate this, between December 1, and April 1. The preachers to be notified by the Secretary, authorized by the District Council as to date.

RESOLUTION No. 2—Whereas, Rev. Adams has had charge of the kitchen and is acquainted with its needs; Therefore, be it resolved: That he present a plan for a new kitchen and pantry, with the interior needs to the District Council, for the betterment of the Camp for the future.

RESOLUTION No. 3—Since there are dangers of fire, and other hazards, Be it therefore resolved: That a Committee of three be appointed by the District Superintendent, and authorized by the Conference to look after these matters, and hire such help as is needed to renovate the same.

RESOLUTION No. 4—Whereas all the districts in the Eastern School zone, including our own, have found the “penny-a-day-plan” for raising finances in support of Allentown Bible Institute, workable and blessed of God; Be it resolved: That we continue our support of this plan and urge that our churches throughout the District make an effort to raise the equivalent to a penny a day, per member for the Conference year.

RESOLUTION No. 5—Since there have arisen so many extra duties in connection with the office of District Treasurer, be it resolved: That our District Treasurer be paid \$50.00 instead of \$25.00 per year.

**REPORT OF THE RESOLUTIONS COMMITTEE**

RESOLUTION No. 1—Be it resolved: That the District Council elect a District Sunday-school Board of four, including the Sunday-school Director. The duties of the District Sunday-school Board, in harmony with the Manual of the Pilgrim Holiness Church, shall be as follows:

1. The District Sunday-school Board shall arrange for an annual Sunday-school Convention to be held some time during the year.

2. To promote and encourage the Sunday-school work throughout the District.

3. To present an annual report to the District Conference, which shall include the following:

(A) A statement of the work accomplished during the year.

(B) A statement of the general condition of the Sunday-school work on the District.

(C) To recommend to the District Conference through the Ways and Means Committee, the amount considered necessary to finance the District Sunday-school work.

4. The District Sunday-school Board shall be amenable to the District Council.

5. The District Council shall have the right to remove, or cause to be removed, any member of the District Sunday-school Board who, in the Judgment of such Council, is not in harmony with the teaching of the Manual of the Pilgrim Holiness Church.

6. If for any reason there is a vacancy on the District Sunday-school Board, the District Council, by a majority vote, may fill the vacancy. And be it further resolved that:

7. The District Sunday-school Board shall work in conjunction with The General Sunday-school Committee in promoting the annual Rally Day, etc., etc.

8. To have published each month a District Sunday-school sheet showing the attendance of each Sunday-school on the District for the month, the preceding month, and the attendance for the same month a year ago, as well as the average attendance for the year. This sheet to be sent to each pastor and Sunday-school superintendent on the District.

RESOLUTION No. 2—Whereas there is a pressing need for a God-called and equipped ministry today, and whereas the only way to meet this need is to have our Bible-schools, with all their possibilities and privileges presented to everyone possible. Be it resolved: That when our Bible-school meeting is held during the Camp, no other services be conducted simultaneously.

RESOLUTION No. 3—Whereas many of our preachers have never had the privilege of attending a Bible-school, be it resolved: That we have one ministerial convention a year of three days duration, and that we engage a Bible Teacher for the same to give our ministers and workers a course of study.



RESOLUTION No. 4—Resolved that each minister be asked to donate three consecutive days work on the Camp during the year, being given ample notice, and entertained at District expense, between September 1st and June 1st.

RESOLUTION No. 5—Be it resolved that we express our appreciation to our General Superintendent, Brother Surbrook, for so ably presiding over this Conference with love and kindness to all.

RESOLUTION No. 6—Resolved that we express our appreciation to Bro. Dukes, our District Superintendent and Brother Dixon, our Assistant District Superintendent for their faithful labors of supervision.

RESOLUTION No. 7—Resolved that we express our appreciation for our Camp workers, Revs. Shelhamer and Whitecotten our evangelists; Sister Shelhamer and Brother Fred Bertolet, our Children's and Young People's workers; Sister Hoffman our Song leader, and Sisters Martin and Dobie, our pianists for their faithful labors throughout the Camp, and for all others who so generously gave their services.

RESOLUTION No. 8—Resolved that we express our appreciation to Bro. Lowry, our District Secretary and Bro. Bean, our District Treasurer, for their faithful services throughout the year.

RESOLUTION No. 9—Resolved that we express our appreciation to Bro. Bradley, our Statistician, for his work on the statistical report.

RESOLUTION No. 10—Resolved that we express our appreciation to Bros. Adams and Dixon for their labors on the Camp-ground and in the dining-room.

### STANDING RULES

1. Inasmuch as our Y. P. S. Rallies have proven to be a great benefit and uplift to our district, be it resolved that they be continued. We further recommend that the Missionary activities among our Y. P. S. be continued and all monies for same be sent to the District Treasurer.

2. Inasmuch as our General Administration budget has been set at 50c per member; General Home Missions at 60c per member, and General Foreign Missions at \$1.00 per member, be it resolved that our District budget be set at \$1.00 per member, making a total of \$4.00 per member, this money to be sent to the District Treasurer as budget money to be proportioned accordingly. Furthermore, we suggest that a mite box be given each member and they be asked to give 1c a day for the year.

3. We recommend that each pastor's wife ask her church for a donation of fruits, vegetables, and canned goods not later than two weeks before the Denton Camp opens.

4. Inasmuch as Denton Camp has held a high spiritual standard from its beginning, be it resolved that we continue to both advertise and announce that nothing will be sold on the Lord's Day.

5. Inasmuch as there is a trend these days toward worldly dress, be it resolved that more strict rules be applied to the platform at Denton Camp.

6. Be it resolved that there will be no annual church business meetings held on the Lord's Day.

7. Be it resolved that the District Council engage children's and young people's workers, also pianists before camp convenes.

8. No pastor's wife shall serve as a delegate to the annual Conf., if another member of the church is available.

9. Be it resolved that each of our churches designate one day or evening of each month as "Donation Day" for the pastor and that the delegates present this resolution to their respective churches and see to it that this is carried out, inasmuch as many of our pastors are receiving inadequate support.

10. In order to defray the expenses of sending delegates to the General Conf., be it resolved that each pastor take an offering equivalent to 5 cents per member, same to be sent yearly to the District Treasurer.

11. Wherever possible each pastor shall hold a meeting within the bounds of his own church within the Conf. year.

12. The manuscript for the District Minutes shall be in the hands of the printer within at least 60 days and be it further resolved that churches receiving them send money for same within 10 days to District Treasurer.

13. No member from one Pilgrim Holiness Church shall be received into another in this District unless he receives a letter of good standing from the church of which he has been a member.

14. Each pastor shall raise the equivalent of 5 cents per member in order to defray the expenses of the District Conf.

15. Whereas our General Superintendent has ruled that our Conf. Year ends when we close our books, be it resolved that our books be closed June 30th and that our newly elected church board take office immediately, and that all reports be in the hands of our Statistician three weeks prior to our Conf.

16. The District Superintendent, Secretary and Treasurer shall be paid from the District Treasury for all postage relative to the District work.

17. The churches with fifty or more members shall pay the District Superintendent \$10.00 a visit, all others \$5.00 a visit.

18. Resolved that no individual serve as a member of more than one of the following: Council, Examining and Educational Board, and Resolution Committee.

19. Inasmuch as there are many duties for the District Secretary and Treasurer to discharge during the year, be it resolved that our District pay each the amount of \$25.00 for their labors.

20. Resolved that there be a registration of all who go to the dining room during our District Camp and that all be supplied with tickets to be presented upon entrance into the dining room.

21. Since the Assembly follows the District Camp, be it resolved that each minister and wife and delegate be entertained free, all others to pay 25 cents a meal to help pay expenses of the dining room.

22. Inasmuch as the ring meeting has been much appreciated in years past and since there are many who wish them continued, be it resolved that a leader be appointed by the Council to have charge of those meetings for the coming years and the same be announced and encouraged from the Denton Camp platform.

23. Whereas there is an increasing number of cars coming to our camp, be it resolved that the District Council have parking space marked out and three men be appointed as officers who can be empowered to look after this, and also the grounds in general, displaying his badge as officer.

24. Whereas there is too much work for the Caretaker during the Camp, be it resolved that the District secure a lady to assist her in cleaning the rooms and changing bed linens before the rooms are reoccupied.

25. Whereas Denton Camp is our District Camp, be it therefore resolved that the District Council place in every town and village within a radius of 50 to 60 miles, such posters as can be read easily, also notice to be sent to at least four city newspapers two weeks before our next camp.

26. Be it resolved that minister's children, 14 years of age or over, receiving free board, be asked to assist in the dining room when necessary.

28. Be it resolved that during the Camp the family prayer hour from 8 to 9 and the morning praise service from 9 to 10 with a leader appointed for the same, be announced and urged.

28. Whereas we recognize the need of supervision for the music of the camp, we recommend the appointment of Sr. Etta Hoffman as musical director of the same.

29. Resolved that we open all our churches at least once each year to the representatives of the Allentown Bible Institute and urge that a liberal offering be taken for the support of said school.

30. Resolved that the names of delegates representing the churches coming to our District Assembly be mailed to our District Secretary 10 days before the Assembly.

31. Whereas, some of our preachers and churches are allowing special singers and evangelists to come in their pulpit with dresses cut off at the knee and short sleeves; therefore, be it resolved that we as the Eastern

District refuse to tolerate this curse that once we took our stand against either in our home churches or on Denton Camp platform, the management so instructing the workers. Be it further resolved that we go according to the Bible 1 Pet. 3:3, 4 and 1 Tim. 2:9-10 and our manual page 30-31 under section 29 which is the church covenant.

32. Resolved that a day and hour be set for a healing service at Denton Camp annually and same advertised on the posters.

33. Be it resolved: That no trees shall be cut on the Camp Ground without the permission of the Camp Meeting Committee.

34. Be it resolved: That each Pastor have two Sundays off his Pastorate in the year, with pay.

35. Inasmuch as there is some expense connected with the office of District Statistician and much work connected therewith; Be it resolved that this office be paid the sum of \$10.00 per year.

36. Be it resolved, That to encourage the churches in securing Advocate subscriptions, an award be offered to the church securing the greatest number of subscriptions, based on a percentage of membership.
