## Journal of Proceedings

### FIRST SETTING

The District Conference met in session on Denton Camp ground Monday, Aug. 7, 1944, with Bro. H. D. Dukes in the Chair. Bro. Howard Williams was asked to lead the singing, singing "I have anchored in Jesus," after which Bro. Dukes introduced Rev. Harold D. Dieter, who spoke from Eph. 2:19-22, giving a very helpful talk on the same.



The roll call was then called for and since some of the Delegates were not present, a motion was made that we appoint suitable delegates to fill their places.

Moved and supported that Dorothy Ammon be seated as a Delegate of Baltimore Church, passed.

A motion was made that the conference bar be set the same as last year which is the first 9 benches in the two middle blocks and the 10th bench be turned over. Seconded and carried.

Bro. Wm. H. Neff was asked to take a seat on the platform, which he accepted.

A motion was made and seconded and carried that we have the District Superintendent's report. The report was then read.

A motion then made and seconded that the District Superintendent's report be accepted. Carried.

A motion made and seconded that the secretary send a telegram of sympathy to Rev. Shellhouse, telling him that we are praying for him. It was carried. An offering was taken and special prayer made for him.

A motion was made and seconded that the hours of the conference sittings be set the same as last year which is 8:30 A. M. to 12:00, 2:00 to 5:00 P. M., and 7:00 to 10:00 P. M. It was carried.

The District Superintendent presented the second Pilgrim Holiness Church of Baltimore, Md., to the conference. A motion was made, seconded and carried to graciously accept the church into our conference.

The District Superintendent then presented the Quinby Oaks, Va., Church to the conference. A motion made and seconded that the conference accept the church into the conference. It was carried.

Sisters Betty Lou Hickie and Geraldine Gangaware were introduced to the conference as pastors of Home Missionary work in our district. A motion then made and seconded that they take a seat in the conference bar.

Sister Ethel Gilkerson from Kentucky District, was introduced to the conference. A motion was then made and seconded that we approve the transfer of Sister Gilkerson from the Kentucky District to our District. It was carried.

A motion made and seconded that the Resolution committee be excused to work on their resolutions.

Bro. Dean Phillips and Bro. Will Martin were introduced to the conference.

The transfer of Bro. Wm. Martin from the Tennessee District to the Eastern District was read and a motion made and seconded that it be accepted. It was carried.

A motion made and seconded that Bro. Dean Phillips be accepted into the Eastern District and conference pending transfer from the Pennsylvania; New Jersey District.

The transfer has been received, making Bro. Dean Phillips a member of this District.

A motion was made and carried that we have the Auditing Committee report. They reported that the treasurer's book is in excellent condition. It was adopted.

The treasurer's report was then read, showing a considerable increase.

A motion was made and seconded that we accept the report of the treasurer. Carried.

A motion made and seconded to transfer the money sent to the treasurer for the Springfield Redemption Home to the regular District fund, since the Home does not operate any more. It was carried.

The Statistician's report was called for but he was not there. A motion then made and seconded that the statistician's report be given and the Statistician be called in.

A motion made and seconded that the members of our Sunday Schools who have died in service be listed in the memorials. An amendment made and seconded that all the boys who die in service from our Sunday Schools be included in our memorials, but in a separate column. The motion as amended was carried.

The report of the statistician was then given.

A motion made and carried that we accept the Statistician's report with correction.

A motion made that we have two or more report Blanks be sent to each church. Carried.

A motion made that the report blanks be sent out at least 60 days before our conference. It was carried.

The reception committee introduced Bro. Lawson Jump and Bro. Jason Felter to the conference.

A motion was made and carried that the brethren be given a seat within the conference bar.

## SECOND SETTING

Bro. Dukes, our District Superintendent, called on Bro. Wm. H. Vickers to lead the singing, singing "Never Alone." Bro. C. S. Hope led in prayer. Bro. Dieter gave another good message on Eph. 3:14 to the end of the chapter.

The roll call was asked for and called. A motion then made and seconded that the roll call be considered complete and that we disperse with it for the rest of the conference. It was carried.

Bro. Cranfield was introduced to the conference and an explanation as to why he attempted to withdraw from our district was given by him. A motion was made and seconded that a rising vote of recognition be given to Bro. Cranfield, asking him to stay with the conference as one of the Pilgrim Holiness Ministers. The vote was unanimous. He is staying.

Motion made and seconded that we hear the report of the resolutions committee. It was carried and the resolution committee then reported:

Resolution No. 1 was read and a motion made and seconded to adopt it.

After some discussion the motion was carried and the resolution adopted.

Resolution No. 2 was read and motion made and seconded to adopt the resolution. It was adopted. A motion was then made and seconded to reconsider resolution No. 2 bringing resolution open for discussion. It was carried. After

some discussion a motion was made and seconded that the resolution be referred back to the committee.

Resolution No. 3 was read and a motion made, seconded and carried to adopt it. It was adopted.

Resolution No. 4 was read and a motion made, seconded and carried to adopt it. It was adopted.

Resolution No. 5 was read and a motion made, seconded and carried to adopt it. It was adopted.

Resolution No. 6 was read and a motion made, and seconded to adopt it. An amendment made and seconded to forbid the meeting of the council during the ministerial and Young People's convention that would interfere with the services. It was carried. Resolution No. 6 then carried as amended.

Resolution No. 7 was read and a motion made and seconded to adopt it. It was adopted.

Resolution No. 8 was read and a motion made and seconded that we adopt it. It was adopted.

Resolution No. 9 was read and a motion made and seconded that we adopt it. It was adopted.

Resolution No. 10 was read and a motion made and seconded to adopt it. It was adopted and then a motion was made and seconded that we have a third Young People's rally on the first Saturday of the Denton Camp. It was carried.

Resolution No. 11 was read and a motion made and seconded that we adopt it. It was adopted.

Resolution No. 12 was read and a motion made and seconded that we adopt it. It was adopted.

Resolution No. 13 was read and a motion made and seconded that we adopt it. It was adopted.

The chair then called for the ways and means committee to report.

A motion made and seconded and carried that we have the report.

The ways and means committee report:

Resolution No. 1 was read and a motion made and seconded to adopt it. Carried.

Resolution No. 2 was read, a motion made and seconded to adopt it. After much discussion a motion was made and seconded to extend the time 15 minutes. An amendment was offered to this to the effect of extending the time 15 minutes or as long as it necessary to finish this business. The motion as amended was carried.

A motion was then made and seconded to refer this resolution back to the committee. It was carried.

The examining committee then reported the ones who they recommended for ordination. A motion was made and seconded that we adopt the candidates for ordination. It was carried.

A motion was then made and seconded to extend the time long enough to have the remainder of the examining board's report. It was carried.

The report was then read.

A motion made and seconded that we accept the report. It was accepted.

We then recessed by expiration of time and sang and repeated the Doxology. Bro. Dukes gave the closing prayer.

### THIRD SITTING

The chair asked Sister Howard Williams to lead the singing, singing "The Old Account Was Settled Long Ago." And since there is to be an ordination service at 8:00 o'clock the reading of the Scripture and comment will be omitted.

The chair then asked for any business concerning the conference.

A motion was made that we have the election of officers first thing Tuesday morning, seconded. And amendment was made and supported that the election be as soon as the necessary legislation be dispensed with.

The ways and means committee reported again, as follows:

Resolution No. 2 as revised was read and a motion made and seconded that we adopt it. It was adopted.

Resolution No. 3 was read and after some discussion it was tabled.

A motion then made and seconded that the churches take their regular monthly offerings for their budget and then a special offering be taken at Easter time for the home missionary work, and a special offering be taken in Nov. for the foreign missions, along with the regular monthly offering in both months. It was carried.

Resolution No. 4 was read and a motion made and seconded that we adopt it. A motion to amend by striking out the last clause was approved by common consent. The resolution as amended was carried.

The business session was closed to go into the ordination service. Bros. H. D. Dukes, T. S. Dixon, Bean, E. W. Lowry, and Wm. Vickers were asked to serve with Bro. Dieter.

The candidates for ordination were asked to take the front seats. Sister Louetta Holden was asked to lead us in singing "Rescue the Perishing," after which Bro. Wm. Vickers lead us in prayer. Several fitting Scripture lessons were read:

Bro. Bean reading from Titus 3:1-11.

Bro. T. S. Dixon reading from II Timothy 4:1-8.

Bro. H. D. Dukes reading from I Timothy Chapter 3.

The quartette of the Allentown Bible Institute then sang a consecration song, after which Bro. H. D. Dieter brought a very helpful message to the candidates.

Following is a list of those ordained:

To the ministry—Revs. Allen Thomas, Allen B. Clark, Carvell Tribbitt, Victor Bateman, Howard Williams, Marcille Williams, Etta Mitchell and Ethel Gilkerson.

After the beautiful ordination service, the business session was taken up again. A resolution concerning the  $\frac{1}{4}$  of the Pastor tithe being sent through the church to the district was then read and a motion made and seconded that we adopt it. Carried.

A motion made and seconded that the District Superintendent's salary be increased \$5 a week over his salary of last year making his total salary \$40.00 per week. It was carried.

A motion made and seconded that we extend the time one hour that is to 11:00 P. M. It was carried.

The election of officers then being the order of the day, the bar was cleared and Bro. Dukes appointed Bro. Allen Thomas, Bro. Allen Clark, Bro. Newell Reed, and Bro. Howard Williams as the tellers.

The ballots were cast for the election of District Superintendent and the Ballot declared Rev. H. D. Dukes the District Superintendent. The report of the findings on the ballots for the Assistant District Superintendent was read, declaring Rev. T. S. Dixon elected. Ballots were then cast for the District Secretary, and the ballot declared Rev. Earl W. Lowry elected. Brother P. F. Bean, having been nominated by the District Council as candidate for District Treasurer, a motion was made from the floor that we elect him by acclamation—carried, and he was elected.

A motion made and seconded that we put 3 names on our ballot at one time to elect the 3 remaining members of the District council. Carried. Ballots were then cast to elect the three remaining members of the District Council. The tellers were excused to count the ballots while conference continued its business, by a motion which was made, seconded and passed.

It was moved and seconded that the same brethren as last year be elected as District Trustees for the following year. It was carried, electing Revs. Wm. H. Vickers, T. S. Dixon, H. D. Dukes, Mr. Graham Price and Mr. James Trice as the Trustees.

The resolutions committee then reported their final resolutions while waiting a report on the ballot cast for the three council members.

Resolution No. 14 was lost.

Resolution No. 15 which was the resolution of thanks to those who helped to make the camp a success was read and heartily carried by a cherry Amen.

A motion in the hands of the Ways and Means Committee was then called for in regard to the Allentown Bible Institute. It was read and a motion was made and seconded that we adopt it.

The tellers returned with the count of their ballot leaving this motion pending as it was not the order of the day, but was only filling time until the ballot was counted.

The tellers read the report of their findings and it declared Bro. C. S. Hope, Bro. W. C. Beard and Wm. H. Vickers the 3 additional members of the council.

We adjourned by expiration of time until 8:30 A. M., and sang "I'm glad I'm in the Army of the Lord" and dismissed in prayer by Bro. Lowry.

#### FOURTH SITTING

The cahir asked Bro. Victor Bateman to lead in singing and then we were lead in prayer by Bro. Graham F. Senter.

The chair then called for the reading of the minutes which were read and approved.

A motion made and seconded that we hear the report of the committee on memorials while the District Council be excused to make their nominations for the new members of the examining board. The report was then read and a motion made and seconded that we accept it. Carried.

The floor was then opened to entertain invitations for the Young People's Rallies. Bro. Howard Williams invited the Rally to his church at Milton, Del., for the fall rally on Thanksgiving Day. A motion made and seconded to accept. It was accepted.

Bro. Alfred Clark invited the Rally to his church at Harrington, Del., for the Spring Rally on Good Friday. A motion made and seconded to accept. It was accepted.

A motion made and seconded that the names of the service men and women who are members of our churches and Sunday Schools be listed in the District minutes.

The District council returned and reported the nominations for the new members of the District Examining Board, given four names: Bro. E. R. Clough, Bro. Graham Senter, Bro. Alfred C. Clark, Bro. Godwin Rimmer. A motion was then made and seconded that the one receiving the highest number of votes serve the longer term of 3 years and the second highest serve the shorter term of 2 years. It was carried.

A motion made and seconded to vote on the 2 names on the one ballot for the new members of the examining board. It was carried.

The ballot was then cast and the ballot declared Bro. E. R. Clough elected to serve 3 years on the Examining Board and Bro. Alfred Clark elected to serve 2 years on the examining board.

The District Superintendent then read the appointments of the different committees, and a motion was made and seconded that we ratify the appointments. It was carried.

A motion made and seconded that we recind the action on Resolution No. 1. It was carried, recinding Resolution No. 1.

The platform resolution which was left pending from the last sitting because of other business was again taken up. After much discussion, an amendment was offered to the effect that the individual pastors be responsible to tell his own people at home and at Denton Camp. It was carried. A second amendment offered to omit the 14 inches and make it 12 inches from the floor. It was carried. A motion as amended was carried. A motion made and seconded that rule No. 5, Pg. 45 be stricken out and this resolution put in its place.

The invitations for the Ministerial Convention were given:

Bro. T. S. Dixon invited the fall ministerial convention to his church at Denton, Md. A motion made and seconded to accept the invitation to Denton for the fall convention. It was carried. A motion made and seconded

that the District Council set the date for the fall and spring convention in conjunction with the pastor concerned. Carried. Bro. P. F. Bean gave an invitation for the spring ministerial convention to be held at Bloxom, Va. A motion and second was given to the invitation. It was carried and the invitation was accepted.

A motion concerning the list of service men was again brought up and after some discussion it was lost.

A motion made and seconded that the secretary call the roll to see how many minutes are needed. It was carried, and the roll was called.

There was a correction to be made by common consent to No. 2.

Resolution No. 15 was read and adopted.

A motion was made and seconded to allow the minutes committee to order as many minutes as they feel is necessary.

A motion was made and carried that we hear from the ways and means committee. It was carried.

A resolution regarding the Allentown Bible Institute was offered. After which Bro. Dieter then spoke after which resolution No. 8, so stated was adopted.

A motion was made and adopted that the minutes of the last session be approved by the council if necessary.

A motion was offered to express our appreciation to the Denton church for their piano and for the members of the choir that helped with the singing.

A motion was made and carried that all unfinished business be taken care of by the District Council.

A suggestion by Bro. Beard that some move be made to give scholarships to students to our school.

We then adjourned by singing "Bless be the tie that Binds." Bro. Dieter closed with prayer.

## Reports

### DISTRICT SUPERINTENDENT'S REPORT

To the Fortieth Annual Conference of the Eastern District, Greetings:

Another year has passed since we last met as a conference; it has brought its battles and victories, heartaches and accomplishments. The burdens of war have affected all our lives but God and His cause are more precious than ever before.

Part of the hopes of last year have materialized but not all as yet. We have a fine group of people now organized into the second church of Baltimore under Sr. Etta Mitchell's untiring effort. They are hoping to acquire a church home in the near future. The Home Missionary Work at Berkeley Springs has had a year of struggle, however, Srs. Gangaware and Hickle are now looking forward to a well established work there. On July 6th the Quinby-Oaks organization was effected. These good folk have anticipated this advance step for some time. We are glad to welcome them into our midst under Sr. Mary Garrett's capable leadership. Bro. Vickers has faith-

fully sown the good seed of the Gospel in this section of our District for some years and now we are seeing some fruit.

We conducted six revivals on the District this year, two were Home Missionary meetings. In all, over a hundred bowed at the altar of prayer. God unusually blessed and owned these meetings.

Our churches are continuing to pay off old debts and are doing needed repair work. Dover has painted and carpeted the inside of her church and re-roofed her tabernacle on Camden Camp Ground, having rebuilt her parsonage last year. Bro. Floyd Baker was the pastor. The Crisfield brethren under Bro. Merrick Lowry's leadership, has re-roofed their church, carpeted and painted it on the inside and are now painting it on the outside. Goldsboro, too, has beautified and painted their church inside and out. Then they have moved it from its country location to a better one inside the town. At the reopening service on July 23rd Sr. Failing, the pastor, rejoiced to see her heart's desire: the church localized, free of debt, and beautified. The prolific growth of our Baltimore church has reached a new high this year and culminated her efforts on May 21st when Bros. Wolf, Deal, the capable pastor, Sr. Clough, the faithful members and friends, with myself rejoiced to see their mortgage burn to ashes and with it all their debts on church and parsonage. This is the largest church building on the District. This church now with a keen missionary vision is looking forward to doing more in spreading the Gospel this year. There are other improvements over the District which we might mention but time and space will not permit. Surely God is glorified as we seek to keep in repair and beautify His Dwelling Place.

As much as we appreciate these material advancements our hearts rejoice more over the visitations of God in our midst. The Pastors reported good revivals over the District. Some were unusual in the number of old people saved. Praise the Lord! The Ministerial Convention at Oxford was very profitable and a time of spiritual refreshing. The Young People's Rallies of Roxana and Denton were graciously owned of God. In these days of heartaches and pressure we cannot emphasize the spiritual side of life too much. Truly we need to watch and pray lest we get caught into the materialistic whirl and rush of life.

We greatly appreciate the powerful workings of the Holy Spirit in our midst during this camp and the souls that have prayed through to victory.

Our brethren have faithfully labored with us this year on our Camp Ground in the building of a new kitchen well equipped with refrigeration and stoves; surely we all appreciate this improvement. The much needed new bungalow home was built for the keeper of the Grounds this spring. We are thankful for these additions and are looking forward to further improvements, repair work to be done, and cottages to be built.

Our pastors have nobly "carried on" this year despite the heavy hand of sickness that rested upon several of them. Our dear Bro. Bafford is changing from pastorate work to evangelistic work due to the physical disability of his companion. This noble warrior of the Cross refuses to be placed on the shelf—may God give him many sheaves this year. Then, too, let us continue to remember our dear Bro. Schelhouse in believing prayer



as he goes through his physical crisis; God has used him blessedly in the past and we trust God will spare him to us many more years. Our dear Sr. Wiggins, after months of patient suffering, passed to her reward on Nov. 1.

Personally we wish to sincerely express our appreciation for the splendid cooperation and spirit which our brethren and District officials have shown to us. May God bless each one!

Looking forward, we trust this conference will make special provision to care for advance work in our Home Missionary Department. Then, since our General Superintendent has asked for legislation to care for our aged ministers in our next general conference, we should formulate some favorable resolution to send to our next general conference concerning the same. Above all let us "Seek first the Kingdom of God and His righteousness" knowing God's blessings will be ours if we do things God's way.

I have traveled for the District, 9,600 miles, for which I received .03¢ per mile. Also received from the District Treasurer, \$45.32 for telephone and postage; and \$1,820.00 for salary in full. I turned back to District Treasurer nearly \$700.00 from Revivals and District work.

4. Inasmuch as the Board of Directors of Allentown Bible Institute has voted on a five year plan for financing the maintenance of the buildings and property of The School, and at the same time to accumulate sufficient funds to construct a dormitory and library building, without going into debt; Be it therefore resolved: That we as a District agree to support the School program for five years by making every effort to raise the equivalent of .25¢ per member, per month on our District.

## STANDING RULES

1. Inasmuch as our Y. P. S. Rallies have proven to be a great benefit and uplift to our district, be it resolved that they be continued. We further recommend that the Missionary activities among our Y. P. S. be continued and all monies for same be sent to the District Treasurer.

2. Inasmuch as our General Administration budget has been set at 50c per member; General Home Missions at 60c per member, and General Foreign Missions at \$1.00 per member, be it resolved that our District budget be set at \$1.00 per member, making a total of \$4.00 per member, this money to be sent to the District Treasurer as budget money to be proportioned accordingly. Furthermore, we suggest that a mite box be given each member and they be asked to give 1c a day for the year.

3. We recommend that each pastor's wife ask her church for a donation of fruits, vegetables, and canned goods not later than two weeks before the Denton Camp opens.

4. Inasmuch as Denton Camp has held a high spiritual standard from its beginning, be it resolved that we continue to both advertise and announce that nothing will be sold on the Lord's Day.

5. Ladies taking part in the services on the platform at Denton Camp shall be required to wear their dresses not shorter than twelve inches from the floor. Full-length sleeves are requested, and nothing shorter than three-quarter ones will be permitted. No jewelry, shoulder-bobs, permanent waves, nor cosmetics, including finger-pail polish, will be tolerated.— "In like manner also, that women adorn themselves in modest apparel, with shamefacedness and sobriety; Not with broided hair, or gold, or pearls, or costly array; But that which becometh women professing godliness, with good works." II-Tim. II:9-10.

6. Be it resolved that there will be no annual church business meetings held on the Lord's Day.

7. Be it resolved that the District Council engage children's and young people's workers, also pianists before camp convenes.

8. No pastor's wife shall serve as a delegate to the annual Con., if another member of the church is available.

9. Be it resolved that each of our churches designate one day or evening of each month as "Donation Day" for the pastor and that the delegates present this resolution to their respective churches and see to it that this is carried out, inasmuch as many of our pastors are receiving inadequate support.

10. In order to defray the expenses of sending delegates to the General Conf., be it resolved that each pastor take an offering equivalent to 5 cents per member, same to be sent yearly to the District Treasurer.

11. Wherever possible each pastor shall hold a meeting within the bounds of his own church within the Conf. year.

12. The manuscript for the District Minutes shall be in the hands of the printer within at least 30 days and be it further resolved that churches receiving them send money for same within 10 days to District Treasurer.

13. No member from one Pilgrim Holiness Church shall be received into another in this District unless he receives a letter of good standing from

the church of which he has been a member.

14. Each pastor shall raise the equivalent of 5 cents per member in order to defray the expenses of the District Conf.

15. Whereas our General Superintendent has ruled that our Conf. Year ends when we close our books, be it resolved that our books be closed June 30th and that our newly elected church board take office immediately, and that all reports be in the hands of our Statistician three weeks prior to our Conf.

16. The District Superintendent, Secretary and Treasurer shall be paid from the District Treasury for all postage relative to the District work.

17. The churches with fifty or more members shall pay the District Superintendent \$10.00 a visit, all others \$5.00 a visit.

18. Resolved that no individual serve as a member of more than one of the following: Council, Examining and Educational Board, and Resolution Committee.

19. Inasmuch as there are many duties for the District Secretary and Treasurer to discharge during the year, be it resolved that our District Treasurer be paid the amount of \$50.00 and our District Secretary, \$35.00 for their labors.

20. Resolved that there be a registration of all who go to the dining room during our District Camp and that all be supplied with tickets to be presented upon entrance into the dining room.

21. Since the Assembly follows the District Camp, be it resolved that each minister and wife and delegate be entertained free, all others to pay 25 cents a meal to help pay expenses of the dining room.

22. Inasmuch as the ring meeting has been much appreciated in years past and since there are many who wish them continued, be it resolved that a leader be appointed by the Council to have charge of those meetings for the coming years and the same be announced and encouraged from the Denton Camp platform.

23. Whereas there is an increasing number of cars coming to our camp, be it resolved that the District Council have parking space marked out and three men be appointed as officers who can be empowered to look after this, and also the grounds in general, displaying his badge as officer.

24. Whereas there is too much work for the Caretaker during the Camp, be it resolved that the District secure a lady to assist her in cleaning the rooms and changing bed linens before the rooms are reoccupied.

25. Whereas Denton Camp is our District Camp, be it therefore resolved that the District Council place in every town and village within a radius of 50 to 60 miles, such posters as can be read easily, also notice to be sent to at least four city newspapers two weeks before our next camp.

26. Be it resolved that minister's children, 14 years of age or over, receiving free board, be asked to assist in the dining room when necessary.

28. Be it resolved that during the Camp the family prayer hour from 8 to 9 and the morning praise service from 9 to 10 with a leader appointed for the same, be announced and urged.

28. Whereas we recognize the need of supervision for the music of the camp, we recommend the appointment of Sr. Etta Hoffman as musical director of the same.



29. Resolved that we open all our churches at least once each year to the representatives of the Allentown Bible Institute and urge that a liberal offering be taken for the support of said school.

30. Resolved that the names of delegates representing the churches coming to our District Assembly be mailed to our District Secretary 10 days before the Assembly.

31. Whereas, some of our preachers and churches are allowing special singers and evangelists to come in their pulpit with dresses cut off at the knee and short sleeves; therefore, be it resolved that we as the Eastern District refuse to tolerate this curse that once we took our stand against either in our home churches or on Denton Camp Platforms, the management so instructing the workers. Be it further resolved that we go according to the Bible 1 Pet. 3:3, 4 and 1 Tim. 2:9-10 and our manual page 30-31 under section 29 which is the church covenant.

32. Resolved that a day and hour be set for a healing service at Denton Camp annually and same advertised on the posters.

33. Be it resolved: That no tree shall be cut on the Camp Ground without the permission of the Camp Meeting Committee.

34. Be it resolved: That each Pastor have two Sundays off his Pastorate in the year, with pay.

35. Inasmuch as there is some expense connected with the office of District Statistician and much work connected therewith; Be it resolved that this office be paid the sum of \$10.00 per year.

36. Be it resolved, That to encourage the churches in securing Advocate subscriptions, an award be offered to the church securing the greatest number of subscriptions, based on a percentage of membership.
