MINISTERIAL STUDY COURSE AGENCY

Whereas, there is an increasing need of maintaining ministerial study courses such as are provided for by the Manual and inasmuch as it seems advisable to conduct our study course **in a more** effective manner than is now operating, therefore be it Resolved, that the General Conference authorize the General Board to establish and maintain a **central office** at the denominational headquarters to conduct study courses for **the benefit** of the ministry of the Pilgrim Holiness Church, viz.:

1. Such Agency shall be known as the Ministerial Study Course Agency.
2. It shall exist for the purpose of assisting unordained ministers and deaconesses in completing the study courses required by the church.
3. This Agency shall provide a list of study course books as authorized from time to time by the General Board.
4. The Agency shall maintain contact by mail with each enrollee throughout each course of study and shall provide study outlines, examination questions and other appropriate information.
5. The Agency shall maintain adequate educational records as authorized from benefit of the enrollee and the church.
6. It shall be understood that this agency shall in no manner supplant the work of the examining and educational boards of the several districts, but shall cooperate with them by reporting annually on the progress of student ministers and deaconesses within their jurisdiction.
7. The Agency shall provide suitable transcripts and issue certificates upon the satisfactory completion of the work assigned.
8. The Agency shall make reports to the General Board as may be required by that body.
9. The Agency shall be authorized to take all necessary steps for the conducting of its work as indicated by this resolution and may be approved from time to time by the General Board.

Be it further Resolved, that all licensed ministers and licensed deaconesses of the Pilgrim Holiness Church who are taking study course work shall be required to enroll with the ministerial Study Course Agency.

FIRST SITTING, WEDNESDAY MORNING, JULY 29, 1959

The fifth Annual Conference of the Eastern Ohio District of the Pilgrim Holiness Church convened July 29, 1959 at 9:00, at Bethel Camp Grounds, Coschocton, Ohio, Rev. B. A. Awe, our District Superintendent, brought the conference to order and led in prayer, after which Rev. R. Ankrim led in singing "At The Cross" and "Must Jesus Bear The Cross Alone?" Rev. Awe admonished us to let God have His way in this conference so that through the coming year everything will work out for God's honor and glory. Rev. Leadingham led in prayer. Rev. Flexon spoke to the conference before the Communion Service. He spoke from I Corinthians 11:17-34. Communion was then served to the District Council: Rev. Ankrim, Rev. Leadingham, Rev. B. A. Awe, Rev. O. Awe, Rev. Gilkerson, Rev. Stiverson, Rev. Pugh, Rev. Brown and Rev. Siders, by Rev. Flexon. Rev. B. A. Awe, Rev. Leadingham, Rev. O. Awe and Rev. Stiverson served the Conference. There were three tables, Rev. Siders prayed dismissing the first table. Rev. Brown the second and Rev. Stiverson the third. Rev. B. A. Awe, our District Superintendent, introduced Rev. Flexon to the Conference. He complimented our District on the beautiful Camp Grounds. He also gave a brief summary of the Tennessee and North Central districts. Rev. Flexon mentioned to the Conference that a 16 page bi-monthly magazine was published for Pastors only. The first issue to be in the mail this week. This magazine was to be sent to the pastors the first year free of charge. The name of the magazine is "Pilgrim Pastors."

2. A planned ministry never goes to seed on anything. There are three things that can ruin the minister: money, maidens, and modernism.

3. Have a diversified ministry. Preach on sin (Isaiah 58) Preach Doctrine: Virgin Birth, Resurrection, Person of the Holy Ghost, Second Coming, Preach on Hell, Preach the gospel and let us preach the truth. Back it up with the word of God.

Bro. Awe asked us all to take Rev. Flexon's message to heart. He then turned the conference over to Rev. Flexon who is the chairman.

The Conference Bar was established to include the front three sections to the left of the platform and eight rows back.

The time schedule for the sittings of the conference was as follows:

8:30 - 12:00 2:00 - 5:00 7:00 - 10:00

Rev. Flexon asked for the report of the Examining Board. It is as follows: First year license to be given to D. Wachenschwanz, W. G. Peoples, Thomas Craig Duvall, Mrs. V. Dickerson. Motion made that these people be seated in the Conference Bar. Seconded. Carried.

The General Superintendent asked for the District Superintendent's report. A motion was made that we accept this splendid report by a standing vote of thanks. The Asst. District Superintendent, E. E. Leadingham gave his report. This also was accepted by the conference.

Rev. Flexon then asked the conference what they were going to do about seating the delegates and pastors in the conference who have not paid their United Stewardship Fund. Rev. Stiverson recommended the following: "We the District Council feel that many of our churches have done their best in the raising of the U. S. F., therefore, we feel all pastors and delegates should be seated within the Conference Bar." Seconded. Carried.

Motion made that we recess for lunch until the 2:00 P. M. session. Dismissed with prayer by Rev. E. E. Leadingham..

SECOND SITTING, WEDNESDAY AFTERNOON 2:00 P. M.

The second sitting was called to order by Rev. Flexon. Rev. Virgil Miller led in singing "I am Thine O Lord." Rev. Flexon then read from Psalm 20. Rev. Siders led in prayer. Motion was made to dispense with the roll call. Seconded. Passed.

The Auditing Committee Report was given by Mrs. M. D. Stiverson for Mrs. Roy Ankrim. Motion was made to accept this report. Accepted. District Treasurer's Report was given by Rev. O. Awe. Motion was made to accept this report. Seconded. Accepted. Rev. Flexon mentioned the 73.5 per cent of the United Stewardship Fund was paid by this District. The Educational & Examining Board gave their report.. There were 44 - 1st year licensed ministers, 5 - 2nd year licensed ministers and 7 - 3rd year licensed ministers. Rev. K. Beckley was recommended for ordination. Rev. O. Blackford to be added to list of 1st year licensed ministers. Motion was made to accept this report. Seconded - passed.

The S. S. promotional Secretary gave his report. The average attendance for last year was 4,702. This is a 221 increase over the previous year. This report was accepted by the Conference.

The District Council asked Rev. Leadingham to speak on Sunday School work.

Rev. Awe was asked to present the new Church. It was moved and seconded that we accept the Fremont's Church's pastor and delegates into the Eastern Ohio District. Carried.

Recessed until 7:00 P. M. Dismissed by Rev. Flexon.

THIRD SITTING, 7:00 P. M., WEDNESDAY, JULY 29, 1959

Rev. Flexon called the conference together, Rev. Ives led in singing "Tis So Sweet To Trust In Jesus." Bro. Baker then led in prayer.

The Ways and Means Committee finished its report:

Resolution No. 4 - Motion was made that this resolution be referred back to Committee for re-drafting. Seconded - Passed.

Rev. Flexon asked Rev. Awe to introduce District evangelists to Conference. They were Rev. B. H. Pugh and Rev. Lucas.

Rev. Rickner introduced Mrs. Flexon to the Conference. A motion was made that she be given an honorary seat in the Conference Bar. Seconded - Passed.

The Resolution Committee gave their report. Delete No. 2 Camp Ground. Report accepted.

Statistician report was given by Mrs. Violet Barnhart. Motion made that we accept this report with a rising vote of thanks. Seconded - Passed.

Memorial Committee report was given by Mrs. O. M. Awe. Mrs. K. C. Vance passed away April 28, 1959. Rev. Flexon led in prayer after this report was given..

Rev. Flexon asked Rev. Awe to select six tellers. They are: Rev. Earl Pidcock, Rev. R. King, Rev. G. Jordan, Rev. H. Dickerson, Rev. Earl Appleman, Rev. L. Ashcraft. Rev. Flexon led in prayer, asking for God's guidance in our voting.

The election of Officers was as follows: Rev. Leadingham was elected on the second ballot as Assistant District Superintendent. Rev. M. D. Stiverson was re-elected as District Secretary, Rev. O. M. Awe was re-elected as District Treasurer.

Five members of the District Council were elected on the first ballot. They are as follows: R. Ankrim, J. R. Siders, W. Brown, W. Gilkerson and B. H. Pugh. Two members of the Examining and Educational Committee were elected, (One to replace Bro. J. Webb who resigned). They are as follows: Rev. Gilkerson and Rev. Ankrim.

DISTRICT SUPERINTENDENT'S REPORT

To General Superintendent Rev. R. G. Flexon, the pastors, evangelists, delegates, and friends of the fifth annual Conference of the Pilgrim Holiness Church of the Eastern Ohio District on the Bethel Camp Grounds, Coshocton, Ohio.

Greetings in the precious name of Jesus!

This year our District Conference is being held preceding the District Camp. We have been looking forward to this great gathering to do business for the King and for the advancement of our District. We are also looking forward to a gracious camp, a feast of great things, spiritually and souls finding God. For the past three months there has been much preparation for this camp. Our Youth Camp was a great blessing. It went beyond all expectations. Our teachers were at their best. The camp was conducted here at Bethel Camp Ground and Rev. Wm. Gilkerson and Rev. and Mrs. John Minsker were the evangelists. This indeed was a great revival among our youth, scores of souls found. Our Pilgrim Youth are on the march and going forward.

Our Young Peoples Council and our Zone Chairman are all splendid young men. They have done noble and constructive work leading our district young people into a greater realm of spirituality and Christian fellowship. Much credit can be given to Paul Harris, our editor of the "Pilgrim Review." He has done his work well and the paper has been enjoyed by all its readers.

NEW ORGANIZED CHURCHES

On November 9, 1958, we organized a new church in Gallipolis with nine members. Rev. Everett Russell held a revival in that city and as a result we organized a new Pilgrim Holiness Church there. This seemed to be the brightest project for a Pilgrim work I had ever seen. They rented a former Church of God church building and erected a splendid Pilgrim Holiness Church sign and all was going well but all of a sudden someone undermined it with powerful personality and more money and gave the owner of the building far more rent and took the building and some of the people. However, those people were not yet established in the Pilgrim Church and didn't think too much about it. The pastor did not notify the Dist. Supt. and he was not aware of it until he drove through the city sometime later and saw the new Pilgrim sign down and independent posters put up in its place. What a shock this was to the writer of this report and what a loss to our movement.

On February 8, 1959, we were privileged to organize a new church in Fremont with fifteen members. This work was started by Rev. Dallas Ford and his fine family a few years ago. During that period he has built a splendid new church building which is ideal in every respect. Rev. and Mrs. Ford are to be commended for their fine work. Their labors of love are a great blessing to the city of Fremont and to our district. God bless them as they continue their labors there.

NEW CHURCH BUILDINGS

We have a number of new church buildings and improvements added to our District this year. Our Pilgrims in Fostoria where Ronald Travis is pastor have made a great move forward in that they have purchased a beautiful church building all equipped with Sunday School rooms and a fine auditorium in a fine location in

the city of Fostoria. Since this move has been made, the church has taken on new life and has made splendid gains. We predict the Fostoria church will be one of the leading churches in our District.

Our Pilgrims in Nevada where Robert Blinn is pastor, have purchased a good building that can be converted into a splendid church building with plenty space for Sunday School rooms and even a parsonage. Part of this building now is converted into an auditorium for worship. We dedicated this church July 12th. God bless the Pilgrims there.

In Ashley where J. R. Walter is pastor, they are building a beautiful brick church on one of the best lots in the city. Bro. Walter has built a number of churches in our District but this is one of the finest he has built. He has labored faithfully for nearly a year and has done nearly all of the work himself. We have everything in Bro. Walter; he is a brick layer, carpenter, plumber, electrician, seat builder and a good preacher and pastor. We as a District, are greatly indebted to Brother and Sister Walter. They will surely share in the rewards given in heaven.

In Elyria where Carles Fletcher is pastor they completed last year a fine new parsonage wherein they have been worshipping. The work is growing and plans are now underway for a new church building. Pray for them to obtain several thousand dollars for said project. This is where you can invest in souls. This place is a sound investment for anyone. God bless Brother Fletcher who is full of energy and faith.

In Oak Hill where J. R. Siders is pastor, they are in the process of completing a beautiful new church building. This fine large structure is a great asset to the Pilgrims there and to our district. Brother Siders, a veteran of the cross is doing a good work, not only in building but in the spiritual interests of the community.

In Chauncey where Ray Pidcock is pastor, they have all the plans to build a new church building. The old building in which they have worshipped has been taken down and is being cleared away as fast as possible. It was a large building and they are doing it with volunteer labor. May the Lord bless and help them as they go up with the new church building. Pray for them that they may receive enough financial help.

In Barberton Mt. Summitt Church where H. E. Honeycutt is pastor, they are completing a beautiful new church building. This church came to use a little more than a year ago and has proved a great blessing to our District. May God continue to bless our new Pilgrims there under the capable leadership of Brother and Sister Honeycutt.

In Circleville where Alonzo Hill is pastor, they have built a new addition to their church larger than the old structure, which enlarges their auditorium as well as Sunday School rooms and a young people's auditorium. God bless Brother Hill's faithful labors in Circleville.

In Newark where Ralph King is pastor, they have completely rebuilt their church. A very beautiful modern structure, a new auditorium and a complete church. This indeed is a great asset to the city of Newark and our District. God bless those comparatively new Pilgrims there.

In Barberton where Roy Ankrim is pastor, they have purchased a beautiful new parsonage. A lovely home for the Ankrims. They are worthy of this lovely home. The Pilgrims there are aggressive under the capable leadership of the Ankrims.

IMPROVEMENTS ON PROPERTIES

In Danville where Norval Rickner is pastor, they have installed a new furnace in the parsonage and other repair work done.

The Lancaster First Church where Charles Hook is pastor, they have done some general repair on their church, painting, etc. also purchased a Sunday School Bus.

The Lancaster So. Broad St. church where Clyde Goss is pastor have redecorated their church and are making plans to purchase a 'lot' beside them for the purpose of extending their church building.

In Carbondale Church where Ann Mae Simmons is pastor, they have made an addition to their church by adding two beautiful Sunday School rooms. The church has also been redecorated.

The Cleveland Church where Duane Saylor is pastor have purchased a new Hammond Organ, fire proofed the furnace room and by refinancing their program saved several thousand dollars. To God be all the Glory.

In Mansfield where J. H. Sherwood is pastor, are in process of building a new parsonage and it is nearly completed. When fully finished it will be a lovely parsonage.

The church in South Webster, where Frank Williams is pastor, has put in new Sunday School rooms in their basement, also a furnace room.

The Stewart church where Dave Lyons is pastor, have excavated underneath their church and put in a new foundation and four lovely Sunday School rooms.

The church in Zanesville where Virgil Miller is pastor. have received a new organ given by Mr. Claude Foster. This is surely a splendid gift. This brings a total of four new organs that have been given to the Eastern Ohio District by Mr. Foster. We want him to know we deeply appreciate these gifts.

Now something about our improvements on our new camp grounds. First, these are your grounds, The Pilgrims of the Eastern Ohio District and anyone who loves God's beautiful nature ought to love these grounds. It is practically a gift to us, although we had to borrow \$20,000 to pay off the indebtedness on the grounds, build this new motel style dormitory, the dormitory above the children's tabernacle, the new lunch room and putting new ceilings in the other dormitories. Also other repairs and improvements yet to be made. We plan sidewalks and landscaping in front of the dormitory, all buildings to be painted and cement floor in tabernacle. It was a miracle in itself how we obtained a loan of \$20,000. It was in answer to prayer, however, it is all used up on this extensive work here and the indebtedness on the ground. We still need a thousand or more dollars to complete these improvements.

Now a word of appreciation to those that gave time and strength in working on these new buildings on our camp ground and the repairs that were made. There are those who need honorable mention. Rev. Melvin Stiverson who was appointed by the Council to be the Building Manager and Purchasing Agent. Brother Stiverson has done his work well and has worked on the Ground and worked day after day. Brother Miller, an able carpenter, was of great assistance to the Building work and labored faithfully. Dale Jones also spent much time here and labored faithfully. Along with these men there was E. E. Leadingham, O. M. Awe, John Curry, Wm. Gilkerson and a number of his men. Rev. Hook, Harry Dickerson, Charles Fletcher and Duane Saylor, Noval Rickner, Clyde Watters, Frederick Baker and others

whose names we do not recall made it possible to complete this work.

Other repairs and improvements have been made on churches and parsonages that we do not have an account of. We reeplly appreciate the interest our people have shown in the upkeep of their buildings.

In closing, another milestone is passed, another year is gone, and in the good providence of God we are now assembled to do business for the King. Let us pray much for this conference as we chart our course for the years that lies ahead, if Jesus tarries. Let us receive the exhortation the Apostle Paul gave to the Ephesian Church, "Be ye kind one to another, tender hearted, forgiving one, another, even as God for Christ's sake has forgiven you," and again, with the Apostle John, "Herein is love, not that we loved God but that he loved us, and sent His Son to be the propitiation for our sins." Beloved if God so loved us, we ought also to love one another.

We are trusting God for a great camp meeting that lies just before us. Let us keep much in prayer and the unity of the Spirit for the salvation of souls and the strengthening of our churches.

**REPORT OF THE RESOLUTIONS COMMITTEE AS ADOPTED
BY THE CONFERENCE**

UNITED STEWARDSHIP FUND AND DISTRICT BUDGET

NO. 1 BUDGETS

- A. Be it resolved that the Conference Treasurer have cards printed designating what each church is required to raise for the conference and general interests and said cards be forwarded to the pastors as soon after Conference as possible.
- B. That all money raised in the local church for District Budget or United Stewardship Fund and District Budget be sent by the local treasurer direct to the District Treasurer, that the local church may receive due credit.
- C. The District Treasurer shall send a statement to all churches that are in arrears with their budgets, six weeks prior to the close of the conference year.
- D. Whereas, the General Conference has set up a United Stewardship Fund to care for a part of the expense of operating the general church, and
Whereas, the Manual states on Page 82, Paragraph 8 that, Any pastor failing to raise the United Stewardship Fund without a good reason shall be denied voice in the annual conference, and
Whereas, this rule must be enforced beginning with our next annual conference, and
Whereas, there is a great need that all district budgets be paid as early in the year as possible so that the district may function properly
Be it resolved, that we as a conference set the month of September as United Stewardship Fund and District Budget month.
Be it further resolved that during this month each church shall do their best to either raise in cash or pledges the total amount covering each of these items. Any church that now has a workable plan to take care of these items need not feel under any obligation to take such offerings during this month but should continue with their present plan.

NO. 2 CAMP SERVICES

Be it resolved that the schedule of our Camp services be so arranged as to permit one afternoon service each to be devoted to the interests of the following phases of our work, namely, Foreign Missions, General Church Extension and District Home Missions.

NO. 3 COMMITTEES

- A. Be it resolved that the Ways and Means Committee and the Resolutions Committee consist of five members and three shall be a quorum.
- B. Be it resolved that no unauthorized person be permitted to present resolutions on the Conference floor. All resolutions must be cleared either with the Resolutions Committee or the Ways and Means Committee (depending on the nature of the resolution under consideration), who are the only authorized committees to present resolutions on the conference floor.

NO. 4 CONFERENCE

- A. Be it resolved that the Annual Conference of the Eastern Ohio District be opened with a Communion Service for our members, delegates and friends. Be it further resolved that the District Council appoint a committee to arrange for this service.

B. To expedite the business of this conference . . . Be it resolved that all resolutions be sent to the committee chairman 30 days prior to the District Conference and the Committees meet with the respective members and act upon the resolutions; in turn the resolutions be placed into the hands of the District Secretary to be mailed to all local churches, ordained and licensed ministers of the Eastern Ohio District before conference convenes.

NO. 5 CONFERENCE YEAR

- A. Inasmuch as our District Statistician needs more time to prepare reports for conference, be it resolved that our church fiscal year close June 30th and that all reports be sent to the District Statistician not later than July 10th.
- B. Inasmuch as the Conference year closes June 30th, be it resolved that the District Treasurer's books close July 5th.

NO. 6 DAILY VACATION BIBLE SCHOOL

Be it resolved that churches be urged and encouraged to conduct Daily Vacation Bible School in their churches, subject to the camp dates.

NO. 7 DECEASE OF MINISTER OR WIFE

Be it resolved that upon the death of a minister's wife of the District, that the District Secretary be given the information immediately; and that he notify by phone or wire the Zone Chairman and that they immediately notify all pastors in their Zone; and they shall be reimbursed by the District for expense incurred.

NO. 8 LOAN PLAN

Be it resolved that we adopt the Pilgrim Pension, Inc., in the Eastern Ohio District for the purpose of helping churches to build.

NO. 9 MINISTERS

- A. Be it resolved that no person be given or hold license to preach, who is not a member of the local Pilgrim Holiness Church.
- B. See Ministerial Study Agency. See page 12

NO. 10 MINISTERIAL CONVENTION

Be it resolved that the Eastern Ohio Conference have an annual Ministerial Convention. The time and place to be determined by the Council.

NO. 11 MISSIONS

In consideration of the need of District Home Missionary work, be it resolved that each pastor in the Eastern Ohio Conference be subject to a call by the Home Missionary Committee for a two weeks revival.

NO. 12. NAME OF CHURCH

Each church is requested to erect at its place of worship the name of the church and the name and address of the pastor..

NO. 13 PASTORS

- A. Be it resolved that the churches of the Eastern Ohio District shall give first consideration to the Ministers of our conference in extending a call for their pastor. Be it further resolved that the District Superintendent shall not recommend a minister outside the bounds of our district, until after a church has failed to elect a pastor from the ministers of our District. .
- B. Since it requires a two-thirds majority vote at the election to call a pastor, be it resolved that no church vote on more than one name at a time.
- C. Inasmuch as some of our pastors do not receive adequate salary to meet the high cost of living; Be it resolved that the district superintendent take more

interest in the support of the pastors, when the superintendents meet with the local church boards.

- D. In order that the churches may receive credit for the full amount they contribute the pastor's utilities are supplied be made a part of the pastor's annual report. Be it resolved that the question of whether or not
- E. Be it resolved that the pastor's term of office shall continue until and including the second Sunday after Camp.

NO. 14 SALARIES

We recommend that all matters of salaries of District officials be settled before the election of officers, inasmuch as it is embarrassing to discuss such matters after election. Further, that all officers receiving salary for said office when necessary to have assistance to care for their work, shall select help only from those already holding complimentary tickets, or pay for the needed help during camp and conference out of their own pockets.

NO. 15 STANDARDS

- A. Be it resolved that the workers on our camp ground be required to maintain the standards of the Pilgrim Holiness Church.
- B. Inasmuch as there are moral, physical and spiritual danger in and many perils associated with television, be it resolved that this conference go on record urging our people to guard against such.
- C. Inasmuch as our Manual gives only two sacraments or ordinances to be observed in our churches, namely, the Lord's Supper and water baptism, Be it resolved that the Eastern Ohio District forbids public feet washing as part of our worship service.

NO. 16 SUNDAY SCHOOL PROMOTION

- A. Be it resolved that an Annual Sunday School Convention be held in each zone, the same to be under the supervision of the superintendent. Furthermore, that the District Sunday School Committee shall appoint committees in the various zones of the conference to work under the supervision of the superintendent.
- B. Inasmuch as our District Camp is a united and cooperative effort of all of our Eastern Ohio Churches, be it resolved that all Sunday School scholars attending camp be counted in their respective Sunday Schools.
- C. A few of our churches have been faithful in teaching the Sunday School lesson to their shutins, and such who are physically incapacitated, to attend the regular Sunday School sessions of the church. This is commendable and more should be done in this direction which falls under the designation of Home department. But in order to avoid any discrepancies in the Sunday School attendance count in any of the churches, are in all fairness to every Sunday School in the District. Be it resolved that only those present in the Sunday School classes in the church be counted in total attendance for that Sunday. All others who may be taught elsewhere such as our shutins, are to be counted and entered under "Home Department" and not be included in the total count.
- D. Be it resolved that we adopt the following recommendations:
 - (1) That each Sunday School endeavor to start new Sunday School classes.
 - (2) That each Sunday School and each class set goals and strive hard to reach them.
 - (3) That each Sunday School adopt a system for contacting absentees..
 - (4) That each Sunday School plan weekly group visitations.
 - (5) That each Sunday School departmentalized as soon as possible. .

- (6) That much attention be given the Cradle Roll. This is a ripe field, and will pay dividends if worked.
- (7) That at least one branch Sunday School be started by each Zone.
- (8) That each Sunday School subscribe for the Sunday School Advance for all of the teachers.

NO. 17 SUPERINTENDENT

- A. Be it resolved that when the district superintendent prepares his schedule for visiting the churches, that he send a copy of said schedule to each pastor in the district.
- B. Resolved that the District Superintendent shall supervise all annual church business meetings if possible; however he may authorize his assistant or the pastor to conduct this meeting.

NO. 18 TITHE

Whereas the Manual provides that our people pay their tithe into the church in which they hold their membership—therefore, we strongly urge that this matter be called to the attention of our people who wish to move to other communities.

NO. 19 VOTING

Inasmuch as there is some dissatisfaction with district council members receiving office by acclamation, be it resolved that henceforth all members of the District Council be elected to office by secret ballot.

NO. 20 APPRECIATION

- A. Be it resolved; That we extend our General Superintendent a vote of thanks for his Christ-like spirit and efficient manner in which he conducted this Conference.
- B. That we extend a vote of thanks to the District Superintendent, District Secretary, District Treasurer, the additional members of the District Council, the various committees, dining personnel, camp and conference registrars, maintenance men, camp policemen and all others who have assisted in any way to make our conference the success it proved to be.
- C. That we express our appreciation to the Coshocton News and Rev. Paul Harris for the splendid cooperation that they have given us in their paper for this camp meeting and the Conference, and that a letter of appreciation be mailed to them by our Conference Secretary.
- D. Above all, we do fervently offer thanks to our Heavenly Father for his blessings upon us during this Camp and Conference.

**REPORT OF THE WAYS AND MEANS COMMITTEE AS ADOPTED BY
THE CONFERENCE
BUDGETS**

NO. 1 UNITED STEWARDSHIP FUND (Formerly Gen'l Budget)

- A. Be it resolved that the manual provision for the United Stewardship Fund as adopted by the 1958 General Conference of the Pilgrim Holiness Church be adopted by our District Conference. (The amount of United Stewardship Fund \$8.00 per member per year, this formerly General Budget Name).
"If the local church does not properly divide the money, the conference treasurer is authorized to do so." Sec. 149, Par. 1-3, 1958 Manual.
"No church is permitted to specify funds until its monthly quota for general interests is paid."
- B. We recommend that the United Stewardship Fund be raised monthly in the Sunday School or church, taking any Sunday thought best for the offering.
- C. Be it resolved that we request the General Board to send a deputational worker to visit our local churches and assist the pastors in raising the Conference Home Missionary and United Stewardship Fund.
- D. Whereas, there are some churches in our district which have a struggle to pay their United Stewardship Fund, and
Whereas, there are times when such churches have unspecified funds for both foreign missions and general extension, therefore,
Be it resolved, that any church wishing to do so may take from unspecified foreign Missionary money enough to make up that part of the United Stewardship Fund which applies to foreign Missions which is 20% of said fund.
Be it further resolved, that, this may apply to unspecified general church extension funds also, and from such funds the 14% of the United Stewardship Fund which applies to general church extension may be paid.
This can only apply when the other part of the United Stewardship Fund has been made up.

NO. 2 DISTRICT BUDGET

Inasmuch as the response to District Tithing system has been insufficient, be it resolved:

- A. That all stationed ministers pay all their tithe on wages received from their ministerial income to the District.
- B. That all unstationed licensed and ordained ministers pay 50% of their tithe from their ministerial wages to the District.
- C. That all licensed and ordained ministers not receiving income from the church pay 25% of their tithe to the District.
- D. All such tithes are to be paid to the local church treasurer and forwarded to the District Treasurer.
Be it resolved:
- E. That our District Budget be established at \$5.00
- F. That our District Budget be set up on the percentage basis in the same manner as our United Stewardship Fund.

General Conference 6%

Camp Ground Property	24%
District Parsonage	15%

NO. 3 CAMP BUDGET (SPECIAL)

Be it resolved that this Conference set a budget of \$2,000.00 for the operating expenses of the District Camp Meeting.
That each church shall assume a portion of said budget according to their financial ability to pay.

NO. 4 CAMP AND CONFERENCE

- A. Be it resolved that each local church be asked to bring provision to alleviate the financial obligation of the Camp Meeting.
- B. We recommend that the District Council be requested to properly remunerate every person who has by labor or service helped to prepare our camp grounds and to carry on the camp, so far as reason and consistency will permit.
- C. Be it resolved that all ministers' wives shall be subject to call to give one day's work in the kitchen or dining room.
- D. That our active ministers' children under the age of 14 be entertained free. Those over 14 to be subject to call for work in any department.
- E. We recommend that all visitors attending the Annual Conference be charged a reasonable sum for meals, the price to be set by the committee in charge. This does not apply to ministers or their wives. Each church and youth society should take a good liberal offering to provide the expense of the delegate when attending the conference.

NO. 5 CHURCHES NEWLY ORGANIZED

Be it resolved that with the exception of the pastor's tithe, our newly organized churches be assessed but one-fourth of the district budget quota for the first fiscal year following their organizations; one-half of the second year; and three-fourths the third year. From then on they shall assume the full quota.

NO. 5 DISTRICT HOME MISSIONS

Inasmuch as the present demand upon our District Home Missions Department by the several different churches is ever on the increase and in that the finances in this department have been and are at the present time very limited, the following recommendations are made in order that we may more effectively accomplish greater results in this field.

It is recommended:

- A. That all finances now going to the several different churches be withdrawn and that the entire consideration of the District Home Missions be placed in one church at a time and that said church receive such help as long as deemed necessary, but not to exceed one year's approval at a time.
- B. That the District Council along with the District Home Missions Committee decide on the church to be selected to receive such aid.
- C. That each church now receiving financial aid from the District Home Mission Department and those who will receive it in the future will receive at least a 60 day notice before any such funds are withdrawn.

- D. That the last Sunday of September be designated as District Home Missions Sunday and that this Sunday be highly advertised by the District Superintendent, District Home Missions Committee, District Paper, and any other means necessary to get the need before the people of our District.
- E. That the District Home Missions be given equal recognition in the same manner as the General Church Extension, and Foreign Missions at our annual Camp Meeting.
- F. That the pastor of the selected church and District Home Missions Committee be authorized to do District wide deputational work and that each church in the District be required to have at least one such service each year.
- G. That the pastor of the selected church be given substantial aid that he might be able to give full time to the church for at least eight (8) months after such aid has started.
- H. That a quarterly report be made to the District Home Missions committee showing the progress being made and how finances (other than the pastor's support) are being spent.
- I. That funds raised be used to make up that portion of the District Budget which applies to District Home Missions.
- J. That the Eastern Ohio District have, what may be termed as an Emergency Reserved Army. This army to answer calls given by the District Home Missions Committee. Three enlisted persons may give any amount above \$2.00 and will not be called on more than two times in one Conference year. Those enlisted are to be recruited by the District Home Missions Committee and may re-enlist every year if they so desire. The money obtained in this manner is over and above the regular budget.

NO. 7 SUNDAY SCHOOL BUDGET (DISTRICT)

- B. Be it resolved that each Sunday School be assessed annually the following amounts based on their average to be used for the expense of Sunday School promotional work.

Yearly Average	Amount to pay
50 or below	\$.25 per month
50 to 10050 per month
100 to 200	1.00 per month
200 or above	1.25 per month

The same to be paid to the District Treasurer.

MINISTERS

NO. 8

- A. Resolved that no preacher be privileged to pastor a Pilgrim Holiness Church of this district until he has promised to include the various financial activities of the district in the program of his local church.
- B. Be it resolved that all ministers except pastors pay 50% of their tithe into their local church. Pastors are expected to place all their tithe into their local churches.

NO. 9 MINISTERIAL BENEFIT ASSOCIATION

- A. Be it resolved that each pastorate or charge in the Eastern Ohio District shall enroll its pastor and wife in the Ministerial Benefit Association and pay from

the local treasury their membership and call fees. That it shall be the duty of the pastor to turn over to the local church each call as it is presented to him. That the District Secretary notify the secretaries of the local churches of the above action and send application blanks.

- B. Inasmuch as Resolution No. 9A provides for the enrollment of each church's pastor and wife in the Ministerial Benefit Association and, inasmuch as a number of our churches have still failed to follow through on this District's legislation, be it resolved that our District Superintendent when making his first visit of the church he is visiting, has enrolled their pastor and wife in the Ministerial Benefit Association, and it not, to encourage that church to do so as soon as possible.

MINUTES

NO. 10 COST OF MINUTES

Be it resolved that the price of District Minutes to be left to the discretion of the District Council.

NO. 11 PEPARING MINUTES FOR PUBLICATION

Be it resolved that a stenographer be employed to help the Secretary in preparing the minutes that they may be ready for the printer at the close of the conference and that we pay the stenographer \$20.00 for services.

NO. 12 COST PILGRIM REVIEW

Inasmuch as our District Youth can no longer bear the expense of the Pilgrim Review, be it resolved that the expense and space of this periodical be equally shared by the District, District Sunday School, and District Youth Treasuries. This is unanimously recommended by the Eastern Ohio District Youth Council.

RECORDS

NO. 13 RECORDS—SAFE

Due to the fact that we are now a separate conference, and to the fact that our conference records are valuable to us, and to the fact that a small fire could completely destroy the same, therefore

Be it resolved that the council be authorized and directed to purchase an approved safe and place it in the keeping of our District Treasurer for the safe-keeping of our records and finances.

SALARIES

NO. 14 DISTRICT SUPERINTENDENT

- A. Inasmuch as we recognize the high cost of living and the increase of traveling expenses we recommend the following: District Superintendent Salary \$4,200.00, 6c per mile traveling expenses; parsonages; all utilities and four weeks vacation.
- C. Be it resolved that the District Superintendent and his wife be enrolled in the Ministerial Benefit Association and that the dues be paid by the District Treasurer.
- D. Be it resolved that the District shall enroll the Superintendent in the Pilgrim Pension Plan as per the plan for the local churches and their pastors, and be it further resolved that we pay the District Superintendent's Social Security.

NO. 15 ASS'T. SUPERINTENDENT

We recommend that the Superintendent when in need of additional help in the administration of district work, be authorized to secure the services of his assistant. Further, we recommend that the assistant be paid \$12.50 per day.

plus 6c per mile traveling expense.

NO. 16 DISTRICT COUNCIL

We recommend that 6c per mile be given each member of the District Council for traveling to and from the council meetings.

NO. 17 CONFERENCE SECRETARY AND TREASURER

Be it resolved that the Conference Treasurer's salary be \$450.00 and the Conference Secretary's salary be \$200.00.

NO. 18 STATISTICIAN AND SUNDAY SCHOOL PROMOTIONAL SECRETARY

Be it resolved that the Statistician shall receive \$50.00 per year and that the Sunday School Promotional Secretary shall receive \$75.00 per year.

NO. 19 EDUCATIONAL AND EXAMINING COMMITTEE

Be it resolved that the Educational and Examining Committee be given \$50.00 per member.

NO. 20 SOCIAL SECURITY

- A. Whereas, Social Security has been extended to clergy, and whereas, many of the pastors of the Eastern Ohio District have elected to go into the plan, and whereas business enterprises pay 50% of the cost of the Social Security plan for their employees, and we believe it to be in keeping with the Spirit of the New Testament for the local church to share the cost of the Social Security plan for their pastor, therefore, we recommend that the Church share the cost on a 50-50 basis.
- B. We further recommend that all evangelists who tithe their ministerial income one hundred percent into the local church of which they are a member, said local church shall share the cost of the Social Security plan with them on a 50-50 basis. This shall also apply to evangelistic singers.

TREASURER

NO. 21 AUDITING THE TREASURER'S BOOKS

Be it resolved that we employ a certified public accountant to audit the books of the Conference Treasurer. The audit to be made after the books have been closed on July 5, and prior to the convening of the annual conference.

NO. 22 INSURING THE TREASURER

We recommend that the Council be requested to have the District Treasurer bonded.

YOUTH

NO. 23 YOUNG PEOPLE

- A. Be it resolved that all young people be urged to place all their tithe in their own local church, in the usual way.
- B. That each church contribute \$10.00 annually, to be applied on the expense of the District Youth Convention.
- C. That our District Pilgrim Review be placed on a subscription basis. Single copies at 50¢ per year, 10 copies sent to one address, 35¢ per copy per year. All subscriptions are to expire at the end of the conference year.

NO. 24 MONITORS AND POLICE

We recommend that young people who receive free entertainment at our Dis-

trict Convention be required to pay a registration fee of \$1.00, said fee to be used to provide monitors and adult supervision. Furthermore, said monitors shall be appointed by the District Council.

NO. 25 DISTRICT YOUTH PRESIDENT

Inasmuch as the District Youth President receives only a mileage fund, be it resolved that an offering of not less than \$10.00 dollars be given him for each Zone Rally in which he speaks.

NO. 26 YOUTH CAMP

Be it resolved that where the church considers it necessary and they are financially able to do so that they consider paying the way to the Youth Camp to those youth who are unable to pay.

MINUTES OF EASTERN OHIO DISTRICT YOUTH CONFERENCE

The business meeting of the District Youth was opened with congregational singing under the direction of our Executive Youth President, Rev. John Minsker III. Our daily Radio Broadcast, under the direction of Rev. Paul Harris, was made a part of our devotional service.

The Conference was then turned over to the Chairman, Rev. B. A. Awe, our District Superintendent. Rev. Awe expressed his appreciation for the labors and cooperation of the officers and youth of our District.

Roll call was given by the Secretary, with Pastors (22), Presidents (9), and Delegates (30), responding to the call.

The Executive President, Rev. John Minsker, rendered a report of his activities for the year; including a detailed report of our splendid Youth Camp. This report was received with a hearty Amen.

The Treasurer's report was given by Rev. Ronald Travis. This was a very encouraging report and was accepted by a standing vote of approval.

The Zone Leaders gave their reports at this time. In these reports they cited the progress made in their Zone. From these reports we all agree that the youth are moving forward! "Praise God from Whom all Blessings flow."

Zone Leaders: Akron - Rev. Carles Fletcher; Columbus - Bro. Clair Parsons; Jackson - Bro. Wayne Irvine; Nelsonville - Rev. John Minsker III; Portsmouth - Rev. Virgil Miller; Toledo - Rev. Harold Bughman; Lancaster - Rev. Paul Harris.

Rev. Duane Saylor reported for the Resolutions Committee. The Committee recommended Resolution No 9 which was approved.

Rev. Virgil Miller reported for the Ways and Means Committee. The Committee recommended Resolutions No. 5 and 6, which were approved.

It was moved and supported that the Secretary send a mimeographed copy of all Resolutions of each church.

Rev. Minsker presented the following with an award, revealing the Conference's appreciation for their labors in the District Youth Quiz. Betty Holdren, Sharon Downey, Joy Bolin, from Columbus First, (perfect score). Anna Mae Hamilton, Bremen; Charles Fife, Cambridge; Bill Barnhart, Oak Hill; John Sabo, Baltimore. A standing vote of appreciation was given by the Conference.

Rev. Minsker asked for a standing vote of appreciation for the labors of Rev. B. A. Awe in presiding over the Conference.

A motion was made to adjourn.

YOUTH CONFERENCE

RESOLUTION NO. 1

Inasmuch as we feel the visits of our District Youth President to our zones during the past year have been a real blessing, be it resolved that the executive President visit each zone at least once during the fiscal year.

RESOLUTION NO. 2

In order to enlist the greatest degree of cooperation in our zone work, be it resolved that each zone teacher arrange a meeting with the district superintendent, the pastors, and Y. P. presidents of his zone as soon after conference as possible to plan the program for his zone for the year.

RESOLUTION NO. 3

We recommend that the Extensive Committee and Zone Leaders be kept in the age limit of 35 as much as practical.

RESOLUTION NO. 4

Be it resolved that the Resolutions Committee and the Ways and Means Committee be standing committees to be appointed by our Executive Committee as soon after the Annual Business Meeting as possible.

RESOLUTION NO. 5

Be it resolved that the Eastern Ohio Pilgrim Review be published monthly.

RESOLUTION NO. 6

Be it resolved that those participating in sponsored activities such as the choir, orchestra, camp ground labor, etc., be required to maintain the standards of the Pilgrim Holiness Church.

Be it further resolved that it be the responsibility of the Young People's Executive Committee to enforce this during the Young People's Convention.

RESOLUTION NO. 7

Inasmuch as the youth camp this year was a great success, be it resolved that the Eastern Ohio District have an annual youth camp, and the Youth Executive Council to work out details with the District Council.

RESOLUTION NO. 8

Inasmuch as the unity of the District depends greatly upon the "oneness" of the Zone Churches, be it resolved that each Zone plan at least one "Special Prayer Meeting" as early in the Conference year as possible.

RESOLUTION NO. 9

Be it resolved that each church within the Zone be requested to notify the Zone Leader if impossible for that church to be represented at the Zone Rally.

WAYS AND MEANS

RESOLUTION NO. 1

- A. Be it resolved that an executive fund, out of which the expenses incidental to the functioning of the Executive Committee in their official duties, be maintained.
- B. Be it further resolved that each church pay \$2.00 a year plus 1/10 of all offerings, or the equivalent thereto, lifted in youth meetings to maintain this fund.
- C. Be it further resolved that the district Youth President be reimbursed .06 per mile for traveling expenses.

RESOLUTION NO. 2

Be it resolved that a fund be set up from which the Editor of the Pilgrim Review may pay incidentals, to be taken up at the first Zone Rally of the Zone.

RESOLUTION NO. 3

Be it resolved that the Pilgrim Review be published monthly by a commercial printer at the editor's discretion.

RESOLUTION NO. 4

Inasmuch as the editor of the Pilgrim Review must give of his time in preparing this monthly district paper, we recommend that the editor be remunerated \$25.00 from the youth treasury, and the Sunday School and district each paying \$25.00 if agreed upon by the council.

RESOLUTION NO. 5

Be it resolved that each of our seven (7) Zones contribute \$4.00 per Rally for the coming year to be used to send our six (6) contestants to the National Youth Convention at Winona Lake, Indiana, in June of 1960.

RESOLUTION NO. 6

Be it resolved that each Zone contribute \$3.00 per month to the support of a resident Pastor, whom our District Home Mission Board shall select for the current Home Missionary Project.

REPORT OF THE DISTRICT YOUTH PRESIDENT

To the Fifth Annual Youth Conference of the Eastern Ohio District of the Pilgrim Holiness Church at Bethel Camp Grounds, Coshocton, Ohio.

Greetings to you in Jesus Christ our Lord - the source of strength for all our labors.

Another year of time and toil, life and labor has gone into Eternity. We are prone to think it is just another one of those many, many years that we have to see come and go and little value of a precious year seems to be known. The tempo of this age is increasing and day is dying in the West, night is swiftly approaching and the work we represent must be given loyalty if we have such to give.

The following is a brief report on the four phases of our district Youth Work namely - Monthly Zone Rallies, Annual United Zone's Rally, District Youth Camp and the Youth Convention.

The MONTHLY ZONE RALLIES are lacking in interest. According to some of the reports sent in, there is depicted quite a dull picture in behalf of this work. Attendance is low, enthusiasm is a word unknown and many of the reports show we must do something to change this undesirable picture. I visited five (5) of the seven (7) zones this year and without discrediting the zones that are pushing forward, I found the general condition of the zone meetings is not healthy. This picture can be changed if the local congregations will give their best cooperation and good will. Let us challenge this weakness by making it a matter of earnest prayer; and praying until we see the need of having closer fellowship in the zones in these days when the people of God must band together as never before.

The UNITED ZONES RALLY was a great time for the people of God. May 30th, 1959 was a day of rich fellowship for the Eastern Ohio Pilgrims as they met at the District Camp Grounds, Coshocton, Ohio. There were two (2) services - 10:00 A.M. and 2:00 P.M. and over 300 in attendance. It was suggested an offering be received for a new sound system to be purchased for use at the camp grounds and \$300.00 was readily lifted for this need. This day was well spent in the Lord.

The DISTRICT YOUTH CAMP is of no little importance. It is very evident the Holy Spirit sanctioned this great work. There were five days of classes, discussion and practical admonition for the Youth and the evening services were dedicated to Gospel preaching and singing. One outstanding result of this camp was the seeking and finding help in the Lord by over 160 boys and girls. We are convinced this camp must be continued and not ignored. It can be conducted in a manner pleasing to the Lord and we can have Heaven's sweet smile as we stay away from foolish compromises and dangerous ensnarements. Boys and girls who wish to become real men and women even in these days invite the Bible Standard for true success and happiness.

The DISTRICT YOUTH CONVENTION is part of our annual program in which we endeavor to prayerfully choose and elect officers to carry the various responsibilities of the Youth Work.
