PROCEEDINGS

The Illinois and Missouri Districts Assembly of the Pilgrim Holiness Church convened at Charleston, Ill., on Monday morning at 8 o'clock with General Superintendent W. R. Cox in chair. After a song, and prayer, by G. C. Middleton, the chairman addressed the assembly, using the 12th chapter of Romans for a scripture lesson.

The minutes of the last session were read and the roll was called, after which the following business was transacted.

Moved and supported that the first three rows of seats constitute the conference bar. Carried.

On motion the following were admitted into the assembly as advisory members. G. C. Middleton, Henry Kearns, Anderson, Nora Allen, Harry Doerle, Mattie Rice, Mrs. Sara Willis, and Ellis Holt.

Moved and supported that the sessions should be from 8 to 11:45 a. m. and 1:30 to 5:30 p. m. Carried.

Moved and supported that all actively engaged local

preachers be granted an honorary seat in the assembly bar. Carried.

Moved and supported that the rules governing the general assembly with regard to deliberations be adopted to govern the district assembly. Carried.

Moved and supported that we eliminate the reading of the delegates reports, and read only the pastors reports since pastors reports cover delegates reports. Carried.

Moved and supported that we extend the time for business ten minutes. Carried.

Moved and supported that we recind the action relative to the time for convening and adjourning. Carried.

Moved and supported that the sessions should be from 9 to 11:45 a. m. and 2 to 5 p. m. Carried.

Adjourned with prayer.

Afternoon Session, July 12

The afternoon session was devoted largely to the reading of pastors' and evangelists' reports. The following were appointed to serve on committee: Alma Shearer on resolutions committee, and W. H. Pratt, C. E. Connelly, F. A. Shull a committee on memorials.

The assembly at this time entered into a season of prayer in behalf of Rev. M. F. Pratt in his illness, and also the bereavement of Rev. Seth S. Rees and family in the loss of their beloved Seth Jr.

Moved and supported that all pastors and laymen who have sent missionary funds direct to the field or to the General Foreign Missionary treasurer report same to our district foreign missionary secretary and treasurer in

order that her report may be complete. Carried.

Adjourned with prayer.

Morning Session, July 13

The morning session opened with Supt. W. R. Cox in chair. After a season of song and prayer a stirring address was given by the chairman. The roll was then called and the minutes of the last session read.

It was moved and supported that Mrs. W. M. Hall be regarded as delegate from Charleston. Carried.

Reports of pastors and evangelists were read. Partial report of committee on memorials was read and adopted.

Moved and supported that the name of Harry Doerle be referred to the examining board. Carried.

Afternoon Session, July 13

After a short devotional service it was moved and supported that we dispense with reading of the roll.

The report of the resolutions committee was read and adopted.

Moved and supported that the recommendations turned in to the secretary relative to finance be referred to the ways and means committee. Carried.

Partial report of the examining board was read and approved, after slight correction.

The following were appointed by the District Supt. to serve on the Auditing Committee: A. D. Canary, Ellis Holt, Thomas L. Brinton.

A partial report of the ways and means committee was read and accepted. Moved and supported that article No. 5 of same be referred to ways and means committee to be revised. Carried.

The recommendation from the ways and means committee, that the ministers place one-half their tithes in the district treasury to be applied on the support of the district superintendent, was lost.

Moved and supported that we proceed with the election of officers. Rev. D. C. Shearer was elected district superintendent and his report was read and accepted.

Moved and supported that the ways and means committee draft a resolution to provide a plan for raising the deficiency in the salary of the district superintendent. Carried.

It was further moved and supported that all ministers

who have paid their tithes for the support of the district superintendent report the same to the ways and means committee. The motion was amended by inserting the clause, "also all ministers who have not paid in full their tithe for the support of the district superintendent shall report the same and state amount in arrears and when the same can be paid. Carried.

Moved and supported that the time for business be extended one-half hour. Carried.

Rev. W. H. Pratt was elected assistant district superintendent.

Moved and supported that we have a night session. Carried.

Moved and supported that the night session convene at 7:30 and adjourn at 10.

W. E. Catey was elected district secretary.

Adjourned with prayer.

Night Session, July 13

Session opened with song, prayer and an exhortation by the chair.

Moved and supported that we dispense with roll call. Carried.

The following officers were elected: Geo. A. Smith, treasurer; H. M. Bassett, C. E. Connelly, R. S. Wheeldon, members of the district council.

Moved and supported that we suspend the rules and elect by acclamation one trustee, to serve three years. Carried.

D. C. Shearer was elected.

Moved and supported that we elect two examining boards—one to examine candidates on course of study the other on character and conduct. The following were elected on the examining board (educational): W. H. Pratt, Vada Deardorf, and Otis Shaffer.

Moved and supported that we extend the period of session until 11 o'clock. Motion lost.

Moved and supported that we rescind the former action relative to meeting at 9 o'clock a. m. Carried.

Moved and supported that we meet at 8 a. m. Carried. Benediction by A. D. Canary.

Morning Session—July 14

After a short devotional service the assembly entered

into the business session.

Moved and supported that the examining board serve for a term of three years. Carried.

H. M. Bassett, W. E. Catey and C. E. Connelly were elected members of the examining board to examine candidates on character and conduct.

Moved and supported that we suspend the rules and elect a foreign missionary secretary and treasurer. Carried. Mrs. C. E. Connelly was elected.

Moved and supported that the district superintendent appoint a camp-meeting committee. Carried.

The report of the statistical committee was read and accepted after correction.

Moved and supported that we reject the action taken by the E. St. Louis church, until investigation can be made by the district superintendent. Carried.

A partial report of the ways and means committee was read and accepted.

Moved and supported that the district superintendent conduct the first and fourth quarterly meetings and that he instruct pastors to conduct the second and third quarterly meetings on uniform date. Carried.

A partial report of the committee on memorials was read and accepted.

The committee appointed to investigate and report to the assembly prospects for a permanent camp-ground reported that a suitable ground could be purchased at Casey, Ill. After considering this proposition it was moved and supported that a committee of twelve be elected by acclamation to further investigate, and the same to be vested with power to purchase a permanent camp-ground. Carried.

The following committee was elected: W. H. Pratt, D. C. Shearer, W. E. Catey, H. M. Bassett, Geo. A. Smith, R. S. Wheeldon, Otis Shaffer, Roy Beltz, C. E. Connelly, W. M. Hall, Roy Bradley, F. A. Shull.

Adjournment.

Afternoon Session—July 14

After reading of the minutes, the reports of the foreign missionary secretary and treasurer and the district treasurer were read and accepted.

Moved and supported that the churches which have not paid in full for the support of the editor of our church paper, pay as soon as possible. Carried.

A partial report of the committee on memorials was read and accepted.

Moved and supported that the delegates to the general assembly be elected by the district council. Motion was lost. Moved and supported that we elect delegates to the general assembly by acclamation. Carried.

The following ministerial delegates were elected: F. A. Shull, H. M. Bassett, C. E. Connelly, Mrs. Alma Shearer, Mary E. Dice, Geo. A. Smith, Roy Beltz, R. S. Wheeldon, Vada Deardorf, Wm. Beard.

Alternates: Otis Shaffer, Mattie Rice, Pearl Roush.

Lay Delegates: Mrs. W. H. Pratt, Mrs. R. S. Wheeldon, Mrs. W. E. Catey.

Alternates: Ida Vernon, Sister Stenson, Rosa Reed.

Moved and supported that in the event any alternate cannot attend the general assembly the district superintendent be empowered to appoint others to fill vacancies. Carried.

Moved and supported that a pledge be taken among members of the assembly to make up salary deficit for the district superintendent. Carried.

Moved and supported that all churches which did not raise their apportionment in full for the support of the district superintendent do so as soon as possible. Carried.

The report of the examining committee was read and accepted.

Moved and supported that Mark Haley be accepted as a minister of the assembly and that his standing be determined by the district council after investigation. Carried.

Report of the ways and means committee, also committee on memorials, were read and accepted.

Moved and supported that an offering be taken for the retiring secretary. Carried.

Moved and supported that we rescind the action pertaining to quarterly meetings to be conducted by the district superintendent. Carried.

Moved and supported that the district superintendent conduct the first and third quarterly meetings. Carried.

Moved and supported that we adjourn to meet at 7:00 p. m. for next session.

Night Session—July 14

After a beautiful and touching ordination service the minutes of last session were read and accepted.

Moved and supported that the selling of the church at Old York be referred to the district council. Carried.

The auditing committee reported that the books of the treasurer balanced and were correct.

Moved and supported that we rescind the action of the assembly pertaining to the camp meeting committee. Carried.

Moved and supported that the committee be composed of nine members. Carried.

The following were appointed by the chair: O. K. Shaffer, W. E. Catey, C. E. Connelly, Thos. Brenton, F. A. Shull, Roy Beltz, Robert Mobley, Jesse Winney.

Moved and supported that a committee of three be appointed by the chair to assign subjects for the ministerial convention. Carried.

The following committee was appointed: W. H. Pratt, O. K. Shaffer, Vada Deardorf.

Moved and supported that each member of the assembly send two or more subjects to W. H. Pratt, Terre Haute, Ind., R. R. F, Box 86, to refer to the committee on subjects. Carried.

Moved and supported that we elect a camp-meeting treasurer. Carried.

W. M. Hall was elected by acclamation.

Adjournment.

REPORTS OF COMMITTEES

No. 1. Report of the Ways and Means committee Adopted by the Assembly.

1. We recommend that each pastor urge his church to adopt the tithe system and insist that his members place their tithe money into the local church treasury and that from this a stipulated weekly amount be paid to the pastor sufficient for his support; and at the last quarterly meeting the church decide what support their pastor shall receive the following year.

2. We recommend that this assembly require the ministerial members to attend camp and assembly and that they be present on the first day of the camp and remain until the close of the assembly, and that the churches keep up

the salaries of their pastors while attending same and provide their transportation expenses to and from camp and assembly and that if they do not attend they shall send a report of their work and an excuse for their absence, and furthermore if they fail to do so for two consecutive years their names shall be dropped from the assembly roll.

3. We recommend that the churches adopt where practical the envelope system for collecting the tithes and offerings.

4. We recommend that each pastor and evangelist be responsible for one comfortor for camp meeting purposes and that the name of the donor be inscribed.

5. We recommend that each church donate for camp meeting purposes the following articles to be used in the kitchen and dining room: 3 knives, forks, and spoons; 3 plates, cups, and saucers; 1 tray; 3 dish towels; 3 dessert dishes; 1 paring knife; 1 dish pan or skillet, or large kettle. We further recommend that each church contribute to the support of the camp by sending in fruits, vegetables, canned goods, groceries, etc., etc.

6. We recommend that the district superintendent make his district semi-annually and devote the remainder of his time to home missionary and evangelistic work, and that the pastors conduct their own quarterly meetings when the district superintendent is absent.

7. We recommend that the district superintendent make his first round as soon as possible and that he make a home missionary address at each church and take subscriptions for the home missionary work, these subscriptions to be paid weekly or monthly.

8. We recommend that the district superintendent be paid a minimum of one thousand dollars per year and traveling expenses.

9. We recommend that the remuneration which the district superintendent receive for his home missionary and evangelistic work be applied on his salary and that the district be given due credit for same.

10. We recommend that the churches raise for the district superintendent's support as follows:

11. We recommend that all ministerial members of this assembly pay one-tenth of their income from ministerial labor into the district treasury to supplement the district superintendent's support, same to be reported by them to their local church treasurer, and that the district superintendent tithe his income for ministerial labor to the general superintendent's support, same to be reported to the district treasurer.

12. We recommend that all ministers have their reports made out in full before assembly convenes.

13. We recommend that our pastors co-operate with the representatives of our church institutions as to suitable dates to represent their interest and that an offering be taken for same.

14. We recommend that pastors open new work in their community and co-operate with the district superintendent in doing home missionary work where possible.

15. We recommend that the district secretary be instructed to publish three hundred copies of the minutes and send them to the pastors to be distributed among the members and that an amount equal to ten cents per copy

be remitted to the district treasurer by each church to pay for same. We further recommend that all of our people study and practice these recommendations.

16. We recommend that the district secretary keep in touch with the pastors and remind them of the plans of the district assembly and encourage and help them to carry out said plans.

17. We recommend that the district provide uniform envelopes for collecting tithes and offerings in the local church and that on these envelopes space be given to designate the amount to be applied on local expenses, home missionary work, foreign mission work, Bethel Orphans' Home, Beulah Rescue Home, and Gingswood College respectively. We further recommend that the district secretary secure a proper number of these envelopes and that the local churches purchase the number they can use from the district secretary.

18. We recommend that all of our pastors shall place their membership in the church which they are serving as pastor.

19. We recommend that the district secretary notify in writing all members of this assembly who have failed to meet the requirements of recommendation number "two" calling their attention to such failure and to the penalty for same at least thirty days before our next camp and assembly.

20. We recommend that, inasmuch as our young people have organized themselves into a district organization and have elected their officers, we as an assembly recognize them, accept their rules of government and place same in the minutes.

16. We recommend that Alvin Shaffer be retained as a member of the assembly.

17. We recommend that Mira Shaffer be retained as a member of the assembly.

18. We recommend that Etta Smith be retained as a member of the assembly.

19. We advance Roy Beltz to the third year of the course of study.

20. We recommend that Raymond Brothers be retained in the assembly.
