Standing Rules of the Illinois and Missouri District

In force until rescinded by any succeeding Annual Assembly:

(1) Inasmuch as those who teach others the Way of Life should be an example; the women preachers, preachers' wives, who are members of our church, and feminine members of local church boards, in this district, are required not to wear their dresses shorter than nine inches from the floor. Ample time shall be allowed those affected by this ruling to conform to the same.

(2) All local preachers shall be listed in the District Minutes, together with the date of their respective licenses.

(3) All licensed ministers not attending the District Assembly shall take the standard examination required of those attending.

(4) All local churches in the district are advised to adopt six months as the period of probation for receiving members.

(5) Any licensed minister who fails to stand examination on at least one book in the Course of Study during any one year, unless excused on account of sickness or other justifiable reason, shall be demoted to the standing in the course of study next preceding their present standing.

(6) All annual reports shall be mailed to the District Statistician immediately following the close of the assembly year.

At her own request it was moved and seconded that the name Sister Alice Beard be dropped from Assembly Roll. Carried.

Memorial Committee gave a report. Memorials from No. 1 to No. 20 were read and accepted. No. 21 was left in the hands of the committee.

Moved and seconded that time be extended to act upon the memorials. Carried.

Moved and seconded that Bro. and Sister Higgs be granted an open transfer upon their request. Carried.

Adjourned with prayer.

August 29.

August 29, 1933, Night Sitting.

Opened by singing "Heavenly Sunlight" and then Bro. C. C. Breen led in prayer. Sister Surbrook then favored us with a special song, "I Have Been Born Again." Minutes were read and approved. The Ways and Means Committee brought in more recommendations. No.'s 10 and 11 were adopted. The combined reports of the Educational and Examining Boards were read and accepted. (See report). Committee on Memorials gave in three more recommendations which were adopted (Nos. 21, 22 and 23).

The ordination service was now in order. Members of Assembly stood and sang one verse of "A Charge to Keep I Have," after which the District Superintendent read a Scripture lesson from Titus. Bro. W. G. Henschen and Bro. Geo. Smith then read from the Word. General Superintendent Surbrook gave the Charge and Bro. Herbert was duly ordained.

Moved and seconded that Educational and Examining Boards be excused while we have a ten minute recess. Carried. This time was used in pushing the Advocate or planning to get new subscribers and renewals this year.

The Board returned and recommended that Bro. Thomas L. Brenton be re-instated in the second year licensed preacher course in this district, and that he be transferred to the Indiana District.

Memorials No. 24 and 25 were read and adopted. Supplementary report of Educational Board was read and accepted. Moved and seconded that Assembly pay 50c for each examination given to those in the courses of study this past year, and that each candidate pay that amount for each one taken in the future. (Payment to go to the number of Educational Board giving examination). Carried.

Statistical report was read by Sister Hanna. It was accepted. Memorial No. 26 was read and adopted. Resolutions No. 12, 13 and 14 read and adopted. Moved and seconded that District Council appoint Statistician. Carried.

Moved and seconded that Assembly send message of comfort to Sister Rees. Carried.

Moved and seconded that same committee serve on Memorials throughout this year. Carried.

Moved and seconded that stationing of pastors be left to the District Council. Carried.

Minutes were read and approved. Moved and seconded that we adjourn. Assembly closed by singing "Jesus Keep Me Near the Cross."
Closing prayer by Bro. Surbrook.

WAYS AND MEANS

Illinois and Missouri District as revised by the Annual Assembly of 1933.

I.

Since the General Assembly has adopted the Budget System of administering the finances of the General Church, we strongly urge all local Church Boards of this District to adopt the Budget System for administering the finances of their respective local churches. Also that each pastor get his church to tithe their income into the local church treasury, that each pastor be paid a stipulated amount sufficient for his support, and that at the respective annual church meetings each church shall decide what financial support they will pay their pastor during the coming year.

II.

The District Budget shall be raised and disbursed in the following manner:

A. An amount equal to ten per cent (10%) of all funds received by each local church, including that received by the pastor for his services as such, and that raised for evangelists, and exclusive of all funds paid to the purchase, rental or necessary upkeep, of all real estate or buildings for church or parsonage uses, shall be set aside by the local church treasurer each Monday and remitted by him to the District Treasurer on the first of each month. ("Necessary upkeep" would not include money spent for furniture, furnishings, electric light bills, etc. It would include only money spent for anything actually necessary to the maintenance or preservation of the property such as paint, roofing, together with the cost of applying the same, special taxes, insurance premiums, payments on church debt, etc).

B. Each ministerial and lay member of this district shall pay ten cents each month to their local treasurer, same to be forwarded on the first day of the succeeding month to the district treasurer for the district budget. (This assessment and all Foreign Missionary Funds are not subject to the ten per cent tax since they are not raised as local funds.

C. All funds received by the district treasurer, in fulfillment of requirements of paragraphs A and B of this ruling, shall be divided by him as follows:

District Superintendents Fund.....	50%
Miscellaneous District Expense Fund	25%
General Church Budget.....	25%

D. A freewill offering shall be taken by the pastors for the District Superintendent at the time of each year of his regular or called visits to the respective churches, same to be applied by the superintendent on his salary and expenses and the district given due credit for the same.

III.

Since the District Superintendent is to the district what the pastor is to the church, the District Superintendent shall meet with each local church board according to manual (Sec. 58) and inquire carefully into the spiritual and financial condition of the church, and help them to a solution of their various problems.

IV.

The District Superintendent shall present the need of the canned fruits, vegetables, meats, etc., for the district camp meeting, to each local church at least once during the year.

V.

The District Council shall arrange for Zone meetings of pastors, other ministers and officers, members of local churches, for the purpose of helping the churches put on the Budget System. The District Superintendent shall arrange the churches in zones as he deems best.

VI.

The District Superintendent shall be paid \$15.00 per week, plus traveling and mailing expenses, for all services rendered to the district. All revivals held within the district shall be considered as services to the district and all evangelistic offerings so received shall be applied on his salary. The District Council shall determine what constitutes service to the district.

VII.

Each local church shall pay into the camp meeting treasury the sum of \$5.00 for each delegate elected to the annual Assembly, said payment to provide for the entertainment of said delegate throughout the Camp and Assembly.

VIII.

All of our preachers and lay members shall secure, respectively, a copy of our church manual and the minutes of this assembly and shall read and study the same, until they are able to understand and carry out all of their provisions and requirements.

IX.

Each church shall be responsible to furnish one comforter for Camp Meeting purposes and the name of the donor shall be inscribed.

X.

The deacons and deaconesses of each local church shall constitute a committee to secure regular monthly donations of foodstuffs, etc., for the pastor's family, said donations to be brought to the parsonage by the donors on a given date and time.

XI.

The District Superintendent shall visit each church as soon after the Assembly as possible, completing the first circuit by November 30th. He shall conduct the second circuit during the fourth quarter (May, June and July), leaving no Annual Meeting uncondacted after July 31st, 1934.

XII.

Each pastor shall keep a record of all subscribers to the Advocate in each neighborhood or city, where he pastors, and shall, about thirty days before each subscription expires, begin to endeavor to secure a renewal of same.

(B). Each pastor shall endeavor to secure a sufficient number of subscriptions to the Advocate, in the communities where his preaching appointments are located,, to cause the total number of subscribers in each community to be equal to the number of members in the respective churches.

XIII.

Each local church board shall meet prior to each quarterly meeting, for the purpose of auditing the records of the church treasurer and records of the treasurers of all departments of the church.

XIV.

The revision of church membership rolls shall be made prior to the respective annual church meetings.

XV.

Each pastor shall push the interests of the Charleston Camp Meeting Association in his own church. He shall ask each member of his church, and all friends of the said church, to become a contributing member by signing one of the membership cards. The pastor shall request the desired or needed number of such cards from the Camp Meeting secretary who will mail the same to him.

XVI.

The District Council shall select a church extension evangelist who shall give his time to holding revivals in promising places with the object of establishing new church organizations. He shall remain on a given field as long as deemed advisable, or until a suitable pastor can be obtained. All of his work shall be under the direction of and in conjunction with the District Council and District Superintendent. He shall be furnished with a tent and seats by the district and shall be privileged to create and dispense his own fund, making a report of same to District Superintendent quarterly, to the District Council when requested, and to the Annual Assembly. Each church shall take at least one offering per month for church extension work in the district, same to be forwarded to the district treasurer by the local treasurer. The church extension evangelist shall create an interest among the pastors and churches of the district in the work he is doing by making a written report thereof occasionally to the pastor who shall read the same to the churches thereby increasing their interest and securing their co-operation. The church extension evangelist shall be selected for one year and may be dismissed by two-thirds vote of the District Council.

XVII.

Each Sunday school treasurer shall take ten cents from the Sunday school offerings each Sunday and turn it to the church treasurer who shall forward same to the District Treasurer for the Church Extension Fund.

XVIII.

Our people shall not send money direct to any of our General Church Interests, but they shall remit to their own local church treasurer who shall forward all of same to the district treasurer, who shall make disbursement to the proper general interests.

XIX.

The local churches of the district shall accept and work the plan as suggested by the General Board, for increasing interest in Foreign Missions and for raising Foreign Missionary Funds.

XX.

The regular Sunday school offering on one Sunday per month shall be a special offering for Foreign Missions, and shall be forwarded to the district treasurer for this purpose. The particular Sunday on which this offering shall be taken shall be determined by the Sunday School Board.

XXI.

The district secretary shall be paid ten dollars for editing the minutes and the district treasurer shall be paid ten dollars per year for his services.

XXII.

The district secretary and the district treasurer shall have three hundred copies of the Minutes published and the district secretary shall send them to the pastors to be distributed among the members at ten cents per copy, said money to be sent by the local treasurer to the district treasurer.

XXIII.

Each church shall send one dollar within sixty days to the district treasurer to be used for the printing of the minutes.

XXIV.

The district superintendent is an advisory member of all district boards and committees.

XXV.

The Assembly year shall end with July 31st each year and all business transacted between that and the Annual Assembly, shall be included in the following year's reports. Also the Assembly year shall be divided into four quarters ending with the following dates respectively: First quarter August 1st to October 31st, 1933; Second quarter November 1st, 1933, to January 31st 1934; Third quarter February 1st, 1934, to April 30th, 1934; Fourth quarter May 1st, 1934, to July 31st, 1934. A quarterly meeting shall be held in each church within ten days following the close of each quarter, at which time reports covering the quarter shall be read. Said reports shall be copied in the church secretary's book and the original reports sent to the district superintendent. Quarterly meetings shall be conducted by the pastors when the district superintendent does not happen to be present. All annual reports shall be copied in the church secretary's book and mailed to the district statistician immediately following the close of the Assembly year. (July 31).

XXVI.

The district secretary and district treasurer shall keep in touch with the pastors, reminding them of the plans of this Assembly and encourage and help them carry out said plans.

XXVII.

This Assembly requires its ministerial members to attend Assembly and Camp Meeting (they shall be present on the first day and remain until the close). Each church shall keep up the salary of its pastor during Camp Meeting. If any minister does not attend he shall send a report of his work and an excuse for his absence. If he fails to do so for two consecutive years, his name shall be dropped from the Assembly roll.

XVIII.

The district secretary shall notify in writing all members of this Assembly who have failed to meet requirements of the foregoing rule (No. 27), calling their attention to such failure and the penalty for the same, at least thirty days before our next Assembly.
