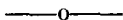

A plan to finance the General and District work, proposed by the District Council and in accordance with the manual, was adopted by a large majority. The plan is as follows: \$5.00 per year per member. \$3.00 for Foreign Missions, \$.50 for Home Missions, \$1.00 for General Budget, \$.50 District Claims.

\$3.00 to be forwarded to Treasurer of Foreign Missions and \$2.00 to be forwarded to District Treasurer.

Monthly offerings should be arranged to meet these requirements.

O. W. Lawrence declared elected.

First ballot for three advisory members of District Council: 65 votes cast. H. J. Olsen 44, M. R. Blann 6, D. E. Wilson 6, G. L. Helsby 4, Ann Wilson 1, Clifton Berg 1, W. E. Reed 1, H. L. Twining 1,

Fifth ballot for member of advisory board: 64 votes cast. G. L. Helsby 43, H. L. Twining 5, D. E. Wilson 10, C. F. Berg 3, Lorrin Wilson 1, Ervin Phillips 2. G. L. Helsby declared elected.

At the opening of the morning session, General Supt. Surbrook delivered a splendid address on the subject, "Essentials to Ministerial Success."

Alvin Young and H. L. Twining declared elected.

First ballot for Board of Education: 56 votes cast. D. E. Wilson 41, Clifton Berg 2, Ervin Phillips 1, G. L. Helsby 7, O. W. Lawrence 1, M. R. Blann 1, M. E. Pierpoint 1, Jasper Hamm 1, A. Young 1.

D. E. Wilson declared elected.

The following persons were nominated by the District Supt. as Members of Foreign Missionary Board: A. E. Blann, H. J. Olsen, Augusta Engwer and Blanch Avery. These nominations were ratified by vote of assembly.

Adjourned to 9 A. M.

SATURDAY, APRIL 20, 9 A. M.

Minutes of last session read and approved.

Report of Committee on Memorials read and accepted.

Report of the Statistical Committee read and accepted.

Voted that 700 copies of the Minutes be printed.

It was voted to accept the invitation of the Binghamton Church for the 1936 assembly.

Mrs. Seth C. Rees delivered a splendid message, laying special stress upon prayer as the foundation of our future success in every field.

Let us go forth from this season of refreshing imbued with the Joshua spirit regardless of every obstacle that may confront us.

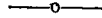

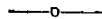

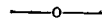

RESOLUTIONS ADOPTED

Resolution No. 1—In order to safeguard one another as churches, and recognize the ecclesiastical governing body be it therefore resolved that no property such as churches, parsonages, or any other buildings or land, shall be sold of any of our incorporate churches without first conferring with the trustees of the district corporation.

Resolution No. 2—Resolved that section 16 of article 2 of the religious corporation law be enforced in our district in regard to churches who have discontinued holding services and where there are less than 7 resident attending members.

That such temporalities and property be managed by the District Council of the Pilgrim Holiness Church, Inc., our ecclesiastical governing body, or may, in pursuance of the provision of law relating to the disposition of real property by religious corporations, sell or dispose of the same, and apply the proceeds thereof to any of the purposes to which the property of such governing religious body is devoted, and shall not divert such property to any other object.

In no case shall property be sold or disposed of to support the preacher who may claim this as an out appointment.

Due notice shall be given by the District Secretary regarding the action of the District Assembly in declaring a church extinct, within thirty days, to the remaining members, if any.

Resolution No. 3—Resolved, that when money is sent direct to any fund the church treasurer shall obtain a receipt for same and forward this to the district representative.

Resolution No. 4—Be it resolved, that all departments of our church shall upon receipt of moneys immediately forward receipt for same to sender.

Resolution No. 5—No preacher, or evangelist coming from another district or denomination shall hold any official position in our conference until one year shall have been spent as supplying a church or sufficient revival work in the district to prove the ability and sincerity of the candidate except they come with an unquestioned recommendation from their former denomination or district.

Resolution No. 6—Inasmuch as it has been a practice in other years for some delegates and ministers to leave the assembly, one or two days before its close, be it resolved that all delegates and ministers shall attend each session of the entire assembly unless excused by the presiding officer.

Resolution No. 7—Resolved: That the District Foreign Missionary Board shall consist of five members including the District Superintendent who shall nominate said board subject to the approval of the assembly.

Resolution No. 8—Resolved: That inasmuch as there seems to be a lack of interest in our district concerning our Sunday School work, we recommend that all our pastors put forth a desperate effort to greater activity and make it a point to be present at every session if at all possible.

Resolution No. 9—Resolved: That inasmuch as the resolutions contain matters of vital importance to our lay members and inasmuch as not every one reads the resolutions, we recommend that our pastors read the resolutions before the church as soon as possible after the distribution of the minutes.

Resolution No. 10—Resolved: That we, the New York District of the Pilgrim Holiness Church in convention assembled at Binghamton, New York, April 16-21, 1935, place ourselves on record as being unalterably opposed to, and deplore the present sale and use of intoxicating beverages throughout the nation, and furthermore we advise and strongly urge our people not to encourage such sale or use of said liquors by patronizing such places where these intoxicating liquors are sold.

Resolution No. 11—Resolved: That an offering be taken by each church to help defray the expenses of the District Assembly, the same to be brought to assembly by the delegate.

Resolution No. 12—Resolved: That each church sending a delegate or delegates to the District Assembly, pay the traveling expenses of said delegates and pastor. The same is to apply to this Assembly and hereafter.

Resolution No. 13—Inasmuch as some of our churches object to their pastor doing evangelistic work, Be it resolved: That each pastor be given freedom to hold at least two revival services each conference year.

Resolution No. 14—Resolved: That all our local churches in the District open their doors to the Allentown Bible Institute and the Beulah Rescue Home, Terre Haute, Ind., at least once a year and that said institutions be allowed to take an offering for their maintenance.

Resolution No. 15—Resolved: That the District Superintendent receive for his services an amount equal to four percent of the pastors salary for the previous year. The same to be raised before or at the time of his visit.
