Rev. H. J. Felter, Secretary of the Penna-New Jersey District, was introduced and voted seat in the Assembly bar.

Several resolutions were presented by the Resolution Committee.

A resolution was presented to change Resolution No. 14 of 1938 Minutes and was defeated by vote of Assembly.

Evangelists Nellie and Louetta Holden were introduced and voted seat in Assembly bar. They also favored the Assembly with a fine song.

The Trustee's report was read and accepted.

Rev. D. M. Cantrell, pastor of the Nazarene Church of Binghamton, Rev. F. E. Pond, pastor of the Free Methodist Church of Binghamton, Rev. and Mrs. Cassius Meyers of Ulster, Penna., were introduced and voted seat in Assembly bar.

The Assembly proceeded to elect officers for the coming year.

District Superintendent A. H. Wilson expressed his desire to withdraw from the field and that the Assembly elect another District Superintendent.

Rickenback, 16; Lorrin Wilson, 22; H. L. Twining, 34; Lee Lawrence, 4; W. A. Shoemaker, 4; Floyd Baker, 22; W. E. Reed, 7; Mary Olsen, 1; Garry Boel, 1; Jasper Hamm, 17; George Culver, 11; David E. Wilson, 5; Orrin Fay, Jr., 1.

D. E. Snow declared elected.

Second ballot for Ministerial Delegates, voting for three out of seven highest; 77 votes cast—Lorrin Wilson, 25; H. L. Twining, 43; G. L. Helsby, 55; Floyd Baker, 27; Clifton F. Berg, 26; M. R. Blann, 19; M. E. Pierpoint, 35.

H. L. Twining and G. L. Helsby declared elected.

Third ballot for Ministerial Delegate, voting for 4 highest; 79 votes cast—M. E. Pierpoint, 38; Floyd Baker, 8; C. F. Berg, 17; Lorrin Wilson, 16. No election.

Fourth ballot for Ministerial Delegate, voting for three highest. The one receiving largest number of votes shall be declared elected. The remaining two shall be declared elected alternate delegates. 80 votes cast—M. E. Pierpoint, 52; Lorrin F. Wilson, 14; C. F. Berg, 14.

Rev. M. E. Pierpoint declared elected. Rev. Lorrin F. Wilson and Rev. C. F. Berg were declared elected alternate delegates to General Assembly.

First ballot for lay delegates to General Assembly, voting for 3: 78 votes cast—Charles Merrill, 42; Echter Fountain, 23; Lawrence Wilson, 34; Channing Posson, 38; Theodore Knapp, 31; Ralph Murphy, 31; Albert Green, 34.

Charles Merrill declared elected.

Second ballot for lay delegates, voting for 5. Two receiving highest number of votes shall be declared elected lay delegates. Two receiving next highest vote shall be declared elected alternate delegates. Voted to extend time to 4:30. Votes cast—Lawrence Wilson, 36; Channing Posson, 45; Theo Knapp, 30; Ralph Murphy, 22; Albert Green, 25.

Lawrence Wilson and Channing Posson were declared elected lay delegates and Theodore Knapp and Albert Green were declared alternate lay delegates.

Adjourned to 10 A. M.

The reports of Rev. Alice M. Coone and Beatrice Dodge of Bridgetown, Barbadoes, were read and accepted.

The District Treasurer read the Church Extension financial report, also the financial report of the Binghamton Camp Meeting.

Both reports were accepted on vote of Assembly.

Moved and seconded that the name of the West Endicott Church be changed to Campville Road. Motion carried.

A resolution was presented that Resolution No. 9 in 1937 minutes be dropped. An amendment was offered that the date in 1937 minutes be deleted and the resolution appear in the 1938 minutes with this change.

Moved and seconded that one-half of the tithes of all pastors and evangelists be paid monthly to the District Treasurer for the support of the District Superintendent.

Rev. A. H. Wilson was elected Assistant District Superintendent by acclamation.

Rev. A. E. Blann was elected as Advisory Member of the District Council on vote of Assembly.

Moved and seconded that we extend a vote of thanks to Mr. William Chase of Binghamton for his kindness in helping us in securing a tent for Gospel meetings.

On recommendation of the District Council, Ethel Mac Fadgen was received as member of this Assembly as licensed minister. Motion carried.

Moved and carried that all memorials and resolutions be referred to the District Council. Motion carried.

Moved and seconded that we have a Ministerial Convention. The time and place and subjects to be arranged by the District Council. Motion carried.

Moved and seconded that we extend a vote of thanks to our General Superintendent for presiding so efficiently as chairman of the Assembly and for his spiritual ministry of the Word. Motion carried.

Olsen, and Sister Olsen, took their places on the platform while the entire Assembly wished Brother and Sister Wilson Godspeed and at the same time wishing Brother and Sister Olsen success in the new field. May the Lord richly bless our outgoing District Superintendent and his wife and give them many years of service for the Lord!

## Reports

### DISTRICT SUPERINTENDENT

To The New York District of The Pilgrim Holiness Church, convened at Binghamton, N. Y. Greetings in Jesus' precious Name:

I herewith submit my report as District Superintendent, for the year ending April 21, 1938.

Another year has passed and we are met in our regular annual assembly. I feel that we should give God the glory, for His many mercies shown us in the year that has passed. God has been pleased to pour out His spirit upon us, as a District, in a very marked way, and several of our churches report good revivals with a substantial gain in membership, while some of the churches have had a struggle, due to circumstances over which they had no control, and will report a loss in membership. Changes have been made, however, which will prove a blessing to the church and District.

Nearly all of the churches have been visited twice during the year and we find our ministers earnestly contending for the faith and willing to sacrifice for the cause of Christ, which they love.

The reports will show that nearly all of the churches have met their district and general budget obligations, and the District Treasurer's report shows our obligations to the general church overpaid in both home and foreign interests, for which we are thankful.

## RESOLUTIONS ADOPTED

**Resolution No. 1**—In order to safeguard one another as churches, and recognize the ecclesiastical governing body be it therefore resolved that no property such as churches, parsonages, or any other building or land, shall be sold of any of our incorporate churches without first conferring with the trustees of the district corporation.

**Resolution No. 2**—Resolved that section 16 of article 2 of the religious corporation law be enforced in our district in regard to churches who have discontinued holding services and where there are less than 7 resident attending members.

That such temporalities and property be managed by the District Council of the Pilgrim Holiness Church, Inc., our ecclesiastical governing body, or may, in pursuance of the provision of law relating to the disposition of real property by religious corporations, sell or dispose of the same, and apply the proceeds thereof to any of the purposes to which the property of such governing religious body is devoted, and shall not divert such property to any other object.

In no case shall property be sold or disposed of to support the preacher who may claim this as an out appointment.

Due notice shall be given by the District Secretary regarding the action of the District Assembly in declaring a church extinct, within thirty days, to the remaining members, if any.

**Resolution No. 3**—Resolved, that when money is sent direct to any fund the church treasurer shall obtain a receipt for same and forward this to the district representative.

**Resolution No. 4**—Be it resolved, that all departments of our church shall upon receipt of moneys immediately forward receipt for same to sender.

**Resolution No. 5**—Resolved, that the plan of preachers and workers to finance the church extension work be as follows: Those receiving from \$300-\$400 per year to pay \$.50 per month; from \$400-\$700 to pay \$1 per month; from \$700-\$1000 to pay \$1.50 per month; from \$1000 up to pay \$2 per month and that the same be reported to the local church Treasurer, but sent to District Treasurer by the preacher or worker.

**Resolution No. 6**—Inasmuch as it has been a practice in other years for some delegates and ministers to leave the assembly, one or two days before its close, be it resolved that all delegates and ministers shall attend each session of the entire assembly unless excused by the presiding officer.

**Resolution No. 7**—Resolved, that inasmuch as there seems to be a lack of interest in our district concerning our Sunday School work, we recommend that all our pastors put forth a desperate effort to greater activity and make it a point to be present at every session if at all possible.

**Resolution No. 8**—Resolved, that inasmuch as the resolutions contain matters of vital importance to our lay members and inasmuch as not every one reads the resolutions, we recommend that our pastors read the resolutions before the church as soon as possible after the distribution of the minutes.

**Resolution No. 9**—Resolved, that we, the New York District of the Pilgrim Holiness Church, place ourselves on record as being unalterably opposed to, and deplore the present sale and use of intoxicating beverages throughout the nation, and furthermore we advise and strongly urge our people not to encourage such sale or use of said liquors by patronizing such places where these intoxicating liquors are sold.

**Resolution No. 10**—Resolved, that an offering be taken by each church to help defray the expenses of the District Assembly, the same to be brought to assembly by the delegate.

**Resolution No. 11**—Resolved, that each church sending a delegate or delegates to the District Assembly, pay the traveling expenses of said delegates and pastor. The same is to apply to this Assembly and hereafter.

**Resolution No. 12**—Resolved, that each pastor be given freedom to hold at least two revivals each conference year.

**Resolution No. 13**—Resolved, that all our local churches in the District, open their doors to the Allentown Bible Institute and the Beulah Rescue Home, Terre Haute, Ind., at least once a year and that said institutions be allowed to take an offering for their maintenance.

**Resolution No. 14**—Be it resolved that we request the Allentown Bible Institute, our official zone school, to prepare courses of study equivalent to the courses required in our Manual leading to the granting of license to preach and to ordination, which may be offered as correspondence courses; and be it further resolved that all our workers desiring license to preach or ordination, be required to take such courses, and that the Board of Education be governed in its recommendations for license to preach and for ordination by a report from the Bible Institute upon the work done by the applicant; provided, however, that due credit may be given by the board, at its discretion, to said applicants for any equivalent work done in any other school acceptable to the Board of Education.

**Resolution No. 15**—Be it resolved that each pastor attend the Binghamton, New York, District Camp, and be required to remain over one Sunday. Due exception shall be made to this rule. All the pastors residing in the extreme northern part of the District, namely, Massena, Brushton, Ogdensburg, Russell, Madrid, Bloomingdale and Lake Placid, are urged to attend and push the Camp at Vermontville which is now the property of the District.

**Resolution No. 16**—Be it resolved, that the New York District go on record as being opposed to the World's Fair ad on our license plates and desire that the proper authorities be notified of our conscientious objections.

**Resolution No. 17**—Be it resolved, that the Board of Examiners be discontinued and the work hitherto handled by the Board be taken care of by the District Council.

**Resolution No. 18**—Resolved, that the New York District of the Pilgrim Holiness Church is opposed to divorce and remarriage, and that all persons who are divorced and remarried, except to be remarried to the one from whom they have been divorced, be denied membership in said church.

**Resolution No. 19**—Resolved, that the plan of \$5 per member be carried out through the District for financing the General and District work. \$3 for foreign missions; \$.50 for home missions; \$1 for General budget; \$.50 for district claims. \$3 to be forwarded to Treasurer of foreign missions and \$2 to be forwarded to District Treasurer.

Monthly offerings should be arranged to meet these requirements.

**Resolution No. 20**—Resolved, that our pastors and evangelist pay 50% of their tithes to the support of the District Superintendent and each church send an amount equal to 4% of the pastor's salary, these amounts to be sent the first of each month to the District Treasurer.

**Resolution No. 21**—Resolved, that the District Council meet on Wednesday of Assembly week to get business in hand for Assembly to convene on Thursday of Assembly week. The date of 1939 Assembly shall be April 20-23.

**Resolution No. 22**—Be it resolved that the support of the District Superintendent be as follows:

He shall be paid on the basis of \$40.00 per week. All moneys coming from the workers' tithes and church assessments shall be sent to the District Treasurer the first of each month so that the weekly support may be forwarded by the District Treasurer promptly. All moneys received by the District Superintendent excepting only the amount received from his editorial work, shall be applied on his salary.

Any excess accumulation in the fund paid in shall be held in reserve toward the purchase of a parsonage for District Superintendent. An offering shall be taken at each visit of the District Superintendent.

### MEMORIAL FOR GENERAL ASSEMBLY

Page 39, Section 52, Paragraph 3, of the Manual. The minister's term of office as pastor of a church shall continue until the following District Assembly.

He may be recalled from year to year. In the recalling of a pastor, it shall require a two-thirds vote of all members present and voting at annual business meeting provided he is nominated by a simple majority vote of Local Church Board.
