The report of the Assistant District Superintendent was accepted.

Several resolutions were read by the Resolution Committee.

A memorial presented by the Memorial Committee on the death of Rev. George J. Becker was read. The memorial was received by the Assembly standing and Bro. Flexon offering prayer.

Invitations were received for 1940 Assembly from Oakdale, Binghamton, Athens, Syracuse.

Oakdale was chosen by vote of Assembly as the place of meeting for 1940 Assembly.

This action was rescinded and motion carried to vote by ballot that the Assembly proceeded to vote by ballot.

The vote follows: 80 votes cast—Oakdale, 52; Binghamton, 9; Syracuse, 17; Athens, 2.

Oakdale was chosen as place of meeting for 1940 Assembly.

Voted that 600 copies of the Minutes be printed.

On vote of Assembly, Floyd Lepper was received as member of Assembly.

The following resolution from the Board of Directors of the Allentown Bible Institute, approved by the District Council, was presented to the Assembly:

Sayre, Pa.

April 21, 1939

A Resolution from the Board of Directors of the Allentown Bible Institute to the Districts comprising the Eastern school zones of the Pilgrim Holiness Church

INASMUCH as the present buildings and equipment of the Allentown Bible Institute have long been recognized as inadequate and inferior to meet the demands of the young people who seek the training required by our Church prior to entering the ministry either at home or abroad, and

INASMUCH as the burden of responsibility for the proper instruction of the hearts and minds of such as are called into the ministry in our Church falls upon us, and

INASMUCH as it is the firm conviction of the BOARD OF DIRECTORS of the school that new buildings and equipment are sorely needed to assure the continued usefulness of the Institute in this field of our Church work,

BE IT RESOLVED that we, the BOARD OF DIRECTORS, submit the following proposals to the various district groups in our school zone:

1. That a new building be erected on our own property at Allentown, Pennsylvania.
2. That the new building include chapel, kitchen, dining room, library, teachers' apartments and laundry.
3. That the present dormitory and administration building be remodeled to provide classrooms on the first floor and dormitory rooms on the second and third floors. (It is estimated that ninety students can be cared for comfortably after alterations are made.)
4. That the maximum actual estimated cost with the present capital debt included will be approximately seventy-five thousand dollars.
5. That this sum be financed for a period of from ten to twenty years.
6. That each District give a definite expression of attitude by ballot with respect to each of the above proposals and that the Board of Directors be assured that the next District Assembly, in each District, will take action by ballot on ways and means to raise a proportionate sum monthly or yearly (not less than 10 cents per member per month) throughout the period of financing mentioned above to assure the execution of said building program.

After much discussion, the proposition of the Board of Directors of the Allentown Bible Institute regarding a building program was accepted by vote of the Assembly.

The vote was as follows: 84 votes cast—Yes, 74; No, 10.

No further business, Assembly adjourned in due form.

## Reports

### DISTRICT SUPERINTENDENT

In the good providence of God I have been able to spend the entire year in the work of the District except the time taken for our General Assembly, one Young People's Convention at Frankfort, Indiana, a revival in Michigan, and two General Board Meetings.

Have helped in the three Camps of our District besides conducting four revivals and preaching 238 sermons, written fifty editorials and fifty-two Sunday School lessons.

Four new churches should be built this year. At Messina about 100 gather in a small hall; at N. Troy they have no room to accommodate the crowds; Monticello has reached its limits and must have more room; at Cambridge there is also need for a church building. The new church at Oakdale, the new parsonage at Syracuse and the enlarged church at Utica are demonstrations of what faith can do when coupled with work.

Our three camp meetings are proving social saving centers, and our entire state stands like a whitened harvest field while God is calling for reapers. There remaineth much land ahead to be possessed.

### RESOLUTIONS ADOPTED

**Resolution No. 1**—In order to safeguard one another as churches, and recognize the ecclesiastical governing body, be it therefore resolved that no property such as churches, parsonages, or any other building or land, shall be sold of any of our incorporate churches without first conferring with the trustees of the district corporation.

**Resolution No. 2**—Resolved that section 16 of article 2 of the religious corporation law be enforced in our district in regard to churches who have discontinued holding services and where there are less than 7 resident attending members.

That such temporalities and property be managed by the District Council of the Pilgrim Holiness Church, Inc., our ecclesiastical governing body, or may, in pursuance of the provision of law relating to the disposition of real property by religious corporations, sell or dispose of the same, and apply the proceeds thereof to any of the purposes to which the property of such governing religious body is devoted, and shall not divert such property to any other object.

In no case shall property be sold or disposed of to support the preacher who may claim this as an out appointment.

Due notice shall be given by the District Secretary regarding the action of the District Assembly in declaring a church extinct, within thirty days, to the remaining members, if any.

**Resolution No. 3**—Resolved, that when money is sent direct to any fund, the church treasurer shall obtain a receipt for same and forward this to the district representative.

**Resolution No. 4**—Be it resolved, that all departments of our church shall upon receipt of moneys immediately forward receipt for same to sender.

**Resolution No. 5**—Resolved, that the plan of preachers and workers to finance the church extension work, be, they shall pay 2% of their salary, the same to be reported to the local treasurer, but sent by the preacher or worker to the district treasurer.

**Resolution No. 6**—Inasmuch as it has been a practice in other years for some delegates and ministers to leave the Assembly, one or two days before its close, be it resolved that all delegates and ministers shall attend each session of the entire assembly unless excused by the presiding officer.

**Resolution No. 7**—Resolved, that inasmuch as there seems to be a lack of interest in our district concerning our Sunday School work, we recommend that all our pastors put forth a desperate effort to greater activity and make it a point to be present at every session if at all possible.

**Resolution No. 8**—Resolved, that inasmuch as the resolutions contain matters of vital importance to our lay members and inasmuch as not every one reads the resolutions, we recommend that our pastors read the resolutions before the church as soon as possible after the distribution of the minutes.

**Resolution No. 9**—Resolved, that we, the New York District of the Pilgrim Holiness Church, place ourselves on record as being unalterably opposed to, and deplore the present sale and use of intoxicating beverages throughout the nation, and furthermore we advise and strongly urge our people not to encourage such sale or use of said liquors by patronizing such places where these intoxicating liquors are sold.

**Resolution No. 10**—Resolved, that an offering be taken by each church to help defray the expenses of the District Assembly, the same to be brought to assembly by the delegate.

**Resolution No. 11**—Resolved, that each church sending a delegate or delegates to the District Assembly, pay the traveling expenses of said delegates and pastor. The same is to apply to this Assembly and hereafter.

**Resolution No. 12**—Resolved, that each pastor be given freedom to hold at least two revivals each conference year.

**Resolution No. 13**—Resolved, that all our local churches in the District, open their doors to the Allentown Bible Institute and the Beulah Rescue Home, Terre Haute, Ind., at least once a year and that said institutions be allowed to take an offering for their maintenance.

**Resolution No. 14**—Be it resolved that we request the Allentown Bible Institute, our official zone school, to prepare courses of study equivalent to the courses required in our Manual leading to the granting of licenses to preach and to ordination, which may be offered as correspondence courses; and be it further resolved that all our workers desiring license to preach or ordination, be required to take such courses, and that the Board of Education be governed in its recommendations for license to preach and for ordination by a report from the Bible Institute upon the work done by the applicant; provided, however, that due credit may be given by the board, at its discretion, to said applicants for any equivalent work done in any other school acceptable to the Board of Education.

**Resolution No. 15**—Be it resolved, that each pastor attend the Binghamton, New York, District Camp, and be required to remain over one Sunday. Due exception shall be made to this rule. All the pastors residing in the extreme northern part of the District, namely, Massena, Brushton, Ogdensburg, Russell, Madrid, Bloomingdale and Lake Placid, are urged to attend and push the Camp at Vermontville which is now the property of the District.

**Resolution No. 16**—Be it resolved, that the New York District go on record as being opposed to the World's Fair ad on our license plates and desire that the proper authorities be notified of our conscientious objections.

**Resolution No. 17**—Be it resolved, that the Board of Examiners be discontinued and the work hitherto handled by the Board be taken care of by the District Council.

**Resolution No. 18**—Resolved, that the New York District of the Pilgrim Holiness Church is opposed to divorce and remarriage, and that all persons who are divorced and remarried, except to be remarried to the one from whom they have been divorced, be denied membership in said church.

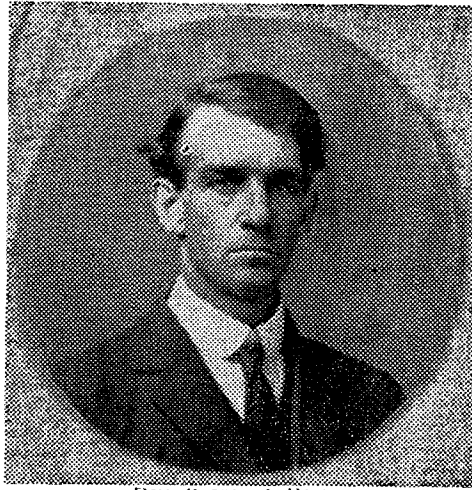
**Resolution No. 19**—Resolved, that the plan of \$5 per member be carried out through the District for financing the General and District work. \$3 for foreign missions; \$.50 for home missions; \$1 for General Budget; \$.50 for district claims. \$3 to be forwarded to Treasurer of foreign missions and \$2 to be forwarded to District Treasurer.

Monthly offerings should be arranged to meet these requirements.

**Resolution No. 20**—Resolved, that our pastors and evangelists pay 50% of their tithes to the support of the District Superintendent and each church send an amount equal to 4% of the pastor's salary, these amounts to be sent the first of each month to the District Treasurer, also all moneys received by the District Superintendent in evangelistic meetings shall be sent to District Treasurer and applied to this fund.

**Resolution No. 21**—Be it resolved, that the support of the District Superintendent be as follows: He shall be paid \$40 per week. Any excess accumulation in the fund paid in shall be held in reserve toward the purchase of a parsonage for the District Superintendent.

**Resolution No. 22**—Resolved, that the District Council meet on Wednesday of Assembly week to get business in hand for Assembly to convene on Thursday of Assembly week. The date of 1940 Assembly shall be April 21-24.

On the nineteenth of September, 1938, our dear Brother Rev. George J. Becker was called from a bed of suffering here to a crown of rejoicing in a land that knows no sorrow, no pain, no night. His last days were fraught with sadness for those who watched the ebbing of the tide of life but made to rejoice over the evidence of victory in those trying hours. Nearly twenty-five years before he had heard the Master's call, and with a glad response had said, "Here am I", and leaving the little farm, started out to do the bidding of Him who had called him to be a soldier.

After several years of local work, he took active work about sixteen years ago serving in Allentown, Union Valley and East Athens, Pa. The last six years of his life he was pastor at Niles, N. Y. He served several years on the District Council and was ordained to the ministry at Schenectady in 1928.

One of the things for which he will long be remembered was his faithfulness in the entertainment of people at the Camp ground.

His funeral was held at the Pilgrim Holiness Church at Middleburg, N. Y., Sept. 21, 1938, where eighteen of the ministerial brethren who had labored with him in years gone by, came to pay their last respects to one of whom it could truthfully be said, he was faithful unto death. His age was sixty-one years.

A brother, true and faithful,  
Hath fallen on the field;  
He did not shrink from battle  
Nor e'er give up his shield.

So bravely let us battle on  
Tho' ranks may broken be,  
All broken ties will be forgot  
When His dear face we see.

But e'en down to the river's brink  
Where armors are laid down,  
With trophies laid at Jesus' feet,  
He there received his crown.

All battle scars are but for time:  
They'll all be washed away;  
There'll be perfection everywhere  
In that eternal day.

No goings out nor coming in,  
But shut in with the Lord;  
We'll have a grand reunion day,  
According to His word.
