

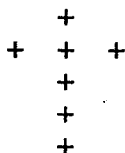

THURSDAY, APRIL 17, 2 P. M.

The congregation was led in singing, "Tell Me the Story of Jesus", by Bro. Young.

Bro. Sturk read from Rom. 14, pointing us particularly to the 19th verse, and spoke briefly and helpfully to the assembly, stressing the great need of charity among ourselves.

Motion made and seconded that we extend the afternoon session one-half hour. Motion carried.

FRIDAY, APRIL 18, 9 A. M.

The congregation was led by Bro. Young in singing, "I Shall Have Glory Divine".

Prayer was offered by Rev. Harold D. Dieter, President of "Allentown Bible Institute".

Bro. Sturk addressed the assembly, after reading from Matt. 4, on the subject, "Our Church, Its Place, Its Purpose, Its Progress."

Moved and seconded that we dispense with roll call for the remainder of the assembly. Motion carried.

Minutes of last sitting read and accepted.

Rev. Myers of Athens was introduced to the assembly.

Rev. Harold D. Dieter was introduced to the assembly, after which he gave his testimony which was enjoyed by all.

Motion made and seconded that Bro. Myers and Bro. Dieter be granted a seat within the conference bar.

Motion was made and seconded that the afternoon session be devoted to the election of officers. Carried.

The resolution dealing with home missionary work was again presented to the assembly by the secretary of the resolution committee.

Rev. Thomas, pastor of the Free Methodist Church of Endicott, was introduced to the assembly and was voted a seat within the assembly bar.

After some discussion the motion was made to refer the resolution concerning home missions to the committee for redrafting. Carried.

Two other resolutions were brought before the assembly and after some discussion one was adopted.

After the auditing committee reported finding the district treasurer's report, Foreign Missionary report, and Victory Grove Camp report, correct, they were read and accepted by vote of the assembly.

Adjourned until 2:00 P. M.

FRIDAY, APRIL 18, 2 P. M.

After the devotional exercises the minutes of the morning sitting were read and accepted.

Bro. Sturk led the assembly in special prayer, after which we proceeded to the election of officers.

Motion made and seconded that Bro. Olsen appoint the tellers. Motion carried.

The following tellers were appointed: Donald Hardy, Gary Boel, A. Alan Gilmour, George Gilmore.

First ballot for District Superintendent: 87 votes cast. H. J. Olsen received 61, the rest were scattering.

H. J. Olsen declared elected.

First ballot for Assistant District Superintendent: 88 votes cast. A. H. Wilson received 64. The rest were scattering.

A. H. Wilson declared elected.

First ballot for District Secretary: 88 votes cast. O. L. Fay received 69. The remainder were scattering.

O. L. Fay declared elected.

First ballot for District Treasurer: 87 votes cast. Bro. O. W. Lawrence received 76. The rest were scattering.

Bro. O. W. Lawrence declared elected.

We proceeded to elect three advisory members to complete the district council by voting for three at a time. Votes cast, 85; Bro. A. E. Blann, 69; Bro. Young, 67; Bro. Helsby, 47. Rest of votes were scattered. Bro. A. E. Blann, Bro. Young and Bro. G. L. Helsby declared elected.

The rules were suspended and Bro. Lawrence was declared elected trustee for 3 years by acclamation.

First ballot for member of board of education for 3 years. 86 votes cast. There was no election.

There being no election, we proceeded to vote for the two highest on a second ballot. Votes cast, 84. D. E. Wilson, 41; Floyd Baker, 43. Bro. Baker declared elected.

Motion made and seconded that we suspend the rules and Sister Blanche Avery was elected as Foreign Missionary Treasurer by acclamation.

The conference proceeded to choose a place for the 21st annual assembly. Invitations were received from Binghamton, Oakdale, and Athens. Votes cast, 86—Binghamton, 44; Oakdale, 38; and Athens, 4. Binghamton was chosen as the place for the 21st annual assembly.

Several resolutions were presented to the assembly and several were adopted.

Motion made and seconded that the time be extended to give the resolution committee time to present its work to the assembly. Carried.

After several other resolutions were presented and adopted by vote of the assembly we adjourned by expiration of time.

SATURDAY, APRIL 19, 9 A. M.

After Bro. Young led the assembly in singing a devotional number, Bro. Twining led in prayer.

Bro. Sturk read from, "The Songs of Solomon", and commented briefly. Minutes of last sitting were read and accepted.

Motion made and seconded that we send word to Bro. P. W. Thomas to secure a floral tribute for Bro. Stone, on behalf of this assembly. Motion carried.

Moved and seconded that Bro. Olsen appoint someone to send message to Bro. Thomas immediately. Motion carried.

Bro. Olsen appointed Sister Olsen to send message to Bro. Thomas.

Church extension report read and accepted.

The report of Binghamton Camp read and accepted.

District Trustees' report read and accepted.

Vermontville Camp report read and accepted.

Several resolutions were brought before the assembly and after some discussion they were adopted by the assembly.

A rising vote of appreciation was given by the assembly to the following people: Bro. Sturk, our Assistant General Superintendent; Bro. Olsen, District Superintendent; Bro. Fay, District Secretary; Bro. Lawrence, District Treasurer; Sister Avery, Treasurer of Foreign Missions; also Bro. Berg and his church for the fine way in which they entertained the assembly.

Motion made and seconded the secretary write Sister Avery, expressing appreciation of the assembly for the work she has so faithfully done for the District. Motion carried.

Adjourned until 2 P. M.

SATURDAY, 2 P. M.

After the devotional exercises and some texts of Scripture were quoted by members of the assembly the minutes of the morning session were read and accepted.

Motion made and seconded that the action of District Council be confirmed and that the following be ordained to the gospel ministry: Charles Rowe, Newland John, William Hartz, Virginia Miller, Ethel Wilson, Sadie Shafer, Helena Shafer, and Lindley Adams. Motion carried.

After several members of the council read a short Scripture lesson, Bro. Sturk, Assistant General Superintendent, addressed the candidates for ordination on the subject, "What a Pilgrim Holiness Preacher Should Be". Brother Helsby prayed and the service was concluded by the laying on of hands.

Motion made and seconded that Bro. Masterman be granted a Preacher's License. Motion carried.

There being no further business, the assembly adjourned in due form.

DISTRICT SUPERINTENDENT'S REPORT

To the Annual Assembly of the New York District of the Pilgrim Holiness Church, convening at Oakdale, N. Y., April 17-20, 1941. I herewith submit my report for the past twelve months.

Since we met a year ago, the shadows, politically, over the world have deepened. Earthly kingdoms are crumbling, kings have left their thrones, and it is with the greatest difficulty that we are able to trace the boundary lines of nations. How refreshing it is in days of trouble and war to be engaged in a conquest where "The weapons of our warfare are not carnal, but mighty through God to the pulling down of strongholds." (2 Cor. 10:4.)

Four of our young people have responded to the call of God to work in foreign lands. Meredith Helsby and wife from the Gloversville church, and Thomas Weir and wife from our work in Schenectady. The District is well represented at our Zone School at Allentown, where workers are in training for the great harvest field.

Revival fires have been all the way from the banks of the St. Lawrence River to the borders of Pennsylvania. Some of these revivals have doubled the attendance at our places of worship. The new church dedicated at North Troy is a model of plainness and beauty. At Syracuse every available inch of space in the church is in use. Our three camp meetings are witnessing the greatest spiritual power in their history, with an increased attendance each year.

Coming second only to the salvation of souls, the outstanding occasions this year were witnessed when the indebtedness on the campgrounds at Victory Grove and Port Dickinson was fully paid. Our people have experienced the blessings that attend liberality. "The liberal soul shall be made fat." Someone has written:

"That man may last, but never lives,
Whom much receives but never gives,
Whom none can love, whom none can thank,
Creation's blot, creation's blank.
But he who marks from day to day,
In generous acts his radiant way,
Treads the same path the Savior trod,
The path of glory, and to God."

My time during the past twelve months has been spent as follows: 162 days have been spent with the churches of the District, 48 days have been spent on our three Camp-Grounds, 36 days were given to work outside the District, 20 days were spent in new fields. Seventeen days and fourteen nights have been spent in traveling, and five days in our Annual Assembly.

I have preached 273 sermons, written 102 pages for the Pilgrim Holiness Advocate. My salary has been paid in full. I thank God for all His mercies and blessings.

RESOLUTIONS ADOPTED

Resolution No. 1—In order to safeguard one another as churches, and recognize the ecclesiastical governing body, be it therefore resolved that no property such as churches, parsonages, or any other building or land, shall be sold of any of our incorporate churches without first conferring with the trustees of the district corporation.

Resolution No. 2—Resolved that section 16 of article 2 of the religious corporation law be enforced in our district in regard to churches who have discontinued holding services and where there are less than 7 resident attending members.

That such temporalities and property be managed by the District Council of the Pilgrim Holiness Church, Inc., our ecclesiastical governing body, or may, in pursuance of the provision of law relating to the disposition of real property by religious corporations, sell or dispose of the same, and apply the proceeds thereof to any of the purposes to which the property of such governing religious body is devoted, and shall not divert such property to any other object.

In no case shall property be sold or disposed of to support the preacher who may claim this as an out appointment.

Due notice shall be given by the District Secretary regarding the action of the District Assembly in declaring a church extinct, within thirty days, to the remaining members, if any.

Resolution No. 3—Resolved, that when money is sent direct to any fund, the church treasurer shall obtain a receipt for same and forward this to the district representative.

Resolution No. 4—Be it resolved, that all departments of our church shall upon receipt of moneys immediately forward receipt for same to sender.

Resolution No. 5—In view of the great need of the education of our youth and that it is from our schools that we largely obtain our ministry; Therefore be it resolved that the New York District go on record as favoring a permanent representative of the Allentown Bible Institute for visiting the churches in our school zone; and that we will stand back of such a program and will open our churches for the raising of funds for liquidating the debt on the school property and for securing proper facilities for the advancement of the school.

Resolution No. 6—Inasmuch as it has been a practice in other years for some delegates and ministers to leave the Assembly, one or two days before its close, be it resolved that all delegates and ministers shall attend each session of the entire assembly unless excused by the presiding officer.

Resolution No. 7—Resolved, that inasmuch as there seems to be a lack of interest in our district concerning our Sunday School work, we recommend that all our pastors put forth a desperate effort to greater activity and make it a point to be present at every session if at all possible.

Resolution No. 8—Resolved, that inasmuch as the resolutions contain matters of vital importance to our lay members and inasmuch as not every one reads the resolutions, we recommend that our pastors read the resolutions before the church as soon as possible after the distribution of the minutes.

Resolution No. 9—Resolved, that we, the New York District of the Pilgrim Holiness Church, place ourselves on record as being unalterably opposed to, and deplore the present sale and use of intoxicating beverages throughout the nation, and furthermore we advise and strongly urge our people not to encourage such sale or use of said liquors by patronizing such places where these intoxicating liquors are sold.

Resolution No. 10—Be it resolved, that the District Superintendent appoint a committee of not less than three to prepare report blanks by January, 1942, if there are none issued by the General Board by that time. The statistician shall be an ex-officio member of the committee.

Resolution No. 11—Resolved, that each pastor be given freedom to hold at least two revivals each conference year.

Resolution No. 12—Resolved, that all our local churches in the district open their doors to the Allentown Bible Institute and the Redemption Rescue Home at Springfield, Illinois, at least once a year and that said institutions be allowed to take an offering for their maintenance.

Resolution No. 13—Be it resolved that we request the Allentown Bible Institute, our official zone school, to prepare courses of study equivalent to the courses required in our Manual leading to the granting of licenses to preach and to ordination, which may be offered as correspondence courses; and be it further resolved that all our workers desiring license to preach or ordination, be required to take such courses, and that the Board of Education be governed in its recommendations for license to preach and for ordination by a report from the Bible Institute upon the work done by the applicant; provided, however, that due credit may be given by the board, at its discretion, to said applicants for any equivalent work done in any other school acceptable to the Board of Education.

Resolution No. 14—Inasmuch as the work of the Board of Examiners has been delegated to the District Council, therefore be it resolved: When the District Council deems any licensed preacher unable to meet the expense of taking the study course as directed in Resolution No. 14, page 21, 1939 minutes, they may pay all or a part of the cost of such course. The Licensee shall in such case agree to finish a year of such course in the assembly year.

Resolution No. 15—Be it resolved, that each pastor attend the Binghamton, New York, District Camp, and be required to remain over one Sunday. Due exception shall be made to this rule. All the pastors residing in the extreme northern part of the District, namely, Massena, Brushton, Ogdensburg, Russell, Madrid, Bloomingdale and Lake Placid, are urged to attend and push the Camp at Vermontville which is now the property of the District.

Resolution No. 16—Be it resolved, that the Board of Examiners be discontinued and the work hitherto handled by the Board be taken care of by the District Council.

Resolution No. 17—Resolved, that the New York District of The Pilgrim Holiness Church is opposed to divorce and remarriage, and that all persons who are divorced and remarried, except to be remarried to the one from whom they have been divorced, be denied membership in said church.

Resolution No. 18—Inasmuch as our manual declares itself against the wearing of jewelry; Be it resolved that none of our preachers shall use the ring ceremony in marriages, or in any way encourage the use of it. Any minister who uses such ceremony shall be dealt with by the District Council.

Resolution No. 19—Resolved, that the plan of \$5 per member be carried out through the District, for financing the General and District work. \$3 for foreign missions; \$.50 for home missions; \$1 for General Budget; \$.50 for District claims. \$3 to be forwarded to Treasurer of Foreign Missions and \$2 to be forwarded to District Treasurer.

Monthly offerings should be arranged to meet these requirements.

Resolution No. 20—Be it resolved, that the ministers and workers of the district shall pay 2% of all monies which they receive from their ministerial labors for the support of church extension. They shall pay the same into the treasury of the local church of which they are members. This shall be sent to the district treasurer so specified.

Resolution No. 21—Resolved, that the ministers and workers of the district shall pay 50% of the tithe of all monies received from their ministerial labors, for the support of the District Superintendent. This shall be paid into the treasury of the church of which they are members. Such tithe shall be sent to the district treasurer so specified.

Each church shall send an amount equal to 4% of the pastor's salary for the support of the District Superintendent. All monies shall be sent in monthly.

All monies received, less traveling expense, by the District Superintendent in evangelistic meetings shall be sent to the District Treasurer and shall be applied to this fund.

Resolution No. 22—Be it resolved, that the support of the District Superintendent be as follows: He shall be paid \$40.00 per week. Any excess accumulation in the fund paid in shall be held in reserve toward the purchase of a parsonage for the District Superintendent.

Resolution No. 10—Resolved, that an offering be taken by each church to help defray the expenses of the District Assembly, the same to be brought to assembly by the delegate.

Resolution No. 11—Resolved, that each church sending a delegate or delegates to the District Assembly, pay the traveling expenses of said delegates and pastor. The same is to apply to this Assembly and hereafter.

Resolution No. 23—Inasmuch as the District Treasurer has a receipt form by which he acknowledges receipt of moneys sent him; Be it resolved that a like form be printed whereby the local church treasurer may remit the same funds to the district treasurer directing him in distributing the same, these to be printed in tablet form. The District Treasurer shall retain these for the year as authority for distributing all money.

Resolution No. 24—Be it resolved that all reports be in the hands of the Statistician and all moneys in the hands of the treasurer by April 10 and in the event any church fails to comply, a penalty of one dollar will be assessed. Such assessment shall go to the Statistician.

Resolution No. 25—Resolved, that the District Council meet on Wednesday of Assembly week to get business in hand for Assembly to convene on Thursday of Assembly week. The date of 1941 Assembly shall be April 17-20.

Resolution No. 28—Be it resolved, that a rising vote of thanks be given to our Assistant General Superintendent for his services in presiding in the Assembly and for his timely messages.

Resolution No. 29—Be it resolved that a rising vote of thanks be given to our District Superintendent for his faithful services during the year and for his deep interest in the ministry and our churches.

Resolution No. 30—Be it resolved, that a rising vote of thanks be given to our District Secretary for his labor of love in the work of the district.

Resolution No. 31—Be it resolved, that a rising vote of thanks be given to our efficient and faithful District Treasurer for his untiring service to the district.

Resolution No. 32—Be it resolved, that a rising vote of thanks be given to Miss Blanche Avery for her willing and efficient service as Foreign Missionary Treasurer.

Resolution No. 33—Be it resolved, that a rising vote of thanks be extended to the Oakdale Church and Brother Berg, their good pastor, and their many friends for their kind hospitality in entertaining the Assembly.
