Journal of Proceedings

The Twenty-ninth session of the Annual Assembly of the Ohio District of the Pilgrim Holiness Church convened at the Sugar Grove Camp Ground, Springfield, Ohio, August 14-15-16, 1933.

FIRST SITTING

Monday morning, August 14, at 8:30 o'clock, the first business session opened with Rev. L. R. Roberts, District Superintendent, Chairman. The assembly sang, "He Leadeth Me." Rev. C. M. Brown led in prayer, and Rev. F. C. Saneholtz read a Scripture lesson from the fifth chapter of I Peter, and offered appropriate comments.

The District Superintendent, Rev. L. R. Roberts, addressed the Assembly. His message was encouraging and we were directed to the practice of brotherly love and unity.

The proceedings of business were as follows:

The roll was called by the Secretary.

Moved and carried that Mrs. Thomas act as delegate for Marion First Church. Margaret Jones was appointed as Assistant Secretary.

It was moved and carried that the Assembly Bar comprise the first six seats in front of the platform and the two sections of seats to the right.

Moved and carried that the hours of Assembly be from 8:30 to 11:30 A. M., from 1:30 to 4:30 P. M., and from 7:00 to 9:00 P. M.

A motion was made and carried that all churches', pastors', and evangelists' reports be handed to the Committee on Statistics.

The Chairman appointed the following committees:

RESOLUTIONS—C. P. Pridgen, I. J. Snyder, J. L. Schell, N. O. Stuckey, and Charles Marshall.

Memorials—Joel Harmon, C. M. Brown, B. O. Shattuck, J. A. Fields, and Harry Holtzapple.

WAYS AND MEANS—C. V. Holstein, R. E. Ross, E. E. Connin, B. H. Pugh, and F. C. Saneholtz.

RECEPTION-Mrs. H. C. Walker, and J. H. Pernell.

STATISTICAL—H. S. Harrold, Anson Skillings, and A. A. Haines.

AUDITING-Helena Saneholtz and Celia Bradshaw.

EDITING—D. C. Shearer.

Moved and carried that the three Pastors of the following churches: Murray City, Floodwood, and Oak Grove, act as delegates for their respective churches, since these Pastors are holding Local Preacher's Licenses.

Moved and carried that the new churches be received and that the delegates be seated within the Conference Bar.

Moved and seconded that Velma Verness act today as delegate for Dayton Second Church, since the delegate is absent. Carried.

The following brethren were introduced to the Assembly: Rev. D. R. Close, Rev. K. A. Brannon, Rev. J. B. Zeits, and Rev. S. I. Emery. Moved and carried that these brethren be granted a seat within the Conference Bar with privileges of the floor.

The Resolutions Committee read Resolution No. 1. Carried that it be accepted.

The Chairman declared the question open, inasmuch as so few voted.

The Resolution was reconsidered. After considerable discussion a motion was moved and carried that the Resolution be referred to the Committee for redrafting.

Resolution No. 2 was read and adopted. Resolution No. 3 was read and adopted.

Resolution No. 4 was read and it was moved and seconded that it be adopted.

After considerable discussion it was moved and carried that the time be extended 15 minutes.

A motion was made and supported that the Resolution No. 4 pertaining to the Stationing Committee be referred back to the Resolutions Committee for redrafting. Carried.

Adjourned with benediction by Rev. B. O. Shattuck.

SECOND SITTING

Monday Afternoon

The Assembly was called to order by the Chairman, Rev. L. R. Roberts. The Assembly sang "Glory to His Name" and prayer was offered by Mrs. C. M. Brown.

The roll was called by the Secretary.

The following visitors were introduced: Rev. and Mrs. Brandenburg of the local Nazarene Church, Rev. James Corwin, Rev. McKinley, Rev. O. W. Stockman, Rev. Reed, Rev. Walter Carson, Sister Kittle of Rossburg, and Mr. Zellers and Mr. Dowdell, Anti-Saloon League promotors. It was moved and carried that these visitors be granted a seat within the Conference Bar with privileges of the floor.

The following ministers: Rev. K. A. Brannon, Rev. Walter Carson, Rev. D. L. Close, Rev. J. B. Zeits, Rev. Reed, and Rev. James Corwin, were on motion re-

ferred to the Examining Board.

The minutes of the previous sitting were read and approved.

A motion was made and supported that the election of officers be held at this evening sitting. Carried.

Resolution No. 4 of the Resolutions Committee was read. After discussion it was on motion adopted.

Resolution No. 5 was read and tabled.

Resolution No. 6 was read. By motion it was referred to the Committee on Memorials.

Resolution No. 7 was read and adopted by motion.

Resolution No. 8 was read and adopted.

A motion was made and supported that we rescind the former action on Resolution No. 7. Motion lost.

A motion was made and supported to have a song by the Bible Holiness Seminary Quartette. They sang "O Happy Day."

Resolution No. 9 was read. It was moved and supported that the resolution be adopted. Then it was discussed at length.

Adjourned with benediction by Bro. Holstein.

THIRD SITTING

Monday Evening

The evening sitting convened at 7:00 o'clock P. M. with Rev. L. R. Roberts in the chair. The Assembly sang "Glory to His Name."

A motion was made and supported that we dispense with the roll call. Carried.

The minutes of the previous sitting were read and approved.

A motion was made and supported that Miss Mary Moon act as delegate for the Bowersville Church in the absence of the delegate. Carried.

By a motion Mr. Dowdell and Mr. Zeller were permitted to present slides on an Anti-Saloon Address at the close of the election of officers in the evening sitting.

The following visitors were introduced to the Assembly: Miss Stockman and Rev. Benner.

The Chairman appointed Bro. Harry Holtzapple, Bro. W. F. Childs, Bro. J. H. Pernell, and Bro. H. S. Harrold as tellers.

Inasmuch as there was an oversight in the granting of license to Rev. Rutherford last year, it was moved and carried that he be granted a voice in the conference.

The Assembly then entered into the election of officers and the ballots were spread. Rev. L. R. Roberts was re-elected as District Superintendent by a great majority on the first ballot.

By motion, rules were set aside long enough to rescind the action made earlier in the day, which prevents the acceptance of ministers coming to us from other districts of the Pilgrim Holiness Church.

A motion was made and carried that we accept the brethren coming to us from other districts of the Pilgrim Holiness Church with letters of transfer, and that they be given a voice in the Assembly. Rev. Close and Rev. Zeits were accepted.

Rev. F. C. Saneholtz was re-elected Assistant District Superintendent on the first ballot.

By motion, rules were suspended and D. C. Shearer was duly elected District Secretary by acclamation.

A motion was made and seconded that we suspend rules and re-elect Rev. C. P. Pridgen as District Treasurer by acclamation. Carried.

By motion rules were suspended and Rev. C. M. Brown and Rev. Joel Harmon were re-elected by acclamation as advisory members of the District Council.

FOURTH SITTING

Tuesday Morning

It was decided that an offering be taken to buy paint for the dormitory.

Resolution No. 10 of the Committee on Resolutions was submitted. A motion prevailed and the resolution was adopted.

Resolution No. 11 was read and adopted by motion. A rising vote of thanks to Brother and Sister Connin.

Resolution No. 12 was submitted. It was moved and carried that it be adopted.

Resolution No. 13 was adopted by motion.

Resolution No. 14 was read and adopted.

A motion made by Bro. Slater carried and the Assembly arose with bowed heads

in reverence and respect to our Dear Brother Rees. Brother Slater prayed. Resolution No. 3 of the Ways and Means Committee was read. Amended

by motion and adopted.

Resolution No. 7 of the Ways and Means Committee was read. Amended by motion and adopted.

A motion was made and carried that a mite box be placed in each church in order to secure funds for Home Missions.

The report of the Auditing Committee was read and accepted.

Recommendation No. 1 of the Examining Board was accepted by motion. Three resolutions were then accepted by motion as recommendations from the Examining Board.

Resolution No. 15 of the Committee on Resolutions was then submitted. It was moved and adopted.

The report of the Stationing Committee was read and accepted. Brother J. A. Schell then sang a song.

It was moved and carried that we receive the church at Goose Run into the District.

A motion carried that the Secretary write to each Pastor informing him of the action that was taken concerning the financial plan.

A song by the Calvary Quartette.

The Assembly sang "Blest be the Tie That Binds."

Adjourned until next Assembly, benediction by Brother Schell.

THE ANNUAL REPORT OF THE DISTRICT SUPERINTENDENT

It is with great joy that I bring greetings to the Twenty-ninth Annual Assembly of the Ohio District, Pilgrim Holiness Church.

I am delighted to report that this has been a year of continuous and precious fellowship with my Lord and Saviour. I feel that I have grown in grace and that my vision has been broadened during the months that have come and gone since we met here one short year ago.

I am also delighted to report that this has been the busiest year of my min-

isterial career. I have traveled more miles, preached more sermons, made more visits among our people than in any other like period of time throughout the years that I have labored in the service of the Master.

I wish to further report that I have been kindly received and generously entertained wherever I have gone. Not an unkind word, not an unfriendly look, nor an unchristian attitude has been mine to endure at any time, or any place under any condition as I have gone in and out among our good Pilgrims.

I am also glad to report that the Lord has been pleased to visit our people and churches this year with some unusually good revivals. Nearly every church reports two revivals and several of them three or more. In nearly all of these revivals souls have sought and found the Lord for either pardon or purity while in many places, a goodly number have been taken into membership.

In addition to this I wish to report that four new P. H. Churches have been organized since last Assembly.

During the month of May a Pilgrim Holiness Church was organized in Oak Hill with fifty-six charter members. On the sixteenth of June a new church was organized in the city of Lima with some twenty members. On the sixteenth of July a splendid body of saints in Afton decided to cast their lot with the Pilgrim Holiness Church, and we were enabled to organize with some twenty-three or twenty-four members. Also one of the brethren was helped of the Holy Spirit to reorganize the church at Arthur with seven members, bringing into our connection a few over a hundred members by the way of new organizations. For all the good folk the Lord has been pleased to add to our number this year, whether by new organization or by adding to the membership of churches already organized, I wish to give our God all the praise.

Yet, while I rejoice for all the good things the Lord has done for us as a church this year, my heart is grieved beyond expression as pleas come in from cities, towns and villages asking for revival meetings with the thot of organizing a new Pilgrim Holiness Church. The fields are indeed "White unto harvest." The time to strike is now. Thousands are asking for the "Old Paths" and it is up to the Pilgrim Holiness Church to do her bit to give the perishing multitudes the "Bread of Life." I plead with this Assembly to do something definite and worth while in the way of a forward movement for Home Missions the coming Conference year. I believe that each licensed and ordained minister should be required to give one dollar per quarter for this great need.

In connection with what this Assembly may do for Home Missions in the way of finances, I strongly urge that each and every pastor be made available for at least a three weeks' Home Missionary Evangelistic Campaign, subject to the call of the District Superintendent, without charge, except for transportation, the churches of which he or she is pastor to see that the pastor's regular support be taken care of during his absence. I feel that with a small sum in money, plus two or three hard working, praying, experienced pastors to help, several good Pilgrim Holiness Churches can be organized during the coming Conference year.

I should also like to see plans set on foot whereby the District would be able to purchase two or three new tents for the coming tent season. I would suggest that this Assembly authorize the District Superintendent, on his first visit to the different churches after the Assembly, to take pledge offerings of not more than one dollar per person, to be paid at any time in from four to six months, with which the District Board shall purchase a suitable tent or tents, at the best price obtainable, for Home Missionary work.

One of the best and surest ways to take care of our District Indebtedness and our General obligations, at home and abroad, is to dig out new churches, and thereby increase our source of revenue.

There are other financial needs that will require our careful and prayerful

consideration during this Assembly if the Ohio District wishes to do her share

as a part of the Pilgrim Holiness movement.

The Foreign Missionary needs of our church have been fearfully neglected. The salaries of our general officials have been paid but in part. While the District Treasurer has been embarrassed once and again because of the failure of promised funds to materialize with which to meet many of the most pressing needs of the District.

'As pastors, evangelists and delegates we should go on record as favoring something definite and workable, and then go back to our homes and churches, and by the aid of the Holy Spirit, put it over for our God and the Pilgrim Holiness Church.

During the year I have anointed and prayed with the sick, administered the sacraments, held business meetings, and have endeavored to encourage the saints as well as to exhort the unsaved to seek the Lord. I have also met with the District Board on several occasions and assisted in the administration of the affairs of the Kingdom when duty demanded and opportunity permitted and, by the help of the Lord, have preached two hundred and twenty-two different times.

For our support we have received the gross sum of nine hundred, forty-five dollars and sixty-four cents. Of this sum it cost us three hundred, thirty-four dol-

lars and forty-one cents for parsonage rent and traveling expenses.

Leaving us a net support of six hundred, eleven dollars and twenty-three cents for our year of labor.

In closing our report we wish to thank our God for the blessings that have

been ours to enjoy throughout the year.

We also wish to voice our appreciation for the reception that our good Pilgrims have extended us as we have gone in and out among them during this time.

As we close the old year, and take up the duties of the new, let us look to our Heavenly Father with a simple, trusting faith and go forward to greater victories than we have known in the past.

REPORT OF THE WAYS AND MEANS COMMITTEE

1

Inasmuch as we feel the need of a clear understanding of our District financial condition, be it resolved that the District treasurer be instructed to read the reports of the various churches, informing us of our deficiencies in regard to the District.

2

In the light of the fact that Brother Connin uses his car to haul freights of various kinds, be it resolved that this Assembly pay him the sum of \$10.00 for the use of the same.

3

Referred to Committee for redrafting.

In consideration of the work of our District Secretary and Treasurer, be it therefore resolved that we pay our District Secretary \$25.00 per year and our District Treasurer \$75.00 per year for their services.

Since the District finds there are pressing obligations on the Camp Ground that are facing us, be it therefore resolved that we as a District ask each of our

Sunday Schools to take a special offering or set aside from their regular Sunday School offering each Sunday an amount equal to one cent for each attendant. This to be sent monthly to our District Treasurer and to be applied on indebtedness on the Camp Ground.

6

That each local church raise the equivalent of \$3.00 per member. Two dollars for Foreign Missions and one for General Interests.

Each Local, Licensed, and Ordained Minister is requested to pay the sum of \$1.00 this year for Home Mission Work. The money to be paid to the local church Treasurer and the same forwarded to the District Treasurer quarterly. Amended that the Secretary correspond with the Pastors asking them to urge the Ordained, Licensed, and Local Preachers to pay the \$1.00 for Home Missions.

Be it resolved that all our members tithe their income into the local treasury of the Church in which their respective memberships are held. That 10 per cent of all gross receipts with the exception of General Budget, Foreign Missions, Evangelistic support and the Building Fund, be forwarded monthly to the District Treasurer. 70 per cent of this to be applied on District Superintendent's support, the remaining 30 per cent to go for District expenses.

We further add that the District Superintendent pay his own traveling expenses, and receive an offering at each local church visit, the offering to be applied on his support and credited to the local church tithe.

RECOMMENDATIONS FROM EDUCATIONAL BOARD

Those desiring to pursue the Course of Study and take Examinations during the Assembly year may write to the following for information: For Sell's Bible Study by books, Guide to Study of Old and New Testaments, and Parliamentary procedure write to Rev. F. H. Tormohlen, Bowersville, Ohio.

For English Composition and the Manual write Emerson Smith, Rossburg, Ohio, Route 1, Box 166.

For Bible Doctrines, Elements of Divinity, Homiletics, and Bible History write to E. G. Marsh, 1810 Young St., Cincinnati, Ohio.

Be it resolved that all preachers and lay delegates remain until the close of the Assembly; no pastor or delegate shall be excused without a good and written reason.

When a licensed minister continues year after year as a licensed preacher, making no attempt to take the course of study, and is doing little or no active preaching, he or she may be referred by the Examining Board to the Local Church for Local Preacher's License.

Whereas there are many licensed preachers who are doing little or no active preaching, and who have no prospect of doing more than local work, we urge that our local churches be more careful in recommending candidates for District License to preach.

These three resolutions were adopted by the Assembly.

REPORT OF THE RESOLUTIONS COMMITTEE

The following resolutions were adopted by the Assembly:

There are different churches in the District that owe borrowed money to the District. Be it resolved that this Assembly ask them to make arrangement with the District Treasurer for payment if possible.

Inasmuch as our bed clothing is insufficient for the Camp Meeting, be it resolved that each church be requested to bring two sheets and pillow cases this year, the same to be left at the Camp Ground.

4

Resolved that we continue the Stationing Committee resolutions the coming year as it was passed last year, providing that the committee be composed of the District Officials (as stated) with the lay delegation from the particular church being dealt with.

Where a church is changing pastors, in the usual way, it is to be understood that the pastor's time of service is to include the Sunday following the District Assembly.

8

All people should read good literature, and inasmuch as the PILGRIM HOLINESS ADVOCATE is second to no paper published, and further, it is our church paper and we should do our best to enlarge its circulation, Therefore, It is recommended that all our Sunday Schools subscribe for it for the homes of the regular attendants of our Sunday School for the adult classes, and senior young people, and that people be urged to bring their ADVOCATES into Sunday School for distribution. We further recommend that one or two pages of the ADVOCATE be devoted to stories and articles suited for Sunday School work.

9

A suggested financial plan for relieving the pressure on our camp ground. The trustees to give a blanket mortgage covering one hundred and fifty notes. One hundred at \$25 each and fifty at \$50 each, making a total of \$5,000.00. These notes are to run without interest ten years, or until the death of the purchaser or until such a time as the District is able to liquidate them. They become due and payable to the estate of the purchaser at his death. The notes are to be sold, the \$25.00 at \$1.00 down and \$1.00 per month for two years, the \$50.00 notes at \$2.00 down and \$2.00 per month for two years. Ten per cent of the money collected plus \$100.00 a year annually to be paid by the camp meeting to be held in a special fund for the paying of the notes when they come due.

If for any reason ten notes were to become due and unpaid, then, with the consent of the people holding 51 per cent of the money represented by the notes,

they may foreclose and force collection on all notes.

The trustees are to invest this reserve money in some safe bonds or securities, or deposit it with some savings bank as a trust fund. The interest accruing from such purchases or loans is to be held in the special fund to be used in paying notes when they come due.

By consent of the District Council, new notes may be sold from time to time

provided the total obligation does not exceed \$5,000.00.

It is understood that this plan may be changed so as to comply with the law, providing such change does not jeopardize the interest of the District or the holders of the notes.

The District Superintendent shall be sales manager, etc. A worker may be appointed in each community.

10

Be it resolved that steps be taken to interest our local churches in preparing Page 18

such foods as cookies, noodles, jellies, jams, and other fruit and pickles for our Camp Meeting and Assembly of 1934, and that the Council make provision for a committee of three ladies to cooperate with our pastors in meeting these needs.

11

Inasmuch as Brother and Sister Connin have been living on the Camp Ground, being given quarters here if they keep up the grounds, and since they have been so faithful in their duties and have gone to special pains to beautify the grounds by building a fish-pond, flower-beds, and setting out of a number of trees, be it resolved that we as an Assembly give our dear Brother and Sister Connin at least a rising vote of thanks for their faithfulness.

12

Inasmuch as we have in our District many as fine young people as there are to be found anywhere; and whereas our General Officials have expressed themselves as questioning the advisability, if not prohibiting, Young People's District Organization; and whereas different ones of the General Officers have expressed themselves as favorable to a reconsideration of their position on the matter: Therefore, be it resolved that we continue our District Y. P. Organization; until the General Board hands down a final ruling.

13

Resolved that 500 copies of the Minutes be printed and sold on the same conditions as last year. Ten cents per copy to the laity and twenty-five cents to the ministry.

14

Resolved that the District Assembly of 1934 be held August 14, 15, and 16, the three days following Camp Meeting.

15

(a) Be it resolved that we extend to our beloved District Superintendent a vote of thanks for the spirit of sacrifice through the past year of great necessities and for the beautiful example he has set before the churches as he journeyed throughout the District: as well as for his labors many through the past year.

(b) That we extend a vote of thanks to our District Secretary for his untiring work of the year and to him and his assistants for their multifold labors

throughout the present Assembly.

(c) That we express our appreciation for our efficient treasurer and his wife for the splendid and efficient manner in which they have taken care of the financial records of the District and the work pertaining thereto.

(d) That we recognize the untiring labors of our Statistical Committee in

compiling the records for the District.

(e) That we thank the Camp Meeting Committee and especially its able president and corps of workers for their efficient and hospitable manner with which they provided for the entertainment of the Camp Meeting and Assembly.

(f) Inasmuch as our cooks have been faithful and fed the Assembly and

Camp so well, be it resolved that we give a vote of thanks to them.

(g) That we reverently offer thanks to our Heavenly Father for His blessing during the Camp Meeting and Assembly.

MEMORIALS ADOPTED BY THE ASSEMBLY
