Journal of Proceedings

FIRST SITTING

SECOND SITTING

Monday Afternoon

The second sitting of the Annual Assembly was called to order by the Chairman, Rev. W. L. Surbrook. After Scripture Reading and prayer by Nev. Paul Greeson the roll was called and corrected.

The minutes of the previous sitting were read and accepted as corrected. Kev. J. B. Zeit of the Indiana Assembly of the Pilgrim Holiness Church was introduced and given a seat within the conference bar.

He later returned and delivered a speech of acceptance of the office of District Superintendent. A motion prevailed that D. C. Shearer be elected Assistant District Superintendent by acclamation.

The ballots were cast for District Secretary which resulted in no election. A motion was moved and seconded that the rules be suspended and Rev. Paul Greeson be declared elected District Secretary. Carried.

Adjourned with benediction by Rev. C. P. Pridgen.

THIRD SITTING

Monday Evening

The Assembly assembled at 7 A. M.

Rev. W. L. Surbrook in the chair.

Rev. L. R. Roberts read a Scripture lesson from Romans, chapter twelve. Prayer by the secretary. The male quartette sang a song entitled, "We'll Never, Never Die."

An outpouring of the Spirit resulted and the shouts of victory were many.

At the roll call the ministers and deaconesses were asked to pledge themselves as to the number of subscribers they would attempt to secure for the Pilgrim Holiness Advocate. 957 were thus pledged.

Prayer was offered by Rev. M. G. Standley before continuing the election of officers.

Rev. Paul Greeson resigned from the office of conference secretary. A motion was made and seconded that the two names receiving the highest number of votes on the former election for District Secretary be the nominees. Carried. F. C. Saneholtz and L. R. It was moved and seconded that we return to the former number of seven members to comprise the District Council. Carried.

It was moved and seconded that we elect the three councilmen on one ticket. Carried.

The ballots were cast and Rev. Joel Harmon was elected.

Inasmuch as Rev. E. E. Connin only lacked two votes of being elected, it was moved and seconded that he be elected by acclamation. Carried.

It was moved and carried that the two next highest in votes be the nominees. They were Rev. Greeson and Rev. Emerick.

It was moved and seconded that we reconsider the question of electing

It was moved and seconded that the District Council elect the Examining Board. Carried.

A motion prevailed that the District Council elect the Camp Meeting Board.

The District Council nominated for a member of the District Council the following: Richard Powell, Harold S. Harrold and Harold Osborn. The ballots were cast resulting in the election of Richard Powell.

It was carried that the time be extended thirty minutes.

It was moved and seconded that we suspend the rules and have the District Council to elect the trustee. Carried.

A motion was made and seconded that the District Superintendent appoint the following committees as standing committees: The Resolutions Committee, and the Ways and Means Committee, each consisting of three members and the Statistical Committee consisting of one member with the understanding that other members be added at the next Annual Assembly if desired. Carried.

The Auditing Committee reported. (See printed minutes.)

The District Treasurer read his report. (See printed minutes.)

It was moved and seconded that the report be accepted. Carried.

The District Superintendent announced the committees as follows:

Resolutions Committee: Joel Harmon, C. M. Brown, and E. E. Connin. Ways and Means Committee: Paul Greeson, I. J. Snider, and A. A. Haines. Statistical Committee: A. O. Skillings.

By request Rev. Pridgen was excused from Ways and Means Committee. Rev. M. C. Kittle was appointed to serve on the Ways and Means Committee.

The Assembly adjourned by expiration of time. Benediction by L. R. Roberts.

FOURTH SITTING

Tuesday Morning

The fourth sitting of the Annual Assembly convened Tuesday morning with the General Superintendent, Rev. W. L. Surbrook, in the chair.

After a song the secretary read a Scripture lesson from II Tim. 4:1-8. Prayer by Rev. C. M. Brown and Rev. O. L. King.

A motion prevailed that we dispense with the roll call.

The minutes of the previous sitting were read and accepted.

At this time Rev. R. P. Ditmer, Presiding Elder of the Mennonite Brethren in Christ, and wife were introduced to the Annual Assembly, and were granted a seat within the Assembly Bar.

Mrs. Nuby then sang a song.

The Resolutions Committee reported as follows:

RULES FOR CAMP WORKERS

RESOLUTIONS Relative to Rules and Regulations of the Camp Meeting No. 1

Resolved that workers who come to work their way for their board and lodging should if possible be a member of some Pilgrim Holiness Church and bring a recommendation from their Pastor.

No. 2

Resolved that such workers must come for the Interest of the Camp and their own spiritual uplift and not for a social time and outing.

No. 3

Resolved that such lady workers must wear dresses with full length sleeves and with unbobbed hair.

No. 4

Resolved that all men and boy workers also dress modestly and be of clean habits.

No. 5

Resolved that all such workers when possible must attend services and not be lounging about on the grounds or off the grounds.

No. 6

Resolved that all such workers must report to the Camp Management, president or to the one in charge of them, before leaving the ground or place of work.

No. 7

Resolved that all platform workers be fully dressed, without bobbed hair and without jewelry, meeting all other requirements of the Manual.

No. 8

Resolved that each pastor must instruct each worker in reference to these rules before coming.

No. 9

Resolved that workers who become unwilling to be subordinate to these rules also become subject to dismissal at once.

REPORT OF THE WAYS AND MEANS COMMITTEE AS ADOPTED BY THE ASSEMBLY

No. 1

General Assembly Expenses

Under our present set up our District is entitled to 4 delegates by virtue office, viz., District Superintendent and Assistant Superintendent, District Secretary and District Treasurer. Eleven ministerial delegates and 6 lay delegates. Total 21.

Be it resolved that we adopt a 3-year plan for the payment of General, Assembly expenses whereby each local church pay to District Treasurer the equivalent of 21 cents per member over the period of 3 years.

No. 2

District Home Missions

Be it resolved that Sunday Schools take birthday offerings and that all licensed and ordained ministers and deaconesses give in addition to their regular birthday offerings one dollar per annum, the same to be sent monthly to the District Treasurer to be used for District Home Missions.

No. 3

Tent

Because of the great need of tents to do Home Missionary work, be it resolved that each Sunday School give the equivalent of 10 cents per Sunday or \$5.20 per year, the same to be sent quarterly to the District Treasurer.

No. 4

Tithe

Be it resolved, all members generously support the interests of the church by their tithes and offerings, and all gross receipts of the local church, excepting Foreign Missionary funds, General Church Budget, Building fund and Evangelistic support, be tithed. The same to be forwarded monthly to the District Treasurer. 70 per cent of which is the support of the District Superintendent. The 30 per cent to be used on the District. The Superintendent is to pay his own expenses excepting to District Council meetings. All cash offerings received by him are to apply on his support and to be credited on the local church tithe.

No. 5

Camp Ground

Inasmuch as no provision has been made to care for the financial obligation of the Camp Ground; be it resolved that we ask the local churches to raise the equivalent of 25 cents per member per annum, the same to be forwarded to the District Treasurer.

Salaries

In consideration of the work done by our District Secretary and District Treasurer; be it resolved that we pay the following amounts for the year: District Secretary \$25.00; District Treasurer, \$100.00.

No. 6

No. 7

Headquarters' Repairs

In regard to the necessary repairs now in progress at our Headquarters in Indianapolis, Indiana, we recommend that each of our churches in the very near future take a very liberal free will offering and forward the same to the District Treasurer.

No. 8

Assembly Expense

We recommend all visitors attending the District Assembly be charged a reasonable amount for meals. The price to be set by the committee in charge. This does not apply to ministers and their wives. Amended—That each Church and Young People's Society take a good, liberal offering to provide for the expense of the delegate while attending Annual Assembly.

No. 9

Foreign Missions and General Budget

We recommend that the General Foreign Missions and the General Budget be raised monthly in the Sunday School or church, taking either Sunday thought best for the offering.

g. Inasmuch as our cooks have been faithful and fed the Assembly and Camp so well; be it resolved that we give a vote of thanks to them as well.

i. That we as an Assembly appreciate the presence of Rev. M. G. Standley, President of God's Bible School and extend him a hearty invitation to return next year.
