### STANDING RESOLUTIONS

- 1. We recommend that our preachers preach at least one sermon each quarter on Scriptural giving.
- 2. Instead of having one Committee functioning as an Educational and Examining Committee, we recommend the appointment of two Committees, as provided for in the Manual.
- 3. We recommend that our Sunday Schools be privileged to use the Advocate as a Sunday School paper, providing one for each family; However, wherever Sunday Schools desire to do so, they may also provide other literature for junior and primary classes.
- 4. We recommend that all our workers tithe the ministerial support to the District Superintendent, and that all our unstationed licensed ministers pay at least half their tithe to the District Treasurer, to be used at the discretion of the District Council.
- 5. We recommend that the District Superintendent notify the vastors as nearly as possible of the time of his visits, in order that the pastors may announce his coming, and stress upon the churches their financial obligation to their Superintendent.
- 6. We recommend that our churches hold at least one missionary meeting each month, one month to be in the interest of foreign missions and the next to be in the interest of home missions; further, that a monthly missionary offering be taken alternatley in the interest of home and foreign missions; and that where advisable, our churches have weekly missionary prayer-meetings.
- 7. We recommend that the pastors be kept informed as to the imminent needs of home missions that they may intelligently present the needs to their congregations.

8. We recommend that the local church take up a special offering previous to our Annual Camp Meeting for the support of pastor and delegate during Camp and Assembly.

### From 1937 Minutes:

- 9. Resolved that before calling any evangelist the pastors shall consult with and on the advice of, the District Superintendent.
- 10. Resolved that half the birthday offerings shall be paid to Home Missions.
- 11. Resolved that all money raised for the district and also for General funds, shall be forwarded to the District Treasurer at the end of each month.
- 12. Resolved that a remuneration of ten dollars per annum be paid to the District Secretary-Treasurer.
- 13. Resolved that each local church shall supply the parsonage with stove, chairs, table, and dresser.
- 14. In as much as most of our pastors are not receiving sufficient financial support, be it resolved that monthly donations other than cash be given, the same to be announced in the service each month by the Assembly delegates.

### JOURNAL OF PROCEEDINGS

### First Session

The Twelfth Annual Assembly of the Ontario District of the Filgrim Holiness Church convened in the Filgrim Holiness Church, 380 Oakwood Ave., Toronto, at 9 A. M. on September 6 th. 1937, General Superintendent W.L. Surbrook presiding.

After an inspiring song service, conducted by Robert Gordon, pastor of Massey church, Rev. Surbook led the Assembly in prayer, then read and spoke from Romans, chapter twelve. In this opening message addressed to the workers, Bro. Surbrook stressed the reality of holiness, and gave timely council concerning the pulsations of the spiritual life, the diversity of ministerial gifts, the true shepherding of youthful talent, and general ministerial diligence.

The roll was called and revised.

It was moved and seconded that the right side of the Church be constituted the Assembly bar.

It was moved and seconded the hours of Assembly be as fablows:

forenoon session, 9 to 12 o'clock. afternoon session, 1.30 to 5 o'clock. evening evengelist service, 8 o'clock.

At the request of the Chair, the District Superintendent, Rev. George Beirnes, read the list of the Committees of last year.

The Chair suggested the forming of a Committee for drafting memorials for the General Assembly. The matter was deferred until the settlement of the time of the next Annual Assembly.

The Auditor's, being called for, was read by S. D. Short.

Moved and seconded that we accept the report of Auditing Committee. Carried.

The report of the Secretary-Tressurer was read by the Secretary.

Moved and seconded that we accept the Secretary-Treasurer's report. Carried.

The report of the Statistician was read by the Secretary.

Moved and seconded that we accept the Statistician's report. Carried. It was moved and seconded that we redeive into our District, the foronto Church, which was newly organized this year. Carried.

The Chair requested the Superintendent to appoint a Reception Committee. Bro. Beirnes appointed to comprise this Committee, Bros. Allan AcGuire, and Herbert Shaw.

White's name was substituted. Frank Bain was elected.

It was moved and seconded that we leave the business of date, place and evangelist for next year's Camp-meeting to the District Council. Carried.

It was moved and seconded that we meet again at 2 P.M. Carried.

The meeting adjourned by expiration of time. Dismissal by prayer.

Report of District Superintendent.

To the twelfth Annual Assembly of the Filgrim Holiness Church of the Ontario District, g greetings.

Through the good providence of God and His manifold mercies, we have come to another Assembly. This year just closing has been one of some hard-fought battles, but the Captain of our Salvation has given as some glorious victories. Through all the trying hours and with all the many problems that have confronted us on the District, we have been conscious of the presence of God, and we give him the glory for all that has been accomplished.

he we have looked upon the field and seen the many needs, we have been made to dry to dod for his help, and again he had answered prayer and sent deliverance, for which we praise him.

During this Assembly year there have been eleven tent meetings held on the District.

Lest fall we were able to secure the services of Rev. R. W. Chatfield, who held a good meeting in Toronto, and we were able to organize the first filgrim Holiness Church in the city. Bro. W. J. Tompkins, our Assist at Superintendent, followed this with another month's campaign. After this, Rev. Harold Hobbs for a short period supplied, and then Bro. Allan acquire was called as pastor, whose ministry has been much blessed of God.

This Spring, with our Executive Secretary of Home Missions, Rev. H. W. offe, we burriedly ran over most of the field where we have churches gnand also visited new places where we were considering holding tent-campaigns, advising with him. We hastened with him to Indianapolis.

and together we met our General Treasurer, presented our field with its urgent needs, and made our plea for help. From here we went to the Revivalist Camp at Cincinnati, where we met Bro. Wilcox, whom Bro. Wolfe had recommended to us; as well as my old friend, Rev. Donald Deware. of Walston, Mass.

From Cincinnati we came back to Barrie, where we had opened last summer with a tent-meeting. Here we held another, but the attendance was poor, and result not that for which we had hoped.

About the first of July we pulled stakes, loaded all on my car, and tame to Brampton. We found and secured the best lot in the town, and opened fire on the enemy. We had much opposition from the start, but God blessed, and quite a number sought the Lord. We have secured a fine hall, the attendance is good, and the cutlook is very encouraging.

We secured Evangelist, Philip Overstreet, of Cincinnati, with the Clark Bros. of West Virginia, for the tent-meeting in Oshawa. Here we contacted many hungry-hearted people. Not many were seeking, but many expressed themselves as receiving help, as well as wanting the Pilgrims in Oshawa. We were able to secure Bro. B. A. Eary, and wife from Cheboygan, Mich. who had lately given our church in Massey a good meeting. He arrived in a bad storm which did much damage to our tent. We mended it as best we could and got it up. His text the first night was, "The battle is the Lord's". The people rallied, and the outlook is very promising for the future in Oshawa.

Last fall Bros. Hobbs and Gordon held a fine camp with the Indians, and witnessed many seeking God We have now erected a fine log-cottage for the pastor, and are erecting a chapel at the present time. The work among the Indians has been very fruitful. Many reserves are waiting for our Message, and present a great need.

During the Assembly year I have visited all of our churches twice, meeting the boards and holding

the annual meetings. I think this has been about the busiest year of my ministry. In checking up, I find that I have travelled 12,500 miles, held 3 revivals, assisted in a number of others, preached ninety-three sermons, assisted in some sixty other services; dedicated 6 children, attended both General Board meetings in Indianapolis, and succeeded in securing some help from them for the District, which was much appreciated.

I might mention that a good friend gave me \$100.00 to help 100.00 in my work. Part of this I turned to the District, in fact all was used--part on my car, , for this I have used almost entirely for the District. I did practically all the hauling of tents as well as cayrying workers, eliminating considerable cost to the District.
