# **PROCEEDINGS**

The Seventeenth Annual Conference of The Pilgrim Holiness Church convened at 9 a.m. Friday morning, September 25th, 1942, in the Pilgrim Holiness Church at Proton Station, Ontario; with Rev. Gordon in charge of the song service. Rev. Basil E. Shaver and Myra McIntyre, led in prayer.

At this time our chairman, Rev. R. W. Wolfe, of Indianapolis, Indiana, General Secretary of the Department of Home Missions, was introduced to the Conference, who in turn spoke at length to the Conference using as the Scripture reading, John 7:37.39.

He explained to the Conference our privileges as a Home Missionary District as regarding church government.

The Secretary called the roll, after which the church delegates were registered, as follows: Lions Head delegate, Annie Bridge; Massey delegate not present; Powassan, no delegate; Proton, Sr. Vause; Toronto delegate, Sr. Eileen Baker; Oshawa delegate, Sr. Almira Caverly; Wiarton delegate, Sr. Atkey; Dyers Bay, no delegate.

Moved and seconded that the first six seats constitute the conference bar.—Carried.

The resolution committee reported all members present and ready to function.

The educational committee having two members absent was completed by the appointing of Rev. A. L. McGuire, by the District Superintendent and by motion the other place was filled by R. D. Brown.

Moved and seconded that these two committees combine their work during the conference.—Carried.

The reception committee was appointed, Rev. H. W. Hobbs and Sr. Bertha Gordon.

Rev. Basil E. Shaver, of Victoria Harbour, Ontario, was introduced to the Conference, after a few words of testimony he was given an honorary seat within the conference bar.

The Chairman, Bro. Wolfe, informed the conference that we were entitled to have a Secretary, Treasurer and one advisory member of the council: or, a Secretary-Treasurer and two advisory members.

It was moved and seconded that these members be elected by secret ballot; and, consist of a Secretary-Treasurer, also two advisory members.—Carried.

The Statisticians report was read; and accepted by a rising vote of thanks.

It was moved and seconded that the first session adjourn at 11:30 a.m.—Carried.

The following appointments were made by the District Superintendent:

Examining Board—Rev. S. D. Short, three years. Educational Board—Rev. Annie Short, three years.

Auditing Committee-Annie Short, Myra McIntyre.

Election of council members followed by secret ballot, Rev. F. A. Hobbs was elected as Secretary-Treasurer on the first allot. Rev. Robert Gordon, elected council member.

The voting for the third council member resulted in a tie between A. L. McGuire and H. W. Hobbs; Rev. McGuire asked to be permitted to remove his name in favor of Bro. Hobbs, Another vote was called for, for the next Session.

Moved and seconded that the District Council be the Ways and Means committee.—Carried.

Resolution committee recommended that standing resolution No. 23 be deleted. Moved and seconded it be accepted .- Carried.

Moved and seconded that our afternoon session convene at 2 p.m. and

that we adjourn at 5 p.m.-Carried.

Moved and seconded that we recess until 2 p.m .-- Carried. Conference adjourned, prayer by Rev. H. W. Hobbs.

#### SECOND SESSION

Second Session convened at 2 p.m. in the church, with the singing of "Every Day and Every Hour."

After the devotions minutes of the first session were read and approved.

The roll call was read and corrected

Moved and seconded that the Secretary write Sr. B. A. Eary sending her the conference's compliments and blessings and wishes for her speedy recovery.—Carried.

The District Treasurer's report was read and accepted.

Moved and seconded that the conference recess until 2 p.m Saturday with special services at 8 p.m. and also at 10 a.m. tomorrow; Rev. R. D. Brown to be in charge.-Carried.

Conference was adjourned with prayer by Rev. Mae Cornfield.

#### THIRD SESSION

Session was opened by singing, "Go Labour On," led by Rev. S. D. Short. Prayer was offered by Rev. B. E. Shaver and Rev. F. A. Hobbs.

Since the Chairman Rev. R. W. Wolfe and several of the brethren were detained on important business at Toronto: it was suggested by the District Superintendent that we take a short time to honor the Lord in testimony. This was enjoyable indeed. At this time the Chairman arrived and business was resumed.

A report from Brother Wolfe stated that the trip was very successful.

Minutes of last session were read and approved.

The Committee on Resolutions was excused,

The report of the Auditors was received nad accepted.

Brother Wolfe stated that definite plans were on foot to aid the District. Sr. Baker, the delegate from Toronto, extended an invitation from the Toronto, P. H. Church to entertain the 1943 District Conference. The motion

to accept was made, seconded and carried.

At the request of the Secretary, Bro. Wolfe was asked + explain the General Budget. He did so, covering all that it embraces.

The Educational and Examining boards made a joint report.

Moved and seconded to receive the report.—Carried.

Moved and seconded that Bro. R. D. Brown be accepted into this conference, subject to placing of his letter of transfer.—Carried. (Letter was placed).

Resolution Committee reported. (See resolutions).

Motion was made and seconded that the conference hear the report of Rev. A. L. McGuire concerning the General Conference which he attended at Owosso, Michigan.-Carried.

The Report was given and accepted, and enjoyed by all as he reported the glorious outpourings of God's blessings and emphasized the prevailing atmosphere of spirituality.

Motion was made and seconded to recess.-Carried.

#### FOURTH SESSION

Following the evangelistic service the session was called to order. Minutes of last sitting were read and approved.

Motion was made and seconded by the Educational and Examining Boards to re-consider the name of Rev. I. C. McIntyre previously reported third year license; To read, recommended for Ordination.—Carried.

Moved and seconded that we vote by secret ballot for District Superin-

tendent .-- Carried.

Rev. R. D. Brown was elected on the first ballot.

Moved and seconded, that the District Superintendent and the District Secretary be the editing committee.—Carried.

Moved and seconded that we elect by ballot the third member of the

District Council.—Carried.

Rev. H. W. Hobbs was elected on the first ballot.
