# CONFERENCE PROCEEDINGS

### THE FIRST SESSION

The Twenty-sixth Annual Conference of the Ontario District of the Pilgrim Holiness Church convened at 9:00 a.m., Monday, July 16th, 1951, in the Camp Meeting tent at Proton, Ontario.

Rev. Fred Wagner led the congregation in singing, "Amazing Grace" and "A Child of the King."

Sister Tanier and Brother Winger offered prayer for the Conference, after which Rev. and Mrs. Earl Bray sang a spiritual selection and medley of appropriate songs.

Rev. M. Yundt, District Superintendent, presented and introduced the General Superintendent, Dr. L. W. Sturk, as the presiding officer of the Conference.

Brother Sturk remarked on the conscientious labors of the District and General officers through the wide areas of our denomination. He stressed the importance of the Conference as affecting the work of the year and the need of much prayer.

He addressed the Conference from Psalms 85:6—"Wilt thou not revive up again, that thy people may rejoice in thee?" and entitled his address, "Revival in the Pilgrim Holiness Church". He stressed the need of revival in our own church to bring into clear focus the standards of doctrine, spirit, and practice that characterized the beginning of our history. As "Second-generation Pilgrims", he reminded us of such men as Seth C. Rees and George B. Kulp. We were warned as preachers not to get into bondage to Homiletics. This is no time for us to compromise the basic issue of Entire Sanctification with the Calvinistic emphasis of our day. The men of the Kremlin know where they're going, and the Spirit-filled ambassadors of Christ should speak with certainty amidst the confusion of our national and ecclesiastical leaders. We must have a revival to replenish our ranks and replace the casualties of the spiritual war through death, backsliding, and those captured by the Enemy. A revival will save us from either dwindling and dying, or substituting some other method of building our churches.

He stressed revival in the local church, emphasizing evangelism and not entertaining, and the calling of burdened Evangelists. Evangelism must be stressed in the Sunday School and Youth work with a Gospel adaptable to all ages. We must emhasize the spirit of Evangelism in our schools and the doctrine of Entire Sanctification in our preaching. As pastor and ministers, we must encourage family worship in every Pilgrim home by precept and example. "Little foxes" mentioned were: unbended knees, a trend to silent services, and the observing of worldly niceties in our spiritual relationships. Brother Sturk stressed that kneeling is the way for Pilgrims to pray, though other postures may be the exception. He suggested that spiritual freedom and the "Amen Corner" are a part of our heritage. As a church family it is Scriptural to use the terms, "Brother" and "Sister".

At the conclusion of the address the Secretary was instructed to call the roll. The following ordained ministers responded to the calling of the roll: J. W. Bray, May Cornfield, Colin B.

Grassie, Alvin L. Jackson, H. B. Jackson, L. W. Sturk, Irene Tanier, Florence White, Clive Winger, Moreland S. Yundt. The following ordained deaconesses were present: Jessie Walpole and Myrtle Watson. Licensed ministers present were: Earl Bray, Marjorie Pollard, Fred Wagner, Darlean Zimmerman. The following lay delegates were seated by the Conference: Durham, Mrs. Russell Jackson; Lion's Head, Julia Hoath; Massey, no delegate; Oshawa, Mrs. W. Snyder; Proton, Miss G. White; Toronto, Mrs. E. G. Rossiter.

The Conference bar was set as the three front rows across the tent.

The Examining Board reported as follows: Viva Atkinson, Marjorie Pollard, Fred Wagner, Darlean Zimmerman were recommended for renewal of third year license. C. E. and Mrs. Randall were recommended for second year license. The report was adopted, and Mr. and Mrs. Randall seated in the Conference bar.

The newly organized church at Bruce Mines was received by the Conference and the introduction of the pastor and delegate was followed by the seating of the delegate, Mrs. Betty Greene, in the Conference bar.

Conference sessions were set as follows: from 9:00 A.M. to 12:00 noon, and from 1:30 P.M. to 5:00 P.M. with an evening session if necessary. Meals would be served at 12:00 and 5:30.

The District Superintendent's report was called for and received by motion, the Conference responding with a hearty "Amen". Brother Sturk commented on the membership and the Sunday School gains as leading so far in District reports.

The Treasurer's report was called for and mimeographed copies were distributed to the Conference. After hearing the splendid report, a question was asked concerning unpaid pledges. A motion prevailed to accept the report. The Treasurer spoke about the matter of sending in Youth Project monies for the White Work in Africa and Church Extension in Florida. The motion to accept his report was carried.

The report of the Sunday School Promotional Secretary was presented and accepted by the Conference.

The report from the District Statistician was postponed until the next session.

The Resolutions Committee reported to the Conference and recommended thirteen items. Th first six resolutions offered were passed.

Resolution No. 7 was lost.

Resolution No. 8 was passed.

Resolution No. 9 was amended to read: "District Council" instead of "Camp Board". No. 9 as amended, passed.

Resolution No. 10 was discussed and left pending, with motion to adopt, until after lunch. The session adjourned by the Conference standing for the benediction pronounced by Rev. Moreland Yundt.

### SECOND SESSION

### 1:30 p.m.

Rev. F. Wagner lead the Conference in singing, "Lead Me Higher". The good spirit of liberty continued as the Conference sang, "The Cross, The Cross, The Blood Stained Cross".

The District Superintendent called upon J. R. Crites, pastor of the Church of the Nazarene, Owen Sound, and also President of The Canadian Holiness Federation, to lead in prayer.

The General Superintendent based his remarks on 1 John 2:20; "But ye have an unction from the Holy One, and ye know all things." He suggested various definitions for "unction", as a holy disposition, an inward teaching, and an anointing for service. The five ingredients of the Old Testament anointing oil, myrrh, sweet cinnamon, calamus, cassia and olive oil suggest a spiritual lubrication, an inward teaching and spiritual freedom. There are many fillings but only one cleansing by the Baptism of the Spirit. The Holy Ghost provides for the sanctified believer an inward sweetness and tenderness against the friction and rub and sourness of the world. He will warn against false teachings, and give His anointed servant enough discernment to protect himself, though not necessarily in all things. Real spiritual freedom is just being yourself in the Holy Ghost.

The minutes of the morning session were read and corrected.

The Reception Committee presented the following visitors: Rev. and Mrs. R. Gordon of the Free Methodist Church; Rev. J. R. Crites of the Church of the Nazarene, Owen Sound; Rev. W. Motoux, Wesleyan Methodist evangelist; Rev. and Mrs. C. Randall, N. Y. District; Miss Mary Mills of the Gospel Workers' Church, and student and school nurse at the Allentown Bible College; Brother Ed. Jarry, licensed minister of the Church of the Nazarene. Testimonies were heard from all the visitors with blessing and inspiration. The visitors were granted honorary seats in the Conference bar by motion of the Conference.

The Resolution Committee continued their report with further discussion of No. 10. The motion to adopt the resolution was lost.

Resolution No. 11 was amended to read, "Executive members of the District Council be District Home Missions Committee". No. 11, as amended, passed.

Resolution No. 12, passed.

Resolution No. 13 was discussed at length by the Conference, pro and con. The feeling of the Conference was that we could not avoid heavy District indebtedness in establishing a new Camp. We should make limited improvements, and seek to build up the Camp we have here, using our monies carefully and sparingly. A motion prevailed to table the resolution. The motion was carried.

. The Chairman ruled No. 14 out of order.

A resolution was offered from the floor as follows: "Resolved that the Church fiscal year be from the first of October to the thirtieth of September and we have a Workers' Convention and Conference in the third week of October. The Convention would begin on Tuesday night and through Wednesday, Thursday with the Conference on Friday. During the Convention there would be preaching in the morning. The afternoons would be for committee meetings, with preaching at night." A motion to table was carried.

The report from the Ways and Means Committee was presented. Ways and Means resolutions Nos. 1, 2 and 3 carried by motion of the Conference.

A further report from the Examining Board was read and a motion to accept was carried. Rev. A. Muir was recommended for second year license, and Mrs. J. Bray, for first year Deaconess license.

Rev. H. W. and Mrs. Hobbs were recommended for transfer to the N.Y. Oistrict.

The report of the Statistician was called for and heard by the Conference. The motion to adopt carried.

The Chairman suggested that the Conference proceed with the election of officers. We were reminded that under our Canadian charter our officers must be voted upon by the Conference.

The District Superintendent appointed Rev. F. Wagner and C. E. Randall as tellers.

The Chairman announced that the General Executive Council had nominated Rev. M. Yundt for District Superintendent.

The following officers were elected for the new conference year.

District Superintendent, Rev. M. Yundt.

Assistant District Superintendent, Rev. A. L. Jackson.

A motion prevailed to extend the time for thirty minutes.

The ballot for District Secretary showed Rev. C. B. Grassie re-elected.

The Chairman asked for nominations from the Council for District Treasurer. Mr. Ed. Rossiter, the remaining nominee after the election of Rev. A. L. Jackson to Assistant District Superintendent, was elected as District Treasurer.

The first ballot for advisory members to the District Council resulted in the election of Rev. C. Winger.

After the next ballot, a motion prevailed to vote on the three names with the highest number of votes. The motion carried.

A motion carried to extend the time until the present election is completed.

The election resulted in Rev. J. W. Bray and Rev. F. Wagner being seated as advisory members to the Council.

A motion prevailed that Rev. F. Wagner and his delegate be excused by the Conference. His request was granted.

A motion prevailed that the Conference reconvene at 7:00 P.M. for Ordination Service.

Brother Sturk adjourned the session with prayer.

### EVENING SESSION 7:00 P.M.

The evening session convened at 7:00 p.m., and the Secretary announced that the District Council had ratified the recommenda-

### tion of the Examining Board of W. Earl Bray for ordination. The Ordination Council included Rev. L. W. Sturk, General Superintendent; Rev M. Yundt, District Superintendent; Rev. C. B. Grassie, District Secretary; Rev. A. L. Jackson, District Treasurer; Rev. J. W. Bray, Assistant District Superintendent; and Rev. H. B. Jackson.

Rev. C. B. Grassie led the conference in singing, "A Charge to Keep I Have", and "Guide Me O Thou Great Jehovah", while the candidate, Rev. W. Earl Bray, was seated in front of the altar.

Appropriate Scriptures were read by Rev. A. L. Jackson and Rev. H. B. Jackson, using 1 Timothy 3, and 2 Timothy 4:1-8.

Praver was offered by the District Superintendent.

Brother Sturk based his remarks on a passage in 2 Kings 2:1-14; and spoke of the character and qualifications of a minister He reminded us that the call of God came to a busy man, plowing on his father's farm. In obeying the call he made a clean break with his old life, using the implements and a yoke of oxen for a feast for his friends The call of God necessitates burning all bridges behind us. The casting of the prophet's mantle suggests a vesting with authority, and our making God's call a voluntary service. Brother Sturk emphasized that a call to the ministry may be either a sudden impression on a growing conviction. As a voluntary service it may be necessary at times, for the God-called minister, to work with his hands, following the example of the apostle Paul. Elisha's spirit of humility was seen in the beginning of his ministry, going with Elijah as his servant, cooking the meals, and doing other menial tasks. Brother Sturk said it was better to start at the bottom of the ladder, knowing each rung on the way up, and not being dizzy at the top. Elisha coveted and obtained the double portion blessing, after being tested to the limit by the old prophet. The mantle of authority and power was proved by Elisha at Jordan, anticipating the anointing of Jesus centuries later. Elisha performed twice as many miracles as Eligah.

The Presence of the Lord was very precious as the candidate knelt at the altar and Rev. J. W. Bray, his father, led in prayer, and the General Superintendent ordained him to the ministry of the Church of God in the Name of the Father, Son, and Holy Ghost.

Members of the Conference congratulated and pledged their prayers to Brother Earl Bray, while singing, "Blest Be The Tie That Binds".

Business was resumed at the conclusion of the ordination service, and a motion prevailed to omit the reading of the minutes.

The Chairman asked the Conference to complete the district elections and the Secretary reported the Council nominations for

the Examining and Educational Boards.

The nominations of Rev. J. W. Bray to the Examining Board, and Rev. A. L. Jackson to the Educational Board, were ratified by motion of the Conference.

The report of the Committee on Memoirs was heard and received by the Conference.

The General Superintendent made a few closing remarks and excused himself from completing the business of the Conference, owing to the heavy schedule of further work.

The District Superintendent took the chair and the District Treasurer submitted the 1950 Camp-meeting Financial report. A motion carried to adopt the report.

The Resolutions Committee offered Res. No. 15, setting the annual date for the District camp. A motion to adopt this resolution carried.

A motion prevailed that the District Council approve the minutes of the afternoon and evening sessions and finish any other business of the conference. The motion carried.

A motion prevailed to adjourn the Conference, and Rev. A. L. Jackson pronounced the bendiction.

# THE REPORT OF THE DISTRICT SUPERINTENDENT

To the Twenty-sixth Annual Conference of the Ontario District of the Pilgrim Holiness Church, Greetings:

I have been honored this past year to be accounted a coworker with the Father, the Son, and the Holy Spirit in the work of advancing His Kingdom in our beloved church. The cause of the King and His Kingdom has been uppermost in my affections and efforts this past year. The Lord is evermore precious to me as we near the return of our Saviour and the abiding influence of the Holy Ghost, in my heart, becomes more real as the days come and go.

Conscious of my inexperience in the service as a superintendent I have tried to do what I thought would be the will of the Father and have tried to avoid as many mistakes as I possibly could. I have tried to be impartial and show fairness to both pastor and people in decisions in local church affairs. I appreciate the district's ministry and laity in their display of Christian charity toward me.

At this point I wish to express my appreciation to the District Council, the Home Missionary Committee, and the Campmeeting Board for their loyalty and concern for the advancement of the Lord's work within our district. They have been most considerate of me and have shown great forbearance toward me.

We have brought the year to a close without any indebtedness resting upon the district and have guarded the Lord's treasury until we now have sufficient funds to launch a new Home Missionary effort in a new field. At the close of the district's fiscal year we had \$2,693.93 on hand that are specified for this purpose. Some consideration is being given to the construction of a portable tabernacle, which if constructed, will take the major portion of this amount.

In addition to saving the above stated amount, we have also supplemented the salaries of the pastors at Durham and Thessalon-Bruce Mines. This additional financial support to these pastors, has enabled the Durham pastors to start a regular weekly prayer meeting among an interested group of people in and around Chesley, Ont. It has also made possible the organizing of a new church of eight members, including the pastor, at Bruce Mines.

For the benefit of the camp-meeting, we did some very necessary repairs on the building and on the grounds prior to the campmeeting this year. We built ten new seats for camp-meeting use with the thought that they would also help solve the seating problem if a portable tabernacle is constructed. In addition to the seats we also constructed a sectional camp-meeting platform, measuring eight feet by sixteen. All the seats, the platform, the ice box, and the new oil stoves, also purchased for camp use, are paid for.

At Oshawa the church is in the process of disposing of their old church property and buying a lot in another area on which to construct a new church.

Toronto has purchased new rugs for the platform and altar, installed a new front door and built two class rooms across the hear of their auditorium. The pastor's study is provided for in the balcony over the two rooms. They have met both of this year's mortgage payments and are slowly reducing their indebtedness.

Proton has installed a new forced air heating system with automatic temperature and damper controls that facilitates the heating of their church. At the annual meeting they voted unanimously to redecorate the inside of the church.

Lion's Head has redecorated tht interior of the church. Mr. William Bowden, one of their prominent laymen and faithful workers, is largely responsible for the beautiful color scheme and the work so neatly done.

Durham, after many lapsed payments, has consistently made every payment on their indebtedness this year. They insulated the ceiling with rock wool and decorated the interior of the parsonage.

Massey has the concrete floor and steps laid in front of the church preparatory for an enclosed vestibule sometime in the future. Rev. and Mrs. Frank Hobbs are largely responsible for this as a memorial to some of their loved ones.

Bruce Mines, the newly organized church, is contemplating building a new structure or purchasing a building originally built for a church, for a place of worship. When they get a permanent place of worship it will be known as the Melvin Pratt Memorial Church. A substantial gift, as a memorial to his sainted father, has been given the district for this church by Rev. and Mrs. William Pratt of Indianapolis, Indiana. The cash gift is now in the district treasurer's hands.

In my labours as District Superintendent, besides pastoring the Toronto church, I have travelled approximately 21,000 miles. This includes the two visits to the Michigan and California-Arizona Districts to conduch Sunday school conventions. I have visited every church and preaching point, visiting some of the churches several times on regular visits and for matters of business. In all I made thirty-five visits to the churches on the district, visiting some as often as seven and eight times. On these visits I conducted seven annual meetings, sixteen board meetings, made twenty-one visits as superintendent, and preached eleven times.

The district has been toured by a Foreign Mission deputational worker and has given liberally to both General Church Extensions and Foreign Missions.

Other duties fulfilled by me as superintendent are as follows: I toured the district with the General Superintendent, attended the District Superintendents' meeting in Indianapolis, conducted fifteen Sunday school conventions on two districts, presided at the Ministerial Convention, conducted three district council meetings, one camp meeting board meeting, two Home Missionary Committee meetings, and partially toured the district with the District Sunday School Promotional Secretary in the interests of the Sunday Schools.

The district has shown some forward movement this year inasmuch as we gained one newly organized church, 12.4% in district membership, and 8.4% in district Sunday school attendance.

My salary as superintendent and my travelling expenses for district service are paid in full.

# SUNDAY SCHOOL PROMOTIONAL SECRETARY'S REPORT

To the twenty-sixth Annual Conference of the Ontario District, Greetings in the Name of Jesus our Lord.

We praise Him for the privilege of being co-labourers together with Him, and obeying His command to preach the gospel to every creature by bringing it to the children. The Sunday School presents to us our first line of attack, and with a strong offensive here we can carry the battle for souls into the enemy's territory. This is a service in which everyone can take part, and in which all can see fruit for their labours.

This year has been one of steady plodding work rather than startling records or sensational statistics. In aiming at the ten per cent average gain for all schools and districts we have attained a district average gain of 8.4%. Six of our schools show gains of 10% or over, with the two smallest schools reaching the highest percentage gain of 23%. One school gained 3% and two showed losses of over 20%. The total district average gain was from last year's average of 312 to 339. In the month of May, during the Sunday School revival we had the highest average of 420, and on Rally Sunday there were 519 in attendance, with both Lion's Head and Massey breaking their records.

Three schools show gains for each quarter, two others had no losses in any quarter.

In citing these facts we do not bow down to the golden calf of statistics, nor emphasize the means and forget the chief end of all efforts in this field, which is to bring the boys and girls to Jesus as early as possible in their lives.

Your Secretary visited each church and conducted a Sunday School service, and met with two of the Sunday School boards. A Sunday School clinic was conducted at the Ministerial Convention, and problems discussed as discovered through a questionnaire sent to both pastors and superintendents.

The Secretary has written a Sunday School page for each edition of the Canadian Pilgrim, and has mailed promotional materials monthly to the pastors.

In driving at the Four Star program as offered by the General Department, we have discovered many problems and not too much success. The Sunday School revival and the Rally have been well worked, but in the field of Daily Vacation Bible Schools and the Lay Visitation campaign our efforts have not been so fruitful.

We are gratified at the up-surge in our urban schools, with both Oshawa and Massey making splendid gains, and Toronto making over the 10% gain goal.

It does seem to your Secretary that we must aim definitely at new schools before we can make too much headway in the way of further gains. The history of our own church points up the fact that the opening of a new Sunday School and making a favourable and friendly impression on the parents is often the thin edge of the wedge leading to a new Pilgrim Holiness Church. Each "one school" church on the district should pray and give earnest attention to the matter of opening a new school this year.

Let us remember that as God's husbandmen He expects us to work all the fields within our reach, and not just give all our attention to one small one that is conveniently near the house. Let us aim at a real ministry of evangelism in our Sunday Schools this year and leave no stone unturned to open ONE new school wherever there is only one.

Our pastors and the District Superintendent have shown a wonderful spirit of co-operation with the Secretary, and we wish to express our sincere appreciation for this. The Lord of the harvest alone knows the real story of burden and effort that make up the Sunday School ministry of some reporting in a minor key this year.

May His blessing rest upon the efforts of every Sunday School worker on the district, is my prayer.

# REPORT OF COMMITTEE ON MEMOIRS OF ONTARIO CONFERENCE

We deeply appreciate the several outpourings of the Holy Spirit in His faithful conviction of needy hearts and the refreshing of the saints. Let us rise and sing the Doxology in appreciation of God's graciousness to us.

We feel that we have been honored in having Rev. J. H. Philpot as our Camp Evangelist. He is one of God's great servants, and is a man with power in prayer and is gifted with a Spiritfilled ministry of the Word. His messages have been both searching and inspirational, and have proved to be a blessing to all who have heard him. We were also blessed with the splendid leadership of our Song Evangelists, Rev. and Mrs. Athel McCombs, who ministered to us both in song and word, and who, together with Rev. Irene Tanier, conducted interesting and profitable Children's services. Be it resolved that we rise and show our appreciation by a warm, "God bless you."

God in His providenc has given us the privilege of having our beloved General Superintendent, Rev. L. W. Sturk, with us to declare unto us the Word, and to conduct our Conference. Let us express our appreciation by a cheery, "Amen."

Inasmuch as the members of the Camp-meeting Board, Revs. M. Yundt, C. Winger, C. Grassie, and A. Jackson, who have laboured so faithfully and efficiently to plan and promote\_our Campmeeting, shall we show our appreciation by a rising vote of thanks.

We are indeed grateful to Rev. Darlean Zimmerman, Camp Matron; Mrs. Moreland Yundt and Mrs. Colin Grassie, cooks; and Camp-meeting help, for their untiring labors during the Camp. Let us express our gratitude by a hearty, "God bless you."

We wish to recognize the liberality of Young's Grocery of Portlaw, Ont., who so graciously have given us a discount on all the groceries purchased by the Camp. Let us show our appreciation by a "Thank you, and may the Lord richly reward you."

We appreciate the use of the auditorium of the Proton church for our Children's meetings We wish to acknowledge this kindness by a rising vote of thanks.

In loving memory of Mrs. Emma Mae Hoath, a charter member of the Lion's Head Church, who was born in Wiarton, Ont., in 1888, and went to her reward on January 27th, 1951. Mrs. Hoath is remembered for her faithfulness in attendance of church even under adverse circumstances. She is greatly missed by the members of the church and her friends.

# STANDING RESOLUTIONS

1. Resolved that all stationed preachers come, send someone, or pay the equivalent of two days' labour for the preparation for the District Camp and Conference, when called by the District Superintendent.

2. Resolved, that twenty-five cents be set as the fee for each examination of the Study Course, plus expense for postage and questions.

3. Resolved that each local church supply the parsonage with cooking and heating equipment.

4. Resolved, that inasmuch as the Ontario District is exempt from paying the General Budget, we recommend that we give special emphasis to the three yearly offerings for the General Church interests. These are the Rally Day offering for the General Department of the Sunday Schools, the November Self-Denial Offering for Foreign Missions, and the Easter Offering for General Church Extension.

5. Resolved, that all money raised for District Funds, be forwarded to the District Treasurer at the end of each month, and that each local church close their books after the last Sunday of each month.

6. Resolved, that the District Treasurer forward to the District paper a monthly report revealing each church's standing regarding their payment on District and General interests.

7. Resolved, that the District Superintendent appoint a Campmeeting Board each year and it shall be responsible to the District Council for the over-all management of the camp.

8. Resolved, that each pastor and the District Superintendent be granted a two-week vacation (including two Sundays) with pay. Pastors who are not on a stated salary shall receive their vacation pay and camp-meeting Sunday offerings equivalent to their average weekly offering.

9. Whereas the Manual, page 108, Section 2, reads as follows: "The annual conference shall reject any recommendation for licensing of any minister who does not tithe and teach tithing into the Pilgrim Holiness Church", therefore, be it resolved, (1) that each month the local treasurer shall forward the pastor's and evangelists' tithes to the District Treasurer and (2) that all unstationed or inactive ministerial members shall support their own denomination and local church financially.

10. Resolved, that one hundred and fifty copies of the Conference Journal be printed and sold for 25c. each. The District Secretary shall forward mimeographed copies of the Standing Resolutions to each pastor for posting on the church bulletin board, and they shall be printed in the first issue of the Canadian Pilgrim following the District Conference.

11. Resolved, that the District Council appoint an Editor of the District paper and that one page of this paper be devoted to Sunday School and Youth promotional work.

12. In the light of a laxity which appears to be growing among our people relative to standards of attire, be it resolved that our preachers call attention of our people to this danger by giving clear exposition of the Scriptures pertaining to this matter.

13. We recommend that we strengthen and consolidate our smaller churches, and after a careful and thorough survey of the field we endeavour to open one new church this conference year.

We further recommend, in co-operation with the General Program of Evangelism as adopted by the General Conference, that we urge our pastors and people to fasting and prayer on Friday of each week, for the prayerful promotion of at least one good revival in each church during the year.

14. Inasmuch as several of our schools have correspondence courses to meet the Manual requirements for ministerial candidates, be it resolved that we urge our licensed ministers to use the same in pursuing the study course.

15. In order to promote new interest for Pilgrim Youth in Ontario, be it resolved that the 1952 camp be opened with a Young Peoples' District Convention beginning Thursday evening and closing with a Saturday night Rally. The convention shall be planned by the District Council and the District Young Peoples' Executive Committee.

16. Be it resolved that the Executive members of the Council be the District Home Missionary Committee, and that said committee have full authority to appoint home missionary pastors and build or select new locations.

17. Be it resolved that the District Superintendent shall appoint the Committees which are to function under the district council for the ensuing year.

18. Be it resolved that the District camp-meeting date be set as beginning the first Thursday in July through the two following Sundays.

### **RESOLUTION COMMITTEE REPORT**

Resolution Number 1.

We recommend that standing Resolution Number 5 be amended to read as follows, "Be it resolved that all money raised for District Funds be forwarded to the District Treasurer at the end of each month, and that each local church close their books after the last Sunday of each month."

Resolution Number 2.

Whereas there is a Camp-meeting Board appointed by the District Superintndent, we recommend that the following be substituted for Number 8. "Be it resolved that the District Superintendent appoint a Camp-meeting Board each year and it shall be responsible to the District Council for the over-all management of the camp."

### Resolution Number 3.

We recommend that Number 9 be amended to read as follows, "be it resolved that each pastor and the District Superintendent be granted a two-week vacation (including two Sundays) with pay. Pastors who are not on a stated salary shall receive their vacation pay and camp-meeting Sunday offerings equivalent to their average weekly offering".

### Resolution Number 4.

We recommend that Number 10 be substituted by the following, "Whereas the Manual, p. 108, Sec. 2, reads as follows, quote, "The annual conference shall reject any rcommendation for licensing of any minister who does not tithe and teach tithing into the Pilgrim Holiness Church', therefore, Be it resolved, (1) that each month the local treasurer shall forward the pastors' and evangelists' tithes to the District Treasurer; (2) that all unstationed or inactive ministerial members shall support their own denomination and local church financially.

### Resolution Number 5.

We recommend that Number 13 be amended to include the following clause, "And that the District Secretary forward mimeographed copies of the Standing Resolutions to each pastor for posting on the church bulletin board, and the same to be printed in the first issue of the Canadian Pilgrim after conference."

### Resolution Number 6.

We recommend that Number 14 be deleted.

### Resolution Number 7.

Whereas several pastors have had difficulty raising their District Budget, and experience has proved that the monthly offering is the most successful method in paying the same, therefore Be it resolved that each local church raise its district budget by regular monthly offerings.

#### Resolution Number 8.

Inasmuch as several of our schools have correspondence courses to meet the Manual requirements for ministerial candidates, be it resolved that we urge our licensed ministers to use the same in pursuing the study course.

### Resolution Number 9.

In order to promote new interest for Pilgrim Youth in Ontario, be it resolved that the 1952 camp be opened with a Young People's District Convention beginning Thursday evening and closing with a Saturday night Rally. The convention shall be planned by the District Council and the District Young Peoples' Executive Committee.

### Resolution Number 10.

Be it resolved that no local church board endorse for Conference license anyone who is not willing to give full time to the ministry of God's Word, and that the Examining Board pass no candidate for conference license who fails to give evidence of a Divine call, or who is not willing to give full time to the ministry.

#### Resolution Number 11.

Be it resolved that the Executive members of the Council be the District Home Missionary Committee, and that said committee have full authority to appoint home missionary pastors and build or select new locations. Resolution Number 12.

Be it resolved that the District Superintendent shall appoint the committees which are to function under the district council for the ensuing year.

#### Resolution Number 13.

In view of the fact there is no probability of using the Bible School property except for camp-meeting, and the expense involved in improving the present facilities for adequate camp use would be considerable, and whereas the building and equipment are deteriorating through disuse, and whereas the 1941 Conference adopted the following resolution, quote, "Whereas the community in the vicinity of Proton has had abundant opportunity to accept the Gospel, and considerable prejudice exists, thus hindering our evangelists from reaching the unsaved, be it resolved that we endeavour to move our camp to a new location, preferably near Toronto or Oshawa". Therefore, be it resolved that the district council at their discretion be ordered to investigate the disposal of the property and assets with a view to a new location elsewhere.

### Resolution Number 14.

Whereas our District is so small, and the number of experienced ministers available is not large, we recommend that there be one lay member elected to the District Council from three nominations offered by the District Council.

### Resolution Number 15.

The Resolutions Committee offered Resolution Number 15 as follows, "Be it resolved that the District camp-meeting date be set as beginning the first Thursday in July through the two following Sundays."

# REPORT OF WAYS AND MEANS COMMITTEE

Number 1. We recommend that the salary of the District Superintendent be \$200.00 per month, of which a minimum of \$75.00 is to be paid by his pastoral charge, and the balance from the District treasury.

Number 2. We recommend that travel expense for District officials be 5c. per mile when using automobile and clergy fare plus berth when travelling by train, and meals.

Number 3. We recommend that the District Budget be \$6.00 per member, to be divided as follows: \$4.00 for District Administration, \$1.00 for Student Loan Fund, 50c. for District Camp Expense, and 50c. for General Conference Expense.

Number 4. We recommend that a remuneration of \$25.00 be paid to the District Treasurer, and \$10.00 to the District Secretary, annually.
