REPORT OF THE DISTRICT SUPERINTENDENT

To the 17th Annual Assembly of the Penna. and N. J. Dist.:

Greetings:

As we gather here for another assembly, we are reminded how fast time passes, it seems but a short time since we last met. We are another year nearer eternity and one year less of Christian activity possible.

There is much to rejoice over in the past year. God has been gracious to us in so many ways. First—He has spared all of our lives, death has not visited among our ministers. Second—He has given us the victory over sin and the enemy. Third—He has enabled some of us to win a few souls for the Master. Fourth—There is some advance among a few of our churches as reports will show.

There are also some things that we regret, some failures made, disappointments because of not having reached the goal we set as we left the last assembly, and some of us keenly felt, no doubt, our insufficiency to meet the many problems that come to us in our church life. We can but ask a merciful God to forgive us for our failures and let them be buried with the past, and renew our strength and courage for another year if God permits.

We have dedicated two new churches this year. Last fall we dedicated a beautiful church and parsonage at Hyde, Pa. Brother Hoffman is the good pastor. This church and parsonage surely speak well of progress and that Holiness has come to stay. Much credit is due to Brother Hoffman for his untiring efforts. May the Lord bless these dear people.

A small class was organized at Locus Ridge as a result of the labors of Brother Heise, a local preacher of the Hyde church. They are few in number and solicit the prayers of the District for them.

The second church was dedicated at Lock Haven, Pa. Brother Baker is the pastor. Here another beautiful building was added to the District. This is a growing church and with the enthusiastic pastor, they will march on to victory. It is easy to preach to the Lock Haven Saints.

A few pastors report additions to the District by increase in membership. We are always glad to hear we are growing and rejoice with them. It is one way of being rewarded for our labors. It is a sign of life. To report less members at each assembly is nothing to boast of. But to win men to Christ and hold them is our real business. We can succeed if we will apply ourselves properly. To stand still is to die. New soldiers must be added to the army of the Lord, and it is up to us as pastors to be "Wise and Win Souls."

As the world becomes more worldly and amusements multiply, Gospel work becomes more intricate. More HEROIC efforts must be put forth to win men to the church and God. Pastors must visit homes more than ever or be snowed under with empty pews. We must pray more, preach better and keep under the anointing of the Spirit or the world will steal a march on Him.

There are various needs in the District which have revealed themselves very forcibly to me. First—We need a strong Home Missionary program. A number of our rural churches need help. We must as a District devise a way to give it to them. We hope this assembly will consider this. We feel the pressure in our foreign missionary work is largely due the fact or the result of neglecting Home Missionary work. We are top heavy and have pushed abroad and forgotten to strengthen the home base accordingly. I believe we can remedy this by pushing Home Missions until we have a larger constituency to draw from.

We call attention to the salaries that many of our pastors receive. Many of them do not receive enough to give a fair living. There is no system. There are some who do not bother about the pastor, whether he gets little or much, and according to reports of many of our pastors must suffer. We have been urging our churches to adopt the plan suggested in the manual and go on record as endorsing and emphasizing the need of systematic giving in our church. The District Superintendent would be glad to help any church to arrange this system.

Also, our pastors need to push out into new fields. For myself, I could not be satisfied to merely "hold the fort." We should get into new locations, and work for something permanent. Do some scouting and get a line on new and open doors. We would be ready to help any of our brethren on these lines. Communicate opportunities to your District Superintendent. Perhaps he can help you.

RESOLUTIONS TO THE GENERAL ASSEMBLY

No. 1. Resolved: The general council appoint a committee of seven to classify and arrange all resolutions and present the more important ones first to the assembly. The said committee be empowered to revise those of a conflicting nature.

No. 2. Resolved: A manual committee be appointed to correct all errors, grammatical and otherwise.

No. 3. Resolved: The church covenant in all doctrinal points be retained in the manual without revision.

No. 4. Resolved: The home work be divided into five zones and that a correlated board be elected by the general assembly in which each zone shall be equally represented.

No. 5. Resolved: A ways and means committee be appointed to devise a budget system and to present the same to the General Assembly; this to be apportioned to the districts according to their membership and that each district be privileged to devise their own plan of financing the same; Home Missions receiving at least one-third the consideration of Foreign work.

No. 6. Resolved: That districts having a school or other institutions be exempt from the general budget of like institutions.

No. 7. Resolved: That only ordained preachers be eligible for ministerial delegates to the General Assembly; they having been members of the Pilgrim Holiness Church for at least two years.

No. 8. Resolved: That the delegates to the General Assembly be elected at a ratio of one ministerial delegate to seven ordained and licensed ministers and one lay delegate to every two hundred and fifty members.

No. 9. Resolved: That no new schools be opened anywhere in our Church except by consent of our General Council.

No. 10. Resolved: That we have local deaconess' license of two years, the same as the local preachers.

No. 11. Resolved: That we have a list of one hundred questions taken from each book in our ministerial course of study and that ten of these questions be selected from each list for an examination; that each licensed preacher be required to pass a written examination on each book in the presence of at least one member of the examining board or his assistant and his standing be placed in the district minutes from year to year; questions to be furnished from the general headquarters.

RESOLUTIONS OF THE DISTRICT ASSEMBLY

Resolution No. 1. Whereas much time is consumed in the reading of reports that could be used to a better advantage, be it resolved that all reports be sent into a Statistical Committee appointed by the assembly and each pastor be allowed not more than three minutes to speak of any special feature of his work.

Resolution No. 2. In order that we may be kept in closer touch with each other and the progress of the district, be it resolved that the conference year be divided into quarters and that the pastor of each church hold quarterly meetings at the expiration of each quarter, having reports read at this meeting and forwarded to the District Superintendent and that on the first Sunday of each quarter communion be observed if desirable.

Resolution No. 3. Whereas the District work is growing and many new opportunities are presenting themselves which must be properly cared for to produce gratifying results: Be it resolved that we as a District Assembly elect a man to devote his entire time to the duties of Superintendent office.

Resolution No. 4. Inasmuch as we desire a Superintendent to devote his whole time to the field: Be it resolved that all preachers of this District give 50 per cent of their tithe to his support, and that each church give him an offering in his visitation, the total amount of support to be fixed by the District Council.

Resolution No. 5. Whereas there is growing laxity among us in connection with Sunday work, be it resolved that we go on record as strictly opposed to all forms of Sabbath desecration, such as buying and selling and Sunday working, and we therefore urge our preachers to refrain from taking into their Churches anyone who habitually works for a living on the Lord's Day. Resolved that those who have Sunday workers in their churches be urged to take immediate steps in advising such to find other employment.

Resolution No. 6. Whereas it is commonly reported among us that the world is seeking an entrance into the Church, and we see the wearing of god and worldly attire in our midst which is positively in opposition to our manual, and we as a District are opposed to these things: Be it resolved that any minister allowing these things to exist in his church be dealt with according to the Manual.

Resolution No. 7. Whereas there has been in the past dissatisfaction between some churches because of receiving members in their churches who have been dismissed from other Pilgrim Holiness Churches for breach of covenant: Be it resolved that no Church Board be allowed to receive such into their Church as a member or use same in their meetings except they repent and adjust matters with the church or people they have wronged.

Resolutions No. 8. Whereas we have a number of churches who need help from the district, which, if not given, will cause them to close their doors: Be it resolved that we authorize our Home Missionary Board to use their judgment in laying plans to hold revivals and assist in reviving spiritual life, also to employ our brethren who are underpaid in these meetings. Be it resolved further that this conference adopt and urge that "Missionary Bands" be organized in each church, rates being 10c a member per month.

Resolution No. 9. In view of the fact that our District Superintendent, Brother Joppie, has so faithfully and earnestly given himself to the work of the District: Be it resolved that this Assembly give him a rising vote of thanks.

Resolution No. 10. Whereas, we as an assembly have received such gracious hospitality, such splendid dining room service, and well-selected and prepared foods, during both the Camp and Assembly: Bt it resolved that we extend a rising vote of thanks to all interested in this matter.

Resolution No. 11. Resolved that we as an District Assembly, show our appreciation to our General Superintendent, Brother Rees, for his timely exhortations, wise council, and helpful influence at this assembly, and that we express this appreciation by a rising vote of thanks.
