## **STANDING RULES OF DISTRICT ASSEMBLY**

---

### **Rule No. 1**

Each minister, ordained or licensed, shall pay fifty percent of his tithes to the support of the District Superintendent from all his earnings received from ministerial work, and all ministers failing to do so shall not, together with their families, be entertained free at our District Campmeeting.

The tithes shall be paid to the local church treasurer who shall forward them to the District Secretary with other Church funds on the first of each month.

### **Rule No. 2**

At the opening meeting of each Annual Assembly the District Superintendent shall appoint the following committees: Committee on Resolutions, Committee of Auditors, Committee on Ways and Means, Committee on Statistics, Committee on Memorials, Committee on Reception, Committee on Education and Committee on Equalization of Carfare.

### **Rule No. 3**

The carfare of ministers and delegates to the Annual Assembly shall be equalized on the basis of 1½ cents per mile, using railroad mileage.

### **Rule No. 4**

Thursday afternoon of our District Campmeeting shall be devoted to the interest of Foreign Missions.

### **Rule No. 5**

A Bible School service shall be conducted the last Sunday afternoon of our District Campmeeting.

### **Rule No. 6**

Tuesday afternoon service of our District Campmeeting shall be devoted to the interest of our Young People's Society.

### **Rule No. 7**

The first seven seats and forward shall constitute the conference bar.

## PROCEDURE OF THE TWENTIETH ANNUAL ASSEMBLY PENNSYLVANIA and NEW JERSEY DISTRICT

### Saturday Meeting, 9 a. m.

The members of the Twentieth Annual Assembly of the Pilgrim Holiness Church, convened at 9:00 a. m., July 15, 1933, in the Tabernacle of the Beulah Park Camp Ground, Allentown, Pa.

The Assistant Superintendent, R. W. Ives, and G. L. Helsby led in prayer.

The Assembly was called to order by the District Superintendent. The song service was led by W. H. Joppie, singing "Revive Us Again" and "Rock of Ages." Scripture lesson was read from John 6:15-22 by the District Superintendent after which he made special remarks on the difficulties of the times and how to meet them, emphasizing the keeping power of Jesus Christ. The chaotic conditions in the world MAY affect us BUT they need not. HE IS ABLE TO KEEP.

Business conducted:

Moved and supported that the first seven rows of seats across the Tabernacle constitute the conference bar. Carried.

Moved and supported that Philip Doyle holding local preachers' credentials, being an active pastor, be granted the full privileges of the floor. Carried.

Moved and supported that Rev. John Bradway, a minister of the Methodist Episcopal Church be granted an honorary seat within the conference bar. Carried.

He was introduced to the conference and gave a rousing testimony which was followed by the singing of a number of old choruses by the Assembly.

Moved and supported that the Chairman appoint a reception committee. Carried.

Sherwood, from the Arkansas and Louisiana District; and A. R. Brookes from the Indiana District, all of these being ordained ministers. Mrs. Floyd Baker, licensed deaconess from New York District. Carried.

Moved and supported that a resolution of condolence and sympathy be framed by a committee appointed by the chairman and that the resolution be mailed to the widow of our beloved General Superintendent, Seth C. Rees. Carried

Moved and supported that a Booster Secretary be appointed in each church to report to the publisher each month and send in one offering from the church each year. Motion tabled.

Moved and supported that we express our sincerest appreciation as an Assembly to Brother George Duell for his willing sacrifice of time and labor in preparing and publishing the Booster. Carried

A rising vote of thanks was given.

Moved and supported that we take an offering in the Monday meeting for Brother Duell to help defray the expense of printing the Booster. Carried.

Moved and supported that we return to the old method of reading and commenting on church reports. Motion lost.

Adjourned by motion 11:00 a. m.

### **Tuesday Meeting, July 18, 1933, 9:00 a. m.**

The Assembly was called to order by the District Superintendent, the General Superintendent presiding.

Rev. Frank Schweitzer led the Assembly in singing "Saviour Like a Shepherd Lead Us." The General Superintendent read a Scripture Lesson from Phil. 2:1-15. In a message to the Assembly he emphasized three words and their meaning to the Church: COMMUNION, COURTESY and COOPERATION. ## DISTRICT SUPERINTENDENT'S REPORT

To the 20th Assembly of Pilgrim Holiness Church of the Pennsylvania and New Jersey District, convening in Allentown, Pa., July 15, 1933.

Greetings: The Lord has been gracious unto us and caused his face to shine upon us, and we have great reasons to praise God for His blessings, His presence and guidance which we need so much in these strenuous times.

We want to thank God for the preservation of our lives and the precious gospel privileges we each enjoy. We are here again assembled to do business for the King. We trust that this Assembly and Camp will redound to His glory and the edification of His saints.

This has been one of the busiest years of our lives. If work could keep the enemy away he surely could not have bothered us much.

We can see some progress among us. Some of the most gracious revivals have been witnessed. People are still getting to God. He still answers prayer today. Some of our Churches have been built up, considerably, in membership. Others have gained for themselves many friends who come to worship with them.

Six new organizations have been affected the past year, some of which are very promising. One new church at Pennsville, New Jersey, another at Millersburg, Pa., and one at Pine Grove, Penna. Phillipsburg, Pa., also has an organized church. Williamsport had a good revival resulting in a P. H. Mission, which will, no doubt, soon develop into a church organization. It is encouraging to note the progress.

There is a note of progress in the district in a material way. Brother Adams of Glassboro has again enlarged his church and reports that he can now take care of a godly congregation and Sunday School.

Brother Price of Stroudsburg has also enlarged his church to accommodate the congregation and Sunday School. Other folks are talking of improving some of their property. God bless these efforts.

The Home Mission Board has given material aid to part of these new organizations as reports will show.

The Bible School had a gracious degree of success this year, though hard pressed for funds. The Lord has answered prayer and we were at least able to keep school so as to close on schedule time.

There are a few changes which I believe would be beneficial to our work in the District and would greatly help us to avoid unnecessary expense. **FIRST:** We believe a change in our Home Mission Department necessary. The nature of this kind of work often calls for sudden action, or plans may suddenly change, making it necessary for an immediate action, or plans may suddenly change, making it necessary for an immediate board meeting. This is impossible when the board is scattered as at present. It is too expensive to meet often so we recommend that the District Council appoint this board with a view of making board meetings less expensive and their getting together more accessible. **SECOND:** We believe a Woman's Foreign Missionary organization in our district would prove a blessing. We have a number of lady ministers now who would be delighted to advance Foreign interests among us. We have capable women, who are yearning to do something of this nature, who are without authority at present to step out into work of this kind. If we can have a church free from worldliness, we can have a Missionary Society free from the same. If not, why not? **THIRD:** We further believe our Young People's organization should be given our wholehearted support. This society is new to our district but we have witnessed enough of God's blessing in the past year in their gathering to know God is pleased, and my soul says Amen. **FOURTH:** Ample reasons have developed in the church the past year, and even before, that convince us a change is necessary in the stationing of our pastors. Our pastors need the protection that a godly committee can give, and the church needs the careful, discreet and godly council and direction of this sort of stationing committee. We hope this Assembly will carefully and in a brotherly way give this proper consideration. **FIFTH:** We believe the only Salvation for our School's future lies in the fact that we must completely reorganize. No district is large enough or strong enough, financially, to keep a school. We need more help; we

must enlist the service of our entire zone. In other words, we feel we should take in our other districts as partners with us. This they are willing to do, I am sure. SIXTH: We believe that if each pastor will do their best to open other Sunday Schools, look for openings to preach, visit other towns, our Home Mission Department will grow. A sister Church reports from her district over 800 additions in one year. They accomplish it by the above method.

God has signally blest us this year. There is good interest and zeal manifest. Our brethren are faithful and if Jesus tarries we look hopefully into the future feeling our God will lead. By His grace let us follow.

**PREAMBLE:**

WHEREAS the present system of stationing our Ministers has proven unsatisfactory in so many cases,

BE IT RESOLVED that the District Council, together with the General Superintendent, constitute a STATIONING COMMITTEE and

BE IT FURTHER RESOLVED that they operate under the authority granted by the Manual, Section 64, and that the word "assist" in paragraph one be interpreted to give them authority to make necessary changes, instead of merely assisting.

**Rules Governing the Committee**

Rules No. 1—During the Annual Church Meeting the members present shall vote for the return of their Pastor only, the Church Board shall nominate two other names. The Delegate to the Annual Assembly shall convey the decision, giving the number of votes cast for or against return of Pastor, and the other two names

to the Stationing Committee. The Delegate shall sit with the committee and must be at least twenty-one years of age. No-Delegate Churches may report in writing.

Rule No. 2—At all times the Stationing Committee shall consider the best interests of the Church and Pastor. They shall have authority to place anyone of the three presented to them. In the event that none of the three can be placed, they shall station the one they deem advisable.

Rule No. 3—When the interests of any member of the Stationing Committee are involved, that one shall not sit with the committee.

Rule No. 4—The District Superintendent shall announce, if possible, the appointments during the last meeting of the Annual Assembly.

WHEREAS we have our statistics published annually in the minutes,  
BE IT RESOLVED that the reading of the same be omitted in our Annual Assembly, and that each minister be allowed not more than three minutes in which to give an oral report of the work in which he has been engaged.

WHEREAS there is no provision in the Manual for absentee members' votes to be counted at the annual business meeting of the local church,

BE IT RESOLVED that no votes be accepted by mail, or otherwise, and that we strictly follow the Manual (Section 49) which requires a two-thirds vote to call a pastor.

#### Resolution No. 8

BE IT RESOLVED that we print the minutes of this assembly and that the chairman appoint a committee of two to publish them.

BE IT FURTHER RESOLVED that the minutes be distributed not later than sixty days after the Assembly.

#### Resolution No. 9

Tabled.

#### Resolution No. 10

RESOLVED that ten percent of the regular Sunday School offerings be taken from each Sunday School treasury and be appropriated as follows: Five percent for the Sinking Fund for the General Assembly expenses and five percent for Home Missionary work.

NOTE: Send all these funds through your local church treasurer to the District Secretary and he will apportion the funds in the proper way.

#### Resolution No. 11

RESOLVED that each of our churches designate one day or evening of each month as "Donation Day" for the local pastor, and

BE IT FURTHER RESOLVED that the delegates of our churches present this action to our local church boards.

**Resolution No. 12**

RESOLVED that we express our sincere appreciation to those who labored so faithfully before the Camp and Assembly to get the buildings and grounds ready for our comfort; to kitchen and dining room help for so excellently providing for and serving in feeding our physical bodies; to Brother Surbrook, our beloved General Superintendent, Brother Joppie for his patience and wisdom in presiding over the meetings of the Assembly and over the services of the Camp; to Brother Dieter for so faithfully discharging the Secretarial duties of the Assembly.
