SPECIAL MINUTE

From Monday Evening Sitting July 3, 1950

RESOLUTION #7, 1950

(General Resolution #16)

INASMUCH, as the twenty-first General Conference of the Pilgrim Holiness Church has adopted a program of evangelism to win souls and strengthen the cords of the church, and

INASMUCH, as the establishment of 200 new churches has been set as a goal for the entire denomination during the next quadrennium, therefore

BE IT RESOLVED, That we as a District Conference give our united support to this program of soul-saving and evangelism, establish goals comparable to our strength in the denomination, and begin an aggressive four-year District Home Missionary and Church Extension endeavor with the following goals:

(1) *New Churches*. At least 12 new churches should be established during the quadrennium, or three churches a year; (2) *Sunday School Scholars*. At least 800 new scholars enrolled in our Sunday Schools, or 200 new scholars a year; (3) *Average Sunday School Attendance*. An increase of at least 600 in average Sunday School attendance, or an increase of 150 a year; (4) *Prayer and Fasting*. Every pastor shall exemplify and urge his people the solemn and sacredness of intercession and physical self-denial as a requisite to the success of this program; (5) *Soul Winning*. The major emphasis in every gathering from the morning worship service to the board meeting shall be the harvesting of souls and the advance of the cause of Christ.

MINUTES

Monday Morning, July 3, 1950—9:00 A. M., A. B. I. Auditorium

The thirty-seventh Annual Conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church was opened by the District Superintendent, Rev. J. Franklin Lint.

Brother Oliver G. Holden led the Conference in singing " 'Tis So Sweet to Trust in Jesus", and "Hiding In Thee".

Brother Raymond Hoffman led in prayer.

Brother Lint presented the General Secretary of the Pilgrim Holiness Church, Rev. S. M. Stikeleather, as presiding officer of the District Conference.

Brother Stikeleather proceeded at once with the conducting of the Communion Service as provided for by the 1949 District Conference. He read Luke 22:14-20; and I Cor. 11:23-34, and made a few pertinent remarks emphasizing God's mercy on our human shortcomings and the necessity of charity in our consideration for our fellow-Christians.

The response to the invitations to come to the communion table seemed to be unanimous. The presence of God beautified the whole service.

The Chairman asked for the Roll Call. Upon its completion, he presented Rev. R. A. Beltz, General Secretary of Church Extension and Home Missions.

The burden of Brother Beltz' message was the General Conference Program of Evangelism, setting forth a revival program throughout the Church which would yield, among other advances, 200 new churches and boost our membership to 50,000. He proposed that the 200 new churches should be established through work in three fields: (1) Outside the bounds of organized Districts through the General Department of Home Missions; (2) Within the organized Districts through an aggressive District Home Missionary Campaign; (3) In communities near the Local Churches through cottage prayer meetings, Sunday Schools, and revivals promoted by the local churches.

He gave an inspiring account of how God had honored the faith of Rev. Paul H. Hollmann in pioneering the work of the Pilgrim Holiness Church in Milwaukee.

He closed his appeal with mention of Brother W. H. Pratt's new book on the life of his father, Rev. Melvin Pratt entitled "God Amid the Shadows", the proceeds from which were to go entirely for the work of missions. A good number of the books were sold immediately.

Brother Stikeleather and Brother Lint expressed the appreciation of the Conference for Brother Beltz' visit.

A motion carried that the sittings convene from 9:00 a. m. to 11:30 a. m.; 2:00 p. m. to 4:30 p. m.; and 7:00 to 9:00 p. m.

The Reception Committee presented Mr. A. L. Downey of Indiana who gave a brief word of greeting.

The sitting adjourned by expiration of time and was dismissed with prayer by Brother C. J. Reiff.

Monday Afternoon, July 3, 1950

The 2:00 p. m. sitting was opened with a song led by Brother Jester, "Sweet-er As the Years Go By".

After prayer by Brother Jennings, Brother Stikeleather spoke briefly from James 1, emphasizing the importance of patience and a right spirit in times of tribulation and stress.

The minutes were read and approved as corrected.

The Secretary called the Roll.

By separate motions carried, the District Superintendent's report on the progress of the District, and his personal report were accepted.

Two new churches were presented to the District: Jamesburg, N. J., and Rockville, Pa.; and by motions carried they were accepted by the Conference and their delegates seated.

Likewise, Brother Raymond Culp, a local preacher serving the State College-Linden Hall circuit, was granted a seat within the bar with full privileges of participation in the Conference.

The Statistician read his report which was accepted by motion carried.

A motion prevailed that the Conference send greetings to Brother and Sister Ferguson who were absent because of illness.

It was moved and seconded that the Executive Secretary of Young People report to the next District Conference on the activities of the various zones. An amendment carried calling for the publication of the past year's activities in the 1950 Conference Journal. The motion as amended carried.

The Resolutions Committee reported.

Resolution #1 was adopted by a motion carried.

Resolution #2 was adopted in the same manner.

Resolution #3 was amended by a substitute, and a motion carried to adopt it.

By motion carried the Conference adopted Resolution #4.

Resolution #5 was adopted by motion carried.

It was moved to adopt Resolution #6. An amendment carried adding another penalty clause. A substitute motion was offered and seconded.

By motion carried the time was extended 15 minutes.

A motion to table Resolution #6 was lost on the second count.

The sitting adjourned at 4:55 p. m. by expiration of time, and Brother Lint dismissed with prayer.

Monday Evening, July 3, 1950

The 7:00 p. m. sitting opened with the singing of the song, "Such Love", led by Brother William Schaffner.

After a prayer request was made for Brother Gunsalus' complete recovery from his sickness, Brother Clarence Kresge led the Conference in prayer.

Brother Stikeleather read the beautiful story of the Syro-Phoenician woman and her daughter from Matt. 15:21-28.

Brother Gorman thanked the Conference for their note of remembrance sent him a year ago during his sickness.

The minutes were read and approved.

A motion carried to dispense with the Roll Call.

Resolution #6 carried over from the afternoon sitting was referred back to the committee by motion carried.

The Conference with a wholehearted, unanimous standing vote carried Resolution No. 7, and sang spontaneously, "We'll Work Till Jesus Comes". God's blessing was especially evident upon this piece of business.

The Reception Committee presented Rev. Herbert Dongell of the Wesleyan Methodist Church and an Instructor in the Allentown Bible Institute, and a motion carried to give him an honorary seat within the Conference Bar.

The Ways and Means Committee reported.

Resolution #1 was tabled by voice vote in view of the Manual statement, Section 135, Paragraph 12.

A motion carried that the Ways and Means Committee bring in a resolution that would put the new general budget before the churches of the District.

Resolution #2 was adopted by motion carried.

Resolution #3 carried.

Resolution #4 was presented. A motion carried to defer action until the Treasurer's Report was heard.

After the Conference had accepted the auditor's report by motion carried, the Treasurer's report was adopted with a rising vote of thanks to Brother Bowman.

An effort to amend Resolution #4 was lost; and the whole resolution was lost by voice vote.

Resolution #5 carried.

Resolution #6 was offered. After a motion to amend carried, a substitute motion prevailed, and the Resolution was adopted.

A motion carried that the \$20.00 phase of Resolution #5 be carried out at once with reference to the passing of Sister D. I. McCracken.

The time was extended 10 min. by motion carried.

It was moved to adopt Resolution #7. By motion carried it was referred back to the Committee.

The Secretary read the Examining Board and Council recommendations for ordination, and a motion carried that the Conference ordain: L. Paul Bauer, William B. Derr, Charles T. Jester, and William H. Schaffner.

The sitting adjourned at 9:38 p. m. with prayer by Brother M. E. Dieter.

Tuesday Morning, July 4, 1950

The nine o'clock sitting was opened with the singing of "What a Friend We Have in Jesus" led by Brother Harold Tallman, and Brother Irvin Kratzer led the Conference in prayer.

After reading a short Scripture, the presiding officer, Brother Stikeleather gave a brief and practical message which was appreciated by the Conference.

The minutes were read and approved.

The Ways and Means Committee reported.

Resolution #7 was adopted by motion carried.

A motion prevailed to consider Resolution #5, and after a successful amendment the motion carried.

A motion carried setting the order of the day at 2:00 p. m. as election of officers.

A motion prevailed that the Secretary send to all pastors, prior to each district conference, an information blank requesting the data pertinent to his preparation for the District Conference.

Brother Stikeleather emphatically urged that all the churches circulate and use the Advocate to the full extent of their ability, and urged further that all the ministers and their wives join the Ministerial Benefit Association of the Church. He also mentioned the Pension Plan.

The Ordination Service followed with an opening song led by Brother Holden, "A Charge to Keep I Have".

Brother Raymond Hoffman offered the prayer, and the Conference joined in singing "Rock of Ages".

Appropriate Scriptures were read by Brothers Lint, Bubb, and Bowman; and Brother Stikeleather gave the Ordination Address based principally around the theme, "I Am Debtor" taken from Romans 1:14, and emphasized by a number of fitting illustrations the importance of the minister's dependence upon God in every problem of his work.

The Ordination Council consisting of Brothers Lint, Bubb, Adams, Bowman, and Campbell, together with Brother Stikeleather, prayed for the Candidates, and Brother Stikeleather gave the Ordination Charge to L. Paul Bauer, William B. Derr, William H. Schaffner, and Charles T. Jester.

After a good season of hearty congratulations by Conference members and visitors to those who were ordained, the Service closed with prayer by Brother Schweitzer.

Tuesday Afternoon, July 4, 1950

At 2:00 p. m. the sitting opened with Brother Holden leading the song, "Constantly Abiding". Prayer was made by Brother Shemelia.

At the call of the presiding officer, a number of favorite Scriptures were quoted by many of the Conference members.

The minutes were read and approved.

At Brother Stikeleather's request, Brother Lint appointed the following tellers for the election of officers: Allen G. Adams, M. R. Crissinger, William B. Derr, William H. Schaffner, Charles T. Jester, and L. Paul Bauer, with Allen G. Adams tallying at the blackboard.

Brother Stikeleather led the Conference in prayer for Divine Guidance.

On the first ballot for District Superintendent, Rev. J. Franklin Lint was elected with 95 out of 117 votes. His acceptance speech was one of courage and called for full cooperation in connection with the program of Evangelism.

The Reception Committee presented Miss Florence Sommers of Grand Cayman, an associate missionary of the Pilgrim Holiness Church.

The presiding officer appointed Brothers Whitmore, Daniels, Castevens, and Dieter to assist in sorting the ballots.

Rev. G. A. Castevens was elected Assistant Superintendent on the fourth ballot with 91 out of 119 votes.

On the first ballot, Rev. R. Lewis Adams was elected Secretary with 96 out of 115 votes. After a momentary declining of the election, he accepted the office.

The Secretary read the following Council nominations for Treasurer: Mark H. Bowman, Edward Houston, and Fred Oplinger.

Rev. Mark H. Bowman was elected Treasurer on the first ballot with 109 out of 118 votes.

A motion carried to vote for four ministerial advisory members on the same ballot. After the ballot was taken the Conference agreed to ballot for the lay member of the Council while the ministerial ballot was being counted.

On the first ministerial ballot Rev. John P. Campbell, Rev. Oliver G. Holden, and Rev. Raymond Hoffman were elected with 62, 48, and 48 votes respectively out of 95 ballots.

The ballot for the Lay Council Member resulted in the election of Irvin L. Crissinger with 74 out of 110 ballots.

A motion carried to elect the fourth ministerial councilman from the two highest minority candidates, i. e., Brother Gunsalus who received 35 votes and Brother Bubb who received 32. Rev. R. D. Gunsalus was elected with 61 out of 111 votes.

A carry-over of General Conference pleasantries was inserted by a request that "General Lee" sing "His Eye is On the Sparrow", and Brother Stikeleather proceeded to oblige to the thorough enjoyment of the Conference.

The Council nominations for the Examining Board member were read by the Secretary as follows: H. A. Saneholtz, R. C. Dettmer, and E. E. Hostetter.

While the ballot was being counted, the Secretary read the Examining Board and District Council recommendations for renewal of District Preachers Licenses as follows: Howard J. Frey, Louis D. Phiffer, Herbert W. Fisher, M. E. Dieter, Joseph H. Uhrig, Bruce N. Hall, A. A. Walls, Albert Snader, J. E. Wolfe, Mrs. Grant R. Bertolet, Mrs. Walter F. Bubb, Mrs. George E. Culver, Mrs. R. C. Dettner, Mrs. F. W. Greenley, Mrs. J. Harry Smith, and Mrs. L. W. Zehner.

The Conference granted these credentials by motion carried.

The Secretary read the Examining Board and District Council recommendations for Song Evangelist Licenses as follows: Ward F. Printz and Harold Tallman. The Conference granted the credentials by motion carried.

The Conference granting of licensed deaconess credentials was ruled out of order by the presiding officer in view of the recent General Conference action placing licensed deaconesses in the same class with local preachers.

The Examining Board ballot resulted in the election of Rev. H. A. Saneholtz with 72 out of 114 votes.

A motion carried to have three nominees from the floor for the office of District Trustee. L. L. Kerstetter, Allen G. Adams, and Fred Oplinger were nominated. The first ballot resulted in no election. A motion carried to vote for one of the two highest on the second ballot, namely: Allen G. Adams and Fred Oplinger.

While the ballot was being counted, a motion carried to extend the time to the end of business, and the Council was excused to consider other necessary Council business for presentation to the Conference.

By unanimous consent Brother J. E. Wolfe favored the Conference with a song "The Stranger of Galilee."

On the ballot for District Trustee, Allen G. Adams was elected for a term of 7 years with 82 of 112 votes.

On return of the Council, Brother Stikeleather called for the report of the Resolutions Committee.

The Resolutions Committee reported on Resolution #6 previously referred back to the Committee. It was moved to adopt the resolution. Two amendments were adopted by motion carried, and the motion carried adopting the Resolution.

It was moved to adopt Resolution #8. After the offering of an amendment, the Resolution was tabled by motion carried.

Resolution #9 was adopted by motion carried.

The Conference enthusiastically adopted Resolution #10 according to its own terms.

Brother Stikeleather expressed his appreciation for the fellowship that he had enjoyed during the Conference.

According to its own terms Resolution #11 was wholeheartedly adopted by the Conference.

The Ways and Means Committee reported Resolution #8 which was adopted by motion carried.

The Secretary read the Examining Board and District Council recommendation for a new district preacher's license for Raymond F. Culp. The credential was granted by motion carried.

The District Superintendent appointed the Committees for the ensuing year.

At 5:50 p. m. the Conference adjourned with the singing of "Blest Be the Tie That Binds", and prayer by Brother Castevens.

The minutes of the last sitting were approved by the District Council at its meeting immediately following the Conference.

STANDING RULES

1. The District Superintendent shall appoint all Committees.
2. Thursday afternoon of our District Camp Meeting shall be devoted to the interest of Foreign Missions.
3. The first nine rows of seats and forward shall constitute the Conference Bar.
4. At the close of the Conference, the District Council shall attend to any

business that may have been overlooked, and approve the minutes of the closing sitting.

5. The District Superintendent shall have a two weeks vacation annually, with pay.
6. The District Conference recommends that each church in the Conference give its pastor a two weeks vacation with pay each year.
7. The first part of the first session of our Annual Conference shall be devoted to observing the sacrament of the Lord's Supper with the presiding officer in charge.

GENERAL RESOLUTIONS

1. *BE IT RESOLVED*, That the Saturday afternoon and evening of the Camp Meeting be declared a District Young People's Rally and that the Executive Secretary of the Young People, together with the District Council, make further plans and announcements for the same.

2. (1950 No. 1) *BE IT RESOLVED*, That the Young People's Services be pre-arranged so as to appear on Campmeeting announcements, and each Zone Leader be given a night with authority to arrange the service with speaker and singers.

3. *BE IT RESOLVED*, That our District Camp Meeting shall begin on Tuesday and continue over the following Sunday; and that the District Conference shall convene on Monday at 9:00 a. m., following the close of the District Camp and continue until business has been concluded.

4. (1950 No. 2) *BE IT RESOLVED*, That our District Camp be given more publicity in the locality in which our camp is held; by radio, newspaper, large window cards; also that efforts be put forth to place markers on Union Boulevard and Maxwell Streets, and Hanover and Maxwell Streets, directing folk to the grounds.

5. *BE IT RESOLVED*, That our District Superintendent be allowed to keep the remuneration from two revivals a year, unless holding the meeting for the Home Missionary Board.

6. *BE IT RESOLVED*, That our Ordination Service be held during Conference on Tuesday at 10:30 a. m.

7. *INASMUCH*, as the Church Manual does not state an age requirement for Delegates to the District Conference,

BE IT RESOLVED, That we require Delegates to the District Conference to be 18 years of age or over.

8. *BE IT RESOLVED*, That any congregation considering the erection of a church building and/or parsonage, or the making of extensive improvements and remodeling of church property, submit their tentative plans for same to the District Council for approval before final action by the local board and the beginning of said construction.

9. *BE IT RESOLVED*, That no one, having held or is holding ministerial credentials, making application for membership in any of our churches, shall be accepted without the approval of the District Council.

10. *WHEREAS*, the District Council generally lacks the proper and necessary information relative to ministers of other Districts and denominations desiring membership in our district;

BE IT RESOLVED, That the same be required to answer a questionnaire supplied by the District Council.

BE IT FURTHER RESOLVED, That no church shall extend a call to the said minister without having first obtained the approval of the District Council.

11. *BE IT RESOLVED*, That the Executive Officers of the District Council constitute the Home Missionary Committee with authority to employ a Home Missionary and that said Committee report their activities to the District Council.

12. (1950 No. 3) *BE IT RESOLVED*, That the Conference create a Committee on Memoirs to be appointed from year to year by the District Superintendent.

13. (1950 No. 4) *WHEREAS*, the District records indicate that several of our church properties are not deeded according to the Manual,

BE IT RESOLVED, That this Conference request the local church boards of the District to check the wording of their property deeds and urge those whose deeds are faulty to have them recorded according to Section 218, paragraph 1 of the 1946 Manual.

14. (1950 No. 5) *INASMUCH*, as the responsibility of the execution of all Conference action rests primarily on its active ministry,

BE IT RESOLVED, That this Conference instruct its Examining Board to recommend for their first district licenses, only those who have had sufficient preaching experience to indicate a permanent place in the ministry, or those who have a call to, and are accepting, a pastorate.

15. (1950 No. 6) *BE IT RESOLVED*, That this Conference require the District Council to deal with those holding Credentials from our District who do not support the Conference with their personal assessments, nor send in their personal reports.

2. *INASMUCH*, as the income from the Pastors' tithe, has so rapidly increased, due to the development of the District,

BE IT RESOLVED, That we require all our ministers, who are actively engaged, to pay 50% of their tithe received from ministerial work, through the local treasurer to the district treasurer, and

BE IT FURTHER RESOLVED, That we pay our District Superintendent a salary of \$3,200 per year, and that each pastor shall raise an offering upon the visit of the Superintendent for his expenses and that the telephone, postage, and telegrams shall be paid from the District Treasury, and

(1950 No. 3) *BE IT FURTHER RESOLVED*, that 50% of the surplus of ministerial tithes over the amount required for the District Superintendent's salary, be placed in a District Parsonage Fund, and the other 50% surplus in the Home Missionary Fund.

3. *WHEREAS*, There has been no fund provided to maintain the Superintendent's Retiring and Emergency Fund,

BE IT RESOLVED, That all of our actively engaged ministers be required to pay 2% of their tithe to the said fund.

4. *RESOLVED*, That the Council be authorized to make a special appeal to the churches for funds to meet deficits which might develop in the District Expense Fund at any time.

5. *WHEREAS*, A generous gift of \$500.000 has been received by the District Council with which to establish a fund from which loans may be made to new and needy churches,

BE IT RESOLVED, That we maintain a Church Building Loan Fund. The fund is to be held in trust by the District Council, and

That 5% of the total Home Missionary Offerings be appropriated by the District Treasurer to the increase of said Church Building Loan Fund.

Loans can be made from said fund by the Council to congregations endeavoring to erect new church buildings, but only after a thorough investigation of the financial status of the congregation by the Council.

When a loan is granted, the congregation to which the loan is made shall give a note to the District Treasurer signed by the local trustees.

The principal shall be paid back in installments, with interest at 5% in advance, monthly, except that the minimum charge for interest shall not be less than 50c per month. The amount of the monthly installments shall be determined by the District Council.

The District Treasurer shall mail a statement of the amount due on the 20th of each month to each church that has a loan from said Fund.

In the event that a congregation which has made a loan according to this plan, fails to meet its installments for a period of three months, its financial standing shall be investigated by the District Council.

7. *INASMUCH*, as there is no provision to raise the funds for the delegates expense to the General Conference,

BE IT RESOLVED, That we deduct 10% from the District Expense Fund for this purpose.

8. *RESOLVED*, That each church provide the District Conference with no less than \$4.00 each for the pastor and delegate, or delegates who attend the District Conference, and

RESOLVED, That all other members of the District Conference be requested to pay at the rate of \$1.00 for each day, or for any portion thereof during the Conference sessions.

REPORTS

DISTRICT SUPERINTENDENT'S REPORT

To this 37th Annual Conference Greetings!

It is with a sense of appreciation to God for the blessings of His grace that we gather for this meeting. I had planned to report to the Conference that the hand of death was stayed from all our ministers' families. The homegoing of Sister McCracken on Sunday afternoon, June 25, makes this impossible. Sister McCracken was the wife of our Muncy pastor, Rev. D. I. McCracken, and was herself an ordained minister in our Conference. Our heartfelt sympathy and prayers are with our brother.

Revivals: With few exceptions, our churches conduct at least two revivals a year. While some of these meetings followed the ordinary trend, good preaching—good singing—good spirit, there were a few that are reported as definite soul saving meetings. New people were saved and have become a part of our church.

Churches and Parsonages: Soon after the close of last Conference, the new church at Stroudsburg was dedicated to the Lord, completed and free of debt.

A church building is under construction now at Jamesburg, New Jersey. This will be a concrete block structure.

The Delaware Run church is building a new place of worship.

The North Rome Church has decided to purchase a church building and move it to their lot, instead of building as was originally planned.

Millersburg is engaged in an extensive remodeling program that will increase the seating capacity and utility of the building considerably.

Both Cherryville and Milroy have improved their Sunday School facilities by constructing basement rooms.

Ashland built a new parsonage and accomplished the remarkable feat for our day of not spending one penny for labor. While the building is not complete in detail, it is very livable with furnace and running water. Much credit is due the pastor, Rev. Charles Jester, for his leadership and untiring labors. The Sunbury Pilgrims purchased another parsonage that much more adequately meets the need.

Bush Hollow has a parsonage under construction.

We have a total of 50 church buildings and 39 parsonages, with two churches and one parsonage under construction.

Sunday Schools and Youth: A District Sunday School and Youth Conference was held at Williamsport and Reading with Rev. Paul F. Elliott, General Secretary of Sunday School and Youth work, as the speaker. The purpose of

having the Conference in two churches was to make it accessible to more of our people.

The district is divided into five zones with active young people's rallies under the leadership of a zone representative in each.

A Sunday School Convention, under the direction of the Sunday School Committee was also conducted in all of the zones. Some of our Sunday Schools have conducted Daily Vacation Bible Schools that have proven to be a blessing.

New Churches: Rev. and Mrs. C. F. Kresge, of Trenton, N. J. started cottage prayer services about twenty-five miles northeast of their pastorate at Jamesburg. These services grew in spirit and interest, and after several months a tent was pitched for a meeting. A house was purchased and used for a place of worship. Last October the Superintendent, conducted a revival there and on Saturday night organized a Pilgrim Holiness Church with eleven members. A new church building is under construction at present.

In February of this year a meeting was held in a school house at Rockville, Pennsylvania, just north of Harrisburg. A group of people, many of whom had been members of the Pilgrim Holiness Church previously, were conducting cottage meetings and then located the school house. A good interest was manifest in the Revival with a number of seekers. The evangelist, Rev. Raymond Hoffman, conducted regular services after the revival closed. A number of our ministers preached from time to time. By action of the Council, the group was organized into a Pilgrim Holiness Church on May 30, with eighteen members.

Home Missions: The last Conference granted the Home Missionary Committee the authority to employ a Home Missionary. The committee, feeling it was the desire of the Conference to have a Home Missionary worker, took definite steps to employ the same. A contract was drawn and it appeared all would be taken care of several months ago. A delay in the plans on the part of the missionary has forced a postponement, however.

The department has given assistance to the work at Jamesburg, N. J., Quakertown, Lebanon, Bridgeton, N. J., Gloucester, N. J., and York.

Pastoral Changes: Fifteen of our churches have changed pastors the last year.

Personal Report: June 20, 1949 to June 21, 1950. I preached one hundred and sixty times and held one hundred and twenty-six board meetings, two revivals, two week-end meetings, six council meetings, four Home Missionary Committee meetings, nine annual church meetings, five special church meetings, one young people's committee meeting, one Sunday School Committee meeting, and two ministerial convention committee meetings. I attended the District Superintendents' Conference, the General Conference, A. B. I. Laymen's Fellowship meeting, two Bible School Board meetings, six Sunbury Camp Board meetings, and two Bald Eagle Valley Camp Board meetings. I conducted four communion services, presided at the Ministerial Convention, the Y. P. and S. S. Conference, and one Sunday School Convention. I dedicated one church building, and two parsonages, and organized two churches.

I have appreciated the fellowship of the brethren. You have given me the greatest consideration. Your prayers have been the source of inspiration and courage.

My contact with the Allentown Bible Institute was not only the attendance at Board meetings, to speak in Chapel, and the visits to the Special Services, but I thoroughly enjoyed being present in several classes and appreciating the work of the school at close range. I have confidence, and my wholehearted support is for the full salvation program of the Institute in training and preparing young men and women for active Christian Service.

I received for my services the following: District Treasurer \$3200; Offerings from the churches \$969.22; Revivals and week-end meetings \$225.00; and Gifts and Donations \$32.10.
