# FORWARD MOVEMENT LEGISLATION

Inasmuch as the General and District Forward Movement Committees have set Three New Churches and Seven Branch Sunday Schools as goals for the Pennsylvania-New Jersey District for this Conference year,

Be it therefore resolved that the following legislation be adopted by the Conference to implement the realization of the above goals:

First, That the Home Missionary Committee spearhead, under the Direction of the District Forward Movement Committee, the establishing of three new Churches in the District this Conference year.

Second, That the District Sunday School Board, spearhead under the direction of the District Forward Movement Committee, the starting of seven Branch Sunday Schools.

Third, That the Executive Secretary of District Youth and the Zone Leaders give continuous emphasis to these goals in the District Youth Conference and Zone Rallies, with the aim of inspiring our Young People to soul winning.

Fourth, That the pastors and church boards keep before the Churches, the Forward Movement goals of the Churches, and that a special prayer meeting be held each week in the Church or Homes for a spiritual awakening in our Churches, and for a deep passion for souls that will send us out into the over-ripened harvest field.

Fifth, That the laymen join unitedly behind the pastors and boards in promoting the soul saving effort proposed by both the General and District Forward Movement Committees.

# Conference Proceedings

# FIRST SITTING

The first sitting of the 43rd annual conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church convened in Eastern Pilgrim College's Wesley Chapel June 5, 1956 at 2:00 p. m. with District Superintendent Castevens presiding.

Reverend Kenneth Masterman led the conference in singing "Break Thou the Bread of Life." Mrs. Kenneth Masterman presided at the organ.

Prayer was offered by Reverend Walter F. Bubb, after which Brother Masterman thrilled hearts with a special number, "The Love of God."

Reverend G. A. Castevens then introduced Reverend Melvin H. Snyder, First Assistant General Superintendent of the Pilgrim Holiness Church, and now full-time assistant in charge of the Fcrward Movement. Brother Snyder spoke feelingly of God's providences that had bereft the denomination of the late General Superintendent L. W. Sturk and had detained the present General Superintendent, Reverend William H. Neff from attendance at this gathering. He then read several portions of scripture found in I Corinthians, chapters one and two, and chose I Corinthians 1:18 as his text.

Using "The Centrality of the Cross" as his theme, Brother Snyder emphasized the fact that if the Pilgrim Holiness Church is to have a Forward Movement, we must produce a denominational ministry that will major on the central truths of the Bible. He indicated that the cross of Christ and the Christ of the cross have a vast significance and drawing power—that the cross not only speaks of the awfulness of sin but portrays the spotless holiness of God, the peace of God, the Love of God, the Power of God, the wisdom of God, and divine insistence on separation from the world.

Scripture lessons significant to the Sacrament of the Lord's Supper were read from Luke 22:14-20 by Harold R. Crosser and from I Corinthians 11:23-34 by G. A. Castevens.

In remembrance of our Lord's death and in anticipation of His second coming, Communion was served to 150 officers, ministers, delegates and friends of the conference. God's presence was keenly felt and appreciated. A sweet spirit of holy oneness prevailed. The service closed with two stanzas of "There is a Fountain Filled with Blood."

The first business session was called to order by Assistant General Superintendent Snyder at 4:05 p. m. following a brief recess. Brother Snyder offered prayer for Divine guidance.

The bar was established according to Standing Rule 1 and the roll was called.

The District Secretary read the names of ministerial transfers that had been approved by the District Council. A motion carried to accept the following into full conference relations: ordained ministers, J. A. Byrd, Donald Pownell, Mrs. W. E. Honeycutt, George Lup, Margie Morris, P. R. Doyle, Birdsal Bell; licensed minister, James C. Brillhart; and ordained deaconesses, Rae Gale Pownell, Mrs. Susan Lup, and Jennie Griffis.

Rev. George Lup of the Quaker Garden Church was introduced to the conference. He was welcomed with a hearty amen.

The sitting adjourned by expiration of time. The dismissal prayer was offered by Reverend Frank H. Schweitzer.

### SECOND SITTING

The second sitting of the 1956 conference came to order with Reverend Kenneth Masterman leading the congregation in singing "My Burden is Gone." Reverend Edgar Haskins accompanied at the organ.

Reverend Mrs. Russell Lutz led in prayer.

The minutes were read and approved by motion.

A motion passed by the Conference ratified the list of proposed ordinands as recommended by the Council. This list included Charles H. Sorrells, William Miller, Charles L. Cooper, and Robert N. Campbell.

Reverend G. A. Castevens, District Superintendent, read an outstanding report indicating that there had been good progress in every phase of the District effort. A motion carried that this wonderful report be accepted with a rising vote of thanks. The conference spontaneously and enthusiastically showed its appreciation.

The report of the Assistant Superintendent Reverend Edward T. Houston was accepted by a motion that carried with a hearty "Amen."

A hearty "Praise the Lord" signified Conference approval of the report read by the Promotional Secretary of Sunday Schools, Reverend E. S. Rutherford.

Acceptance of the report of the Executive Secretary of Youth, Reverend Howard J. Frey, was indicated by motion passed with a hearty "Amen."

The Auditors' Report was read by Reverend William Derr, Committee Secretary, and approved by motion.

District Treasurer M. E. Dieter's financial report was accepted by a motion that expressed sincere thanks for his splendid piece of work. The motion was formally passed with a "Praise the Lord."

The Presiding Officer spoke about the wholesomeness of setting goals. He encouraged the Conference to place holy challenges before its constituency and indicated this practice had motivated great soul winners and soulsaving agencies in the past. Reverend Edward T. Houston spoke words of deep appreciation for the help given to him and to the Stroudsburg Congregation by the district and the denomination after the tragic flood last Summer.

Dr. R. D. Gunsalus, President of Eastern Pilgrim College, spoke on the current program of expansion adopted by the college board of directors and expressed gratitude for generous support given by the district to the Share Campaign and the budget.

The Home Missionary Committee Report was read by Secretary E. E. Hostetter. A motion to accept this report was passed with a hearty "Amen."

A motion carried that Statistician Reverend E. L. Adams read the numerical totals and post his report.

By motion it was decided to extend the time until all reports have been completed.

A motion to accept the Statistician's Report carried with a robust "Amen."

Attention was given to the significant fact that the Conference had enjoyed a  $4\frac{1}{2}$  percent gain in membership.

Reverend Floyd Fehr of the Pittsburgh District was presented by the Reception Committee. After his testimony the conference voted to grant him an honorary seat in the conference bar.

The sitting was adjourned by expiration of time after announcements and several clarifications of committee policy and activity. Reverend Walter F. Bubb dismissed with prayer.

### THIRD SITTING

The conference convened with the singing of "I Will Fraise Him," under the leadership of Assistant District Superintendent Houston. Previously, a local press photographer had taken pictures.

Gods presence was very real as delegates and ministers freely responded, at the suggestion of the Presiding Officer, with favorite verses of scripture.

After prayer by Brother Houston, "Take the Name of Jesus with You" was sung, and a spirit of praise seized the gathering as several score testified to the glory of God.

A motion carried that the Secretary complete the roll by observation.

The minutes were approved by the Presiding Officer after the correction of Sister Lutz's first name.

The new churches at Quaker Garden, N. J. and Bethlehem, Calvary, were presented by District Superintendent G. A. Castevens.

Representatives of the Quaker Garden Church were introduced, and this congregation was enthusiastically received by motion and a standing vote.

Representatives of the Calvary Church were introduced in their turn and were received formally by motion and a standing vote.

In gratitude to God for these two new congregations the Assembled delegates and ministers said a heart-felt "Praise the Lord."

Brother John P. Campbell, interim pastor, gave an oral resume of the organization and the continued progress of the Calvary Church.

New District licentiates as recommended by the Examining Board and the District Council were received into the conference by motion. As a result of this action, Eugene Michael, Jr., Vernon W. Price, Edgar H. Eckley, Arthur E. Yeager, and Irwin Miller received first ordination and were asked to come forward for the ordination service.

After a short recess, the ordination service began with the old song, "A Charge to Keep I Have." Prayer was offered by Harold Crosser. Appropriate scripture lessons were read from the New Testament by Brothers Castevens, Houston, and Dieter.

As a basis for his charge to the ordinands, Assistant General Superintendent Snyder read I Timothy 4, highlighting the verse, "Take heed unto thyself, and unto the doctrine; continue in them; for in doing this thou shalt both save thyself, and them that hear thee." He averred that ones self represents a man's first responsibility and a man's greatest problem. Pointing out that "people will remember what you were longer than what you said," he urged the candidates to practice holy humility and to seek spiritual success. This success will not pivot on the byproducts of salvation but on the preaching of the irresistible doctrine centering in Jesus the crucified. The message was climaxed with an admonition to persevere in the holy conflict despite the buffetings of an evil world, Satan, and circumstances.

The Ordination Council composed of Reverends Melvin H. Snyder, R. D. Gunsalus, G. A. Castevens, E. T. Houston, Harold R. Crosser, M. E. Dieter, and John P. Campbell performed the solemn rite of laying on of hands.

God's presence characterized the gathering as the newly ordained ministers, Robert N. Campbell, Charles H. Sorrells, Charles L. Cooper, and William Miller, were congratulated by ministers, delegates, relatives, and friends.

President Gunsalus of Eastern Pilgrim College dismissed with prayer.

### FOURTH SITTING

The fourth conference sitting convened promptly at 2:00 p.m. Brother Masterman led in singing, "Near the Cross" after which Reverend Elmer Hocking prayed.

Minutes of the last sitting were approved by motion as read.

#### PILGRIM HOLINESS CHURCH

The Presiding Officer, who is the Chairman of the General Forward Movement Committee, spoke on the evident leadership of the Holy Spirit in this matter. He emphasized that we must revive or die. His report of the Forward Movement Rallies indicated that a third of the denominational membership was in attendance. Brother Snyder affirmed that we cannot go farther until we go deeper.

Forward Movement Legislation coming from the Council was read by the District Secretary. A motion carried that these Forward Movement proposals be adopted in toto.

Brother and Sister Robert Smith of the New York District were presented to the conference and gave their testimonies. A motion passed that they be granted honorary seats within the bar.

Brother C. E. Wert gave a word of explanation concerning the maps in the vestibule.

Brother Castevens spoke words of commendation for Reverend Charles Lewis' artistic presentation of the Forward Movement. A motion of appreciation by the conference was passed with a rising vote of thanks and a "Thank God" for this use of talent in the cause of holiness.

The chair called for the report of the Resolutions Committee. The Secretary of the Committee read Resolutions I through VI.

It was moved and seconded that we adopt Resolution Number I. A substitute motion was made and seconded that "the second Sunday in April be the deadline for the call pastor meeting." The motion to substitute was lost. Resolution number I carried. (See Report of the Resolutions Committee).

After Resolution Number II was read the second time it was moved and seconded to adopt it. A substitute motion was offered. The motion to substitute was lost. The Resolution was amended to read "And that the pastor's name and address be placed with the directory of churches rather than with the Minister's report in the statistical tables." The amendment carried and Resolution Number II as amended was carried.

Resolution Number III was read and put before the conference by motion. The motion was amended and the amendment carried. A substitute motion stating that, "It shall be a conference procedure under the direction of the District Secretary to distribute appropriate blanks for a listing of the various church officers and that this data be distributed among the various official personnel of the conference" was moved and seconded. The motion to substitute carried as well as the substitute motion.

Resolution Number IV was put before the Conference by motion. An amendment "and that such payments shall be made from the retirement and emergency fund" was carried. Resolution Number IV as amended was passed.

By motion the time was extended 25 minutes.

The Chair ruled Resolution Number V out of order.

It was moved, seconded and carried to adopt Resolution Number VI. We were dismissed with prayer by Brother Edgar Haskins.

### FIFTH SITTING

The last session of the Conference convened with Oliver G. Holden leading the song, "I Shall Be Like Him." V. G. Gattone led in prayer.

Minutes of the fourth sitting were approved by the Chair as read.

A motion that a message of greeting be sent General Superintendent Neff was passed with a hearty "Amen."

Ways and Means Secretary John A. Gangaware reported for that committee by reading Resolutions I through III.

Ways and Means I. (See report of Committee) carried.

Ways and Means II was moved, supported and carried.

Ways and Means III was adopted by motion carried.

The Resolutions Committee reported again through its secretary. Resolution VII was passed by an "Amen."

The Memoirs Committee Report was read by the Committee Secretary, Clifford Berry. After silent tribute to the memory of departed saints, the presiding officer led in prayer.

John R. Clough, Leroy Fetterolf, Daniel L. Gehman, Frederic Newton, Leonard Shiley and William Thurston were recommended by the Examining Board and District Council for ordination next year providing their spirit and practice in the intervening time conform to the spirit and practice of the Pilgrim Holiness Church. The Conference adopted the recommendation by motion. A motion also carried that preliminary recommendation for ordination as a deaconess be accorded Mrs. Marie Horwath.

A motion carried that recommendations of the Examining Board and the District Council for the renewal of District License be approved. The list as read to the Conference follows:

Curtis Blimline, Pearl Clauser, John Clough, Mrs. George Culver, Walter Dill, Leroy Fetterolf, George File, Mrs. Milton Frantz, Daniel L. Gehman, Edwin Mayes, Mrs. Edwin Mayes, Frederic Newton, Mrs. Frederic Newton, Leonard Shiley, William Thurston, Robert Williams, David Wooten, Miss Emma Yoder, Mrs. L. W. Zehner, James Brillhart, Mrs. D. I. McCracken, Claire Ulmer, Burton B. Balliet, Kingsley Yauger, Donald Moyer.

The next order of the day was the election of officers. After kindly admonition from Presiding Officer Snyder, he led in prayer and invoked divine guidance. The list of tellers as appointed by the District Superintendent was read. The first ballot for District Superintendent produced the election of Reverend G. A. Castevens for a two year term with 97 of 126 votes cast.

Reverend Edward T. Houston was elected Assistant District Superintendent on the second ballot with 96 of 127 votes.

Nominees from the Council for District Secretary were read as follows: Albert Massey and Harold R. Crosser. Harold R. Crosser was elected with 120 of 127 ballots.

A motion carried to extend the time until the completion of all business.

M. E. Dieter, John P. Campbell, and E. S. Rutherford were presented to the Conference as nominees for District Treasurer. Brother Dieter withdrew his name because of the pressure of many duties. By motion the Conference expressed appreciation for Brother Dieter's past work by a rising vote of thanks. The third ballot for Treasurer produced the election of E. S. Rutherford with 107 out of 126 votes cast.

Five names were then placed on each ballot for the five Advisory Council members. While the votes for advisory members were being tallied, the Chairman declared a short recess. After the Conference convened the Chairman spoke briefly about the **Advocate**, the General Budget, and the new Sunday School literature.

There were 122 votes cast for Advisory Council members. Reverends Albert Massey and R. D. Gunsalus were elected with 72 and 65 votes, respectively.

The Chair ruled that three of the six highest names not receiving a majority on the first ballot, should be placed on the second ballot. The names of C. E. Wert, John P. Campbell, Walter F. Bubb, M. E. Dieter, L. W. Chappell, and Raymond Hoffman were used in the balloting for the three remaining Advisory Council members.

The District Superintendent announced the first Youth Conference to be held at Bethany Camp, Bowmanstown, Pennsylvania, July 21, at 2:00 p.m.

On the second ballot for Advisory members to the Council, C. E. Wert and M. E. Dieter were elected with 77 votes each and John P. Campbell with 65 votes.

The District Secretary read the nominees for the Examining Board: C. F. Kresge, Howard J. Frey, E. E. Hostetter. While this ballot was being counted M. E. Dieter, Assistant to the President, spoke on the Eastern Pilgrim College student procurement program. C. F. Kresge was elected to the Examining Board with 58 out of 115 votes.

A ballot was prepared for a three year term on the Home Missionary Committee. The nominees were C. F. Kresge, Walter F. Bubb, and Alvin Jackson.

E. S. Rutherford, Promotional Secretary of Sunday Schools, presented Sunday School awards to the Allenwood School for the highest percentage gain (J. Lamont Johnson, Pastor) and to the Allenwood, Harrisburg First, and Bridgeton schools for the largest numerical gains (J. Lamont Johnson, Charles H. Sorrells, and P. W. Braisted, pastors).

There was no election on the first or second ballot for the Home Missionary Committee. The two highest, Walter F. Bubb and Alvin Jackson, were used on the third ballot. Brother Bubb was elected with 54 out of 102 ballots.

A motion carried to amend Standing rule number two so that Conference sittings will be held from 8:30 a. m. to 11:30 a. m.; 1:30 p. m. to 4:30 p. m.; and 6:30 p. m. to 9:00 p. m.

By request of the Resolutions Committee the District Superintendent expressed appreciation to all who had helped make the Conference a success.

His motion that the Conference express thanks to Brother Chappell for his service rendered on the District Council carried with a rising vote.

The District Superintendent's motion carried that we rise and express appreciation to our capable and efficient Chairman with a hearty "Amen."

A rising vote of thanks was also given to E. E. Hostetter, Miss Margurite Carr, the culinary staff and dining room corps.

Assistant General Superintendent Snyder then expressed his delight with the aggressive attitude of the district and the college. He exhorted the Conference to extended areas of usefulness, and requested prayer for divine direction in his leadership of the Forward Movement.

A motion to adjourn carried at 10:51 p.m. and the Conference closed with the Doxology and prayer by the Presiding Officer.

# Conference Reports

## REPORT OF THE DISTRICT SUPERINTENDENT

Through the unbounded providence of our Heavenly Father, we are again favored to meet in the capacity of another Annual Conference. And, we are grateful for the privilege of convening this forty-third Conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church on these spacious grounds of Eastern Pilgrim College. On this occasion I extend greetings and a warm welcome: first, to our presiding officer, First Assistant General Superintendent, the Rev. Melvin H. Snyder and to the delegates and friends assembled.

It is proper to state that we sincerely regret that our General Superintendent, the Rev. William H. Neff was forced to change his schedule, because of illness, and was unable to be present for our Annual Conference. However, we are assured of efficient chairmanship in our presiding officer. Let us join in fervent prayer for the speedy recovery of our General Superintendent. It would be most fitting for this Conference to send him greetings and assurance of our interest and prayers.

I am pleased to report that amidst the problems confronting Kingdom building, progress has been made on both the General and District level. Progress in the General Church is evident and highlighted by the launching of the great "Forward Movement" in the Pilgrim Holiness Church. Each step taken to further this spiritual awakening is witnessed to by additional pentecostal effusions. This was repeated in the May meeting of the General Board when Rev. Melvin H. Snyder was employed by the General Board as an all-time Assistant General Superintendent. He was also installed as the chairman of the General Forward Movement Committee, and is responsible in furthering the Forward Movement throughout the Church. On this occasion, Gcd again made known that we were in Divine Order by another reanointing of the Holy Spirit.

On instructions from the General Board, the District Council will serve as the District Forward Movement Committee. Also, upon ratification of the goals set by the General Forward Movement Committee, the General Board set goals for each Conference. These goals have been set up on the District level and will be presented to the Conference. For your convenience mimeographed copies have been prepared for each delegate.

Permit a word of exhortation. Every one of us, ministers and laymen, MUST get wholeheartedly behind this Spirit-approved movement in our Zion. Not to do so is to jeopardize that which God is doing in our midst. Personally, I am one hundred per cent in favor and behind this spiritual awakening that the Lord is bringing to our Church.

God grant that we shall have such a pentecostal re-anointing that to stay within our four walls will be an utter impossibility. God grant that the ministers and laymen of the Pennsylvania-New Jersey District will experience such a tremendous re-birth of soul passion that will turn our prayer meetings, Sunday Schools, and regular services into dynamic agencies of evangelism, until the cry of new born souls will become the usual in our Churches. Is it too strong to state, to have less than this is to be classified as non-pentecostal? This, I am sure, none of us desire.

According to reports available, progress has been made on the District this Conference year. Spiritually, the Pilgrims in our Conference are sinking their wells deeper in God's grace. Growth spiritually cannot be computed mathematically. But on my visits to the Churches, I am impressed by the evident hunger to know Christ in the power of His resurrection and the fellowship of His sufferings. Repeating one of the inscriptions on the Forward Movement posters,—"Spirituality is the key to progress."

From tabulations of reports reaching my office an appreciable increase in membership over the past five or six years is indicated. Approximately one hundred and forty-two additions are recorded. This should show a gain of about one hundred members. Two new Churches will be presented at the proper time to this Conference. Our new Church at Quaker Gardens, New Jersey, will be received with seventeen members. We are grateful to Rev. George Lup in bringing this group into the Pilgrim Holiness Church. They have a comfortable basement Church. Brother Lup, feeling that the Church needed a younger man to pastor the flock, requested the superintendent to send them a pastor. This request I complied with in the person of Rev. John Robert Clough, Jr. Brother Clough was given a call to the Church and is doing a very commendable job. A hearty welcome to these fine folk into the fold of our Conference.

Calvary Pilgrim Holiness Church was organized by the District Superintendent in John Wesley Chapel in January. On that occasion thirty-three members were received into membership. On Mother's Day, which was the deadline for charter membership, fifty-one members were recorded. Rev. John P. Campbell has been serving acceptably as paster. On May 27, Rev. Allen Clark was unanimously called to pastor Calvary Church. In the near future, he and his family will be moving into the nice brick parsonage, recently purchased at 1236 Club Avenue, Allentown. Negotiations are under way to acquire lots in the vast housing project—Midway Manor, located just across the Allentown-Bethlehem city limits. This type of organizing new churches should be duplicated all over this Conference. These new housing projects present us with unlimited possibilities. This type of expansion should not only be the concern of the Home Missionary Committee and the District Council, but should receive the keen attention of each pastor, who in turn should endeavor to interest his church in mothering a new church in these new housing projects.

The Church at Gloucester City, New Jersey, has purchased an adequate parsonage at a cost cf \$4,500.00. It was an exceptional buy.

Checking the goals set last Conference for soul winning and membership increase revealed that two of our Churches reached or went over their goals without reporting any losses in membership. Leading in this respect is the Highland Church pastored by Rev. and Mrs. Frederic Newton. God visited this Church with a gracious revival, and they received nine members into fellowship. Their goal was five new members. The Church at Jersey Shore reached their goal of five additions. This Church was pastored by Rev. and Mrs. D. I. McCracken. Jamesburg Church, pastored by Rev. and Mrs. C. F. Kresge, made their goal of five additions and reported a gain of four in membership. Allenwood Church, pastored by Rev. and Mrs. J. L. Johnson, leads in receiving the highest number of members into fellowship during the year. Thirteen additions were received which gave them a net gain of eleven. During the calendar year of 1955, the Allenwood Church added twenty-two members. With a number of the other Churches nearly making their goals, I am persuaded that the Lord is pleased with this type of legislation.

Receipts for both General and District interest reached an all-time high mark. Total giving to the General Church amounted to \$37,858.48. This exceeds last year's giving to the amount cf \$3,138.50. Out of the total giving to the General Church interests, Foreign Missions received \$24,819.33. Of special interest, it is noted that the total disbursements to the General Church equals about four times the amount of our General Budget. Total receipts for the District amounted to \$54,360.31. Giving to District interests amounted to \$92,218.79. Last Conference receipts for the same interests amounted to \$83,006.28.

On March 18, a ground breaking service was held on the lots at Levittown. These lots, which were donated by Levit Brothers are about two acres in size, and are evaluated at about \$8,000.00. In order to retain these lots, construction work had to be under way within a year from the date on the deed, otherwise the lots would revert back to the doncrs. About the first of May the Building Committee, appointed by the District Council, issued crders to begin the first unit of the Church plant. This unit is the Sunday School building, which will serve for both Church and Sunday School purposes. The building is of brick veneer construction. Its dimension is forty by seventy feet. When completed it will be an asset to the District and entire Church. The estimated cost is between fifteen and eighteen thousand dollars.

Too much credit cannot be given to Rev. William B. Derr, your home missionary in Levittown. He is working day and night on the building. He is time-keeper and pay-master. Brother Derr has prepared a poster of photographs so that we may see the progress of the building now under construction. If we could realize a hundred per cent of the District Budget, and the same relative to the Special Home Missionary allocations to each Church, the financial burden would be much lighter in the kind of work being sponsored at Levittown by the Home Missionary Committee and the District Council.

This Conference year did not pass without its tragedies. During the annual campmeeting at Sunbury, Rev. J. E. Wolfe was hit by a passing car while crossing the highway to his home. A short while later he was called home to be with his Lord. Brother Wolfe was a licensed minister in this Conference. For many years he did acceptable work in the Home Missionary field. A number of Churches are the result of his efforts. Many miles were covered on foot in Kingdom interests by this servant of the Lord. He is now with his Lord, and due reward will be compensated to him by the Lord of the Harvest.

On August 18, past, an unprecedented flood sent the placid Broadheads Creek at Stroudsburg roaring out of its banks. Caught in the wake of this devastating flood was our fine church and parsonage. Damages to the Church property amounted to about \$16,000.00. But the greatest loss was that of the Arnt family who were drowned when their home was completely demolished. Through all these trying circumstances, the pastor Rev. E. T. Houston proved to be a faithful and courageous shepherd. Our Pilgrims there also proved faithful through all the hardships. Within three months the Church was restored and redecorated. In fact, it is more beautiful in appearance than before the flood. They have suffered quite a loss in Sunday School attendance, but under the aggressive leadership of their pastor, this loss I am sure can and will be overcome. New additions to the Church enabled them to report the same in membership as last year. God bless the Church and pastor at Stroudsburg, and give them the greatest year in the history of the Church.

It has been my high privilege to observe Eastern Pilgrim College at close range. Spiritually, the College has had one of its best years. Pentecostal outpourings have repeatedly been experienced by faculty and student body. It was my pleasure to be in at least two of these times of refreshings from God's presence. Spiritual demonstrations were equal to anything seen in the yesteryears. The student body has been one of the most matured ever to attend the College. The enrollment reached the gratifying number of 314. Plans are now under way to launch a city wide campaign to raise funds for a boys' dorm, which is so badly needed. Let us all get back of this drive with our prayers and do all we can to see this campaign a success for God's glory and the training of young men for Gospel work. Dr. R. D. Gunsalus and the unexcelled faculty are giving their best in the training of our youth to serve this Age. The College is very deserving of our prayers, and moral, and financial support. Let us not fail our College.

The report of the Home Missionary Committee will be given by the Secretary, Rev. E. E. Hostetter. Rev. E. E. Rutherford, the efficient Secretary of Sunday Schools will report on the activities of the District Sunday Schools. Rev. Howard J. Frey, who has rendered acceptable service as Executive Secretary, will bring in his report to the Conference, the endeavors of the Youth Societies.

My personal report follows: Times preached 171; visits to Churches 115; church board meetings 77; annual meetings 32; pastoral call meetings 2; District Council meetings 15; ccmmittee meetings 22; revivals on and off the District 2; week-end meetings 4; dedicatorial services 2; Eastern Pilgrim College directors' meetings 2; communion services 1; children dedicated 7; District Sunday School rallies 4; churches crganized 2; marriages 1; camp board meetings 5; regional camp meetings organized 1; Forward Movement Rallies 4; and ground breaking services 1.

I have traveled approximately 26,120 miles in the interest of the Lord's work. About 19,578 miles was in the interest of the District. I presided at the District Camp, the Ministerial Convention, attended the Church Leaders' Conference in January, and the General Board meeting in May. My salary from the District is paid in full. Offerings from revivals and week-end meetings have amounted to \$675.00. To date I have received \$983.30 for travel expense.

#### PILGRIM HOLINESS CHURCH

In concluding this report, permit me to express my deep gratitude to an understanding and faithful District Council, to a very godly group of ministers and wives, and to nearly two thousand faithful laymen for their personal considerations. I wish to thank them also for their untiring efforts which have made humanly possible any and all progress this Conference year. But all honor is due my ever-present Lord who has given me health, strength, and preservation in performing the work this Conference year.

With end-time signs prevailing throughout the world, and the return of our Lord near, it is no time to be quibbling over incidentals, but to rise to the tremendous challenge of making Christ known to every soul possible, so that they may be gathered safely into the fold before the storm of God's wrath breaks upon an unsaved world. God grant that the Pilgrim Holiness Church and the Pennsylvania-New Jersey Conference shall meet the challenge in HIS NAME. Amen.

# REPORT OF THE PROMOTIONAL SECRETARY OF SUNDAY SCHOOLS

To the Forty-third Annual Conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church—Sunday School Greetings:

The curtain has fallen on another year of activity for the Sunday Schools and their leaders of our great Conference. What is written is written. In fact, five Sundays of the new year are now history. This has been another year of gain—the seventh in succession. The gain is small but it brings us a little nearer to the goal of 4000 for average attendance set by my highly esteemed predecessor. The average Sunday School attendance for the year 1955-56 was 3913, showing a gain of 52 over the previous year.

Tragedy left its cruel effect upon the largest of our District Sunday Schools this year. Our work in Stroudsburg, Pennsylvania was severely hindered in its operations. Besides the loss of life and property, a large number of scholars began attending other Sunday Schools during the time that services were not held in their own building. The entire Pilgrim Holiness Church admires the optimistic attitude of Pastor and people and the way they set about to restore the beautiful sanctuary and parsonage back to their former state of usefulness.

The Reverend Edward T. Houston was appointed Promotional Secretary for this year. Due to the increased responsibilities upon him, he asked to be relieved of that post. This work fell to us during Labor Day week-end making it impossible to attend the Sunday School Leaders' Convention which convened in General Headquarters a few days following the appointment.

Our first task was to continue the plans already laid for a series of Conventions which were conducted in different areas of our work with Mrs. Louise Lynn, Muncie, Indiana, as the speaker.

We wish to recognize the following leaders in numerical gain for the year. Allenwood 28; Bridgeton 28; Harrisburg First 28; Coleville 23; Pocono Lake 20.

The high five in percentage gain likewise are listed: Allenwood 44%; Erma 40%; Bridgeton 39%; Lebanon 32%; Harrisburg First 31%.

Other schools eligible for the Blue Ribbon award are: Lehighton, Shillington, Highland, North Rome, Jersey Shore, Williamsport, Coleville and Pocono Lake.

We welcome two new schools, viz. Quaker Gardens and Calvary. We want to give special attention to the goal set last year for Branch Sunday Schools. I quote from the report of the Promotional Secretary of last year, "Five Branch Sunday Schools this year should be a minimum goal as we go onward in this holy effort." We are all so happy to know that this goal was reached! Praise God! Five Branch Schools were opened since we last met in Conference.

A very interesting and profitable contest was conducted during the Sunday School Revival from Easter to Mother's Day. The schools were divided North and South of a Mason-Dixon line and reported weekly their attendance. Two members of the District Sunday School Board served as leaders in their fields, Rev. E. T. Houston led the great Union army on to final victory and The Rev. Paul Braisted gave competent guidance to the Southern forces who staged a real battle before they were finally subdued. A goodly number of conversions were reported during the Revival period.

A complete report is not available for the teacher training classes, Bible clubs, Vacation Bible Schools, Junior Church Services, and other fields of endeavor to win the lost through our Sunday Schools and their related agencies in the Church. THE FORWARD MOVEMENT IS ON. TO THE BATTLE BRETHREN. LIFE UP YOUR EYES ONCE MORE. THE NEED IS GREAT; THE OPPORTUNITIES ARE LIMITED; THE DAY IS DARK; THE NIGHT IS AT HAND—BUT MERCY'S DOOR IS OPEN. BRING THEM IN.

An aggressive, non-relenting, persevering program must be the order of the day. There is no short cut to victory in bringing the lost to Christ and the Church.



# **GENERAL RESOLUTIONS**

### **Close of Conference Year**

1. BE IT RESOLVED, that our Conference Year end on April 30.

#### **Deadline for Statistical and Financial Reports**

2. BE IT RESOLVED, that all reports to the District Statistician and remittances to the District Treasurer be postmarked not later than May 15.

#### Questionnaire for Ministers Entering Pa.-N. J. Conference

3. WHEREAS, the District Council generally lacks the proper and necessary information relative to ministers of other districts and denominations desiring membership in our district;

BE IT RESOLVED, that the same be required to answer a questionnaire supplied by the District Council.

#### **Church Call to Ministers Outside District**

4. BE IT RESOLVED, that no church shall extend a call to a minister outside of the District without having first obtained the approval of the District Council.

#### Council Permission for Ministerial Membership in Local Church

5. BE IT RESOLVED, that no one, having held or holding ministerial credentials, making application for membership in any of our churches, shall be accepted without the approval of the District Council.

#### **Council and Delinquent Ministers**

6. BE IT RESOLVED, that this Conference require the District Council to deal with those holding Credentials from our District who do not support the Conference with their personal assessments, nor send in their statistical and financial reports, regardless of their field of labor.

#### **Recommendations for First District Ministers' Licenses**

7. INASMUCH, as the responsibility for the execution of all Conference action rests primarily on its entire ministry,

BE IT RESOLVED, that this Conference instruct its Examining Board to recommend for their first district licenses, only those who give evidence of intention to take a permanent place in our ministry.

### **Council Permission for Building and Repair**

8. BE IT RESOLVED, that any congregation considering the erection of a church building and/or parsonage, or the making of extensive improvements and remodeling of church property costing more than \$2,000.00, submit their tentative plans for the same to the District Council for approval before final action by the local board and the beginning of said construction.

#### Appointment and Notification of Youth Officers

9. BE IT RESOLVED, that the newly elected District Council appoint the District Young Peoples officers and notify them of their appointment within one week after the annual conference adjourns.

#### District Superintendent's Revival Schedule

10. BE IT RESOLVED, that the District Superintendent be permitted to conduct only two revivals a year outside of the bounds of the Conference.

### Home Missions Committee

11. BE IT RESOLVED, that the Conference elect a District Home Missions Committee, and

That the District Council shall nominate three candidates from which the conference shall elect one person to fill the expiring term on the Home Missionary Committee.

That the District Superintendent who shall be Chairman of the Committee, and the District Treasurer shall be ex-officio members.

That the Home Missions Committee shall have authority to direct all Home Missionary Work.

#### **District Charter Nullification**

12. WHEREAS, the development and progress of the International Holiness Church has outmoded the District Charter of 1914, and

WHEREAS, for many years the District has been operating under the Charter of the Pilgrim Holiness Church of the United States,

BE IT RESOLVED, that this Pennsylvania-New Jersey Conference go on record officially as operating under the Charter of the Pilgrim Holiness Church of the United States of America.

### Local Church Deeds

13. WHEREAS, the District Records indicate that several of our Church properties are not deeded according to the Manual,

BE IT RESOLVED, that this Conference request the local church board of the District to check the wording of their property deed and urge those whose deeds are faulty to have them recorded according to the requirements of the 1954 Manual.

#### **Candidates for Ordination**

14. BE IT RESOLVED, that all candidates for ordination be examined a year in advance of their ordination.

Said candidates shall be passed upon by the Examining Board and the District Council.

The final approval of the Conference shall be reserved until the first session of the Conference, where they are to be ordained. Said Conference approval shall be the order of the day immediately after the roll call of the first sitting.

A list of said candidates shall be announced in the final sitting of the Conference preceding their ordination and such list shall be published in the Conference Journal.

Any default in spirit or practice during the intervening year or failure to carry out any prescribed program of the Council or Examining Board shall cancel out the possibility of the final approval of the Conference.

#### **Time of Call Pastor Meeting**

15. INASMUCH, as the dates for Annual Meetings, at which time pastors are called, cover such a long period of weeks,

IHEREFORE, BE IT RESOLVED, that to facilitate matters the calling of the pastor be separated from the Annual Meeting and that all of our churches have a call pastor meeting some time during the period from the first Sunday in April through the second Sunday in April. (As amended by the 1956 Conference).

#### Procedures for Calling a Pastor

16. INASMUCH, as there seems to be considerable confusion in the placing and calling of pastors due to the diversity of methods and procedures being used and insisted upon by the churches,

THEREFORE, BE IT RESOLVED, that a form of procedure for the calling of pastors be established as follows to serve as a guide for the future:

(1). Let all of the call pastor meetings be held during the period involving the first Sunday in April through the second Sunday in April.

(2). If the pastor is not recalled, resigns or does not submit his name for a vote, the result of the meeting should immediately be forwarded to the Superintendent by the church secretary.

(3). If the pastor is recalled he can have the legal time established by the manual to accept or reject the call. If he does or does not accept the call he shall immediately inform the superintendent of his decision.

(4). In the event of the pastor's leaving, whatever the circumstances, the superintendent shall present either in person, writing, or through an authorized representative the list of available ministers, with recommendations that naturally fall within his jurisdiction.

(5). It shall be the privilege of the local board and the church to immediately call a man on the basis of recommendation, without having a trial message.

(6). In the event a board and church desire a trial message, the board shall make a choice of a candidate. If two or three candidates are chosen they should be designated as first, second, and third choice.

(7). After the trial message of the first candidate there shall be a vote on the candidate within a reasonable length of time, preferably immediately.

(8). If the first candidate is not called, or refuses to accept the call, the same procedure shall be followed with the second candidate or third.

(9). In no case however shall a second candidate be called to preach a trial message until a vote has been taken by the board and the church on the first candidate.

(10). Let all retiring ministers consider their ministry to a church as ending, according to manual, the Sunday following Conference, and all moving take place the following week. (As amended by the 1956 Conference).

### WAYS AND MEANS RESOLUTIONS

### **Ministerial Tithes to District**

1. BE IT RESOLVED, That we require all our pastors to pay 50% of their tithe received from ministerial work, through the local treasurer to the district treasurer; and all other licensed and ordained ministers send 50% of the tithe they receive from Christian service direct to the District Treasurer.

### **Division of Ministerial Tithes**

2. BE IT FURTHER RESOLVED, That 40% of the surplus of ministerial tithes over the amount required for the District Superintendent's salary and

the Pilgrim Pension Plan allotment be placed in a District Parsonage Fund, and the remaining 60% surplus in the Home Missionary Fund.

#### Ministerial Assessment for Superintendent's Retiring And Emergency Fund

3. WHEREAS, There has been no fund provided to maintain the Superintendent's Retiring and Emergency Fund,

BE IT RESOLVED, That all of our actively engaged ministers be required to pay 2% of their tithe to the said fund.

#### District Expense Deficits

4. RESOLVED, That the Council be authorized to make a special appeal to the churches for the funds to meet deficits which might develop in the District Expense Fund at any time.

### **General Conference Expense Fund**

5. INASMUCH, As there is no provision to raise the funds for the delegates' expense to the General Conference,

BE IT RESOLVED, That we deduct ten percent from the District Expense Fund for this purpose.

#### District Budget

6. RESOLVED, That 7% of the total church receipts, excepting General Budget, money for indebtedness, building fund, revival offerings, Sunday School, Youth Society funds, and special funds raised for the departments covered by the District Budget, be paid monthly to the District Treasurer to be apportioned by him as follows:

### Salaries of Treasurer, Secretary, Statistician, and Sunday School Secretary

7. RESOLVED, That the following officers be remunerated for their services from the District Expense Fund as follows:

District Treasurer(annually)	\$225.00
District Secretary(annually)	75.00
District Statistician(annually)	35.00
Promotional Secretary of Sunday	
Schools(annually)	35.00
(As amended by the 1956 Conference)	

#### Eastern Pilgrim College Special Apportionment

8. BE IT RESOLVED, That each church raise a minimum equivalent to  $25\phi$  per member, per month, for the Eastern Pilgrim College.

#### **Conference Remembrances for Bereaved Ministers' Families**

 $\boldsymbol{9}.$  SINCE, There are times when death enters the immediate family of our ministers,

BE IT RESOLVED, That the District send a floral tribute and a love offering of \$50.00 to such bereaved families, payment to be made from the Retiring and Emergency Fund.

#### **General Budget**

10. There shall be an annual General Budget of 6.00 per member per year: Fcreign Missions 35%, Administration 25%, Church Extension 20%, Church Extension Loan Fund 6%, Senior College 10%, Sunday School and Ycuth 4%, this budget to be raised monthly.

It shall be the responsibility of the pastor and the church board to see that their church raises its portion of the General Budget. It shall be raised as one item under the term "General Budget," and shall be raised monthly

#### Cash Balance to Be Retained by Youth Leaders

11. WHEREAS, There is a financial inconvenience placed upon Young People's Zone Leaders having insufficient funds to engage a speaker and for advertising purpose,

BE IT RESOLVED, That each Youth Zone Leader be permitted to retain a working balance of \$35.00 throughout the conference year and that said balance be forwarded to his successor.

#### **District Conference Expense Assessment**

12. RESOLVED, That each church provide the District Conference with no less than \$4.00 each for the pastor and delegate, or delegates, who attend the District Conference, and that all other members of the District Conference, ence be required to pay \$3.00. (As revised by the 1955 Conference).

#### **Church Building Loan Fund**

13. WHEREAS, A generous gift of \$500.00 has been received by the District Council with which to establish a fund from which loans may be made to new and needy churches,

BE IT RESOLVED, That we maintain a Church Building Loan Fund. The fund is to be held in trust by the District Council, and

That 5% of the total Home Missionary Offerings be appropriated by the District Treasurer to the increase of said Church Building Loan Fund.

Loans can be made from said fund by the Council to congregations endeavoring to erect or buy a church or parsonage, but only after a thorough investigation of the financial status of the congregation by the Council. ( $\P$  as amended by 1953 No. 2.)

When a loan is granted, the congregation to which the loan is made shall give a note to the District Treasurer signed by the local trustees.

The principal shall be paid back in installments, with interest at 5% in advance, monthly, except that the minimum charge for interest shall not be less than 50% per month. The amount of the monthly installments shall be determined by the District Council.

The District Treasurer shall mail a statement of the amount due on the 20th of each month to each church that has a loan from said Fund.

In the event that a congregation which has made a loan according to this plan, fails to meet its installments for a period of three months, its financial standing shall be investigated by the District Council.

#### Parsonage Utilities

14. WHEREAS, Some of our churches provide the utilities for their parsonages, and

WHEREAS, There is a growing interest among the District churches to provide the same,

BE IT RESOLVED, That, as far as possible, each church provide its parsonage with a cooking range, electricity, fuel for heating and cooking, water, and telephone service.

#### District Superintendent's Salary and Allowances

15. BE IT RESOLVED, That Ways and Means Resolution Number 17, page 62, be amended to read: That we pay our District Superintendent a salary of \$4,160.00 per year, supply his utilities and fuels, pay his telephone, postage, and telegraph expenses, and that the Superintendent shall be paid at the rate of six cents per mile, for all travel in the interest of the District directly from the Superintendent's fund, and that the offerings taken at the time of the Superintendent's visits be given to him to be applied toward travel expense. The District Superintendent shall submit his mileage report to the District Treasurer at least once per month for payment. (As amended by the 1956 Conference).

## STANDING RULES

#### **Time of Conference**

1. The District Conference shall convene annually in the auditorium of the E. P. C. at 2 p. m. Tuesday afternoon following the commencement and all Committees shall meet at 9 a. m. Tuesday morning.

#### **Conference Bar**

2. The first nine rows of seats and forward shall constitute the Conference Bar.

#### Time of Sittings

3. Sittings of the District Conference shall be from 8:30 a. m. to 11:30 a. m.; 1:30 p. m. to 4:30 p. m.; and 6:30 p. m. to 9:00 p. m.

#### **Conference** Communion Service

4. The first part of the first session of our Annual Conference shall be devoted to observing the sacrament of the Lord's Supper with the presiding officer in charge.

### **Time of Ordination Service**

5. The Ordination Service shall be held at 10:30 a.m. the second day of Conference.

### Minimum Age for District Conference Delegates

6. Delegates to the District Conference must be 18 years of age or over.

#### **Unfinished Conference Business**

7. At the close of the Conference, the District Council shall attend to any business that may have been overlooked, and approve the minutes of the closing sitting.

#### **Committee Appointments**

8. The District Superintendent with Council consultation shall appoint all Committees.

### **Permanent Committees**

9. The following committees: Resolutions, Ways and Means, Publicity and Reporting, Editing, Auditing, Memoirs, Reception and Statistical shall be permanent.

#### **District Trustees**

10. The members elected each year to the District Council shall simultaneously be elected to the District Board of Trustees.

#### **Ministerial In Memoriam**

11. A picture and a brief sketch of the labors of deceased ministers shall be placed in the Conference Journal.

#### Superintendent's Vacation

12. The District Superintendent shall have a two weeks vacation annually, with pay.

#### **Pastors' Vacations**

13. The District Conference recommends that each church in the Conference give its pastor a two weeks vacation with pay each year.

#### **Procurement of Loans**

14. The District Council is authorized to work with any local church in procuring loans using the financial standing of the Conference, as reflected in the property statement and the District Treasurer's balance sheet, as the basis of negotiation for such loans.

#### **Ministerial Convention Committee**

15. The Ministerial Convention Committee of which the District Superintendent is chairman by virtue of his office, shall be listed annually in the official Minutes of the district along with all other conference and district committees.

#### **Transfer of General Resolutions to Standing Rules**

16. The District Secretary is authorized to transfer items that are in reality rules of procedure and orders of the day to standing rules.

#### **Camp Service for Foreign Missions**

17. Thursday afternoon of our District Camp Meeting shall be devoted to the interest of Foreign Missions.

#### **District Camp Financial Report**

18. The District Treasurer's report shall include a detailed financial report of the District Camp.
