

# CONFERENCE PROCEEDINGS

## FIRST SITTING

The Forty-fifth Annual Conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church convened in Wesley Chapel on the campus of E.P.C., June 24, 1958 at 10:00 a. m. at the call of the District Superintendent, Rev. Castevens.

The annual communion service began with Rev. Kenneth Masterman leading the congregation in singing "There Is a Fountain Filled With Blood." Mrs. Masterman accompanied at the organ.

Rev. Robert L. Smith led the congregation to the Throne of Grace in prayer.

District Superintendent Rev. G. A. Castevens introduced our esteemed General Superintendent, Rev. Melvin H. Snyder to the Conference.

Following words of greeting, our General Superintendent spoke on words found in I Cor. 11:26, "Ye do shew the Lord's death till He come," using for his subject, "The Significance of Christ's Death." He emphasized that Christ's death meant the putting away of our sins personally. He hath redeemed us and our sins were laid on Him. He did bear them away by the sacrifice of Himself. We came to the Lord's Table in recognition of this fact. He pointed out that the Lord's Supper not only looks back to Calvary but it also looks forward to Christ's coming. In the light of this, we are on the side of victory and success. Therefore, we are not to speak of faithfulness without success but we are to experience the faithfulness of success.

General Superintendent Snyder and District Superintendent Castevens served the Sacrament to the District Council. The Council then served the Sacrament to approximately 125 delegates and friends. The keen sense of the sacred presence of the Lord made this a blessed and hallowed service to each of our hearts.

The congregation then lifted their voices in singing, "Majestic Sweet-ness."

The session cocluded at 11:35 a.m. with prayer by our General Super-intendent.

#### SECOND SITTING

The second session of the 1958 Conference convened at 1:30 p. m. with Rev. Oliver Holden leading the group in singing "I Feel Like Traveling On." Rev. Edgar J. Haskins accompanied at the piano.

We were led in a season of prayer by Rev. P. R. Doyle.

By request of the Presiding Officer, the District Superintendent read the preamble of his report to the conference. Included in this were warm words

of welcome to our highly esteemed General Superintendent, Rev. Melvin H. Snyder, whom he formally presented to the Conference.

The General Superintendent set forth to the Conference the objectives of the church for the quadrennium, as passed by the General Conference.

These objectives are:

First, the church is to realize a net gain of 5,000 members during the quadrennium.

He stated that in order to reach this goal we must win souls to Christ. The importance of taking new converts into the church was stressed. He recommended that our churches institute the Probationary Membership Plan in receiving them immediately into membership.

The provision of the recent General Conference relative to junior membership was highlighted.

The second objective set forth for the denomination is the organizing of 150 new churches. The important place of prayer meetings and branch Sunday Schools in realizing this goal was particularly emphasized.

The third objective is the establishing of ministers' conferences for the purpose of instructing them to become spiritual supervisors of their churches.

The fourth goal is in accentuated Holiness Evangelism.

The fifth and final point of this program is the organizing of prayer and fasting leagues in the local churches by the pastors.

Each phase of the program was enlarged upon and its importance emphasized by the speaker.

Our District Superintendent expressed on behalf of the conference our appreciation for this splendid address.

The Annual Report of the District Superintendent, Rev. G. A. Castevens, which included district goals for the quadrennium and the goals for the new Conference year, also a comprehensive report of his activities of the past year was presented. By motion this splendid report was accepted with a deep sense of appreciation.

The bar was cleared at the call of the Chairman.

By motion carried, the delegates from two new churches were seated in the Conference Bar. The delegate from the Zion Pilgrim Holiness, Point Phillips Church being Mrs. Earl Heckman and Bro. Charles F. Walter from the Port Ann Pilgrim Holiness Church.

The transfers of Rev. L. W. Drury and Rev. Gilbert Delong to the Pennsylvania-New Jersey District were accepted and were invited to take their places within the conference bar.

It was moved and carried that Bros. Earl Heckman and Myron Campbell be granted seats within the conference bar with full rights and privileges.

The roll was called and proper revisions made.

David Wooten and Edwin Mayes were presented from last year's list of proposed ordinands (1957 Conference Journal, page 18) for second ordination. They were accepted by motion for ordination June 25, 1958, 10:30 a.m.

By a motion carried the report of the Assistant District Superintendent, Rev. John P. Campbell, was accepted with a rising vote of thanks.

Rev. Robert Campbell read the report of the Auditing Committee which was accepted by motion.

The District Superintendent read the names of the ushers and tellers for the conference period.

District Treasurer, Rev. E. S. Rutherford presented his report. By motion this excellent report was received by a rising vote of appreciation.

The Executive Secretary of Sunday Schools, Rev. P. W. Braisted, read his report. By motion it was accepted with "Praise the Lord."

Rev. Charles Lewis, Executive Secretary of Youth, presented his report. This was accepted by motion with "Praise the Lord," out of appreciation for such a fine report.

The report of the Youth Treasurer, Rev. John Wiktorchik, was received by motion with appreciation.

Motion made that special greetings be sent to General Superintendent Dr. William H. Neff assuring him of our prayers at this time. Also, that greetings be sent to Bro. David Gorman, Sister Bessie Hatcher, Sister Emma Garman, Bro. L. W. Chatfield, Sister Edward Key, and Florein Strohl, carried by saying "Amen."

The session concluded by expiration of time. Rev. Edgar J. Haskins offered prayer.

#### THIRD SITTING

Bro. Holden led in singing, "Take the Name of Jesus With You" to open the third session of the Forty-fifth Annual Conference. Rev. E. L. Adams led in prayer. General Superintendent Snyder asked for Scripture quotations which would be Christ-centered.

General Superintendent Snyder then spoke to the conference concerning the "United Stewardship Fund." He made commendatory remarks about the very capable message that General Secretary-Treasurer Beltz delivered to the General Conference on stewardship.

The attention of the conference was called to the setting up of the Liberal Arts College as directed by the 1954 General Conference. This must be supported through the "United Stewardship Fund" and would naturally increase the need for finances. He also stated that the 1954 General Conference asked for the Three-General Superintendent Plan. This also demands an increase in the budget. He further stated some of the things that will hinder our going forward:

1. Fear.

2. Laziness or spiritual lethargy.

- 3. Self-interest.
- 4. Lack of divine passion.

The minutes of the first and second sittings were read and approved.

Motion was made that this Conference authorize the Council to send a committee to take greetings in person to Rev. David Gorman and Sister Emma Garman. Motion seconded and carried with an "Amen."

The Home Missionary Committee reported through its secretary, Rev. William Derr. The report was accepted by motion.

Rev. E. L. Adams read the statistical totals of the conference and the report was received by motion with appreciation.

District Superintendent G. A. Castevens presented two new churches to the conference. The pastors, Rev. Kermit Shrawder and Rev. Earl Heckman together with their delegates, were introduced to the conference. The Zion Pilgrim Holiness Church, Point Phillips, Pennsylvania, and the Port Ann Pilgrim Holiness Church, Penns Creek, Pennsylvania, were accepted by motion with a warm welcome and a rising vote of thanks and praise to the Lord. Thanksgiving to God was further expressed by the conference singing the "Doxology."

The Resolutions Committee reported through its Secretary, Rev. Oliver Holden, who gave a full report of the resolutions up to this time.

Motion made that Resolution No. 1 be amended to include a monthly report from the District Treasurer. The amendment carried by motion. The resolution as amended carried.

It was moved that Resolution No. 2 be amended by striking out the words, "these low increases" from the latter part of the resolution. Amendment carried. Motion as amended carried with a standing vote.

Resolution No. 3 carried by motion.

Resolution No. 4 was amended to include Blue Shield. By motion Resolution No. 4 was referred to the committee for further study.

The Ways and Means Committee reported through Rev. William Derr who read the full report of the committee.

Following discussion on Ways and Means Resolution No. 1, motion was made and seconded calling for the previous question. Motion carried. Ways and Means Resolution No. 1 carried by motion.

Ways and Means Resolution No. 2 carried by motion.

Motion made that we extend the time to take care of Ways and Means Resolution No. 3. Motion carried. Ways and Means Resolution No. 3 carried by motion. The session concluded at 9:10 p. m. Prayer was offered by Rev. E, J. Hocking.

After a third ballot produced no election for District Superintendent, a motion was made that we dispense with the election until after the Ordination service. Motion carried.

The Conference recessed at 10:20 a.m.

The Conference reconvened at 10:30 a. m. with Rev. L. W. Drury leading in the singing of the old hymn "A Charge to Keep I Have."

Following prayer by Rev. John P. Campbell, District Superintendent Castevens presented the names of the candidates. General Superintendent Snyder responded with words of counsel both to the candidates and the congregation.

Appropriate Scriptures were read by Rev. W. A. Massey, Rev. E. S. Rutherford, and Rev. R. D. Gunsalus.

General Superintendent Snyder spoke on the theme, "The Preacher God Wants," basing his message on words from II Chronicles 16:9. He pointed out that to be a true minister requires a true dignity that God Himself can respect. To have God in our hearts has universal appeal. Also, he said if we are to have true revivals, discipline must be exercised. He stated that God is looking for men whom He can trust. The three following thoughts were emphasized: 1. God wants a man who will be quiet enough to hear His voice. 2. You must be courageous enough to preach God's message. 3. If you are to be a minister of the Pilgrim Holiness Church, you are to be honest enough to live your message.

After the candidates took the ordination vows, Brothers Castevens and Gunsalus led in prayers of consecration. The Ordination Council laid their hands on the Ordinands. Credentials and Certificates of Ordination were presented. The Ordinands were congratulated by the congregation and the service concluded with the congregation singing, "Blest Be The Tie That Binds."

## FIFTH SITTING

The fifth and final session of the Forty-fifth Annual Conference convened at 1:40 p. m. with Brother Holden leading the congregation in singing, "Jesuh Has Lifted Me." Our Presiding Officer led us in prayer.

Motion was made, seconded and carried that the reading of the minutes be dispensed with in order that we may proceed with the election.

After the fourth ballot produced no election for District Superintendent, motion was made and carried that the Conference request our General Superintendent to nominate for this office.

By motion the roll call for Conference Journals was taken while the Presiding Officer took some time alone in meditation before making nominations.

General Superintendent Snyder made the following nominations for the Conference: Rev. G. A. Castevens and Rev. W. A. Massey. After three ballots on the nominees failed to produce an election, the Presiding Officer added the name of Rev. John P. Campbell to the list of nominees.

Following the next ballot, Rev. W. A. Massey withdrew his name from the nominees.

The succeeding ballot produced the election of Rev. G. A. Castevens, receiving 88 out of 122 votes.

While the first ballot for Assistant Superintendent was being counted, the Resolutions Committee presented Resolution No. 7 which carried by motion.

Rev. Thomas Weir, Superintendent of the Capitol District, was escorted to the front of the Chapel by the Reception Committee and was introduced to the Conference. After words of greeting, Brother Weir was invited within the Conference bar.

It was moved, seconded and carried that the third ballot for Assistant Superintendent be on one of the two having received the highest vote. These being: John P. Campbell and W. A. Massey.

While the third ballot was being counted, the Memoirs Committee reported through its secretary, Mrs. Russell Lutz. The Conference stood for a few moments of silence in honor of those who have gone on to be with the Lord. District Superintendent Castevens concluded this period with prayer.

Due to pressing obligations, our General Superintendent asked to be excused from the Conference early, and left at 3:35 p. m. By request of the General Superintendent, Dr. R. D. Gunsalus presided over the remaining part of the Conference.

W. A. Massey was elected Assistant District Superintendent on the fourth ballot, receiving 115 votes out of 131 votes.

The Council nominations for Secretary were read. They being Robert L. Smith, and E. J. Hocking.

While the first ballot was being counted, the Ways and Means Committee presented Resolution No. 7. Resolution was adopted by motion.

While the tellers counted the second ballot for Secretary, District Superintendent Castevens requested R. D. Gunsalus to speak concerning the building program of E. P. C. He made particular mention of the proposed dormitory and explained the need for another \$100,000.00 before construction can be made. He also mentioned the need for a full time field man.

Rev. E. J. Hocking was elected Secretary on the second ballot, receiving 103 out of 128 votes. Brother Hocking declined the office because he is physically unable to assume this responsibility.

The Council then presented the names of Robert L. Smith, Howard J. Frey, and George E. Culver as nominees.

Rev. Howard J. Frey was elected Secretary on the second ballot, receiving 81 out of 115 ballots cast.

#### PILGRIM HOLINESS CHURCH

The Council nominees for District Treasurer were read, which were: E. S. Rutherford, E. L. Adams and E. E. Hostetter. Brother Rutherford was elected on the first ballot, receiving 90 out of 118 votes cast.

Motion made, seconded and carried that we extend the time to 5:45 p. m. to complete the business of the Conference.

By unanimous consent Vernon Price was added to the list of proposed ordinands for 1959 Conference as recommended by the Board of Education and Examination and approved by the District Council.

Dr. R. D. Gunsalus spoke briefly on the Ministerial Benefit Association of the Pilgrim Church.

Five names were placed on the first ballot for Advisory members to the Council. R. D. Gunsalus and M. E. Dieter were elected on the first ballot.

It was moved, seconded, and carried that we vote on three of the six highest on the second ballot. These being: Robert L. Smith, B. L. Bidwell, John P. Campbell, E. E. Hostetter, W. F. Bubb, and L. W. Drury.

The second ballot resulted in the election of B. L. Bidwell, Robert L. Smith, and L. W. Drury.

It was moved and carried that this Conference express its appreciation to Brother Campbell by a standing vote for his many years of faithful service as an Official of this Conference.

It was moved, seconded, and carried that the Council meet in front of the Chapel to make nominations for the Board of Education and Examination, since Brother Drury's name was eliminated by his election to the Council. The Council nominees were: Edgar J. Haskins, John P. Campbell and E. J. Hocking. Brother Haskins was elected on the first ballot, receiving 61 out of 118 votes.

Brother Oliver Holden read Resolution No. 8 which carried unanimously.

The Forty-fifth Annual Conference was outstanding in that it is believed to be the largest delegation in the history of the Pennsylvania-New Jersey District. Also, there was a large attendance of friends and visitors. This is just another indication that this great Conference is on the march for God and the Church.

Conference recessed due to expiration of business at 5:35 p.m.

Brother Oliver Holden offered the closing prayer.

# **CONFERENCE REPORTS**

## REPORT OF THE DISTRICT SUPERINTENDENT

Through the providence of our Heavenly Father we gather in the Fortyfifth Annual Conference of the District. Again we are afforded the fine facilities of Eastern Pilgrim College. For this we are grateful.

Overwhelmingly, the recent General Conference voted in favor of three General Superintendents. The following were chosen by the Conference to fill the highest office in the Church: Dr. William H. Neff, Rev. R. G. Flexon, and Rev. Melvin H. Snyder. Upon election, it became the duty of the General Board to designate the area in which the General Superintendents would serve. By vote of the General Board, General Superintendent Rev. Melvin H. Snyder was assigned to the Eastern area. And, since the Pennsylvania-New Jersey District falls within this area, we extend to you General Superintendent, Rev. Melvin H. Snyder, a very warm welcome. We count it a distinct honor that the Pennsylvania-New Jersey Conference is the first of the District Conferences you will conduct in the capacity as our General Superintendent. On behalf of this Conference, I assure you of our prayers and consideration. It now gives me personal pleasure to present as the presiding officer to this Conference, our General Superintendent,—the General Superintendent of the Eastern area, Rev. Melvin H. Snyder.

In presenting my Annual Report, I shall do so under the following headings:

#### THE GENERAL CONFERENCE

According to the general consensus, the most historical General Conference of the Pilgrim Holiness Church concluded at noon, June 16, 1958. This general opinion prevails in view of the gracious manifestations of the Spirit throughout the Conference, and because of the forward looking legislation adopted. Following are listed several of the major legislative items:

- 1. The overwhelming vote favoring the merging of the Pilgrim Holiness Church with the Wesleyan Methodist Church.
- 2. The United Effort to Lift Up Christ.
- 3. The election of three General Superintendents.
- 4. The United Stewardship Fund.

No doubt our Presiding Officer will highlight these and other major items adopted at the General Conference in his addresses to this Annual Conference.

#### DISTRICT CONFERENCE INTERESTS

#### "Toward Tomorrow"

Under this caption "Toward Tomorrow," the Soul Saving Crusade, or the Federated Movement, which the Spirit gave birth to at the National

#### PILGRIM HOLINESS CHURCH

Headquarters of the Pilgrim Holiness Church, January 1956, is being enthusiastically implemented by the vote of the recent General Conference. This has my wholehearted support. No other attitude should be tolerated by officials, ministers, or members, throughout the entire Church. It is my candid opinion because of our inability to carry through with the "Forward Movement" the entire Church was retarded; but my hopes have been raised by this forward looking program presented and adopted in the General Conference. The proposal in its entirety must be supported by us all. But that part that has to do with "Organized Districts" demands our first attention.

For the Pennsylvania-New Jersey District to fulfill its part in this Church-wide program of making Christ known, we must unitedly strive to lead souls to a saving knowledge of Christ, and then take them into the fellowship of the Church and its departments. Permit some related and vital statistics that must result from our "Accentuated Holiness Evangelism," coupled with prayer and fasting. District-wise we must realize these extra low minimum results over the next four years, if our Lord tarries.

- 1. Gain of 12 New Churches,—or 3 Churches per year.
- 2. Gain of approximately 600 members,-or 150 per year.
- 3. Gain of 600 in Sunday School attendance,—or 150 per year.

In order to realize these very low goals each Church in the District must gain three members per year and increase Sunday School attendance three members per year. If we will move out of our four walls with a compassion for souls that will supercede material gains and personal credit, God will help us to exceed all set proposals. If each pastor and minister will go back to his field of labor, and major on essentials and the winning of the lost to Christ, both in preaching and example, we will go forward.

The term "United Stewardship Fund" replaces that disliked name, known as the "General Budget" in the past, but it means the same thing. An overall four year program has been set up for the Pilgrim Holiness Church. In order to care for this over-all interest, the General Conference adopted the "United Stewardship Fund" which calls for each Church to raise eight dollars, per member, each year. The Manual places this responsibility upon the Pastor and the local Church Board. So, pastors on return to your Churches, meet with your Church Boards and start some plan now to raise your allotment of this Fund monthly. It can be done, if we will do it. The Churches will be greatly influenced toward this united effort of our Zion by the pastor's attitude.

#### PAST CONFERENCE YEAR

For several years God has given this District growth and increase. But the past year, if tabulations for the forty-nine reports reaching my office are correct, there will be a loss in both membership and Sunday School attendance. However, in checking I discover that this Conference shared ten of its ministers and their families to other Conferences. This would total about twenty or more members transferred. It should be pointed out also that from May to October the District Sunday Schools were making good gains. Then, the very severe epidemic of flu struck during the Annual Rally. And during the month of October we sustained a loss of 1,000 over October of 1956. Repeated epidemics and the most severe winter for a number of years, with its blizzards, counted for continued losses in Sunday School attendance. These unavoidable hindrances are not mentioned to comfort us where we failed, but to challenge us to greater effort in Kingdom building this Conference year.

#### **NEW CHURCHES**

It will be my delight and privilege to present two newly organized Churches to this Conference. With a burden and concern, Rev. E. S. Rutherford and the fine people of the Cherryville Church have sponsored a branch work at Point Philips, Pa. for about three years. The work developed well and on Sunday afternoon, November 17, 1957, Zion Pilgrim Holiness Church was organized by Rev. Rutherford with 12 charter members. Rev. Earl Heckman is the pastor, and God is blessing this new Church. They have a very presentable chapel. This was made possible through the contributions in both money and labor of the Cherryville Pilgrims.

A duplication of the above has been accomplished by Rev. L. W. Chappell and the Middleburg Church. It was my delightful privilege to be there over a week end recently; and on Saturday evening, May 17, 1958, organized the Port Ann Pilgrim Holiness Church with 9 charter members. This Church is located about three miles west of Penn's Creek, Pa. Rev. Kermit Shrawder is pastor of this new Pilgrim congregation. Both of these Churches have good prospects of becoming strong rural congregations. What has been accomplished by the Cherryville and Middleburg Churches could be duplicated by a number of our District Churches.

A very promising branch work in Stroudsburg has been carried on by the Church. Human leadership has been furnished in the person of Mr. Daniel Marvin, former Sunday School Superintendent of the Stroudsburg Church. Rev. L. W. Drury, the aggressive pastor of the Mother Church, is backing this effort wholeheartedly. Recently the local Church Board turned this work over to the Lehigh Valley Home Missionary Committee, and we are looking forward to a strong lighthouse for God and the Church to develop out of this branch work during this Conference year. Join in prayer for this to be realized.

#### SPECIAL INTERESTS

God was pleased to visit both the Regional Camps and the District Youth Camp with His manifest presence. The first Youth Camp sponsored by the District was held last August on the Hughesville Camp grounds. It was well attended and well organized, and was conducted on the highest level. God honored His word in the night services, and many of the youth in attendance found spiritual help at the place of prayer. Another Youth Camp is being planned for August 11-15, at the same location. Pastors encourage your young people to attend. I am sure under the leadership of Rev. Charles Lewis, and the staff of workers, they will be in good hands. Let us do all we can for our youth. We should all join in earnest prayer that the four Regional Camps will be visited powerfully this summer, and that many will find Christ as Saviour.

#### PILGRIM HOLINESS CHURCH

Eastern Pilgrim College, our college, has enjoyed another good year. Approximately 300 young people were in attendance. God repeatedly met with the faculty and students in classroom and chapel. The school year closed with a great visitation of the Spirit. Throughout our connection will not be found a greater sacrificial group than our President, Dr. R. D. Gunsalus, and his Staff. The College is worthy of any and all the support we can give to it. Let us remember our College in prayer and our continued financial support.

There is particular reason to be thankful to God for His visitations and progress given at the Mt. Union Church. For a number of years this Church has had a hard struggle. But because of the faithfulness of former pastors and the diligent work of the present pastors, Rev. and Mrs. Lloyd Shank, God has blessed with a revival spirit in recent months. Just recently, God gave the Church 12 new members. On a recent visit, I counted about 22 men and boys in the Sunday night service. This Church is the leader this year in adding new members. I am sure we all rejoice because of this that has come to the Mt. Union Church.

#### PROPERTY GAINS

Many thousands of dollars have been expended in improvements of Church property. Much of this progress has been reported through the Pilgrim Action. However, a cause for rejoicing is pointed up in these major projects. Harrisburg First Church is now worshiping in a beautiful Church and parsonage combination plant. This new church plant is located in a new housing development. Rev. Charles H. Sorrells in a recent report gives encouraging news.

The Pilgrims at Lehighton have erected a beautiful new parsonage. At this time a new Church plant is under construction at Glassboro, New Jersey. Progress is being made in the Glassboro Church under the capable leadership of the pastor, Rev. George Harris. The Loganton Church has renovated the entire auditorium, making it one of the most attractive sanctuaries in the District. Rev. Edward Crosser and the Pilgrims at Loganton are to be commended for this beautification of God's house. A beautiful new parsonage has been purchased by the Rebuck Church, and the Lewis family have occupied it with much delight for several months now.

Another worthwhile property achievement to be mentioned is the Bethany Pilgrim Holiness Church, Cherryville, Pa., acquiring clear deeds to the property. All these years the property has not been owned by the local church. But within the last few months the deeds have been properly recorded, and made to the Pilgrim Holiness Church of the United States of America. This is the way all our properties should be deeded. Also to be mentioned is a combination dining room and dormitory building presently under construction on the Bethany Camp Grounds between Stroudsburg and Lehighton. For all that has been gained materially, we give thanks to God.

#### FINANCIAL SUMMARY

According to the District Treasurer's records a total of \$68,664.96 was received. These funds were disbursed as follows: General Church inter-

ests \$42,391.49. Of the total receipts, the General Church interests shared about 65%, or about four times the amount required by the General Budget. Last Conference year the total giving to General Church interests amounted to \$37,891.80. This is an increase of \$4,499.69. Total giving to Foreign Missions amounted to \$24,604.03, or an increase of nearly \$2,000.00. General Church Extension received \$8,540.64, an increase of \$1,240.27. Eastern Pilgrim College received a total of \$9,265.43, or a decrease over last year of \$2,240.77. From the final report of the General Church Treasurer, the District paid 71.2 per cent of the General Budget this Conference year. This represents a total amount of \$8,314.52.

#### PERSONAL REPORT

Sermons and addresses 189; Church visits 113; Church Board Meetings 70; Annual Meetings, 37; Pastoral Recalls 4; District Council Meetings 15; Committee Meetings 11; Revivals on and off the District 4; Meetings of short duration on the District 4; Youth Rallies 5; Dedicatory services 2; Mortgage burnings 1; Communion services 2; Children dedicated 3; Sunday School Workers rallies 5; Churches organized on the District 2; Funerals 1; Marriages 1; General Board Meetings 4; Eastern Pilgrim College Board Meetings 2; Pastoral Installation services 6; Fellowship Meetings 4; Camp Meeting Annual Business Meetings 2.

In addition to the above I served on the Committee with the other District Superintendents of the area in arranging for the Regional Ministerial Convention. It was my privilege to attend the Annual Church Leader's Conference in January. I enjoyed having part in the first Youth Camp in the District last August. I have traveled approximately 24,900 miles in the interest of God's work. My salary has been received in full. Offerings from revivals and week end meetings have amounted to \$998.13. To date I have received \$924.64 for travel expenses. It should be pointed out that this report covers about 13 months of activities.

#### CONCLUDING WORD

Our ministerial constituency is one less this Conference because of the home going of Rev. Thomas B. Ferguson. His was a long and useful life. To my knowledge his entire ministerial work was done with this Conference. God calls his workman home, but His work goes on. We will anticipate meeting our fellow-soldier in the morning of reunion and rewards.

We are all very grateful for the overshadowing mercies of God, which protected and preserved the lives of Rev. and Mrs. John Robert Clough and baby in a very serious automobile accident near the Christmas season. It is a pleasure to see them in the Conference.

Also our gratitude to the Giver of life for sparing Rev. Clifford Berry to his family and the Church, when his parked car was hit from the rear and he was pinned between his and another car. He suffered very serious leg injuries. We welcome him here today.

For all the personal kindnesses shown by the ministers, their good wives, and a host of godly laymen, our heartfelt thanks. To an understanding and considerate District Council, my special gratitude. Quoting from last Conference report, "It is no time to be quibbling over incidentals while the world is perishing for the Bread of Life. I appeal to you, let us rise and meet the tremendous challenge of making Christ known to every soul possible. If this passion can grip us as it should, there will be little or no room for extended debate over the extraneous and mundane things. But, our hearts will be burning to bring some wanderer to the fold. God grant that it may be so!"

## REPORT OF THE PROMOTIONAL SECRETARY OF SUNDAY SCHOOLS

To the Forty-fifth Annual Conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church, Sunday School Greetings:

It is with a sense of gravity that I submit the Sunday School Report for this Conference year. After eight successive years of gain, our average attendance of 3,855 this year leaves us with a loss of 189.

I will take this opportunity to commend our Sunday School officers and teachers for the way in which they have responded, and for the measure of recovery which we have attained. It is not to find an excuse for ourselves, but to acquaint others with some of the reasons for our losses, that I point out the following: The first five months of this year revealed a numerical gain of more than 875 over the same period last year. The flu epidemic, in October, left us with a staggering loss of nearly 1,000 for the month. Naturally this not only wiped out all of the previous gain but left us with a loss which the severe winter weather served to increase. To add to our plight five of the Branch Sunday Schools reported last year have been discontinued.

Our sincere congratulations go to our churches at Cherryville and Middleburg, whose branch Sunday School efforts have resulted in the organization of two new churches.

The two churches to receive the Conference awards are: Bush Hollow with a numerical gain of 35. Glassborc with a numerical gain of 14.

Others to receive honorable mention, for having a numerical gain of 10 or more, are:

## PILGRIM YOUTH REPORT

To the 45th Annual Conference of the Pa.-N. J. District of the Pilgrim Holiness Church— Greetings in the name of the Lord:

Another year in the history of this department has come to a close as of this Conference. It has been a year of accomplishments in a number of youth activities. Our youth endeavors have been blessed of God with souls won to Jesus Christ.

The days of July 29-August 2 were high days in the history of Penn-Jersey Youth. It was the First District Youth Camp. Prayer and careful planning were the foundation for this venture. This camp was conducted at Hughesville, Pa. Holiness Association Camp Grounds. Ninety-five persons were registered for this camp of which 77 were young people between the ages of 12 and 25. Various ministers of the district assisted as workers, teachers and speakers. Approximately 60 young people sought spiritual help at the altar, some for the first time.

Thirty-five m.m. slides were taken and tape recordings made of the Camp activities. These I have shown in six youth zones during the past year. They are now available for local church use.

The Annual Youth Conference, August 3, 1957 voted to have Youth Camp again in 1958. This is to be August 11-15, 1958. Extensive plans have been made for this 1958 camp. The directors are making plans for more campers than last year.

Various pastors and wives will be serving as teachers, counsellors and camp personnel. Rev. and Mrs. Kenneth Masterman will be music directors, and district ministers will be the evening speakers. Prayer is solicited from each church in behalf of this part of the youth work.

I am happy to report the organization of two new societies—Bethlehem. Calvary and Mable.

The District Youth Department purchased a reconditioned typewriter for use by the Executive Youth Secretary.

Gains have been realized in attendance in youth rallies in two zones. Eastern Lehigh zone under the direction of Rev. James Brillhart made a gain of 47%, amounting to a numerical gain of 54. Central Susquehanna, led by Rev. L. W. Chappell, also showed an increase. Below is a statistical report of rallies and attendance:

A bit of friendly rivalry known as "Tug-O-War" was continued this past year among the seven zone leaders. In this the zone leaders receive points for various efforts in the youth work. This year, Rev. Fred Newton has the highest number of points—1,922.

National Youth Week, sponsored by our General Church was observed throughout the district. This year's project, known as Operation Radio was the launching of the program, "The More Abundant Life" which since has been changed to the "Pilgrim Hour" due to conflict of name with another organization.

Tapes are available for use free of charge to local societies, churches or groups who will purchase radio time. I hope a number of churches will take this matter up.

By way of personal report, I attended the National Youth Leaders meeting, Frankfort, Indiana, last August; I met with the District Zone leaders in September and during the Sunday School Leaders Institutes, I met with the local Youth Society Presidents. I conducted two Youth Camp Board meetings. I visited each youth zone of the district and preached in six rallies. I traveled 4,285 miles in the interest of Penn-Jersey Youth work, received a total of \$189.38 of which \$79.38 was for mileage.

Paul admonished Timothy "To let no man despise thy youth." J. B. Phillips translates this, "Don't let people look down on you because you are young; See that they look up to you because you are an example." This challenge I now put to the youth of this great district. I solicit the help of all others to see it accomplished.

## HOME MISSIONARY COMMITTEE REPORT

To the Forty-fifth Annual Conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church, Greetings:

Supplemental aid has been given, during the 1957-58 Conference year to our churches at Lebanon, West Pen Argyl, and Calvary Church. God is abundantly blessing all the efforts of our pastors in their respective field of labor.

Through the efforts of the Cherryville Church there has been organized the Zion Pilgrim Holiness Church at Point Philips, Pennsylvania. This Church was organized November 17, 1957 with Rev. and Mrs. Earl Heckman as pastors and God is blessing their efforts. The Home Missionary Department has purchased a space heater for this work.

Through the efforts of Rev. and Mrs. Lodge Chappell and people of our Middleburg Church, a Branch Sunday School was started at Port Ann, Pennsylvania. This Sunday School was organized as the Port Ann Pilgrim Holiness Church on May 17, 1958, with Rev. Kermit Shrawder as acting pastor. There seems to be a possibility of an organized Church developing from the branch Sunday School of our Stroudsburg Church. Rev. and Mrs. Russell Lutz who conducted a Revival Meeting in this area have helped to spearhead this work. The Committee recommends that a pastor be moved into this field as soon as possible.

The major financial aid has been directed to the project at Levittown, Pennsylvania. The Home Missionary Rev. William Derr has resigned said charge and the Rev. and Mrs. Robert Campbell are accepting the pastorate. It is recommended by the Home Missionary Committee that financial aid be continued for another year by paying the mortgage payments from District Home Missionary funds and permit the local congregation to support pastor and disperse with all local expenses entailed.

The Home Missionary Committee has been considering several other projects throughout the district which have not come to fruition.

We are on the forward move in the Home Missionary work of our district. Every step is forward and directed to winning the lost to Christ.

As a Committee we are grateful to the Eternal God for all the progress that has been made and are praying that God will give a harvest of souls for the advancement of the Pilgrim Holiness Church of the Pennsylvania-New Jersey District.

## **REPORT OF RESOLUTIONS COMMITTEE**

**Resolution Number I** (As amended by the Conference)

INASMUCH as there is much repetition in the Sunday School and Youth reports with the District News,

BE IT THEREFORE RESOLVED that the District News be published monthly and that the Sunday School, Youth News, and the District Treasurer's report be incorporated therein. Report to be due by the 10th of each month.

#### **Resolution Number II** (As amended by the Conference)

Since the General Conference adopted by united voice the "Toward Tomorrow" effort to advance God's work through the Pilgrim Holiness Church this quadrennium, and inasmuch as the Pennsylvania-New Jersey District warmly welcomes any forward looking and soul saving endeavor,

THEREFORE BE IT RESOLVED that this forty-fifth Annual Conference by a rising vote pledge wholehearted support of same.

BE IT FURTHER RESOLVED that each minister solemnly pledge to subscribe to and earnestly endeavor to carry through items 4 and 5 listed under Organized Districts. These items have to do with "Holiness Evangelism" or personal soul winning, and Prayer and Fasting, and BE IT FURTHER RESOLVED that each Pastor and local Church Board shall take immediate steps to increase Church Membership by 7% and Sunday School Attendance by 8% this Conference year.

#### **Resolution Number III**

INASMUCH as item 5 under "Organized Districts" calls for "Prayer and Fasting League",

BE IT THEREFORE RESOLVED that each Church Board be urged to set up such "Prayer and Fasting" groups; that the Church Board choose the most suitable time and place for such groups to meet, and that some qualified and reliable person be made responsible to keep the meetings within the object and purpose of same.

#### **Resolution Number IV**

WHEREAS there has been a number of inquiries relative to Blue Cross and Blue Shield Group Insurance.

BE IT THEREFORE RESOLVED that the District Superintendent investigate the advisability of organizing a group or groups among the Pennsylvania-New Jersey District ministers and present it to this District at his discretion.

#### **Resolution Number V**

INASMUCH as the Pilgrim Action is to be published monthly,

BE IT THEREFORE RESOLVED that the District Council appoint any needed personnel for compiling and publishing of same.

#### **Resolution Number VI**

#### JUNIOR CHOIR MEMBERSHIP

(A new section following Section 33 of the Manual)

Any local church may receive into church membership children under 14. They must answer in the affirmative the following questions:

1. Have you received the Lord Jesus Christ as your Saviour?

2. Are you willing that all your life shall be governed by the Bible?

3. Will you attend Sunday School and Church services?

4. Are you willing to give of your means to the support of the Lord's work?

Junior church members shall have all the rights and privileges of members in full connection excepting to vote and hold office in the church.

Junior membership ceases at age 14. They may then be received into the church as probationary or regular members in the usual manner for receiving such members.

## **Resolution Number VII**

WHEREAS our General Superintendent has so ably presided over this Forty-fifth Annual Conference,

BE IT THEREFORE RESOLVED that we extend to him a rising vote of thanks.

### **Resolution Number VIII**

WHEREAS our District Superintendent, our District Officers, Kitchen, and Dining Room Personnel have so efficiently labored to provide everything needful for this Forty-fifth Annual Conference,

BE IT THEREFORE RESOLVED that we extend to them a rising vote of thanks.

## **REPORT OF WAYS AND MEANS COMMITTEE**

#### **Resolution Number I**

BE IT RESOLVED that we require all our pastors to pay 60% of their tithe received from ministerial work, through the local treasurer to the Distric Treasurer, and all other licensed and ordained ministers send 60% of the tithe they receive from Christian service direct to the District Treasurer.

AND FURTHER that the division of Ministerial Tithes be as follows: That all the Superintendent's salary, travel, pension and parsonage expense be paid from the 50% tithe, and that 4% be placed in the District Expense Fund, and that 4% be placed in the General Conference Fund, and that the remaining 2% be placed in the Retiring and Emergency Fund, and that any surplus be placed in the Home Missionary Fund.

## **Resolution Number II**

BE IT RESOLVED that in order to make up the deficit in the General Conference Fund of \$795.00 that we take \$200.00 from the Retiring and Emergency Fund and the balance of \$595.00 from the Loan Fund.

#### **Resolution Number III**

BE IT RESOLVED that all ministerial members of the District Conference pay a Conference fee of \$4.00 and further that all retired ministers be exempt from the payment of this fee.

#### **Resolution Number IV** (As amended by Conference)

BE IT RESOLVED that a committee shall be appointed by the Council to investigate the possibilities of strengthening this loan fund by setting up a plan of borrowing from available sources and thus creating sufficient resources to make more substantial loans to the churches. This committee to report to the 1959 Conference.

## **Resolution Number V**

BE IT RESOLVED that Resolution No. 2, page 69 be amended to read as follows: That remittances to the District Treasurer be post-marked not later than May 10.

#### **Resolution Number VI**

BE IT RESOLVED that we substitute for Resolution number 4, item 3, paragraph 3, page 37 of the Conference Journal to read as follows: That the Home Missionary Zone Committees shall be authorized to raise their funds for special projects over and above budget apportionment in the zone churches through the plan authorized by the District Council last year and further, that a record of these zone apportionments to the churches be placed in the Conference Journal.


## **Resolution Number VII**

# In Memoriam PASTOR



**REV. THOMAS B. FERGUSON** was born in Lanarkshire, Motherswell, Scotland, August 31, 1874. He came to America in his early teens and settled in Clearfield County, Pennsylvania. There he followed the occupation of coal mining; later he was promoted to Mine Superintendent with a rating of first grade.

In 1920 he was united in marriage to Rev. Miss Carrie A. Yoder, a minister in the Pennsylvania-New Jersey District.

In 1924 the Fergusons accepted the pastorate at Lock Haven, Pennsylvania. Their next pastorates were Stroudsburg and Millersburg, then Camden, New Jersey, with some evangelistic work in the interim.

In 1940 they accepted the work at Milroy, where they served together until the death of Mrs. Ferguson in 1951.

Rev. Ferguson continued to pastor the church for the next six years, until his retirement from active ministry June 1956.

Brother Ferguson served in varied positions in the Pennsylvania-New Jersey District, including that of a District Councilman. He departed to his heavenly home Wednesday, November 20, 1957, at the age of 83 years. Several days before his death he said, "Wednesday will be the Lord's day," and for him it was the Lord's day.

# **GENERAL RESOLUTIONS**

#### **Close of Conference Year**

1. BE IT RESOLVED, that our Conference Year end on April 30.

#### **Deadline for Statistical and Financial Reports**

2. BE IT RESOLVED, that all reports to the District Statistician and remittances to the District Treasurer be postmarked not later than May 10.

#### Questionnaire for Ministers Entering Pa.-N. J. Conference

3. WHERAS, the District Council generally lacks the proper and necessary information relative to ministers of other districts and denominations desiring membership in our district;

BE IT RESOLVED, that the same be required to answer a questionnaire supplied by the District Council.

#### Church Call to Ministers Outside District

4. BE IT RESOLVED, that no church shall extend a call to a minister outside of the District without having first obtained the approval of the District Council.

#### Council Permission for Ministerial Membership in Local Church

5. BE IT RESOLVED, that no one, having held or holding ministerial credentials, making application for membership in any of our churches, shall be accepted without the approval of the District Council.

#### **Council and Delinquent Ministers**

6. BE IT RESOLVED, that this Conference require the District Council to deal with those holding Credentials from our District who do not support the Conference with their personal assessments, nor send in their statistical and financial reports, regardless of their field of labor.

#### **Recommendations for First District Ministers' Licenses**

7. INASMUCH, as the responsibility for the execution of all Conference action rests primarily on its entire ministry,

BE IT RESOLVED, that this Conference instruct its Examining Board to recommend for their first district licenses, only those who give evidence of intention to take a permanent place in our ministry.

#### **Council Permission for Building and Repair**

8. BE IT RESOLVED, that any congregation considering the erection of a church building and/or parsonage, or the making of extensive improvements and remodeling of church property costing more than \$2,000.00, submit their tentative plans for the same to the District Council for approval before final action by the local board and the beginning of said construction.

#### **Tabulation of Branch Sunday Schools and Mother Churches**

9. WHEREAS, there has been no official method of tabulation of attendance of branch Sunday Schools and the mother churches; BE IT RESOLVED, that this method be adopted:

1. The attendance at the mother church should be recorded in the usual manner.

2. All persons present, including members of the mother church, shall be counted as attendants at the branch Sunday School.

3. These figures of attendance shall be reported separately.

#### District Superintendent's Revival Schedule

10. BE IT RESOLVED, that the District Superintendent be permitted to conduct only two revivals a year outside of the bounds of the Conference.

### **District Charter Nullification**

11. WHEREAS, the development and progress of the International Holiness Church has outmoded the District Charter of 1914, and

WHEREAS, for many years the District has been operating under the Charter of the Pilgrim Holiness Church of the United States,

BE IT RESOLVED, that this Pennsylvania-New Jersey Conference go on record officially as operating under the Charter of the Pilgrim Holiness Church of the United States of America.

## Local Church Deeds

12. WHEREAS, the District Records indicate that several of our Church properties are not deeded according to the Manual.

BE IT RESOLVED, that this Conference request the local church board of the District to check the wording of their property deed and urge those whose deeds are faulty to have them recorded according to the requirements of the 1958 Manual.

#### **Candidates for Ordination**

13. BE IT RESOLVED, that all candidates for ordination be examined a year in advance of their ordination.

Said candidates shall be passed upon by the Examining Board and the District Council.

The final approval of the Conference shall be reserved until the first session of the Conference, where they are to be ordained. Said Conference approval shall be the order of the day immediately after the roll call of the first sitting.

A list of said candidates shall be announced in the final sitting of the Conference preceding their ordination and such list shall be published in the Conference Journal.

Any default in spirit or practice during the intervening year or failure to carry out any prescribed program of Council or Examining Board shall cancel out the possibility of the final approval of the Conference.

#### Time of Call Pastor Meeting

14. INASMUCH, as the dates for Annual Meetings, at which time pastors are called, cover such a long period of weeks,

THEREFORE, BE IT RESOLVED, that to facilitate matters the calling of the pastor be separated from the Annual Meeting and that all of our churches have a call pastor meeting some time during the period from the first Sunday in April through the second Sunday in April. (As amended by the 1956 Conference).

#### **Procedures for Calling a Pastor**

15. INASMUCH, as there seems to be considerable confusion in the placing and calling of pastors due to the diversity of methods and procedures being used and insisted upon by the churches,

THEREFORE, BE IT RESOLVED, that a form of procedure for the calling of pastors be established as follows to serve as a guide for the future:

(1). Let all of the call pastor meetings be held during the period involving the first Sunday in April through the second Sunday in April.

(2). If the pastor is not recalled, resigns or does not submit his name for a vote, the result of the meeting should immediately be forwarded to the Superintendent by the Church Secretary.

(3). If the pastor is recalled he can have the legal time established by the manual to accept or reject the call. If he does or does not accept the call he shall immediately inform the Superintendent of his decision.

(4). In the event of the pastor's leaving, whatever the circumstances, the Superintendent shall present either in person, writing, or through an authorized representative the list of available ministers, with recommendations that naturally fall within his jurisdiction.

(5). It shall be the privilege of the local board and the church to immediately call a man on the basis of recommendation, without having a trial message.

(6). In the event a board and church desire a trial message, the board shall make a choice of a candidate. If two or three candidates are chosen they should be designated as first, second, and third choice.

(7). After the trial message of the first candidate there shall be a vote on the candidate within a reasonable length of time, preferably immediately.

(8). If the first candidate is not called, or refuses to accept the call, the same procedure shall be followed with the second candidate or third.

(9). In no case however shall a second candidate be called to preach a trial message until a vote has been taken by the board and the church on the first candidate.

(10). Let all retiring ministers consider their ministry to a church as as ending, according to manual, the Sunday following Conference, and all moving take place the following week. (As amended by the 1956 Conference).

#### District Conference Home Missionary Policy (As amended by 1958 Conference)

16. Since the Pennsylvania-New Jersey Conference covers such a vast area, and inasmuch as the present policy is inadequate to properly supervise and promote the Home Missionary interest of the conference, BE IT THEREFORE RESOLVED, that the following outlined policy for the home missionary work in the conference be adopted:

1. That the Conference be divided into four home missionary zones, namely: The Bald Eagle Valley Zone, the Susquehanna Valley Zone, the Lehigh Valley Zone, and the Garden State Zone.

2. That a zone chairman shall be elected by the delegates in attendance at the Annual Conference. The zone elections shall be presided over by the executive officers of the District Council. And the zone chairmen elections shall be ratified by the Annual Conference.

3. That there shall be zone home missionary committees composed of the zone chairman and two other members appointed by the Conference home missionary board. The zone committees shall promote the interest of home missions in their respective zone.

Each zone committee shall present through its chairman any and all home missionary projects to the conference home missionary board for approval.

The Zone Committees shall be authorized to raise their funds for special projects over and above budget apportionment in the zone churches through the plan authorized by the District Council last year, and further, that a record of these zone apportionments to the churches be placed in the Conference Journal. All funds shall be sent to the District Treasurer by the local treasurer, specified for said zone.

Should additional funds be necessary in establishing home missionary projects, that said funds be paid out of the District budget home missionary fund. This supplemental financial assistance shall require District Council action and approval.

4. That the election of zone chairmen and the appointment of zone committee members shall be for two years. If for any reason vacancies should occur in zone chairmanship or committeemen, that the vacancy of zone chairmen shall be filled by the District Council, and the vacancy of zone committeemen shall be filled by the conference Home Missionary Board.

5. That each zone chairman shall submit a quarterly report of the zone committee's activities to the District Superintendent.

6. That the District Council shall review any home missionary endeavor of the conference Home Missionary Board and the zone committees. The District Council shall have the right to issue directives to the conference Home Missionary Board, when in their judgment such directives are needed relative to home missionary work within the conference.

#### **Church and Pastoral Directory**

17. BE IT RESOLVED, that the pastor's name and address be listed in the church directory of our Conference minutes with the church.

#### Local Church Directory for Conference Officials

18. BE IT RESOLVED, that it shall be a procedure under the direction of the District Secretary, that blanks shall be supplied to each pastor for an official directory of his church, and that this information be passed on to the various official personnel of the Conference.

#### **Preference to District Ministers**

19. BE IT RESOLVED, that the Conference go on record as requesting that the Local Church Boards give due consideration to all District Ministers, desiring pastorates, presented to them by the District Superintendent.

## WAYS AND MEANS RESOLUTIONS

## Ministerial Tithes to District (As amended by 1958 Conference)

1. BE IT RESOLVED, that we require all our pastors to pay 60% of their tithe receved from ministerial work, through the local treasurer to the district treasurer; and all other licensed and ordained ministers send 60% of the tithe they receive from Christian service direct to the District Treasurer.

## Division of Ministerial Tithes (As amended by 1958 Conference)

2. BE IT FURTHER RESOLVED, that the division of ministerial tithes be as follows: That all the Superintendent's salary, travel, pension and parsonage expense be paid from the 50% tithe; and that 4% be placed in the District Expense Fund; and that 4% be placed in the General Conference Fund, the remaining 2% be placed in the Retiring and Emergency Fund, and that any surplus be placed in the Home Missionary Fund.

# Ministerial Assessment for Superintendent's Retiring and Emergency Fund

3. WHEREAS, There has been no fund provided to maintain the Superintendent's Retiring and Emergency Fund,

BE IT RESOLVED, that all of our actively engaaged ministers be required to pay 2% of their tithe to the said fund.

#### **District Expense Deficits**

4. RESOLVED, That the Council be authorized to make a special appeal to the churches for the funds to meet deficits which might develop in the District Expense Fund at any time.

#### **General Conference Expense Fund**

5. INASMUCH, as there is no provision to raise the funds for the delegates' expense to the General Conference,

BE IT RESOLVED, that we deduct ten percent from the District Expense Fund for this purpose.

#### **District Budget**

6. RESOLVED, that  $8\frac{1}{2}\%$  of the total church receipts, excepting United Stewardship Funds, money for indebtedness, building funds, revival offerings, Sunday School, Youth Society funds, and special funds raised for the depart-

urer to be apportioned by him as follows:

7. RESOLVED, that the following officers be remunerated annually for their services from the District Expense Fund as follows (with the Youth and Sunday School Leaders being paid out of their own funds):

#### Eastern Pilgrim College Special Apportionment

8. BE IT RESOLVED, that each church raise a minimum equivalent to  $25\phi$  per member, per month, for the Eastern Pilgrim College.

#### Conference Remembrances for Bereaved Ministers' Families

9. SINCE, there are times when death enters the immediate family of our ministers,

BE IT RESOLVED, that the District send a floral tribute and a love offering of \$50.00 to such bereaved families, payment to be made from the Retiring and Emergency Fund.

#### United Stewardship Fund

10. We recommend that the United Stewardship of \$8.00 per member per year: Foreign Missions 20%, Church Extension 14%, Administration 36%, Sunday School and Youth 2.6%, Senior College 21.4%, Church Extension Loan Fund 3%, Contingent 3%, this fund to be raised monthly.

It shall be the responsibility of the pastor and the church board to see that their church raises its portion of the United Stewardship Fund. It shall be raised as one item under the term "United Stewardship," and shall be raised monthly.

#### Cash Balance to Be Retained by Youth Leaders

11. WHEREAS, there is a financial inconvenience placed upon Young People's Zone Leaders having insufficient funds to engage a speaker and for advertising purpose, BE IT RESOLVED, that each Youth Zone Leader be permitted to retain a working balance of \$35.00 throughout the conference year and that all money in excess of \$35.00 shall be forwarded to the District Youth Treasurer. (As amended by the 1957 Conference).

#### **District Conference Expense Assessment**

12. RESOLVED, that each church provide the District Conference with no less than 4.00 each for the pastor and delegate, or delegates, who attend the District Conference, and that all other members of the District Conference). (As amended by the 1955 Conference).

#### Church Building Loan Fund

13. WHEREAS, a generous gift of \$500.00 has been received by the District Council with which to establish a fund from which loans may be made to new and needy churches,

BE IT RESOLVED, that we maintain a Church Building Loan Fund. The fund is to be held in trust by the District Council, and

That 5% of the total Home Missionary Offerings be appropriated by the District Treasurer to the increase of said Church Building Loan Fund.

Loans can be made from said fund by the Council to congregations endeavoring to erect or buy a church or parsonage, but only after a thorough investigation of the financial status of the congregation by the Council. (Paragraph 4 as amended by 1953 No. 2).

When a loan is granted, the congregation to which the loan is made shall give a note to the District Treasurer signed by the local trustees.

The principal shall be paid back in installments, with interest at 5% in advance, monthly, except that the minimum charge for interest shall not be less than  $50\phi$  per month. The amount of the monthly installments shall be determined by the District Council.

The District Treasurer shall mail a statement of the amount due on the 20th of each month to each church that has a loan from said fund.

In the event that a congregation which has made a loan according to this plan, fails to meet its installments for a period of three months, its financial standing shall be investigated by the District Council.

#### **Parsonage Utilities**

14. WHEREAS, some of our churches provide the utilities for their parsonages, and

WHEREAS, there is a growing interest among the District churches to provide the same,

BE IT RESOLVED, that, as far as possible, each church provide its parsonage with a cooking range, electricity, fuel for heating and cooking, water, and telephone service.

#### District Superintendent's Salary and Allowances

15. BE IT RESOLVED, that we pay our District Superintendent a salary of \$4,680.00 per year, supply his utilities and fuels, pay his telephone, postage, and telegraph expenses, and that the Superintendent shall be paid at

the rate of seven cents per mile, for all travel in the interest of the District directly from the Superintendent's fund, and that the offerings taken at the time of the Superintendent's visits be given to him to be applied toward travel expense. The District Superintendent shall submit his mileage report to the District Treasurer at least once per month for payment. (As amended by the 1958 Conference).

#### **Emergency Moving Provisions for Pastors**

16. In the event a pastor is forced to vacate the parsonage, not having received a pastoral call to another church:

BE IT RESOLVED, that the District shall pay up to one hundred dollars (\$100.00) toward his moving expenses, all such payments to be made from the Retirement and Emergency Fund.

# STANDING RULES

## Time of Conference

1. The District Conference shall convene annually in the auditorium of the Eastern Pilgrim College at 10:00 a.m., Tuesday morning following the commencement exercises, and all committees shall meet on Monday at 2:00 p.m.

#### **Conference** Bar

2. The first twelve rows of seats and forward shall constitute the Conference Bar.

#### Time of Sittings

3. Sittings of the District Conference shall be from 8:30 a. m. to 11:30 a. m.; 1:30 p. m. to 4:30 p. m.; and 6:30 p. m. to 9:00 p. m.

#### **Conference** Communion Service

4. The first part of the first session of our District Conference shall be devoted to observing the Sacrament of the Lord's Supper with the presiding officer in charge.

#### **Time of Ordination Service**

5. The Ordination Service shall be held at 10:30 a.m. the second day of Conference.

#### Minimum Age for District Conference Delegates

6. Delegates to the District Conference must be 18 years of age or over.

## **Unfinished Conference Business**

7. At the close of the Conference, the District Council shall attend to any business that may have been overlooked, and approve the minutes of the closing sitting.

#### **Committee Appointments**

8. The District Superintendent with Council consultation shall appoint all committees.

#### **Permanent Committees**

9. The following committees: Resolutions, Ways and Means, Publicity and Reporting, Editing, Auditing, Memoirs, Reception, Statistical and Ministerial Convention shall be permanent.

#### **District Trustees**

10. The members elected each year to the District Council shall simultaneously be elected to the Board of Trustees.

#### Ministerial in Memoriam

11. A picture and a brief sketch of the labors of deceased ministers shall be placed in the Conference Journal.

#### Superintendent's Vacation

12. The District Superintendent shall have a three weeks vacation annually, with pay.

#### **Christmas Offering for Superintendent**

13. The District Secretary shall write to all ordained ministers, deaconesses, and all licensed ministers in regards to a Christmas love offering to be sent to the District Treasurer and forwarded to the District Superintendent and family by December 15th.

## **Ministerial Convention**

14. A two-day Annual Ministerial Convention shall be held in Wesley Chapel beginning 10:00 a. m. the first Tuesday after Easter.

#### **Installation Service**

15. An Installation Service shall be conducted by some district official for each incoming pastor to the local church.

#### **Pastors' Vacations**

16. The District Conference recommends that each church in the Conference give its pastor a two week vacation with pay each year.

#### **Procurement of Loans**

17. The District Council is authorized to work with any local church in procuring loans using the financial standing of the Conference, as reflected in the property statement and the District Treasurer's balance sheet, as the basis of negotiations for such loans.

## Transfer of General Resolutions to Standing Rules

18. The District Secretary is authorized to transfer items that are in reality rules of procedure and orders of the day to standing rules.

# THIRD ANNUAL DISTRICT YOUTH CONFERENCE PROCEEDINGS

The third annual youth conference of the Pennsylvania-New Jersey District of the Pilgrim Holiness Church convened at the Hughesville Holiness Association Camp Grounds, Hughesville, Pa., on August 15, 1958, at 3:00 p. m.

The Executive Youth Secretary, Reverend Charles Lewis called the Conference to order.

Reverend Kenneth Masterman led the conference in singing "What a Wonderful Saviour." Prayer was offered by Reverend John Wiktorchik.

The Executive Youth Secretry introduced Reverend M. T. Cockman of the General Church Extension Department. Reverend Cockman complimented the Youth Camp Board on their Educational Plan of teaching the History, Doctrine and Standards of the Pilgrim Holiness Church. He also presented the "Family Plan" of giving one dollar a month to General Church Extension.

Reverend Lewis read of the changes made in the district youth organization by the recent action of the 1958 General Conference. The business session followed with Reverend Lewis presiding.

The Secretary called the roll and the conference bar was established. The first six rows of the front section of the tabernacle constituted the conference bar.

The Chairman called for the report of the combined Resolutions and Ways and Means Committee. The Secretary, Reverend John Wiktorchik read the resolutions.

Resolution Number I was read, moved, seconded, and carried. (See report of Committee).

Resolution Number II was read, moved, seconded, and carried.

Resolution Number III was read, moved, seconded, and carried.

The floor was opened for discussion.

Reverend Robert Tice recommended a sign on the highway directing visitors to the Youth Camp. (No Action).

The Executive Youth Secretary took a count of the delegates present from the seven Zones. He explained the new action of the 1958 General Conference, that is: All Zone Leaders are to be elected at the District Youth Conference by delegates from their Zone.

It was discussed whether or not the district should be re-zoned.

It was moved, seconded, and carried: that the Executive Youth Council study the Zone situation of the district, and report to the 1959 Youth Conference.

The next order of the day was the election of the Executive Youth Council as provided by the action of the 1958 General Conference. John Wiktorchik, Paul Braisted, Arthur Yeager, John Smith, and Paul Smith were appointed as Tellers and Ushers respectively.

The Secretary read the nominations from the District Council for the office of District Youth President as follows: Reverends Charles Lewis, George Harris, James Brillhart, and John Wiktorchik.

The first ballot produced the election of Reverend Charles Lewis as Distric Youth President. Upon request Brother Lewis made a speech.

An open ballot was cast for the new office of District Youth Vice President.

With no election on the first ballot, a motion was carried to retain the two highest names.

The second ballot declared Reverend James Brillhart as the District Youth Vice President.

Open ballots were prepared for the new office of District Youth Secretary.

With no election on the first ballot, a motion was carried to retain the four highest names. There being no election on the second ballot, a motion was carried to retain the two highest names.

The third ballot declared Reverend David Wooten as District Youth Secretary.

The nominations for District Youth Treasurer were read by the Secretary as follows: Reverend George Harris and Reverend John Wiktorchik.

The first ballot declared Reverend John Wiktorchik as District Youth Treasurer.

Questions were raised as whether members of the Executive Youth Council could hold office as Zone Leader; and whether Zone Leaders could be over 35 years of age.

Reverend Lewis answered that there are many little details concerning the new organization that will be answered by the new forthcoming Youth Handbook.

In accord to the new action by the 1958 General Conference, the delegates divided into Zone groups for election of their Zone Leader.
