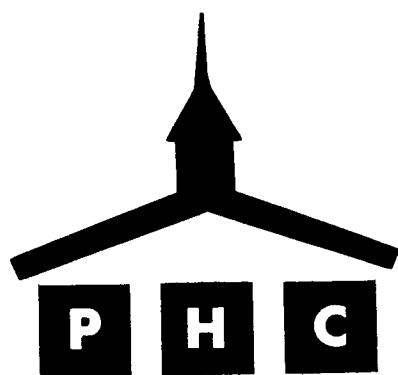

## CONFERENCE PROCEEDINGS

### FIRST SITTING:

July 7, 1967

The twenty-ninth Annual Conference of the Pittsburgh District convened at the call of District Superintendent, Rev. J. L. Clark, at 10:30 A. M., July 7, 1967, meeting in the Youth Tabernacle of the Cherry Run Camp Grounds, near Rimersburg, Pa.

Rev. Frederick Schaffner, a student at Eastern Pilgrim College, led the conference in singing the old hymn, "The Solid Rock."

Assistant Superintendent, Rev. E. S. Rutherford, led the Conference in prayer.

Rev. Clark then introduced to the Conference, Dr. P. F. Elliott, General Superintendent, who brought greetings from the Board of General Superintendents. He spoke relative to the wonderful spirit of unity and harmony that has prevailed throughout the denomination. Though Pilgrims may not always agree on every minute detail, he intimated, we can have a spirit of harmony and love one for another.

The District Secretary was asked to call the roll.

By common consent it was agreed to seat Mrs. Nelson Douglass as a delegate from the Elizabeth Church.

A motion prevailed that the Conference Bar include the platform and the first seven rows of seats.

By common consent, it was agreed that Mrs. Brink, wife of the delegate from Linesville should be seated within the Conference Bar to render assistance to her husband.

A motion carried that Rev. E. S. Rutherford, from the Pennsylvania-New Jersey District, Rev. Wilbur Antrim, (Pa.-New Jersey District), Rev. E. E. Lindsey (Ontario District), and Rev. Samuel Butler, (Pa.-New Jersey District) be received as ministerial transfers from these Districts. Rev. Rutherford and Rev. Antrim were introduced to the Conference, the other brethren having not yet arrived.

It was moved, seconded, and carried that the time of the sessions shall be:

Dr. Elliott called for the report of the District Superintendent. District Superintendent, Rev. J. L. Clark, then presented his report, which noted areas of needed improvement as well as areas of growth and development. This fine report was received by a rising vote of thanks, with all delegates deeply appreciative of the excellent leadership Rev. Clark has given to the Pittsburgh District.

Assistant District Superintendent, Rev. Earl Rutherford, presented an oral report of his activities during the time of his service as Assistant District Superintendent. A motion prevailed to receive his report with appreciation.

Rev. Paul Braisted, District Treasurer, read the Auditor's report, as the ushers passed out mimeographed copies of the Treasurer's report.

A motion carried that the report of the Auditor be received.

At this time, several announcements were made, and the First Sitting of the 1967 Pittsburgh District Conference adjourned with a benediction being offered by the Rev. James K. Reed.

## SECOND SITTING:

July 7, 1967 - 1:30 P. M.

The second sitting convened at 1:30 P.M. Mr. William Campbell, delegate from the Warren Church led the Conference in singing, "Draw Me Nearer." Mrs. Hazel Piper, delegate from McKeesport presided at the piano.

A request for prayer was presented in behalf of Mrs. Lois Waddell, wife of the pastor from McKeesport, who has been ill.

Rev. Nelson Douglass led the Conference in prayer.

Rev. E. E. Lindsey, new pastor at Donora, who was transferred into the Conference in the morning sitting, was introduced to the Conference.

Three lay delegates: Arthur Bennet, (West Freedom); William Huweart (Donora); and James McClintock, (Donora) were introduced to the Conference, and seated within the Conference Bar.

The minutes of the first sitting were read, and approved as read.

District Treasurer, Rev. Paul Braisted read the Treasurer's Report, reading only the totals, inasmuch as delegates had in possession mimeographed copies of said report.

A motion carried that the report of the District Treasurer be received.

Rev. Kenneth Reed then presented Rev. Donald Boyd, Conference President of the Allegheny Conference of the Wesleyan Methodist Church, Rev. David Robertson, pastor of the Sandy Lake Wesleyan Methodist Church, Rev. Henry LeLear, General Evangelist of the Wesleyan Methodist Church, and Rev. Charles Boston, of Coopers-town, Pennsylvania. Each of these men brought words of greetings and testimony.

A motion prevailed that they be granted honorary seats within the Conference Bar.

The District Statistician, Rev. Newell Reed, presented his report. A motion carried to receive the Statistician's report.

Dr. Elliott called for the report of the District Sunday School Promotional Secretary. Rev. C. Lindy Adams read the report of Rev. Annie Carlson, who was Sunday School Promotional Secretary last year.

A motion carried that the report of the Sunday School Promotional Secretary be received.

Rev. Richard Williams, District Sunday School Treasurer reported on District Sunday School Finance. A motion prevailed to receive this report.

The District Director of Christian Education, Rev. M. E. Waddell, presented a report of both District Christian Education, and the Pilgrim Evangelical Leadership Training. By motion carried, this report was received. Rev. Waddell spoke words of appreciation to Rev. J. L. Clark for his help and assistance in the work of Christian Education on the District level.

The District C. Y. C. Director, Rev. Roy Humphries, reported on the District C. Y. C. Program. His report revealed great gains throughout the District in this area. By motion carried, this report was received.

The attention of the Conference was called to the C. Y. C. Booth Rev. Humphries constructed in the main tabernacle.

A motion prevailed that the report of the Memoirs Committee be postponed until the evening sitting.

Dr. P. F. Elliott presented certificates of recognition from the Board of General Superintendents to the following churches and pastors for their giving to the General United Stewardship Fund: Bellebridge, 100% (3 star); Bentleyville, 100% (3 star); Geneva, 100% (3 star); McKeesport, 100% (3 star); New Castle, 100% (3 star); Weedville, 100% (3 star); West Newton, 100% (3 star); Warren, 100% (3 star); Josephine, 91% (2 star); Armbrust, 86% (1 star). The pastors and delegates of the above churches were congratulated for the faithfulness in Denominational giving which is reflected by these percentages.

The General Superintendent called for the report of the Conference Action Committee, which reported through its secretary, Rev. C. Lindy Adams.

The election of officers then became the order of the day.

Ballots were cast for the office of District Superintendent. Rev. J. L. Clark was overwhelmingly re-elected to the office of District Superintendent on first ballot, being elected for a two year term. Fitting words of appreciation and acceptance were spoken by Rev. Clark.

Balloting resulted in the election of Rev. E. S. Rutherford to the office of Assistant District Superintendent, being elected on second ballot. He also spoke words of appreciation and acceptance, pledging loyal support and help to Rev. J. L. Clark.

The District Secretary read the following names as District Council Nominations for the office of District Secretary: M. E. Waddell and Newell Reed. Voting resulted in the election of Rev. M. E. Waddell as District Secretary on first ballot.

The nominations from the District Council for the office of District Treasurer were read. They were: Paul Braisted, Ralph Houseman, and Wayne Chapman. The voting resulted in the election, on first ballot, of Rev. Paul Braisted as District Treasurer.

Ballots were then cast for the Advisory Members of the District Council. By common consent it was agreed the tellers would count the ballots after adjournment.

A motion prevailed that the second sitting of the Pittsburgh District Conference adjourn. Prayer was offered by the Rev. Donald Boyd.

## THIRD SITTING:

July 7, 1967 - 7:00 p. m.

The third sitting of the Pittsburgh District Conference was called to order by District Superintendent, Rev. J. L. Clark, at 7:00 p.m.

The order of business was the report of the Memoirs Committee and a Memorial



Service for those who have gone to their Eternal Home. Chairman, Rev. Wayne Chapman, led in prayer, and also led the congregation in singing, "What a Friend We Have In Jesus." Mrs. Paul Braisted presided at the piano.

Rev. James K. Reed read from God's Word, reading St. John 5:19-29 and Revelation 21:1-7.

Rev. Chapman then read Psalms 23, and spoke some very fitting words relative to the life of the Rev. W. E. Burgess. Brother Burgess, who was a member of the District Council, District Youth President, and served on various committees had endeared himself into the hearts of young and old alike. His ministry and work on the Pittsburgh District will long be remembered.

Rev. Chapman also made mention of the home-going of veteran missionary, Miss Bertha Joy, who went to meet her Lord last winter, from the Continent of Africa.

He also mentioned others who have departed to be with the Lord this past year.

Then, the Memorial Service was concluded with Brother Chapman reading a poem entitled, "Beyond This Vale of Tears."

District Superintendent Clark turned the Conference over to the Presiding Officer, General Superintendent Elliott.

The minutes of the second sitting were read and approved as read.

The tellers, who had tabulated the vote for advisory members of the District Council reported. Balloting resulted in the election of Rev. Jack Pease, and Rev. C. Lindy Adams.

A motion prevailed that the Conference vote on the four highest for the office of Advisory Member of the District Council, which were: Rev. Ralph Houseman, Wayne Chapman, Newell Reed, and J. K. Reed. On the second ballot, Rev. Ralph Houseman was elected the third Advisory Member of the District Council.

The District Council nominations for the three year term on the Educational and Examining Board were read. They were: Newell Reed, C. L. Adams, and Jack Pease. Rev. Newell Reed was elected for the three year term on the Educational and Examining Board.

A motion carried that the Conference authorize the District Council to appoint the P. E. L. T. and the C. Y. C. Directors.

Dr. Elliott called for the report of the Educational and Examining Board. Rev. Earl Rutherford read the report, and by motion it was received.

The Order of Business became the election of delegates to the International and Merging General Conferences.

It was reported that the Pittsburgh District would have three Ministerial Delegates besides the District Superintendent. Ballots were cast for the Ministerial Delegates to the International and Merging General Conferences. Rev. M. E. Waddell was elected on first ballot.

A motion prevailed to vote on the three highest who were: Rev. Jack Pease, Rev. Earl Rutherford, and Rev. Paul Braisted. Rev. Earl Rutherford was elected.

Ballots were then cast for one additional Ministerial Delegate to the International and Merging General Conferences from the names of Paul Braisted and Jack Pease.

A motion carried that the District Council excuse itself for the purpose of bringing to the Conference at least 8 nominations for Lay Delegates to the International and Merging General Conferences. It was announced that the Pittsburgh District would have three Lay Delegates to the International Conference, and four Lay Delegates to the Merging General Conference.

A motion carried that the second highest in the vote for Ministerial Delegate to the Merging Conference (between Paul Braisted and Jack Pease) would be the first alternate.

Balloting resulted in the election of Rev. Jack Pease as the third Ministerial Delegate to the International and Merging General Conferences, and Rev. Paul Braisted as first alternate.

At this time, Rev. Kenneth Reed introduced Rev. G. A. Castevens, pastor of the Pilgrim Holiness Church of Roanoke, Virginia, and the Evangelist for the 1967 Pittsburgh District Camp, who brought greetings to the Conference.

By motion, carried, he was granted an honorary seat within the Conference Bar.

The nominations of the District Council for lay delegates to the International and Merging General Conferences were read. They were: H. E. Neff, Walter Lynch, William Crouse, Ernest O'Vell, Joseph Jeffers, Allen Cannon, Sr., Wayne Howard, Jim McClintock, William Campbell, and William Kunkle.

Two additional nominees were named from the floor: Hazel Piper, and Daniel Slozat.

A motion prevailed that those next in line serve as alternate Lay Delegates. It was announced that the first three elected would be Lay Delegates to the International Conference, and that the first four elected would be Lay Delegates to the Merging General Conference.

Mr. H. E. Neff was elected on first ballot as a Lay Delegate to both the International Conference and the Merging General Conference.

A motion carried to vote on the five highest: Walter Lynch, Ernest O'Vell, Allen Cannon, Sr., William Kunkle, and Hazel Piper. Balloting resulted in the election of Ernest O'Vell and Walter Lynch, who along with H. E. Neff, will serve as Lay Delegates to the International Conference. Those elected as Lay Delegates to the Merging General Conference are: H. E. Neff, Ernest O'Vell, Walter Lynch, and William Kunkle, with Allen Cannon, Sr., Hazel Piper, Daniel Slozat, and James Jeffers elected as alternate Lay Delegates.

A motion prevailed that the District Council approve the minutes of this third sitting prior to printing.

A motion carried that the Pittsburgh District Conference express its sincere appreciation to the Rev. Armor Peisker, General Editor, and his staff, for the excellent work they have performed in the publication of the Pilgrim Holiness Advocate.

At this time several announcements were made.

The Conference Action Committee brought the following resolution: RESOLVED, that this Conference express its appreciation by a rising vote of thanks to General Su-

perintendent, Dr. P. F. Elliott, who so ably presided over the Conference; to our beloved District Superintendent, Rev. J. L. Clark; to the dining and lunch room staffs, and to all others who have labored for our comfort and the success of this 1967 District Conference.

A motion prevailed that the Conference express its appreciation to Miss Francene Allison for her assistance and help to the District Secretary, by serving as Conference Typist.

The twenty-ninth Annual Conference of the Pittsburgh District adjourned by motion carried, at 9:35 p.m.

Prayer was offered by Dr. P. F. Elliott for District Superintendent J. L. Clark, and for the District Council. While singing the song, "Blest Be The Tie That Binds", the delegates marched forward and shook hands with Rev. Clark and the newly elected District Council.

### **DISTRICT SUPERINTENDENT'S REPORT**

To our esteemed General Superintendent, Dr. Paul F. Elliott, fellow ministers, and lay delegates of the Twenty-ninth Annual Conference of the Pittsburgh District:

Greetings in the name of our Saviour and Shepherd:

God has been merciful in granting us this pleasant opportunity of coming together from our respective district churches to this place of Christian business and fellowship. Somehow may His Holy Spirit so captivate this Conference that each minister and lay delegate will get a fresh touch of God and then go back to our churches energized and full of renewed purpose to get more souls into the Kingdom of God and our churches.

Let us briefly review the past year's endeavor on the Pittsburgh District:

#### **THE MISSION OF RENEWAL**

This "mission" was presented by the Superintendent to the district constituency during the 1966 camp meeting. The District Council and all other departmental boards then set out to define and implement the various tenets of the "mission". You will recall it called for Renewal of Preacher, People and Property where necessary.

To strengthen and encourage our pastoral service, two ministerial meetings were held in each of the two areas of the district. Seven issues of a preacher's paper were published. To stimulate and involve our laity in Kingdom building, several district projects were introduced and promoted with most churches co-operating. These included: Seven Sundays of Evangelism, a Sunday School promotional - "Race for Space", Membership Sunday, Cradle Roll Enrollment and Family Month. Also, zone PELT classes, under the able leadership of Rev. Mark Waddell, were held with over 100 enrolled. Complementing this ministry, two area Christian Education institutes with Rev. O. D. Emery and Rev. Wayne Pruez were conducted and capped with a district wide Sunday afternoon conclave. The results of these multiple ventures as a district are gratifying; yet the statistics reveal that there is a deepening need for fervent praying, increased VISION and a Revival of Divine grace and power in our midst.

Those churches showing membership gains are: Armbrust 15, Clinton 5, DuBois 8,

Emlenton 11, New Castle 7, Rimersburg 7, Twin Rocks 2, Warren 8, Washington 1, West Freedom 1.

Those churches reflecting Sunday School gains are: Armbrust 13, Bentleyville 9, Clinton 6, Emlenton 12, McKeesport 13, New Castle 12, Richeyville 1. (Note: All of these except Armbrust and Richeyville attained their "Mission of Renewal Goal".)

Several churches earned special recognition in payment of the USF. In a special report, Treasurer Braisted will list these and they will be duly honored. As a District, we paid 58.4% of our USF as compared with 46.5% last year.

Dr. Elliott has asked that we continue our "Mission of Renewal" emphasis this year.

#### CHURCH EXTENSION

Immediately after conference last year the Church Extension Board reviewed the possibility of transferring the present New Castle congregation to the East Side of New Castle to a building and a nucleus of people with the idea of launching an all out Church Extension project. The transfer did not materialize and a fellowship with five members was then organized on the East Side of New Castle. To make a long story short, the Church Extension Board, due to several extenuating circumstances, regretfully dissolved this work and fellowship, effective June 30, 1967.

#### EMLENTON CHURCH REORGANIZED

Under the excellent leadership of Rev. & Mrs. Kenneth Reed at Emlenton, the church, which in a previous year became defunct, was reorganized with seven members. Four others have since united. Plans are underway now for a building program.

#### CHRISTIAN YOUTH CRUSADE

This year DuBois and Bentleyville churches began a CYC program bringing the total to six churches now using this invaluable service to reach and train and evangelize children. Rev. Roy Humphries has done a fine piece of work in this field.

#### NEW CHURCHES DEDICATED

This year the following new church buildings were dedicated: Washington (\$45,000), Bellebridge (\$30,000), Armbrust (\$200,000).

#### PROPERTY IMPROVEMENTS

Rimersburg: Paneling of sanctuary walls, rest rooms, and nursery. Rev. Wayne Chapman, pastor.

Warren: Organ and wall to wall carpeting. Rev. Roy Humphries, pastor.

Bentleyville: Organ. Rev. Jack Pease, pastor.

Clinton: Almost single handedly, Pastor Braisted has completed the parsonage area of the parsonage-church building. (Value of the building, \$65,000.)

McKeesport: 3 story addition added to parsonage. Rev. Mark Waddell, pastor.

## DISTRICT INDEBTEDNESS

Some months ago the final payment was made in repayment to the Church Extension Fund.

## TWO CONGREGATIONS WITHDRAW

In recent weeks the congregations at Franklin and Strattanville along with their pastors, without any prior notice of intention, severed all relationships with the Pilgrim Holiness Church. Their right to withdraw is without question. The subtle, unscrupulous manner in which they acted is a violent contradiction of Christian ethics, to say the least. I must say that in respect to property settlement the Strattanville group has been honorable in asking to negotiate for a property settlement. The District Council has agreed to accept their offer of \$3,000.00. The settlement should be finalized shortly. Rev. Andrew Slozat and his Franklin group are claiming that the property never belonged to the Pilgrim Holiness Church and to date they have shown no disposition to negotiate. Should they persist in this attitude, they leave the Pittsburgh District no course but to litigate. In answer to those individuals who object to the Pittsburgh District's claim for property settlement in such cases, may we state that it is our inherent responsibility to preserve what Pilgrim Holiness preachers and laity have given - both in labor and money - in prior years for the establishment and continuation of a Pilgrim Holiness Ministry in the respective community. When such dissentients choose to divert Pilgrim Holiness Church property, bought and financed by Pilgrim Holiness Church dollars, to serve their own interests, the Pittsburgh District leadership would be extremely remiss to sit by and watch this spirit of divisiveness and rebellion go unchallenged..

## THE YEAR AT HAND

The imminent merger with the Wesleyan Methodist Church claims much prayer and planning in the coming months. A Comity Committee should be provided for by this Conference to establish liaison with the Wesleyans of this area. Of principle concern should be a request for the establishment of new district boundary lines so as to assure full time supervision for this area immediately following the 1968 Merging General Conference.

In the area of district administration for this coming year, there should be a renewed emphasis on:

1. The development of a Total Church Ministry in every church: CYC, VBS, Sunday Evening Training Hour, Youth, and Lay Visitation.
2. A definite effort to conserve more of our converts -- junior members, too.
3. Improvement in quantity and quality of pastoral calling.

## PASTORS

We are all saddened by the home-going of Rev. Wilbur Burgess, our pastor at Bellebridge and District Youth President. His presence and leadership are greatly missed.

Rev. Miss Bertha Joy, one of our missionaries to Africa, went to her eternal reward last November.

Coming to the Pittsburgh District in November was Rev. E. S. Rutherford to Weedville; more recently Rev. E. E. Lindsey to Donora, Rev. Wilbur Antrim to DuBois and Rev. Samuel Butler to Bellebridge. We welcome these brethren.

## APPRECIATION

The co-operation and prayers of the District Council and the other district boards, the local church boards and congregations has been constantly evidenced and is deeply appreciated.

## PERSONAL REPORT

Presided over six District Council Meetings, four Church Extension Board Meetings; attended two District Christian Education Board Meetings; two Youth Council Meetings. Visited all the churches or pastors at least once; conducted ten annual meetings; attended four EPC Board Meetings; served on the Merger Committee for EPC and Owosso College and attended meetings at Allentown, Wilmington, Owosso and Indianapolis; attended Leaders' Conference at Richmond, Virginia; dedicated one church; assisted in dedication of two churches; and taught four lessons in the PELT classes in February; published seven issues of "Between Us Preachers", and three issues of the Pilgrim Messenger; have pastored the Armbrust Church and taught a Youth Sunday School Class.

My salary and mileage have been paid to date.

## REPORT OF SUNDAY SCHOOL PROMOTIONAL SECRETARY

To the 1967 Annual Conference of the Pittsburgh District, greetings.

This conference year has been a busy one for District Sunday Schools. We give the Lord praise for the accomplishments resulting from our various promotional programs. In September a lively Race for Space campaign was very effective with 118 new scholars enrolled and 720 visitors attending during the month. First place winner in the contest was Bentleyville while Armbrust received the second place award, each a lovely set of maps.

January's Baby Hunt netted 60 new little ones added to the cradle rolls over the District.

Christian Education Seminars in March, though not initiated by the Sunday School Department, proved extremely helpful to teachers and workers as did the zone meetings of October. Workers from the General Headquarters were featured in both.

March also is known for the annual attendance punctuality thrust throughout the denomination in the form of MARCH TO SUNDAY SCHOOL IN MARCH. Our district did well in these areas.

This year's conference theme has been MISSION OF RENEWAL with its goal of a 10% increase in all departments. The Emlenton church reached this goal in average attendance every month. New Castle showed a 10% gain ten of the twelve months while McKeesport reached the goal nine times. Many others attained their goal several times throughout the year. A note of appreciation is in order for these churches.

Records indicate that Sunday School attendance in America is down slightly in all churches. However, Pittsburgh District records are encouraging. Our average attendance for 1965-66 was 60 25/27 while the 1966-67 average is down only a fraction as it stands at 60 19/27, a loss of only 2/9. The enrollment last year was 2,314 while it is

2,291 for the 1966-67 conference year, a loss of 23.

It was reported from the office of Rev. O.D. Emery, General Secretary of Sunday Schools and Youth, that the McKeesport Sunday School placed second in the denomination in the class "B" classification in the "March To Sunday School In March" drive.

## REPORT OF THE DIRECTOR OF CHRISTIAN EDUCATION AND P. E. L. T.

Mr. Chairman, Delegates, and friends of this 29th Annual Conference of the Pittsburgh District of the Pilgrim Holiness Church.

It was in a meeting of the District Council conducted on these grounds on July 12, 1966, that a motion carried that the District Director of Christian Education also serve as the District Director of P. E. L. T. Also, in that Council Meeting, it fell my lot to be elected to serve in this capacity.

The Purpose of the District Director of Christian Education, of course, is to endeavor to correlate the entire program of Christian Education on a District level. This effort was to cover the fields of Sunday School, Youth, Christian Youth Crusaders, and Pilgrim Evangelical Leadership Training.

Two meetings of the District Christian Education Board were conducted; one last September 8th, and the other in the month of January. The personnel of the Board consisted of the District Superintendent, Assistant District Superintendent, Sunday School Promotional Secretary, District Youth President, District C. Y. C. Director, and the District Director of Christian Education and PELT.

Inasmuch as these various agencies will be reporting through their directors, very little of their activities will be covered by this report. Suffice it to say that the exchange of ideas did serve to correlate the total program of Christian Education on the District level, and all felt that more adequately we could:

1. Win others to Christ.
2. Train others in Christ.
3. Send forth others for Christ.

The climax of the entire year's activity was the very special Christian Education Rallies conducted in Strattonville on March 2; in Donora on March 3; and the District Wide Rally at Armbrust on Sunday afternoon, March 5th.

Rev. O. D. Emery, General Secretary of Sunday Schools and Youth, and Rev. T. Wayne Preusz, of the office of the Department of Sunday Schools and Youth, were the special workers. Their efforts were greatly appreciated, and Eternity alone will reveal all the good accomplished.

And now, just a few words relative to the P. E. L. T. Program. Plans were laid for some simultaneous PILGRIM EVANGELICAL LEADERSHIP TRAINING CLASSES to be conducted during the month of February and a part of March on successive Monday nights. These classes were held in the southern part of the District in a different church each Monday night. Rev. J. L. Clark, District Superintendent, very ably and efficiently served as instructor. On two occasions, he was unable to teach because of illness in the family. However, Mrs. Eleanor Braisted, a certified PELT instructor, very ably filled in on those occasions. The total in attendance in these classes averaged around 50.

Thirty-two people were presented PELT Credit Cards for successfully completing the course.

Also, Rev. Earl Rutherford taught PELT Classes in the DuBois-Weedville area, and Credit Cards were given to 15 people.

Because of the distance, it was not feasible for the Clinton Church to participate in the united PELT thrust in the Southern area of the District; however, Mrs. Braisted taught the course in the Clinton Church, which resulted in credits being awarded to 5 people.

While we are a long way from arriving, as far as Christian Education and PELT are concerned, we do appreciate the headway we have made. WE ARE HEADED IN THE RIGHT DIRECTION. Let me express my deep appreciation for the fine co-operation, and especially to those who served as instructors. May God bless you one and all. Let us make 1967-68 the greatest year ever on the Pittsburgh District, in the great field of CHRISTIAN EDUCATION.

### STANDING RESOLUTIONS

#### DISTRICT CONFERENCE

1. RESOLVED, That the fiscal year of the District shall run from June first to May thirty-first.
2. RESOLVED, That all annual reports shall be sent to the District Statistician postmarked no later than June 20.
3. RESOLVED, That the Educational and Examining Board shall consist of 3 members serving in a rotating basis with the term of one member expiring each year and a full term to be a period of 3 years.
4. RESOLVED, That a minimum of one ministerial gathering shall be conducted annually in each of the northern and southern areas of the district under the supervision of the District Superintendent.
5. RESOLVED, That a district ministerial convention be held the first Monday and Tuesday of November and that the said convention shall consist of five services, concluding with the afternoon service on Tuesday. The convention shall begin with a communion service at 11 a.m. on Monday, and further the emphasis of the convention shall be the spiritual life of the minister; and be it further RESOLVED, That papers shall be assigned by the District Council for reading and discussion at said ministerial convention.
6. RESOLVED, That a district news media, known as Pilgrim Messenger, shall be published monthly (except July and August) and distributed to the churches by the District Superintendent or his delegate.
7. RESOLVED, That the Resolutions and Ways and Means Committees be combined into one committee known as The Conference Action Committee.  
  
BE IT FURTHER RESOLVED, That this committee consist of seven (7) members.
8. RESOLVED, That copies of the Conference Action Committee report be sent to all pastors and delegates at least three weeks prior to conference.

9. RESOLVED, That the Pittsburgh District request the Executive Council of the General Board, or other authorized body to give consideration to the adjustment of District boundary lines, so as to assure full-time supervision for this area, immediately following the 1968 Merging General Conference.
10. RESOLVED, That a Comity Committee, comprised of the Executive members of the Pittsburgh District Council, be established to work with a comparable committee of the Wesleyan Methodists towards effecting merger on the District level.

15. RESOLVED, That the District Treasurer shall send to each minister and local church treasurer a copy of the Standing Ways and Means resolutions within fifteen days following the district conference.

#### DISTRICT CAMP

16. RESOLVED, That an annual District Camp Meeting be conducted, and further be it RESOLVED, That the supervision of the camp be under the direction of the District Council.
17. RESOLVED, That no concession be opened during service, nor until the close of the altar invitation.

20. RESOLVED, That each pastor be granted a minimum of three weeks vacation with pay after serving five years in the ministry of the Pilgrim Holiness Church; a minimum of one week with pay shall be granted the first year; a minimum of two weeks the second, third, and fourth, and  
RESOLVED, That the pastor select a supply preacher who shall be remunerated by the church.
21. RESOLVED, That the pastor shall be called by the Promotional Secretary in the event of a delinquent Sunday School attendance report, and said charges shall be reversed.
22. RESOLVED, That no pastor shall be permitted to conduct any kind of special service during the District Camp, Conference, and Ministerial Convention without the consent of the District Council.

## LOCAL CHURCH

23. RESOLVED, That each church be encouraged to give an offering to the lay delegate towards his expenses to the District Conference.
24. RESOLVED, That each local church shall enroll and pay the membership calls in the Ministerial Benefit Association for the pastor and his wife.
25. RESOLVED, That whereas most of our lay members have provided for them Hospital, Medical and Surgical benefits by their employer; and  
WHEREAS, the majority of our pastors are on a sub-standard salary,  
RESOLVED, That each local church shall be encouraged to assume the cost of the quarterly premium of Hospital, Medical and Surgical benefits for the pastor and his family.

## CHURCH EXTENSION

26. RESOLVED, That the Executive members of the District Council shall constitute the District Church Extension Board; and  
RESOLVED, That the committee have the following authority:
1. The selection of workers.
  2. The general location to start the new churches.
  3. Type of buildings to be used.
  4. The raising and spending of funds; and
- RESOLVED, That the District Church Extension Worker requirements be as follows:
1. Written contract between the committee and the worker.
  2. Monthly reports from the worker to the committee.
  3. The responsibility for the worker's salary is to be gradually assumed by the new work with a diminishing responsibility on the part of the committee; and
27. RESOLVED, That the matter of raising funds for any Church Extension project shall be the responsibility of the Church Extension Committee subject to the approval of the District Council.

## WAYS AND MEANS STANDING RESOLUTIONS

RESOLVED, The District Superintendent when in need of additional help in the administration of district work shall secure the services of his assistant who shall be remunerated \$10 per day plus 9¢ per mile travel expense.
36. RESOLVED, That the following district officers shall be compensated accordingly; Treasurer - \$240.00; Secretary - \$75.00; and Statistician - \$25.00.
37. RESOLVED, That the cost of publishing the Pilgrim Messenger shall be underwritten as prescribed: District Youth - \$3.00 a month, District Sunday School - \$3.00 a month, and the balance of cost from the District Budget.
38. RESOLVED, That the cost of publishing the Conference Journal shall be underwritten from the two following sources: Allocation of 10% of District Budget, and distribution of Journal, as per ordered by the churches, at 50 cents per copy.
39. RESOLVED, That all persons engaged in authorized district travel shall be compensated at the rate of nine (9) cents per mile; and RESOLVED, That any other expense incurred incidental to the district work also be paid.

## PITTSBURGH DISTRICT FINANCIAL PROGRAM

### 1. UNITED STEWARDSHIP FUND:

A. \$9.50 per adult member per year

### 2. EASTERN PILGRIM COLLEGE:

A. Twenty-Five (25) cents per member per month

### 3. DISTRICT ADMINISTRATION:

A. Each church shall contribute an amount equivalent to 5% of the Pastor's Salary.

B. Each pastor and supply pastor shall pay seventy-five (75) per cent of the tithe of his regular wages, both ministerial and secular, to the District, through the local treasurer.

C. All District ministers not pastoring shall pay 10% of their tithe from secular work through the local treasurer to the District Treasurer.

D. Churches with a membership of twenty-five or more shall remit to the District the sum of \$7.50 for each of two regularly scheduled visits by the District Superintendent or his designate. Churches with a membership less than twenty-five shall remit the sum of \$5.00

### 4. DISTRICT SUNDAY SCHOOL:

Based on the previous year's Sunday School Average, each Sunday School shall contribute each month to the District Sunday School Treasurer, accordingly:

- a. Less than 50 average .....\$1.00
- b. Average of 50-75 ..... 1.50
- c. Over 75 average ..... 2.00

### 5. DISTRICT YOUTH:

A. Each chartered Youth Society shall contribute 5% of its local receipts to the General Youth Department.

B. Each local Society shall contribute \$2.00 per month to the District Youth Treasurer, and churches with no organized Society likewise shall be asked to contribute \$2.00 per month to the District Youth Treasurer.
