STANDING RESOLUTIONS

- 1. That all buildings, such as churches, parsonages, or extensive improvements be approved by the District Superintendent before construction.
- 2. That no Church of our District shall call a pastor, evangelist, representative of Foreign Missions or other church institutions without consulting our District Superintendent.
- 3. That money shall be paid from District Treasury as directed by District Superintendent.
- 4. Being our conviction as to the standard of I Peter 3:3-4, be it resolved that all women of the church shall in public wear their dresses with full length sleeves, close fitting necks, and reaching at least half way between the knee and the floor; also leave off the wearing of all jewelry including wedding rings, and that they dress their children as becometh saints, not with half socks and dresses above the knee.

RESOLUTIONS PASSED BY THIS ASSEMBLY

- 1. We recommend that the Ways and Means, Resolutions, and Statistical Committees be appointed by the District Superintendent at the Assembly for the following year. Be it further resolved that any material may be presented to said committees diring the year.
- 2. That the pastors verify the reports of their respective churches before sending them to the District Assembly.
- 3. Be it resolved that the District Superintendent devote his entire time to the Church work of the District.
- 4. Whereas God in His great wisdom and goodness has seen fit during the past year to call to his eternal reward our beloved friend and colaborer, W. J. Boddy. Brother Boddy was a

faithful and aggressive missionary of the Peoples Mission Church, and spent his last days of service in a Holiness Mission in Denver. Constant in prayer, fervent in spirit, a messenger of comfort to the neglected everywhere, our brother poured out his life without reserve to the cause of Christ he so fondly adored and served. "He being dead yet speaketh." Be it therefore resolved that this memorial be spread upon the minutes of this Assembly.

- 5. We the members of the Fourteenth Annual Assembly of the Pilgrim Holiness Church resolve that there be given our District Superintendent, D. W. Reynolds, a rising vote of thanks to express our appreciation of his love and faithful service.
- 6. We the members of the Fourteenth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our General Superintendent, Walter L. Surbrook, a rising vote of thanks to express our appreciation of his labors of love and faithful service.

STANDING RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE

- 1. That all District monies be paid monthly through the local treasury.
- 2. That the District Superintendent be given a salary of \$1200.00 per year, together with his house rent and traveling expenses.
- 3. That all our churches take an offering for our District Superintendent on each official visit to each respective church.
- 4. That pastors and evangelists of this District, when working in the District, pay their tithe into the District Treasury.
- 5. That this Assembly proportion each church at the rate of \$2.00 per member, to raise the General and District funds.

- 6. That each local church furnish their parsonage with at least one cook stove, a heater, a kitchen cabinet, six chairs, a dining room table, and a dresser.
- 7. Whereas many of our pastors are not receiving sufficient financial support, and whereas many of the friends of the Church not being able to give cash, but would like to help in some material way, we therefore recommend that each local church designate one prayer meeting night each month as donation night for the pastor.
- 8. We recommend that each Sunday School take at least ten cents out of each weekly offering, to be sent to District Treasurer on District Tent Fund.
- 9. We recommend that the remuneration of the District Secretary and Treasurer be increased from \$25.00 to \$40.00.

WAYS AND MEANS RECOMMENDATIONS ADOPTED BY THIS ASSEMBLY

- 1. We recommend that we strike out Recommendation No. 2 on page four of the Minutes of our last District Assembly.
- 2. With reference to our District support of Foreign Missions, we hereby recommend that we whole-heartedly support the General Board's program of prayer and preaching on Missions, and will pledge ourselves to hold weekly prayer service and the monthly Missionary Rally. We further resolve to set our District Missionary Budget at \$2400.00 for the year, one third to go to Hone Missions and two thirds to Fireign Missions. In connection with this, we recommend that our pastors be responsible for raising their proportionate amount of this Missionary offering each month by a free will offering taken at the time of the monthly Missionary Rally.

DISTRICT SUPERINTENDENT'S REPORT

God has given us a blessed year with many battles and glorious victories. Throughout the District we have faced and fought the most trying circumstances in the history of the work. Never before had we experienced such severe and far reaching drought, dust storms and floods. But we have come through with hope and courage and will fight on till Jesus comes. Because of these trying conditions the people have moved away from certain sections of the country until our churches have suffered considerably.

On the other hand we have much to be encouraged about. Much has been done in the pioneer work this year. Rev. C. J. Meyers and family together with Rev. A. G. Wheeler and his people from Hawksprings put much effort into a pioneer meeting in Mitchell, Nebraska. Much good was accomplished in this meeting. and a number of souls were seeking salvation.

Rev. C. C. Coleman and wife, assisted by Rev. L. L. Miller and wife, held a good pioneer meeting at

Womer, Kansas. Many sought salvation in this meeting. Later they held a school house meeting at this same place.

Rev. Walter Drown started a pioneer meeting at Pierce, Colorado in a small hall, but the meeting soon outgrew the hall, and the big tent was erected. Brother and Sister Miller and Brother George Marshall helped go ahead with the meeting. There was real good interest and a number of souls seeking God.

Brother Coleman and wife and Rev. Orvan Kellar and wife recently held a tent meeting at Superior, Nebraska. Brother Coleman reports many souls seeking God in this meeting.

Rev. Herbert Haines, assisted by Brother and Sister George Marshall recently held a pioneer tent meeting in Grand Junction, Colorado. They report a good meeting at that place.

Other pioneer meetings in mission hall and school houses have been hald by the pastors and evangelists over the District.

While there has been but one new church organized, a number of preaching points have been started which we hope will develope into good churches.

This year I have made 98 church visits; not including Chapel services, I have preached 168 times; held 60 quarterly meetings and 29 annual business meetings. Held one revival effort which resulted in nothing much but the effort.

Besides a trip to the General Assembly at Frankfort, Indiana and another trip to the General Board meeting at Indianabolis, Indiana, I have traveled 13,423 miles in connection with the District work.

I have also spent two weeks in Kansas and Oklahoma in the interest of the Colorado Springs Bible Training School traveling about 2,000 miles. This expense and time was paid for by the Bible School.
