#### FIRST SITTING

The Seventeenth Annual District Assembly was called to order at 8:30 A. M. Monday, June 27, 1938, by Rev. W. L. Surbrook, General Superintendent. The members of the assembly joined in singing "The Lily of the Valley." Prayer was offered by W. F. Drown. Rev. P. W. Thomas read and commented upon Acts 2:37-47; 4:31-33, urging us to make Pentecost the central theme of our preaching.

Three churches, Canon City, Colo., Imperial, Neb., Champion, Neb., were presented by District Superintendent Rev. W. A. Elkins to the Assembly and were joyfully accepted.

It was moved and carried that the first five rows of seats in the south sections and the platform constitute the assembly bar.

It was moved and carried that the hours for gathering be as follows: 8:30 to 11:30 A. M., 1:00 to 4:00 P. M., and 6:30 to 9:00 P. M.

District Superintendent Rev. W. A. Elkins appointed Rev. B. O. Shattuck and Rev. C. H. Dael to serve as Reception Committee.

The summarized statistical report was read and accepted, and was commented upon by our General Superintendent who expressed his gratitude for the splendid gains made in Church and Sunday School work in this district.

District Superintendent recommended to this Assembly the following Ministers: B. O. Shattuck, Mrs. Alice Waldron, John Wilson, and Mrs. Minnie Barnes and a motion was made, seconded and carried that we accept them.

On the District Superintendent's recommendation Rev. Elsie McGaughey was granted an honorary seat in the assembly bar.

The reception committee then brought the following Ministers before our General Superintendent who presented them to the Assembly: Mrs. Alice Waldron, Mrs. Minnie Barnes, John Wilson, Edw. Waldron, E. G. Marsh, and Scott Clark.

Bro. Elkins introduced Rev. O. E. Howell to the Assembly.

Bro. Surbrook introduced Sister Shattuck to the Assembly. It was moved, seconded, and carried that she be granted an honorary seat in the Assembly bar.

Rev. Armor D. Peisker, and Miss Ruth Stapleton were appointed by the District Superintendent as the Auditing Committee.

The Chairman of the Ways and Means Committee read the Committee's standing recommendations and advocated that changes be made in recommendations number 2 and 9. It was moved, seconded, and carried that we adopt the recommendations.

Motion made and seconded that we extend the time of this sitting to 11:45.

Moved and seconded and carried that we proceed with the election of officers at 1:30 P. M.

## SECOND SITTING

An opening song service was led by R. D. Perry, and Marion Hill led in Prayer.

Motion carried to dispense with the roll call.

District Superintendent's report was read and accepted.

Greetings from Rev. C. J. Meyers and Rev. L. L. Miller were conveyed to the Assembly, and the Secretary was instructed to send them Greetings from this Assembly.

At the District Superintendent's suggestion a rising vote of thanks was given Mrs. Ruby Martin for her gift of property to the District.

Bro. Elkins appointed Bros. Perry, Canaday, Doll, and Freed as tellers, and the assembly proceeded with the election of officers.

Memorial No. 6 was presented. Moved and seconded that we adopt the same. Carried.

Memorial No. 8 was presented. Moved and seconded that we adopt it. Carried.

Ways and Means Committee recommendation No. 13 was read. Moved and seconded that we adopt it. Carried.

Recommendation was made that we rescind that part of recommendation No. 8 having to do with the District Treasurer's Salary and that we pay him \$40.00 per year instead of the amount stated in the original recommendation. Moved and seconded that we adopt the same. Carried.

The District Superintendent appointed the following standing Committees: Ways and Means, W. F. Drown, F. L. Freed and J. A. P. Porter; Resolutions: B. O. Shattuck, C. C. Coleman, D. W. Lacy; Statistical: Marion Hill, R. D. Perry and Ruth Stapleton; Auditing, Ruth Stapleton and Armor Peisker.

General Superintendent W. L. Surbrook gave information concerning the raising and paying of General Assembly Expenses.

Bro. Surbrook urged membership in the Ministerial Benefit Association and in the Burial Association of the Pilgrom Holiness Church.

Motion made and seconded that we refer to the District Council the matter of raising the money yet needed to defray the expenses of the General Assembly. Carried.

Memorial No. 7 was brought before the Assembly. Moved and seconded that we adopt the same. Carried.

We were dismissed with prayer by Bro. Dael.

#### FOURTH SITTING

The song service was led by Carl Dael. F. L. Freed and B. O. Shattuck led in prayer. Rev. W. F. Drown gave a message from 11 Cor. 4.

Minutes of previous sitting read and approved. Memorial to General Assembly No. 9 presented. Moved that we adopt. Seconded. Carried.

Auditing Committee, report read and accepted.

Treasurer's report read and accepted. The Treasurer then urged us on to a spirit of aggressiveness. Following this our District Superintendent raised the balance of money needed to pay for a District tent.

Report of Examining Committee read and accepted after some changes and additions were made.

General Superintendent W. L. Surbrook spoke in behalf of the Pilgrim Holiness Advocate. Assembly Delegates pledged themselves to try to secure 223 subscriptions.

Resolution that we stand and express our appreciation to our General Superintendent for faithful services rendered was adopted.

Resolution that we stand and express our appreciation to our District Superintendent for faithful services rendered was adopted.

Resolution that we stand and express our appreciation to our Assistant District Superintendent for faithful services rendered was adopted.

At the suggestion of the District Superintendent, the members of the assembly stood in appreciation of the members of the Statistical Committee, District Secretary and District Treasurer.

Bro. Elkins appointed the following Ministers to serve with himself as an Ordination Committee: W. F. Drown, Marion Hill, Charles Luscombe, and B. O. Shattuck. The charge was given by the General Superintendent to J. E. Canaday, Roy E. Davis, Mrs. Alice Waldron, Clifford Maxwell, and Floyd Prather.

Motion to adjourn was carried. The Seventeenth Annual Assembly was dismissed with prayer by General Superintendent Rev. W. L. Surbrook.

# STANDING RESOLUTIONS

1. We recommend that the Ways and Means, Resolutions, and Statistical Committees be appointed by the District Superintendent at the Assembly for the following year. Be it further resolved that any material may be presented to said committees during the year.

2. That the pastors verify the reports of their respective churches before sending them to the District Assembly.

3. That all buildings, such as churches, parsonages, or extensive improvements be approved by the district superintendent before construction.

4. That no church of our district shall call a pastor, evangelist, representative of foreign missions or other church institutions without consulting our district superintendent.

5. That money shall be paid from district treasury as directed by district superintendent.

6. Being our conviction as to the standard of 1 Peter 3: 3-4, be is resolved that all women of the church shall in public wear their dresses with full length sleeves, close fitting necks, and reaching in length at least half way between the knee and the floor; also leave off the wearing of all jewelry, including wedding rings, and that they dress their children as becometh saints, not with half socks and dresses above the knee.

1. We the members of the seventeenth annual assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our general superintendent, W. L. Surbrook, a rising vote of thanks to express our appreciation of his labors of love and faithful service.

2. We the members of the seventeenth annual assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our district superintendent, W. A. Elkins, a rising vote of thanks to show our appreciation of his love and faithful service.

3. We the members of the seventeenth annual assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our assistant district superintendent, W. F. Drown, a rising vote of thanks to show our appreciation of his love and faithful service.

**STANDING RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE**

1. That all district monies be paid monthly through the local treasury.
2. That the district superintendent be given a salary of \$750.00 per year, together with his house rent and 2½ cents per mile for traveling expense.
3. That all our churches take an offering for our district superintendent on each official visit to each respective church.
4. That pastors and evangelists of this district, when working in the district, pay their tithe into the district treasury.
5. That each local church furnish their parsonage with at least a cook-stove, a heater, a kitchen cabinet, six chairs, a dining room table, and a dresser.
6. Whereas many of our pastors are not receiving sufficient financial support, and whereas many of the friends of the church not being able to give cash, but would like to help in some material way, we therefore recommend that each local church designate one prayer meeting night each month as donation night for the pastor.
7. We recommend that each Sunday school take at least ten cents out of each weekly offering to be sent to district treasurer on district tent fund.
8. We recommend that the annual remuneration of the district secretary, and the district treasurer be \$25.00 and \$40.00, respectively.
9. With reference to our district support of foreign missions, we hereby recommend that we whole-heartedly support the general board's program of prayer and preaching on missions, and will pledge ourselves to hold weekly prayer service and the monthly missionary rally. In connection with this, we recommend that our pastors be responsible for raising their proportionate amount of the missionary offering each month by a free will offering taken at the time of the monthly missionary rally.
10. We recommend that our district budget be set at \$2,400.00 for the year; 30% of the same to go to foreign missions, 15% to General budget, and 55% to district use.
11. It is recommended that a registration fee of one dollar be charged at the Pikes Peak Holiness Camp Meeting for all those registering who are 14 years of age and above.
12. We recommend that each local church pay the expenses of its delegates to and from the District Assembly.

**DISTRICT SUPERINTENDENT'S REPORT**

To the Seventeenth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church, greetings.

I feel humbled as I look back over the past year, and see how good God has been, and how He has led in the battle.

We submit this report to this Assembly, being very grateful to God and to my Brethren, and to all who have prayed for us and helped in any way to make the past year's work what it has been.

We have been blessed with good revivals in our churches, and are glad to report a 13% gain in church membership. Also there has been a 20% gain in Sunday School attendance over last year.



We were enabled to organize two new churches, namely, Canon City, Colo., and Imperial, Nebr. Also we established a preaching point at Falls City, Nebr., which we believe can soon be organized into a church.

Thru the kindness of our good friends, Mr. and Mrs. C. M. Eggers of Lewellen, Nebr., we received a deed to the splendid church building there. Sister Ruby Martin of Walsh, Colo., who has been a faithful standby of the Pilgrim Holiness Church for years, gave the P. H. Church a deed to 478 acres of land; 318 acres for the Home Missionary work of the Rocky Mountain District, and 160 acres for the Foreign Missionary Department.

The newly organized church of Imperial has purchased a good corner lot and erected a nice frame building for worship.

The Pilgrims at Superior have purchased a lot and bought an abandoned church building, and are making plans to move the building onto the lot soon.

I have traveled 24,948 miles in the interest of the District work, making 78 visits to the churches, and 21 annual church business meetings. Have preached 116 times, held two revivals and assisted in two Home Missionary meetings.

I have made over 100 calls in homes for the spiritual interest of others. My salary is paid in full, and beside this, I have received \$65.51 toward purchasing a car.

My heart is in the work of the Lord, and I love the Pilgrim Holiness Church, and my aim is to help to keep it spiritual.

I have enjoyed my work with my Brethren, and believe there has been perfect harmony. I say "let us go forward" together.

PILGRIM HOLINESS CHURCH



1. BE IT RESOLVED: That as soon as any member of the Pilgrim Holiness church unites with another denomination his membership with the Pilgrim Holiness church will automatically be discontinued.

2. BE IT RESOLVED: That we dispense with assistant General Superintendents, and that we elect three General Superintendents, Whose duty it shall be to supervise the work of our Church at home and abroad, and that they alternate in their work.

3. BE IT RESOLVED: That the words "upon reaffirmation of faith," shall be deleted from section 34, page 33, of our Manual.

4. BE IT RESOLVED: That members of the General Board shall serve the full four years term after their election by the General Assembly, irrespective of resident location.

5. BE IT RESOLVED: That our Missionary funds for both Home and Foreign Missions be raised under one heading, Namely, Missionary Funds.

Further,

BE IT RESOLVED: That the finance committee shall give the General Board an estimated budget which will cover the salaries of all our general officials, except the General Treasurer who shall draw 50% of his salary from the Publication Department as Business Manager. This shall be known as our General Budget and shall be a preferred claim. This budget shall be apportioned by the General Board to our districts according to their financial strength. The district in turn will apportion to their local churches on the same basis.

BE IT FURTHER RESOLVED: That our people shall then be privileged to give all they wish over and above our general budget, which monies shall be

stipulated for missions.

BE IT FURTHER RESOLVED: That these missionary funds shall then be divided between the home and foreign missionary work at the ratio of two-thirds for foreign missions and one-third for home missions.

BE IT FURTHER RESOLVED: That when people outside of our church wish to stipulate funds for certain interests that the same shall be received and applied as stipulated.

BE IT FURTHER RESOLVED: That our deputational workers from henceforth shall represent missions at home and abroad, which matter in itself will terminate our duplication of effort.

6. BE IT RESOLVED: That we change the date of the General Assembly from the first Tuesday of September to the first Tuesday in June beginning in the year of 1942.

7. BE IT RESOLVED: That whereas there is nothing in our Manual to provide for the organization of a body of people less than the number required for regular church organization.

THEREFORE BE IT RESOLVED: That where a group of saved people less than the number required for the organization of a church wish to be received into membership, they shall accept the covenant, doctrines and Manual of our church and be received into membership the same as in a regularly organized church.

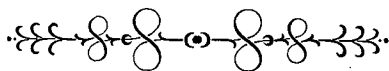
BE IT FURTHER RESOLVED: That an advisory council shall be appointed by the district superintendent who shall act as a governing body. This council shall consist of the pastor or one in charge, the Sunday school Superintendent and a Secretary-Treasurer. This council shall regulate its activities according to the Manual. This organization shall be continued until sufficient members have been received into the church to effect a regular church organization.

BE IT FURTHER RESOLVED: That the above named council shall be directly amenable to the District Superintendent and the final church organization shall be effected when he so directs.

8. BE IT RESOLVED: That the words "The council shall at all times have the best interest of the district in mind," found in paragraph 8, section 129, page 75, be deleted from our Manual.

9. BE IT RESOLVED: That section 104, paragraph 2, of the Manual be amended to include the ordained deaconesses.
