FIRST SITTING

It was moved and carried that the first five rows of seats in the south sections and the platform constitute the assembly bar.

It was moved and carried that the hours for gathering be as follows: 8:30 to 11:30 A. M., 1:00 to 4:00 P. M., and 6:30 to 9:00 P. M.

The District Superintendent appointed Rev. R. C. Stalcup and Rev. Glenn Abla to serve as a Reception Committee.

Motion made, seconded, and carried that we proceed with the election of officers at 2:00 P. M.

It was moved, seconded, and carried that we grant Rev. H. K. Busby, Superintendent of the Kansas District, an honorary seat within the conference bar.

SECOND SITTING

The Assembly opened with Rev. W. F. Drown in charge of the song service after which we were led in prayer.

The roll call was taken.

Minutes of previous session were read and approved.

Recommendations of Educational-Examining Committee were read asking that we grant First Year District Licenses to the following: Edward E. Waldron, Ellis Morrell, John Grauberger, and John Abla. It was moved and seconded that the assembly accept them. Carried.

The Reception Committee presented the following ministers: Mrs. Elsie McGaughey, Paul C. Nering, Dale G. Zeits, Rev. and Mrs. R. W. Wolfe, Miss Ethel Jordan, R. A. Kirby, Henry H. Lyder and William Beirnes, all of whom were granted honorary seats within the conference bar.

The report of the District Superintendent was read and accepted.

The Assistant District Superintendent gave a verbal report which was accepted.

Standing Recommendations of Ways and Means Committee were read.

Rev. E. G. Marsh and Rev. Sada Beth King were presented to the Assembly by the Reception Committee and were granted honorary seats within the assembly bar.

The Chair appointed tellers and the Assembly proceeded with the election of officers with the result that the following were elected:

THIRD SITTING

Rev. John Abla led the song service and Rev. T. E. Aslin led in prayer. Rev. E. G. Marsh gave a message from First Timothy 3:1-8, and followed it with a fervent appeal to the pastors for full spiritual cooperation with the Bible School.

Minutes of the previous sitting were read and approved.

Standing Recommendation No. 7 of the Resolutions Committee was read. Moved, seconded. Carried.

Ways and Means Committee Recommendation No. 13 was read. It was moved, seconded, and carried that we adopt same.

Election of Examining Committee was called for at this time and the following were elected to serve for terms of three, two, and one years respectively: W. F. Drown, C. C. Coleman, and F. L. Freed.

Election of Educational Committee followed with the result that Charles Luscombe, R. D. Perry, and Marion Hill were elected to serve for terms of three, two, and one years respectively.

Minutes of this sitting were read and approved.

FOURTH SITTING

The song service was led by Rev. Paul C. Nering, and Rev. John Abla led in prayer. Rev. W. A. Elkins gave a message from Rom. 1:14-15.

The roll call was taken with delegates responding by pledging to solicit Advocate subscriptions. Delegates and visitors to the Assembly pledged 360 new and renewal subscriptions.

The Statistical report was read and accepted.

Report of Auditing Committee was read and accepted.

Treasurer's report was read and accepted.

Standing Recommendation No. 8 of the Resolutions Committee was read. It was moved, seconded and carried that we adopt the same.

It was moved and seconded that we rescind No. 6 of the Ways and Means Committee Standing Recommendations. Carried.

A motion that we rescind Ways and Means Standing Recommendation No. 7 was seconded and carried.

A Recommendation to replace No. 7 was brought to the floor by the Ways and Means Committee. It was moved, seconded and carried that we adopt the same. Hereafter to be known as Recommendation No. 6.

Minutes of the previous sitting were read and approved.

Rev. Dow Wright of the Church of the Nazarene was presented and granted an honorary seat within the conference bar. He followed with his testimony.

It was moved and seconded that we rescind Standing Recommendation No. 10 of the Ways and Means Committee, Carried.

A Recommendation to replace No. 10 was brought in by the Ways and Means Committee. Its adoption was moved, seconded and carried. To be known as No. 9.

It was moved and seconded that we rescind Ways and Means Standing Recommendation No. 3. Carried.

The Ways and Means Committee presented a Recommendation to take the place of No. 3. It was moved and seconded that we accept the new recommendation. Carried.

Members of the Assembly joined in singing "The Child of a King" and "Come to the Feast." Prayer by Rev. R. D. Perry. Rev. Paul C. Nering gave a message from Acts 20.

Several unctuous testimonies were given. John and Glenn Abla sang "I Want My Life To Tell for Jesus."

There were more Spirit-anointed testimonies.

The report of the Educational-Examining Committee was read and accepted.

Report of Stationing Committee was read.

Brother Elkins gave a message of gratitude for past and present victories in the district and of encouragement for coming battles.

There were more testimonies and exhortations from the floor.

Resolutions that we stand and express appreciation to our District Superintendent, Assistant Superintendent, Secretary, and Treasurer were adopted and acted upon.

Minutes of this sitting were read and approved.

The Eighteenth Annual Assembly of the Rocky Mountain District closed with the delegates kneeling in prayer.

STANDING RESOLUTIONS

- 1. We recommend that the Ways and Means, Resolutions, and Statistical Committees be appointed by the District Superintendent at the Assembly for the following year. Be it further resolved that any material may be presented to said committees during the year.
- 2. That the pastors verify the reports of their respective churches before sending them to the District Assembly.
- 3. That all buildings, such as churches, parsonages, or extensive improvements be approved by the district superintendent before construction.
- 4. That no church of our district shall call a pastor, evangelist, representative of foreign missions or other church institutions without consulting our district superintendent.
- 5. That money shall be paid from district treasury as directed by district superintendent.
- 6. Being our conviction as to the standard of 1 Peter 3:3-4, be it resolved that all women of the church shall in public wear their dresses with full length sleeves, close fitting necks, and reaching in length at least half-way between the knee and the floor; also leave off the wearing of all jewelry, including wedding rings, and that they dress their children as becometh saints, not with half socks and dresses above the knee.
- 7. That the Assembly year close on May 31 and that all reports be in the hands of the District Secretary by June 10, and that all District monies be sent in to the District Treasurer by the same date.
- 8. Inasmuch as it is a great inconvenience to our brethren that do not know where they are going for the coming year, be it resolved that the committees, Educational and Examining Boards and Stationing Committee (District Council) have their work well along before Assembly convenes.

RESOLUTIONS PASSED BY THIS ASSEMBLY

- 1. We the members of the Eighteenth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our District Superintendent, W. A. Elkins, a rising vote of thanks to show our appreciation of his love and faithful service.
- 2. We the members of the Eighteenth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our Assistant District Superintendent, W. F. Drown, a rising vote of thanks to show our appreciation of his love and faithful service.
- 3. We the members of the Eighteenth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our District Secretary and our District Treasurer a rising vote of thanks to show our appreciation of their love and faithful service.

STANDING RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE

- 1. That all District monies be paid monthly through the local treasury.
- 2. That the District Superintendent be given a salary of \$750.00 per year, together with his house rent and $2\frac{1}{2}$ cents per mile for traveling expense.
- 3. That an offering be taken by our District Superintendent on each official visit to each respective church, the same to be applied on the District Budget.
- 4. That pastors and evangelists of this District, when working in the District, pay their tithe into the District treasury.
- 5. That each local church furnish their parsonage with at least a cookstove, a heater, a kitchen cabinet, six chairs, a dining room table, and a dresser.
- 6. We recommend that each Sunday School take 5% of the regular Sunday offering to be sent to the District Treasurer to be applied on the District Tent Fund.
- 7. We recommend that the annual remuneration of the District Secretary and the District Treasurer be \$25.00 and \$40.00 respectively.
- 8. With reference to our District support of Foreign Missions, we hereby recommend that we wholeheartedly support the General Board's program of prayer and preaching on missions, and will pledge ourselves to hold the weekly prayer service and the monthly missionary rally. In connection with this, we recommend that our pastors be responsible for raising their proportionate amount of the missionary offering each month by a free will offering taken at the time of the monthly missionary rally.
- 9. We recommend that a District Budget be set at \$3230.00; that Foreign Missions be raised under its own head; and that a District Home Mission Budget be set at \$300.00, the same to be raised by the Department of General Home Missions at the time they raise their claim; that General Administrative funds be raised automatically at 10% of the Budget and that we as a District raise the balance by pastor's tithe plus \$1.60 per member.
- 10. It is recommended that a registration fee of one dollar be charged at the Pike's Peak Holiness Camp Meeting for all those registering who are 12 years of age and above.
- 11. We recommend that each local church pay the expenses of its delegates to and from the District Assembly.
- 12. That each church pay their pastors, their offerings or salaries during Camp and Assembly.
- 13. In accordance with section 52, paragraph 8, and section 65 where it is required that every pastor put his entire time into the work of the ministry, be it resolved, that each church be required to pay its pastor a minimum of \$5.00 per week and that the District Superintendent see to this on each of his quarterly visits.

DISTRICT SUPERINTENDENT'S REPORT

To the Eighteenth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church; Praise be to our God for His Abundant Grace.

First of all, we want to report victory through Him who loved us and gave Himself for us. Next we want to express our appreciation for our Brethren, and all that have prayed and cooperated with us in this great work of the Lord. The past year has been a constant battle, but with glorious victories. We are not able to report the country taken for God, but we can say we believe God has helped the Pilgrim Holiness Church on this District to deepen in God, and to fan the revival fires to greater intensity.

There have been some splendid forward steps taken in the building program. The Superior church has a splendid building with full basement, and no debts. The Imperial church has been improved with paint, plaster, and good seats. The Canon City church has a parsonage nearly finished, 24 by 36 feet, and arranged so as to worship in part of it until they finish the church building. They have a nice corner lot, with ample room for both church and parsonage. The Pilgrims at Saguache have purchased a good corner lot, and are starting to build both a church and parsonage.

I have traveled 20,158 miles in District work, have made 71 church visits, held 36 business meetings, preached 142 times; held all the annual business meetings except one, conducted two revivals and assisted some in three; dedicated 2 children, baptized 1, solicited 27 subscriptions to the Advocate, prayed with several for healing, and enjoyed my work and had sweet fellowship with God. We glance back, but look ahead, and feel an urge to go on.
