Resolution No. 9 was read. Motion that we adopt same was seconded and carried.

#### STANDING RESOLUTIONS

- 1. We recommend that the Ways and Means, Resolutions, and Statistical Committees be appointed by the District Superintendent at the Assembly for the following year. Be it further resolved that any material may be presented to said committees during the year.
- 2. That the pastors verify the reports of their respective churches before sending them to the District Assembly.
- 3. That all buildings, such as churches, parsonages, or extensive improvements be approved by the district superintendent before construction.
- 4. That no church of our district shall call a pastor, evangelist, representative of foreign missions or other church institutions without consulting our district superintendent.
- 5. That money shall be paid from district treasury as directed by district superintendent.
- 6. Being our conviction as to the standard of 1 Peter 3:3-4, be it resolved that all women of the church shall in public wear their dresses with full length sleeves, close fitting necks, and reaching in length at

least halfway between the knee and the floor; also leave off the wearing of all jewelry, including wedding rings, and that they dress their children as becometh saints, not with half socks and dresses above the knees.

- 7. That the Assembly year close on May 31 and that all reports be in the hands of the District Secretary by June 10, and that all District monies be sent in to the District Treasurer by the same date.
- 8. Inasmuch as it is a great inconvenience to our brethren that do not know where they are going for the coming year, be it resolved that the committees, Educational and Examining Boards and Stationing Committee (District Council) have their work well along before Assembly convenes.
- 9. Owing to the soon coming of Jesus and the great spiritual need of the world, be it resolved that each pastor be privileged to hold two revival meetings of two weeks' duration each per year with regular support paid, subject to the approval of the District Superintendent.
- 10. Be it resolved that the Assembly decide the number of District Minutes to be printed annually.
- 11. Be it resolved that we have a District Ministerial and Young People's Convention during Thanksgiving week.
- 12. That the District Treasurer give an itemized account to the District Assembly of where all the Home Missionary money was spent.

#### SPECIAL RESOLUTIONS

- 1. We the members of the nineteenth annual assembly of the Rocky Mountain District resolve that there be given our general superintendent, Rev. W. L. Surbrook, a rising vote of thanks to express our appreciation of his labors of love.
- 2. We the members of the nineteenth annual assembly of the Rocky Mountain District resolve that there be given our district superintendent, Rev. W. A. Elkins, our assistant superintendent, Rev. W. F. Drown, and our Secretary and our Treasurer a rising vote of thanks to express our appreciation of their faithful service.

### STANDING RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE

- 1. That all District monies be paid monthly through the local treasury.
- 2. That the District Superintendent be given a salary of \$850.00 per year, together with his house rent and 2% cents per mile for traveling expense.
- 3. That an offering be taken by our District Superintendent on each official visit to each respective church, the same to be applied on the District Budget.
- 4. That pastors and evangelists of this District, when working in the District, pay their tithe into the District treasury.

- 5. That each local church furnish their parsonage with at least a cookstove, a heater, a kitchen cabinet, six chairs, a dining room table, and a dresser.
- 6. We recommend that each Sunday School take 5% of the regular Sunday offering to be sent to the District Treasurer to be applied on the District Tent Fund.
- 7. We recommend that the annual remuneration of the District Secretary and the District Treasurer be \$25.00 and \$40.00 respectively.
- 8. With reference to our District support of Foreign Missions, we hereby recommend that we wholeheartedly support the General Board's program of prayer and preaching on missions, and will pledge ourselves to hold the weekly prayer service and the monthly missionary rally. In connection with this, we recommend that our pastors be responsible for raising their proportionate amount of the missionary offering each month by a freewill offering taken at the time of the monthly missionary rally.
- 9. We recommend that we set our district budget at \$1.00 per member for home missions, and \$1.60 per member plus the pastor's tithe for district administrative expense. Also \$1.10 per member for General administrative fund and General Home Missions to be divided in accordance with the Manual, page 84, section 12, and that Foreign Missions be raised under its own head and the minimum be in accordance with the Manual (\$1.90 per member).
- 10. It is recommended that a registration fee of one dollar be charged at the Pikes Peak Holiness Camp Meeting for all those registering who are 12 years of age and above.
- 11. We recommend that each local church pay the expenses of its delegates to and from the District Assembly.
- 12. That each church pay their pastors, their offerings or salaries during Camp and Assembly.
- 13. In accordance with section 52, paragraph 8, and section 65 where it is recommended that every pastor put his entire time into the work of the ministry, be it resolved, that each church be required to pay its pastor a minimum of \$7.00 per week cash, and a systematic pounding at least one Sunday morning each month, and that the District Superintendent be responsible in seeing that this is carried out.
- 14. We recommend that the Pastor see that all monies be correctly specified before being sent in to district treasury.

#### REPORT OF DISTRICT SUPERINTENDENT

To the Nineteenth Annual Assembly of the Rocky Mountain District, we submit this report, giving praise to our God and to our sacrificing pastors and people for what has been accomplished.

We have traveled 25,183 miles in the interest of the District, besides over 2,500 miles going to the General Board meeting at Indianapolis.

I have made seventy visits to the churches, holding 38 business meetings, and 21 annual meetings. I have preached 129 sermons, have seen several bowing at the altar of prayer for pardon and purity. Have secured 112 subscriptions to the Advocate, giving pastors credit for 22 of these. Brother and Sister Coleman and Sister Rogers held a meeting in Grand Junction which resulted in the organizing of a Pilgrim Holiness church. Wife and I pastored this church from Oct 8th to Dec. 3rd, making 140 pastoral calls, and received \$39.91 for our labors which we turned into the District Treasury. We are glad to report the Grand Junction folk have bought a corner lot in a good location, and have made a good payment on it, and expect to build in the near future. Canon City has their basement walls in for their church, and plan to go on up with the building soon. They have a fine parsonage. The Saguache folk have their splendid building nearly finished, and are worshipping in it while finishing it. Oshkosh has built a church building that is a credit to the District. It is of white stucco finish, with pebble dash, with hardwood floor, and with full basement for Sunday School rooms for their fast growing Sunday School. The Superior folk have finished their church basement, and now have one of the nicest churches on the District. The Arthur folk have done some splendid work on their church, having replastered, and painted the entire inside, and torn off all the old stucco and have rewired and stuccoed the outside. Bladen has put new shingles on their parsonage. Walsh is building an addition to their parsonage. Madrid has redecorated the inside of their church building. Stratton church is making plans to secure a parsonage.

The combined indebtedness on all churches and parsonages is only \$5,509.50.

We thank God for His continued help through this past year, financially, numerically, and most of all spiritually.

Besides this amount, I have turned in miscellaneous sums for sale of property, camp meeting pledges, money for District minutes, song books, etc., etc. My salary is paid in full, as well as my traveling expenses. In addition to my salary, I have received about \$30.00 in gifts and donations.

My tithes are all in, and the windows of Heaven are open. I have enjoyed the fellowship of the brethren as I have labored with them, and have rejoiced, and suffered with them as they have fought a courageous battle. Thank God, I believe we have gained some ground. I have rejoiced to see the working of the financial system adopted last Assembly, and I believe it has worked the best of any system we have ever tried.

Our people seem to be catching the vision for District Home Mission work, and I trust this needy field will soon be able to report some gracious results. With war clouds lowering, cannons roaring; and in a world or bursting bombs, and shricking shells; with the groans of dying men only a few hours away, let us work while it is day. For we know not how soon this night of war and madness may settle down upon us, and make our work more difficult.
