## STANDING RULES

1. We recommend that the Ways and Means Resolutions and Statistical Committee be appointed by the District Superintendent at the conference for the following year. Be it further resolved that any material may be presented to said committees during the year.

2. That the pastors verify the reports of their respective churches before sending them to the District Conference.

3. That all buildings such as churches, parsonages, or extensive improvements, be approved by the District Superintendent before contruction.

4. That no church of our district shall call a pastor, evangelist, representative of foreign missions or other church institutions without first consulting the District Superintendent.

5. That the conference year close on June 30 and that all the reports be in the hands of the district statistician by July 10th and that all district monies be sent to the District Treasurer by the same date.

6. That we go on record as being opposed to our children having to dress, dance or do other things in the physical education department of the public schools in violation of our religious convictions and our church standards.

7. Owing to the soon coming of Jesus and the great spiritual need of the world, be it resolved that each pastor be privileged to hold two revival meetings of two weeks duration each year with regular support paid, subject to the approval of the District Superintendent.

8. Be it resolved that we have a Foreign Missionary Convention in the fall, time to be set by the District Council.

9. That the District Treasurer give an itemized account to the District Conference of where all the Home Missionary money was spent.

10. That all members pay their tithes into the church in which they retain their membership, according to Section 69 in the Manual.

11. That the District secure and maintain all the books in the different courses of study as prescribed by the Manual in sufficient number to

accommodate, if necessary, any candidate taking any one of the courses. That the Educational Committee formulate rules for the loaning of such books, determine the number to be secured, and select custodian, subject to the approval of the District Council.

12. That the conference bar shall include the first seven rows of seats in the center and south sections and the platform.

13. Be it resolved that the time for Conference sittings be fixed as follows: 8:00—11:45 a.m., 1:45—5:00 p. m. and 6:30—9:00 p. m.

14. That the District Superintendent shall appoint all committees and fill all vacancies.

15. Be it resolved that the District Superintendent be granted a two weeks' vacation with pay each year.

16. We recommend that each pastor be granted a two weeks' vacation with pay each year.

17. Whereas the present trend toward immodesty of dress is so evidently out of keeping with the Word of God, girls and women who are members of the Pilgrim Holiness Church are not to appear in public wearing immodest forms of dress so current today, such as sun suits, shorts or without stockings, dresses of immodest lengths, slacks, or similar garments. Men and boys of the church are not to appear in public in shorts or without shirts.

18. Whereas the trend of worldliness is so prevalent and is making inroads in the Church, be it resolved that we strongly urge parents to dress their children according to the spirit of the Manual which sets forth a standard of modesty.

19. Be it resolved that District Minister's license shall not be granted to any person who does not have a definite call to, or who does not plan to enter the active ministry.

Be it further resolved that no licentiate be advanced in ministerial standing unless actively engaged in the ministry.

20. Be it resolved that each pastor report all seekers in the church of which he has the oversight.

21. Be it resolved that semi-annual zone Sunday School conventions be held for the purpose of encouraging the work of the Sunday School, such conventions to be arranged for, and supervised by the chairman of the District Sunday School Board if possible, or by some other member of the District Sunday School Board.

22. Whereas there is considerable work cleaning the camp ground and storing equipment, Be it resolved that each member of the conference remain one day after conference to assist the District Superintendent in doing the work.

23. We recommend that our laity be given recognition along with our ministry in the list of memorials.

24. Owing to the soon coming of Jesus and the great spiritual need of the world. Be it resolved that our District Superintendent be privileged to hold two revival meetings during the year outside of the district with regular support.

25. Whereas in accordance with the Manual be it "Resolved, That Ministerial Study Course be put on a yearly basis with the requirement that three study books and three reading books be the minimum requirement." and

Whereas some of our licensed ministers have failed to comply with the above provisions:

Be it therefore resolved that we ask each member of the Educational Board to be responsible for contacting each licentiate under his jurisdiction, urging him to follow the prescribed course of study as outlined in the Manual, before the beginning of next conference.

Be it further resolved that we urge each licentiate to co-operate with the Educational Board in the above matter.

26. Whereas it is very necessary at the time of pastoral change for the new pastor to become acquainted with his people as soon as is possible and whereas the pastor leaving does not have adequate time for the preparation of a complete list of names and addresses of the members and constituency.

Therefore be it resolved that every pastor compile and keep up to date a complete file of all those attending his or her church.

27. Be it resolved that a printed statement be given each person registering at the Pikes Peak Holiness Camp showing the registration requirements.

28. Whereas the District has purchased a suitable safe for all abstracts and legal papers, be it resolved all abstracts and other legal papers be placed in same.

29. Whereas, the General Board of the Pilgrim Holiness Church has authorized Pilgrim Pension Plan, Inc., to make loans of pension funds to local Pilgrim Holiness Churches, under such conditions as required active participation on the part of the Pilgrim Holiness Districts.

**THEREFORE, BE IT RESOLVED** by the Annual Conference of this district that the District Council, District Trustees, and all District Officials be, and they are hereby authorized, to do and perform any and all acts required of them in the consummation of authorized loans to local Pilgrim Holiness Churches of this district, subject however, to the limitations and conditions set out in said Resolution of the General Board of the Pilgrim Holiness Church authorizing said loans.

30. Whereas the District Conference desires the continuation of the Rocky Mountain Pilgrim, with 10 issues per year.

We recommend the offices of Editor of the Rocky Mountain Pilgrim and the District Sunday School Secretary be combined.

31. Be it resolved that in case of the death of a minister or a member of the family, that the District Superintendent be responsible for notifying the pastors of the District, and the Conference to stand expense of same.

32. Whereas many times there are close friends and relatives of licensed ministers who want to attend the ordination service, but are unable to do so because necessary announcement has not been made, be it resolved that the ordination service be announced prior to conference.

33. Whereas the majority of television programs are a definite hindrance to the spirituality of our people, bring evil influence into the home: Be it resolved we go on record as opposing television.

34. Be it resolved that all Sunday Schools in the Rocky Mountain District stop counting scholars present ten minutes before the close of the Sunday School period.

35. We recommend the price of Conference Minutes be set at 50c each and that each pastor be responsible to collect and bring to conference the money for the number of minutes that his church desires.

36. Be it resolved that the time of the district camp meeting be set as follows: To begin the Friday nearest of July 15, same to become effective in 1961.

37. A copy of the Rocky Mountain District by-laws can be found on page 10 in the 1961 District Conference Minutes.

#### **Standing Recommendations of Ways and Means Committee**

1. We recommend that the District Superintendent be given a salary of \$300.00 per month with district parsonage and utilities, together with six (6) cents per mile for traveling expense while driving his own car, and actual traveling expense while traveling otherwise.

We further recommend, that whereas, the mileage incurred by the District Superintendent in the work of the District is that beyond the average driven, thus making mechanical repair and trade-in more often than the recommended time of driving a car: We therefore recommend that the District Treasurer be instructed to set aside each year the sum of Three Hundred Dollars (\$300.00), the same to be applied as a supplement to the depreciation and trade-in of the District Superintendent's car.

2. Be it resolved that if the District Superintendent prefers not to live in the district parsonage the rent from same be returned to the district treasurer, and a reasonable housing allotment be paid the District Superintendent. Said allotment to be determined by the District Council according to the amount of rent received and necessary up-keep on the parsonage.

3. We recommend that the assistant District Superintendent, or any member of the Council acting in the District Superintendent's place receive \$5.00 per day, plus (4) cents per mile traveling expense while driv-



ing his own car, and actual traveling expense while traveling otherwise. The District Council when traveling to Council meetings, shall be paid (4) cents per mile traveling expense while driving his own car, and actual traveling expense while traveling otherwise.

4. Be it resolved that the District pastors and unstationed ministers not participating in the Pension Plan pay three-fourths of their ministerial tithe into the district treasury to be applied on District administrative expense and the remainder to be paid into the treasury of the local church to which they belong.

Be it further resolved that all District evangelists, teachers and other unstationed ministers, participating in the Pension Plan, pay their entire tithe into the District treasury. On the basis of the tithe paid to the District, the District Treasurer shall pay the 4 percent as required by the Pension Plan.

5. That each local church furnish its parsonage with at least a cook stove, a heater, a kitchen cabinet, six chairs, a dining room table and a dresser.

6. We recommend that the annual remuneration of the District Secretary be \$100.00 and that the District Treasurer be paid \$25.00 per month. Be it further resolved that the District Statisticians be given \$15 per year and that the salary for the combined offices of District Sunday School Secretary and Editor of the Rocky Mountain Pilgrim be set at \$50 per year.

7. We recommend that all attending the Pikes Peak Holiness Camp Meeting be properly registered. Each registrant twelve years of age and above, except active ministers and their families, will be required to pay a fee of \$2.00. Each registrant 12 years of age and above including active ministers and their families, will be required to pay a fee of 50 cents for insurance purposes.

Registration cards will be so made that each registrant be assigned specific duties in one of the work departments of the camp, the foreman of that detail to punch each card each day when duty has been performed. These duties will be assigned by a Camp Meeting Committee of three persons to be appointed by the District Superintendent.

We further recommend that an attendant be in charge at each meal to check registration cards and receive free-will offerings.

8. We recommend that the local church pay the expenses of its delegates to and from District Conference.

9. We recommend that each church pay their pastor's offerings or salary during Camp and Conference.

10. Be it resolved that each Sunday School pay 10c per enrolled Sunday School member per year, for promotion of District Sunday School work.

11. Be it resolved that each local church send to the District Treasurer each month an amount equivalent to 10 percent of all regular offerings. From this amount the District Treasurer shall take a proper percent for District administration and District Home Missions. The remainder of the 10 percent shall apply on General administration, General Church extension loan fund, General Sunday School and youth work and Senior college.

Be it further resolved that each church be assessed \$1.50 per member to supplement the United Stewardship fund and 50 cents per member for International Conference expense fund.

12. We recommend that, in compliance with the request of our zone school board, each senior member of our district be assessed \$5.00 per year for Bible School budget, 25 cents of which will go for the Rocky Mountain District's portion of the school boards travel expense, this budget to be raised in any way the local church may desire.

13. We recommend the district treasurer set aside the amount equal to 32 percent of the United Stewardship fund from unspecified general church extension funds, the same to be included in the United Stewardship fund.

14. Be it resolved that the members of the District Sunday School and Young People's Boards be given five (5) cents per mile for traveling expense to be paid from the funds of their respective boards.

15. We recommend that each Church take up a free will offering to help defray the expenses of the Ministerial meeting in March.

16. Be it resolved that a fee of one dollar each be made for the use of the District study books and that a fee of 50 cents each made for the use of District Reading Books.

17. Due to the conference decision to purchase a District Camp Grounds:

We recommend that the District Superintendent be authorized to take three special offerings in each church each year, 90 percent of said offerings to be applied to the District Camp ground debt and interest, and 10 percent to be set aside for maintenance and repair on the Camp Ground.

We further recommend that the goal for these offerings be set at \$10.00 per year per senior member for the District.

We further recommend that the District Superintendent be authorized to take a special offering each year at District Camp to be applied to the District Camp ground debt and interest.

18. We recommend that the District Superintendent meet with each local Advisory Board at least once each year to review the Church's financial welfare and endeavor, wherever possible, to obtain yearly raises in pastors support.

19. We recommend that our conference accept the proposal of Central Pilgrim College in granting each year a one-half tuition scholarship to Central Pilgrim College to a student on our district. The college will then grant the same to another student.

We further recommend that these students be chosen by the District Council from Pilgrim Holiness ranks on the basis of the two students with the best scholastic and church records.

20. Be it RESOLVED that each local youth society, organized or unorganized, send five per cent (5%) of the regular youth offering to the District Youth treasury.

### **Pension Plan**

Whereas the General Church has adopted and recommended the Pilgrim Pension Plan as a sound method of providing retirement benefits for aged Pilgrim ministers, and Whereas the Rocky Mountain Conference has declared its endorsement of the plan, and Whereas action taken at the 1954 General Conference makes it mandatory for each local church to participate in the plan, we therefore recommend that every church, no less than once each quarter, send to the District Treasurer an amount equivalent to four percent of the pastor's salary as the conference contribution to the Pension Plan.

## **FORTY-FIRST ANNUAL DISTRICT CONFERENCE**

**First Sitting July 23, 1962 — 8:00 A. M.**

The Forty-first Annual Assembly of the Rocky Mountain District Conference of the Pilgrim Holiness Church was called to order by the District Superintendent, L. E. Schendel at 8:00 a. m. July 23, 1962 at the Camp Grounds in Colorado Springs, Colo.

Motion prevailed to accept the report.

The Chair urged the Committees to enforce the requirements of the Manual for renewal of license.

The Committee on Resolutions reported.

RESOLUTION NO. 1 — WHEREAS the First Western Regional Pilgrim Holiness Sunday School Convention is planned for August 1963 to be held in the Colorado Women's College in Denver, and

WHEREAS we believe that the benefit which may be had from such a Convention can have telling effect upon the work that each of us represent, and

WHEREAS for it to be the success for Christ and the Church, that it can be, the full co-operation of all our people is necessary, therefore,

BE IT RESOLVED that the Rocky Mountain District Conference recommend the following:

1. That we engage ourselves in prayer each month in our Sunday School Workers' Conference and in other prayer sessions for the coming Convention, for the speakers, work shop leaders, financial needs and all who will attend.

2. That all pastors, Sunday school teachers, officers and other Christians of our local constituencies be encouraged to make plans to attend the Convention in Denver August 20-22, 1963.

3. That where possible financial help be given to key Sunday School workers in the local church to help them in the cost of attending the Convention.

Carried.

Resolution No. 2 — WHEREAS the task of getting ready for camp each year takes considerable time and work and,

WHEREAS the ladies of the local churches take the responsibility of getting the cafeteria ready, but are unable to help much with the dormitory rooms and this work falls largely on the District Superintendent's wife.

THEREFORE BE IT RESOLVED that each pastor's wife understand she is to clean her own room after arriving at camp. The three local churches to be responsible for cleaning the three guest rooms.

Carried.

The Committee on Ways and Means reported.

Recommendation No. 1 — WHEREAS plans are being made to have our First Western Regional Pilgrim Sunday School Convention for the eleven districts west of the Mississippi River August 20-22, 1963 in Denver, Colorado, and

WHEREAS such a meeting of Pilgrims for the purpose of Sunday School instruction, study and inspiration with guest speakers, workshops and displays can be of invaluable benefit to our work, and

SINCE the costs of conducting a convention of such scope are great and it is necessary to have them raised prior to the convention, and

SINCE in a meeting of the district superintendents and promotional secretaries of this area with Rev. J. D. Abbott, Secretary of General Sunday School, last February a financial plan was agreed upon for this purpose, therefore

BE IT RESOLVED that we, in the Rocky Mountain District give an amount equal to 40 cents per Sunday School member in the 1962-1963 conference year for the purpose of financing our FIRST WESTERN SUNDAY SCHOOL CONVENTION and that said monies as collected shall be mailed monthly to Headquarters (through the District Treasurer) clearly designated for that purpose.

Carried.

Recommendation No. 2. — We recommend that the first part of standing recommendation of Ways and Means Committee number six (6) be changed to read — We recommend that the annual remuneration of the District Secretary be \$100.00 and that the District Treasurer be paid \$25.00 per month.

Carried.

The committee on Memoirs reported.

The report was received by a standing vote and a time of silent prayer. Brother Snyder led the Conference in a prayer of thanks for these Saints and entreating of God to enable us to also be faithful.

Dale Rummel was elected to the Council.

Further report of the Ways and Means Committee.

BE IT RESOLVED that if the District Superintendent prefers not to live in the district parsonage, the rent from same be returned to the district treasurer, and a reasonable housing allotment be paid the District Superintendent. Said allotment to be determined by the District Council according to the amount of rent received and necessary up-keep on the parsonage.

Carried.

Recommendation No. 4 — WHEREAS the offerings at our annual Camp are the only means of finance for our District Youth organization,

BE IT RESOLVED that each local youth society, organized or unorganized, send five per cent (5%) of the regular youth offering to District Youth treasury.

Carried.

Recommendation No. 11 and 18 were read to the Conference for emphasis.

Recessed for ten minutes.

Further report of the Resolutions Committee.

Resolution No. 3 — BE IT RESOLVED that the second paragraph of Standing rule 26 be changed to read:

BE IT RESOLVED that our district give one-fourth year's credit to each licentiate for each such Seminar successfully completed.

Motion prevailed to refer the said Resolution No. 3 and Paragraph No. 26 to the Educational Board and the College Administration for adjustment.

The following Special Resolutions were read and approved by a standing vote:

We, the members of the Forty-first Annual Conference of the Rocky Mountain District of the Pilgrim Holiness Church, resolve that there be given our chairman Dr. Melvin Snyder, a rising vote of thanks to express our appreciation of his labor and love.

We, the members of the Forty-first Annual Conference of the Rocky Mountain District of the Pilgrim Holiness Church, resolve that there be given our District Superintendent, L. E. Schendel; our secretary, W. J. Brown; and our treasurer, J. H. Fortner a rising vote of thanks to express our appreciation of their faithfulness to us. Be it further resolved that there be given our cook, Mrs. Woodard, and all the kitchen and dining room help a rising vote of thanks to express our appreciation of their faithful service.

Brother Schendel spoke words of appreciation for Brother Gilbert and Sister Stewart for their years of labor as pastors on our District.

Motion prevailed for the Council to read and approve the minutes of the last sitting.

The Pastoral Appointments were read.

Brother Snyder admonished the Conference to go forth in expectancy of being fruitful this coming year and come back next Conference to read our reports in victory.

Sister Stewart spoke of her appreciation for the privilege of working on the District.

The District Superintendent called for the awarding of the ship for the "Decade of Progress."

Brother Schendel made several announcements.

Motion prevailed for the Conference to give Brother and Sister Gilbert and family and Sister Stewart a vote of their love and appreciation.

## **DISTRICT SUPERINTENDENT'S REPORT**

To our presiding General Superintendent, Rev. Melvin Snyder, Pastors, Evangelists and lay delegates of the Forty-first Annual Conference of the Rocky Mountain District. Our heart is made to rejoice day by day because of the unfailing promises of God. It is surely true we are living in a rapidly changing age, but His promises are as unchanging as God Himself. The words of the inspired writer are as real today as a year ago, yea as real as when they were written, "It is of the Lord's mercies that we are not consumed, because His compassions fail not. They are new every morning! Great is thy faithfulness."

The tasks of the church, no matter how faithfully pursued, are never completed. The unending stream of humanity born into the world is a never ending challenge to the church to reach them with the Gospel.

We thank God that in His mercies He has seen fit to spare all but one of our ministers. Rev. F. L. Freed was called to his eternal reward during this past year. He was a brother beloved indeed, and elsewhere in these minutes there will be an appropriate memorial.

### **Church Improvements**

There have been several major additions and improvements to church property this past year.

The entire yard at the Arthur church has been grassed by the local historical society. A friend donated the grass from his meadow and the society cut it into strips and laid it around the church. A complete lawn in a couple of days.

Through the good providence of God many yards of fill dirt has been donated to the Boulder church and grading of the yard is completed.

Denver First has built a new parsonage, and the pastor and family are now enjoying it.

The loan for the Ft. Collins church has finally been processed and they are now working on their new church.

The church extension church at West Park, Pueblo has done considerable improvement on the building, and are in the process of building lovely new pews.

The pastors and families of the Superior and Rocky Ford churches have moved into new, or at least other parsonages during the past year.

### **District Church Extension**

The work of District Church Extension has progressed nicely during the past year. The District Treasurer's report will show that District money has gone to Grand Junction, West Park, Pueblo, Holdrege and Tecumseh. One of these will be on their own this next year, and two are cut down with a view to complete self support soon. In the good providence of God the way is opening for a new work in Thornton, Colorado (North Denver) and a major part of our District church extension money will be channeled into that work for the next few years. Rev. James Butler will be working in this new field. Let each of us stand by this new work with our prayers and support.

### **New Churches**

It is a real pleasure to bring to this Conference two new churches with their pastors and delegates. Bro. and Sr. Sander have toiled faithfully at Holdrege, Nebraska for several years, and on May 6 it was my privilege to organize this extension work into a Pilgrim Holiness church.

For a number of years Bro. and Sr. Russell Campbell have labored faithfully in Denver for a new Pilgrim Holiness church, and on March 4 it was a real time of rejoicing when we organized the Bethany Pilgrim Holiness church of Denver. The pastors of both of these churches bring reports of progress.

### **Bible College**

A word is in order relative to our Bible College. Rev. R. G. Flexon has accepted the office of President of our College. This District, along with the entire western zone is looking forward to a good year in our school, and all of us anticipating the coming of young men from this institution who will help with the great task of spreading Scriptural Holiness across these western States. Bro. Bonner has done a wonderful work in

the College and will continue to be closely associated in the internal workings of the school. Let us continue to pray earnestly for the entire staff of C. P. C. and for the new student body that God will make this coming year all He would have it to be.

### **Camp Ground**

The real financial struggle is meeting our Camp Ground expense. Several of our churches have paid all their quota this past year, and for that they are to be highly commended. However, some of our churches are far behind in reaching their quota. I feel this obligation should come up for review and discussion at this conference. Some of the churches are planning to pay this quota, along with the rest of their financial obligations on a monthly basis, and it seems to me this is as it should be. It is hardly fair for the pastor and church board to give this need no consideration except when the District Superintendent is present. Sometimes I have the feeling that the Superintendent is to take a special Camp Ground offering gets very little publicity ahead of his appearing in the pulpit. The Camp Ground was purchased at the instruction of this conference, and it is the obligation of every pastor and his church board to see that the local quota is met.

### **Camp Meeting**

It has been a real spiritual treat to have had the privilege to work with our camp meeting workers this year. The evangelists were faithful in giving to us the messages God laid on their hearts. The messages were scriptural and practical, and the Holy Spirit was faithful to apply the truth. The ministry of the Lewis family in the musical end of the services was greatly appreciated. Good gospel singing is always an uplift to the soul. The fine cooperation of the pastors and people in each making his contribution to the success of the camp cannot be overlooked.

### **Personal Report**

This past conference year I have preached 91 times, held 32 local church board meetings, 27 church meetings and all but one of the annual meetings. I have endeavored to visit all of the churches at least 3 times this past year. While visiting the churches I have assisted in communion services and special services as the occasion demanded. I have driven many miles to be at all of the board meetings of the college and church leaders conference, and have driven 17,814 miles for the District.

Brother Abbott visited our District last fall in the interest of the General Sunday School work and it was my privilege to accompany him on most of his tour, being with him in conventions in McCook, Nebr., and Colorado Springs, Colorado First Church and enjoying his visit and services in our church in Denver.

In October of last year I held a convention in the church at Sutherland, Nebr., at the invitation of the Holiness Convention of the Southwest Nebraska churches. There was very good cooperation by the various churches and we had a fine convention.

In February Brother Abbott was in Bartlesville, Okla., at the college and wished to meet with the District Sunday School Promotional Secretaries from the 11 Districts west of the Mississippi. I accompanied Brother Schendel to the college and participated in business sessions at which it was decided to hold a Western Regional Sunday School Convention in Denver in August of next year.

At the Ministerial Convention in March one afternoon session was given into my charge for a Sunday School service. With the help of several in attendance we presented a skit and discussed the Sunday School Standard of Excellence. The service was well received.

On July 8th Brother Flick of Grand Junction relinquished his pulpit to me for the morning and evening services in the interest of Sunday School work. I appreciated the good group that attended and participated in those services.

I received from the District Sunday School treasurer the sum of \$80 for expenses to Allentown.

I traveled on the District approximately 1500 miles in Sunday School work and received free will offerings in the sum of \$26.21.

With thanks to God let us look at the Sunday School gains on our District in the past year. In 1960-61 we had an average weekly attendance of 1504. In 1961-62 we averaged 1558, a gain of 54 per Sunday. This represents a percentage gain of 3 plus %. Almost 60% of our schools showed a gain for the past year. Seventeen of our twenty nine schools gained with ten showing over a 10% gain. They were:

Stratton with a gain of 5 which was 13% plus.

Rocky Ford with a gain of 4 which was 15% plus.

Arthur with a gain of 5 which was 18% plus.

Boulder with a gain of 7 which was 19% plus.

McCook with a gain of 11 which was 29% plus.

Fort Collins with a gain of 12 which was 33% plus.

Denver Bethany with a gain of 4 which was 40%.

Kiowa with a gain of 10 which was 41% plus.

Pueblo West Park with a gain of 10 which was 43% plus.

Lincoln with a gain of 19 which was 52% plus.

I wish to thank all who have cooperated with and helped me in this past year. Let us pray that in the year to come we can march on together, under God, to many victories, many conversions, and many blessings in our Sunday Schools.
