#### STANDING RULES

- 1. We recommend that the Ways and Means, Resolutions and Statistical Committees be appointed by the District Superintendent at the conference for the following year. Be it further resolved that any material may be presented to said committees during the year.
- 2. That the pastors verify the reports of their respective churches before sending them to the District Conference.
- 3. That all buildings such as churches, parsonages, or extensive improvements, be approved by the District Superintendent before construction.
- 4. That no church of our district shall call a pastor, evangelist, representative of foreign missions or other church institutions without first consulting the District Superintendent.
- 5. That the conference year close on June 30 and that all reports be in the hands of the district statistician by July 10th and that all district monies be sent to the District Treasurer by the same date.

- 6. That we go on record as being opposed to our children having to dress, dance or do other things in the physical education department of the public schools in violation of our religious convictions and our church standards.
- 7. Owing to the soon coming of Jesus and the great spiritual need of the world, be it resolved that each pastor be privileged to hold two revival meetings of two weeks duration each year with regular support paid, subject to the approval of the District Superintendent.
- 8. Be it resolved that we have a Foreign Missionary Convention in the fall, time to be set by the District Council.
- 9. That the District Treasurer give an itemized account to the District Conference of where all the Home Missionary money was spent.
- 10. That all members pay their tithes into the church in which they retain their membership, according to Section 69 in the Manual.
- 11. That the District secure and maintain all the books in the different courses of study as prescribed by the Manual in sufficient number to accommodate, if necessary, any candidate taking any one of the courses. That the Educational Committee formulate rules for the loaning of such books, determine the number to be secured, and select custodian, subject to the approval of the District Council.
- 12. That the conference bar shall include the first seven rows of seats in the center and south sections and the platform.
- 13. Be it resolved that the time for Conference sittings be fixed as follows: 8:00-11:45 a.m., 1:45-5:00 p.m. and 6:30-9:00 p.m.
- 14. That the District Superintendent shall appoint all committees and fill all vacancies.
- 15. Be it resolved that the District Superintendent be granted a two weeks' vacation with pay each year.
- 16. We recommend that each pastor be granted a two weeks' vacation with pay each year.
- 17. Whereas the present trend toward immodesty of dress is so evidently out of keeping with the Word of God, girls and women who are members of the Pilgrim Holiness Church are not to appear in public wearing immodest forms of dress so current today, such as sun suits, shorts or without stockings, dresses of immodest length, slacks, or similar garments. Men and boys of the church are not to appear in public in shorts or without shirts.
- 18. Whereas the trend of worldliness is so prevalent and is making inroads in the Church, be it resolved that we strongly urge parents to dress their children according to the spirit of the Manual which sets forth a standard of modesty.
- 19. Be it resolved that District Minister's license shall not be granted to any person who does not have a definite call to, or who does not plan to enter the active ministry.

Be it further resolved that no licentiate be advanced in ministerial standing unless actively engaged in the ministry.

- 20. Be it resolved that each pastor report all seekers in the church of which he has the oversight.
- 21. Be it resolved that semi-annual zone Sunday School conventions be held for the purpose of encouraging the work of the Sunday School, such conventions to be arranged for, and supervised by the chairman of the District Sunday School Board if possible, or by some other member of the District Sunday School Board.
- 22. Whereas there is considerable work cleaning the camp ground and storing equipment. Be it resolved that each member of the conference remain one day after conference to assist the District Superintendent in doing the work.
- 23. We recommend that our laity be given recognition along with our ministry in the list of memorials.
- 24. Owing to the soon coming of Jesus and the great spiritual need of the world, Be it resolved that our District Superintendent be privileged to hold two revival meetings during the year outside of the district with regular support.

25. Whereas in accordance with the Manual be it "Resolved, that ministerial Study Course be put on a yearly basis with the requirement that three study books and three reading books be the minimum requirement," and that each licensed minister correspond with the study course agency respecting his course and tests.

BE IT FURTHER RESOLVED that the seminar work be evaluated and credit be given by the study course agency.

26. Whereas it is very necessary at the time of pastoral change for the new pastor to become acquainted with his people as soon as possible and whereas the pastor leaving does not have adequate time for the preparation of a complete list of names and addresses of the members and constituency.

Therefore be it resolved that every pastor compile and keep up to date a complete file of all those attending his or her church.

- 27. Be it resolved that a printed statement be given each person registering at the Pikes Peak Holiness Camp showing the registration requirements.
- 28. Whereas the District has purchased a suitable safe for all abstracts and legal papers, be it resolved all abstracts and other legal papers be placed in same.
- 29. Whereas, the General Board of the Pilgrim Holiness Church has authorized Pilgrim Pension Plan, Inc., to make loans of pension funds to local Pilgrim Holiness Churches, under such conditions as required active participation on the part of the Pilgrim Holiness Districts.

THEREFORE, BE IT RESOLVED by the Annual Conference of this district that the District Council, District Trustees, and all District Officials be, and they are hereby authorized, to do and perform any and all acts required of them in the consummation of authorized loans to local Pilgrim Holiness Churches of this district, subject however, to the limitations and conditions set out in said Resolution of the General Board of the Pilgrim Holiness Church authorizing said loans.

30. Whereas the District Conference desires the continuation of the Rocky Mountain Pilgrim, with 10 issues per year,

We recommend the offices of Editor of the Rocky Mountain Pilgrim and the District Sunday School Secretary be combined.

- 31. Be it resolved that in case of the death of a minister or a member of the family, that the District Superintendent be responsible for notifying the pastors of the District, and the Conference to stand expense of same.
- 32. Whereas many times there are close friends and relatives of licensed ministers who want to attend the ordination service, but are unable to do so because necessary announcement has not been made, be it resolved that the ordination service be announced prior to conference.
- 33. Whereas the majority of television programs are a definite hindrance to the spirituality of our people, being evil influence into the home: Be it resolved we go on record as opposing television.
- 34. In order to bring our Sunday Schools in line with the General Policy: BE IT RESOLVED that no Sunday School Scholars be counted after the half way mark in the class period.

BE IT FURTHER RESOLVED that the yearly Sunday School average be based on the 50 best Sundays.

- 35. We recommend the price of Conference Minutes be set at 50c each and that each pastor be responsible to collect and bring to conference the money for the number of minutes that his church desires.
- 36. Be it resolved that the time of the district camp meeting be set as follows: To begin the Friday nearest to July 15.
- 37. A copy of the Rocky Mountain District by laws can be found on page 10 in the 1961 District Conference Minutes.
- 38. Whereas standing rules No. 38 and 39 seem to be impracticable, Be it therefore resolved, that the candidates for Ordination, passed upon by the district conference, be ordained at a set time during the last Sunday of the following camp meeting.

# STANDING RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE

1. Be it resolved that the District Superintendent be given a salary of \$300.00 per month with district parsonage and utilities, together with six (6) cents per mile for traveling expense while driving his own car, and actual traveling expense while traveling otherwise.

We further recommend, that whereas, the mileage incurred by the District Superintendent in the work of the District is that beyond the average driven, thus making mechanical repair and trade-in more often than the recommended time of driving a car: We therefore recommend that the District Treasurer be instructed to set aside each year the sum of Three Hundred Dollars (\$300.00), the same to be applied as a supplement to the depreciation and trade-in of the District Superintendent's car.

- 2. Be it resolved that if the District Superintendent prefers not to live in the district parsonage the rent from same be returned to the district treasurer, and a reasonable housing allotment be paid the District Superintendent. Said allotment to be determined by the District Council according to the amount of rent received and necessary up-keep on the parsonage.
- 3. Be it resolved that the assistant District Superintendent, or any member of the Council acting in the District Superintendent's place receive \$5.00 per day, plus (4) cents per mile traveling expense while driving his own car, and actual traveling expense while traveling otherwise. The District Council when traveling to Council meetings, shall be paid (4) cents per mile traveling expense while driving his own car, and actual traveling expense while traveling otherwise.
- 4. Be it resolved that the District pastors and unstationed ministers not participating in the Pension Plan pay three-fourths of their ministerial tithe into the district treasury to be applied on District administrative expense and the remainder to be paid into the treasury of the local church to which they belong.

Be it further resolved that all District evangelists, teachers and other unstationed ministers, participating in the Pension Plan, pay their entire tithe into the District Treasury. On the basis of the tithe paid to the District, the District Treasurer shall pay the 7 percent as required by the Pension Plan.

- 5. That each local church furnish its parsonage with at least a cook stove, a heater, a kitchen cabinet, six chairs, a dining room table and a dresser.
- 6. Be it resolved that the annual remuneration of the District Secretary be \$100.00 and that the District Treasurer be paid \$25.00 per month. Be it further resolved that the District Statisticians each be given \$15 per year, and that the salary for the combined offices of District Sunday School Secretary and Editor of the Rocky Mountain Pilgrim be set at \$50 per year.
- 7. Be it resolved that all attending the Pikes Peak Holiness Camp Meeting be properly registered. Each registrant twelve years of age and above, except active ministers and their families, will be required to pay a fee of \$2.00. Each registrant 12 years of age and above including active ministers and their families, will be required to pay a fee of 50c for insurance purposes.

Registration cards will be made so that each registrant be assigned specific duties in one of the work departments of the camp, the foreman of that detail to punch each card each day when duty has been performed. These duties will be assigned by a Camp Meeting Committee of three persons to be appointed by the District Superintendent.

We further recommend that an attendant be in charge at each meal to check registration cards and receive free-will offerings.

- 8. We recommend that the local church pay the expenses of its delegates to and from District Conference.
- 9. Be it resolved that each Sunday School pay 10c per enrolled Sunday School member per year for promotion of District Sunday School work.

10. Be it resolved that each local church send to the District Treasurer each month an amount equivalent to 12 percent of all regular offerings. From this amount 43 percent shall be for United Stewardship fund, 45 percent shall be for District Budget and 12 percent shall be for District Church Extension.

BE IT FURTHER RESOLVED that each church be assessed 50c per senior member for International Conference expense fund.

- 11. Be it resolved that, in compliance with the request of our zone school board, each senior member of our district be assessed \$5.00 per year for Bible School budget, 25c of which will go for the Rocky Mountain District's portion of the school boards travel expense, this budget to be raised in any way the local church may desire.
- 12. We recommend the District Treasurer set aside the amount equal to 32 percent of the United Stewardship fund from unspecified general church extension funds, the same to be included in the United Stewardship fund.
- 13. Be it resolved that the members of the District Sunday School and Young People's Boards be given (5) cents per mile for traveling expense to be paid from the funds of their respective boards.
- 14. We recommend that each Church take up a free will offering to help defray the expenses of the Ministerial meeting in March.
- 15 Be it resolved that a fee of one dollar each be made for the use of the District study books and that a fee of 50c each made for the use of District Reading books.
- 16. Due to the conference decision to purchase a District Camp Ground: Be it resolved that the District Superintendent be authorized to take three special offerings in each church each year, 90 percent of said offerings to be applied to the District Camp ground debt and interest, and 10 percent to be set aside for maintenance and repair on the Camp Ground.

We further recommend that the goal for these offerings be set at \$10.00 per year per senior member for the District.

We further recommend that the District Superintendent be authorized to take a special offering each year at District Camp to be applied to the District Camp ground debt and interest.

- 17. We recommend that the District Superintendent meet with each local Advisory Board at least once each year to review the Church's financial welfare and endeavor, wherever possible, to obtain yearly raises in pastor's support.
- 18. We recommend that our conference accept the proposal of Central Pilgrim College in granting each year a one-half tuition scholarship to Central Pilgrim College to a student on our district. The college will then grant the same to another student.

We further recommend that these students be chosen by the District Council from Pilgrim Holiness ranks on the basis of the two students with the best scholastic and church records.

19. Be it resolved, that each local youth society, organized or unorganized, send five percent (5%) of the regular youth offering to the District Youth Treasury.

#### Pension Plan

Whereas the General Church has adopted and recommended the Pilgrim Pension Plan as a sound method of providing retirement benefits for aged Pilgrim ministers, and Whereas the Rocky Mountain Conference has declared its endorsement of the plan, and whereas action taken at the 1954 General Conference makes it mandatory for each local church to participate in the plan, we therefore recommend that every church, no less than once each quarter, send to the District Treasurer an amount equivalent to 7 percent of the pastor's salary as the conference contribution to the Pension Plan.

#### FORTY-THIRD ANNUAL DISTRICT CONFERENCE

First Sitting July 27, 1964-8:00 a.m.

The Forty-Third Annual Assembly of the Rocky Mountain District Conference of the Pilgrim Holiness Church was called to order by the District Superintendent, L. E. Schendel, at 8:00 a.m. July 27, 1964, at the Camp Ground at Colorado Springs, Colorado.

James Butler led the conference in singing two songs, namely "Love Lifted Me" and "The New Jerusalem."

The Superintendent called the Conference to prayer with Clifford Conard leading.

Superintendent L. E. Schendel made explanation that General Superintendent Dr. William Neff would be somewhat late because of a delay. It was decided to take care of the preliminary items.

The conference bar was set according to the minutes.

The Secretary called the roll. Bonnie Clough was seated in the conference as a delegate for the Lincoln, Nebraska, church.

Upon request of the District Superintendent, the Secretary read the joint report of the Educational and Examining Boards. Motion prevailed to accept this report.

Words of appreciation were spoken in behalf of Rev. J. C. Beckner, new pastor of our Tecumseh Church. His testimony was appreciated by the conference.

It was then moved and seconded that we set the time for the Ordination Service for 6:30 p.m. July 27, 1964. It was carried.

The Report of the Sunday School Promotional Secretary was called for. His report was encouraging and he pointed out that we had a substantial gain. The attendance gains were reviewed and awards were presented. Churches awarded were—Campo, Knob Hill, Denver Bethany, Fort Collins, Lamar, Lewellen, Lodgepole, and Pueblo. He then read the rating of our Sunday Schools according to the Standard of Excellence, and certificates were awarded. The Denver Villa Park pastor, E. K. Purcell, and delegates were awarded the Decade of Progress Ship and also the award for the March to Sunday School in March Campaign.

Words of appreciation were expressed for our Promotional Secretary and his work over the past year.

Dr. William Neff arrived and was introduced as our presiding officer for the Conference by Superintendent L. E. Schendel. Dr. Neff gave words of greetings to the Conference, also from General Superintendents Dr. Melvin Snyder and Dr. P. W. Thomas. He expressed words of appreciation for the Rocky Mountain District.

The report of the District Superintendent, L. E. Schendel, was read and greatly appreciated. A motion prevailed to accept it.

The Assistant District Superintendent read his report. It was graciously accepted.

The Auditor's report was read. It was accepted by common consent.

The District Treasurer read his well prepared report. The motion prevailed to accept it.

The Statistical Report was read by Bro. Marvin Moberly. The report was appreciated and a motion prevailed to accept it.

The Pastors' individual reports were read. The General Superintendent asked the Secretary to read the names of the active pastors, after which they gave their reports.

The Reception Committee presented Dr. and Mrs. William S. Deal, Rev. Donald Larson, Regional Director of the N.A.E., Rev. Roy Glendenning and Rev. Mark Waddell. They were granted honorary seats in the Conference Bar.

Rev. Donald Larson was asked to address the Conference. He extended greetings from the N.A.E. In his short address he mentioned the purpose and work of the N.A.E., pointing out the need for uniting our forces of good against the forces of evil.

Dr. Neff spoke kind words of the work of the N.A.E. and asked that we support its program.

The Committee on Resolutions reported.

Resolution No. 1 was read—"Inasmuch as each district has been directed by the general board to elect a district CYC (Christian Youth Crusaders) director, be it resolved that the offices of district youth president and district CYC director be temporarily combined." Motion prevailed to adopt it.

Resolution No. 2 was read—"Inasmuch as each district has been directed by the general board to elect a district PELT (Pilgrim Evangelical Leadership Training) director, be it resolved that the offices of Sunday School promotional secretary and district PELT director be combined. Motion prevailed to adopt it.

Resolution No. 3 was read. Motion prevailed to refer it back to the Committee.

The Conference recessed by expiration of time.

#### Afternoon Sitting

The afternoon sitting opened by singing "Down at the Cross."

Brother E. K. Purcell led the conference in prayer.

The minutes of the morning sitting were read and approved.

The Resolution No. 3, previously referred back to the committee, was brought back in. It was read and then amended to read, "Whereas standing rules Numbers 38 and 39 seem to be impractical, be it therefore resolved that the candidates for ordination, passed upon by the district conference, be ordained at a set time during the last Sunday of the following Camp Meeting." Carried.

Resolution No. 4 was read—"Be it resolved that recommendations for the Resolutions and Ways and Means Committees be sent to the chairmen of said committees not later than June 1st preceding the annual district conference. Be it further resolved that mimeographed copies of these recommendations be sent to each local Church by July 1st. Carried.

The Ways and Means Committee reported.

Recommendation No. 1 was read—"Whereas the Rocky Mountain Conference has accepted the proposal of one-half scholarship tuition for a student, and the district has supported this amount, we further recommend that this amount be raised through our five youth zones at their monthly meetings of the amount of \$34.00 per zone for the year, to the amount of \$170.00." Carried.

Recommendation No. 2 was read—"Whereas the borrower is servant to the lender" we recommend that two microphones be purchased for the annual Camp and Conference of the Rocky Mountain District, this amount to be raised through our local church youth groups in the amount of \$5.00 per youth group for the year, to the total amount of \$100.00."

We further recommend and urge our pastors and youth leaders to stress this in their local groups. Carried.

Recommendation No. 3 was read — "Be it resolved that recommendations No. 1, 3, 6, 7, 9, 12, 17 be changed to read, 'Be it resolved' in place of 'we recommend.' Be it further resolved, that each pastor consider recommendations 9, 11 and 17 as part of their budgets." Carried.

The District Superintendent appointed the following tellers:

At the board, Hubert Hughes;

To read, James Butler, Gerald Kahre and Jack Fitts.

To hand out ballots, Marvin Jenkins, Ed Purcell and Melvin Brown.

Dr. Neff called the conference to silent prayer for the mind of the Lord in our voting. Followed by a prayer by Dr. Neff.

Ballots were cast for Assistant District Superintendent. W. J. Brown was elected.

The Council's nominations for District Secretary were read. They were as follows: D. L. Knierim and Floyd Hadsell. Ballots were cast and D. L. Knierim was elected.

The Council's nominations for District Treasurer were read. They were as follows: V. G. Story, Paul Gafford and Floyd Kelley. Ballots were cast and V. G. Story was elected.

The Council's nominations for Educational Board Member were read. They were as follows: Ed Reiff and E. K. Purcell. Ballots were cast and Ed Reiff was elected.

The Council's nominations for Examining Board Member were read, as follows: Floyd Hadsell and C. C. Darr. Ballots were cast and Floyd Hadsell was elected.

Ballots were cast for three advisory members to the council. Those elected were W. F. Drown, Donald Moller and Paul Gafford.

The District Council's nominations for District Missionary Society President were read. They were as follows: Mrs. L. E. Schendel, Mrs. Floyd Hadsell and Mrs. V. G. Story. Ballots were cast and Mrs. L. E. Schendel was elected.

In view of the progress of the conference it was moved that we rescind the motion made earlier that we have the Ordination Service at 6:30 and have the service at 4:00 p.m. Carried.

The Committee on Memoirs reported. The report was accepted by all standing reverently and a time of silent prayer.

The need of a polity committee was brought before the Conference by Dr. Neff. It was moved that the District Council be the polity committee. It was carried.

Motion prevailed to authorize the District Council to take care of all unfinished business.

Rev. L. E. Schendel announced the names of the committee members.—See Directory.

The Pastoral appointments were read by the secretary.

The following Special Resolutions were read and approved by a standing vote:

We, the members of the Forty-Third Annual Conference of the Rocky Mountain District of the Pilgrim Holiness Church, resolve that there be given our chairman, Dr. William H. Neff, a rising vote of thanks to express our appreciation for his labor of love.

We, the members of the Forty-Third Annual Conference of the Rocky Mountain District of the Pilgrim Holiness Church, resolve that there be given to our District Superintendent, L. E. Schendel; our Secretary, D. L. Knierim; and our Treasurer, V. G. Story, a rising vote of thanks to express our appreciation of their faithfulness to us. Be it further resolved that there be given our cook, Lois Rothfuss, and all the kitchen and dining room help a rising vote of thanks, to express our appreciation for their faithful service.

Motion prevailed for adjournment.

Conference was dismissed by our beloved Superintendent, L. E. Schendel. (Secretary's note — An account of the Ordination Service)

The service opened by singing the song, "A Charge to Keep I Have," led by Hubert Hughes.

Appropriate portions of scripture were read by W. J. Brown, W. F. Drown and V. G. Story.

Dr. William Neff, General Superintendent, delivered the Ordination Address. The candidates, namely Ruth Brizendine, Roy Berkley and Carl Lathrum, were invited to the altar where they received the Ordination Charge and the laying on of hands of the Ordination Committee. The Ordination Committee was composed of Dr. William Neff, L. E. Schendel, W. J. Brown, V. G. Story, W. F. Drown and D. L. Knierim.

The Lord crowned this service with His abundant blessing.

#### DISTRICT SUPERINTENDENT'S REPORT

To our presiding General Superintendent, Rev. William H. Neff, pastors, evangelists, and lay delegates of the 43rd annual conference of the Rocky Mountain District. Our heart is full of joy because of the never failing promises of God. You and I have laid hold of some special promises for particular needs in our respective fields, and proven again to our complete satisfaction that His promises never fail. The pace of the world about us has not slackened one bit, but seems to be ever increasing. We need to be more careful than ever lest we be swallowed up in the rush and pursuit of "things" and fail to keep ourselves spiritual.

Along with the general hurry of the things of the world, we find the tasks and opportunities of the church ever increasing. We must push into every open door, for there we will find another chance to help a lost soul. I feel that each of our pastors has a keen vision of the great task of the church and because of this vision each one is succeeding in placing upon his people a greater burden. The work of the church can only be accomplished as all of the pastors and all of the people constantly keep before them this vision.

The heart of every person of this district was made heavy in the month of December by the tragic death of one of our fellow ministers, Rev. Reece Farlow.

The same tragedy took the life of his sixteen year old son, Wray.

#### Church Property Improvement

The pastors and people of each local church, from year to year, take a wonderful delight in keeping the properties in good repair and a presentable place in which to worship.

The Bethel Church has completed its move to the west side of the city. They have installed a hot water heating system, which is quite adequate for

the building.

The Canon City Church at this writing is in the planning stage of a much needed building program. This will be an addition to their educational department.

First Church in Colorado Springs, after months of planning, praying and

negotiating, should begin work on their new building in a week or two.

The church at Rocky Ford had an opportunity to purchase some nearly new oak pews at a greatly reduced price. These pews make for comfortable and adequate seating in their church.

The parsonage at Superior has had two much needed rooms added, in what was a large attic. Thanks to Brother Hadsell and his people there, these

rooms mean a real need met at Superior.

The pastor and people at Walsh Church have done a fine job in lowering

the ceiling in the church.

Beside the above specific improvements, several of the churches have done outside and inside decorating.

#### District Church Extension

The District now has only two extension projects. We are obligated for a small monthly payment on the property at West Pueblo. The prospects for organization at this place are bright. This church should be brought into the dis-

trict at conference time next July.

The Thornton work has been making fine progress under the capable leadership of Brother Butler. The new Parsonage-Church is nearly completed, the Butlers have moved in and services are being held in the new building. To record all of the wonderful leadings and work of God in this project would consume more time and space than is allotted to us here. For all that has been accomplished, and for the prospects of the future we praise God. We shall need the continued prayers and support of all the people of this district for the work at Thornton.

#### Bible College

The past year has been a time of change for our college. Because of his health, Bro. Flexon felt he must resign as president. His resignation was accepted with many regrets by the committee of the College Board. Brother Bonner accepted the presidency of the college and God is surely helping him. The college service at this past camp was well accepted by our people and the offering

was the largest in several years. It seems to me that this is an indication of the high regard our people have for the college and for Brother Bonner as its leade. I trust that every church will do its best to meet the Bible College budget and let us all pray much for the school.

#### Camp Ground

Each year brings us nearer to the time when the Camp Ground debt will be liquidated. This year again a number of churches have met their quota in full. For this we are grateful. However, some churches have fallen woefully behind in this obligation and this is creating a real problem in meeting our semi-annual payments. I trust that every pastor and each local church board will give their attention to this matter this year. It is not only the duty of the District Superintendent to take an offering each time he comes to your church, it is the obligation of each pastor and local church board to see that this quota is met.

#### Camp Meeting

God has again seen fit to give us a good camp meeting. He has graciously used Brothers Adcock and Deal in the presenting of Gospel truth, which in turn, by the aid of the Holy Spirit, has produced results in the hearts of the hearers. The anointed singing of the Sheets was enjoyed by our people. The fine spirit of the cook and all of the Camp Meeting help was greatly appreciated. Also relative to the camp meeting it is worthy of note that the Lord helped us to install another much needed rest room and to make some necessary repairs on the tabernacle.

#### My Personal Report

During the past year I have preached 84 times. I have held 23 local church board meetings, 20 church meetings, and have personally conducted all of the annual meetings. I have had two funerals, assisted in the dedication services of the church and parsonage at Fort Collins. I have dedicated babies and assisted my pastors in Communion services. I have presided at all of the District Council meetings. I have tried to visit all of the churches at least three times this past year and in doing so have traveled 17,435 miles. It was my privilege to attend the church leaders conference in Indianapolis in November. I have tried to faithfully carry out my obligations as the chairman of the Board of Trustees of Central Pilgrim College, and in doing so have traveled 5,640 miles above my travel for the district. My labors have been limited, but they have been pleasant. The fine reception we have had in each church and in each pastor's home has been heart warming, and the spirit of determination on the part of pastor and people bespeaks of victories ahead.
