

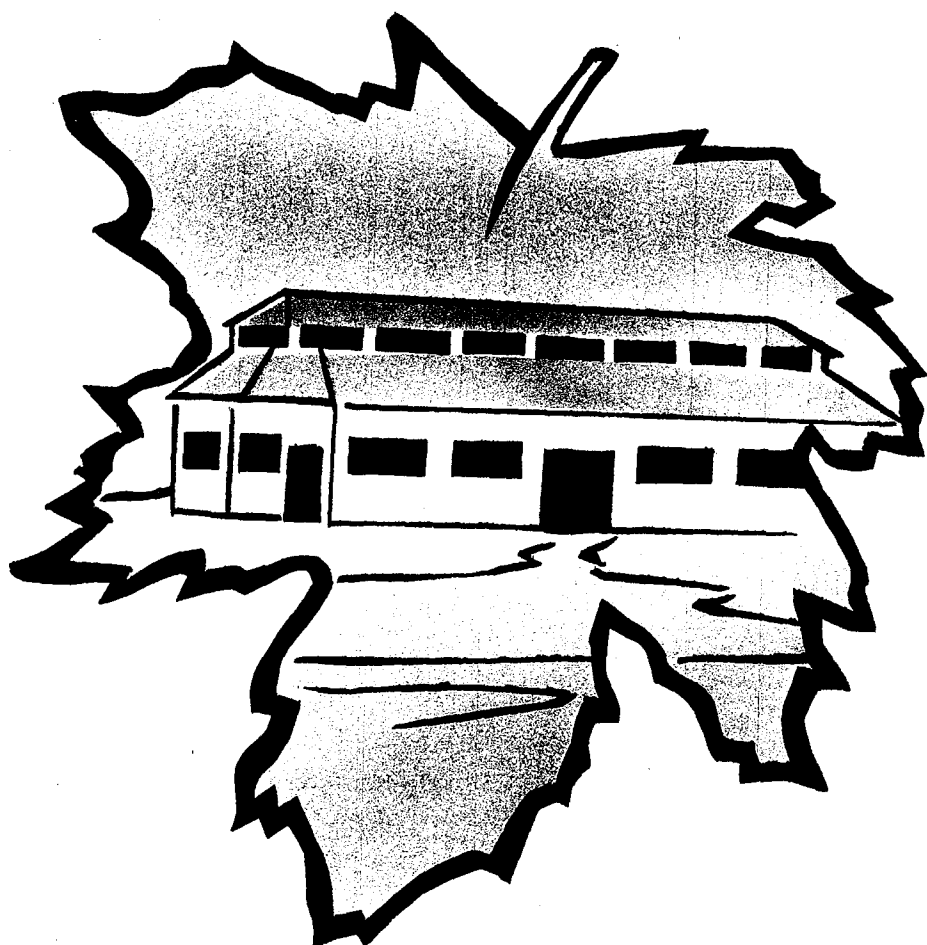

### DISTRICT SUPERINTENDENT'S REPORT.

To the Eighth Annual Assembly of the Tennessee District of the Pilgrim Holiness Church, greetings:

In the spirit of gladness I can report victory in my soul, praise His dear name.

The District Sunday School Rally in June added new interest and numbers to our growing Sunday Schools. McEwen gained 275%. Others made encouraging progress.

We sponsored two Home Missionary meetings, one at Waverly, Tennessee, and another at Rose Hill, Virginia. Each one seems to be a prospect for future Pilgrim Holiness Churches.

During my work for the District I have traveled about 5000 miles, including the trip over the District with Brother Howell. We organized the church at Knoxville, and dedicated the church at Monterey. Have held ten Annual Business Meetings. Preached in revival work and District eighty times. Have had about 100 seekers. Have received from the District on salary \$138.00, for traveling expenses \$21.21, and other sources estimated at \$500.00.

The spirit and co-operation of the pastors and workers has been responsible for the progress that has been made. We see better things ahead for

the Tennessee District.

Report of former District Superintendent, Rev.

To the Eighth Annual Assembly of the Tennessee  
District of the Pilgrim Holiness Church, greetings:

It is with deep gratitude to Almighty God that  
He has privileged us to have part in the ministry  
and enabled us to help further the cause of Christ  
in the District.

The period of time which this report covers were  
months of strenuous labor. We endeavored to push  
each department of the Church knowing that only as  
each is developed will our Church grow.

We wish to submit the following report: We  
have traveled 8370 miles in our work on the Dis-  
trict and received \$39.67 for traveling expenses.  
We received from the District for our support  
\$404.39. Preached 58 times and saw 30 seekers  
kneel at the altar, many of whom were happy find-  
ers. We held 14 business meetings, baptized  
three individuals, conducted three funerals and  
dedicated one church. We visited each church  
at least twice and some many more. We also  
nearly completed the construction of the taber-  
nacle. During this period of time we have also  
seen our Home Mission work at Knoxville develop  
until it became self supporting and ready to be  
organized.

We wish to thank each one for their co-operation,  
and inasmuch as we felt the Lord leading to new  
fields of labor, we offered our resignation effect-  
ive March 1, 1941. We trust the work of the Dis-  
trict will continue to grow, and pray God's bless-  
ings upon all.

## RESOLUTIONS

No. 1. Be it resolved that the date of the next Campmeeting and Assembly be July 17-26, 1942.

No. 2. Be it resolved that each Church devote one service each month to General Missionary interests, the offering to be taken either in the Sunday School or church service and to be sent to the District Treasurer for General Missions.

No. 2. Resolved that each Church donate two bed springs and furnishings, or the equivalent in cash, for Campmeeting equipment.

No. 4. Be it resolved that the District Superintendent or his assistant visit each Church three times this year, and each Church give poundings at each visit.

No. 5. Since it is a matter of importance for all pastors of the District to attend the Assembly and Campmeeting, be it resolved that the pastor's support at the Church where he is serving continue over the Sundays he is attending Campmeeting and Assembly.



- No. 6 Resolved that we as pastors co-operate with our District Superintendent in work on the Camp ground, and that when called upon we come or send someone.
- No. 7. Be it resolved that each Church with its pastor try to dig out one new work.
- No. 8. Be it resolved that each pastor read all resolutions to his Church at the earliest convenience, and also a few weeks previous to Campmeeting.
- No. 9 Be it resolved that each Church take an offering of groceries, vegetables and cash for the Camp.
- No. 10. Be it resolved that all monies of the local Church be sent in by the tenth of the month.
- No. 11. Whereas many of our pastors have not received sufficient financial support, be it resolved that each Church or pastor appoint some one to take poundings for the pastor.
- No. 12. We request that no pastor's wife be elected to serve as delegate to the Assembly where the Church has a sufficient number of members to select from.
- No. 13. Be it resolved that each pastor organize a Young Peoples' Society where possible, and to encourage same. Furthermore, that Home Missionary offerings be taken monthly at regular Young Peoples' services.
- No. 14. Be it resolved that one copy of the minutes be in every Pilgrim Holiness Church to be there for use of those wishing to read same, also that pastor urge members to have their own copy of the minutes.
- No. 15. Be it resolved that the District Council appoint someone or persons to have charge of the printing of the minutes.

No. 16. Be it resolved that the Ministerial Convention be held the 4, 5 and 6 of March, 1942.

No. 17. Be it resolved that all annual Church and ministerial reports be in the hands of the district statistician not later than ten days before the next Camp.

No. 18. Be it resolved that the District Superintendent and his assistant be elected a Camp-ground Committee to look after any emergency that may arise between Campmeeting seasons.

No. 19. Be it resolved that the District Council nominate two members for the office of District Treasurer, one of them to be elected by the Assembly.

#### RECOMMENDATIONS OF THE WAYS AND MEANS COMM.

No. 1. We recommend that the Ministers' tithes be paid into the District Treasury, same to be applied on District Superintendent's salary.

No. 2. We recommend that all members tithe into the local treasury, and that ten percent of the regular offerings, or its equivalent, be sent to the District Treasurer to be prorated to the various departments of the District work. Be it further resolved that the percent for the various departments be for District Superintendent 45%, Home Missions 35%, incidentals 20%.

No. 3. We recommend that the District Superintendent be allowed the privilege of holding six or eight revivals off the District each year. That he be permitted to keep his evangelistic offerings over and above his salary, but he shall pay his own traveling expense.

No. 4. We recommend that the District Superintendent be paid three cents per mile for traveling expense for each trip over the District, and that each Church be asked to raise the following amounts for the year: Clinton \$20.00; Chattanooga \$20.00; Lake City \$15.00; Jamestown \$10.00;

McEwen \$10.00; New Tazwell \$4.00; Monterey \$3.00; LaFollette \$2.00; Brown's Chapel \$1.00; Knoxville \$10.00; Silver Point \$2.00; Moss \$1.00. We further recommend that each Church at the regular visit of the District Superintendent take an offering for him, same to be applied on traveling expense.

No. 6. We recommend that the District Treasurer be allowed \$1.00 per month for postage, phone calls, etc., same to be paid from incidental fund.

No. 7. We recommend that each Sunday School take ten cents out of each Sunday offering, same to be used for the upkeep of the District property.

No. 9. We recommend that a Home Missions Board consisting of District Superintendent, Assistant District Superintendent and District Treasurer, be empowered to handle all Home Missions projects within the District, and that all expenditures to be made, be agreed upon by a majority of said Board.

We further recommend that the present building fund be transferred to the Home Missions fund.

No. 10. We recommend that the District Council be informed to provide a plan to raise General Assembly expense.
