The Fourth Annual Assembly of the Tennessee-Alabama District, Pilgrim Holiness Church, convened at Cumberland Grove Camp Ground, Jamestown, Tennessee, July 29, 1937. District Superintendent, Rev. E. O. Howell, in the chair. The first session opened at 10:00 o'clock A. M. by singing, "When the King Divine Saved Me" and "I Have Settled the Question." Reading from 2 Timothy, 2nd chapter, by Brother Howell. Prayer by Brother Simmons.

First three rows of seats established as the conference bar.

Moved and supported that pastors' wives be given a seat within the conference bar.

Appointing of committees by the District Superintendent.

Moved and supported that a committee be appointed to draft a letter to the General Superintendent, expressing our regrets that he could not be with us in the Assembly, and also words of comfort.

Assembly went to prayer to thank Almighty God for victories. The season of prayer wound up with shouts of victory and an old-fashioned hand shake.

District Superintendent submitted his report which was accepted.

Moved and supported that all unread reports be accepted.

Moved and supported that the Assembly adjourn until 10:30 A. M.

### RESOLUTIONS

1. Be it resolved that the Camp and Assembly begin next year on the last Friday of July, and that the first business session be called the following Monday.
2. Be it resolved that each church devote one service each month to Missionary interests, the offering to be sent to the District Treasurer for Foreign Missions.
3. Be it resolved that the District Superintendent or his assistant visit each church three times this year.

4. Be it resolved that each church with its pastor do its best to dig out one new work each year.
5. Resolved that we as pastors co-operate with our District Superintendent in the work on the camp ground, that when called upon we come or send someone.
6. Be it resolved that each pastor read all resolutions to his church at the earliest convenience.
7. Since it is a matter of importance for all pastors of the District to attend the Assembly and Camp Meeting, be it resolved that the pastor's support at the church where he is serving as pastor continue over the two Sundays he is attending the Camp and Assembly.
8. Be it resolved that each church donate one bed complete, with two extra sheets, or its equivalent in cash, for Camp equipment.
9. Resolved that each church take an offering of groceries, vegetables and cash for Camp.
10. Be it resolved that all monies of the local churches be sent in by the tenth of each month.
11. Whereas many of our pastors have not received sufficient financial support, be it resolved that each local church appoint one or more prayer meeting nights each month, as the need may be, as donation nights.
12. Due to much laxity heretofore on the part of our pastors, be it resolved that all pastors be at the Camp and Assembly by the first service, and that they remain until the closing service, unless excused by the Assembly, or in case of sickness.
13. Be it resolved that we have a weekly prayer meeting for Home and Foreign Missions.
14. Resolved that no pastor's wife be elected to serve as a delegate to the Assembly, where the church has a sufficient number of members to select from.
15. Resolved that each pastor organize a Young People's Society where possible, and to encourage same. Furthermore, that Home Missionary offerings be taken monthly at regular Young People's services.

#### RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE

1. We, the Ways and Means Committee, recommend that the District Council prorate the District and General Budgets and the District Superintendent's traveling expense on the same ratio as last year, and that the churches and pastors be notified of the same at the earliest convenience.
2. We recommend that each church raise an equivalent of seventy-five cents per member, same to be forwarded to the District Treasurer, for General Assembly expense.
3. We recommend that all stationed ministers and evangelists pay their tithes to the District Treasurer, same to be applied on the District Superintendent's support.
4. We recommend that the District Superintendent be paid \$800.00 this year.

6. Resolved that the District Superintendent, or one directed by him, shall hold at least one revival in each church during the year, and that the income from said revival shall be applied on said church's budget, after the evangelist's traveling expenses are paid.

7. Resolved that 15 per cent of the District Budget be used to create a sinking fund for incidentals.

### DISTRICT SUPERINTENDENT'S REPORT

To the Fourth Annual Assembly of the Pilgrim Holiness Church, Tennessee-Alabama District, at Cumberland Grove Camp Ground—Greetings.

At the close of the Assembly of last year, your servant assumed the work of the District as Acting Superintendent. During the last of September Brother R. W. Wolfe resigned, and since then we have been in labors abundant for the church and district. We have worked hard to preserve the work entrusted to our care, and through the help of the Lord and faithful workers have not only succeeded in this, but have made some advancements as well.

I wish to submit the following report: Have traveled 15,000 miles, preached 138 times, have had 94 seekers at the altar, called at and prayed in 180 homes, conducted 9 regional meetings and held 4 revivals. Some of the churches have been visited as many as five or six times.

This year we have bought a District parsonage, as well as a new tent for Home Missionary Work. The church at East Chattanooga has finished paying for their lot and hope to begin building soon. We organized and dedicated the church at LaFollette, free from debt. The churches at Clinton, New Tazwell and Jamestown have been painted. Brown's Chapel is almost completed. A parsonage is being constructed at York's Chapel. Some improvements have been made on the Camp Ground, and little indebtedness remains.

We received from the District \$553.83 on our salary, and \$65.11 on traveling expenses, also approximately \$54.00 in donations. We have paid out approximately \$285.00 for traveling expenses.

Two new places have been opened this summer where we have good prospects of establishing works. Other doors are open and people are calling for the Gospel. Our desire is to be humble at the feet of the Master and let Him use us for His glory.
