To the Seventh Annual Assembly of the Pilgrim Holiness Church, Tennessee-Alabama District, greetings:

We are glad to report victory through the blood of Jesus. The past year has been one of hard work toil for the master. As we wiew the entire work of the District we are glad to say that we have made good progress along all lines.

Our church at Jamestown has built Sunday School rooms under the church. At Monterey we have built a new parsonage. The church at LaFollette is building rooms under their church and will soon have them completed. A new church has been erected at Moss. A new asphalt shingle roof has been put on our district parsonage and much work has been done on our new tabernacle. At McEwen we are buying the church property. A new church building is also under construction at Sharp corner.

We have endeavored to push our Home Missionary work this year also. A tent meeting has been held at Pletcher, Alabama, and many souls sought and found God. A lot has been donated for a church there and we are now endeavor: ing to secure a building for a church.

Our Knoxville work is making progress but we are greatly hindered by a shortage of finance.

A good work has been turned over to us at Moss by Brother Elmer Kizzee and is making good progress.

During the year we have traveled in the District, not including one trip to General Board meeting, 13891 miles. Preached 74 times and had 47 seekers at the altar. Have made 110 calls and received thirty members into the church. From the District I have received on salary \$561.05. For traveling expense I have received \$63.36. In donations approximately \$64.30. I also received from the General Church \$175.00. Visited the Pittsburg District Campmeeting in the interest of General Home Missions and traveled approximately 800 miles. My expenses were paid by the General Church.

We have good co-operation from all of the pastors and workers the past year, and their help has made our progress possible. We predict a good year ahead for the Tennessee-Alabama District.

We further recommend that his visits to Home Missions projects be financed out of the Home Missions fund.
