FIRST SITTING

The twelfth annual Conference of the Texas District of the Pilgrim Holiness Church convened June 4, 1962 at 7:30 P.M., at the Dallas Church. Miss Elsie Morris led the members of the conference and their friends in singing, "At Calvary," and "In My Heart There Rings a Melody." Rev. N. N. Bonner, president of Central Pilgrim College, led in prayer. Ed and Mary Smith sang a special song, "I Will Make a Way Somehow." Our District Superintendent, Rev. J. M. Burcham, presented our General Secretary of Church Extension, Dr. R. C. Hawkins, who also was the speaker of the Conference. Brother Hawkins preached from the passage of Scripture found in Hebrews 13:5-9. His theme was "The Tranquil Life, or, the Life of Evenness."

SECOND SITTING

The business session opened at 9:00 A.M., with Miss Morris leading the Conference in singing "Trust and Obey." Brother Keen led in prayer. Brother Burcham presented Brother Hawkins, as the chairman of the conference. Brother Hawkins brought a devotional message from St. John 9:1-12, emphasizing verse 4: "I must work the works of Him that sent me while it is day." He asserted that our purpose as workers for the Lord was not to meet emergencies, but to complete the job at hand."

The Secretary called the roll. Superintendent Burcham proposed that the Conference Bar be set to include the first four seats on each side of the church and the platform. It was so ordered by common consent, and the delegates were instructed to take their seats within the bar.

Brother Downing presented Rev. and Mrs. Bonner to the conference, and they were given a seat within the conference bar.

The times of the sitting were set at 9 to 12 A.M., 2-5 P.M., and the night service at 7 P.M.

The following were received into the conference pending the receipt of their transfers from districts of which they were formerly members: Rev. and Mrs. William Whybrew, Rev. and Mrs. Paul Scheuermeier, Rev. and Mrs. G. L. Keene, and Rev. Larry Jarvis.

The new Latin-American Church at Lyford was presented to the Conference, and was formally received into the District. The Lyford delegate was seated within the conference bar.

The District Superintendent read his report, and it was accepted and approved by a hearty, "Amen."

The Statistical report was read and accepted.

The Sunday School Promotional Secretary reported, and then gave out the following awards: Borger received a 5% gain ribbon; San Antonio received a 55% gain ribbon. and Hillsboro received 60% gain ribbons; San Antonio received the award for the highest numerical gain, and Hillsboro the award for the highest percentage gain. San Antonio was awarded the Trophy for the Decade of Progress. This good report was received and accepted.

The Superintendent was given time to present the Program for Progress for the next four yeas, as he had worked it out for the entire district. This program received hearty support, was approved.

The session was adjourned by expiration of time. The Bible School service was announced to be held at two o'clock in the afternoon.

THIRD SITTING

At two o'clock the conference was called to order, and Bob Bonnen led in singing "I am Thine" Brother Whybrew led in prayer. Brother Burcham then presented Rev. N. N. Bonner, President of Central Pilgrim College who was the speaker for the College service. He presented several of the students of the college, and announced that the Area Representative for the school will be Rev. Anatole Ferlet. He named Mrs. Gene Roberts as the Alumni Representative.

After the Bible School service, the conference was again called to order, and the report of the Auditing Committee was called for. The Committee reported, and their report was accepted by the conference.

The District Treasurer's report was read and accepted.

The Educational and Examining Board's report was read and approved.

The Resolutions Committee reported. Resolution No. 2 passed as changed. It was moved to delete resolution No. 3. The motion lost. It was moved to reconsider, which motion was carried. The entire resolution was then referred back to the committee.

It was moved to correct Resolution No. 7. The following was offered as a substitute motion: Resolved that Zone I shall include Corpus Christi, Houston East Side, Lyford, Raymondville, and San Antonio; Zone II, Dallas, Fort Worth, and Hillsboro; and Zone 3, Borger and Dalhart. The move to substitute carried, and then the substituted motion prevailed.

Resolution No. 2 under Sunday School was passed.

The Ways & Means Committee report was covered and passed in the Superintendent's Program of Progress report.

The Superintendent appointed Revs. Ferlet and Nettleton and Bro. Reed as tellers.

The chairman announced that the following appointments were made by the General Board of the Church: District Superintendent, J. M. Burcham; Secretary, S. A. Thomas; and Treasurer, L. B. Jarvis.

The Advisory members of the council selected by the Conference were Anatole Ferlet and G. L. Keene.

The Council nominated the following for the vacant posts on the Educational and Examining Board: Keene, Nettleton, and Scheuermeier. Rev. Keene was elected for 3 years and Rev. Nettleton was elected for 2 years.

The Council nominated Revs. Jarvis and Thomas for the vacancy on the Board of District Trustees. Rev. Thomas was elected.

The Superintendent read the committee appointments.

A fifteen minute recess was declared. After the recess the Committee on Memoirs reported. Tribute was paid to our departed Pilgrim Friend, Mrs. Ina Cash. Rev. Hawkins led in prayer.

The Miscellaneous Resolutions were passed, after which the Conference stood and sang the Doxology in closing. The Conference adjourned.

REPORT OF DISTRICT SUPRENTENDANT

To our General Superintendent, R. G. Flexon, General Church Extension Sec'y, R. C. Hawkins, and delegates of the 12th annual conference of the Pilgrim District, Inc. of the State of Texas, a big Texas greeting to all.

May heaven's richest love and grace rest upon every one of you.

This has been a transitory and adjustment year. A time when all have had to learn God's new program, and how to love and work with His new servants. This has been a year with a pinch of opposition. A small minority have been in opposition to the program and its leadership for various unqualified reasons. This we expected. No program worthwhile can come to fruition without being opposed, even by good people. We do not have any ill feelings toward such because, we have served our Lord long enough to realize many dear people do not fully understand the total program, and its true promotional purposes.

Furthermore, if we are going to lift ourselves out of a serious dilemma of one year ago, necessity forces us to make some drastic changes and to put a stop to what so ever may be killing the program of God.

However, I am happy to tell you the good word is: almost a unanimous majority all across the district have endorsed, supported, and promoted the entire program.

One year ago today our forces were scattered, and we were showing losses in almost every area of the district program. Today, because of a fighting; never quitting, spiriual, and dedicated corps of Church Extension Marines, this picture has not only been stayed, but we have some remarkable gains as well. Only God could give us so much so soon.

While we have been forced to sell in some areas, due to this shifting period, God has helped us to relocate in better areas. There has not been a single change of this nature made but what our dollars re-invested have purchased more, and better, than we had in the beginning.

Our district has a new outlook because God has given us men of kindred spirits who know how to look up. The leadership of the present, and that is to come, we pray shall always be men of valor and corageous faith. Not once in any area of the district growth have I heard fall from the lips of our men anything that sounded like defeatism. I believe God will win this battle for us. I'm happy to say our men believe He will win this battle, and is winning this battle for us all.

One year ago I insisted that if we keep the best of fellowship among us and Divine love radiant, the devil and all of his imps may try to pile the trash of opposition a mile high before us, but it can never defeat us.

I shall insist again as your leader that we keep radiant in our midst the finest spirit of brotherly love. "Behold how they loved one another." I'd like to see more "giving and receiving admonition" — "and so much the more as we see the day approaching."

We are not in need of criticism, or insubordination, or super holiness. We need Practical holiness, submission attitudes, ("submitting yourselves one to another"), and a constant stream of encouragement flowing from our hearts to all.

We need a greater emphasis upon a better and more effective praying people. We need to move in our devotion, humility, sacrifice, faith and works, until the heavens are opened, and the angels of Gods divine love are proclaiming revival fires all across the Texas District. Our future lies in our ability to move God and His felt presence into the very midst of our effort. New buildings, better locations, and strong leadership are a must. But there can be no substitute for a constant and a divine manifestation of Christ in our midst. Christ is the answer.

Today we are charged with an impossible task for man. However, let us not forget that we have not been asked to face this mountain of responsibility alone. We have ever by our side the specialist with the impossible, "He trod the way before us."

Today we are faced with opposition, but the Achans of every camp have been destroyed.

Today is the most difficult day of our district. All who have the courage to fight have been given the opportunity to do so. The cowards will quit and desert us, but unafraid soldiers will continue to fight to the victorious end.

Today is our greatest opportunity in Texas. The field is large and over-ripe with 9½ million Texans and 1 million Latin Americans. We have available all the strength the General church can throw our way. Each year brings to our district additional strong leadership for our pulpits. We have a workable program, and the men with the courage and fortitude to carry it out. We have hearts dedicated to the task.

Today we are looking in to a 4-year program. This program with almost the least amount of percentage gain possible should double our membership and Sunday school. It should bring every church up to its highest potential. Only two quadrennials away at the present percentage growth rate, this district should be nearing self sufficiency.

Our task is to build this district of Texas on the rock of deep spirituality. We must be ever faithful and dedicated to this responsibility.

God help every one of us to accellerate our efforts, keep our consciences clear, by an honest effort to pay our just monthly budgets, to give our people messages with meat and depth, and to keep ourselves ever humbly in His presence. May we keep our sights set high enough, though we should stumble a bit, we will still be able to reach out to receive the high medals, and silver cups of rewarding success.

REPORT OF THE CHURCHES

1. BORGER — The work here has been affected by some of their faithful people moving to other areas. However, some say they have been able to take out a great deal of the slack, and come up this year with the best Sunday school average in three years. Also they have made tremendous improvement in meeting their district and general budgets. There is evidence the Nettletons have worked hard this year. Although they are leaving Borger this conference, the good from the lives of this family will cast their shadows upon this people for a long time to come.

- 2. CORPUS CHRISTI Our pastor Rev. Larry Jarvis as only been on this field for six months. God has helped him wonderfully. He has been able to make up for the first six months sagg and has a gain in the last one-half conference year. They have met head on some pressing financial responsibilities. They report that they are in the best financial position for some time. They have taken in some new members, and the spiritual tide is high. Their plans are to meet at budgets next year. The big word of the church now is "go Roger go."
- 3. DALHART The work here has at last moved into position to take its greatest step ever, forward. For the first time in years, the people have become excited about the future. They have proved this by their excellent spirit and loyal giving. They have in the past year paid off the entire indebtedness of the little parsonage and also the church. I doubt that any other church can say the same. They have called the Downings for three years and plans are now under way for a new church parsonage. Already a lot has been given to the church for this purpose.
- 4. HILLSBORO This work has been re-activated by the coming of the Whybrew family. The pastor has fixed the church windows, torn down the eyesores around the buildings. They plan to paint the church soon, and put up a new church sign. They have had a good Sunday school gain and have kept their budget paid well. The people greatly appreciate the pastor, and gave him a unanimous re-call. Next year undoubtedly will be the greatest days in years for this good people.
- 5. DALLAS This church has had its ups and downs during the year. However, it has been up in spirit. Although they have lost some families that have moved away, and some by death, they have maintained a good Sunday school. They have confronted some problems that make it necessary to sell the church and parsonage. It is refreshing to know all has not been valley experiences. Rev. Keene and his good wife are not quitters, nor are their fine folks. They have worked hard in planning for re-location. I'm happy to tell you they have located approximately three acres in Singing Hills addition for a brand new church site. This is a great step forward and in the proper direction. We hope to have conference on the new church grounds next year. By God's wonderful guidance this should soon become one of the best churches on the district.

HOUSTON FIRST — This fine group of people have been led for the past several years by their now retiring pastor Rev. Abernathy. This Sunday school has suffered the only major loss in the district. However, they have taken in several new members. They have built on a new steel constructed annex, which gives them the best equipment with which to promote the church interest than ever before. They are to be commended for this venture of faith. We are daily praying that the future leadership of this church will lead this people in a new and brighter day.

7. LYFORD AND SEBASTIAN — This missionary circuit is carried on by the Thomases and Sister Elsie Morris. These two churches were received into the Texas District and fellowship this year. We welcome the wonderful people here into our midst. We are writing and searching every where possible for a pastor or missionary team to help in these new areas. We have many wonderful people here and with good leadership to help our present workers, we could be running one hundred per Sunday. Pray for this need.

- 8. FT. WORTH This work has been aided by the splendid leadership of Rev. Keene and his fine people. There have been weekly services in this new field for some months now. They are saving their tithes with plans for their new pastor, parsonage, and new church as soon as is possible. The newly appointed pastor for this fine people, and area of golden opportunity is Rev. Scheuermeier. There is no doubt about the future of this work with such dedication as is represented by the pastor and people.
- 9. RAYMONDVILLE This is the only foreign missionary work in Texas and perhaps the U.S.A. that does not cross some river or ocean. Brother and Sister Thomas along with the fine help of Sister Morris, are doing a tremendous job in our Latin American field. They have had success and growth all about them this year. They have received the greatest clothing response for this people ever. Only God knows how much this life line of clothing means to these works. They have out grown the church and are having classes in the parsonage, and any place they can find to meet. They need a larger building, and effort is being put forth to accomplish this in the near future. They have had a wonderful Sunday School gain and have taken in some fine new members recently. They have some wonderful young people one of which is in our Bartlesville School.
- 10. SAN ANTONIO Brother and Sister Ferlet are having the best days of their entire ministry here. This has been the best year on record for this work. While it is un-oganized now they hope to be able to bring it into the conference next year. They have taken in new members recently, and show one of the best Sunday School gains on the district. They have greatly improved their district budget giving. It is almost unbeleivably true that God has helped them to redecorate the inside of the church, put up a new church steeple, and have one man underwrite the full amount needed to brick-veneer the entire church. The Lord has sent to the aid of this fine pastor helping hands that have given good support to see this program go forward. Soon they will put in new stained glass windows, and new church pews. When these things are finished the church will look brand new. There is already in view for this church truly a great tomorrow.

PERSONAL REPORT OF THE DISTRICT SUPERINTENDENT

I have visited each church three times. Some have been visited as much as five and six times. We have conducted all of the annual meetings. There have been dozens of contacts made to secure new pastors for the district, and to promote the cause of the Texas interest. I have outlined and personally introduced to all pastors a new financial program for our district. This program known as Unified Budget, was voted upon last conference and was unanimously received. It was outlined in part detail by our District Council last Ministerial time. The final details have been worked out at this Conference by the District Council, and will now become this year fully in force as our new financial system.

This new program has the sanction of the General Church, the Gen. Secy. R. C. Hawkins, the District Council, and your humble servant-

We have personally sat down with each pastor and helped outline a new revival program for next year. We have also outlined and set goals for remodeling, church construction, and re-location for each church, in the next four years.

We have helped raise several hundred dollars to brick-veneer our San Antonio church. Also have helped raise approximately \$11,000.00 in addition to regular running expenses, to help boost our Extension program. We have set up a new District church and parsonage constuction, loan fund, with approximately \$9000.00 as a starter.

We have made several contacts with other Holiness groups for the promotion of better relationship among said groups. This overture has already helped our work.

We have received two churches officially into the Texas District. Have attended one school board meeting at Bartlesville, Okla. Attended one church leaders conference, at Indianapolis, Ind. Attended and spoke in two ministerial conventions. Have attended two camp meetings as special speaker. Held six week end revivals, and one ten-day revival. We have held 13 services in interest of our Easter drive.

I have traveled 29,690 miles in interest of the district and General church. I have met all church boards in planning for a new year's work. We have met the district council on two occasions collectively, and once on a person to person basis, due to the mileage expense involved. May I say our district council has exercised good judgment in the past year, and have been a splendid board to work with. I have met with, and written to the Gen. Secy. R. C. Hawkins numerous times in interest of the work throughout the year. We have helped to set up new supply lines of clothing for our Latin American work. Have spent days in the purchase of new church and parsonage locations, and the selling of others.

We have worked and sweat to make your district parsonage what we believe you would want it to be since the storm and freeze. Mrs. Burcham and I would like the conference to accept our little gift of \$100.00 for new and replaced shrubbery.

My parsonage has been supplied, my mileage and untilities have been paid, and I have received my salary in full.

For every ounce of strength God has allowed me under difficult conditions, I am humbly grateful. He has given us the desire of our hearts in the face of strong opposition. Souls have been helped and saved by, or in spite of our feeble ministry. We rejoice with you that on this our first year as your humble servant, God has given us an increase, and the adopted Program Of Progress has taken a big step forward May all praise and honor be given to our Lord who hath called us.

REPORT OF THE RESOLUTIONS COMMITTEE

CHURCH GOVERNMENT

- 1. We recommend that the annual business of the church be closed on April 30th. We also recommend that the District Treasurer's books be closed on May 10th, and that each church send all District funds to the District Treasurer before May 10th.
- 2. Be it resolved that the Annual Conference be held June 4-6, 1963, the place to be set by the District Council
- 3. We recommend that a quarterly bulletin be compiled by the District Superintendent, and sent to each church at the beginning of each quarter. Be it further resolved that the amounts of budget paid by each church in that quarter be published in said bulletin.
- 4. We recommend that a Worker's Convention be held during the year, the time and place to be agreed upon by the District Superintendent, the General Secretary of Church Extension, and the District Council.
- 5. We recommend that each church set aside one service each month as a time for bringing donations to the Pastor, announced by a deacon or deaconess of the local church as provided for by the manual, page 28, Section 50.
- 6. We recommend that the location of the churches and parsonages appear in the minutes. We further recommend that where the parsonages are equipped with telephones, the name of the pastor and the Pilgrim Holiness Church be listed in the directory, and also that the number appear in the minutes.
- 7. Be it resolved that the churches of the Texas District be zoned as follows: Zone 1, Corpus Christi, Houston I, Houston II, Lyford, Raymondville and San Antonio; Zone 2, Dallas, Fort Worth and Hillsboro; Zone 3, Borger and Dalhart.
- 8. Be it resolved that no church or church group on this District shall build or cause to be built any structure or improvement exceeding a cost of \$500.00 without authorization from the District Superintendent, and General Secretary of Church Extension.

SUNDAY SCHOOL

1. We recommend that there be a Sunday School Promotional Secretary. We further recommend that each pastor send his a report on Monday following the last Sunday of each month, including average Sunday School attendance, church attendance, total calls and contacts made by the church and pastor, and other interesting news from his church, which the promotional secretary shall include in a monthly bulletin to be issued to each of the churches.

CONFERENCE

- 1. We recommend that the pastor see that the yearly reports be in the hands of the Statistician by May 10th.
- 2. We recommend that each pastor report in full to the General Secretary of Church Extension and District Superintendent on blanks provided by the General Secretary.
- 3. We recommend that each pastor shall be granted a two weeks vacation with pay.
- 4. We recommend that no pastor shall call an evangelist outside our church without the approval of the District Superintendent.

5. We recommend that immediately following the conference the District Treasurer shall mail to each pastor an itemized notice of the financial responsibilities of his church to the District for the year, giving the address of the District Treasurer.

MISCELLANEOUS

- 1. Whereas Almighty God has given us another year of splendid progress on our District, and has permitted us to enjoy another conference, Therefore be it resolved that we express our appreciation to God by standing and singing the Doxology.
- 2. Whereas our General Secretary of Church Extension, Dr. R. C. Hawkins, has given unstintingly of his time and efforts to make this conference a success; Therefore be it resolved that we show our appreciation by standing and saying, "God bless you."
- 3. We recommend that an expression of appreciation be made for our District Superintendent, Rev. J. M. Burcham, by saying a hearty, "Amen."
- 4. Our efficient secretary, Rev. Allen Thomas, has served faithfully this conference year: Therefore be it resolved that we express our sincere appreciation by a rising vote of thanks.
- 5. Be it resolved that this conference show its deep appreciation to the efficient District Treasurer, Rev. John Abernathy, who has served faithfully this year, by sending a letter of appreciation.
- 6. Be it resolved that we show our appreciation to our Sunday School Secretary, Rev. Anatole Ferlet, by according him a rising vote of thanks. .
- 7. We recommend that a rising vote of thanks be given for the cooks and all who assisted them during this conference.
- 8. Be it resolved that the local church be accorded our appreciation for the entertainment enjoyed by this conference, for the untiring efforts to properly house us, and that the District Treasurer be authorized to pay the local church \$15.00 or such financial help as needed to defray the cost.
- 9. We recommend that the secretary be authorized to send a letter of appreciation to the local Wesleyan Methodist Church for their cooperative spirit in allowing us the use of their church building and chairs to accommodate our delegates and friends during this conference.
