FIRST SESSION

The Annual Conference of the Texas District of the Pilgrim Holiness Church convened in the Wedgewood Pilgrim Church of Fort Worth at 7:30 P.M., after the Texas Pilgrim Youth had given an outstanding performance of talent singing the praises of God. Rev. Tucker, the host pastor, welcomed the ministers, delegates, and friends on behalf of the local church, and requested, in the absence of Rev. Powell, who had gone to meet Dr. Hawkins at the airport, that Rev. William Jackson lead the congregation in singing. After two good hymns, the Junior Choir of the Forth Worth Church presented the beautiful number, "Amazing Grace." We all joined in singing this universal favorite. Rev. Powell, having arrived with Dr. Hawkins, proceeded in directing the service, calling the ministers and laity to a deeper fellowship with God. Ero. Dillingham, District Treasurer, led in prayer. Rev. Powell presented the chairman for the conference, Dr. R. C. Hawkins, Secretary of Church Extension of the Pilgrim Holiness Church, who brought a provocative message from the Word, about how we need to project our sanctified influence into an unsanctified culture.

SECOND SESSION

The first business session of the Conference was called to order by Brother Powell, who asked William Jackson to lead the congregational singing. "Work for the Night is Coming" was the admonition of the Gospel Song we sang. Bro. John Coe, lay delegate from Dalhart, led in prayer. Bro. Powell then presented the chairman, Dr. Hawkins, who brought an inspiring devotional message using the secondary thought found in Rev. 1:9-20 as his theme, "Christ in the midst of the Churches."

The Secretary called the roll. The motion prevailed to seat Joan Whybrew as delegate from the Hillsboro Church. The transfers into the District from other Districts and Denominations were received and approved. The Conference Bar was designated to include the first five pews on each side of the church and the platform. Rev. Thompson, pastor of the new mission at Lubbock, and Rev. Zamarron, new pastor of the circuit at Lyford and Sebastian, were introduced to the Conference, and asked to give their testimonies.

The time of the sessions was set for 9 to 12 A.M., 2 to the end of business in the afternoon, and the ordination service at 7:30 P.M.

The motion prevailed to seat the representative from the mission at Lubbock, Mr. Oscar Primm, Jr., as a delegate with full privileges.

The report of the District Superintendent was called for and read by our beloved Superintendent. This report was accepted with a rising vote of appreciation.

The Auditing Committee reported, and the report was accepted, after which the District Treasurer read his report. This, also, was accepted with thanks.

The Statistician's report was accepted as read.

Rev. Powell made the "Top Hat" awards. First place went to S. Allen Thomas, pastor of the Raymondville Church; and Second Place went to William Jackson, pastor of the San Antonio Church.

The Educational and Examining Board report was read and accepted. Those whose District License was authorized by this report were invited to come within the Conference Bar.

The Chairman declared a ten-minute recess. Upon resumption of business, the report of the Resolutions Committee was called for. Resolution #1 was passed as proposed. Resolution #2 was amended by inserting the clause, "The total United Stewardship Fund shall be paid before distribution is made for District expense." The resolution as amended carried.

The Committee on Memorials to the International Conference read its proposals. The Conference was adjourned by expiration of time. We were dismissed by Mr. W. A. Reed, lay delegate from Corpus Christi.

THIRD SESSION

The third session of the Conference was called to order, as Brother Powell asked Phillip Nettleton to lead the group in song. The congregation sang, "Break Thou the Bread of Life." Brother Keene led in prayer. Juan Zamarron was requested to sing in Spanish, and he sang, "Now I Belong to Jesus."

Dr. Hawkins called the Conference to order, and instructed the Committee on Memorials to the International Conference to re-read its resolutions preparatory to conference action. Resolution #1 was carried. Resolution #2 was amended by striking out the word "atend" and inserting the words "maintain their residence." The amended motion carried. Resolution #3 was recommended as read.

The Committee on Memoirs read its report, a memorial to Bro. Compton of Hillsboro. The Conference stood for a moment of silent prayer in memory of this departed brother, and then the chairman led in a brief prayer.

The next order of business was the election of officers. The chairman announced that the following appointments were made by the General Board of the Pilgrim Holiness Church: District Superintendent, Rev. Richard T. Powell; District Secretary, Rev. S. Allen Thomas; District Treasurer, Mr. Thomas Dillingham. Brother Powell appointed at tellers Leroy Birnbrook, Phillip Nettleton, Frank Quintanilla, Jr., and Thomas Dillingham to count at the blackboard. The chairman instructed the conference to vote for two advisory members of the Council. Elected were Garland Tucker and William Jackson.

The Council nominated H. A. Downing and William Jackson to fill the vacancy on the Educational & Examining Board. Rev. Downing was selected by the Conference.

Votes were cast for the Ministerial Delegate to the International Conference. Before the vote was counted, the motion was made that when there is an election of the Ministerial Delegate, the person receiving the second highest number of votes shall be declared the Ministerial Alternate. The motion prevailed, and the counting of the ballots revealed that S. Allen Thomas was elected delegate, and William Jackson was elected alternate.

Votes were then cast for the Lay Delegate to the International Conference. Before the votes were counted, the motion prevailed that when there is an election of the lay delegate, the person receiving the second highest number of votes shall be declared the alternate. Counting of the ballots revealed that Thomas Dillingham was selected delegate, and W. A. Reed was declared the alternate.

The Committee appointments were read by the Superintendent. Brother Powell then read his article, a copy of which had already been placed in the hands of each pastor and delegate, on "Waging War." This was a challenge to the pastors for achievement in their respective churches in the coming quadrennium. Several announcements were made.

The Miscellaneous Resolutions were read and approved. It was moved and seconded that the Secretary write those who pledged support for the Lyford work a note of appreciation. Carried.

A special request for prayer for Sister Birnbrook, wife of the pastor of the Corpus 'Christi church, was made. The conference session was adjourned by the prayer around the altar in her behalf, with Bro. Reed being anointed with oil in her place. The final session of the Conference was an Ordination Service. Rev. Phillip Nettleton led the Conference in singing "A Charge To Keep." Rev. H. A. Downing led in prayer. Bob Tucker, a son of one of the candidates, sang a special, "I'd Rather Have Jesus."

Dr. Hawkins acknowledged Rev. Powell, who presented the following motion: Resolved, that since the District Council recommends that Mrs. William Jackson be ordained as a Deaconess, having fulfilled all the necessary requirements, this Conference ordain her to this office. Motion carried.

Rev. H. A. Downing read I Timothy 3; Rev. Herman Nettleton read II Timothy 4:1-8; and Rev. S. Allen Thomas read Titus 3:1-11. Sister Powell sang by special request, "He Giveth More Grace."

Rev. Powell presented the following candidates to Dr. Hawkins: Garland Tucker and William Jackson to be ordained to the Ministry, and Mrs. William Jackson to be ordained as Deaconess. Dr. Hawkins ably presented a stirring message on the duties of the ministry, using for his text II Corinthians 3:6, "Able ministers of the New Testament." His exposition of the theme involved the sub-titles: The Minister and His Master; The Minister and His Mission; the Minister and His Message; and the Minister and His Tomorrow.

With the laying on of hands of the Ordination Council, which consisted of the Reverends Hawkins, Powell, Downing, Nettleton, and Thomas, the Reverends Tucker and Jackson were ordained to the ministry, and Mrs. Jackson was ordained as a Deaconess. It was a wonderful service, in which the presence of the Lord was manifest.

DISTRICT SUPERINTENDENT'S REPORT ____ JUNE, 1965

To our esteemed and beloved General Secretary of Church Extension, Dr. R. C. Hawkins, fellow ministers, lay delegates and visitors to the fifteenth annual conference of the Texas District, Greetings.

We are assembled today in the interest of the highest calling of mankind, that is, the carrying out of the "Great Commission." Of necessity we must review the past. Here we glean some startling facts. The one thing that we are so aware of at this time is that "What is past is forever written in the book." Our rewards as individuals or groups we have already received or they lie just ahead. From the review of yesterday we can see where we are strong and where we are weak. From this vantage point we should be able to build a road to a better and stronger district.

The record of this past year is one that we would like to hide from the view of everyone, however, it cannot be hidden. We must face the real hard facts; we have shown a loss both in our Sunday School attendance and in our Church Membership. The financial returns from our churches are very much in the red. Because we are a small district these losses are all the more glaring. These hard facts point out to us the need for our local churches being led into a new day where they will assume their total responsibility in every area of our beloved church. We have found some of God's choicest saints in our churches here in Texas. I believe all they need is good leadership and they will follow gladly.

Regardless of some discouraging things we thank God that there are some very bright spots showing up in our district. In March we re-opened the work in Borger. Brother and Sister Downing, the youngest oldsters in our midst, felt God would have them go there rather than into retirement. God has honored them and the work is going forward on all fronts.

We will welcome to our midst a new comer to our district, Rev. Joseph Thompson, who opened a mission in the Carpenter's Union Hall in Lubbock in Feb. This man has vision and drive. We can expect much from him. We say, "Praise the Lord for this new beginning."

The Fort Worth church, under the able leadership of Brother Tucker, has taken a long step forward in the past few months. We believe the ministry of this man and his family will soon have a real, live, spiritual following here. During this conference we will welcome the Fort Worth Church into our district as a fully organized church.

Brother and Sister Jackson now have a firm grip on the work at San Antonio. It was quite a change for these young folk. The people, the climate not to mention the problems. But when God gives the command, and His servants obey, the army soon moves forward. We are predicting great things for the work at San Antonio under their fine leadership.

Brother and Sister Thomas are now worshipping in their beautiful new church. What a change from the former days. The new building is an incentive to atract new people to the church. They have shown a gain of twelve in Sunday School with prospects for a greater gain next year.

After many months of heart-ache and some frustration, Brother and Sister Zamarron are now setled in Lyford. This energetic and spiritual man is taking hold of this work with a will to win. Already the church sign is up for the first time since I have been District Superintendent. They have painted the inside of the church and money is being raised to paint the outside. Welcome, Brother and Sister Zamarron! We say to all, "Watch the Lyford church grow."

There is a "holy" unrest among our people. The need for advancement in our churches is being felt. Many are saying to me, "How?" The "HOW" is the one field that belongs to the pastor. He must have a continuing program of advancement. If one plan does not work — throw it out and try another. There is one thing that the pastor must always have and that is ENTHUSIASM. E. B. Butler says, "Every man is enthusiastic at times. One man has enthusiasm for minutes — another man has it for days, but it is the man who has it for years who makes a success in life." Pastor, it is up to you to make your people fee lthat they are in the greatest movement in the world. The first time you voice to anyone in your church the idea that there is no hope for an individual or church, you have lessened your chances for helping them or it. Let your people see this quality of enthusiasm at all times. George Lawis Davis wrote, "Unless you exhibit enthusiasm and patience, you are only one of the mob. Just another guy named Joe. Even the most menial job or the dullest routine offers an opportunity to attract attention to yourself if you tackle it with gusto." Yes, you must attract people to you in order to win them to the church and if you are to be a soul-winner and church builder you must be enthusiastic.

The writer, after careful study and prayerful searching, feels there are some things necessary for the total advancement of our district. First, I question the propriety of the District Superintendent living in a district owned parsonage at this time. It is a standard of living in a district owned parsonage at this time. It is a standard of living that should be left to the future development of the district when there are enough churches to support such a project. The money that is now being used to make these payments could then be applied on a home in an area where we are trying to start a new church. This property could then become the parsonage for that local church. I feel that this should be planned as quickly as possible. In a small Church Extension District the Superintendent should be one of the men helping to start new churches.

Secondly, I would urge our pastors and people that the following measures be taken to implement our program for this coming year:

- a. Each church diligently work a PERSONAL EVANGELISM PROGRAM.
- b. Establish Teacher Training using the Pelt Lessons.
- c. Plan Promotional Sundays, at least quarterly, for the enlargement of our Sunday School attendance growth.
- d. Make every effort possible to attain the goals as set forth and agreed upon at our Ministers Retreat.
- e. Have a more adequate appraisal as to the needs of the pastors in our local churches.
- f. Plan a more lively Youth Program and organize a C. Y. C. in each church.

g. Make an honest effort to raise our budgets in full.

We are a TEAM. If the DISTRICT is to grow it will take our united effort.

REPORT OF THE EDUCATIONAL AND EXAMINING BOARD

We recommend that we accept the tranfers of Josue Zamarron, an ordained minister, and his wife, Mrs. Deborah Zamarron, a Licensed Deaconess, from the Central District of Mexico, to the Texas District.

We recommend that we accept the transfer of Schauner P. Vance, an ordained minister of the Texas District, Church of the Nazarene, to the Texas District.

We recommend that Joseph Thompson, transferring to us from the Abilene District of the Methodist Church, be granted First Year License.

We recommend that Garland Tucker, having completed his course of study to the satisfaction of the District Council, be ordained to the ministry by this conference.

We recommend that William Jackson, having completed his course of study and all necessary requirements be ordained to the ministry by this conference.

We recommend that Mrs. William Jackson, having completed her course of study and all necessary requirements be ordained as a deaconess by this conference.

We recommend that Larry B. Jarvis be granted Fourth Year License.

We recommend that Leroy Birnbrook be granted Third Year License.

We recommend that Phillip Nettleton be granted Second Year License.

We recommend that Joe Aguilar be granted First Year License.

We recommend that Elmer Molle be granted First Year License.

We recommend that Licensed Deaconess Credentials be issued to Elodia Alvarado, Paula Hernandez, Mrs. Allen Thomas, Mrs. Garland Tucker, and Mrs. Deborah Zamarron.

MEMORIALS TO THE GENERAL CONFERENCE

1. Resolved, that there shall be three General Superintendents elected by the International Conference for a term of four years; the term of office shall begin at the close of the International Conference and shall continue through the close of the following one; each shall serve all four years in the area to which he is assigned. One shall be designated as General Superintendent of World Missions, and his primary duties shall be supervision of all works and districts beyond the continental United States; the continental United States shall be divided into two as nearly equal parts as possible both geographically and numerically, which shall be known as the Eastern Area and the Western Area; the General Superintendents of these two areas shall live as near as possible to the center of the area to which he is assigned. It shall be the responsibility of the three General Superintendents to set up meetings at the International Headquarters as needed. As a result of the above designation, the Secretary of World Missions shall serve his primary purpose as an assistant to the General Superintendent of World Missions in the financial and administrative fields.

2. Resolved, that all ministers carrying District License shall become members of the District organization in which they reside. No minister carrying District license shall hold any elective or appointive office in any church other than as pastor. All active ministers shall have a voice and vote in the District Conference. Each minister shall support with his tithes and offerings the church of which he is pastor. Unstationed ministers and evangelists shall support the church where they maintain their residence,

unless requested by the District Superintendent and/or District Council to support another work.

3. Whereas there is a continual transfer of ministers from one District to another, and much confusion caused by lack of a uniform method of transfer, therefore be it resolved that a uniform transfer be issued by the International Headquarters, in triplicate, and that all Districts shall be required to use them, and that no minister shall be issued a license by another District until such transfer is complete. Of the triplicate form, the third copy shall be retained in the book by the District Secretary issuing the transfer; the original and the second sheets shall be sent to the Secretary or Superintendent of the District to which the minister is trans-ferred; upon receipt of these, the original shall be filed, and the second sheet shall be returned to the issuing officer together with a validation on the second by the negocity of these. on the same by the receiving officer.

REPORT OF THE CONFERENCE ACTION COMMITTEE

1. Resolved that the Resolutions Committee and the Ways & Means Committee shall be combined into one committee called the "Conference Action Committee".

2. Resolved, that the Total Budgets, including District and General, shall be \$2.00 per month per member, or a total of \$24.00 per year per member. Said yearly total shall be broken down by the District Treasurer as fol-lows: \$8.00 United Stewardship Fund, \$1.00 Central Pilgrim College, \$1.00 Travel expense of District officials to Conferences, 50¢ General Conference expense, \$1.00 printing and publications, \$12.50 District expense, and \$1.00 Miscellaneous expense. However, the total United Stewardship Fund shall be paid before distribution is made for District expense.

3. Be it resolved that the District Superintendent meet with each pastor and/ or Curch Board to help set up a program to raise the budgets of \$2.00 per month per member.

4. We recommend that the District pay \$50.00 monthly on the salary of the District Superintendent.

5. We recommend that the phone and utility bills of the District Superintendent be paid by the District.

6. We recommend that the District pay any mailing or traveling expense authorized by the District Superintendent.

7. We recommend that each pastor, upon receipt of the District Minutes, take a Sunday Morning to read and discuss with the church congregation all the actions of the District Conference pertaining to the local church, and that in the same service a special offering shall be taken equal to 50c per member family, same to be sent to the District Trasurer , and applied to that church's budgets.

8. We recommend that the annual business of the church be closed on April 30th. We also recommend that the District Treasurer's books be closed on May 10th., and that each church send all District funds to the District Treasurer before May 10th.

9. Be it resolved that the annual Conference be held June 1-2, 1966, the place to be set by the District Council.

10. We recommend that a Worker's Convention be held during the year,

10. We recommend that a worker's Convention be held during the year, the time and place to be agreed upon by the District Superintendent, the General Secretary of Church Extension, and the District Council. 11. Be it resolved that the District Superintendent and the Editorial Com-mittee print and mail to each pastor a District Paper at least once each quarter, preferably monthly. This shall contain the monthly Sunday School report, the Quarterly report of the District Treasurer, which shall list the amounts paid by each church on the total budgets.

12. We recommend that each church set aside one service each month as a time for bringing donations to the pastor, announced by a deacon or deaconess of the local church. (See Manual, Page 28, Section 50.)

13. We recommend that the location of the churches and parsonages appear in the minutes. We further recommend that where the parsonages are equipped with telephones, the name of the pastor and the church name be listed in the directory, and that the phone number appear in the minutes.

14. Be it resolved that the churches of the Texas District shall be Zoned as follows: Zone I, Corpus Christi, Houston, Lyford, Raymondville, and San Antonio; Zone II, Forth Worth and Hillsboro; Zone III, Borger, Dalhart, and Lubbock.

15. Be it resolved that no church or church group in this Distritc shall build or cause to be built any structure or improvement exceeding a cost of \$100.00, without authorization by the Superintendent.

16. Be it resolved that the Texas District shall have a Youth Camp in 1966; the details shall be worked out by the District Superintendent with the cooperation of the Youth President and the C.Y.C. Director; a report of plans shall be given in the District Paper by December, 1965, which shall include announcement of the time, place, cost, and other information that will be needed, so that each person planning to go will have time to prepare for the necessary expenses.

17. We recommend that there be a Sunday School Promotional Secretary. We further recommend that each pastor send him a report on Monday following the last Sunday of each month, on the report cards provided, which report shall include the average Sunday School attendance, and a report of any special offering taken through the Sunday School, such as the Rally Day Offering, Self Denial Offering, Easter Offering, Bible School Offering, etc.

CONFERENCE

1. We recommend that each pastor shall see that the yearly reports be in the hands of the Statistician by May 10th.

2. We recommend that each pastor report in full each month by the 10th., to the District Superintendent, on blanks provided by the Superintendent.

3. We recommend that each pastor shall be granted a two week's vacation with pay.

4. We recommend that immediately following the Conference the District Treasurer shall mail to each pastor an itemized notice of the financial responsibilities of his church to the District for the year, giving the address of the District Treasurer.

MISCELLANEOUS

1. Whereas Almighty God has been with us on our District, and has permitted us to enjoy another Conference, therefore be it resolved that we express our appreciation to God by standing.

2. Whereas our General Secretary of Church Extension, Dr. R. C. Hawkins, has given unstintingly of his time and efforts to make our Conference a success, therefore be it resolved that we show our appreciation by standing and saying, "God bless you."

3. Be it resolved that this Conference express its appreciation for our District Superintendent, Rev. Richard T. Powell, and his wife, for their untiring efforts in leading our district, and that they be accorded a rising vote of thanks and a hearty, "Amen."

4. Our efficient Secretary, Rev. S. Allen Thomas, has served faithfully this conference year: therefore be it resolved that we express our sincere appreciation by a rising vote of thanks.

5. Be it resolved that this conference show its heartfelt appreciation to the efficient District Treasurer, Mr. Thomas Dillingham, who has served faithfully this year, by a hearty, "Amen."

6. Be it resolved that we show our appreciation to our Sunday School Promotional Secretary, Rev. Leroy Birnbrook, by according him a rising vote of thanks.

7. Be it resolved that the local church be accorded our appreciation for the entertainment enjoyed by this conference, for their untiring efforts to properly house us, and that the District Treasurer be authorized to reimburse the local church that which it cost financially.

REPORT OF THE COMMITTE ON MEMOIRS

Raymond Joy Compton was born August 29, 1912, in Emmett, Texas, and passed away January 19, 1965, at the age of 52 years. At the age of sixteen his parents moved to Hillsboro, where he resided until his death. On February 12, 1937, he married Miss Oleta Everett, who survives him, along with two sons, three daughters, and three grand-children. When approximately 16 years of age, Raymond gave his heart to the Lord at the altar of the Pilgrim Holiness Church in Hillsboro, to which church he united in membership. He was faithful in his support of the Lord's work. While earning his livelihood as a carpenter, he established a far-reaching influence in the community. His life will be missed in the church, the home, and the entire community.
