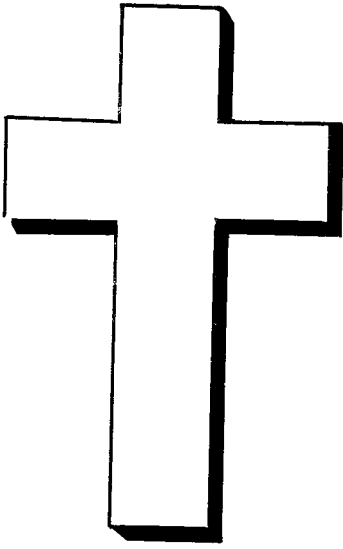

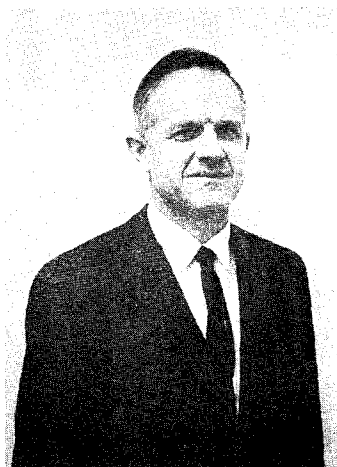

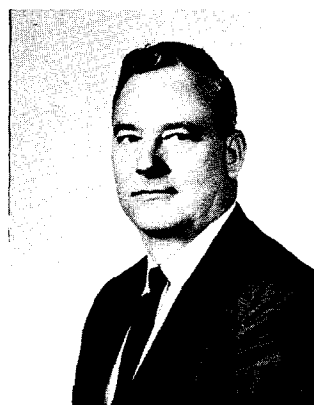

FIRST SESSION, 7:30 P.M., 6-7-67

The First session of the Seventeenth Annual Conference of the Texas District of the Pilgrim Holiness Church, meeting in the First Church, 1103 Maxey Road, Houston, was called to order by our devoted District Superintendent, Rev. Richard T. Powell, who asked that Brother Thomas lead in singing, number 209, "Onward, Christian Soldiers." Brother Powell then asked Brother Ward, a layman in the Houston Church, to lead number 243, "Let the Lower Lights Be Burning." Then he asked Brother Tuckner, pastor at Fort Worth, to lead singing number 225, "Speak, My Lord." Brother Herman Nettleton, pastor at Dalhart, led in prayer.

Brother Powell gave a warm welcome to the Conference on behalf of the local congregation, at the same time mentioning his appreciation for the local members and the way they have helped in preparing for this conference.

After the offering was received, Brother Ward led two choruses, "Everybody Ought To Know" and "When Your Fears Grow." Susan Dillingham and Rachel Nettleton sang a duet, "In Times Like These."

Brother Powell introduced the speaker of the hour, the General Secretary of Church Extension, Rev. W. N. Miller, giving sincere feeling to his words of loyalty and brotherly love for this our leader in the Church Extension Department. Brother Miller responded for all of us to the words of welcome in behalf of the local congregation, and then brought a very practical and inspiring message on the theme, "I will Build My Church," calling attention to the fact that these are Christ's words, and Christ will build His Church if we will let Him work through us, or at least get out of His way.

SECOND SESSION, 9:30 A.M., 6-8-67

Rev. Powell called the Conference to order, and reported his conversation with two absent families, who were unable to attend because of health, and also of his knowledge of the third family that could not attend: namely, Sister William Jackson is ill with an infection; Brother and Sister Downing, also ill, reported that this was the first Conference they had missed in a long time; and our new pastors at Hillsboro, Rev. and Mrs. Holliday, are unable to attend because of his work and her physical condition. Brother Powell asked the conference to stand to pray for these absent members, and called on Brother Dillingham to lead in prayer.

We were led in singing by Brother Jackson, number 328, "My Jesus, I Love Thee," and, "Trust and Obey" number 57. Each pastor prayed a sentence prayer.

Brother Powell presented the Chairman of the Conference, General Secretary of Church Extension, Rev. W. N. Miller, who in turn recognized the President of Central Pilgrim College, Bartlesville, Oklahoma, Rev. N. N. Bonner, and stated that he had asked Brother Bonner to bring the devotional lesson for the morning. He further asked that Brother Bonner present his wife, and give her opportunity to testify.

Brother Bonner's wife gave a glowing testimony to God's grace, and then Brother Bonner gave a deeply spiritual dissertation on Psalms Chapter 103. It was the type of message that Brother Miller dubbed, as from a "spiritual optimist."

The Chairman asked the conference to come to order, and the Secretary to call the Roll.

Brother Powell moved that we grant an honorary seat in the Conference Bar to Rev. & Mrs. N. N. Bonner, including full privileges of discussion. The motion was seconded, and carried.

Brother Powell presented, in their absence, the transfers to the Texas District of Rev. and Mrs. Charles Holliday, new pastors at Hillsboro, from the Michigan District. He moved that the Conference accept these transfers. The motion carried.

The motion prevailed to set the Conference Bar as the first four seats on both sides of the church, and the front.

The hours of the sessions were set at 9:30 a.m. to 12 noon; 2:30 until completion of business in the afternoon, and the evening ministry at 7:30 p.m.

Brother Miller called for the report of the District Superintendent, which was given. In his report, Brother Powell emphasized the theme, "Forward With Christ in 1967-68." The report was accepted with a rising vote of thanks.

The Auditing Committee reported, and its report was accepted.

The District Treasurer's Report was given, and the motion prevailed to accept it with a rising vote of thanks for his good work.

The Statistician's Report was given, and accepted with a rising vote of thanks.

Brother Powell announced that the "Waging War" results show that none of the pastors reached the designated goals in order to qualify for the prizes; but since Brother Zamarron failed only in number of visits on non-members, and Brother Rovenstine failed only in membership goal, therefore, Brother Powell announced that he and his wife are awarding the prizes anyway, and that Brother Zamarron will get the suit of clothing, and that Brother Rovenstine will get the pair of shoes.

It was announced that immediately after the hour of the afternoon session arrives, pictures of the Conference will be taken, and then Brother Bonner will be given time to present the cause of the Central Pilgrim College.

We were adjourned for lunch. Sister Bonner dismissed with prayer.

THIRD SESSION, 2:30 P. M., 6-8-67

Brother Rovenstine led in singing "Tell It To Jesus." Brother Powell was asked to lead in prayer, and then the chairman recognized Brother Bonner, giving him the floor to represent the Central Pilgrim College.

Brother Bonner read from Luke 19:13, and entitled his remarks, "Pounds and Points to Ponder." At the close of his remarks, Brother Powell moved that out of respect to Brother Bonner and the cause he represents, we give him a rising vote of thanks. Carried.

Brother Powell then moved that each church, beyond its regular budget, raise \$5.00 per member per year for Central Pilgrim College. Carried.

The Educational and Examining Board Report was read and adopted.

The District Youth President reported, and his report was well received. He announced that the District Youth Camp will be held August 15 through 18th.

The District Director of the Christian Youth Crusaders had sent her report, which was accepted, and will be spread in the minutes.

Brother Miller declared that the next order of business was the election of officials. He read the following appointments by the General Board:

District Superintendent, Rev. Richard T. Powell

District Secretary, Rev. S. Allen Thomas

District Treasurer, Mr. Thomas Dillingham

Brother Miller then ruled that our District can only qualify for one additional member of the council, and instructed the members of the Conference to cast their ballots for a Member-at-large.

The Superintendent appointed Brother Tucker and Brother Dillingham as tellers.

Rev. William Jackson was elected the District Councilman-at-large. Brother Jackson wished to decline, but was willing to serve while possible.

It was moved and seconded that Rev. H. Nettleton be elected by unanimous ballot to continue on in his position on the Educational and Examining Board. The motion prevailed.

Ballots were cast for delegates to the International Conference. Rev. S. Allen Thomas was elected the ministerial delegate, and Mr. Thomas Dillingham was elected the lay delegate. The Conference then selected Rev. H. Nettleton as the Alternate Ministerial Delegate, and Mr. W. A. Reed as the Alternate Lay Delegate.

The Superintendent moved that the Conference send telegrams to Rev. and Mrs. Downing, and Mrs. Jackson, expressing regrets for their absence due to illness, and to Rev. J. D. Abbott, our General Superintendent, regretting his absence due to other commitments. Carried. The Telegrams follow:

Brothr Miller presented a report on the Pilgrim Pension Plan. Brother Powell then read the Committee Appointments, and finally Brother Tucker read the Miscellaneous Resolutions.

The motion prevailed to refer all unfinished business to the District Council.

The motion prevailed that we adjourn. Sister Powell dismissed the Conference with prayer.

FOURTH SESSION, 7:30 P. M., 6-8-67

The evening service was given over entirely to a devotional and instruction, and a discussion of the Merger with the Wesleyan Methodist Church, forming the Wesleyan Church. A beautiful feature of this service was its fitting close, as all present, including a delegation from the local Wesleyan Methodist Church, and its pastor, joined hands in singing, "Blest Be the Tie That Binds."

DISTRICT SUPERINTENDENT'S REPORT

Mr. Chairman, Fellow Ministers, Delegates and friends of the Texas District Conference, Greetings!

It is indeed a pleasure to have Reverend W. N. Miller, General Secretary of Church Extension with us this year to preside over our conference. We trust that the more he sees of us and Texas the better he will like being among us.

This present age will go down in history as "the age of was." We have a war raging in Vietnam and now also in the Holy Land. This makes us realize more than ever that we too are engaged in a warfare against evil. We cannot sit by and dream of victory and expect to have it. We must fight if we would win and warfare involves much sacrifice which includes man-power and finances.

As we meet in conference today let us take a good look at our yesterdays, the present and our tomorrows. From the past we should gather much knowledge to help us today and in the future. The Word of God is being given to the darkened continent of Africa by our own missionary, Miss Esther Nettleton. If ever a young lady had much to look forward to in a good career for life, she did. However, she heard the call of God and answered and in such a few months left us to go to Africa. This is a good example of Home Missions in action.

Let us take a look at some of our blessings this past year. Most of our churches have shown a marked improvement in their buildings as well as moving forward spiritually.

Dalhart:— The wonderful group of Pigrims here have placed new drapes at the windows. How very attractive they make the church. Prospects are good here for a fine growth this year and we trust God will help them to reach many new folk.

Fort Worth:— Brother Tucker has worked against many odds here but with much effort and help they painted the outside trim on the church last summer. We trust this year will be turning point for the Fort Worth church and we will see a harvest of souls.

Hillsboro:— Brother and Sister Holliday have only been on the job here since February but already things have been changed. The people have a mind to work to build up their congregation and also to put their buildings in good repair. Several window sills that were rotted out have been replaced. When we visited them last month we thought they had put a new rug on the floor, but through the efforts of friends the old one had just had a good cleaning. We believe God has a good work ahead for this fine young couple.

San Antonio:— Many hours of hard work has been put into the property at San Antonio. Both Brother Jackson and his father have been busy. The parsonage and garage have new roofs on them. The Sunday School rooms are refinished and ready for an increase. The front of the church has been finished and the windows all fixed properly. How nice the House of the Lord looks. Now they are ready for an Evangelism Campaign. Let us pray that God will bless this church.

Corpus Christi:— Brother Rovenstine has recently had a contest called "The Rollers and Brushes" to raise money to paint the buildings. What a change has taken place. One would almost think the old buildings had been replaced with new ones. We pray God will bless these good people. They have had a good increase in Sunday School and several have knelt at their altar this past year and found peace with God.

Raymondville:— Something seems to be always going on here. The old church building was leaking so badly, yet money was scarce. Brother Joseph Jackson, our evangelist, accepted a call to this church for a meeting. Not only did he preach but he like Paul, "worked with his hands." He built a new "A" roof on the back of the building. God who keeps the record will repay this wonderful man of God. Raymondville holds forth a tremendous challenge to our Pilgrims.

Lyford:— This year we sent a missionary to Africa. A little over two years ago we brought a man from Mexico to labor among his own people here in South Texas. This man has really worked and for his labors his Sunday School now has the largest attendance average in the past six years. He has just completed a new church building 32' x 48' at a fantastically low cost and complete with new pews. He was his own contractor but let out part of the work on bids. He will be inviting you to visit them soon for their dedication service.

Borger:— It is with a note of sadness that we open this conference without the presence of Brother and Sister Downing. They have labored hard among us for so many years and God has blessed their ministry. Due to ill health their doctor has ordered a complete rest for at least one year. Let us pray for them.

No leader is any better than the men who labor with him. I want to thank the men of this district for their many kindnesses to me. This goes also for the wonderful wives of our pastors who have so graciously entertained both sister Powell and myself.

We are so very fortunate to have a district treasurer like Brother Thomas Dillingham. He spends many hours taking care of the books and seeing that our bills are paid on time. Our district secretary and statistician, Brother Allen Thomas puts in long hours on the work necessary to keep our records in order. Words are not adequate to thank these men for their labors of love. We are indeed grateful to them.

We take this opportunity to express our appreciation for the wonderful cooperation of the council. Without their help and good advice we would have carried a much heavier load his year.

Let us make the motto of this conference the motto for our district this year, namely, "Forward with Christ in 1967-68." There is work to be done and souls to be won. As workers together with Him we can go forward.

REPORT OF THE CONFERENCE ACTION COMMITTEE

1. Resolved, that the Resolutions Committee and the Ways & Means Committee shall be combined into one committee called the "Conference Action Committee."

2. Resolved, that the Total Budgets, including District and General, shall be \$2.00 per month per member, or a total of \$24.00 per year per member. This shall be used to, firstly pay the entire United Stewardship Fund of \$9.50 per member; secondly, to place \$1.00 per member in the International Conference Reserve Fund; and the remaining \$13.50 shall be used by the District as deemed necessary by the District Superintendent and/or District Council. It is provided that the Central Pilgrim College shall be permitted to raise offerings in our churches, but shall not be included in the District Assessment.

3. Be it resolved that the District Superintendent shall meet with each pastor and/or Church Board to help set up a program to raise the budgets of \$2.00 per month per member.

4. We recommend that the District pay \$50.00 monthly on the salary of the District Superintendent.

5. We recommend that the Phone and utility bills of the District Superintendent be paid by the District.

6. We recommend that the District pay any mailing or traveling expense authorized by the District Superintendent.

7. We recommend that each pastor, upon receipt of the District Minutes take a Sunday Morning to read and discuss with the church congregation all the actions of the District Conference pertaining to the local church, and that in the same service a special offering shall be taken equal to 50¢ per member family, same to be sent to the District Treasurer and applied to that church's budgets.

8. We recommend that the annual business of the church be closed on April 30th. We also recommend that the District Treasurer's books be closed on May 10th and that each church send all District funds to the District Treasurer before May 10th.

9. We recommend that a Worker's Convention be held during the year, the time and place to be agreed upon by the District Superintendent, the General Secretary of Church Extension, and the District Council.

10. Be it resolved that the District Superintendent and the Editorial Committee print and mail to each pastor a District Paper at least once each quarter, preferably monthly. This shall contain the monthly Sunday School report, the Quarterly report of the District Treasurer, which latter shall list the amounts paid by each church on the total budgets.

11. We recommend that each church set aside one service each month as a time for bringing donations to the pastor, announced by a deacon or deaconess of the local church. (See Manual, Page 28, Sec. 50.)

12. We recommend that the location of the churches and parsonages appear in the minutes. We further recommend that where the parsonages are equipped with telephones, the name of the pastor and the church name be listed in the telephone directory, and that the phone number appear in the District Minutes.

13. Be it resolved that the churches of the Texas District shall be Zoned as follows: Zone I, Corpus Christi, Houston, Lyford, Raymondville, San Antonio, and Sebastian; Zone II, Fort Worth and Hillsboro; Zone III, Borger and Dalhart.

14. Be it resolved that no church or church group in this District shall build or cause to be built any structure or improvement exceeding a cost of \$100.00, without the authorization of the District Superintendent.

15. Be it resolved that the Texas District shall have a Youth Camp in 1968; the details shall be worked out by the District Superintendent with the cooperation of the Youth President and the C.Y.C. Director; a report of plans shall be given in the District Paper by December 1967, which shall include announcement of time, place, cost, and other information that will be needed, so that each person planning to go will have time to prepare for the necessary expenses.

16. We recommend that there be a Sunday School Promotional Secretary. We further recommend that each pastor send him a report on Monday following the last Sunday of each month, on the report cards provided, which report shall include the average Sunday School attendance, and the Rally Day Offering, Self Denial Offering, Easter Offering, Bible School Offering, etc.

MISCELLANEOUS

1. Whereas our General Secretary of Church Extension, Rev. W. N. Miller, has provided excellent leadership for this Department, and has proven his abilities as the Chairman of this Conference, therefore be it resolved that we show him our appreciation for his time and efforts by standing and saying "God bless you."

2. Be it resolved that this conference express its appreciation to our District Superintendent, Rev. Richard T. Powell, and his wife, for their untiring and inspiring efforts in leading our District and that they be accorded a rising vote of thanks and a hearty, "Amen."

3. Since our efficient District Secretary, Rev. S. Allen Thomas, has served faithfully another year; therefore be it resolved that we express our sincere appreciation by a rising vote of thanks.

4. Be it resolved that this Conference show its heartfelt appreciation to our efficient and faithful District Treasurer, Mr. Thomas Dillingham, by standing and saying a hearty, "Amen."

5. Be it resolved that the local church be accorded our appreciation for the entertainment enjoyed by this Conference, and for their efforts to properly house us, and that the District Treasurer be authorized to reimburse the local church that which it cost financially.

6. Whereas Almighty God has been with us on our District, and has permitted us to enjoy another Conference; therefore be it resolved that we express our appreciation to God by standing and singing the Doxology.

REPORT OF THE AUDITING COMMITTEE

We have examined the books of the District Treasurer, and have found them to be in a most satisfactory condition. There is much proof that the Treasurer has given valuable time to the work involved.
